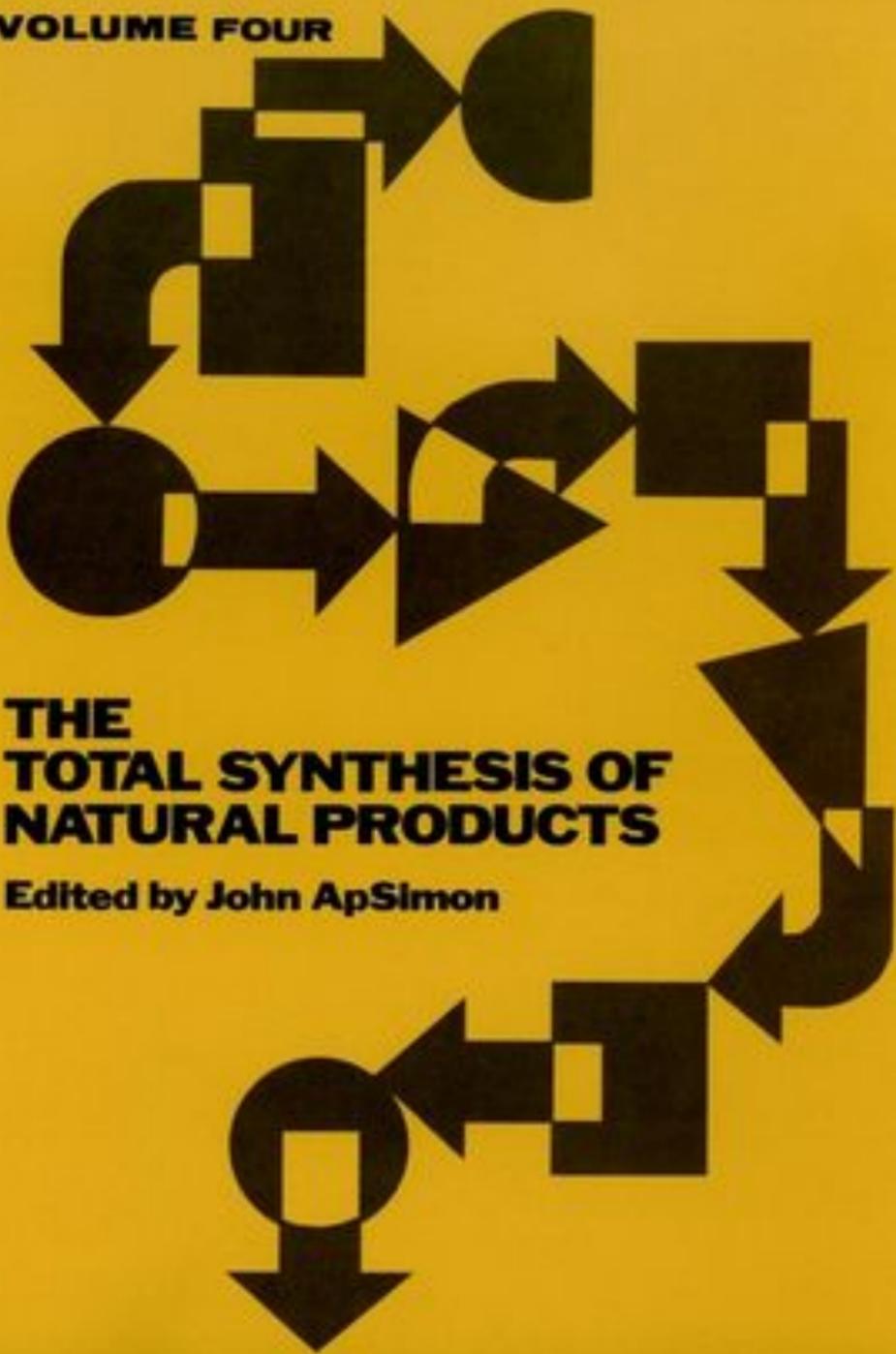

Preface

Throughout the history of organic chemistry, we find that the study of natural products frequently has provided the impetus for great advances. This is certainly true in total synthesis, where the desire to construct intricate and complex molecules has led to the demonstration of the organic chemist's utmost ingenuity in the design of routes using established reactions or in the production of new methods in order to achieve a specific transformation.

These volumes draw together the reported total syntheses of various groups of natural products and commentary on the strategy involved with particular emphasis on any stereochemical control. No such compilation exists at present, and we hope that these books will act as a definitive source book of the successful synthetic approaches reported to date. As such, it will find use not only with the synthetic organic chemist but also perhaps with the organic chemist in general and the biochemist in his specific area of interest.

One of the most promising areas for the future development of organic chemistry is synthesis. The lessons learned from the synthetic challenges presented by various natural products can serve as a basis for this ever-developing area. It is hoped that these books will act as an inspiration for future challenges and outline the development of thought and concept in the area of organic synthesis.

The project started modestly with an experiment in literature searching by a group of graduate students about thirteen years ago. Each student prepared a summary in equation form of the reported total syntheses of various groups of natural products. It was my intention to collate this material and possibly publish it. During a sabbatical leave in Strasbourg in 1968-69, I attempted to prepare a manuscript, but it soon became apparent that the task would take many years and I wanted to enjoy some of the other benefits of a sabbatical leave. Several colleagues suggested that the value of such a collection would be enhanced by commentary. The only way to encompass the amount of data

collected and the inclusion of some words was to persuade experts in the various areas to contribute.

Volume 1 presented six chapters describing the total synthesis of a wide variety of natural products. The subject matter of Volume 2 was somewhat more related, being a description of some terpenoid and steroid syntheses. Volume 3 concentrated on alkaloid synthesis and appeared in 1977. The present volume contains three chapters on new areas of synthetic endeavor and two more encompassing the progress in synthetic work in the areas of monoterpenes and prostaglandins since the appearance of Volume 1.

It is intended that Volume 5 of this series will contain predominantly updating chapters in order that this series may continue to be of timely use to those with interests in synthetic chemistry.

2 The Synthesis of Insect Pheromones

1. INTRODUCTION

Man has wondered at spectacular scenes of metamorphosis, aggregation, and mating of insects for many years. During the past two decades it has gradually become clear that these biological phenomena are regulated by chemical substances known as insect hormones and pheromones. Insect chemistry, the study of natural products of insect origin, is now regarded as an established branch of natural products chemistry.

After the discovery of bombykol 1, the first insect pheromone, by Butenandt and his associates,¹ the term "pheromone" was defined by Karlson and Lüscher.² The name is derived from the Greek *phrein*, to transfer, and *hormon*, to excite. Pheromones are substances that are secreted to the outside by an individual and received by a second individual of the same species, in which they release a specific reaction, for example, a definite behavior or a developmental process.

From the beginning the synthetic approach was very important in pheromone researches because of the limited availability of natural pheromones from insects (usually less than several milligrams). Synthetic work in insect pheromones may be classified into three categories: (1) synthesis as the final proof of the proposed structure, including olefin geometry and relative as well as absolute stereochemistry; (2) synthesis that provides sufficient material for biological study, such as field tests; and (3) synthesis of a number of isomers and analogs to clarify the structure-pheromone activity relationship. Synthesis thus ensures ample supplies of otherwise inaccessible pheromone and facilitates the practical uses of pheromones in agriculture and forestry.

Pheromone structures are scattered among various types of volatile compounds ranging from alkanes to nitrogen heterocycles. Recent studies on structure-activity relationships reveal the importance of stereochemistry in pheromone perception by insects. Three types of isomerism, structural, geometrical, and optical, are all shown to effect the biological activity, as described below.

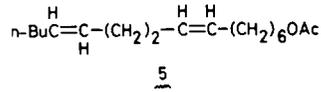
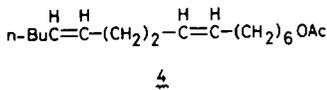
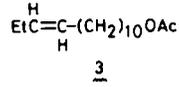
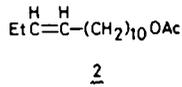
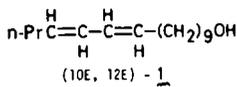
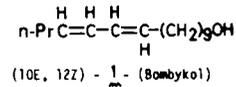
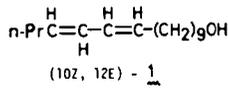
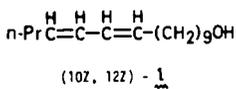
Bombykol, the Pheromone of the Silkworm Moth (Bombyx mori), and its Geometrical Isomers

Butenandt et al.^{3,4} and Truscheit and Eiter⁵ synthesized all of the four possible geometrical isomers of bombykol 1 and compared their attractancy to the male silkworm moth. The results are shown in Table 1. The biological activity, as well as physical properties, of (10*E*, 12*Z*)-10,12-hexadecadien-1-ol was almost identical with that of the natural bombykol. The geometry of the diene system in bombykol was thus established as 10*E*, 12*Z* by this synthetic work. It should be noted that the other three geometrical isomers possess only moderate or weak biological activities. A highly stereoselective synthesis of the most active isomer is therefore of paramount importance both scientifically and economically.

The Pheromone of Red-banded Leaf Roller (Argyrotaenia velutinana) and Its Geometrical Isomer

Roelofs et al. identified (*Z*)-11-tetradecenyl acetate **2** as the sex pheromone of red-banded leaf roller moths.⁶ They then demonstrated that a large amount of the (*E*)-isomer **3** is inhibitory to pheromone action.⁷ Here again stereochemistry was shown to be important. Roelofs' argument on this subject was based on his bioassay results with many pheromone analogs, some of which work in an inhibitory manner, while others act synergistically.⁷ Subsequently Klun et al.⁸ and

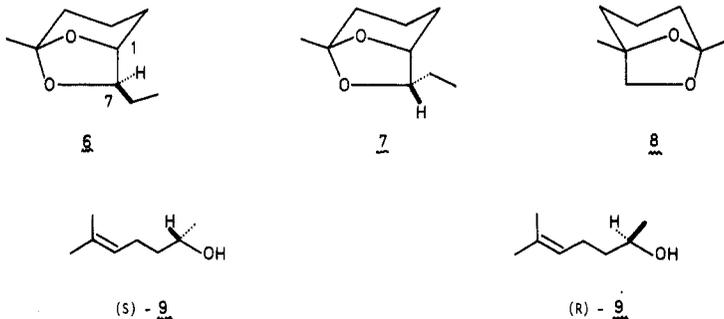
Beroza et al.⁹ reported the very interesting observation that a small amount of opposite geometrical isomer was critical to pheromone attraction. Klun found that a geometrically pure preparation of **2** was very weakly attractive to the moth and that the presence of 7% of (*E*)-isomer **3** was necessary for maximum activity.⁸ Previous syntheses of **2** employed either the Wittig reaction or the Lindlar semihydrogenation, and neither of them was 100% stereoselective. It is therefore obvious that a highly pure geometrical isomer is required to study this kind of very subtle biological phenomena. Beroza's relevant work was on the pheromone of the oriental fruit moth *Grapholitha molesta*. The biological activity of the synthetic pheromone (*Z*)-8-dodecenyl acetate increased 25 times by the addition of a small amount of the (*E*)-isomer.⁹

Gossyplure, the Pheromone of Pink Bollworm Moth (Pectinophora gossypiella)

In the case of gossyplure the pheromone consists of a mixture of two geometrical isomers in an equal amount: (7*Z*, 11*Z*)-7,11-hexadecadienyl acetate **4** and its 11*E*-isomer **5**.¹⁰ Neither is biologically active alone. This suggests the existence of two different receptor sites on the pheromone receptor of the pink bollworm moth.

The Pheromone of Dendroctonus Bark Beetles

Two stereoisomers of 7-ethyl-5-methyl-6,8-dioxabicyclo[3.2.1]octane were isolated from the frass of the western pine beetle (*Dendroctonus brevicomis*).¹¹ Only one of them, *exo*-brevicommin **6**, is biologically active as a component of the aggregation pheromone of the western pine beetle. The other isomer, *endo*-brevicommin **7**, is inactive to the western pine beetle and even inhibits the olfactory response of flying male and female southern pine beetles (*Dendroctonus frontalis*) to the female-produced pheromone, frontalinalin **8**.¹² In this case the *endo*-*exo* stereoisomerism is of utmost importance for biological activity. This necessitated the stereoselective synthesis of these pheromones.



Biological Activities of the Optical Isomers of Pheromones

exo-Brevicommin **6** and frontalin **8** are chiral molecules. They therefore can exist in two enantiomeric forms. Both enantiomers of these pheromones were synthesized, ensuring biological evaluation of the isomers.^{13,14} The biologically active isomers were (1*R*, 5*S*, 7*R*)-(+)-*exo*-brevicommin **6** and (1*S*, 5*R*)-(-)-frontalin **8**.¹⁵ In these cases only one enantiomer of the two optical isomers possesses pheromone activity.

Sulcatol is the aggregation pheromone produced by males of *Gnathotrichus sulcatus*.¹⁶ Both (+)-sulcatol[(*S*)-**9**] and (-)-isomer [(*R*)-**9**] were synthesized.¹⁷ Surprisingly, neither of them was biologically active. However, when combined to give a racemic mixture the synthetic sulcatol was more active than the natural pheromone, which was a mixture of 65% of (*S*)-**9** and 35% of (*R*)-**9**.¹⁸ This situation is somewhat similar to that encountered in the case of gossyplure and suggests the presence of enantiomer-specific active sites on receptor proteins in the same or different cells of *Gnathotrichus sulcatus*. These examples illustrate the importance of stereochemistry in pheromone researches.

The aim of this chapter is to provide a compilation of synthetic works on pheromones. As one of the major synthetic problems in this field is the stereoselective construction of olefinic linkages, Section 2 deals mainly with preparative methods for disubstituted olefins. Then synthesis of individual pheromones is detailed according to a classification based on the type of compound and functional groups present. As the trend in modern organic synthesis is to develop new methods for providing chiral molecules in a stereocontrolled manner, synthesis of chiral pheromones are treated comprehensively. It is hoped that this chapter will be useful not only to synthetic chemists but also to entomologists who wish to prepare pheromones of particular interest to them.

There are a number of monographs and reviews on pheromones. Especially noteworthy is the recent chapter on Insect Chemistry in *Annual Reports on the Progress of Chemistry*, which is a thorough survey on pheromone chemistry.^{19,20} Four reviews on pheromone synthesis are available: Katzenellenbogen's review focuses on the methodological point of view²¹; Henrick discusses selected pheromones (*Lepidoptera*, *Coleoptera*, and *Diptera*) in depth²²; and Rossi reviews the synthesis of both achiral²³ and chiral²⁴ pheromones. Aspects of pheromone chemistry is reviewed in Refs. 25-29. For those who are interested in pheromone biology and its application a plethora of monographs and reviews is available: e.g., Refs. 30-32 (general treatises) and Refs. 33-35 (insect behavior and the practical application of pheromones). Bark beetle pheromones are reviewed in Refs. 36-40. References 41 and 42 are concerned with the terpenoid pheromones, and Ref. 43 is a readable review on the pheromone receptor of moths.

2. GENERAL METHODS

Before the advent of pheromone and juvenile hormone chemistry the stereoselective construction of di- and trisubstituted olefins was of only limited interest to oil and terpene chemists. During the past decade the situation has changed, and we now have many ingenious new methods as well as modifications of older methods for olefin synthesis. References 44 and 45 are excellent reviews on the stereoselective synthesis of olefins. In this section reactions that have been used or may be useful in pheromone synthesis are presented. Synthetic methods for trisubstituted olefins are omitted, since they are the theme of another review on juvenile hormone synthesis.⁴⁶

A. Synthesis of (*E*)-Alkenes

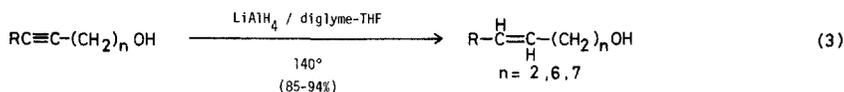
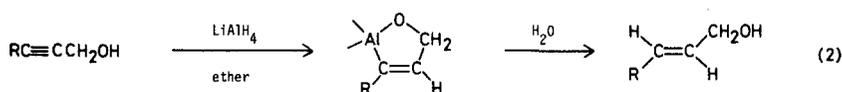
Metal-Ammonia Reduction of Alkynes

The reduction of alkynes with sodium in liquid ammonia is the standard method (Equation 1).⁴⁷ Warthen and Jacobson recommend the use of a large volume of liquid ammonia to minimize the recovery of the starting alkynes.⁴⁸



Lithium Aluminum Hydride Reduction of Alkynes

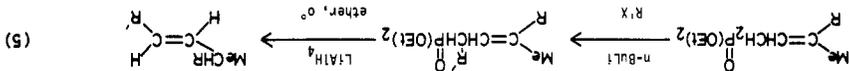
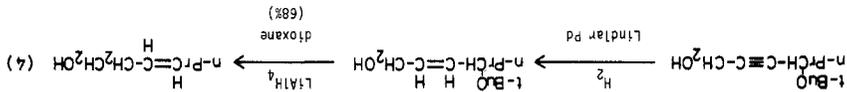
The reduction of 2-alkyn-1-ols to 2-alken-1-ols with lithium aluminum hydride in ether usually proceeds in an excellent yield (Equation 2).⁴⁹ Other alkynols such as 3-alkyn-1-ol, 7-alkyn-1-ol, and 8-alkyn-1-ol can also be reduced to the corresponding alkenols by reacting them at 140° for 48-55 h, under nitrogen, with a large excess of lithium aluminum hydride in a mixture of diglyme and tetrahydrofuran (Equation 3).⁵⁰



Reductive Elimination of Allylic Substituents

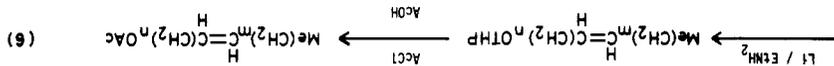
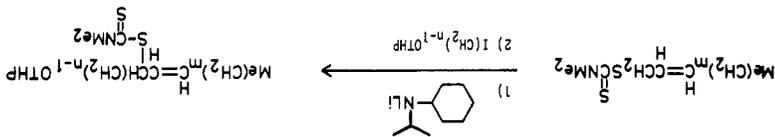
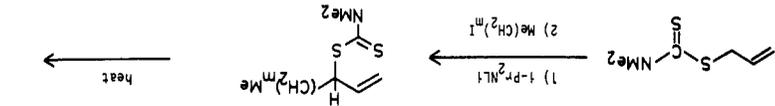
3-Alken-1-ols can be prepared from alkynes by the route shown in Equation 4. The key stereoselective step (97% *E*) is the reductive elimination of the allylic

t-butoxy group.⁵¹ A highly stereoselective synthesis of an (*E*)-alkene employs the reduction of a phosphonate ester as the key step (Equation 5).⁵² The yield is moderate to excellent.



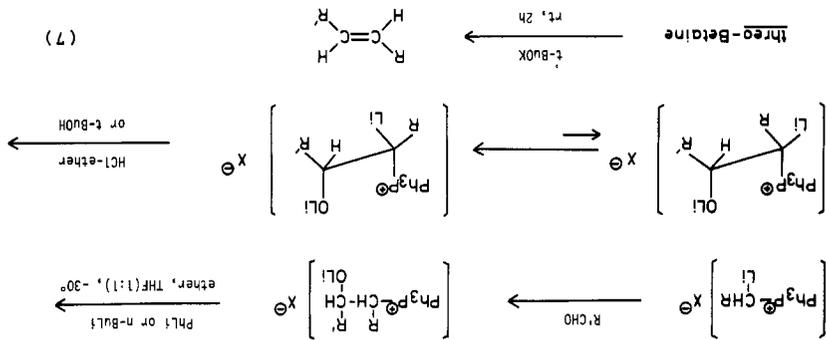
Rearrangement of Allylic Dithiocarbamates

The rearrangement of allylic dithiocarbamates is applicable to the synthesis of various alkenyl pheromones (Equation 6).⁵³ The yield is good to excellent.



The Wittig Reaction

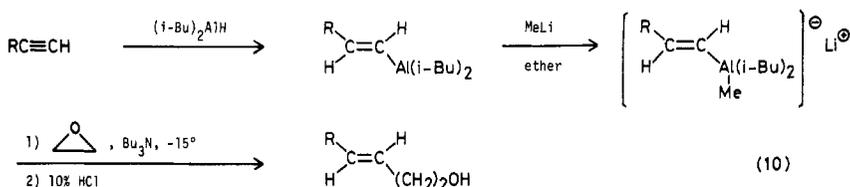
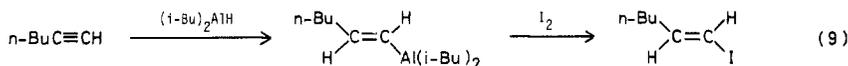
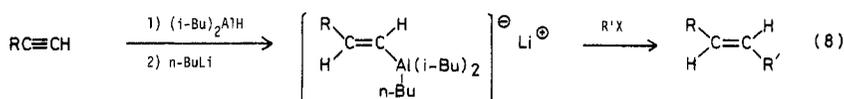
The Schlosser modification of the Wittig reaction as shown in Equation 7 gives an (*E*)-alkene in 60-72% yield with 90-96% stereoselectivity.⁵⁴⁻⁵⁶ For the stereochemistry of this reaction see Ref. 22, p. 1875.

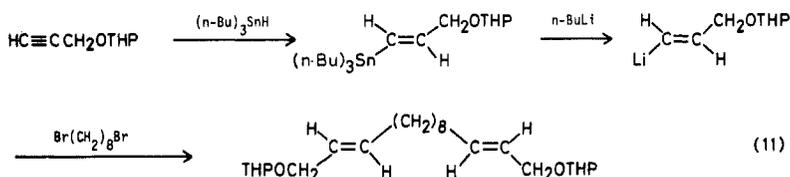
Utilization of Organoaluminum Compounds

Disubstituted (*E*)-alkenes can be prepared by the reaction of (*E*)-alkenyl trialkylaluminates with alkyl halides and sulfonates (Equation 8).⁵⁷ The yield is good (44-79%) for allylic halides and moderate (41-44%) for primary halides. Secondary and tertiary halides gave poor results. (*E*)-Vinyl iodides are obtainable in 94% stereoselectivity, as shown in Equation 9.⁵⁸ Reaction with lithium dialkylcuprate (R_2CuLi) converts the iodide to (*E*)-alkene. A vinylalane is converted to (*E*)-homoallylic alcohol in the yield of 81-88% (Equation 10).⁵⁹



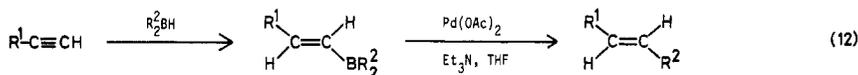
Utilization of Organotin Compounds

(*E*)-Allylic alcohols can be prepared from propargylic alcohol via an organotin compound (Equation 11).⁶⁰

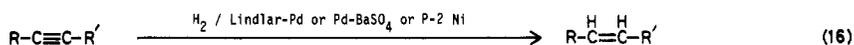


Utilization of Organoboranes

(*E*)-Alkenes are prepared by the reaction of boranes with palladium acetate (Equation 12).⁶¹ (*E, E*)-Conjugated dienes are obtainable via hydroboration (Equation 13).⁶²

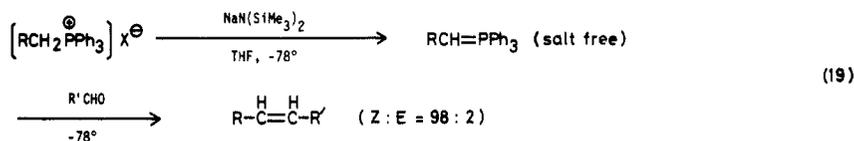
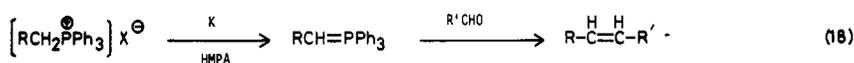
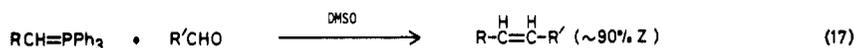

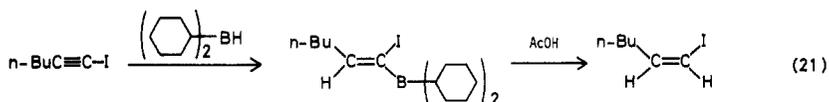
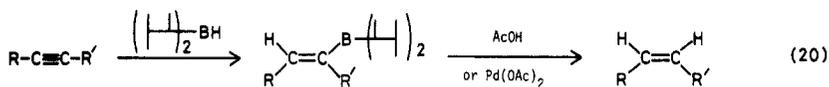
The Wittig Reaction

The Wittig olefination carried out in DMSO is known to give a (*Z*)-disubstituted alkene as the major product (Equation 17).^{71, 72} The use of potassium in HMPA as the base favors the (*Z*)-olefination (Equation 18).^{73, 74} The use of salt-free ylid solution is recommended for the preparation of (*Z*)-alkenes (Equation 19).⁷⁵ The stereochemistry of this reaction is discussed by Schlosser.⁵⁶



Utilization of Organoboranes

(*Z*)-Alkenes (98-99% *Z*) can be prepared from disubstituted alkynes by hydroboration-protonolysis (Equation 20).⁷⁶ The protonolysis is also achieved under neutral conditions by treatment with catalytic amounts of palladium acetate.⁷⁷ (*Z*)-Vinyl iodides are obtainable from iodoacetylenes by the same process (Equation 21).⁷⁸ They are convertible to (*Z*)-alkenes by treatment with organocopper reagents.

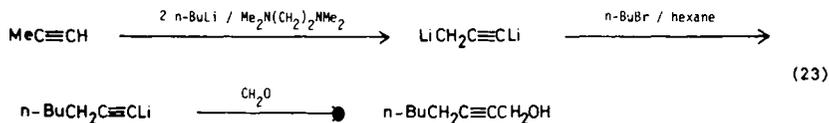
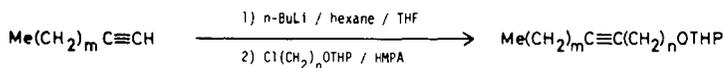
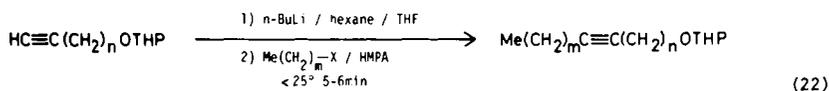


C. Carbon-Carbon Bond Formation

Alkylation of Alkynes

Alkylation of 1-alkynes gives disubstituted acetylenes, which are the starting materials for both (*E*)- and (*Z*)-alkenes. The traditional procedures are listed in Ref. 79. Recently a convenient and efficient procedure for the alkylation was

proposed independently by two groups (Equation 22).^{47,80} The procedure is particularly convenient for small-scale preparations. The yield is excellent if the alkylating agent is a primary and unbranched halide (see also Ref. 22; p. 1847.) An interesting 1,3-disubstitution reaction of 1,3-dilithiopropyne may be useful in pheromone synthesis (Equation 23).⁸¹



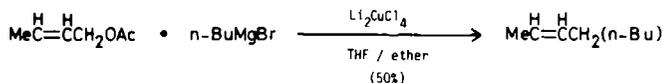
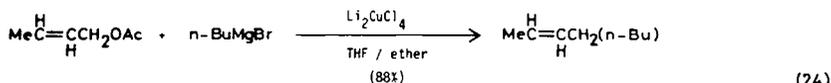
Coupling Reactions with Organometallic Reagents

An acetoxy group occupying the allylic position or a tosyloxy group can be replaced by the hydrocarbon moiety of a Grignard reagent. The replacement is regio- and stereoselective (Equation 24).⁸² The coupling of an (*E*)-terminal vinylolithium with an alkyl halide gives an (*E*)-alkene stereoselectively (Equation 25).⁸³

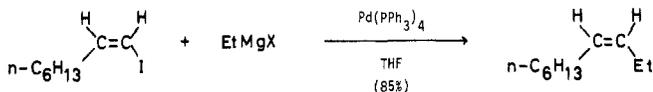
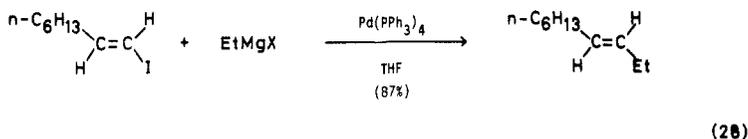
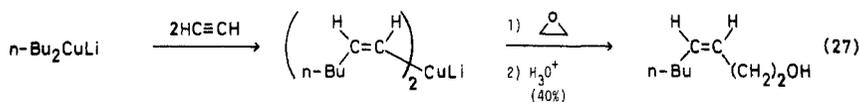
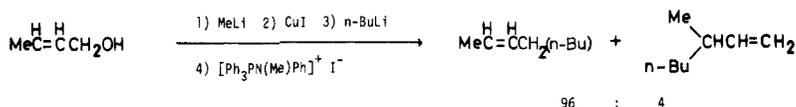
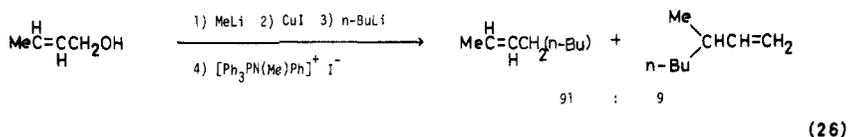
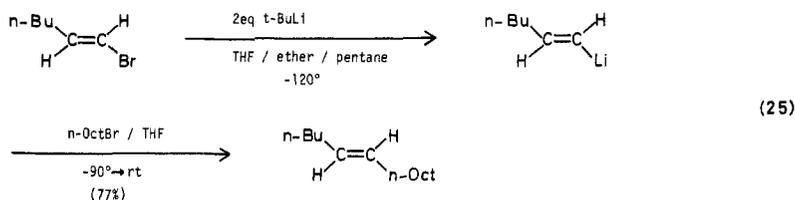
A new regio- and stereoselective olefin synthesis applicable to pheromone synthesis is direct substitution of hydroxyl groups of allyl alcohols with alkyl groups by the reaction of lithium allyloxyalkylcuprates with *N,N*-methylphenylaminotriphenylphosphonium iodide (Equation 26).⁸⁴ By this method both (*E*)- and (*Z*)-alkenes are obtainable.

(*Z*)-Alkenols can be prepared from (*Z*)-vinylic organocopper reagent in a moderate yield (Equation 27).⁸⁵

The palladium-catalyzed cross-coupling reactions of vinylic iodides with a variety of Grignard reagents occurs with retention of configuration (~97%) (Equation 28).⁸⁶



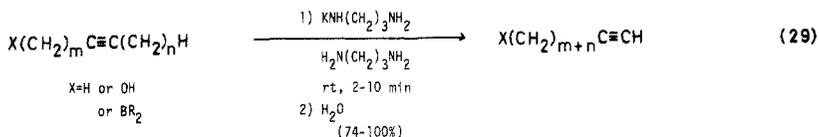

D. Other Useful Methods

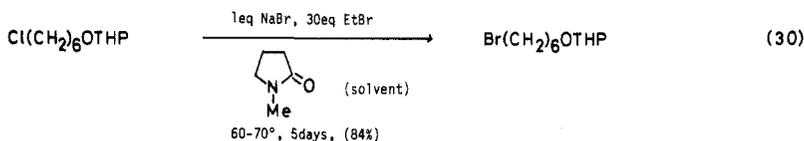
Multipositional Isomerization of Alkynes and Alkynols

Potassium 3-aminopropylamide (KAPA) is an exceptionally active catalyst for multipositional isomerization of alkynes and alkynols to terminal acetylenes (Equation 29).⁸⁷⁻⁸⁹ This is a convenient method to obtain 1-alkynes, popular starting materials for the *Lepidoptera* sex pheromones.



Conversion of Alkyl Chlorides to Bromides

For the alkylation of alkynes (Equations 22 and 23), alkyl chlorides are generally not so reactive. Therefore an efficient method is desirable for the conversion of alkyl chlorides to bromides. A new procedure employs ethyl bromide as the source of bromine (Equation 30).⁹⁰ The high volatility of ethyl chloride, the by-product, is the driving force for the completion of the reaction.



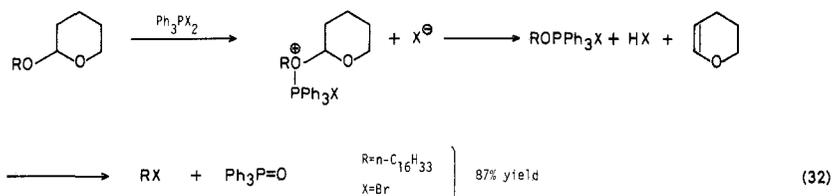
Conversion of Tetrahydropyranyl (THP) Ethers to Acetates

Many pheromones are acetates of long-chain alcohols. The THP group is the most commonly employed protecting group in the course of pheromone synthesis. The direct conversion of THP ethers into acetates can be achieved in 85-90% yield (Equation 31).⁴⁷



Conversion of THP Ethers to Bromides

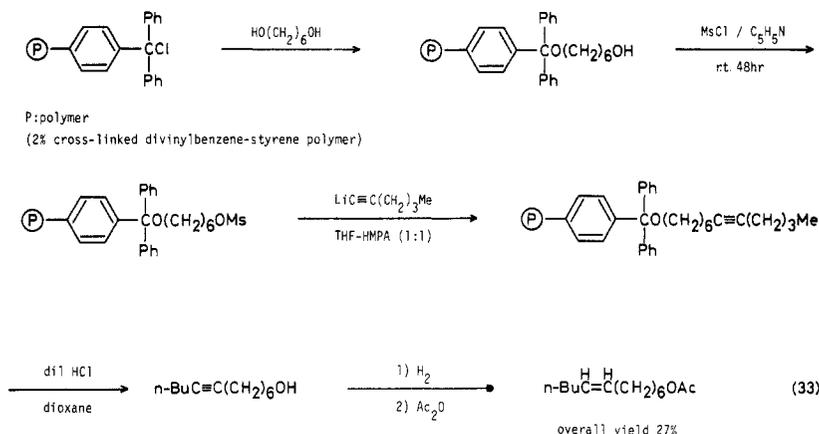
It is possible to carry out the direct conversion of THP ethers to halides (Equation 32).⁹¹



Solid-phase Synthesis

The application of solid-phase synthesis in the pheromone field has been reported by Leznoff (Equation 33).⁹²⁻⁹⁵ Solid-phase synthesis gives comparable or better overall yields than previous methods, uses inexpensive symmetrical diols as starting materials, and has the potential for being adapted to an automated procedure. It is questionable, however, whether this method is suitable for the large-scale preparation of pheromones required for field tests.

Separation of Geometrical Isomers by Formation of Urea Complexes

Mixtures of geometrical isomers can be conveniently separated on a large scale by the relatively inexpensive method of urea inclusion complex formation.⁴⁸² The recovery of both isomers from the separation procedure is almost quantitative. Urea inclusion complexes are formed preferentially with (*E*)-isomers. By applying this method of separation at a convenient stage, several insect phero-

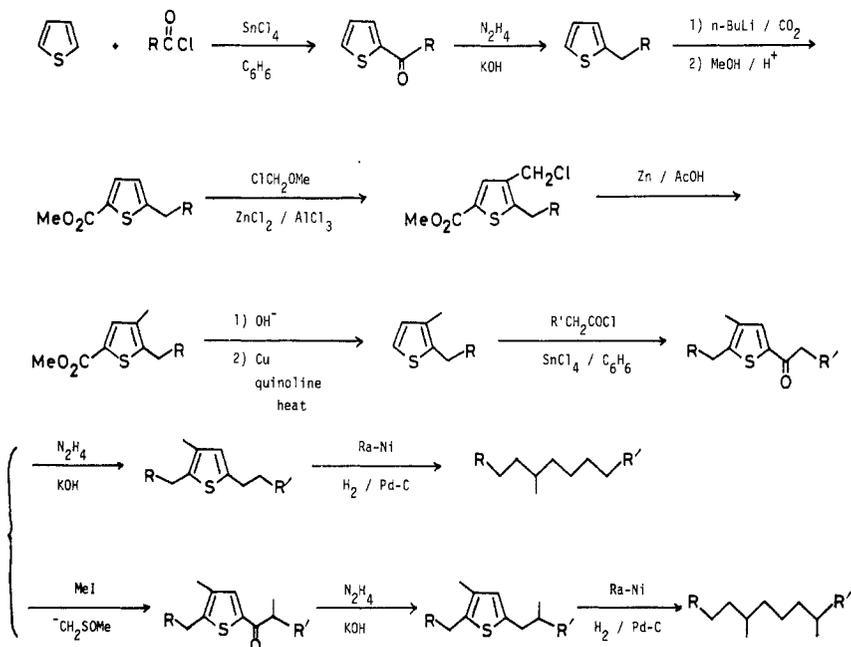

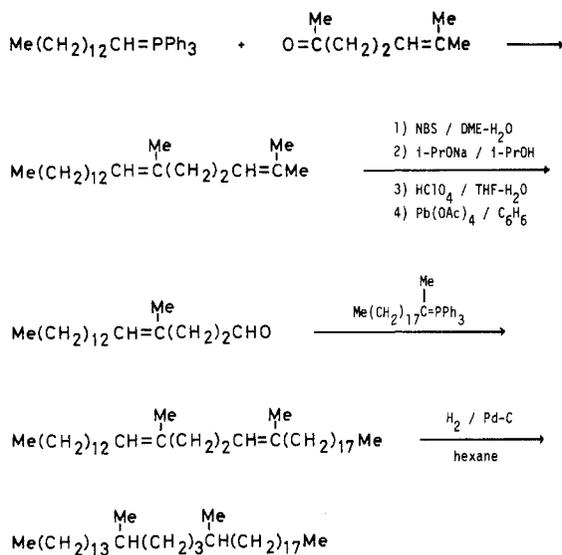
tritriacontanes showed the highest biological activity. The synthesis of 15-methyltritriacontane **10** and 15,19-dimethyltritriacontane **11** were carried out by the Wittig synthesis (Schemes 1 and 2).^{99,100} A general synthetic route to insect hydrocarbons is shown in Scheme 3, which employs thiophenes as intermediates.¹⁰¹ Optical isomers of these hydrocarbons are yet to be synthesized.

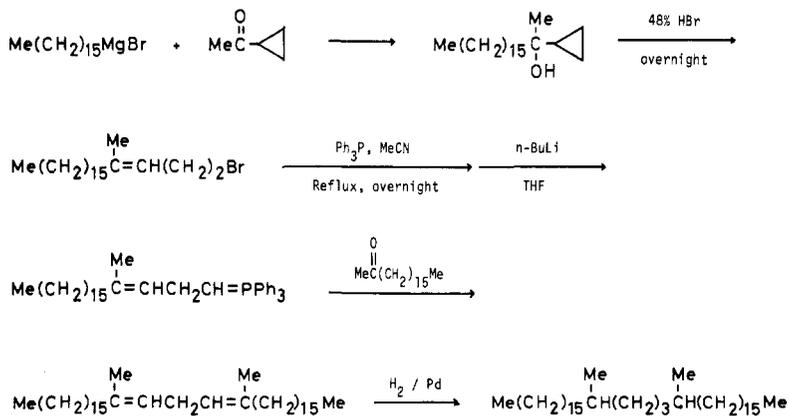
15,19-Dimethylheptatriacontane **12**, 17,21-Dimethylheptatriacontane **13**, and 15,19,23-Trimethylheptatriacontane **14**

These title hydrocarbons are the sex pheromones isolated from the cuticle of the female tsetse fly (*Glossina morsitans morsitans*), which is the major vector of Rhodesian sleeping sickness.¹⁰² The alkanes release mating behavior in the male fly at ultrashort range or on contact with baited decoys. The synthesis of 15,19-dimethylheptatriacontane **12** was carried out as shown in Scheme 4¹⁰⁰ or by a similar route as shown in Scheme 2. The synthesis of 17,21-dimethylheptatriacontane **13** is shown in Scheme 5.¹⁰² The Julia cyclopropane cleavage reaction was used here as well as in the case of the synthesis of 15,19,23-trimethylheptatriacontane **14** (Scheme 6).¹⁰² The trimethylalkane **14** released responses four times more often than **12** and 14 times more than **13**. No synthesis of the optically active forms of these hydrocarbons has been reported.

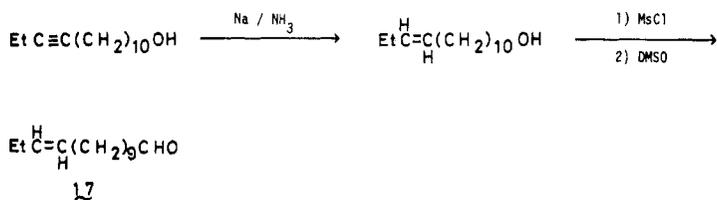

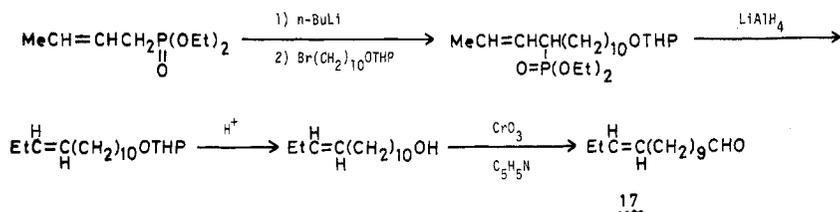

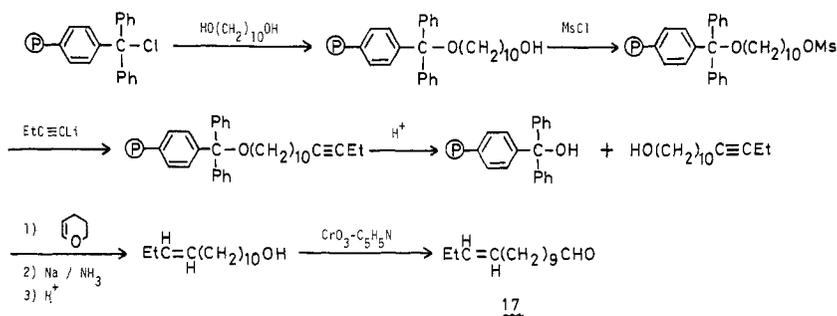
The eastern spruce budworm (*Choristoneura fumiferana*) uses this compound as its sex pheromone.¹⁰⁷ The original synthesis was based on acetylene chemistry (Scheme 9).¹⁰⁷ The second one employed the highly stereoselective phosphonate method (Scheme 10, see Equation 5).⁵² The third one is an application of the solid-phase synthesis (Scheme 11, see Equation 33).⁹⁵

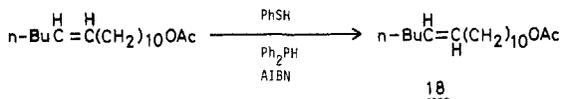

This is the sex pheromone produced by female sweet potato leaf folder moth, *Brachmia macroscopa*.¹⁰⁸ This alkene was synthesized by the inversion of olefin geometry of its (*Z*)-isomer obtainable by the conventional Wittig reaction

(Scheme 12).¹⁰⁸ The inversion was carried out by treating the (*Z*)-isomer with thiols and diphenylphosphine in the presence of azoisobutyronitrile.¹⁰⁹ The equilibrium mixture obtained by this method usually contains 75-80% of (*E*)-alkenes. The current methods of olefin inversion employ epoxides as intermediates.^{110, 111}

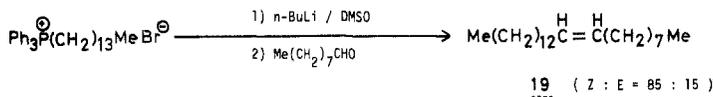

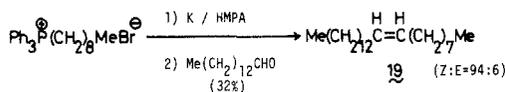

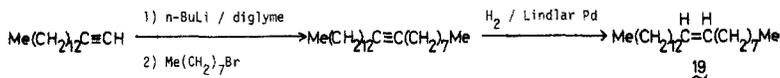
This is a sex pheromone isolated from the cuticle and feces of the female housefly (*Musca domestica*) and attracts the male fly.¹¹² The first synthesis was accomplished via a Wittig route (Scheme 13).¹¹² This Wittig synthesis was later modified, by using potassium in HMPA as the base, to give 94% of the (*Z*)-alkene plus 6% of its (*E*)-isomer (Scheme 14).⁷³ The second type of synthesis employs the Lindlar semihydrogenation of the alkyne (Scheme 15).¹¹³ The use of the naturally occurring erucic acid as the starting material yielded the pheromone only in two steps (Scheme 16), although the acid was rather expensive.¹¹⁴ Reaction of the methanesulfonate of erucyl alcohol with methylmagnesium



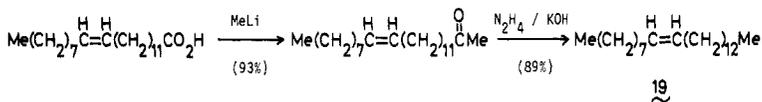

chloride in the presence of lithium tetrachlorocuprate gave muscalure in >90% yield (Scheme 17).¹¹⁵ Cheaper oleic acid was also converted to muscalure in several ways. A two-step synthesis similar to Scheme 16 is shown in Scheme 18.¹¹⁶ A mixed Kolbe electrolysis of oleic and *n*-heptanoic acids gave muscalure in 14% yield (Scheme 19)¹¹⁷ in a single step. A three-step synthesis similar to Scheme 18, but less direct, was recently reported and is shown in Scheme 20.¹¹⁸ The best procedure used to prepare 150-kg batches of muscalure by Zoecon Corporation is the coupling of oleyl bromide with 1.15 eq *n*-amylmagnesium bromide in THF in the presence of 0.03 eq lithium chlorocuprate. The yield is reported to be nearly quantitative (Scheme 21).¹¹⁵

(*Z*)-14-Nonacosene 20

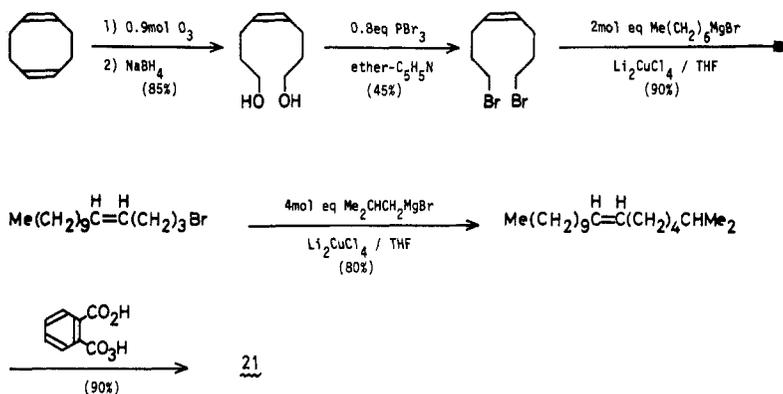
This is the most active component of the sex pheromones of the female face fly (*Musca autumnalis*) and effective for mating stimulation at short range.¹¹⁹ The synthesis was carried out either by the Wittig reaction in THF-HMPA (70% yield of **20** containing ~94-96% of the (*Z*)-isomer)¹¹⁹ or by the acetylene route (Scheme 22).¹²⁰



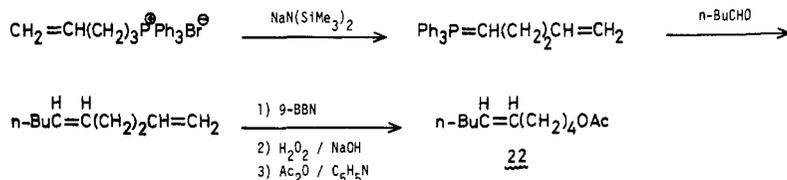

Disparlure, (*Z*)-7,8-Epoxy-2-methyloctadecane 21

The gypsy moth (*Porthetria dispar*) is a serious despoiler of forests. The sex pheromone was extracted from 78,000 tips of the last two abdominal segments of female moths and shown to be an epoxide **21**.¹²¹ The olefinic precursor, (*Z*)-2-methyl-7-octadecene, is present in the female sex pheromone gland of the gypsy moth¹²¹ and inhibits male attraction to disparlure.¹²² As little as 2 pg of **21** was active in laboratory bioassay. The first synthesis employed the Wittig reaction (Scheme 23).¹²¹ The stereoselectivity of the reaction, however, was unsatisfactory, and the final product had to be purified by chromatography over silica gel-silver nitrate. A more stereoselective version of this Wittig synthesis was reported by Bestmann (Scheme 24).¹²³ Bestmann further improved the stereoselectivity to >98% by employing sodium bis(trimethylsilyl)amide as the base (Scheme 25).¹²⁴ Two syntheses were reported by Chan employing organosilicon intermediates. The earlier synthesis gave a 1 : 1 mixture of the *cis*- and *trans*-isomers of **21** (Scheme 26).¹²⁵ The later synthesis was based on the reac-

This is a sex attractant for the male turnip moth *Agrotis segetum*, a ubiquitous grain pest.¹³² A synthesis was carried out by a Wittig route (Scheme 31).¹³²

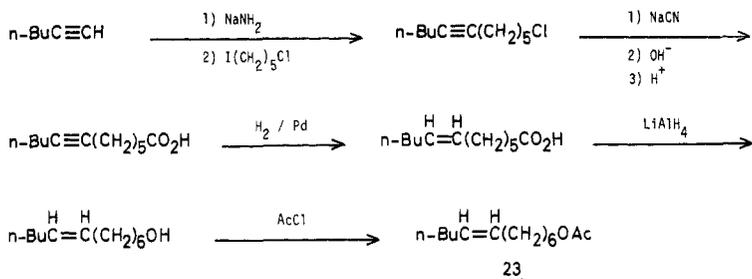
This is the pheromone of the cabbage looper (*Trichoplusia ni*).¹³³ The first synthesis is straight-forward via acetylenic intermediates (Scheme 32).¹³³ A synthesis by Schäfer et al. employed Kolbe electrolysis in the key step (Scheme 33).¹³⁴ Schäfer used ¹H- and ¹³C-NMR to determine the *Z/E* ratio of the key intermediate, 4-nonenoic acid. Useful information was obtained by the inspection of the ¹H-NMR spectrum of the acid in the presence of Eu(fod)₃. Its ¹³C-NMR, however, was more informative. The chemical shift value of C-6 was 27.13 for *Z* and 32.43 for *E* and that of C-3 was 22.55 for *Z* and 27.84 for *E*. The *Z* : *E* ratio was shown to be 4 : 1.¹³⁴

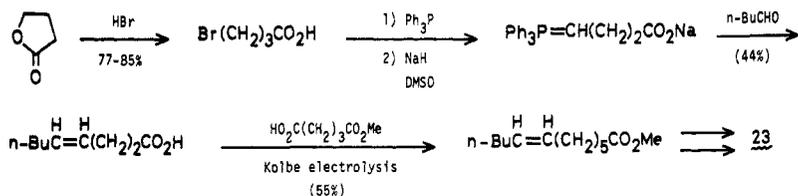

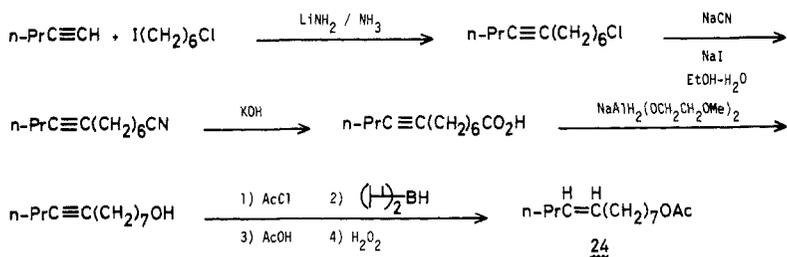
acetylenic routes.¹³⁵ A new version of the acetylenic route is shown in Scheme 34.¹³⁶ Another synthesis by an acetylenic route was recently reported by a Chinese group, who used palladium-calcium carbonate as the catalyst for partial hydrogenation.¹³⁷ A recent synthesis employed cyclohexane-1,3-dione as a C₆ synthon (Scheme 35).¹³⁸



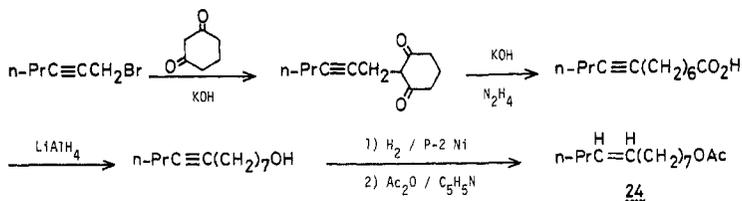

The first synthesis used methyl myristolate as the starting material (Scheme 39).¹⁴⁵ The second synthesis was based on conventional acetylene chemistry (Scheme 40),¹⁴⁷ and the third one was a partial synthesis from 23 (Scheme 41).¹⁴⁸ A Wittig synthesis was also reported (Scheme 42).¹⁴⁹



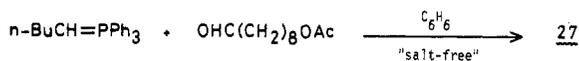

tion (Scheme 49).¹⁵⁷ The synthesis of optically active pheromones will be described later (Schemes 221 and 222).

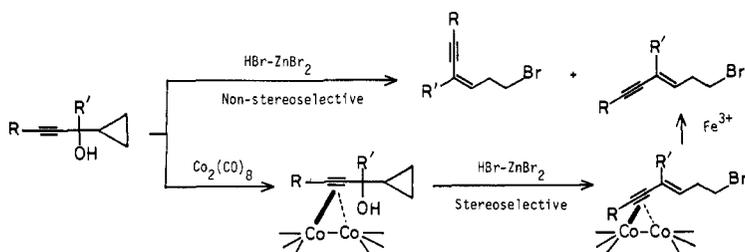

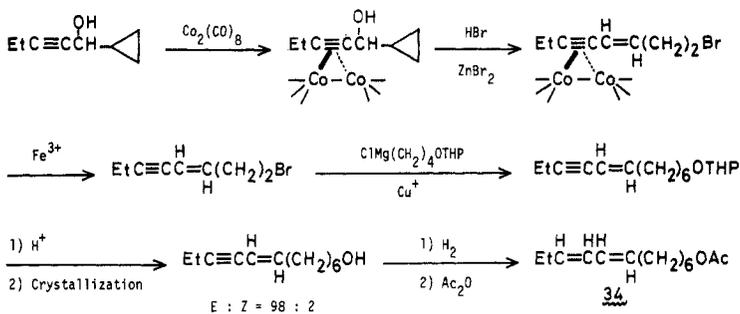
The sex pheromone of the grape vine moth (*Lobesia botrana*) was identified as 34.¹⁵⁸ The first synthesis by Roelofs is shown in Scheme 50.¹⁵⁸ A synthesis by Descoins involves a new method of stereoselective synthesis of a conjugated diene with *E, Z*-geometry. Dicobalt octacarbonyl was used as the protecting group for the triple bond.¹⁵⁹ The bulkiness of this protected acetylene makes the Julia cleavage of the cyclopropane ring stereoselective (Scheme 51).¹⁶⁰



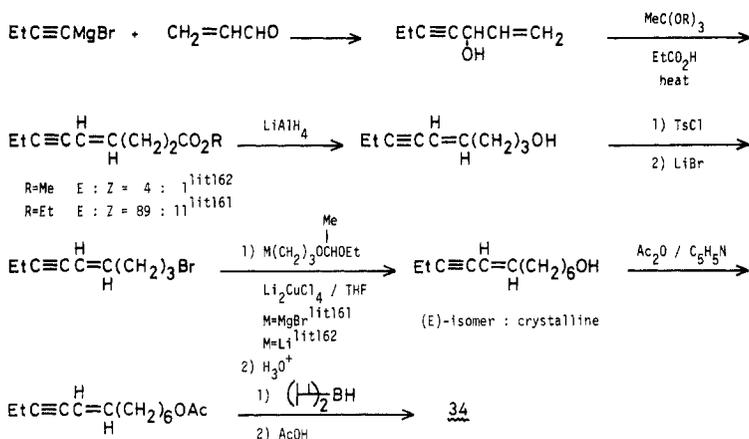

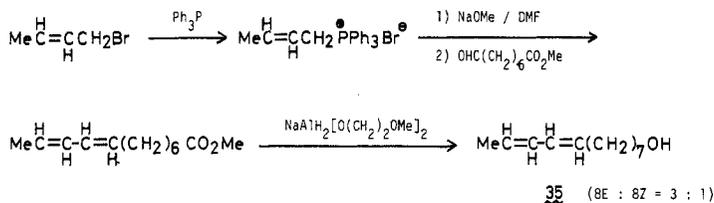
The synthesis based on this idea is shown in Scheme 52.¹⁶¹ A synthesis employing the orthoester Claisen rearrangement as the key step was reported by two groups (Scheme 53).^{161, 162} Organoborane chemistry was also applied in the synthesis of this pheromone (Scheme 54).¹⁶³ The acetylene "zipper" reaction was used in the first step to prepare the 1-alkyne (cf. Equation 29).¹⁶³ Recently a simple synthesis of an internal conjugated (*Z*)-enyne was reported, which might be useful in preparing the starting material for **34** (Scheme 55).¹⁶⁴ In this case the undesired (*E, E*)-isomer was easily removed by the formation of its Diels-Alder adduct with tetracyanoethylene in THF.

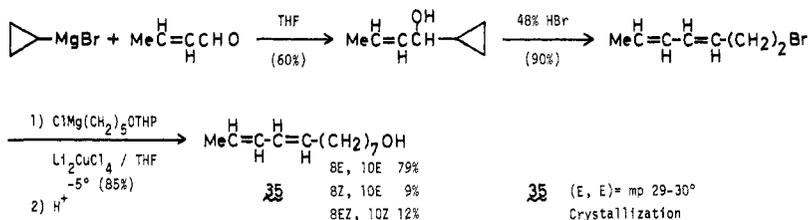

Roelofs et al. isolated this compound as the pheromone of the codling moth (*Laspeyresia pomonella*), a notorious pest of apple orchards.¹⁶⁵ The first synthesis used the Wittig reaction (Scheme 56),¹⁶⁵ and the later syntheses were all carried out by the Grignard coupling reaction. The first Zoecon synthesis was more stereoselective than Roelofs's synthesis, but employed rather inaccessible C₇ and C₅ synthons (Scheme 57).¹⁶⁶ However, the Zoecon group found that pure **35** is crystalline. This facilitated later work when it became possible to isolate pure **35** by recrystallization from pentane at low temperature. Then Mori used two readily accessible C₆ synthons in his synthesis to obtain crystalline



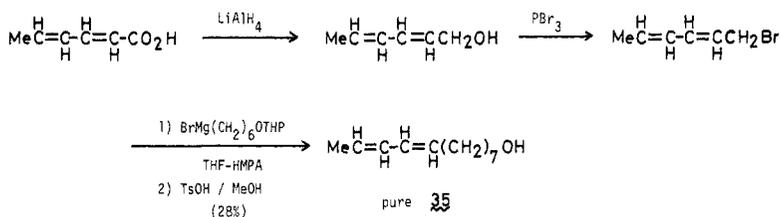

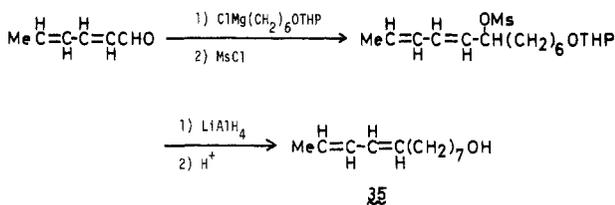

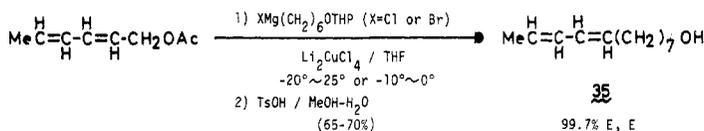
35. (Scheme 58).¹⁶⁷ Sorbic acid and hexamethylene glycol were the starting materials. The second Zoecon synthesis is shown in Scheme 59.¹⁶⁸ Recent syntheses, including the third Zoecon synthesis,¹⁶⁹ used sorbyl acetate as the starting material and were more efficient than any of the previous syntheses (Scheme 60).¹⁶⁹⁻¹⁷¹ The synthesis of **35** is discussed in detail by Henrick.²²

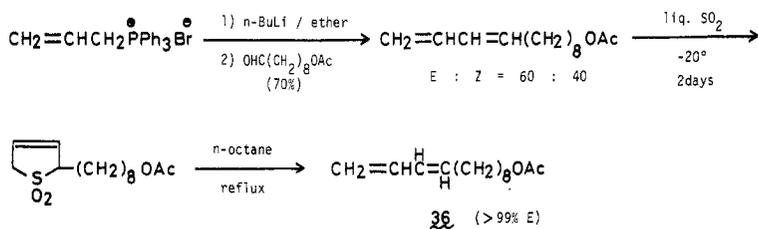

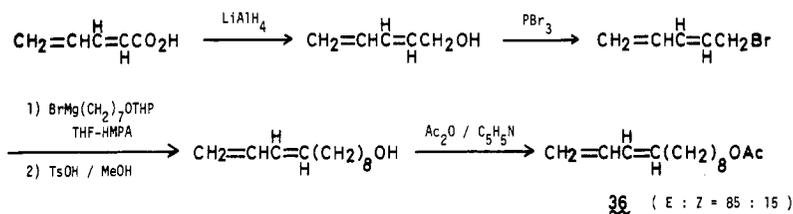

(E)-9,11-Dodecadien-1-yl Acetate 36

The red-bollworm moth (*Diparopsis castanea*) is a major cotton pest in south-eastern Africa. The most potent of the sex pheromones produced by the virgin female was shown to be (*E*)-9,11-dodecadien-1-yl acetate **36** by Nesbitt et al.¹⁷² The components of the pheromones are 9,11-dodecadien-1-yl acetate (*E* : *Z* = 80 : 20), (*E*)-9-dodecen-1-yl acetate, 11-dodecen-1-yl acetate, and dodecan-1-yl acetate. The first synthesis by Nesbitt et al. was accomplished by the Wittig route (Scheme 61).¹⁷³ The stereoselectivity of the olefination step was low (*E* : *Z* = 3 : 2). However, the desired (*E*)-isomer was converted to a sulfolene by treatment with liquid sulfur dioxide and separated as such from the unreacted

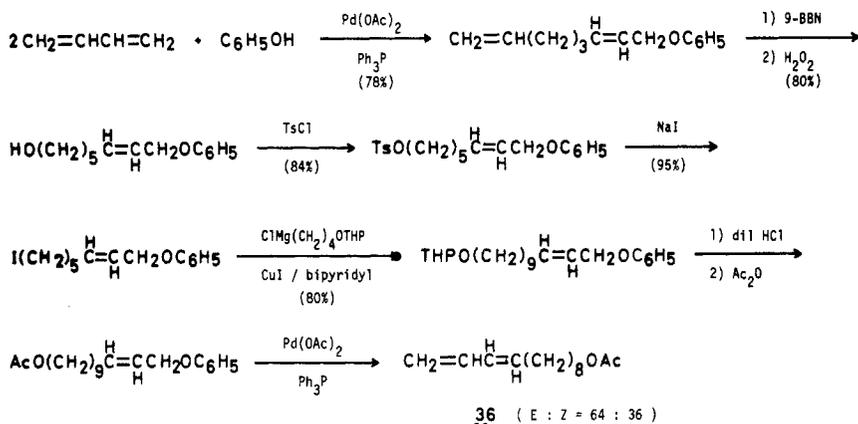

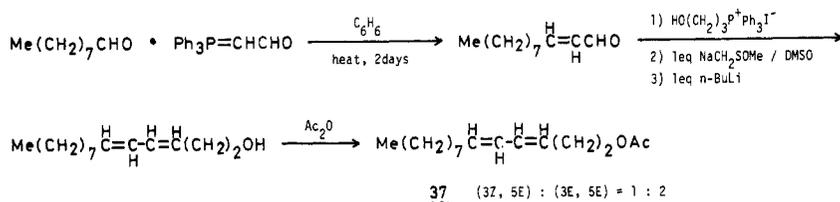
(*Z*)-isomer by chromatography over Florisil. The sulfolene gave back pure **36** on thermolysis. Mori's synthesis was based on the Grignard coupling reaction (Scheme 62).¹⁶⁷ Since the C₁₂-alcohol was an oil at room temperature, its purification was not so successful as in the case of the codling moth pheromone **35** and the yield as well as purity of **36** was not very high in this synthesis. The third synthesis by Yamamoto et al. was based on their new general method for the preparation of 1,3-dienes (Scheme 63).¹⁷⁴ The fourth synthesis by Babler employed the Wittig reaction, as shown in Scheme 64.¹⁷⁵ Recently Tsuji synthesized a mixture of **36** and its (*Z*)-isomer from butadiene, employing a palladium-catalyzed reaction (Scheme 65).¹⁷⁶

This is the sex attractant for the female carpenterworm moth (*Prionoxystus robiniae*).¹⁷⁷ The synthesis outlined in Scheme 66 yielded a 1 : 2 mixture of (3*Z*, 5*E*)- and (3*E*, 5*E*)-isomers, which were separated by GLC, HPLC, or spinning band distillation.¹⁷⁷ The Wittig reaction with (3-hydroxypropyl)triphenylphosphonium iodide was unsuccessful when 2 eq sodium hydride in DMSO was employed to generate the phosphorane. Use of 1 eq sodium hydride and 1 eq *n*-butyllithium was essential for the success.

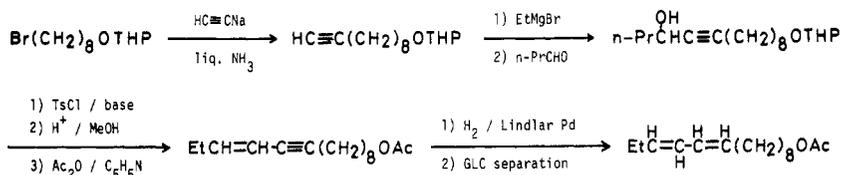

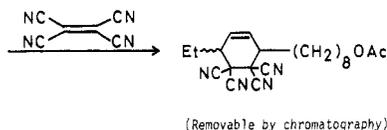
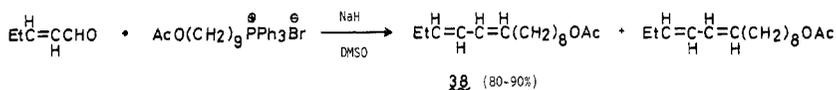
This compound is the major component of the sex pheromone of *Spodoptera litura*, a serious pest of vegetable crops in Japan.^{178, 179} It was also isolated from the Egyptian cotton leafworm (*Spodoptera littoralis*).¹⁸⁰ The first synthesis was nonstereoselective (Scheme 67).¹⁷⁸ The second synthesis was 80-90% stereoselective and carried out independently by two groups (Scheme 68).^{71, 72} The Wittig olefination in DMSO was used to generate the (*Z*)-olefin and the undesired (*E*, *E*)-diene was removed as a Diels-Alder adduct with tetracyanoethylene.

Another synthesis was accomplished by the acetylenic route (Scheme 69).¹⁸¹ Spinning band distillation of an isomeric mixture of hex-3-en-1-yne yielded pure (*E*)-enyne, which was converted to 38 with 98.7% purity containing 0.5% of the (*E*, *E*)-isomer.

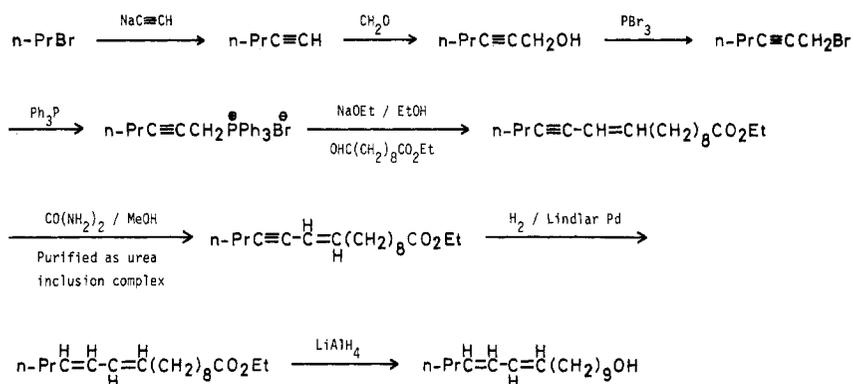

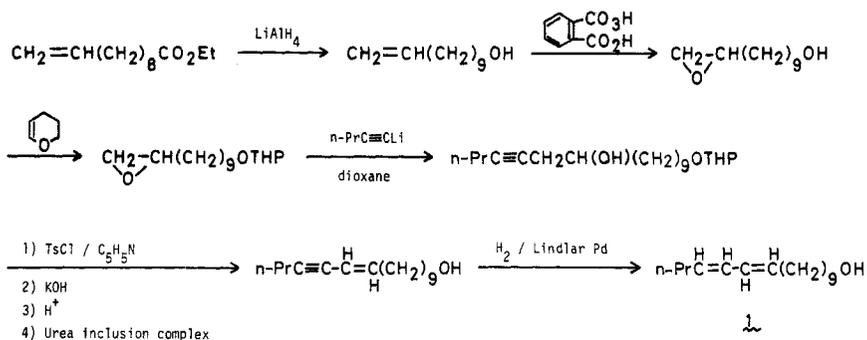

Bombykol, (10E, 12Z)-10,12-Hexadecadien-1-ol 1

The isolation¹⁸³ and structure elucidation¹⁸⁴ of bombykol were fully described in 1961. An earlier nonstereoselective synthesis was achieved by Butenandt et al.^{3,4} and by Truscheit and Eiter.⁵ The separations of the intermediates as shown in Schemes 71⁴, 72⁴, 73⁵, 74⁵, and 75⁵ enabled them to firmly establish

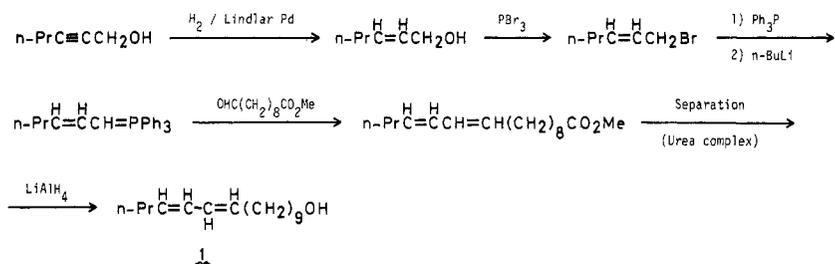

the structure of bombykol as **1** by comparing the pheromone activity of the geometrical isomers. Bestmann recently modified Eiter's Wittig route (Scheme 74) to achieve higher stereoselectivity (Scheme 76).¹⁸⁵ Organoborane chemistry was successfully applied in a recently reported stereoselective synthesis (Scheme



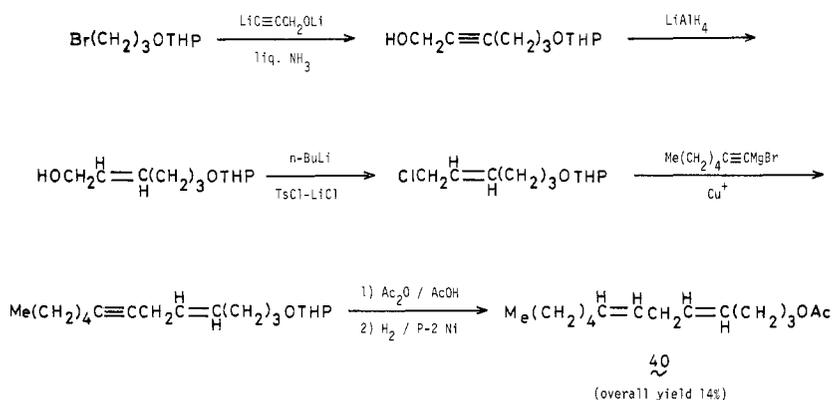

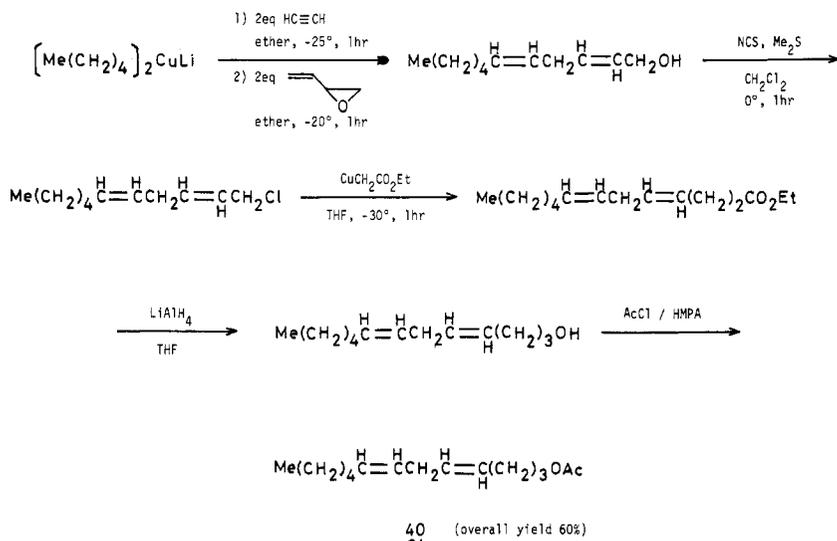

77).¹⁸⁶ Another stereoselective synthesis was based on organocopper and related carbanion chemistry (Scheme 78).¹⁸⁷ Various syntheses of bombykol are a reflection of the synthetic methodology available at the time of achievement. The most recent two syntheses are remarkable in their high stereoselectivities. In 1978 another pheromone of the silkworm moth was isolated and identified as bombykal (10E, 12Z)-10,12-hexadecadienal.¹⁸⁸ The composition of the silkworm moth pheromone was 92.8% bombykol and 7.2% bombykal.^{188a} Bombykal acts as an inhibitor against the action of bombykol.^{188b}

component of the pheromone of this insect was (*Z*)-9-tetradecen-1-yl acetate **27**. Later **41** was shown to be the pheromone of the almond moth (*Cadra cautella*), the Indian meal moth (*Plodia interpunctella*),^{193, 194} and several other insects. Jacobson's synthesis is shown in Scheme 82.¹⁹² Brady's synthesis started from 1,9-decadiyne as shown in Scheme 83.¹⁹⁵ Bestmann's synthesis was a combination of the Julia cyclopropane cleavage and the Wittig reaction (Scheme 84).¹⁹⁶ Bestmann recently synthesized the (*9E*, *12E*)-isomer of **41** by Kondo's phosphonate method (Equation 5) as shown in Scheme 85.¹⁹⁷

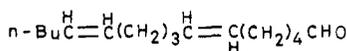

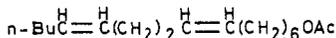
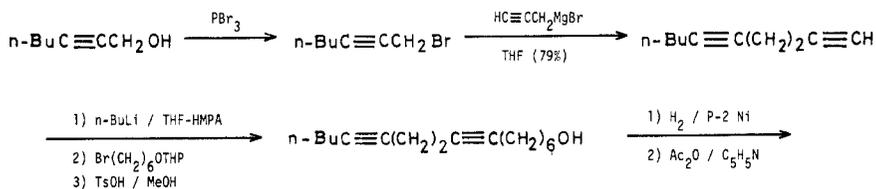
The pheromone produced by the female pink bollworm moth (*Pectinophora gossypiella*), a severe cotton pest in the United States, was studied for many years. It was erroneously assigned the structure (*E*)-10-*n*-propyl-5,9-tridecadien-1-yl acetate (propylure),²⁰⁰ and a number of syntheses were accomplished.²¹ However, in 1973 Hummel et al. identified it as a 1 : 1 mixture of 4 and 5 and named it gossypure.¹⁰ A synthesis reported by Bierl et al. was rather complicated and based on the coupling of two allylic halides to construct the carbon



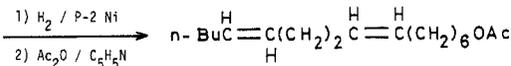
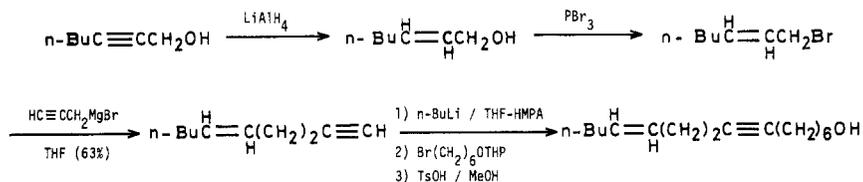

chain, which proved to be unsatisfactory.^{201a} Their paper, however, contains a lot of biological data. The second synthesis by Sonnet was stereoselective in synthesizing 4 but not so in preparing 5, as shown in Scheme 88.^{201b} An acetylenic route to 4 and 5 was devised by Su and Mahany²⁰² and later modified by Eiter et al. to give products with 95% purity (Scheme 89).²⁰³ ¹³C-NMR of 4,5 and other isomers of 7,11-hexadecadien-1-yl acetate was recorded by Eiter et al.²⁰³ Mori's synthesis was based on the Grignard coupling reaction and is highly stereoselective in preparing the both isomers (Scheme 90).²⁰⁴ The next two syntheses illustrate the two different strategies in employing the Wittig reaction. Bestmann et al. synthesized the two isomers separately by the stereoselective *Z*-olefination method developed by them (Scheme 91).²⁰⁵ Anderson and Henrick, however, directly obtained gossyplure by controlling the reaction conditions to give a 1 : 1 ratio of the two isomers 4 and 5 (Scheme 92).²⁰⁶ This is convenient for practical purposes. It is also interesting to note their utilization of 1,5-cyclooctadiene as a precursor of a *Z*-olefinic aldo ester. The synthesis of gossyplure

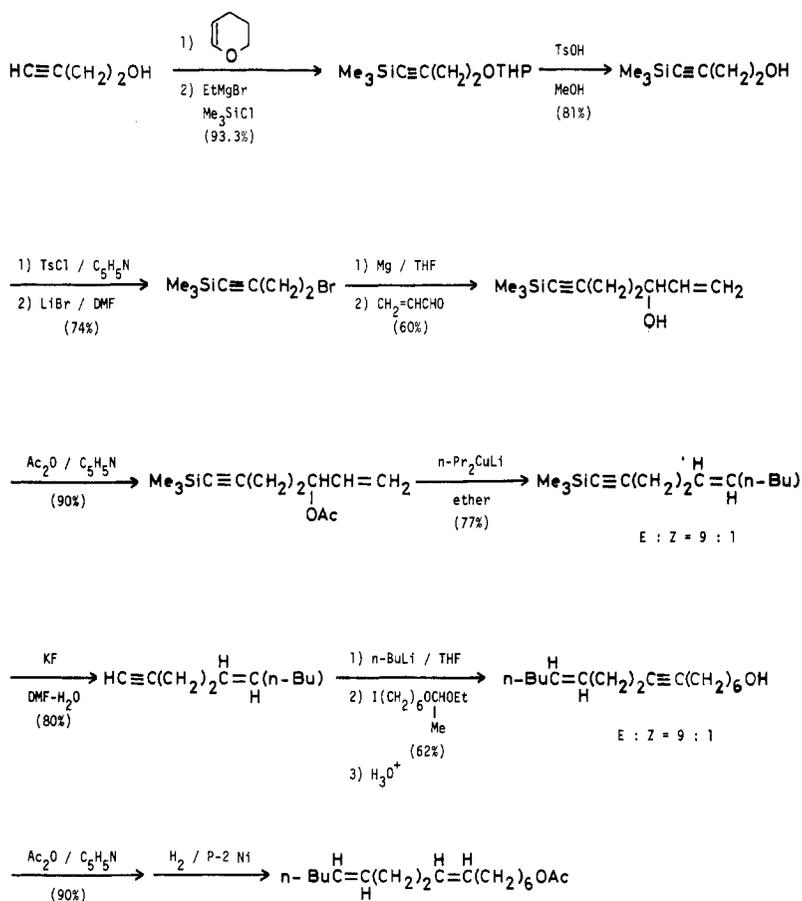

was discussed in detail by Henrick.²⁰⁷ (7Z, 11E)-Hexadecadien-1-yl acetate **5** was also isolated as the pheromone of the angoumois grain moth (*Sitotraga cerealella*) and synthesized by Hammoud and Descoins (Schemes 93 and 94).²⁰⁸ The stereoselectivity of the synthesis was ca. 90%.

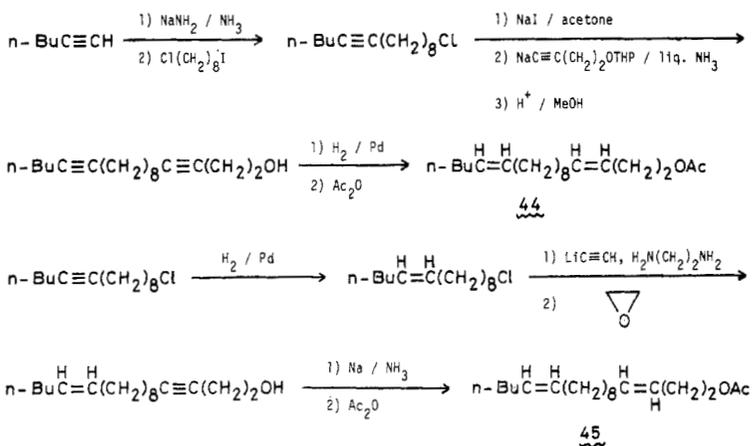

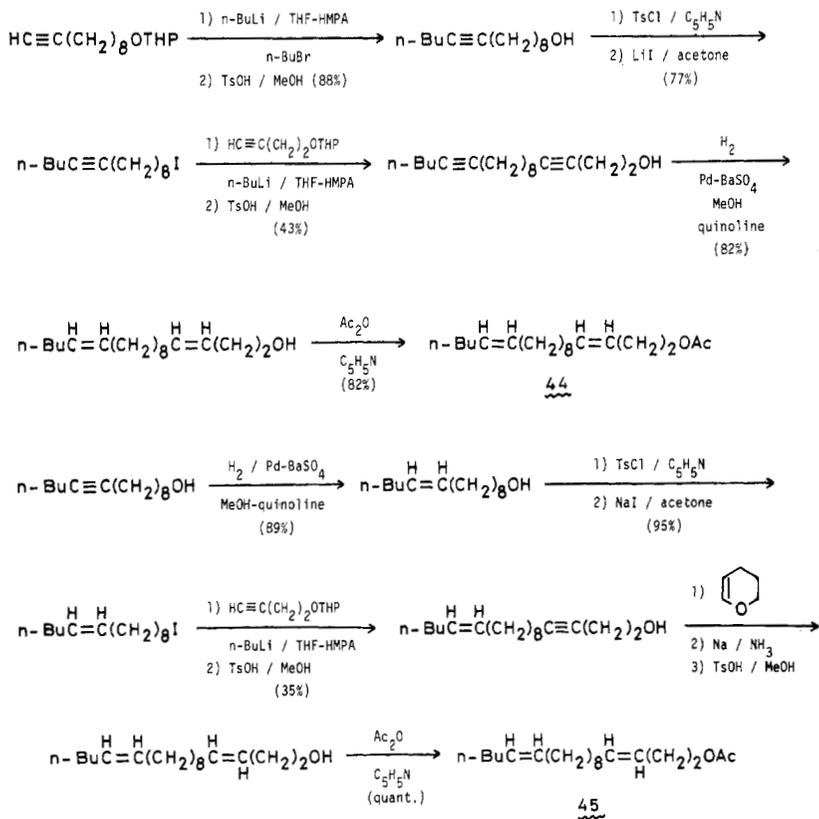

compounds are the largest molecules isolated thus far as pheromones of lepidopterous species. *S. exitiosa* males did not respond to the (3*E*, 13*Z*)-isomer and low concentrations of it in the (3*Z*, 13*Z*)-isomer did not interfere with their response to the (3*Z*, 13*Z*)-isomer. In contrast, even very low concentrations of the (3*Z*, 13*Z*)-isomer (1%) in the (3*E*, 13*Z*)-isomer significantly inhibited the response of *S. pictipes* males. Tumlinson's synthesis was carried out through the acetylenic route (Scheme 95).²⁰⁹ A modification of this synthesis was published recently (Scheme 96).²¹⁰ A 1 : 1 mixture of **44** and **45** were shown to be an effective trap bait for the male cherrytree borer (*Synanthedon Hector*), an economic pest in Japanese peach orchards.^{210, 211} Mori devised a convenient synthesis of the 1 :

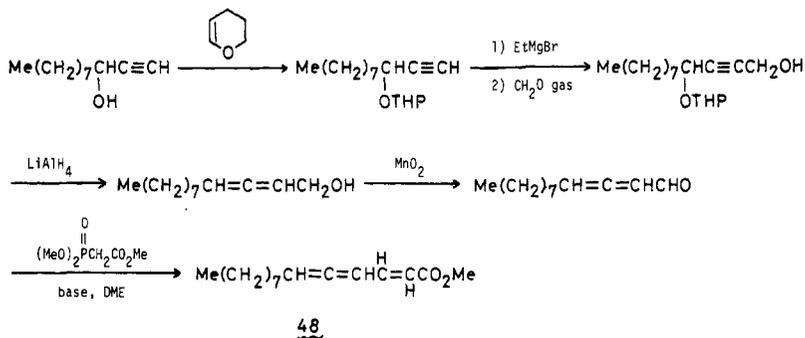

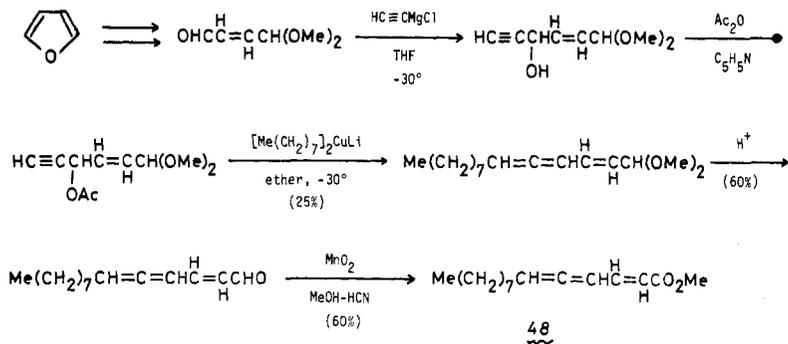
This is a component of the pheromone of the potato tuberworm moth (*Phthorimaea operculella*)^{190, 216} and was synthesized by an acetylenic route (Scheme 100).¹⁹⁰ For the synthesis of another component see Schemes 79 to 81.

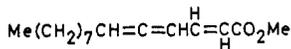
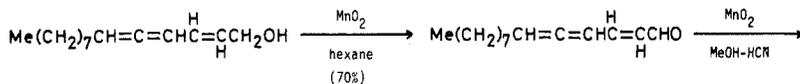
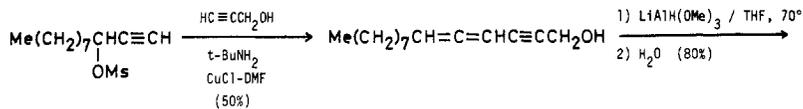
Horler isolated this (-)-allenic ester from the male dried bean beetle (*Acanthoscelides obtectus*) as a sex pheromone.²¹⁷ The unique structure 48 attracted attention of many synthetic chemists and several syntheses were reported. The key problem of the synthesis was, of course, the formation of the allenic system. The first synthesis was achieved by Landor employing a reductive elimination reaction to generate the allenic linkage (Scheme 101).²¹⁸ The second synthesis used the S_N2' substitution reaction at C-1 of a 3-acetoxy-1-alkyne with an organocopper reagent, as the key step (Scheme 102).²¹⁹ Gore's synthesis employed the coupling of two acetylenic units with concomitant elimination of a

mesyloxy group (Scheme 103).²²⁰ Linstrumelle employed organocopper chemistry (lithium diallenylcuprate) to achieve a simple synthesis of **48** (Scheme 104).²²¹ Orthoester Claisen rearrangement was also used to generate allene as shown in Scheme 105.²²² The synthesis of optically active forms of **48** are described in Schemes 262 and 263.

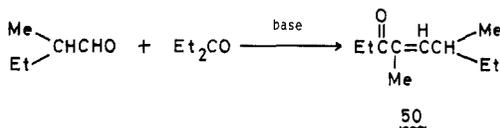

Although there are some aldehydes among insect pheromones, they are commercially available or easy to prepare. A synthesis of undecanal **49** was shown in Scheme 106.²²³ It is the pheromone produced by male greater wax moth (*Galleria mellonella*).²²⁴

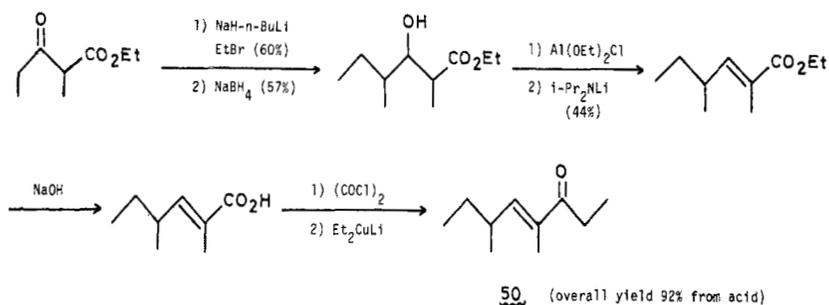

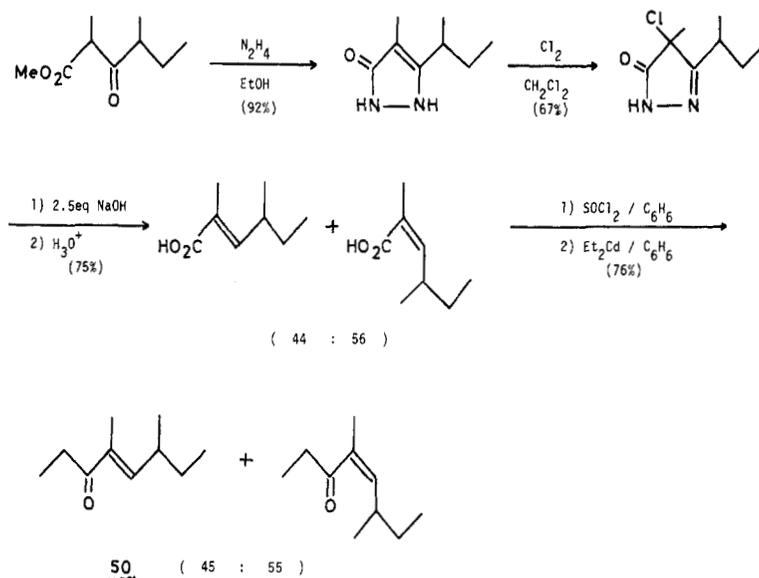
Manicone, (E)-4,6-Dimethyl-4-octen-3-one **50**

The alarm pheromones present in the mandibular glands of *Manica mutica* and *Manica bradleyi* are dominated by manicone **50** with two minor ketones, 4-methyl-3-hexanone and 3-decanone.²²⁵ The first synthesis of manicone was achieved by the conventional aldol condensation (Scheme 107).²²⁵ The second one was based on dianion and organocopper chemistry as shown in Scheme 108.²²⁶ In this synthesis the stereoselectivity of the olefin formation step was satisfactory. Another synthesis by Kocienski yielded a 45 : 55 mixture of **50** and its (*Z*)-isomer (Scheme 109).²²⁷ They were separated by preparative GLC.

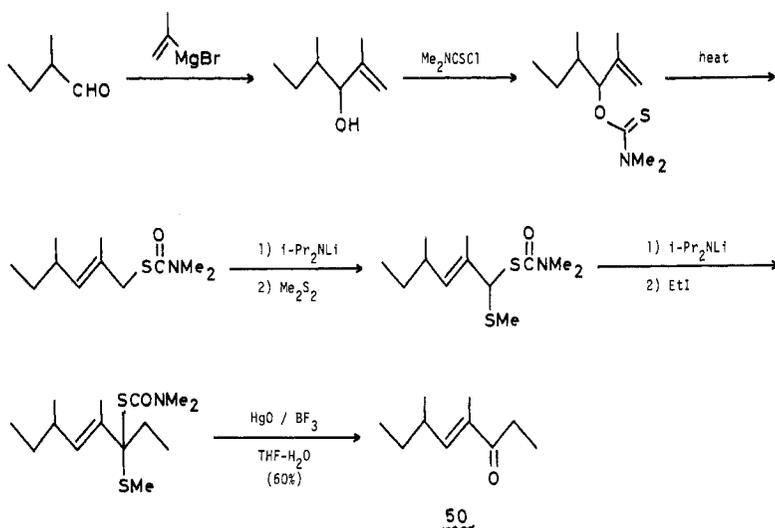

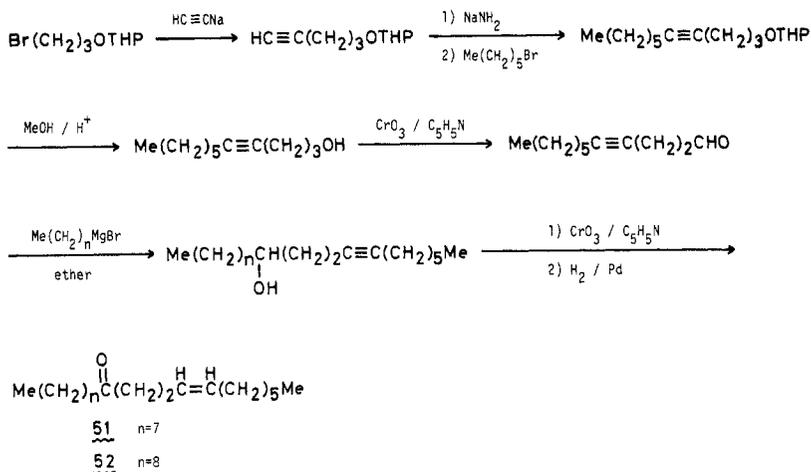
A recent synthesis by Nakai et al. employed the highly stereoselective [3,3] sigmatropic rearrangement of allylic thiocarbamates as the key step (Scheme 110).²²⁸

Tamaki et al. isolated and synthesized **51** and **52** as active components of the female sex pheromone of the peach fruit moth (*Carposina niponensis*), which



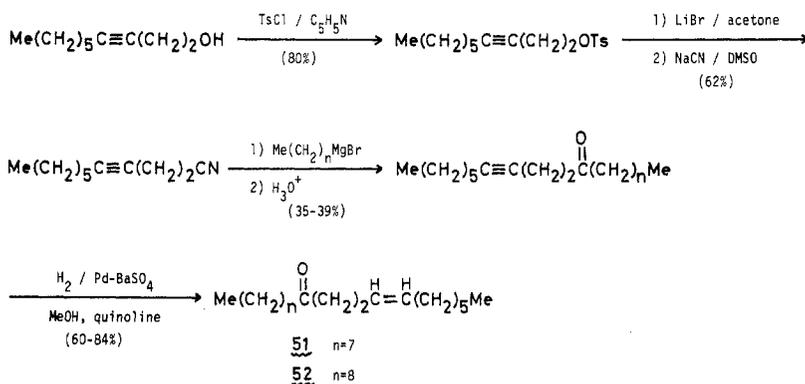

is a major economic pest of apple, peach, and other fruits in Japan.²²⁹ The synthesis is shown in Scheme 111.²²⁹ Another synthesis by Mori et al. employed commercially available 3-decyn-1-ol as the starting material (Scheme 112).²³⁰

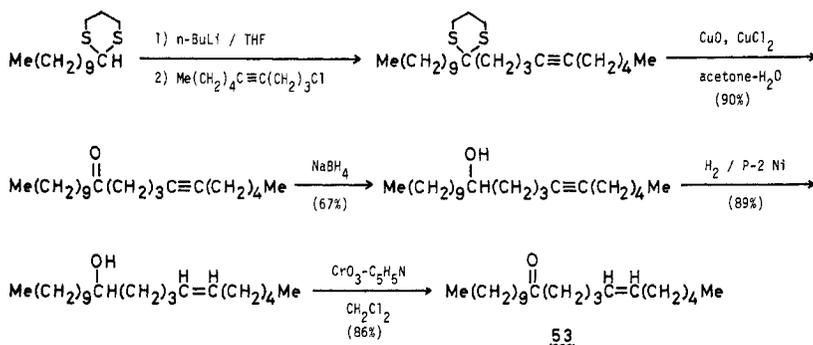

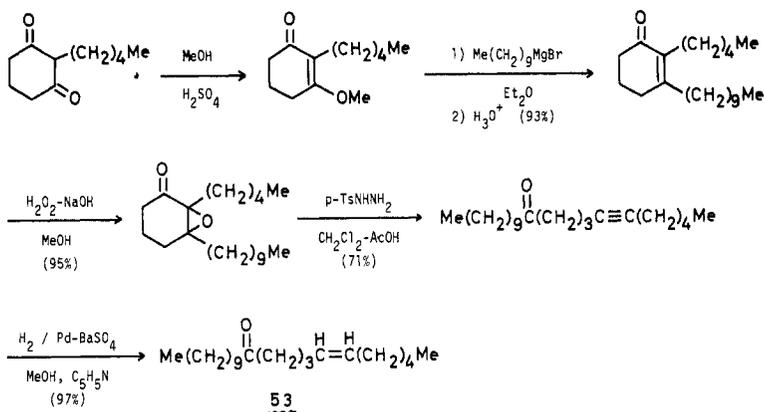

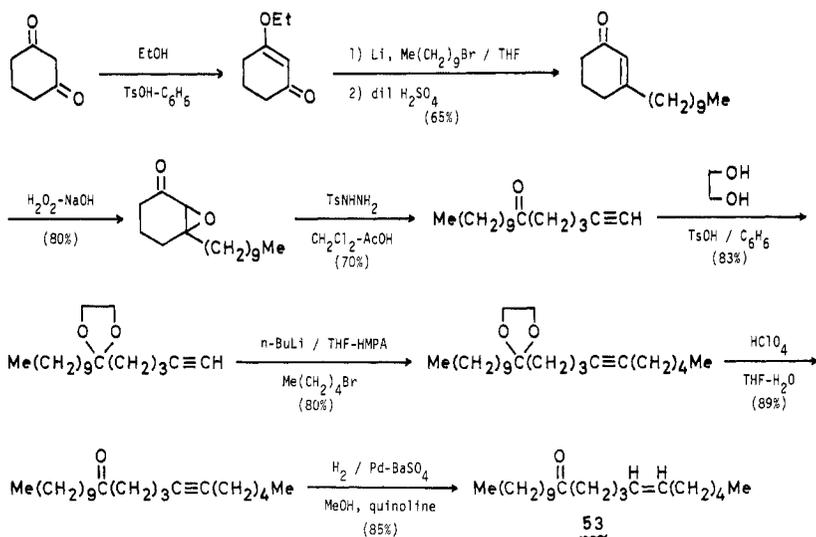
These are the principal (**53**) and minor (**54**) sex pheromone components of the Douglas fir tussock moth (*Orgyia pseudotsugata*), which is a severe defoliator of fir forests of western North America.^{231, 232} Many syntheses of **53** were reported. The synthesis of **53** by Smith et al. was based on the alkylation of a 1,3-dithiane (Scheme 113).²³³ Two independent syntheses of **53** used the Eschenmoser ring cleavage of an epoxy ketone as the key reaction (Schemes 114²³⁴ and 115¹³⁸). The Zoecon synthesis was achieved by an acetylenic route (Scheme 116).²³⁵ The alcoholic intermediates in this synthesis were both purified by crystallization from pentane at -35° . A synthesis by the Wittig route is shown in Scheme 117.²³⁶ The Raman spectrum (double bond stretching at 1652 cm^{-1} ; cf. $E = 1674$, $Z = 1658$) and ^{13}C -NMR spectrum (allylic carbons at 26.76 and 27.03 ppm) of **53** are discussed in Ref. 236. An interesting synthesis of **53** and its *E*-isomer was reported using the -ene reaction (Scheme 118).²³⁷ The steric

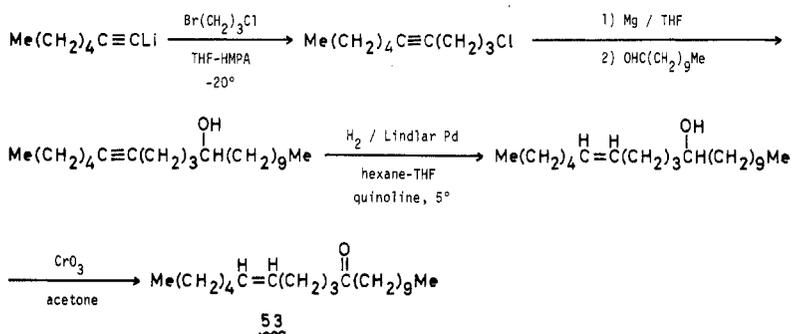

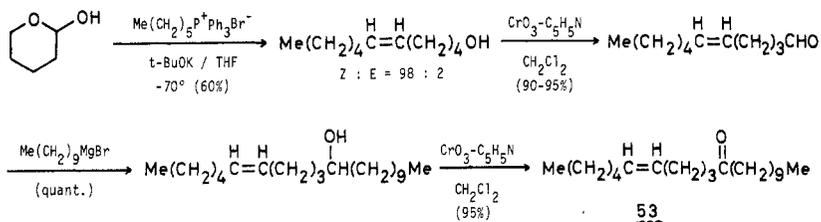

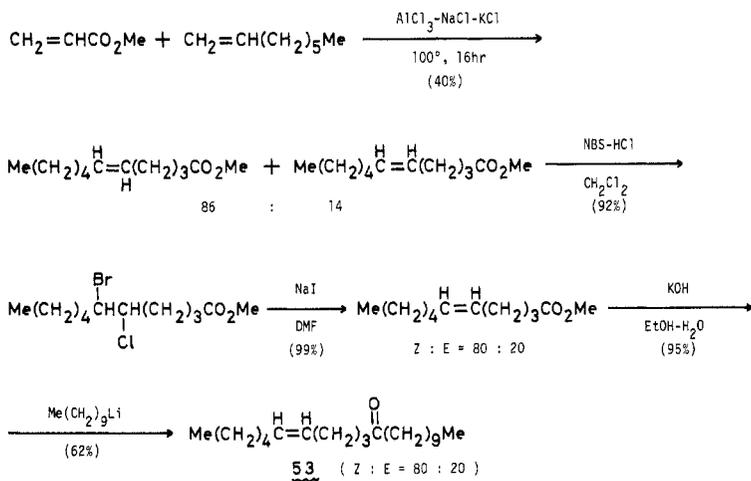
course of the -ene reaction between methyl acrylate and 1-octene, however, favored the formation of the undesired (*E*)-isomer (*E* : *Z* = 86 : 14). Therefore the olefin inversion reaction was necessary to obtain 53. In a recent synthesis undecanoyl chloride was reacted with a Grignard reagent prepared in a novel manner from an organoborane (Scheme 119).²³⁸ It should be mentioned that the pheromone of the southern armyworm moth (27) was also prepared by this new



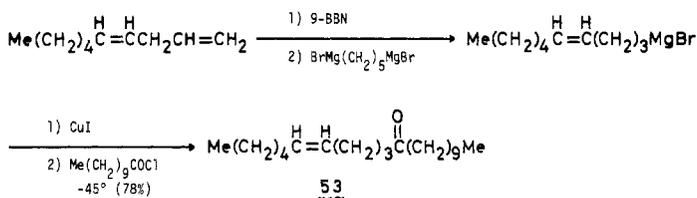

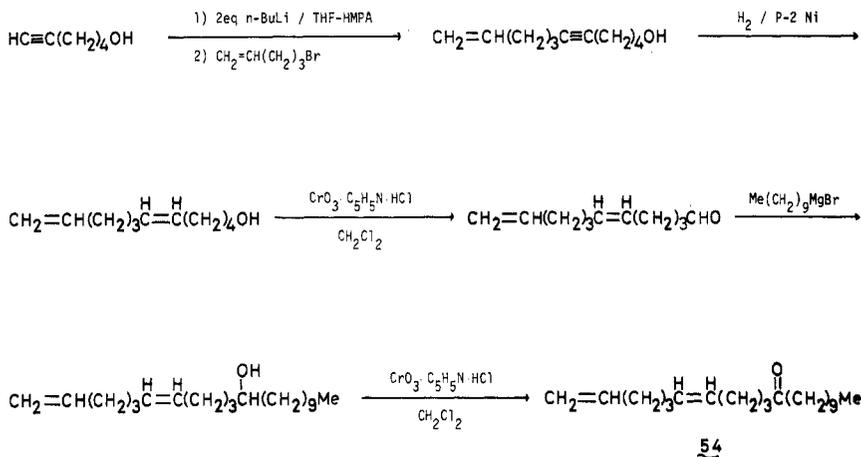

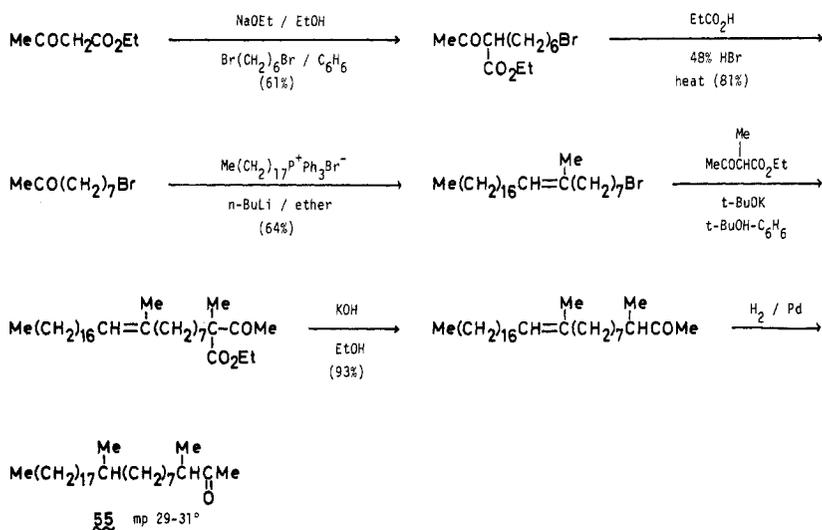

procedure, starting from an organoborane. (*Z*)-1,6-Heneicosadien-11-one **54**, another bioactive component of the pheromone, was synthesized as shown in Scheme 120.²³²

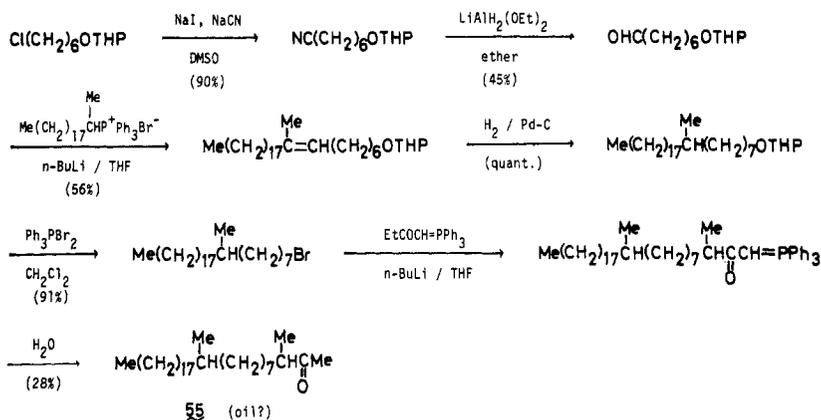

From the cuticular wax of sexually mature females of the German cockroach (*Blattella germanica*) Fukami et al. isolated **55** and **56** as the sex pheromone, which, on contact with antennae, elicited wing-raising and direction-turning response from the male adults at the first stage of their sequential courtship behavior.^{239, 240} Both **55** and **56** were synthesized in several ways as a mixture of all of the possible stereoisomers. The first synthesis of **55** by Fukami et al. is shown in Scheme 121.^{239, 241} The synthetic **55** melted at 29-31°, while the m.p. of the natural **55** was 44.0-45.5° with $[\alpha]_{\text{D}}^{22} + 5.1^\circ$ (*n*-hexane). Scheme 122 illustrates the synthesis by Schwarz et al.,²⁴² whose clever use of a stabilized ylid and

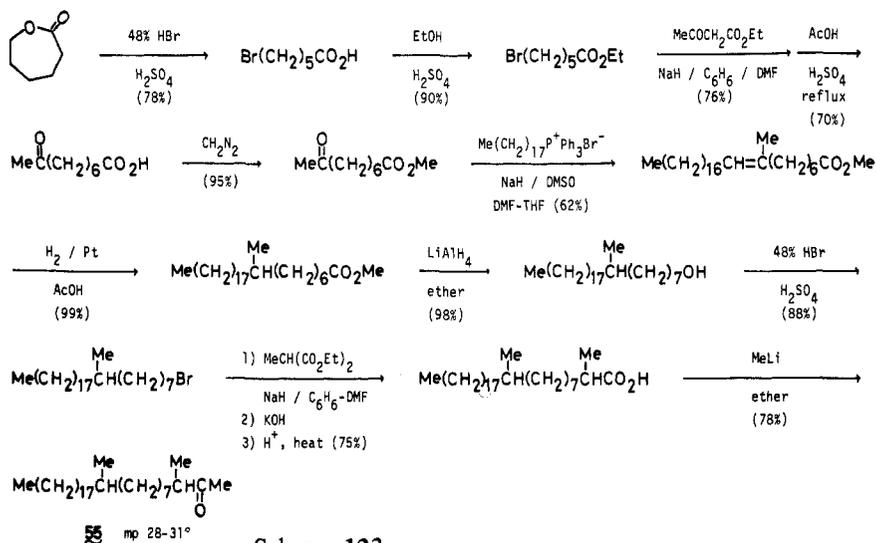

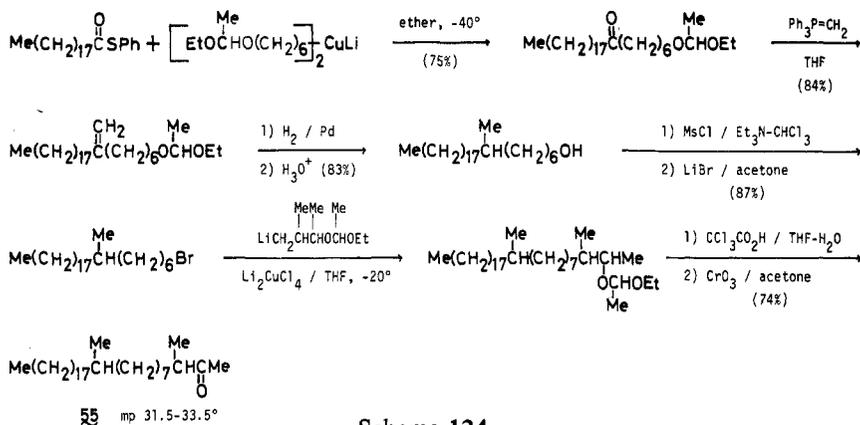

transformation of a THP ether to a bromide are noteworthy. The third synthesis by Burgstahler et al. is summarized in Scheme 123.²⁴³ Organocopper chemistry was applied to the synthesis of **55** by the Zoecon group (Scheme 124).²⁴⁴ A recent unique synthesis of **55** by Gore was based on the reaction of a vinylallenlic Grignard reagent and the Cope rearrangement, as shown in Scheme 125.²⁴⁵ A

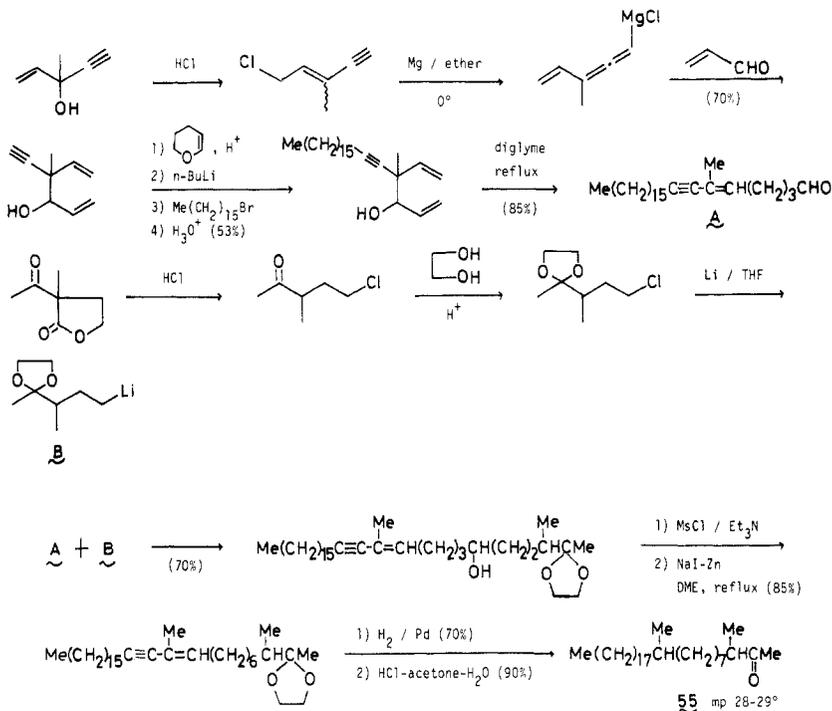

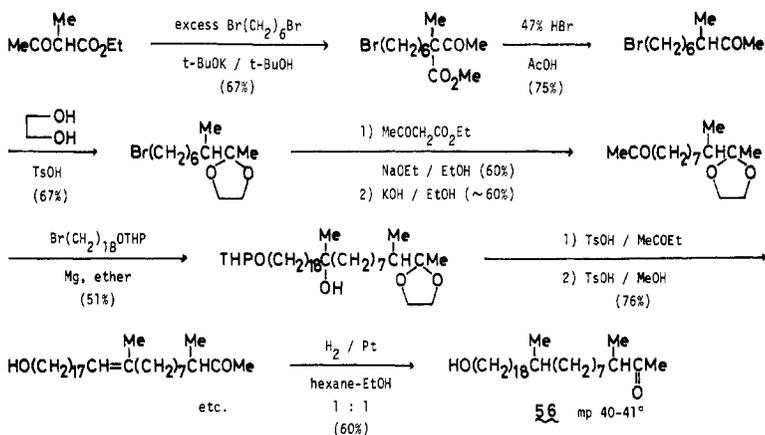

synthesis of a stereoisomeric mixture of **56** was achieved by Fukami et al. in a similar manner as that for **55** (Scheme 126).²⁴⁶ The synthetic **56** melted at 40-41°, while the m.p. of the natural **56** was 42-43°. 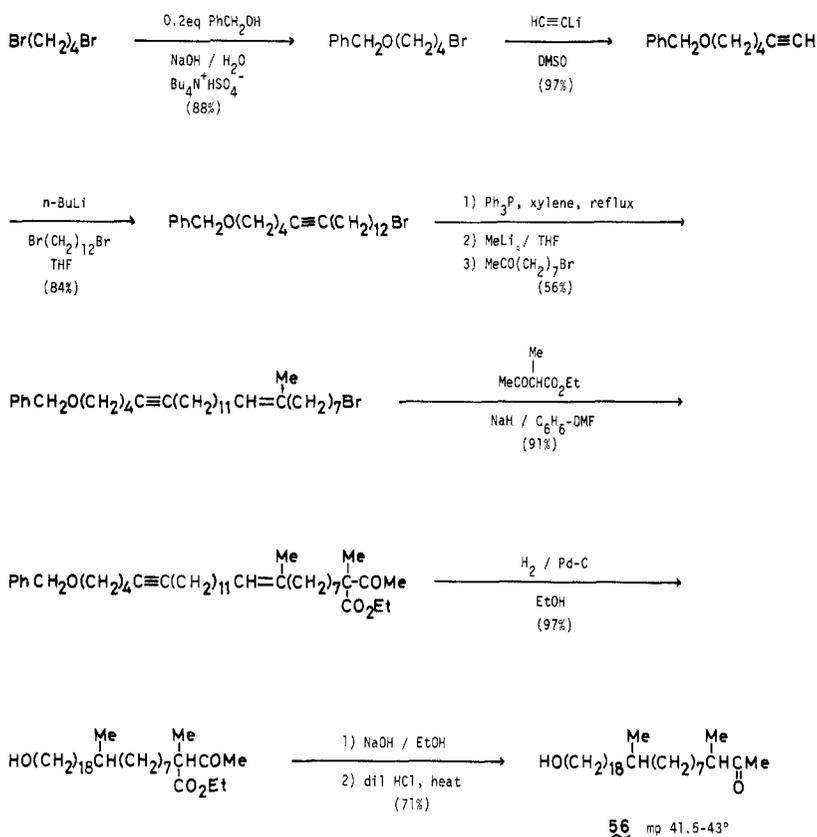

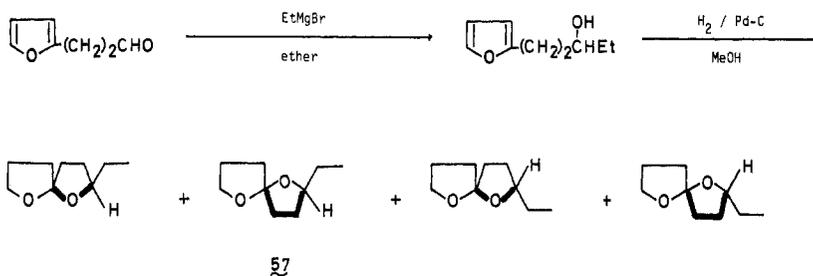

These ketal pheromones are dissymmetric. In this section the argument is restricted to the synthesis of racemates. For the synthesis of optically active compounds, see Section 15. A review is available on the chemistry of the 6,8-dioxabicyclo[3.2.1]octane series.²⁴⁸

Chalcogran, 2-Ethyl-1,6-dioxaspiro[4.4]nonane 57

This is the pheromone produced by male "Kupferstecher" (*Pityogenes chalcographus*).²⁴⁹ A stereoisomeric mixture of **57** was synthesized as shown in Scheme 128.²⁴⁹ The stereochemistry of the natural **57** is unknown.

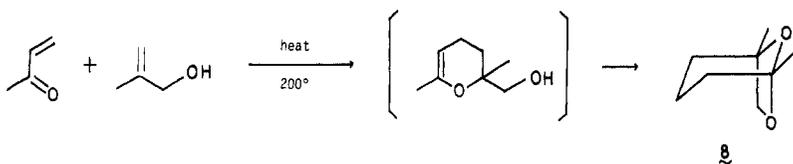

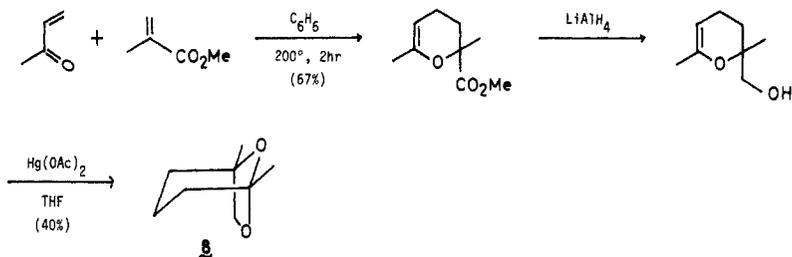

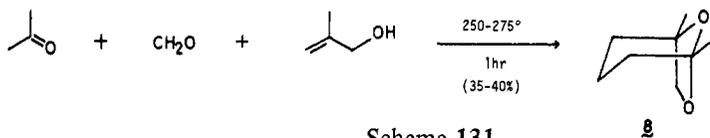
Extraction of about 6500 hindguts of the male western pine beetle (*Dendroctonus brevicomis*) led to the isolation of frontalin 8.²⁵⁰ The first synthesis by Kinzer et al. was based on the Diels-Alder reaction (Scheme 129).²⁵⁰ Mundy's synthesis also used the Diels-Alder reaction (Scheme 130).²⁵¹ D'Silva employed a similar approach (Scheme 131).²⁵² The fourth synthesis was a linear and



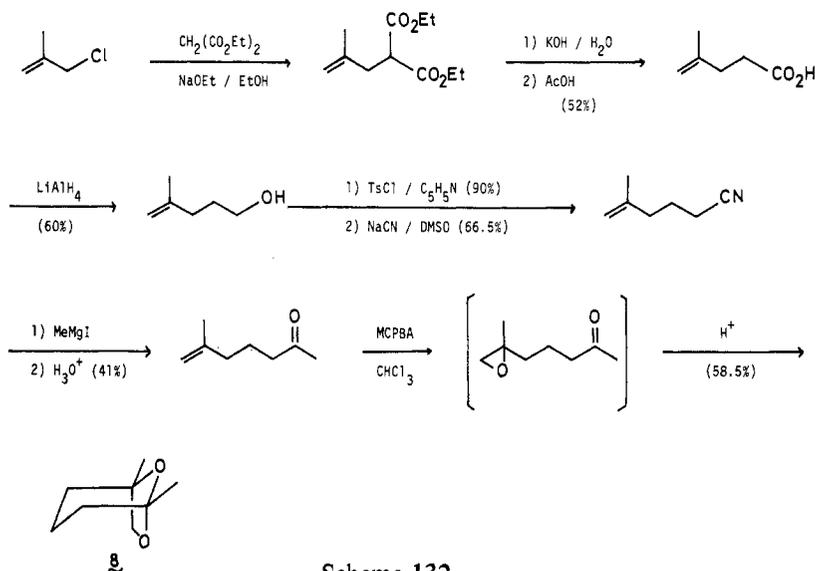

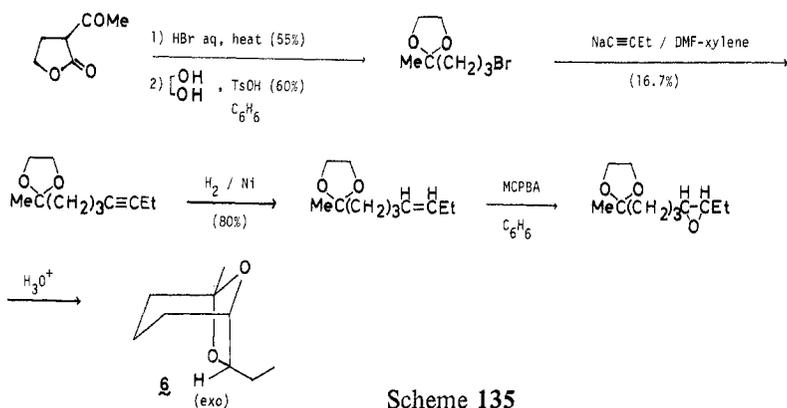
building-block-type approach (Scheme 132).²⁵³ Recently a unique photochemical synthesis of (\pm)-frontalin was reported by Sato et al. (Scheme 133).²⁵⁴ This is based on their findings that saturated ketones give 1,2-diols, accompanied in some cases by ketals as minor products, when irradiated in methanol with quartz-filtered light in the presence of titanium(IV) chloride (cf. Ref. 255).

***exo*-Brevicomin, *exo*-7-Ethyl-3-methyl-6,8-dioxabicyclo[3.2.1]octane 6**

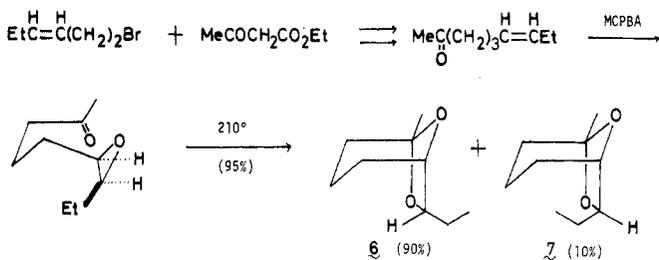
Silverstein et al. isolated *exo*-brevicomin **6** as the principal aggregation pheromone in the frass of the female western pine beetle (*Dendroctonus brevicomis*).¹¹ They achieved two different syntheses of its racemate (Schemes 134 and 135).²⁵⁶ One of them (Scheme 135) was stereoselective. Wasserman's synthesis employed a thermal rearrangement of an epoxy ketone as the key step (Scheme 136).²⁵⁷ A synthesis by Mundy et al. used the Diels-Alder reaction (Scheme 137).²⁵¹ A mixed Kolb  electrolysis reaction was used to prepare **6** in moderate yield (Scheme 138).²⁵⁸ In this synthesis, (*E*)-6-nonen-2-one, the key intermediate, was obtained pure only after GLC separation. Kocienski's synthesis was



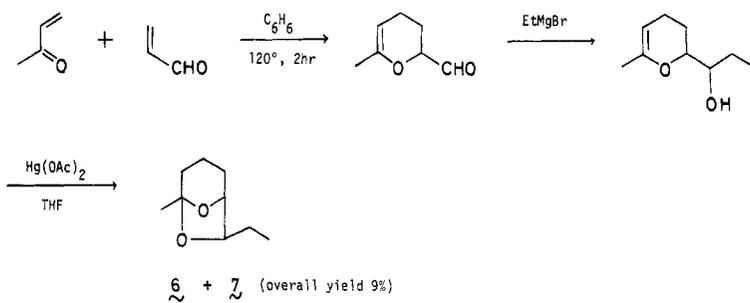

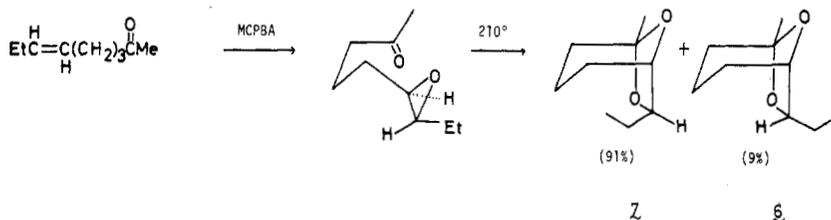
stereoselective and used the Eschenmoser fragmentation of an epoxy ketone as the key step (Scheme 139).²⁵⁹ Kossanyi devised an easy access to **6** by employing the Diels-Alder reaction and a photochemical reaction as shown in Scheme 140.²⁶⁰ A new fragmentation reaction of 3-chloro-2-cyclohexen-1-one was devised and used in a synthesis of **6** (Scheme 141).²⁶¹ The fragmentation (A \rightarrow B) involves the thermal cleavage of the intermediate alkoxide C.

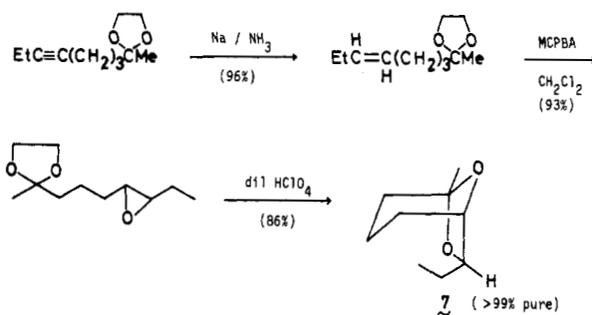

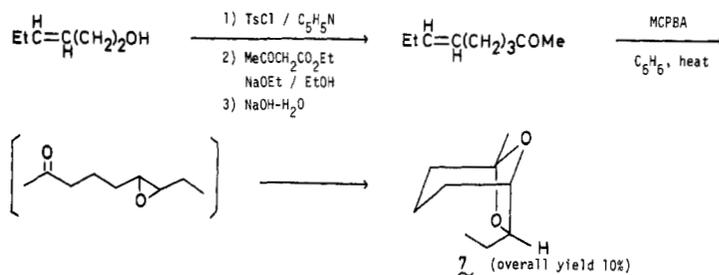
mer was a by-product of a nonstereoselective syntheses of *exo*-brevicomin.^{251, 256} Wasserman's thermal rearrangement of a *trans*-epoxy ketone was about 90% stereoselective to give **7** (Scheme 142).²⁵⁷ The recognition of this substance as a pheromone inhibitor, which may be useful as a pesticide, prompted synthetic work, and four stereoselective syntheses were reported. All of them employ the epoxidation of a pure (*E*)-olefinic ketone as the key step. Kocienski and Ostrow generated the (*E*)-olefin by the Birch reduction (Scheme 143).²⁵⁹ Look's synthesis employed a preformed (*E*)-olefinic alcohol as the starting material (Scheme 144).²⁶² An interesting synthesis based on organopalla-

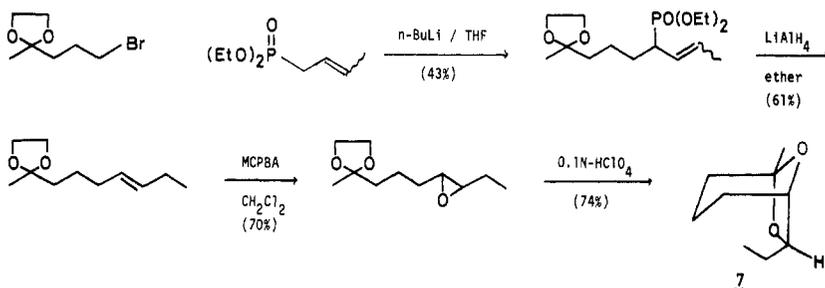
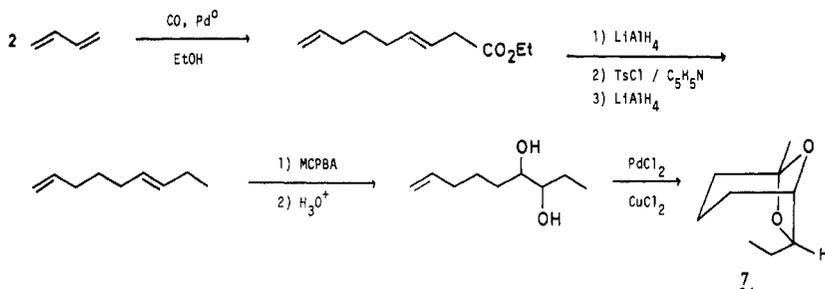

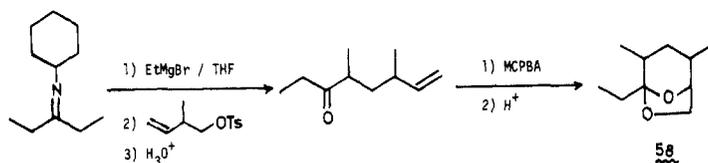

dium chemistry was reported by Byrom et al., in which an (*E*)-olefin was generated by the dimerization of butadiene (Scheme 145).²⁶³ Kondo's phosphonate method (Equation 5) was applied to obtain **7** (Scheme 146).²⁶⁴

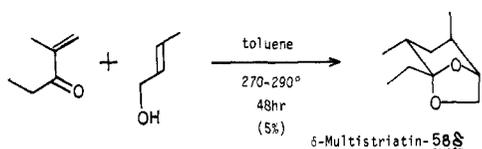
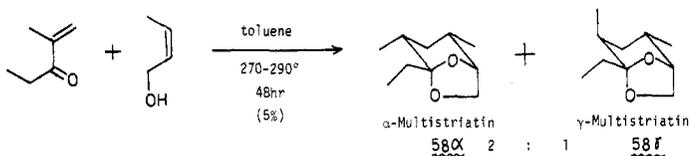

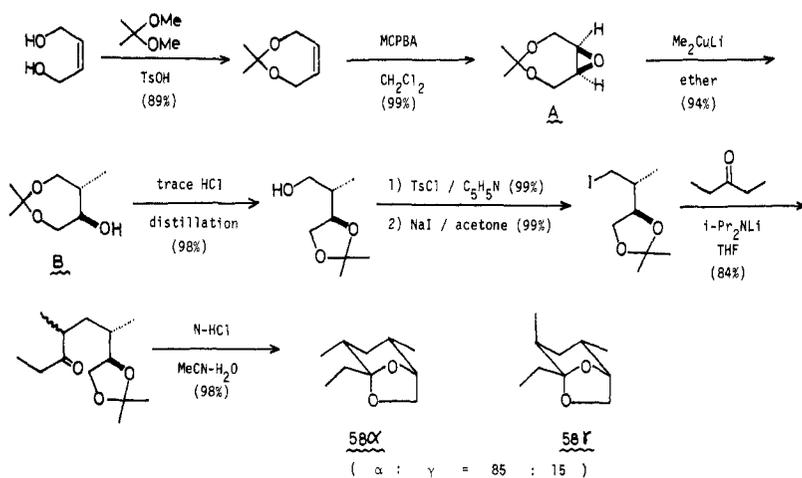
Silverstein et al. found that the attractant for the smaller European elm bark beetle (*Scolytus multistriatus*) is a mixture of (-)-4-methylheptan-3-ol, (-)-*α*-multistriatin **58**, and a sesquiterpene, (-)-*α*-cubebene.²⁶⁵ All three compounds were isolated from the volatile components collected by aerating elm bolts infested with virgin female beetles. Individually each compound was inactive in the laboratory bioassay, but a mixture of all three showed activity nearly equivalent to that of the original extract. Curiously the German populations of *S. multistriatus* did not aggregate in response to the mixture containing (-)-*α*-multistriatin. Instead, (-)-*δ*-multistriatin proved attractive when combined with 4-methylheptan-3-ol and cubeb oil.²⁶⁶ Several syntheses of **58** were reported. Silverstein's earlier syntheses are shown in Schemes 147²⁶⁵ and 148.²⁶⁷ The latter Diels-Alder approach coupled with a detailed NMR analysis²⁶⁸ enabled

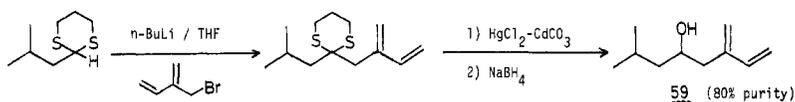

Silverstein et al. to assign **58a** to the biologically active α -isomer. Elliot and Fried reported a stereoselective synthesis of (\pm)- α -multistriatin **58a** as shown in Scheme 149.²⁶⁹ The key step was the stereoselective *trans*-opening of an epoxide with lithium dimethylcuprate (**A** \rightarrow **B**).

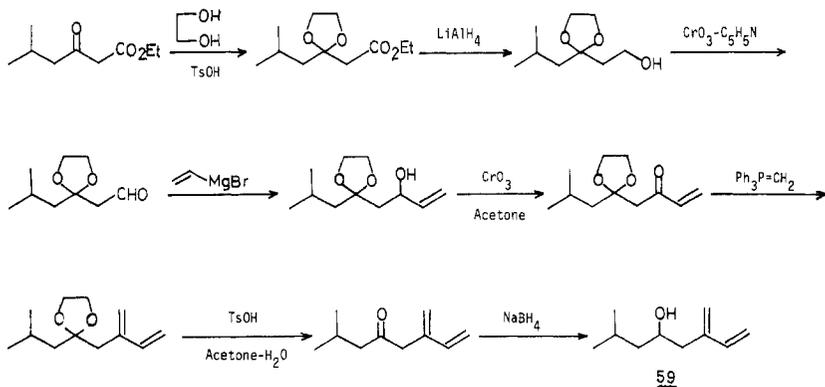

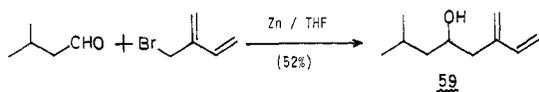
Ipsenol **59**, ipsdienol **60**, and *cis*-verbenol **82** are the monoterpene aggregation pheromones isolated from the frass produced by male California five-spined ips (*Ips paraconfusus*).²⁷⁰ The first synthesis was carried out by the dithiane alkylation reaction as shown in Scheme 150.²⁷¹ Vig adopted a building block-type approach (Scheme 151).²⁷² Katzenellenbogen and Lenox devised a simple synthesis, as shown in Scheme 152.²⁷³ Thermolysis of a cyclobutene generated the characteristic conjugated diene system of **59** (Scheme 153).²⁷⁴ In another synthesis a Claisen rearrangement was used to construct the diene moiety (Scheme 154).²⁷⁵ Kondo et al. reported a simple synthesis of **59** employing a Grignard reagent prepared from chloroprene (Scheme 155).²⁷⁶ A *retro*-Diels-Alder reaction was also used in an ipsenol synthesis (Scheme 156).²⁷⁷ A modification of Scheme 154 was reported recently (Scheme 157).²⁷⁸ Instead of the classical Claisen rearrangement, an orthoester Claisen rearrangement was used in this synthesis. Sakurai et al. recently published an interesting application of organosilane chemistry in ipsenol synthesis (Scheme 158).²⁷⁹ The synthesis of optically active ipsenol is described in Schemes 224 and 225.



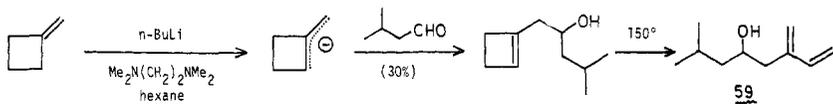

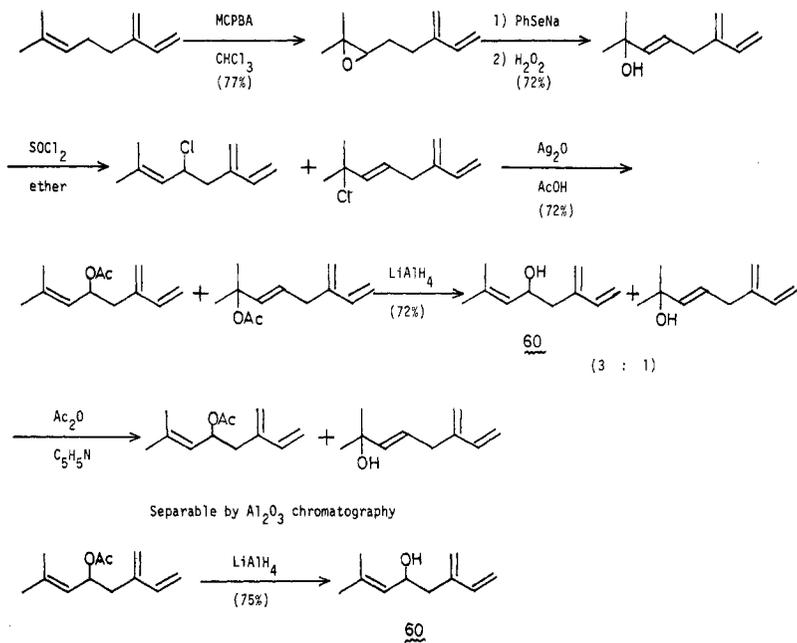
Silverstein synthesized this trienol by dithiane alkylation (Scheme 159).²⁷¹ Extension of Katzenellenbogen's ipsenol synthesis to ipsdienol was particularly successful (Scheme 160).²⁸⁰ Mori developed a synthesis of ipsdienol from myrcene, a readily available monoterpene hydrocarbon (Scheme 161).²⁸¹ In another synthesis the diene moiety was generated by the pyrolysis of an acetate (Scheme 162).²⁸² 3-Methylene-4-pentenal, the key intermediate in ipsenol synthesis, also served as such in ipsdienol synthesis (Scheme 163).^{275, 278} 2-Tri-methylsilylmethyl-1,3-butadiene was useful in ipsdienol synthesis as a new reagent for isoprenylation (Scheme 164).²⁷⁹ The synthesis of optically active ipsdienol will be described later in Schemes 226-228.



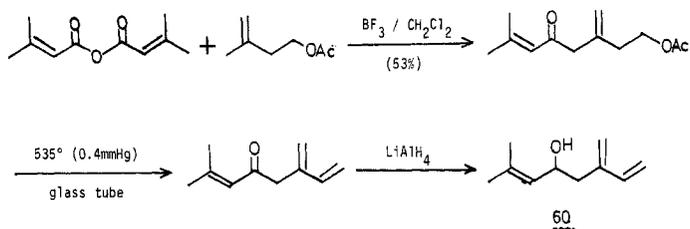

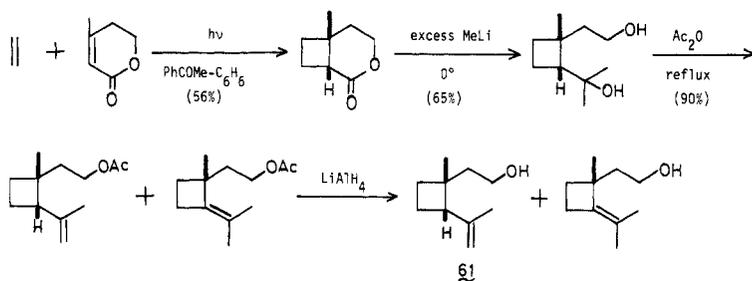
This is one of the pheromones elicited by male boll weevils (*Anthonomus grandis*). The volatile components of the pheromone complex were obtained by steam distillation of the crude extracts of 4,500,000 weevils and 54.7 kg of weevil feces.²⁸³ This cyclobutane compound has attracted the attention of many synthetic chemists and a number of syntheses have appeared.²¹ Photocycloaddition has often been used to construct the cyclobutane ring, as exemplified by



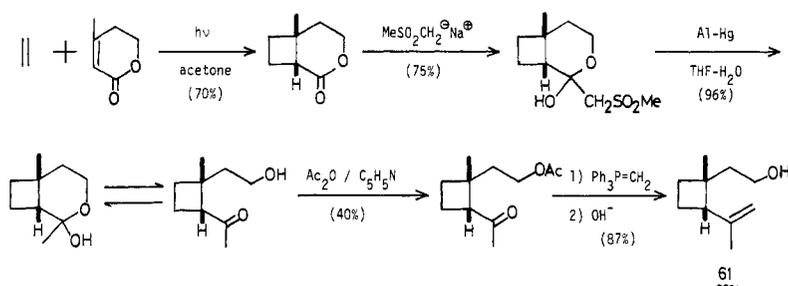

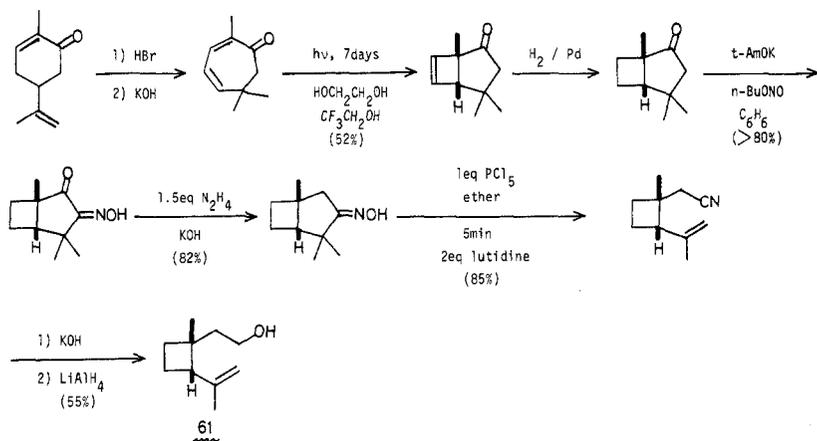
the first synthesis (Scheme 165).^{283, 284} The relative stereochemistry of grandisol was established as *cis* by this synthesis. The second and stereoselective synthesis was carried out by the Zoecon chemists as shown in Scheme 166.²⁸⁵ Gueldner et al. then published a shorter synthesis (Scheme 167).²⁸⁶ The final dehydration step, however, was not regioselective. A similar approach was reported by Uda et al. (Scheme 168).²⁸⁷ This synthesis was both regio- and stereoselective. Another photochemical synthesis by Cargill and Wright involved a new fragmentation of an ozonide (Scheme 169).²⁸⁸

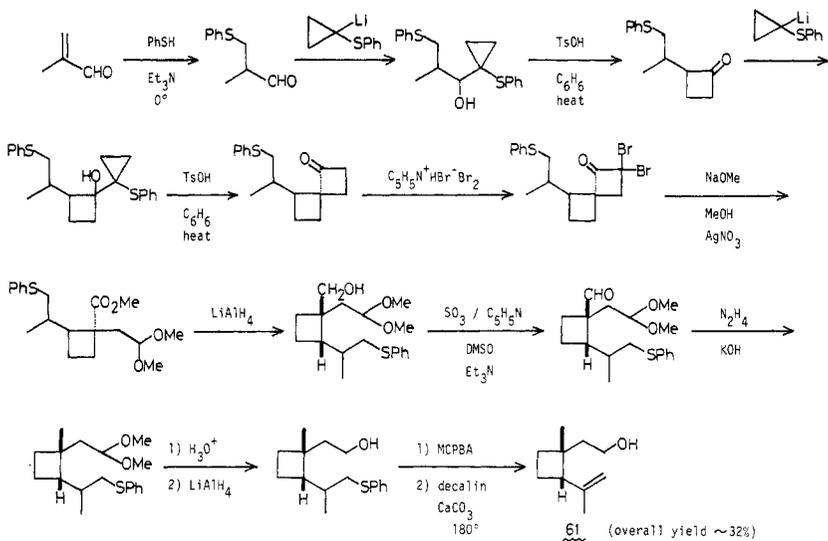
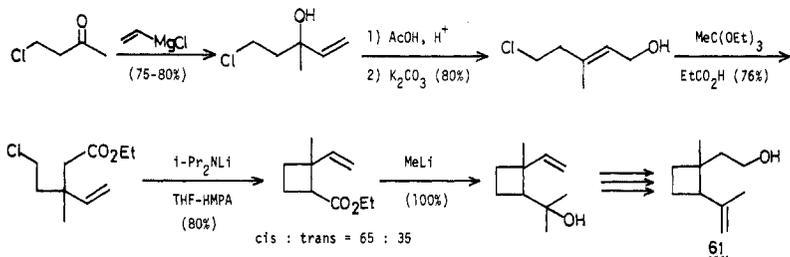
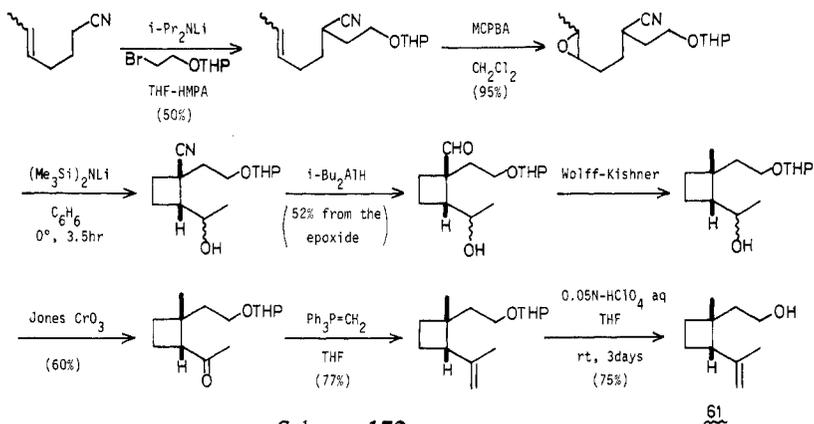
The first and most efficient nonphotochemical synthesis was the two-step preparation of Billups et al. (Scheme 170).²⁸⁹ Catalytic dimerization of isoprene to yield a *cis*-1,2-divinylcyclobutane was the key step of this synthesis. The desired cyclobutane could be separated by fractional distillation at 0° after removal of the unreacted isoprene. Above room temperature the *cis*-divinylcyclobutane undergoes a Cope rearrangement to give 1,5-dimethylcyclooctadiene. Ayer's transformation of carvone into (±)-grandisol employed an intramolecular photocyclization for the formation of the cyclobutane ring (Scheme 171).²⁹⁰ Stork's epoxynitrile cyclization was successful in generating the correct stereochemistry of grandisol (Scheme 172).²⁹¹ An intramolecular cyclization of a chloro ester as shown in Scheme 173 yielded a mixture of the desired *cis* and undesired *trans* compounds in a ratio of 65 : 35.²⁹² The Trost synthesis is a unique application of his secoalkylation reaction based on organosulfur chemistry (Scheme 174).^{293, 294} The introduction of an isopropenyl group by pyrolysis

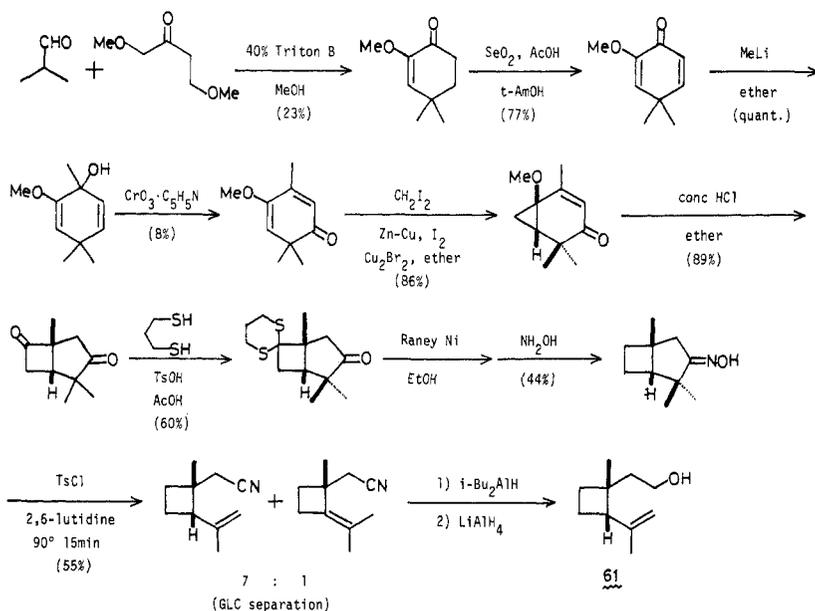

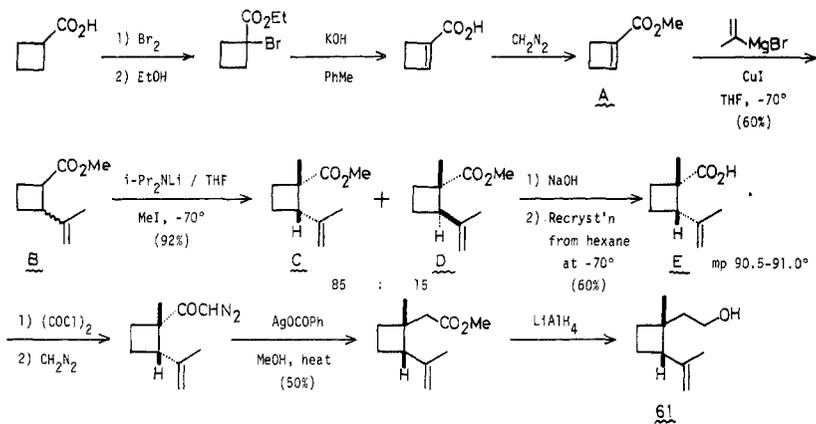

of a sulfoxide yielded only the desired product without producing any double-bond isomer. However, his synthetic grandisol **61** contained about 20% of its *trans* isomer, known as fragranol.²⁹⁵ Recently Wenkert reported a synthesis of grandisol (Scheme 175a).²⁹⁶ He employed a regioselective cyclopropanation and the hydrolytic rearrangement of the resulting methoxycyclopropane to cyclobutanone as the key steps. The final transformation of the bicyclo[3.2.0]hepta-



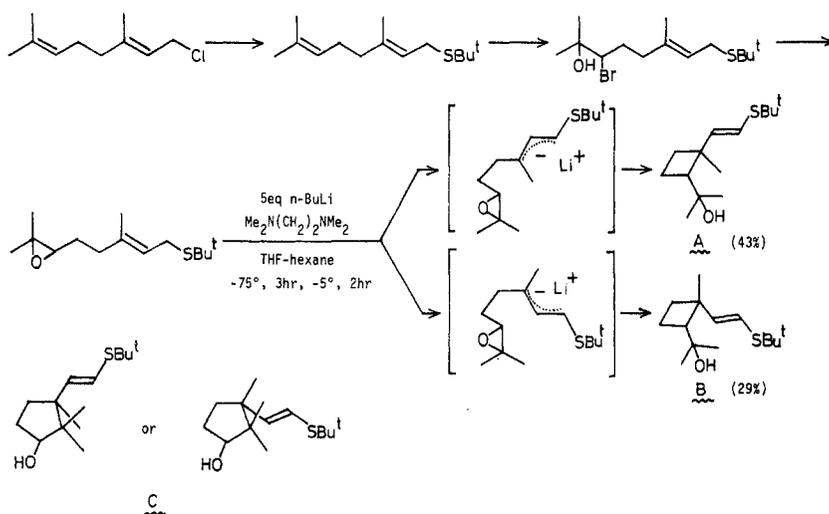

none system to **61** was carried out in a similar manner as that reported by Ayer (Scheme 171). Another synthesis of (\pm)-grandisol was recently reported by Clark (Scheme 175b).⁴⁷⁸ The key reaction was the addition of an organocuprate to methyl 1-cyclobutene-1-carboxylate **A** to give **B** as a mixture of stereoisomers. This was methylated to give a mixture of *cis*-ester **C** and its isomer **D**. Separation was readily achieved by recrystallizing the corresponding acid **E**.

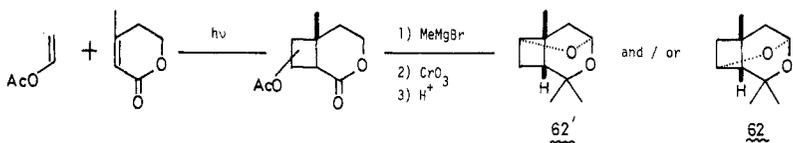
Finally a synthesis of the grandisol skeleton from the geraniol skeleton should be mentioned (Scheme 176).²⁹⁷ In this synthesis, displacement of an epoxide O-atom by a stabilized allyl anion gave cyclobutane compounds **A** and **B** together with **C**. Unfortunately, the compound **A** (fraganol skeleton) was the predominant product. The compound **B**, obtained in only 29% yield, was a grandisol derivative.



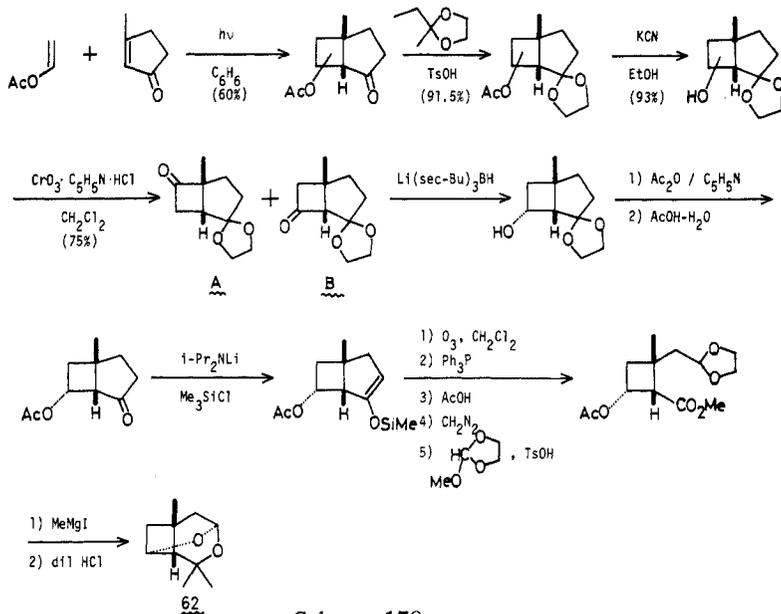

Lineatin, 3,3,7-Trimethyl-2,9-dioxatricyclo[3.3.1.0^{4,7}]nonane 62

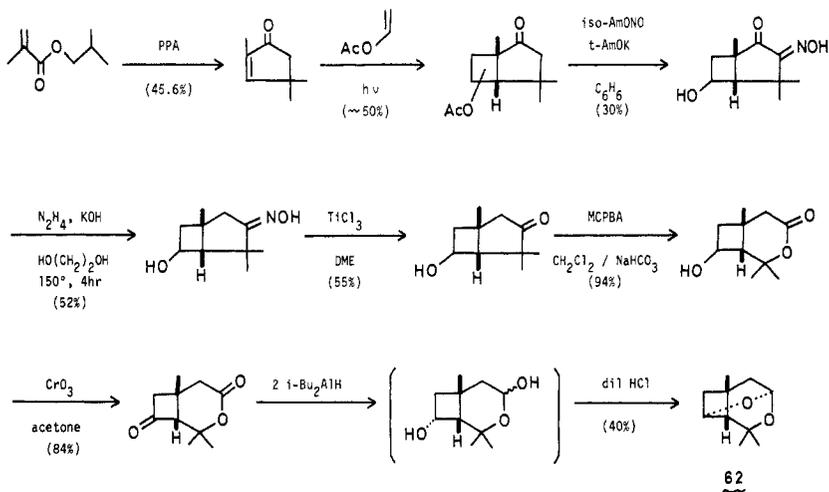
Lineatin is an attractant compound isolated from the frass produced by female beetles of *Trypodendron lineatum* boring in Douglas fir.²⁹⁸ Originally its structure was proposed to be one of the two isomeric tricyclic acetals (**62** or **62'**, Scheme 177) without assignment of the absolute configuration.²⁹⁸ A synthesis shown in Scheme 177 was attempted to confirm one or the other of the postulated structures.²⁹⁸ However, separation of the individual components of the isomeric mixture was unsuccessful and the structure could not be determined by this synthesis. Mori and Sasaki recently reported two syntheses of **62**. The earlier nonselective synthesis is shown in Scheme 178.²⁹⁹ The two ketones **A** and **B** were separated by chromatography and converted to **62'** and **62**, re-

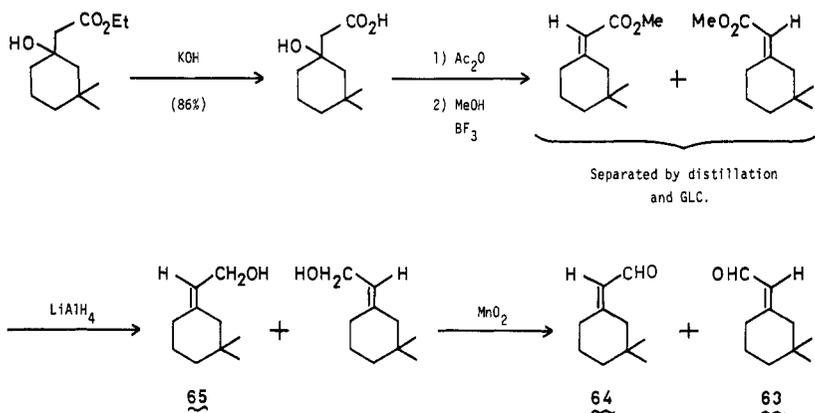

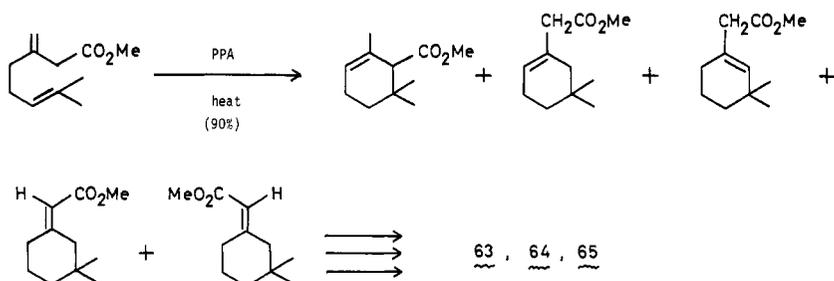
spectively. Comparison of the spectral data revealed **62** to be the racemate of lineatin. A selective synthesis of lineatin also employed photocycloaddition to generate the cyclobutane ring (Scheme 179).³⁰⁰ 2,4,4-Trimethyl-2-cyclopenten-1-one, the starting material, was prepared from isobutyl methacrylate by treatment with polyphosphoric acid as described recently.³⁰¹ Although a mixture of acetoxy ketones was obtained as a photoadduct, subsequent oximation gave the desired keto-oxime as the only crystalline product. The undesired acetoxy ketone presumably resinified via a retroaldol cleavage of the cyclobutane ring of the corresponding β -hydroxy ketone.

(E)-3,3-Dimethyl- $\Delta^{1,\alpha}$ -cyclohexaneacetaldehyde **63**, *(Z)*-3,3-Dimethyl- $\Delta^{1,\alpha}$ -cyclohexaneacetaldehyde **64**, and *(Z)*-3,3-Dimethyl- $\Delta^{1,\beta}$ -cyclohexane ethanol **65**

These monoterpenes are also the components of the pheromone produced by the male boll weevil.^{283, 284} Tumlinson et al. synthesized them as shown in Scheme 180.²⁸⁴ All other syntheses also used cyclohexanones as starting material



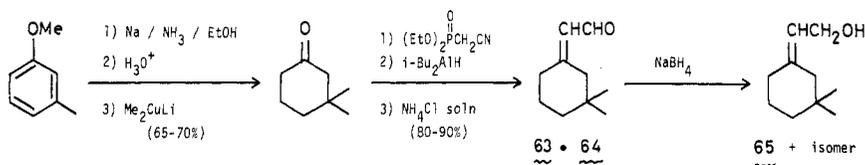

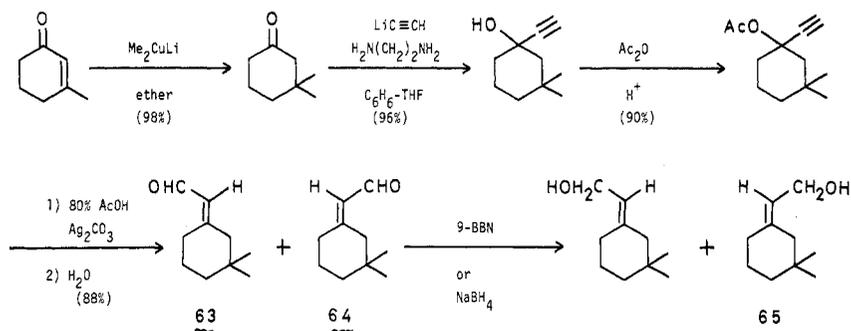

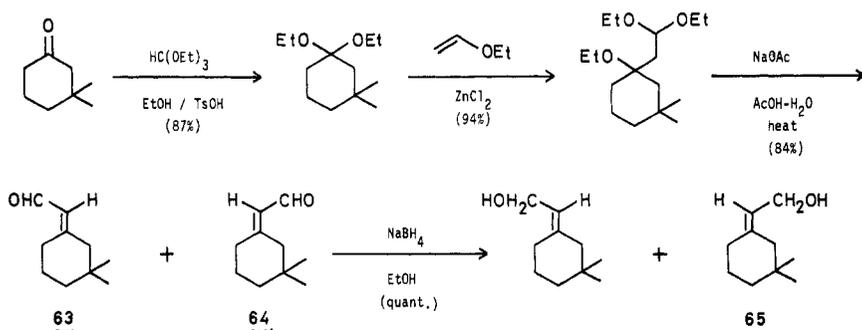
except one reported by Wolinsky.³⁰² Bedoukian and Wolinsky found that acid-catalyzed cyclization of methyl γ -geranate affords a mixture composed primarily of methyl 3,3-dimethylcyclohexenylacetates as shown in Scheme 181.³⁰² These were separated by preparative GLC and converted into **63,64** and **65** in the usual manner. Babler employed the Horner condensation to attach the side chain (Scheme 182).³⁰³ For that purpose Pelletier used acetylene (Scheme 183a)^{304a} and deSouza used ethyl vinyl ether (Scheme 183b).^{304b} The Vilsmeier

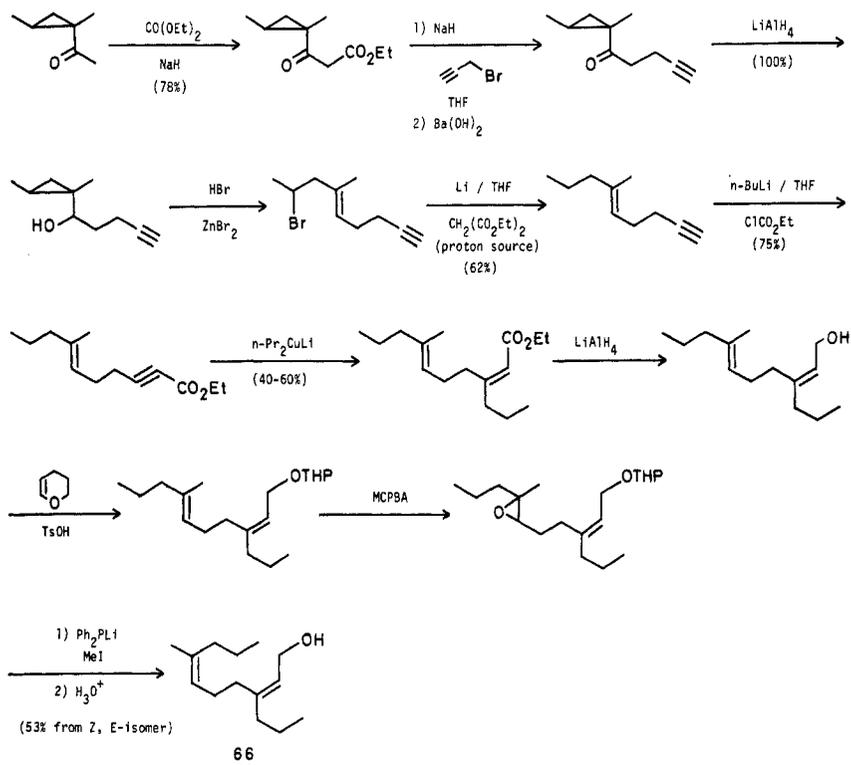
reaction was employed as the key-step of a two-step synthesis of a mixture of **63** and **64** from isophorone (Scheme 184).³⁰⁵ Nakai synthesized a mixture of **63** and **64** using the [3,3] sigmatropic rearrangement of an allylic thionocarbamate as the key-reaction (Scheme 185).³⁰⁶ (For another application of this reaction see Scheme 110.) (*Z*)-2-Ethoxyvinyl lithium was used as a nucleophilic acetaldehyde equivalent in the synthesis recently reported by Wollenberg (Scheme 186).³⁰⁷ (Using this reagent Wollenberg also synthesized the red bollworm moth pheromone **36** in 36% yield from 9-decen-1-ol.³⁰⁷)



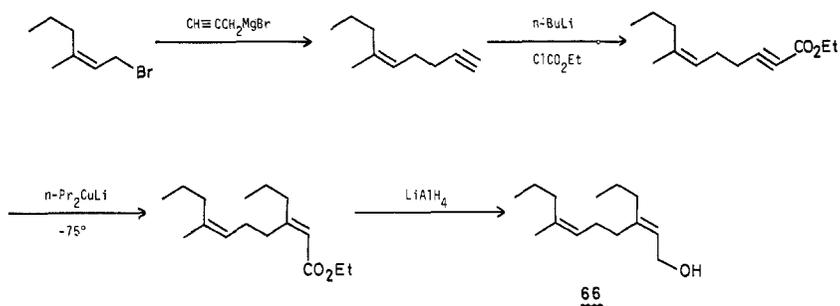

(2Z, 6Z)-7-Methyl-3-propyl-2,6-decadien-1-ol 66

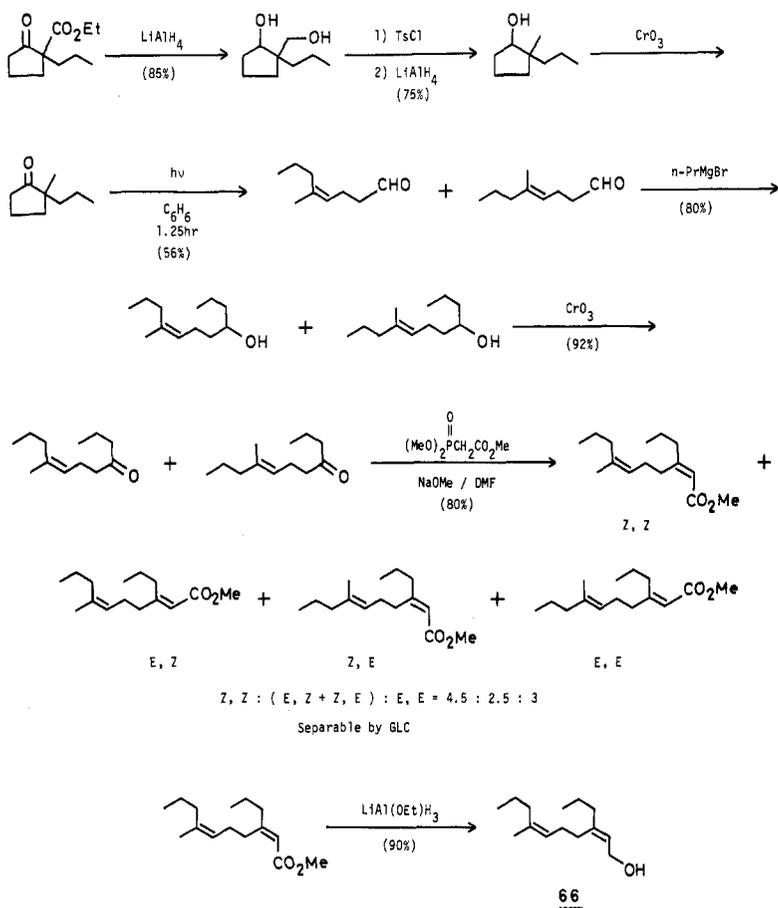
This was once claimed to be the sex pheromone of the codling moth.³⁰⁸ The codling moth pheromone is now known to be **35**. Apart from this claim, the interesting tetrahomoterpene structure **66** attracted attention of chemists and several syntheses were recorded. The synthetic strategies devised for this compound were similar to those used for juvenile hormones. Cooke's synthesis is shown in Scheme 187.³⁰⁹ The final stage of this synthesis was the application of Vedejs's method for the inversion of olefin geometry.^{110a} Another synthesis was reported simultaneously by Katzenellenbogen (Scheme 188).^{310, 311} Conjugate addition of lithium di-*n*-propylcuprate to an acetylenic ester effectively generated the (*Z*)-olefinic ester when carried out at -75° . The third synthesis used a Norrish Type I photofragmentation of 2-methyl-2-propylcyclopentanone as the

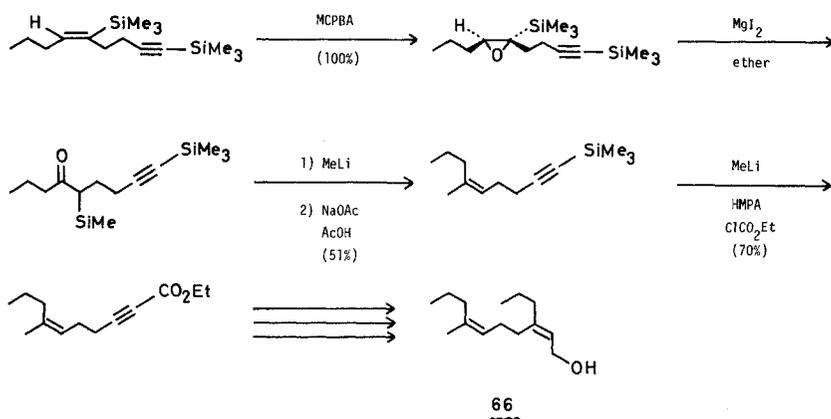
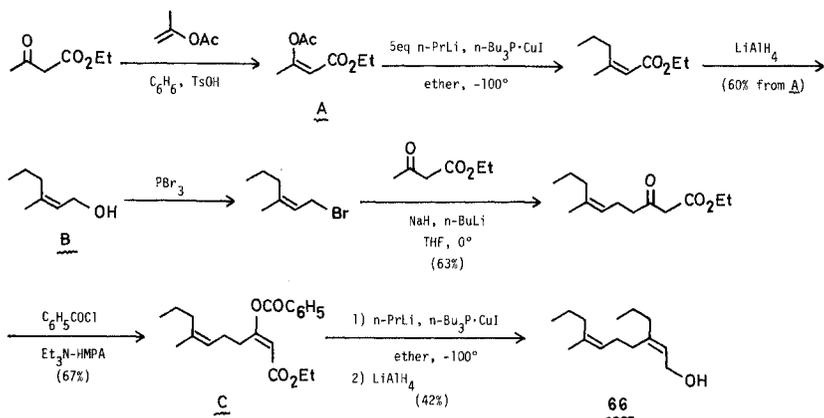

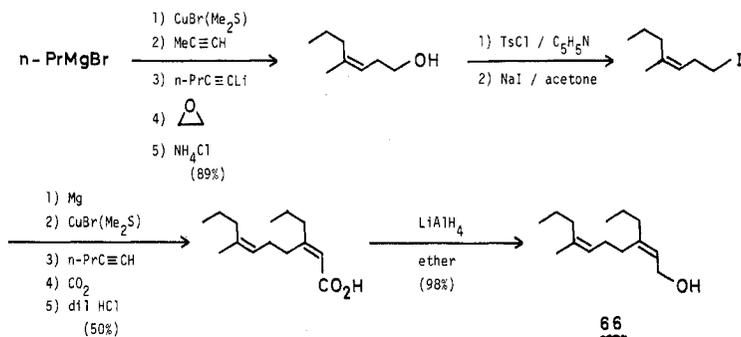

key step (Scheme 189).³¹² The fragmentation lacked stereoselectivity and the Horner condensation was also nonstereoselective. The desired (*Z*, *Z*)-isomer therefore had to be separated by preparative GLC. A stereoselective synthesis as shown in Scheme 190 using a substitution reaction by an organocopper reagent and the alkylation of a dianion was reported by Ouannès and Langlois.³¹³ These authors synthesized all of the possible isomers stereoselectively. Another stereoselective synthesis was based on magnesium iodide induced rearrangement of α,β -epoxysilanes to β -ketosilanes (Scheme 191a).³¹⁴ Further treatment of the β -ketosilane with methyl lithium followed by sodium acetate in acetic acid³¹⁵ gave a trisubstituted olefin in a stereoselective manner. This was converted to the acetylenic ester which had been transformed to **66** previously.³⁰⁹ Another syn-



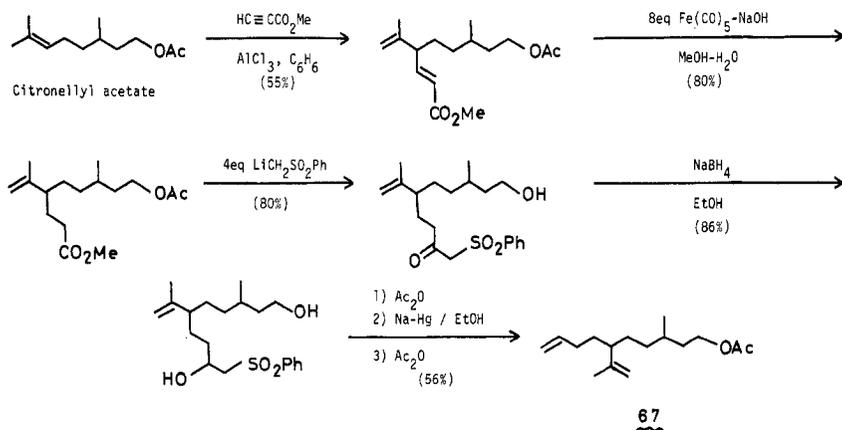
thesis of **66** was recently published by Helquist et al. as shown in Scheme 191b.⁴⁷⁹ The iterative construction of trisubstituted olefin units used in this synthesis seems to be of wide applicability. The overall yield was satisfactory.

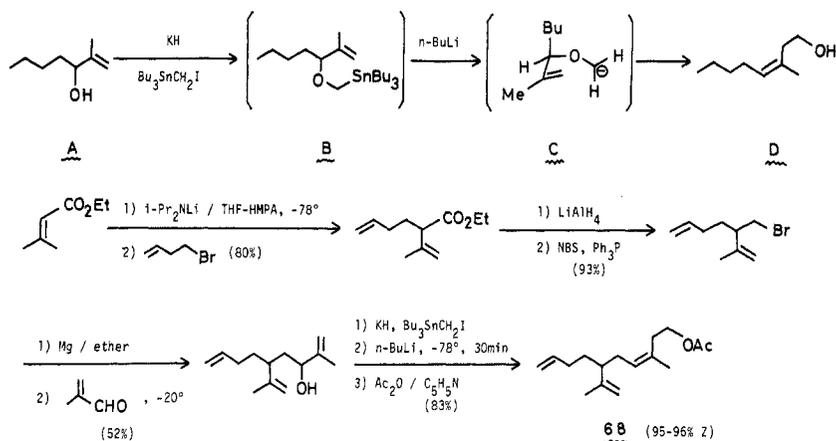
These are pheromone components of female California red scale (*Aonidiella aurantii*).^{316,317} Inspection of the structure **67** suggests synthetic pathways involving alkylation of citronellol. A synthesis of (\pm)-**67** along this line was reported by Snider and Rodini as shown in Scheme 192.³¹⁸ The key step of this synthesis was the aluminum chloride-catalyzed ene reaction of methyl propioate with citronellyl acetate. The ene reaction introduced the isopropenyl group regioselectively and provided appropriate functionality for conversion to (\pm)-

67. The final product was obtained as a mixture of all four stereoisomers. The synthesis was repeated with (*R*)-(+)- and (*S*)-(-)-citronellyl acetate and led to the pheromone with controlled stereochemistry at C-3. The (3*S*)-(-)-67 was more active than the (3*R*)-(+)-67. The natural pheromone therefore seems to have the (3*S*)-configuration.

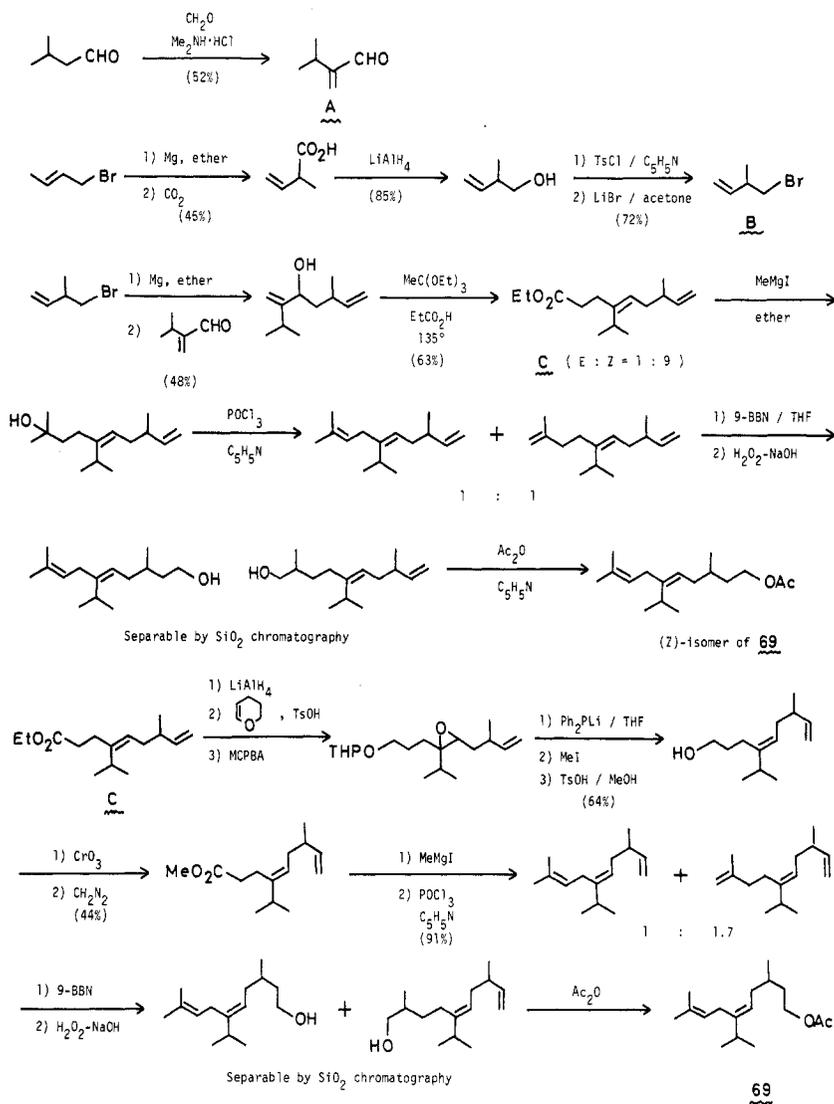
An ingenious synthesis of (\pm)-68 was reported by Still and Mitra (Scheme 193).³¹⁹ Their success was based on a convenient and efficient [2,3]-sigmatropic Wittig rearrangement, which gave *Z*-trisubstituted homoallylic alcohols in high yields and with >95% stereoselectivity ($A \rightarrow B \rightarrow C \rightarrow D$). It is remarkable that in the transition state *C*, a pseudoaxial butyl substituent is strongly preferred. Using this reaction, they synthesized (\pm)-68 stereoselectively starting from the ethyl ester of β,β -dimethylacrylic acid. The synthesis of optically active 68 will be discussed later (Scheme 242).

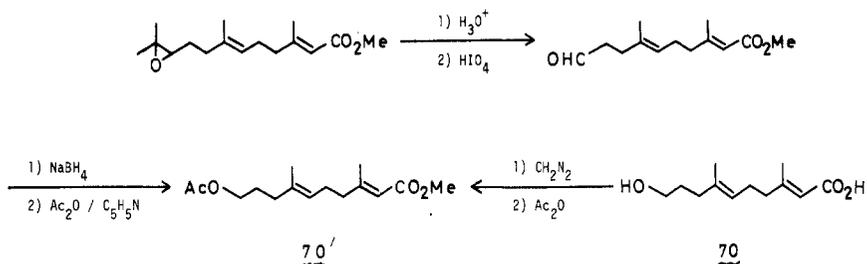
This is the pheromone of the yellow scale (*Aonidiella citrina*), a pest of citrus crops.³²⁰ Anderson and Henrick synthesized a racemic mixture of (*E*) and (*Z*)-isomers (4 : 1 ratio).³²¹ Their synthetic route is unavailable at present. A synthesis of (\pm)-69 and its (*Z*)-isomer was recently reported as shown in Scheme 194.³²² In this synthesis the (*Z*)-isomer of the pheromone was first synthesized starting from *A* and *B* and found to be different from the (*E*)-isomer by NMR and GLC. Then the intermediate *C* was submitted to Vedejs's olefin inversion reaction to obtain the (*E*)-isomer. Subsequent transformation to (\pm)-69 was accomplished as shown in the scheme.



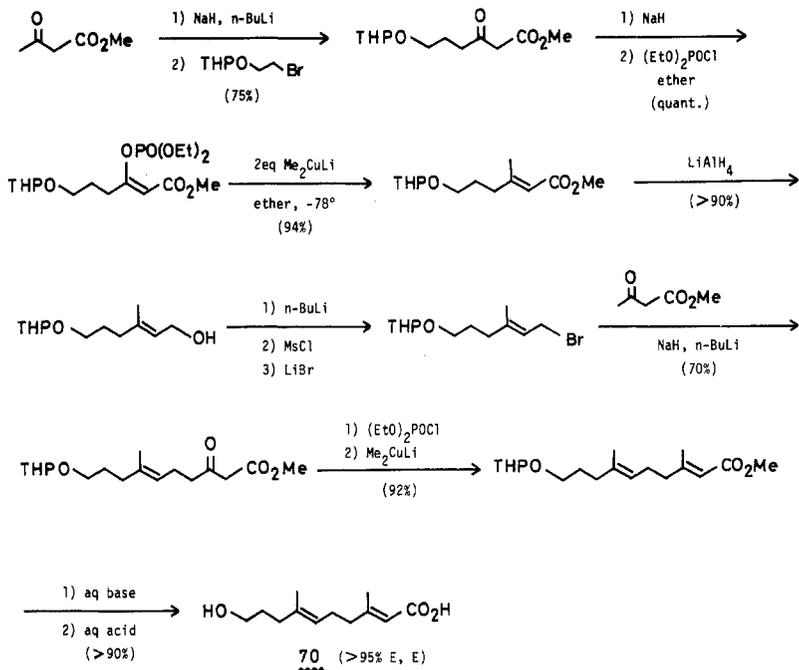

(2E, 6E)-10-Hydroxy-3,7-dimethyl-2,6-decadienoic acid 70

Meinwald isolated this compound as a major component in the "hairpencil" secretion of the male monarch butterfly (*Danaus plexippus*).³²³ Its methyl ester acetate **70'** was prepared by degradation of the (±)-Juvenile Hormone III (Scheme 195).³²³ Dianion alkylation and a new substitution reaction of enol phosphates with organocopper reagents were employed in a stereoselective synthesis of **70** by Sum and Weiler (Scheme 196).³²⁴



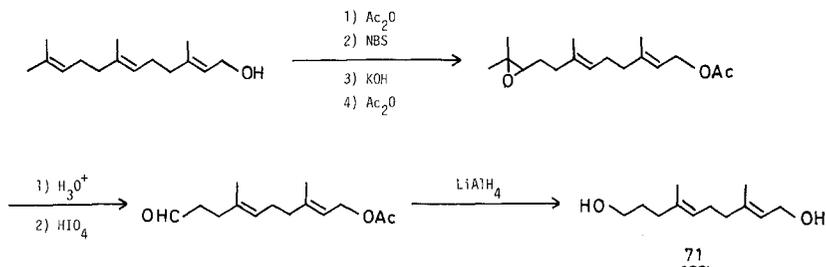

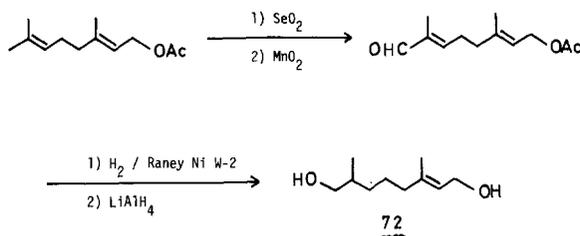
This is one of the components of the hairpencil secretion of the male queen butterfly (*Danaus gilippus berenice*) and was prepared from farnesol as shown in Scheme 197.³²⁵

Meinwald isolated this as one of the components of the hairpencil secretion of the African monarch butterfly (*Danaus chrysippus*).³²⁶ Its racemate was synthesized from geranyl acetate (Scheme 198).³²⁶ Another synthesis of (±)-72 used the Norrish Type I photofragmentation of ethyl-1-methylcyclopentan-2-one-1-carboxylate as the key step (Scheme 199).^{327, 328}

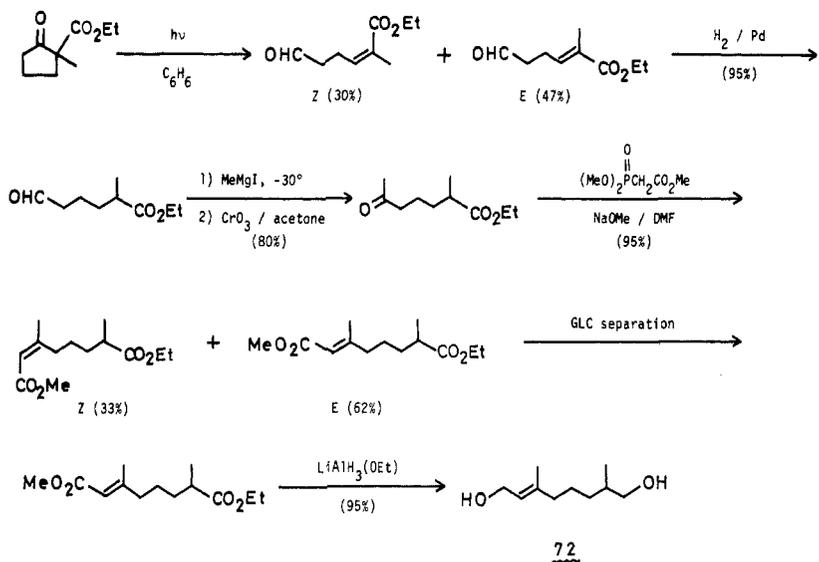

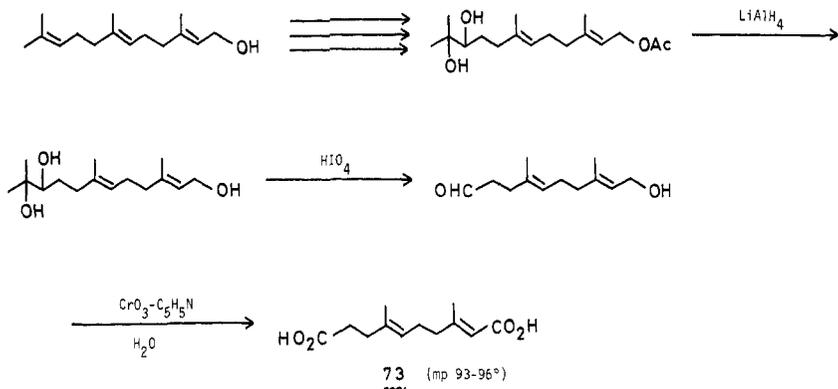

Extraction of hairpencils of about 6500 male monarch butterflies (*Danaus plexippus*) gave 11.8 mg of a solid identified as 73.³²⁹ A synthesis was accomplished starting from farnesol (Scheme 200).³²⁹ Johnson and Meinwald devised a short and stereoselective synthesis of these degraded terpenes utilizing the

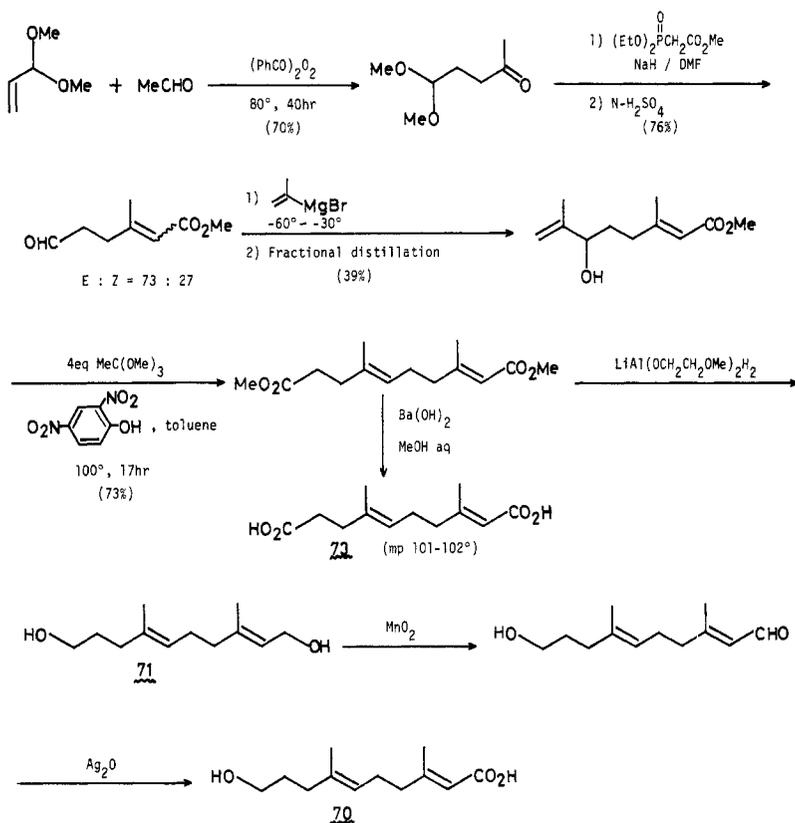

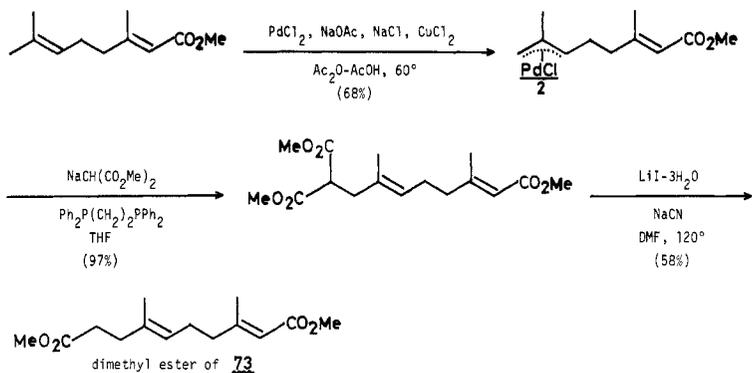

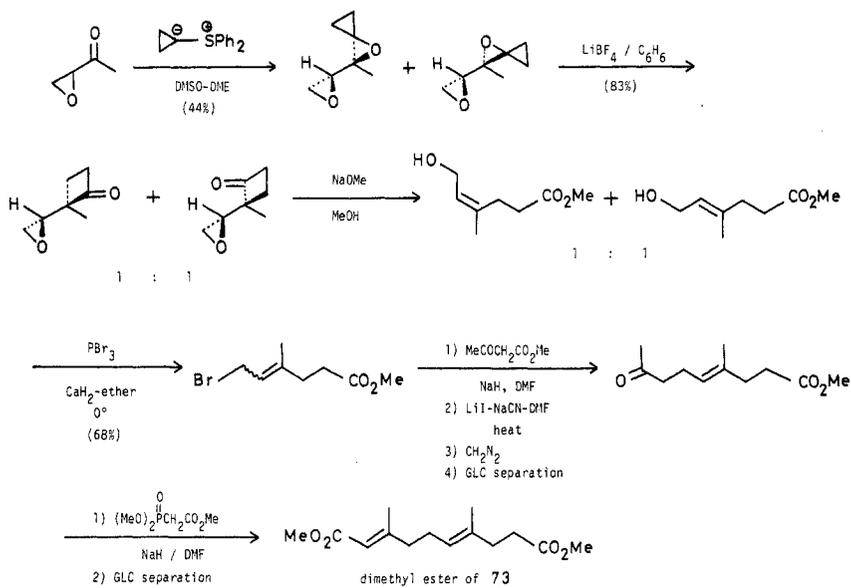
Claisen orthoester rearrangement (Scheme 201).³³⁰ Trost recently reported a synthesis of the dimethyl ester of 73 by means of organopalladium chemistry (Scheme 202).³³¹ Trost's other synthesis of the dimethyl ester of 73 was based on his oxasecoalkylation reaction via a cyclobutanone intermediate (Scheme 203).³³²



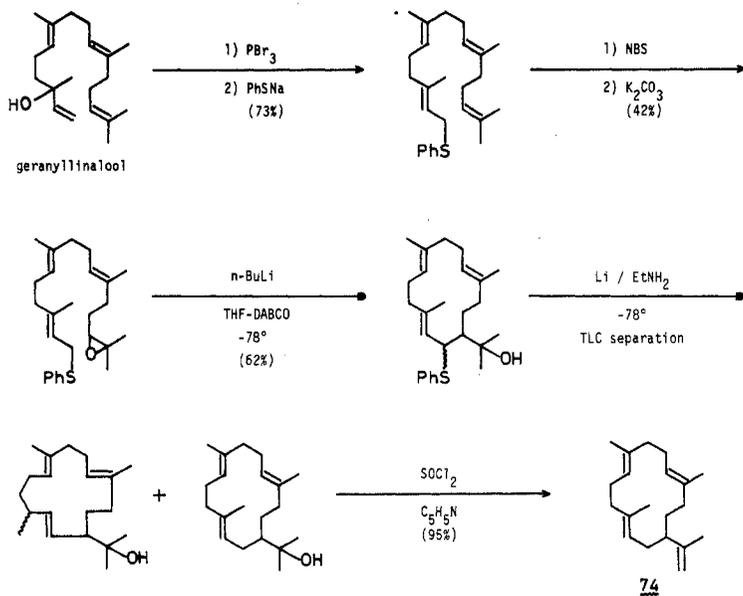

Neocembrene A 74

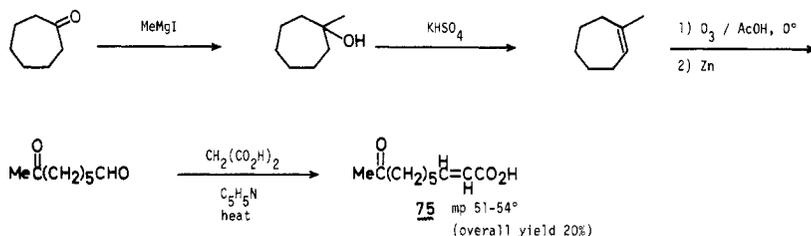
Birch et al. isolated this macrocyclic diterpene hydrocarbon as a termite trail pheromone of *Nasutitermes exitosus*, *N. walkeri*, and *N. graveolus*.³³³ The stereochemistry was elucidated by Sukh Dev et al.³³⁴ Syntheses were achieved by Itô et al.³³⁵ and by Kitahara et al.³³⁶ utilizing different modes of polyene cyclization (Schemes 204³³⁵ and 205³³⁶). An alternative synthetic route to the cembrene skeleton was reported recently by Kato et al. (Scheme 206).³³⁷ For other syntheses of the cembrene skeleton see Ref. 337 and references cited therein.

13. QUEEN SUBSTANCE OF HONEYBEE

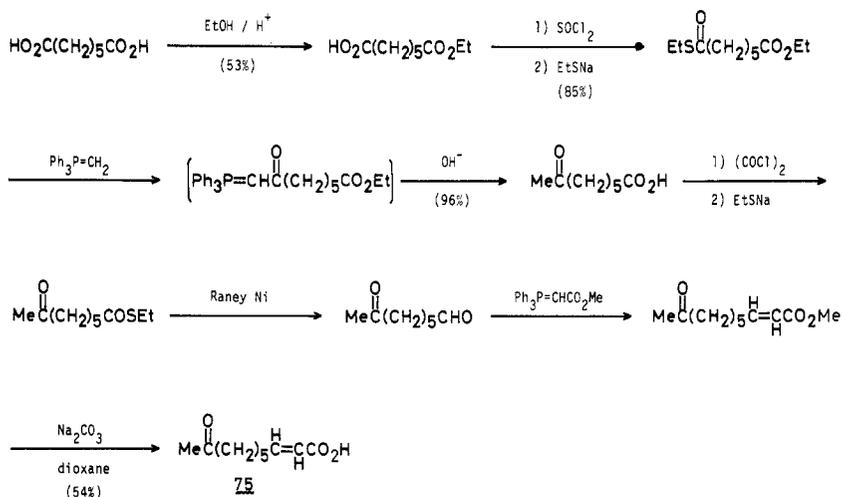
Butler et al. isolated (*E*)-9-oxo-2-decenoic acid **75** as the "Queen substance" of the honeybee (*Apis mellifera*).^{338, 339} Queen honeybees secrete material, which, distributed through the colony, affects the bees in two ways; it inhibits the development of ovaries in workers and influences their behavior by inhibiting Queen rearing (that is, Queen-cell construction). Butler's synthesis is shown in Scheme 207.³³⁹ Barbier et al. employed cycloheptanone as the starting material (Scheme 208).³⁴⁰ Bestmann's synthesis was based on a unique application of ylid chemistry, as shown in Scheme 209.³⁴¹ A photochemical fragmentation reaction was used by Doolittle et al. to synthesize the Queen substance (Scheme 210).³⁴²



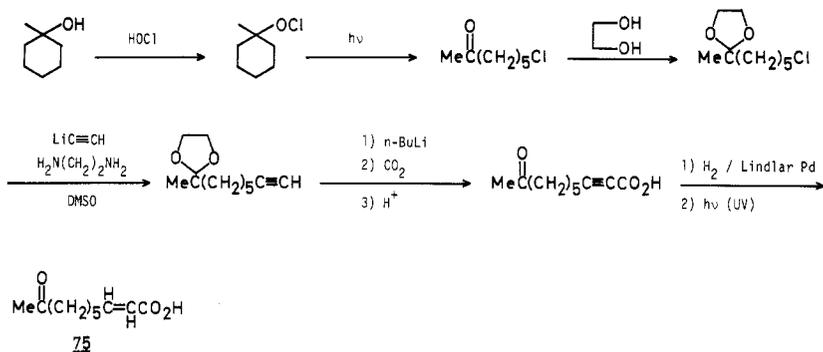

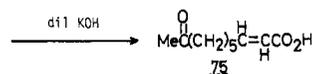
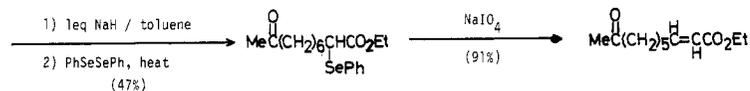
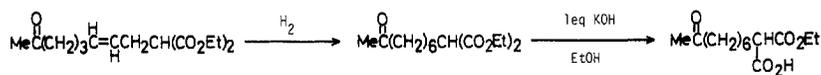
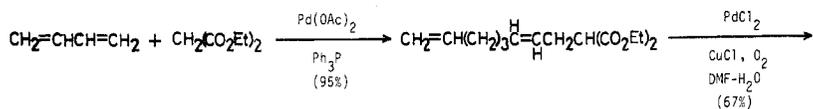
Trost devised an efficient modification of the Butler synthesis by the application of new organosulfur chemistry (Scheme 211).^{343, 344} In this synthesis α -sulfonylation of an ester followed by oxidation and thermal elimination of methylsulfenic acid gave the Queen substance stereoselectively in high yield. Another interesting synthesis of Trost and Hiroi involves an oxidative cleavage as the key step, which is accompanied by rearrangement of 2,2-dithiocyclononan-1-ol, as shown in Scheme 212.³⁴⁵ They called this process “oxidative seco rearrangement.” Tsuji et al. developed a new synthesis from the butadiene telomer (Scheme 213).³⁴⁶ Both organopalladium and organoselenium chemistry were employed

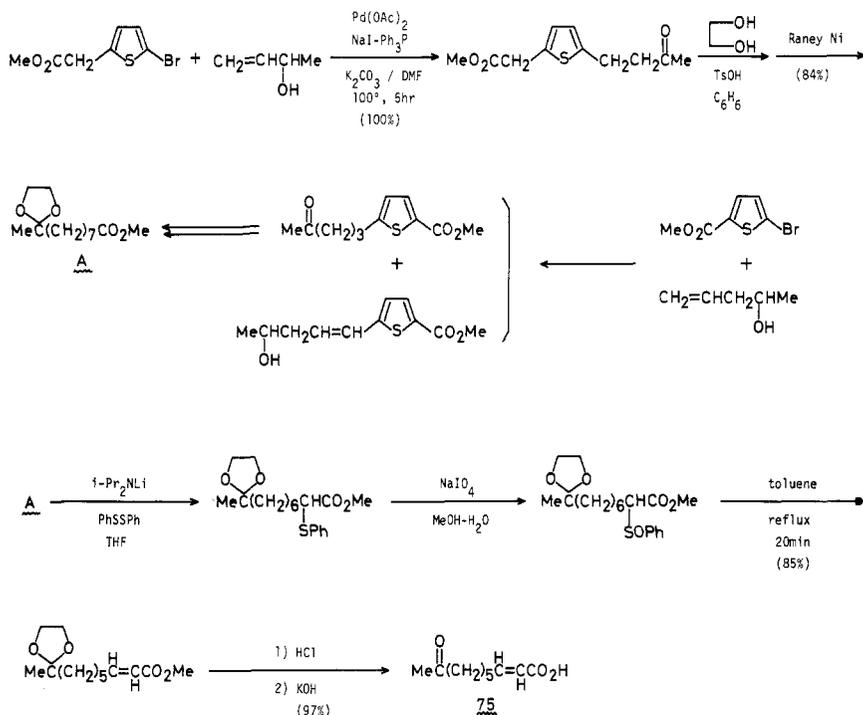

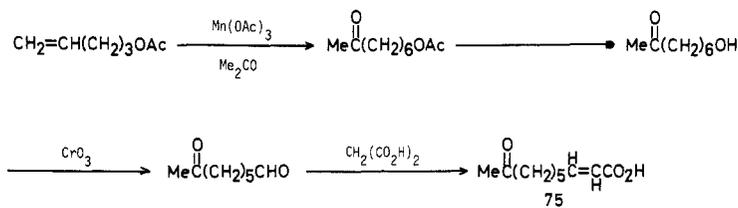

successfully in this synthesis. In a synthesis reported by Tamaru et al. the thiophene ring was used as the source of four methylene units (Scheme 214).^{347, 348} For the similar use of a thiophene ring in pheromone synthesis, see Scheme 3. Subramaniam et al. recently reported a synthesis in which no exotic reagent was used (Scheme 215).³⁴⁹ Manganese(III) acetate successfully generated the MeCOCH_2 group. The salient feature of the synthesis is this terminal olefin-acetone reaction with a three-carbon homologation. Recently Hase and McCoy

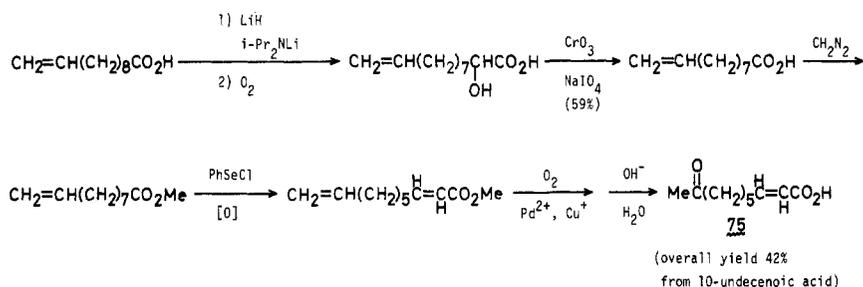

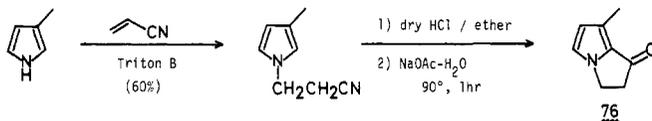

converted 10-undecenoic acid to the Queen substance as shown in Scheme 216.³⁵⁰ This synthesis utilized a new method for the one-carbon chain shortening of carboxylic acid.

14. HETEROCYCLES AS PHEROMONES

2,3-Dihydro-7-methyl-1H-pyrrolizin-1-one 76

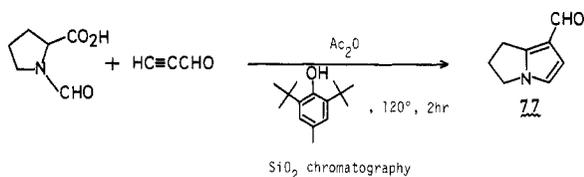
This heterocyclic ketone was isolated by the Meinwalds as a component of the hairpencil secretion of the male Trinidad butterfly (*Lycorea ceres ceres*).³⁵¹ Later this was also isolated from the queen butterfly (*Danaus gilippus berenice*)³²⁵ and from the African monarch (*Danaus chrysippus*).³²⁶ In the case of *D. gilippus berenice*, electrophysiological and behavioral studies indicate that this heterocyclic ketone 76 serves as a pheromone. The role of other compounds such as 70-73 remains unknown. The synthesis is shown in Scheme 217.³⁵¹

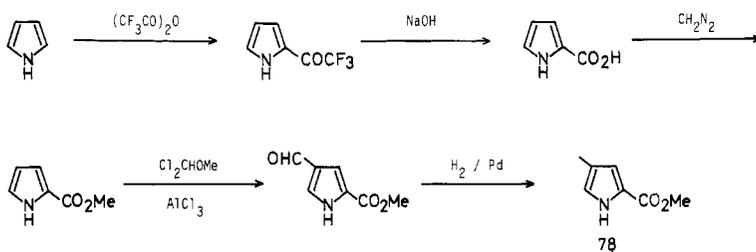
This is one of the hairpencil secretions of male butterflies of *Danaia*.³⁵² Its simple synthesis was reported by means of a cycloaddition to propargylic aldehyde (Scheme 218).³⁵³

This is a volatile trail pheromone of the leaf-cutting ant (*Atta cephalotes*).³⁵⁴ A synthesis by Sonnet is shown in Scheme 219.³⁵⁵



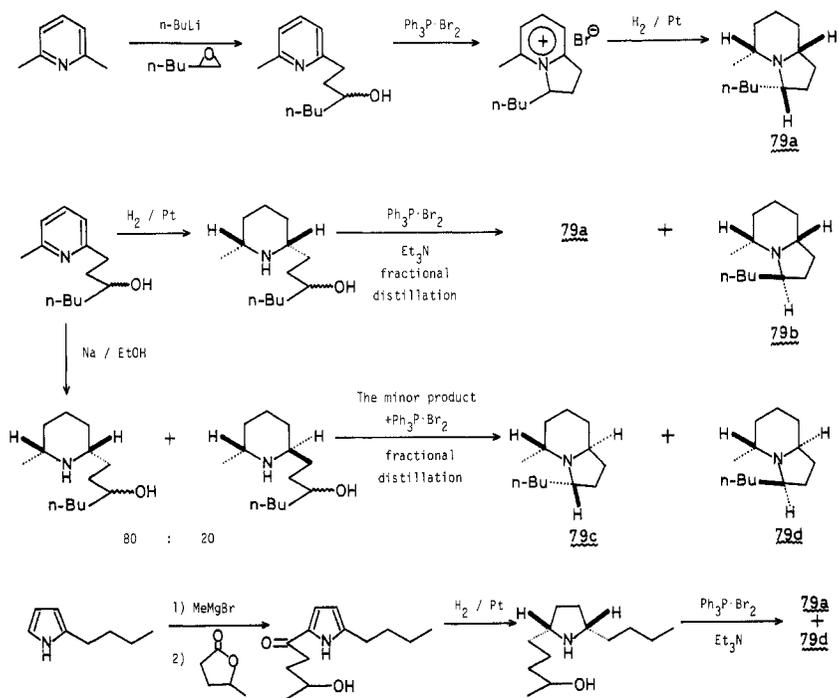

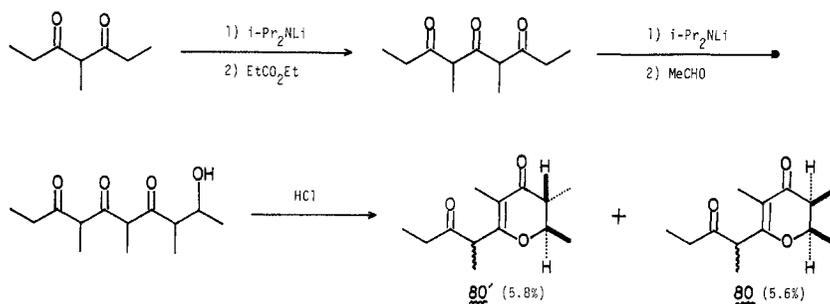
This is a trail pheromone of the pharaoh ant (*Monomorium pharaonis*).³⁵⁶ Synthesis of several stereoisomers of **79** was reported by Oliver and Sonnet (Scheme 220).³⁵⁷

2,3-Dihydro-2,3,5-trimethyl-6-(1-methyl-2-oxobutyl)-4H-pyran-4-one 80

This is the sex pheromone isolated from the female drugstore beetle, *Stegobium paniceum*.³⁵⁸ The natural pheromone is crystalline (m.p. 52.5-53.5°) and optically active, which implies that it is a single enantiomer.³⁵⁸ Its absolute stereochemistry is unknown. A synthesis of a mixture of two diastereomeric racemates was accomplished by Mori et al. as shown in Scheme 221.³⁵⁹ This simple biomimetic synthesis resulted in the production of an oil that was active on the male drugstore beetle. The *trans*-isomer **80'** was removed by chromatographic purification.

15. OPTICALLY ACTIVE PHEROMONES

Introduction

Pheromone chemistry was not discussed in three dimensions until 1973. Many pheromones are achiral aliphatic compounds. Geometrical isomerism was the chief concern of those who were working in the pheromone field.

However, there are also chiral pheromones, whose absolute stereochemistries should be established. Difficulties are often encountered in assigning the absolute stereochemistry of a natural pheromone, because it is obtainable only in minute amounts. The best solution to this problem is a synthesis starting from a compound of known absolute configuration. In 1973 Mori first demonstrated the utility of this approach by synthesizing the antipodes of the dermestid beetle pheromone artifacts **32** and **33** from (*S*)-(-)-2-methylbutan-1-ol and establishing the absolute configuration of the pheromone artifacts to be *R*.^{360, 361} Since then a number of pheromones have been synthesized in optically active form as detailed below.

There was another reason which stimulated the synthesis of optically active pheromones. It was related to the theory of olfaction. Wright's vibration theory of olfaction predicted the unimportance of optical isomerism in pheromone perception.³⁶² From the generalization that no examples were known in which one of a pair of optical isomers had an odor and the other did not, Wright inferred that the primary process of olfaction must be a physical rather than a chemical interaction.³⁶³ The slight differences reported in the odors of some optical isomers, he thought, might have resulted from different level of purity. According to Wright's theory, the vibrational frequencies of an odorous molecule in the far-infrared region (500-50 cm^{-1}) determine the quality of an odor, whereas such factors as volatility, adsorbability, and water-lipid solubility determine the strength of the odor.³⁶⁴ On the other hand, Amoore emphasized the importance of molecular shape in determining the quality of odor.³⁶⁵ His stereochemical theory is an example of the lock-and-key concept so well known in enzyme and drug theory. An odorous molecule must possess a stereostructure complementary to the sites of the receptors. In fact a highly significant correlation existed between molecular shape and ant alarm pheromone activity.³⁶⁶ In Amoore's theory two enantiomers should be different in their odors, for they are not superimposable.

In 1971 the odor differences between extremely purified (*R*)-(-)-carvone and its (*S*)-(+)-isomer were reported simultaneously by two groups.^{367, 368} The (*R*)-(-)-isomer had the odor of spearmint, while the antipode was of caraway odor. Anyway, both enantiomers were odorous, a clearer result is preferable to settle the dispute between Wright and Amoore. If we study chiral insect pheromones, then the relationship between stereostructure and olfaction might be clarified more quantitatively than by employing human noses.

In 1974 three groups reported their work along this line. Silverstein investigated the alarm pheromone of *Atta texana*.^{369, 370} Marumo worked on disparlure, the gypsy moth pheromone,^{371, 372} and Mori studied *exo*-brevicomin, the western pine beetle pheromone.^{373, 13, 15} In all these cases, only one enantiomer of the pheromone was biologically active. This was in full accord with Amoore's stereochemical theory.

It is now evident that the syntheses of chiral pheromones are both chemically and biologically worthwhile. The results so far obtained on stereochemistry-pheromone activity relationships, which is more complex than first thought to be, will be summarized at the end of this section. Rossi recently published a review on chiral pheromones.²⁴

Synthetic Strategies Towards Chiral Pheromones

If the purpose of a synthesis is the determination of the absolute configuration of a natural and optically pure pheromone with known optical rotation, the optical purity of the synthetic pheromone is not so important. What is important is the sign of optical rotation of the synthetic pheromone with known absolute configuration. However, if we want to know the relationship between absolute stereochemistry and pheromone activity, we must synthesize pheromones of high optical purity. Use of optically impure pheromone samples in bioassays may lead to the false conclusion that the both enantiomers are biologically active.

In spite of the strong research activity in asymmetric synthesis, there are only very few methods that afford highly optically pure products with known absolute configuration. It is therefore practical to adopt two classical methods, optical resolution and derivation from chiral natural products, for the synthesis of optically pure pheromones. In the synthetic sequences reactions should not be adopted that may cause racemization. The optical purity of the final product or an intermediate very near to it should be carefully determined whenever possible.

The art of optical resolution was well-reviewed recently.³⁷⁴⁻³⁷⁶ The freedom of choice in the course of planning a synthesis may become wider if we adopt optical resolution instead of derivation from natural products, since we can imagine any kind of suitable intermediates for resolution. However, the resolution is not always completely successful and the absolute configuration of the resolved material must be determined by some means.

In planning a chiral synthesis starting from natural products, a wide range of knowledge concerning their stereochemistry and reactions is required. Two good reference materials are available in this area.^{377, 378} The merit of this approach is the satisfactory optical purities of readily available natural products such as sugars, amino acids, and terpenes. So this is a safe path leading to highly optically pure pheromones. However, the structural limitations among abundant

natural products restrict the planning of syntheses and often necessitates a lengthy route for the completion of the synthesis. Another demerit is that the natural products are seldom available in two enantiomeric forms, so it is often difficult to prepare both enantiomers of the pheromone starting from a single enantiomeric form of the natural product.

Determination of Optical Purity

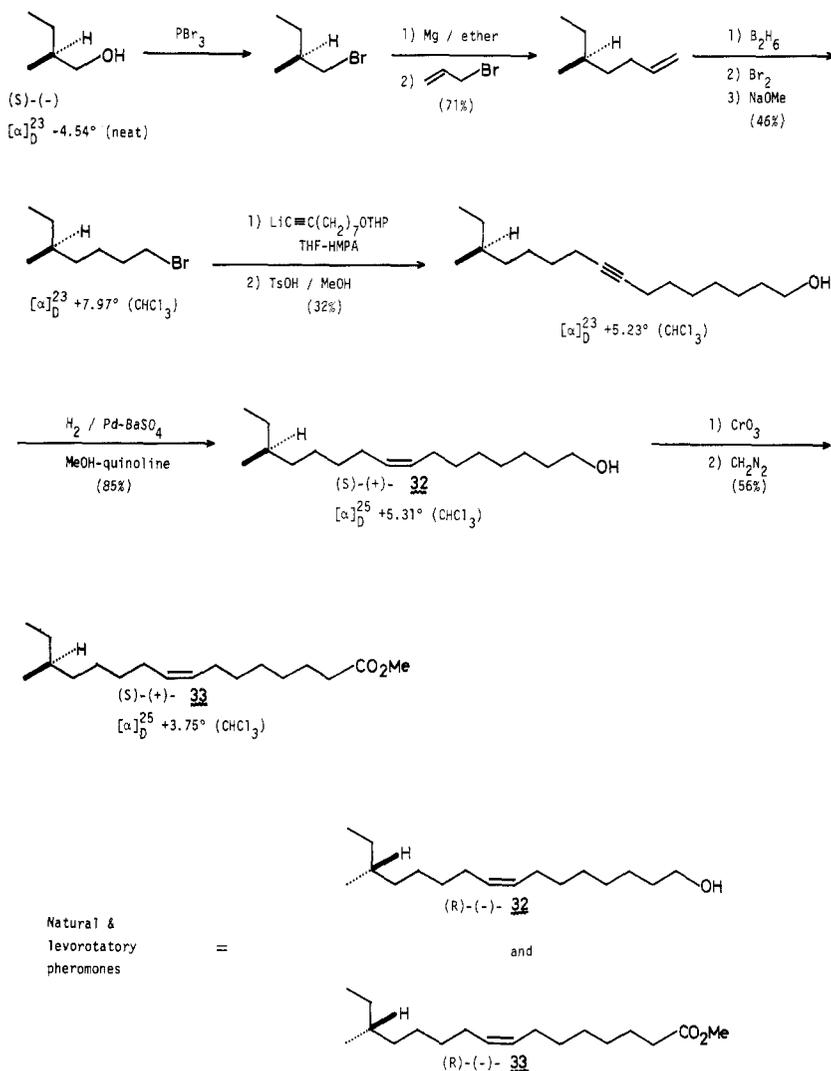
Remarkable progress was recorded recently concerning the techniques for determining optical purities.^{374, 376, 379} The most popular present-day method is the NMR or GLC (or HPLC) analysis of (*R*)-(+)- or (*S*)-(-)- α -methoxy- α -trifluoromethylphenylacetic acid ester (MTPA ester) of an alcohol with unknown optical purity.³⁸⁰ The diastereomeric esters are often separable by GLC or HPLC. In the NMR the diastereomers show a pair of signals due to methoxy protons. The chemical shift difference may be increased by the addition of NMR shift reagents such as Eu(fod)₃. An alternative method is to examine the NMR spectrum of a chiral compound in the presence of chiral shift reagents such as Eu(facam)₃ = tris [3-trifluoromethylhydroxymethylene]-*d*-camphorato] europium.³⁸¹ These two methods enabled Silverstein et al. to determine the enantiomeric composition of several insect pheromones with 5-500 μ g of sample. Pheromone alcohols were analyzed by the MTPA method.³⁸² Remarkably they were not always optically pure. The enantiomeric ratios were as follows: Sulcatol **9** 65 : 35/(+) : (-); *trans*-verbenol **81** 60 : 40/(+) : (-); 4-methylheptan-3-ol **87** 100% (-); seudenol **83** 50 : 50/(+) : (-); ipsdienol **60** from *Ips pini* (Idaho) 100% (-). Several bicyclic ketal pheromones were analyzed by the chiral shift reagent method.³⁸³ The enantiomeric ratios were as follows: *exo*-brevicomin **6** 100% (+); frontalin **8** from *D. frontalis* 85 : 15/(-) : (+); α -multistriatin **58** 100% (-). These findings indicated that insects do not always produce only one enantiomer. This is indeed surprising, since higher animals use only one enantiomer of steroids and higher plants produce only one enantiomer of gibberellins and abscisic acid. Individual synthesis of chiral pheromones will now be discussed in the following order: (1) alcohols and acetates; (2) aldehydes, ketones, and lactones; and (3) epoxides and ketals.

(S, Z)-(+)-14-Methyl-8-hexadecen-1-ol (S)-32 and Methyl (S, Z)-(+)-14-methyl-8-hexadecenoate (S)-33

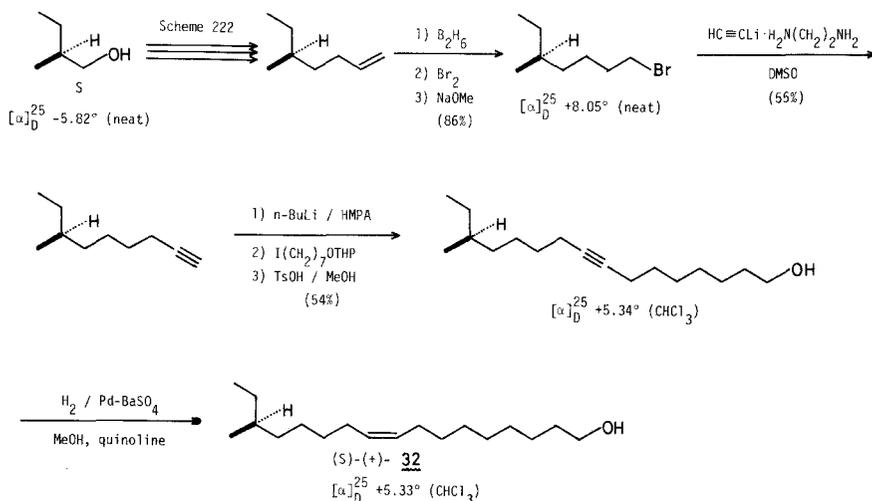
These were isolated as the pheromones of dermestid beetle and levorotatory (see Sections 5-14).¹⁵⁴ Their absolute configurations, however, were unknown. Mori synthesized (*S*)-pheromones starting from commercially available (*S*)-(+)-2-methylbutanol (Scheme 222).^{360, 361} The synthesis was based on an acetylenic route. The synthesized (*S*)-pheromones were dextrorotatory, therefore the natural pheromones possess the *R*-configuration. Later Rossi and Carpita repeated Mori's work with some improved procedures. Their work is shown in

Scheme 223.³⁸⁴ The limitation of this approach is evident when one considers the unavailability of (*R*)-(+)-2-methylbutan-1-ol as a natural product. The synthesis of the natural (*R*)-enantiomer was carried out by quite a different route as will be described later (Scheme 254).

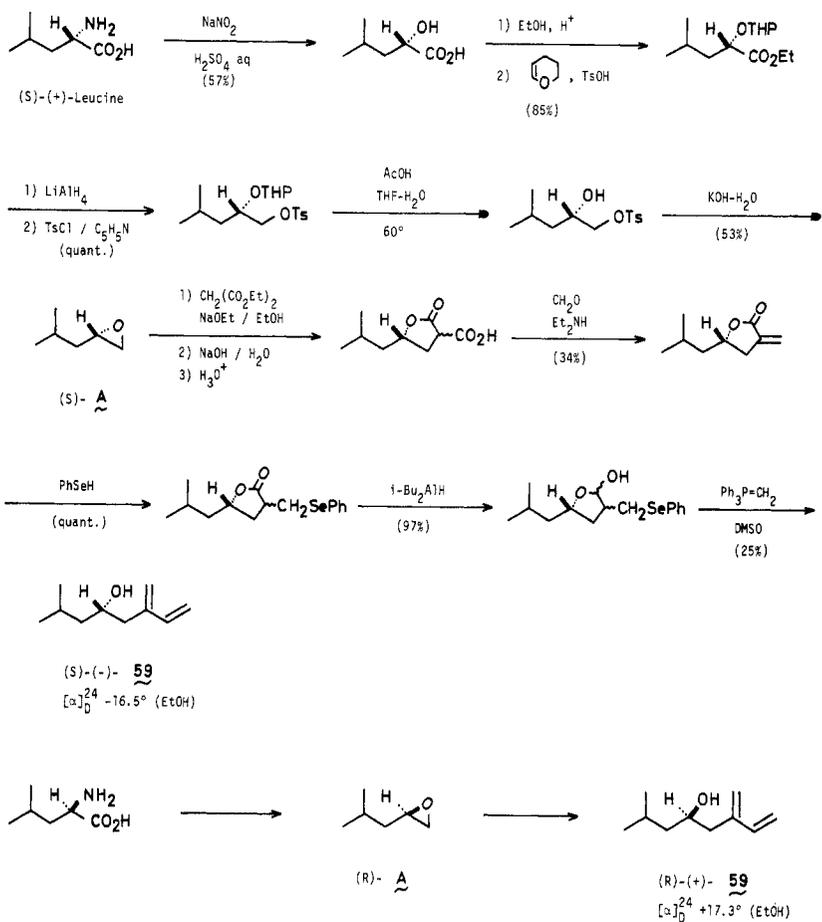

(S)-(-)-Ipsenol (S)-59 and Its Antipode (R)-59

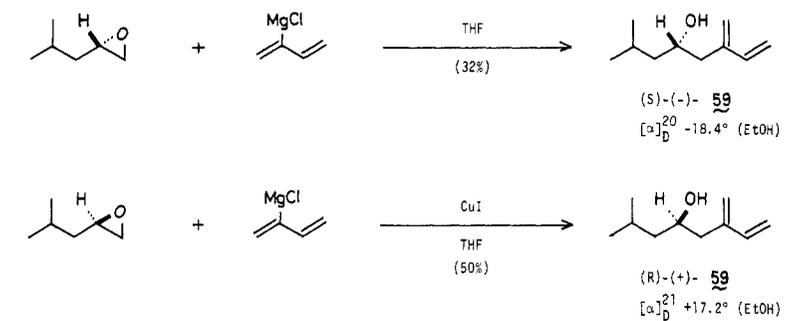
The natural ipsenol, isolated by Silverstein et al. from the frass of *Ips paraconfusus*, was levorotatory: $[\alpha]_{\text{D}}^{25} -17.5^{\circ} \pm 0.7^{\circ}$ (EtOH).^{270, 385} Mori's first synthesis was rather lengthy employing a chiral epoxide **A** and a chiral α -methylene- γ -lactone as intermediates (Scheme 224).^{386, 387} Chiral epoxides were particularly useful intermediates in chiral syntheses. In this case the epoxide was prepared from leucine. The second synthesis by Mori et al. is the chiral version of the Kondo synthesis of (\pm)-**59** (see Scheme 155²⁷⁶) and also employed the chiral epoxide **A** (Scheme 225).³⁸⁸ Since (*S*)-leucine yielded (-)-ipsenol, the natural pheromone was of the *S*-configuration. The biological activity of both enantiomers was studied by Vité et al.³⁸⁹ The five-spined engraver beetle (*Ips grandicollis*) aggregated only in response to the (*S*)-(-)-isomer. The antipode proved nearly inactive. The biological activity of the racemate was inferior to the (*S*)-(-)-isomer when released in comparable quantity, but there was no indication of definite response inhibition by the (*R*)-(+)-isomer. Ipsenol inhibits attack by *Ips pini* on ponderosa pine logs baited with male *Ips pini*.³⁹⁰ Only (*S*)-(-)-ipsenol was responsible for this action as a pheromone inhibitor.³⁹¹

(R)-(-)-Ipsdienol (R)-60 and Its Antipode (S)-60

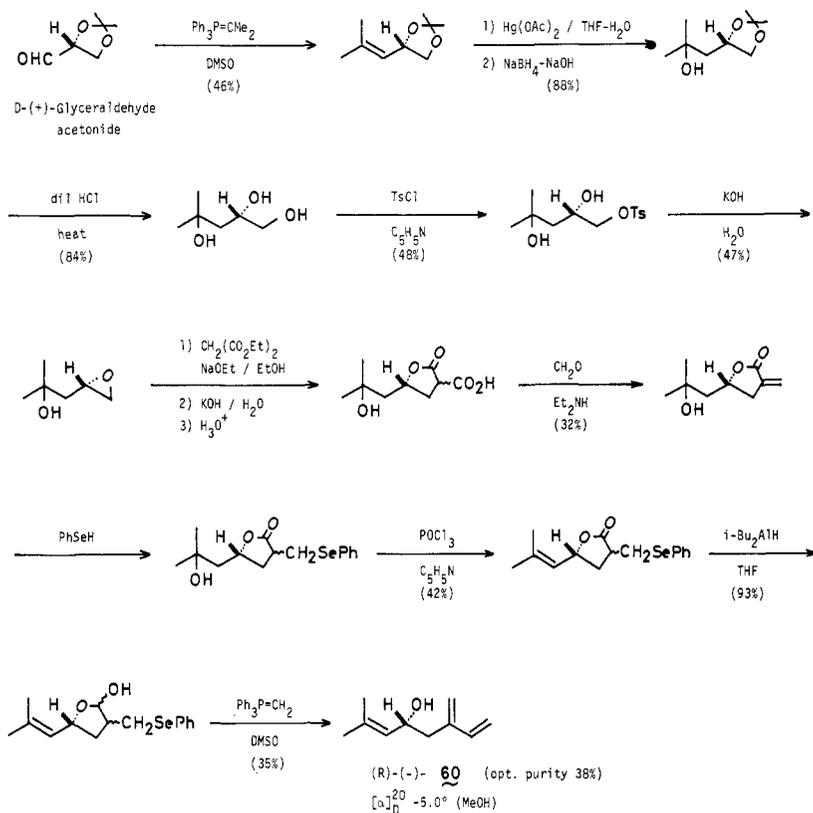
The natural ipsdienol isolated from *Ips paraconfusus* in California was dextrorotatory: $[\alpha]_{\text{D}}^{20} +10^{\circ} \pm 0.9^{\circ}$ (MeOH).^{270, 385} Mori synthesized (*R*)-ipsdienol **60** via a chiral epoxide starting from (*R*)-(+)-glyceraldehyde acetonide as shown in

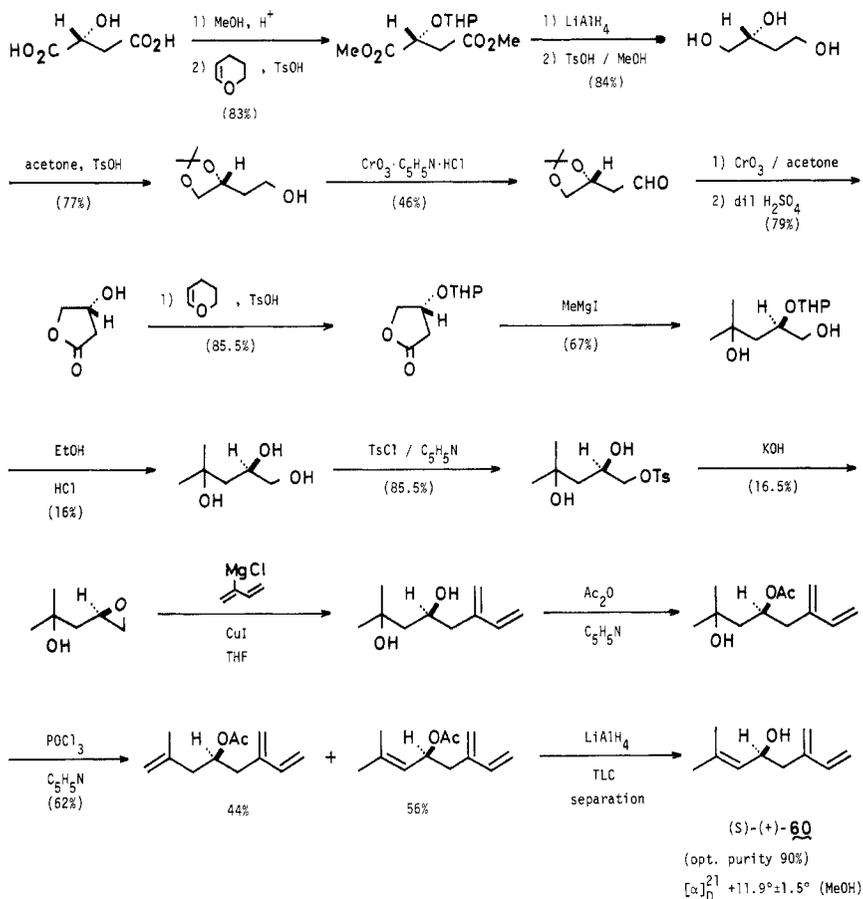

Scheme 226.^{392, 388} The synthetic route was similar to that employed for the synthesis of optically active ipsenol (Scheme 224) except that the extra double bond was introduced, hydrated, and reintroduced by dehydration. The product (R)-**60** was levorotatory. The natural and dextrorotatory pheromone was therefore of the *S*-configuration. Unfortunately in this case the synthetic pheromone was not optically pure (ca. 38% optical purity as shown later by Ohloff³⁹³). Since (*S*)-(-)-glyceraldehyde acetonide was not so readily available as the (*R*)-(+)-isomer, Mori et al. devised a different route to (*S*)-(+)-ipsdienol **60** starting from (*R*)-(+)-malic acid as shown in Scheme 227.³⁸⁸ This synthesis also used a chiral epoxide as the key intermediate and yielded 90% optically pure (*S*)-(+)-**60**. Ohloff and Giersch reported a clever synthesis of optically active ipsdienol from verbenone in only three steps as shown in Scheme 228.³⁹³ The key step of their synthesis is the flash-pyrolysis of 2(10)-pinen-4-ol to give ipsdienol. The

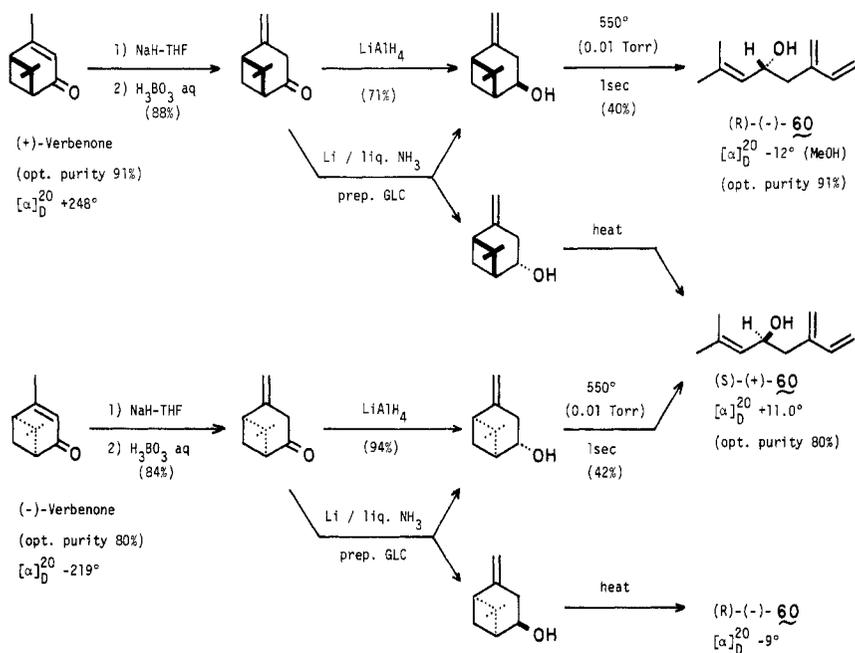

oxygen-bearing chiral center of the pinenols is solely responsible for the configuration of ipsdienols, while the two bridgehead chiral centers are destroyed during pyrolysis. Their synthetic ipsdienol showed larger $[\alpha]_D$ value than the natural pheromone and they concluded that the optical purity of the natural ipsdienol was about 75%.

The availability of these fairly optically pure ipsdienol enantiomers prompted Vité to study chirality-activity relationship.³⁹⁴ The results were very interesting. Both *Ips calligraphus* and *I. avulsus* responded to (R)-(-)-ipsdienol. However, *I. paraconfusus* was attracted by (S)-(+)-ipsdienol. Thus there are certainly species-specific differences in response to the ipsdienol enantiomers.

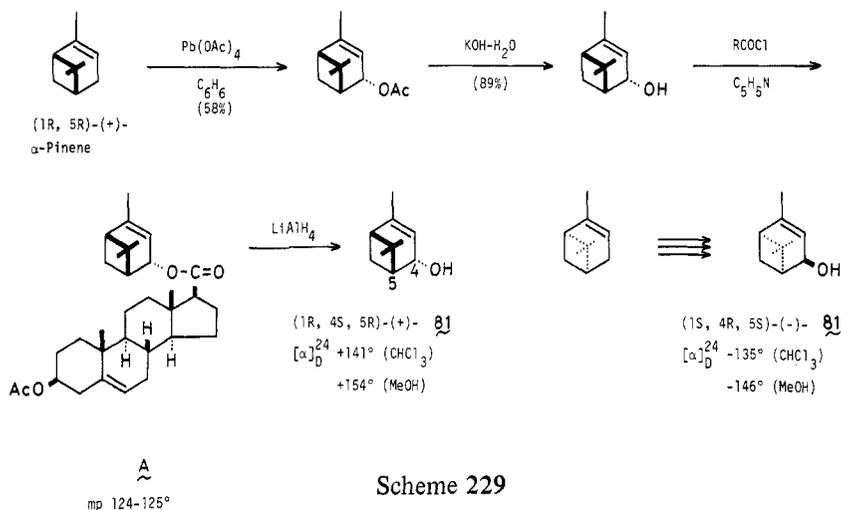

**(1R, 4S, 5R)-(+)-2-Pinen-4-ol[(+)-trans-verbenol, (+)-81]
and Its Antipode [(-)-81]**

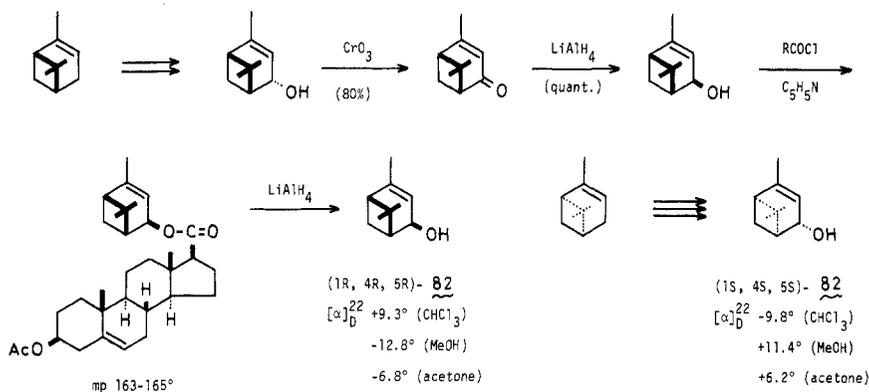
trans-Verbenol **81** was shown to be present in the hindguts of the bark beetles, *Dendroctonus brevicomis* and *D. frontalis*³⁹⁵ and later isolated from the hindguts of female *Dendroctonus ponderosae* as an aggregation pheromone.³⁹⁶ Selective conversion of (+)- α -pinene to (+)-*trans*-verbenol was observed in *Ips paraconfusus*, while (-)- α -pinene was selectively converted to (*S*)-*cis*-verbenol **82**.³⁹⁷ In this insect, therefore, (+)-*trans*-verbenol should be optically pure. However, about 200 μ g of *trans*-verbenol isolated from female southern pine beetles (*Dendroctonus frontalis*) was shown to be a 60 : 40 mixture of (+)- and (-)-*trans*-verbenol **81** by the chiral shift reagent method.³⁸² Mori synthesized the pure enantiomers of **81** from α -pinene (Scheme 229).³⁹⁸ Fairly optically pure *trans*-verbenol was converted to the 3 β -acetoxyetienate **A**, which was repeatedly recrystallized to effect purification. Removal of the steroid portion by reductive cleavage yielded optically pure *trans*-verbenol **81**.

***(1S, 4S, 5S)*-2-Pinen-4-ol [*(S)*-*cis*-verbenol, (*S*)-**82**] and Its Antipode [*(R)*-**82**]**

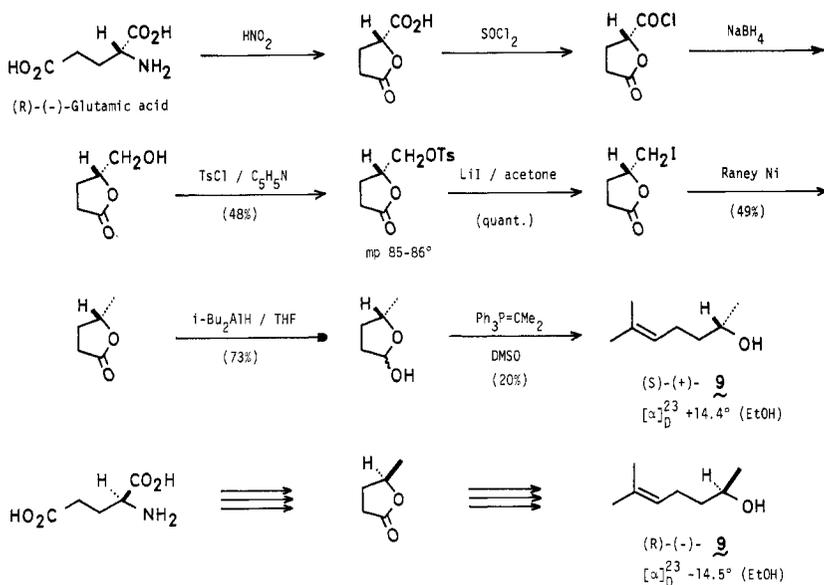
cis-Verbenol **82** was first isolated from male frass of a bark beetle (*Ips paraconfusus*) as a component of the aggregation pheromone.^{270, 385} Later it was found among other bark beetles such as *Ips latidens*³⁹⁹ and *Ips calligraphus*.⁴⁰⁰ $(1R, 4S, 5R)$ -2-Pinen-4-ol (*trans*-verbenol **81**) was converted to $(1R, 4R, 5R)$ -2-pinen-4-ol (*cis*-verbenol **82**) as shown in Scheme 230.⁴⁰¹ The crystalline β -acetoxyetienate of *cis*-verbenol was purified by repeated recrystallization. The optically pure $(1R, 4R, 5R)$ -2-pinen-4-ol was dextrorotatory in chloroform but levorotatory in methanol or in acetone. Since the natural pheromone is known



to be dextrorotatory in methanol or in acetone, it is (1*S*, 4*S*, 5*S*)-2-pinen-4-ol or (*S*)-*cis*-verbenol. The biological activity of the both enantiomers of *cis*-verbenol was tested on *Ips typographus*⁴⁰² and on *Ips calligraphus*⁴⁰³. Only (*S*)-*cis*-verbenol was active. Deploying the isomers at equal rate, (*R*)-*cis*-verbenol does not interfere with response of *Ips calligraphus* to (*S*)-*cis*-verbenol. However, released at a tenfold higher concentration, (*R*)-*cis*-verbenol strongly inhibits response to the (*S*)-isomer.⁴⁰³

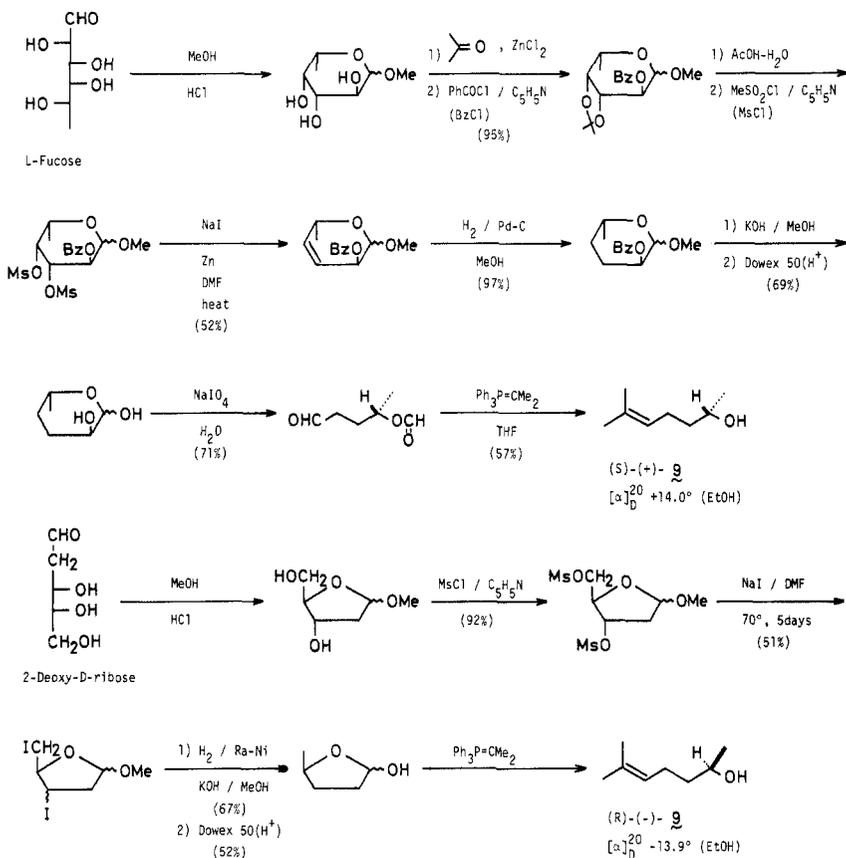
**(*S*)-(+)-Sulcatol [6-methyl-5-hepten-2-ol (*S*)-9]
and Its Antipode [(*R*)-9]**

This is an aggregation pheromone produced by males of *Gnathotrichus sulcatus*, an economically important ambrosia beetle in the Pacific coast of North America.¹⁶ By detailed NMR analysis using MTPA ester method, the natural pheromone was shown to be a 65/35 mixture of the (*S*)-(+)- and (*R*)-(-)-enantiomers. The racemate was obtained by the sodium borohydride reduction of 6-methyl-5-hepten-2-one.¹⁶ Mori synthesized both enantiomers in an optically pure state starting from glutamic acid (Scheme 231a).¹⁷ γ -Tosyloxymethyl- γ -butyrolactone was highly crystalline and could be easily purified to an optically pure state. In laboratory and field bioassays, *G. sulcatus* responded to sulcatol only when both enantiomers were present. Response was greater to racemic sulcatol than to a mixture (65 : 35) of (*S*)-(+)- and (*R*)-(-)-enantiomers, the

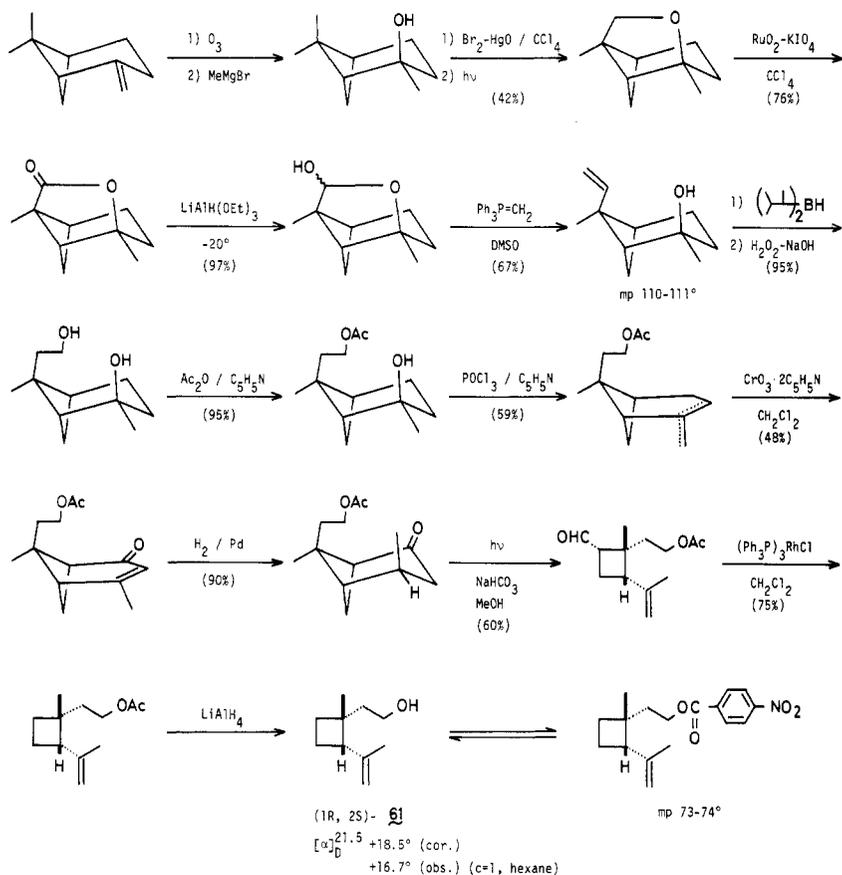

naturally occurring isomeric ratio. This fact implies the presence of enantiomer-specific active sites on receptor proteins in the same or different cells.¹⁸

Another synthesis by Schuler and Slessor employed carbohydrate precursors as shown in Scheme 231b.⁴⁸⁴ Thus (*S*)-(+)-sulcatol was synthesized from L-fucose by deoxygenation, carbon chain shortening, and a Wittig reaction. 2-Deoxy-D-ribose was converted to (*R*)-(-)-sulcatol by deoxygenation and a Wittig reaction. This synthesis, however, seems to be more complicated than that by Mori. Utilization of carbohydrates in a chiral synthesis often requires an efficient method of deoxygenation to destroy unnecessary chiral centers.⁴⁸⁵

(1*R*, 2*S*)-(+)-Grandisol (1*R*, 2*S*)-61 and Its Antipode (1*S*, 2*R*)-61

Natural grandisol is known to be dextrorotatory, $[\alpha]_{\text{D}} + 50^\circ \pm 10^\circ$.²⁸⁴ Hobbs and Magnus accomplished the first synthesis of (1*R*, 2*S*)-grandisol starting from

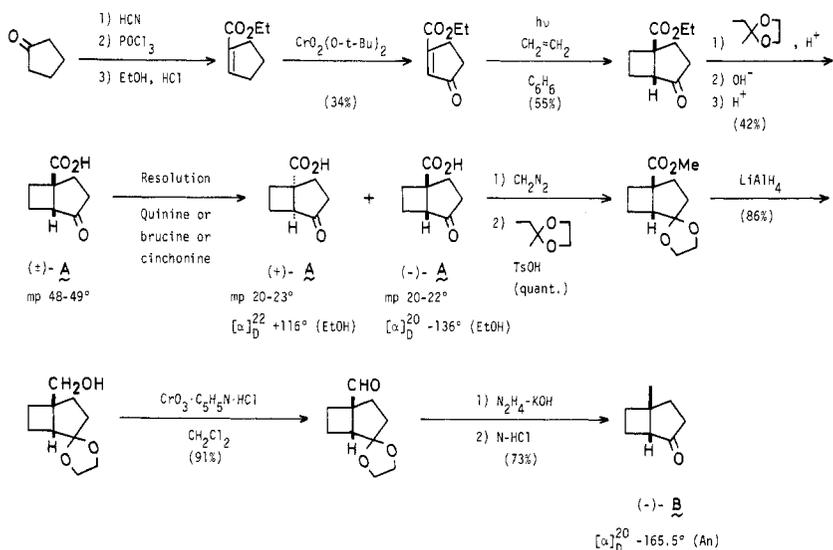

90% optically pure (1*S*, 5*S*)-(-)- β -pinene as shown in Scheme 232.^{404, 405} The grandisol obtained was dextrorotatory: $[\alpha]_{\text{D}}^{21.5} +18.5^{\circ}$ (corrected for the optical purity of β -pinene). The natural grandisol is therefore 1*R*, 2*S*. The large $[\alpha]_{\text{D}}$ value of the natural pheromone might be overestimated.

Mori then published the synthesis of the both enantiomers of grandisol by resolving his intermediate (Scheme 233).⁴⁰⁶ A bicyclic keto-acid **A** obtained by photocycloaddition was resolved with alkaloids. Then the resolved acid (-)-**A** was converted to a bicyclic ketone (-)-**B**. This yielded an acid **C** contaminated with 10-20% of the *trans*-isomer. This was purified by iodolactonization-reduction. The resulting (1*R*, 2*S*)-(+)-grandisol was about 80% optically pure. Similarly (-)-grandisol was synthesized from (+)-**A**. This, too, was shown to be 80% optically pure.

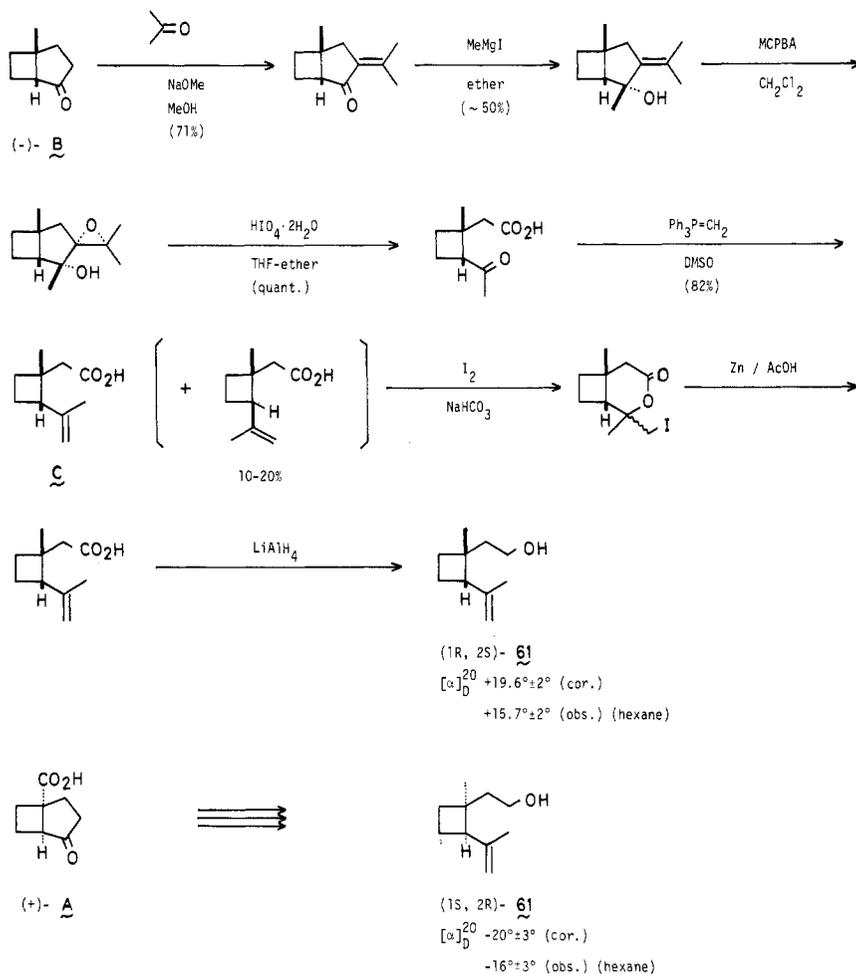

In order to secure highly optically pure (-)-grandisol, the antipode of the natural pheromone, another synthesis was carried out. The synthesis of (-)-grandisol was essential in clarifying the chirality-activity relationship of the boll weevil pheromones. Thus (±)-grandisol was oxidized to (±)-A. It was resolved with quinine and the resulting (-)-A was reduced to give (1S, 2R)-(-)-grandisol with 91-98% optical purity (Scheme 234).⁴⁰⁷ This (-)-61 and the previously synthesized (+)-isomer of about 80% optical purity⁴⁰⁶ were bioassayed in the United States, and surprisingly both were fully active on female *Anthonomus grandis*.⁴⁰⁷

**(R)-(+)-Seudenol [3-methyl-2-cyclohexen-1-ol, (R)-83]
 and Its Antipode (S)-(-)-83**

Seudenol is an aggregation pheromone isolated from female hindguts of the Douglas fir beetle, *Dendroctonus pseudotsugae*.⁴⁰⁸ The natural pheromone is racemic.³⁸² This posed a very interesting problem as to the pheromone activity of the pure enantiomers of seudenol: is only one enantiomer responsible for the beetle aggregation or not? To answer this question, both enantiomers of seudenol **83** were synthesized as shown in Scheme 235.⁴⁰⁹ It should be mentioned that the resolution of (±)-seudenol **83** was unsuccessful.⁴⁰⁹ Instead of seudenol itself, the more stable 3-iodo-2-cyclohexen-1-ol **A** was resolved, and its absolute configuration was correlated with that of 2-cyclohexen-1-ol. The iodoalcohol

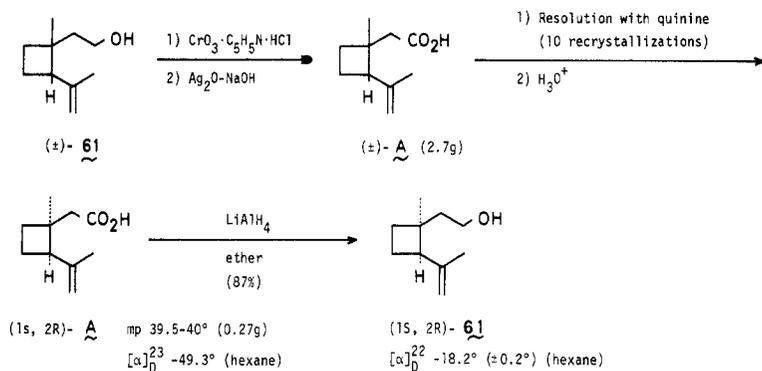

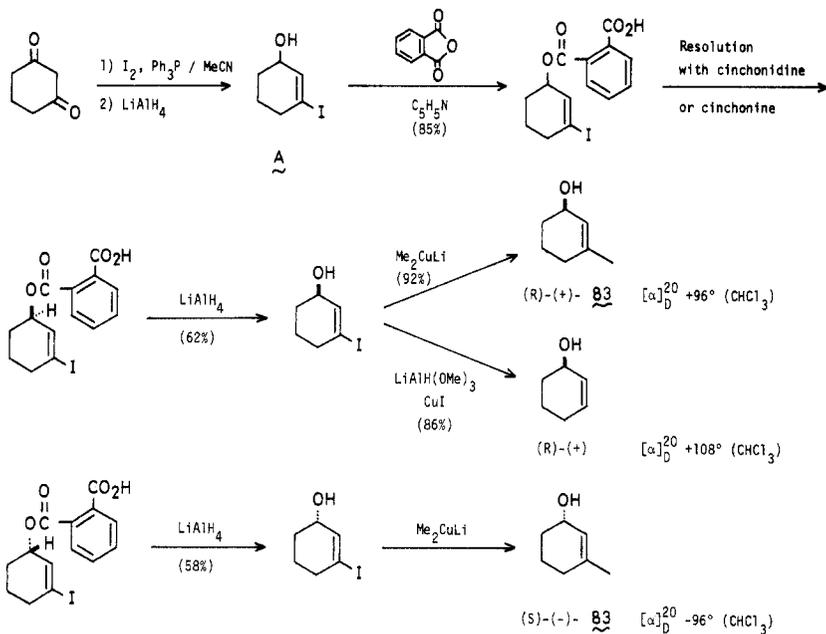
was converted to seudenol **83** with lithium dimethylcuprate. Field tests with synthetic materials revealed that (±)-**83** was more active than either (-)- or particularly (+)-**83** alone.⁴¹⁰

erythro-3,7-Dimethylpentadec-2-yl Acetate **84** and Propionate **85**

In 1976 Jewett et al. identified 3,7-dimethylpentadecan-2-ol as the alcohol in three species from two genera of pine sawflies.⁴¹¹ In *Neodiprion lecontei* and

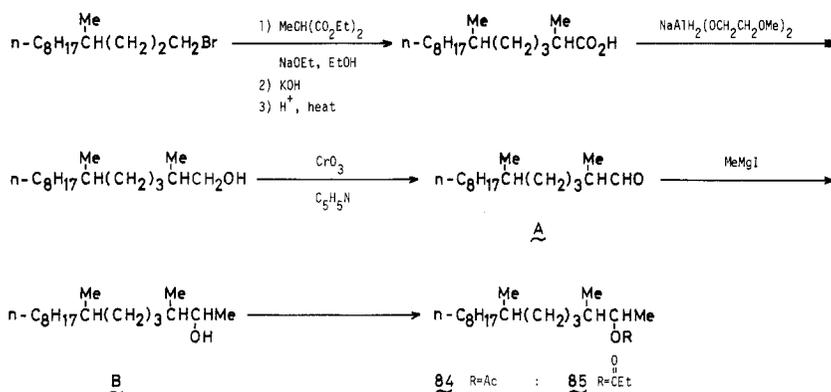

N. sertifer, the acetate **84** of this alcohol was the major component of their sex attractant, while in *Diprion similis*, it was the propionate **85**.⁴¹¹ The alcohol possesses three asymmetric carbon atoms and therefore can exist in eight stereoisomeric forms. Here we also treat the syntheses of stereoisomeric mixtures so that we can understand the importance of stereoselective synthesis. The first synthesis by Jewett et al. is shown in Scheme 236^{411,412} The addition of methylmagnesium iodide to an aldehyde **A** was controlled according to Cram's rule and the resulting alcohol **B** contained more of the *erythro*-isomer, which showed an identical NMR pattern in its methyl signal region with that of the natural pheromone. The relative stereochemistry at C-2 : C-3 was therefore assigned to be *erythro* and the number of the possible stereoisomers was reduced to four. Some analogs of **84** and **85** were also prepared by Jewett et al.⁴¹²

The second synthesis by Kocienski and Ansell proceeded in satisfactory overall yield starting from 2,6-dimethylcyclohexanone (Scheme 237).⁴¹³ The crucial step was a Beckmann fragmentation of the oxime **A** to the isomeric unsaturated nitrile **B**, which proceeded in 90% yield when **A** reacted with 2 eq of *p*-TsCl in refluxing pyridine.

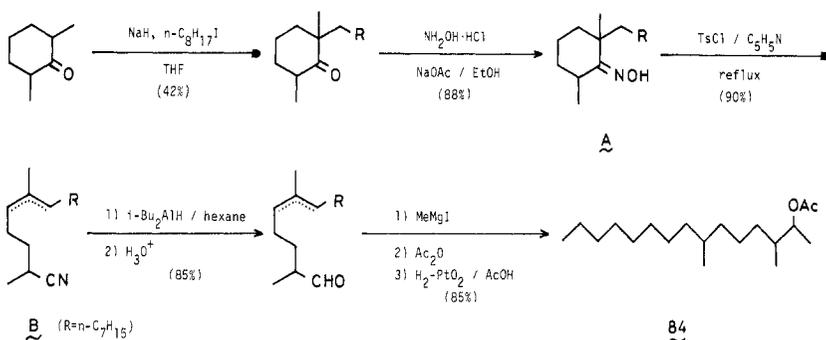
A synthesis by Gore et al. utilized a two-step synthetic sequence for aldehyde **D** by (1) the reaction of a vinylallenic Grignard reagent **A** with an α,β -unsaturated aldehyde **B** and (2) the oxy-Cope rearrangement in refluxing diglyme of the resulting 4-ethynylhexa-1,5-dien-3-ol **C** as shown in Scheme 238.⁴¹⁴ This led to a diastereomeric mixture of **84** in 47% overall yield from alcohol **C**.

Magnusson's synthesis, like Kocienski's, employed a cyclohexanone as the starting material. But he thoughtfully used *cis*-2,3-dimethylcyclohexanone **A** so that the *erythro*-configuration at C-2 : C-3 of **84** might be formed by fragmentation of the cyclohexanone. Controlling the relative configuration at C-2 : C-3 in

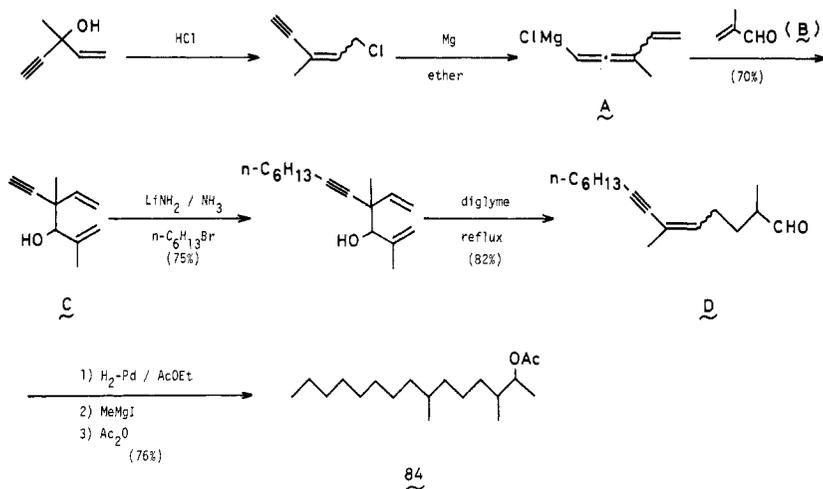

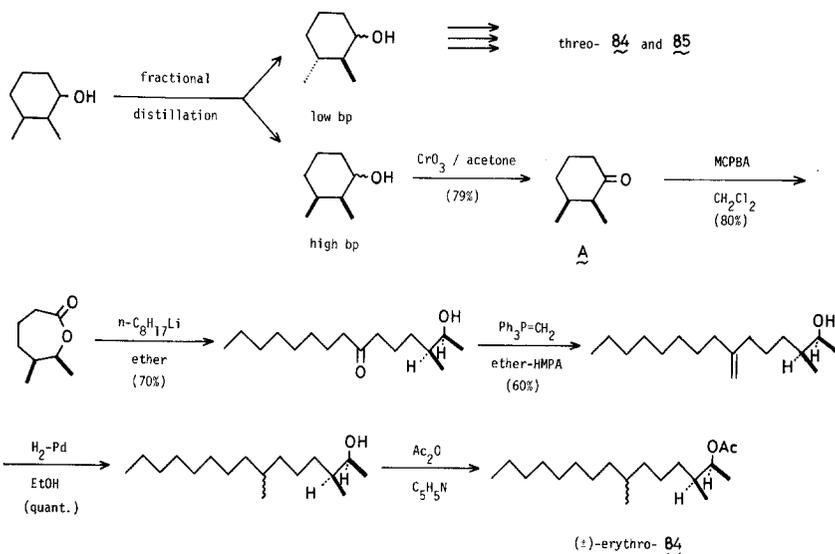

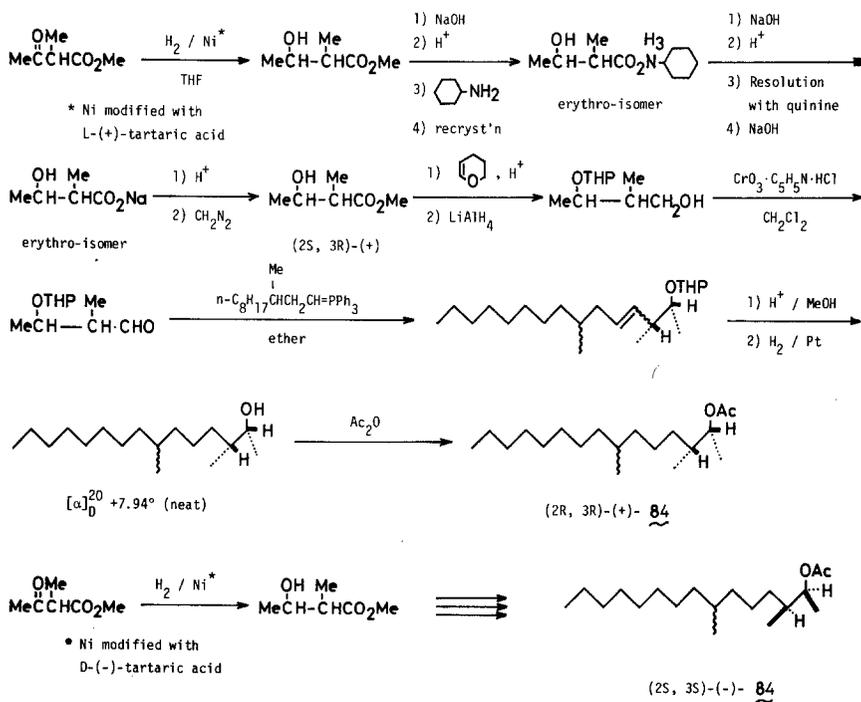

this manner, he obtained **84** as a mixture of two diastereomeric racemates. The stereochemistry at C-7 could not be controlled in this synthesis as shown in Scheme 239.^{415, 416} He also prepared the *threo*-isomer of **84** by employing *trans*-2,3-dimethylcyclohexanone as the starting material.⁴¹⁶ The propionate **84** was also prepared.⁴¹⁶

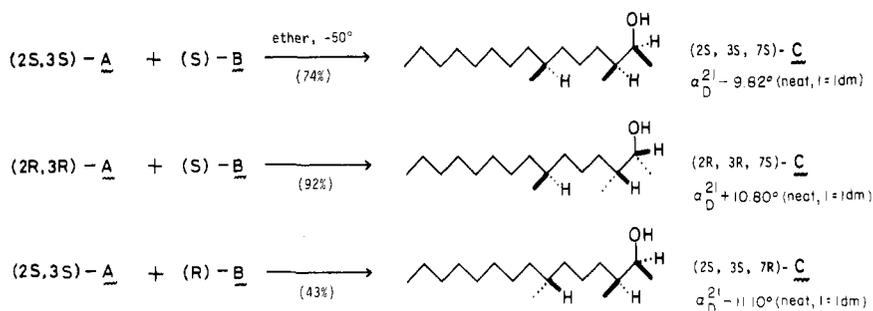
Tai et al. synthesized (2*R*, 3*R*)-(+)-**84** and (2*S*, 3*S*)-(-)-**84** by the sequence shown in Scheme 240.⁴¹⁷ They applied their new method of asymmetric hydrogenation with a modified nickel catalyst.⁴¹⁸ Thus, in the key-step, asymmetric (enantioface-differentiating) hydrogenation of methyl 2-methyl-3-oxobutyrate

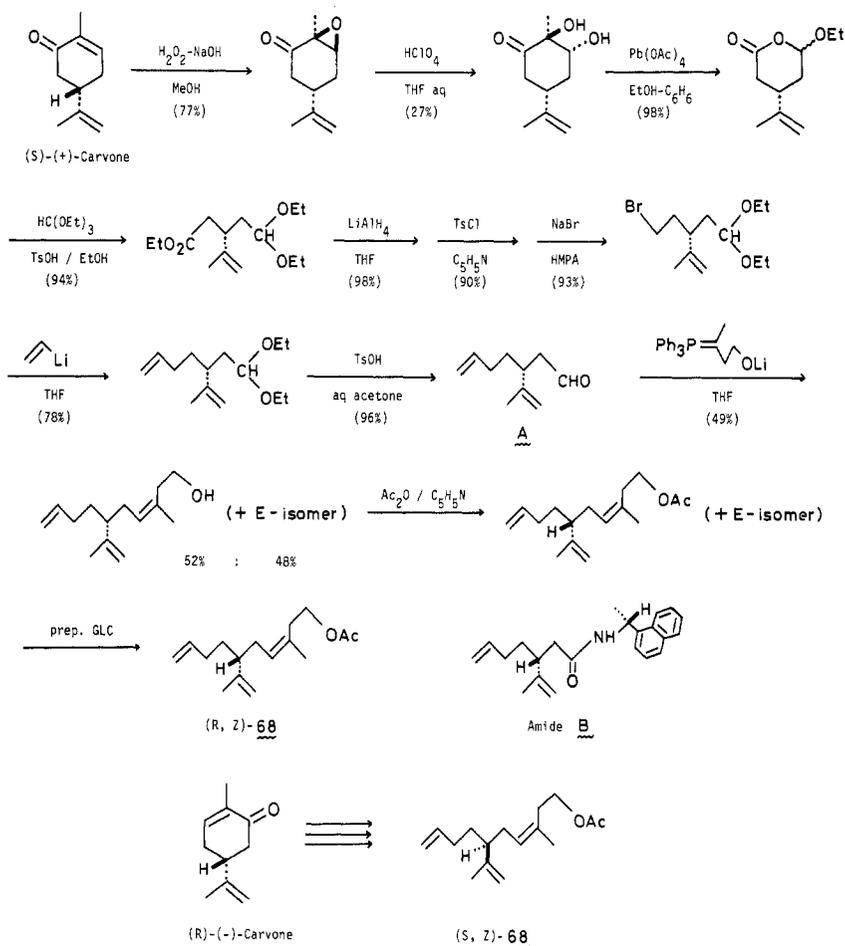
over a nickel catalyst modified with L-(+)-tartaric acid gave methyl 3-hydroxy-2-methylbutyrate in high diastereomeric (*erythro*/*threo*=78/22) and enantiomeric (2*S*, 3*R*)/(2*R*, 3*S*)=84/16) excess. This asymmetric hydrogenation provided a great advantage for further optical resolution. Unfortunately, they could not control the configuration at C-7.^{417, 486}

A stereocontrolled synthesis of all of the four possible stereoisomers of *erythro*-84 and 85 was accomplished by Mori and Tamada as shown in Scheme 241a,b.^{419, 420} The key feature of this synthesis was a stereoselective oxirane cleavage reaction ($A + B \rightarrow C$). The attack of a chiral organocopper reagent (**B**) to a chiral epoxide (**A**) provided the chiral alcohol **C**. The chiral epoxide **A** was prepared from tartaric acid and the chiral organocopper **B** was derived from (*R*)-(+)-citronellol. All possible stereoisomers of 84 and 85 was obtained in optically pure state by this synthesis and their pheromone activity was evaluated by field tests. *Neodiprion pinetum* in the United States was attracted only by (2*S*, 3*S*, 7*S*)-84.⁴²¹ On *Neodiprion sertifer* in Wales, the (2*R*, 3*R*, 7*S*)- and the (2*S*, 3*S*, 7*S*)-84 and 85 were equally effective in trapping.⁴²² It would, therefore, appear that the important part of these isomers is the 7*S* position in this case.

**(*R*, *Z*)-3-Methyl-6-isopropenyl-3,9-decadien-1-yl acetate (*R*, *Z*)-68
and Its Antipode (*S*, *Z*)-68**

This is one of the two pheromone components of female California red scale (*Aonidiella aurantii*). Both enantiomers of 68 were prepared from (*S*)- or (*R*)-carvone as shown in Scheme 242.³¹⁷ In each case the (*Z*)- and (*E*)-isomers were readily separable by preparative GLC (OV-1 column). Bioassays with each of the four isomers showed that only the (*R*, *Z*)-isomer attracted male red scale. Thus the natural pheromone is (*R*, *Z*)-68. The optical purity of the synthetic pheromone was checked by the HPLC analysis of an amide **B** derived from (*R*)-(+)-1-(1-naphthyl)ethylamine and an acid obtained by the oxidation of the aldehyde **A** and shown to be 98.4-99.0%.

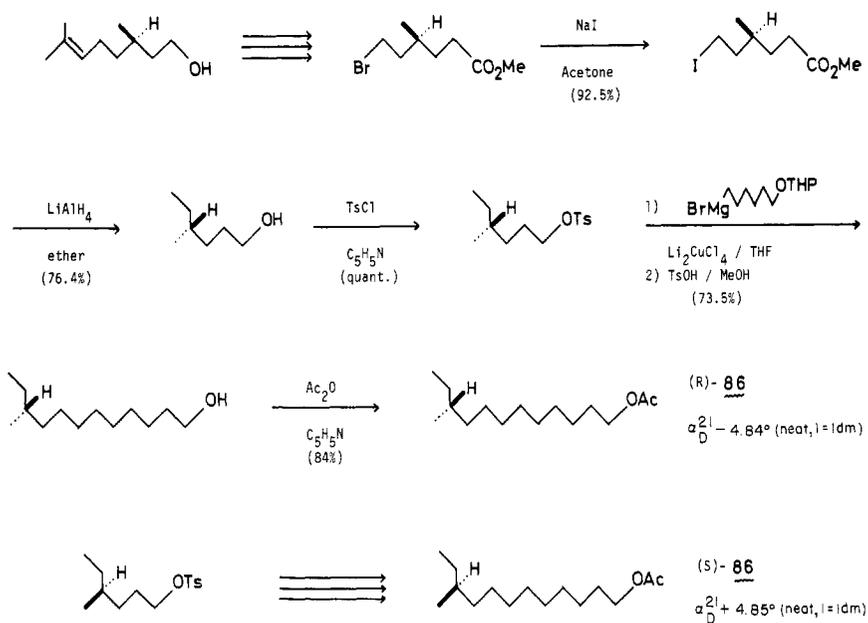

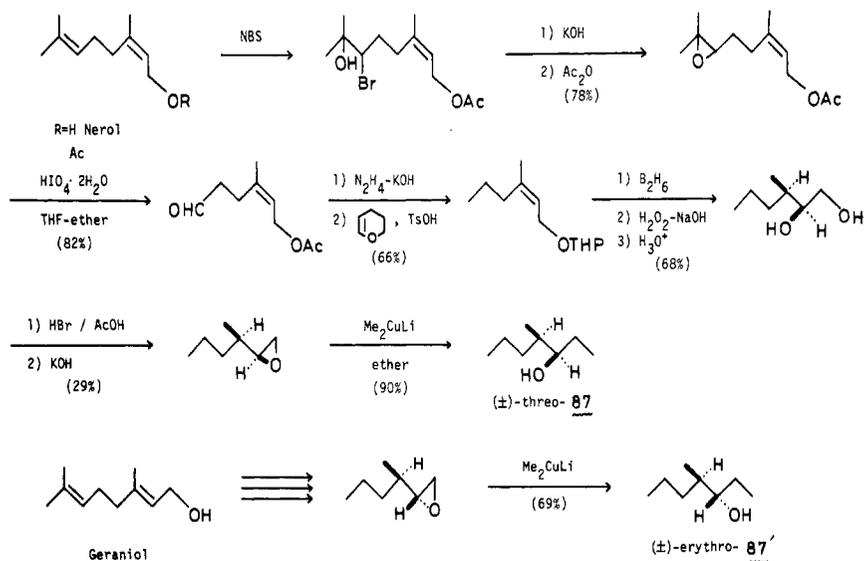

(R)-(-)-10-Methyldodecyl acetate (R)-86 and Its Antipode (S)-86

Tamaki et al. isolated **86** as a minor component (2% of the total amount) of the pheromone complex of the smaller tea tortrix moth (*Adoxophyes* sp.).⁴²³ Both enantiomers of **86** were synthesized from (R)-(+)-citronellol as shown in Scheme 243.⁴²⁴ The key step was the Grignard coupling reaction. Synthesis of the intermediates from citronellol will be detailed in the sections dealing with the dermestid beetle pheromone and the German cockroach pheromone. Preliminary field tests showed that both enantiomers are biologically active.



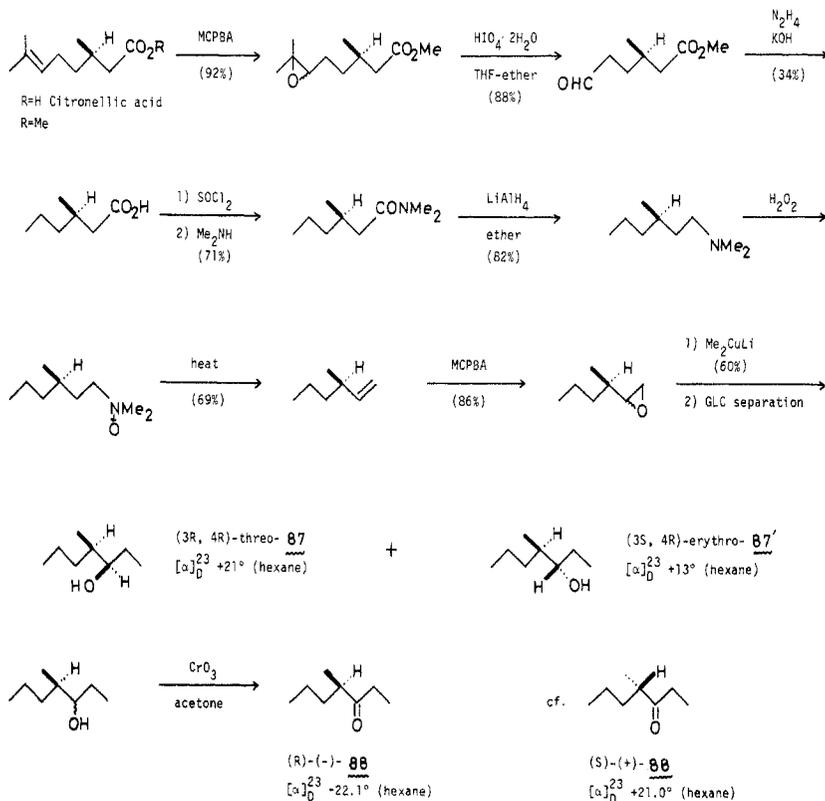

(3R, 4R)-threo-(+)-4-Methylheptan-3-ol (3R, 4R)-87

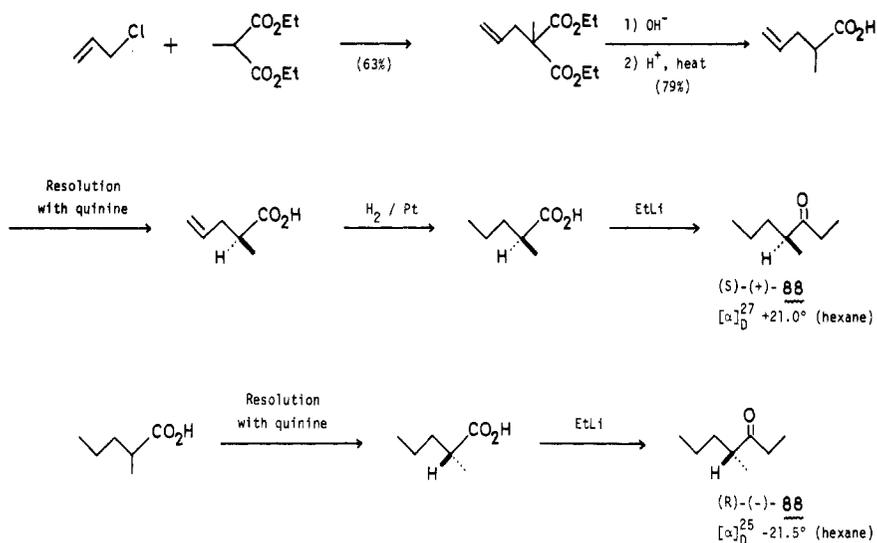
(-)-4-Methylheptan-3-ol [(-)-87] and (-)- α -multistriatin **58** are beetle-produced pheromones responsible for the aggregation of the smaller European elm bark beetles (*Scolytus multistriatus*).²⁶⁵ Mori clarified the relative and absolute stereochemistry of (-)-87 by synthetic means. First, racemic *threo*-87 and *erythro*-87' were prepared from nerol and geraniol, respectively, as shown in Scheme 244.⁴²⁵ The natural pheromone was identical with the *threo*-isomer on the basis of IR, NMR, and GLC. Second, (3R, 4R)-*threo*-4-methylheptan-3-ol **87** was synthesized from (R)-(+)-citronellic acid as shown in Scheme 245.⁴²⁵ The synthesized (3R, 4R)-87 was dextrorotatory. The natural and levorotatory pheromone therefore possesses (3S, 4S)-absolute stereochemistry. The optical purity of the synthetic product was checked by its conversion to the optically pure antipode (R)-(-)-88 of the alarm pheromone of *Atta texana* (S)-(+)-88.

(S)-(+)-4-Methyl-3-heptanone (*S*)-**88** and Its Antipode (*R*)-**88**

This was identified as the principal alarm pheromone of the leaf-cutting ant (*Atta texana*), without specification of chirality.⁴²⁶ The synthesis of the (*S*)-ketone employed the resolved (*S*)-(+)-methylallylacetic acid as the key intermediate (Scheme 246).^{369,370} The (*R*)-ketone was prepared from (*R*)-(-)-2-methylpentanoic acid. The (*S*)-(+)-ketone **88** was about 400 times more active than the (*R*)-(-)-enantiomer on workers of *Atta texana*.³⁶⁹ The (-)-isomer showed no inhibition of the activity of the (+)-enantiomer. The natural pheromone isolated from *Atta texana* or *Atta cephalotes* was dextrorotatory and hence assigned (*S*)-configuration. A synthesis of (*R*)-(-)-**88** from (*R*)-(+)-citronellic acid is shown in Scheme 245.

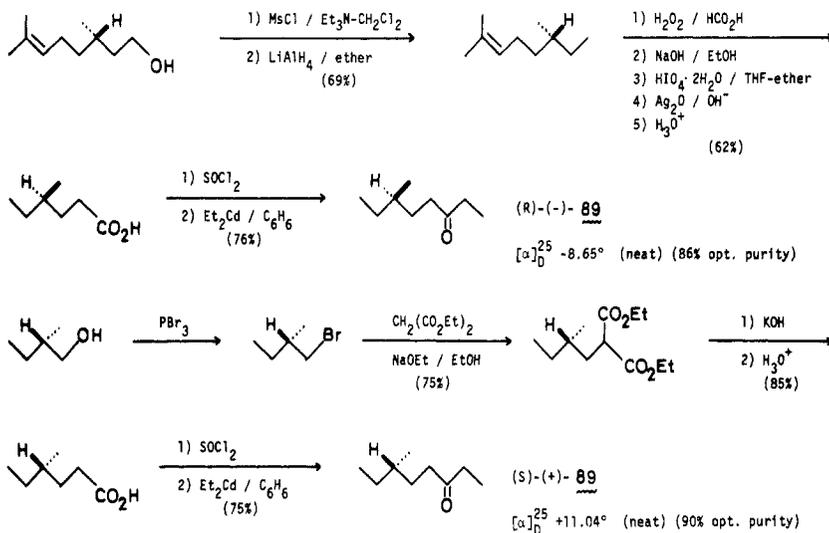

(R)-(-)-6-Methyl-3-octanone (*R*)-**89** and Its Antipode (*S*)-**89**

This was identified as the alarm pheromone of ants in the genus *Crematogaster*.⁴²⁷ Rossi et al. synthesized both enantiomers of **89** as shown in Scheme 247.⁴²⁸ (*R*)-(-)-**89** was prepared in ~33% overall yield starting from commercially available (*S*)-(-)-citronellol, while the antipodal (*S*)-(+)-**89** was synthesized from (*S*)-(+)-2-methyl-1-butanol. Their biological activities are not yet published.

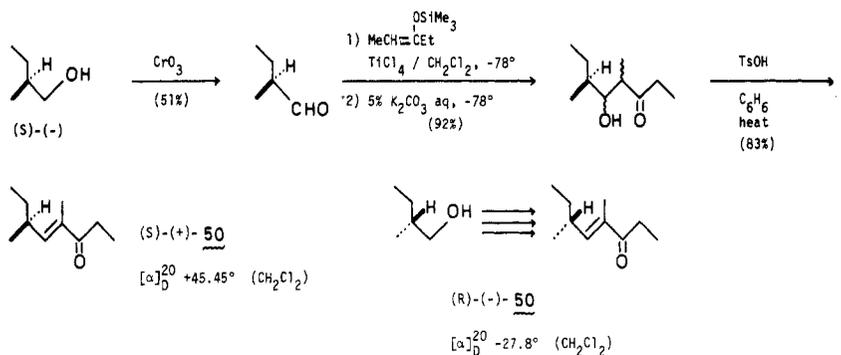

(S)-(+)-Manicone (S)-50 and Its Antipode (R)-50

Manicone **50** is one of the alarm pheromones of ants. The structure was proposed without specification of chirality.²²⁵ (*S*)-(+)-Manicone (*S*)-**50** and its antipode were synthesized by Banno and Mukaiyama employing the titanium tetrachloride-promoted reaction of 3-trimethylsilyloxy-2-pentene with (*S*)-(+)- or (*R*)-(-)-2-methylbutanal.⁴²⁹ The *S*-isomer was 97% optically pure, while the *R*-isomer was of 60% optical purity (Scheme 248).⁴²⁹

**(3*S*, 11*S*)-(+)-3,11-Dimethylnonacosan-2-one (3*S*, 11*S*)-55
and Its Stereoisomers**

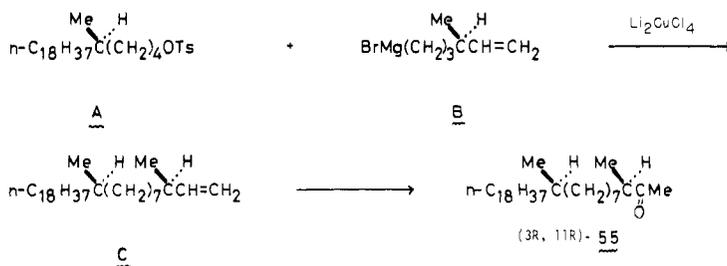
This is the sex pheromone isolated from the cuticular wax of sexually mature females of the German cockroach (*Blattella germanica*).^{239, 240} Mori et al. accomplished the synthesis of all of the four possible stereoisomers of **55** in optically pure forms and established the hitherto unknown absolute configuration of the natural pheromone to be 3*S*, 11*S*.⁴³⁰ The key step was the coupling of a chiral tosylate (**A**) with a chiral Grignard reagent (**B**) to give an olefin (**C**), which was converted to **55** in a standard manner (Scheme 249).⁴³⁰ (*R*)-(+)-Citronellol was the only chiral source used in this synthesis. The preparation of (*R*)- and (*S*)-**A** is shown in Scheme 250. The intermediate alcohol **D** was obtained as crystals. The preparation of (*R*)- and (*S*)-**B** and the coupling of **A** with **B** are shown in Scheme 251. The (3*S*, 11*S*)-ketone was identified as the natural pheromone on the basis of IR, NMR, $[\alpha]_D$ and mixture m.p. determination.

**(3*S*, 11*S*)-(+)-29-Hydroxy-3,11-dimethylnonacosan-2-one
(3*S*, 11*S*)-56 and Its (3*R*, 11*S*)-Isomer**

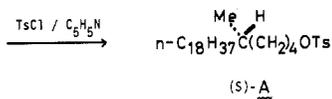
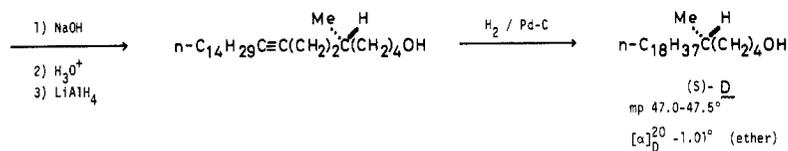
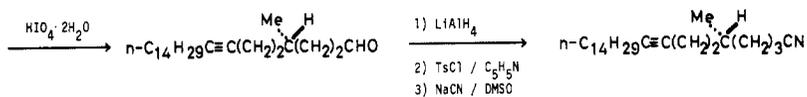
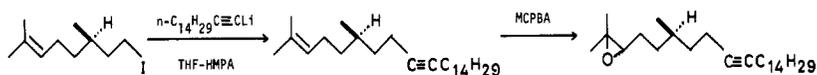
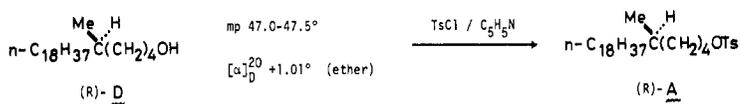
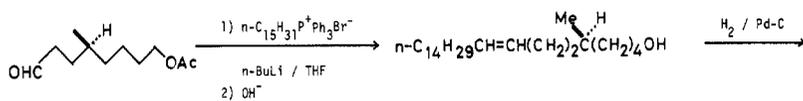
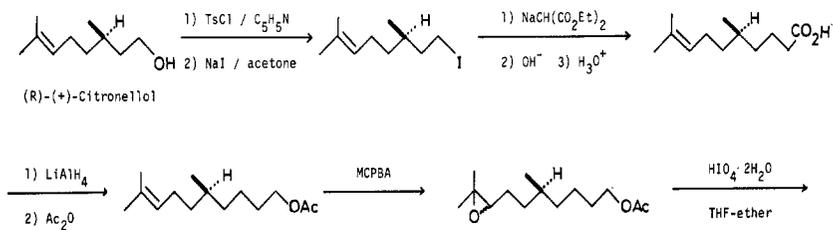
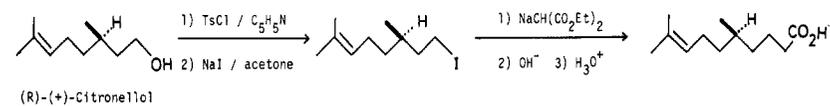
This is also the sex pheromone isolated from female German cockroach (*Blattella germanica*).^{239, 240} Mori and Masuda completed the synthesis of (3*S*, 11*S*)-**56** and its (3*R*, 11*S*)-isomer. The synthetic strategy was same as that used for the synthesis of **55** except that a benzyloxy group was attached at the terminal position of the long alkyl chain of the starting material (Scheme 252).⁴³¹ Comparison of the physical properties of (3*S*, 11*S*)-**56** with those of the natural pheromone strongly suggested their identity, which was proved by direct comparison.

(*R*, *Z*)-(-)-14-Methyl-8-hexadecenal (*R*, *Z*)-90 and Its Antipode (*S*, *Z*)-90

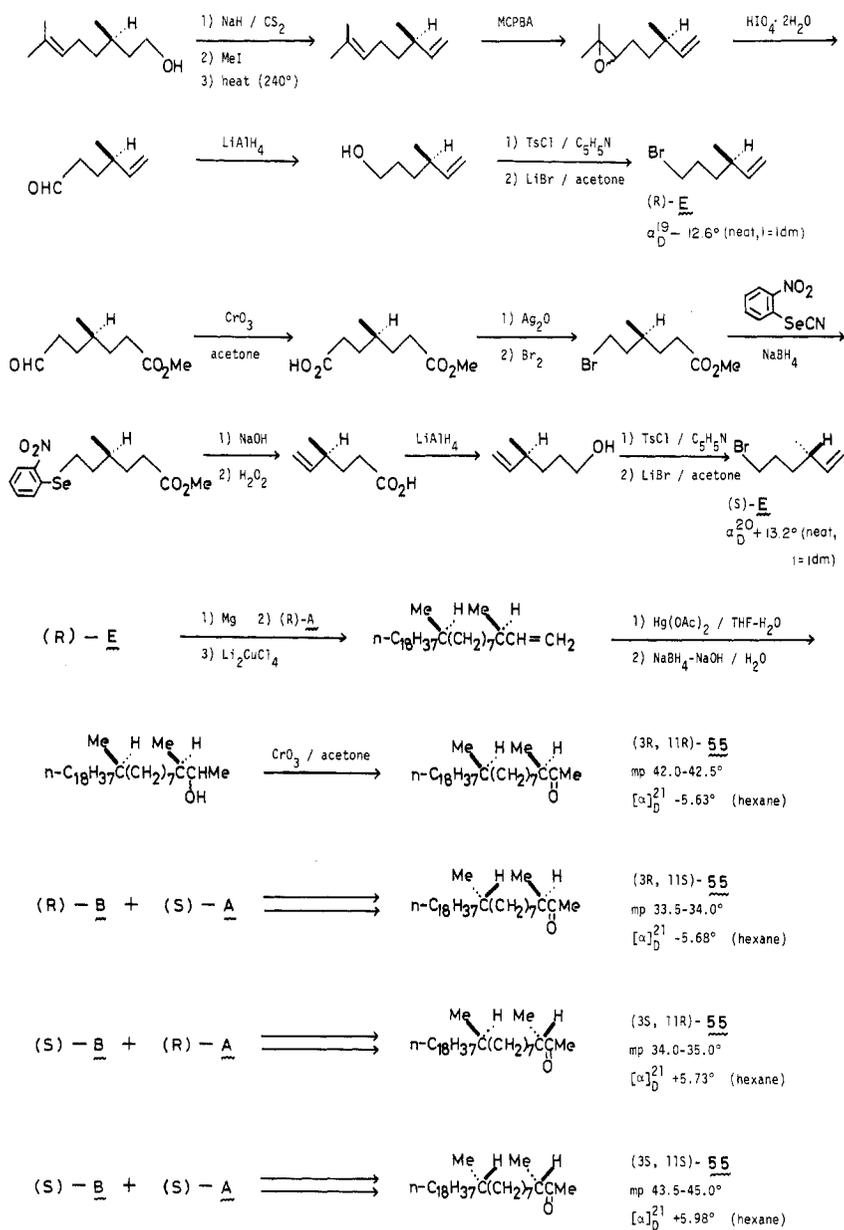
Cross et al. isolated the genuine sex pheromone of *Trogoderma inclusum* and *Trogoderma variabile* by aeration of the female beetles and identified it as (*Z*)-

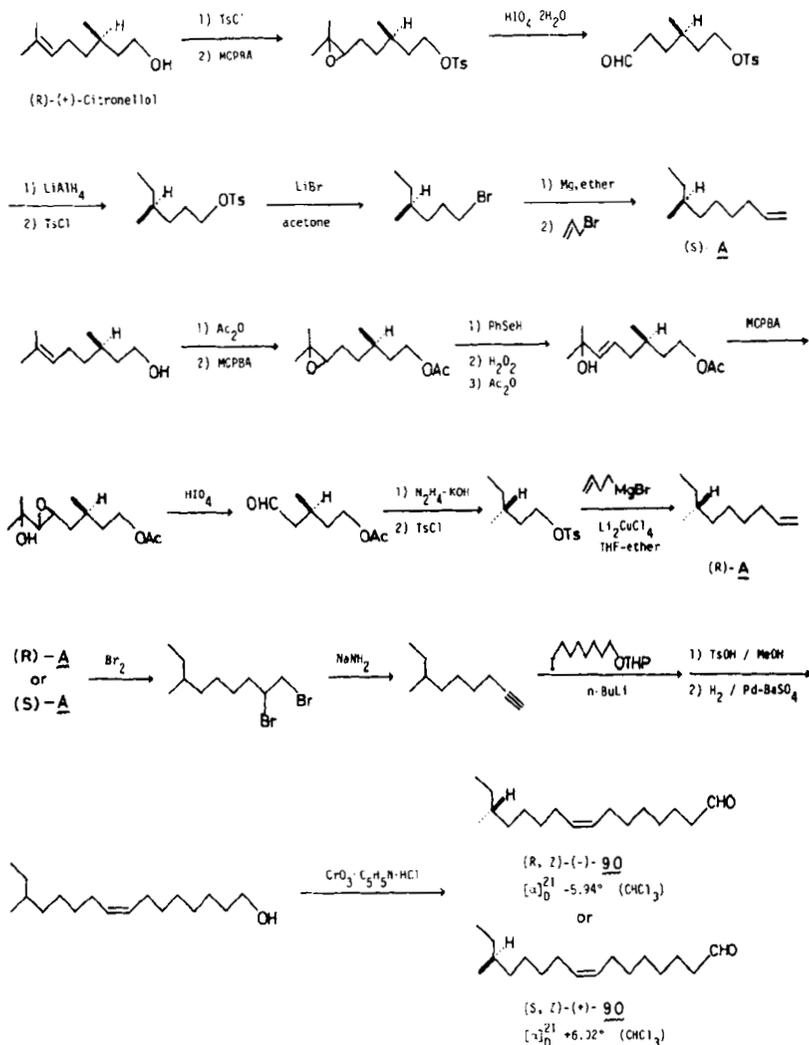

14-methyl-8-hexadecenal **90** without assigning the absolute configuration.¹⁵⁵ Rossi and Carpita synthesized (*S*, *Z*)-**90** by oxidizing (*S*, *Z*)-(+)-**32** (Scheme 253, cf. Scheme 223).³⁸⁴ Rossi and Niccoli claimed that (*S*, *Z*)-(+)-**90**, when mixed with a small amount (8%) of its *E*-isomer, was highly attractive to Khapra beetle (*Trogoderma granarium*).⁴³² Mori et al. synthesized both enantiomers of **90**, employing (*R*)-(+)-citronellol as the common starting material, in a highly optically pure state (Scheme 254).⁴³³ The key intermediate was an optically active

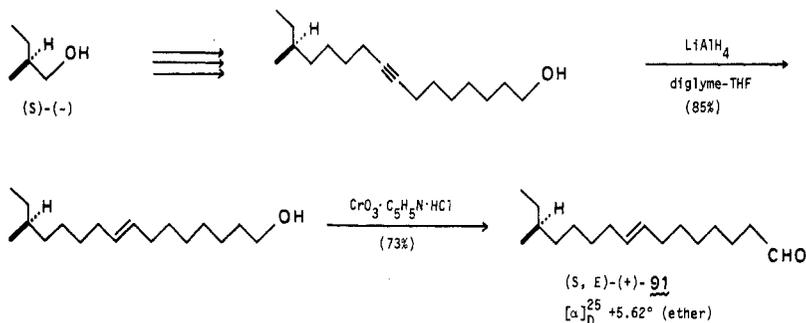

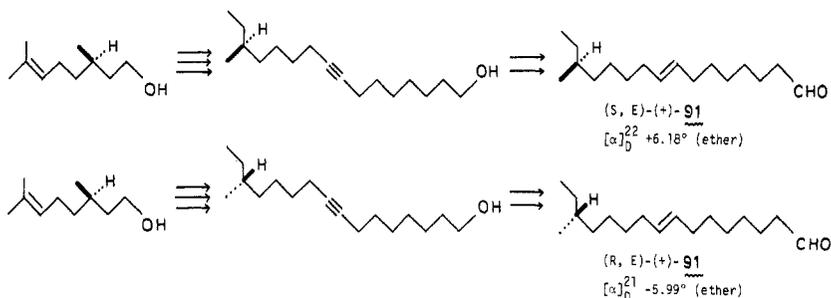
olefin **A**, which was converted to a chiral acetylene and coupled with an achiral intermediate. The (*R*)-isomer was about 250 times more active than its antipode when tested on dermestid beetle (*Trogoderma inclusum*).⁴³³

(*R, E*)-(-)-14-Methyl-8-hexadecenal (*R, E*)-91 and Its Antipode (*S, E*)-91

This is the pheromone of *Trogoderma glabrum* and *Trogoderma granarium* (Khapra beetle).¹⁵⁵ Rossi and Carpita synthesized (*S, E*)-(+)-**91** as shown in Scheme 255.³⁸⁴ Recently both enantiomers were synthesized from (*R*)-(+)-citronellol as an extension of the synthesis of **90** (Scheme 256, cf. Scheme 254).⁴³⁴ The *R*-enantiomer was 10 to 100 times more active than the *S*-isomer on *Trogoderma glabrum*, *T. inclusum*, and *T. variabile*.⁴³⁵

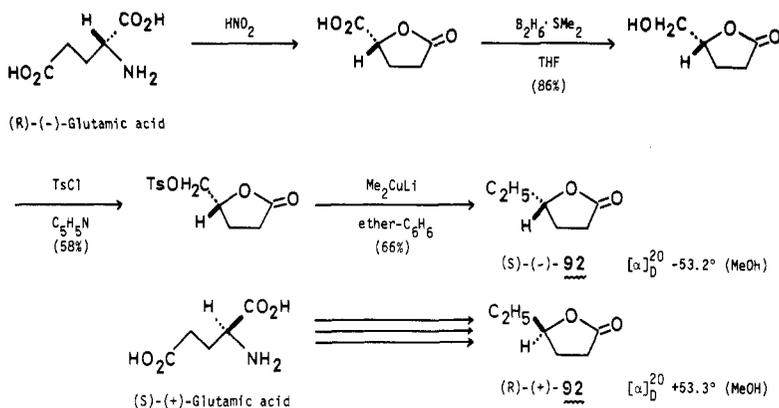

(*R*)-(+)- γ -Caprolactone (*R*)-92 and Its Antipode (*S*)-92

γ -Caprolactone (4-hydroxyhexanoic acid lactone) is a pheromone component of a dermestid beetle, *Trogoderma glabrum*.⁴³⁶ Silverstein et al. synthesized

both enantiomers of this lactone starting from glutamic acid enantiomers as shown in Scheme 257. (cf. Scheme 231).^{437, 438} The optical purity of (*S*)-(-)-**92** was shown to be very high by using Pirkle's chiral solvating agent.⁴³⁹ The optically pure solvating agent (*R*)-(-)-2,2,2-trifluoro-1-(9-anthryl)ethanol (TFAE) can induce NMR spectral nonequivalence between enantiomeric lactones. Substituents on either face of the lactone respond differently to the shielding effect of the anthryl substituent of TFAE. *T. granarium* responds to the (*R*)-(+)-enantiomer of γ -caprolactone but to neither the (*S*)-(-)-enantiomer nor the racemic form.⁴⁴⁰



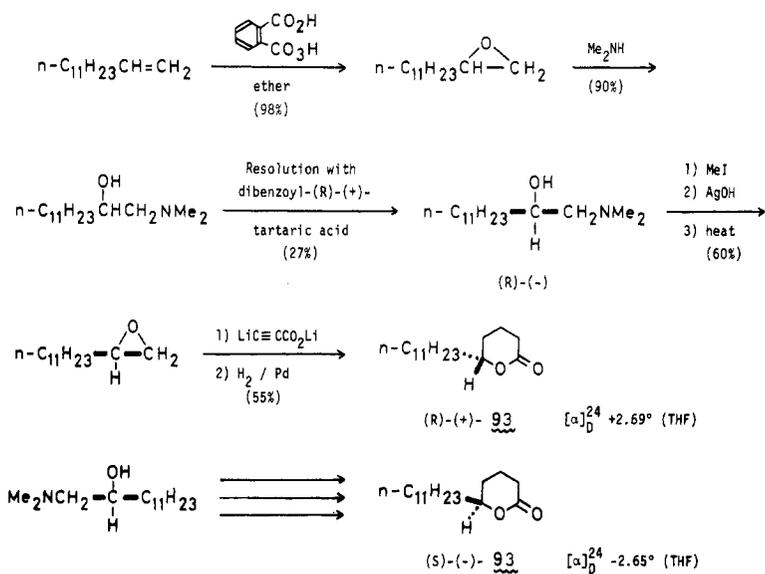

(*R*)-(+)- δ -*n*-Hexadecalactone (*R*)-93 and Its Antipode (*S*)-93

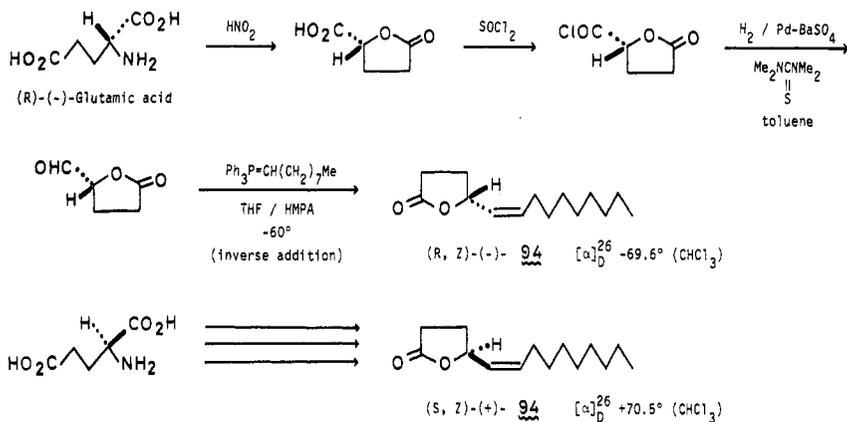
δ -*n*-Hexadecalactone (5-hydroxyhexadecanoic acid lactone) has been found in the mandibular glands of the oriental hornet (*Vespa orientalis*).⁴⁴¹ This plays the role of a queen substance. The (*R*)-(+)- and (*S*)-(-)-enantiomers of **93** were synthesized by Coke and Richon as shown in Scheme 258.⁴⁴² A chiral epoxide was used as the key intermediate in the present synthesis.

(*R*, *Z*)-4-Hydroxy-5-tetradecenoic Acid Lactone (*R*, *Z*)-94 and Its Antipode (*S*, *Z*)-94

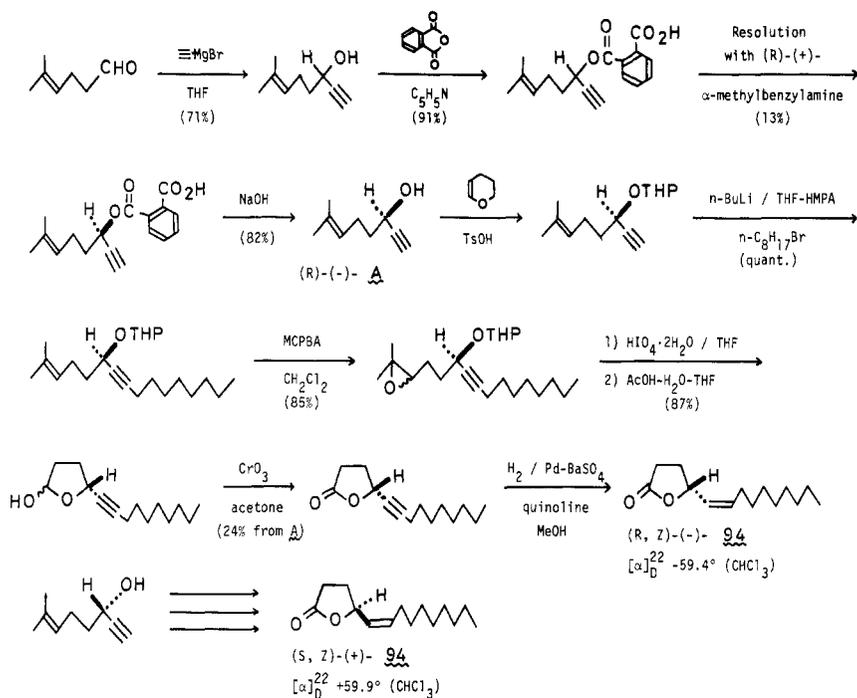
This is the pheromone isolated from the female Japanese beetle (*Popillia japonica*).⁴⁴³ Both enantiomers of **94** were synthesized by Tumlinson et al. from glutamic acid enantiomers (Scheme 259).⁴⁴³ The final products were obtained in highly optically pure states. They employed the Wittig reaction to construct the olefinic linkage. This caused 10-15% contamination by the unwanted (*E*)-isomer

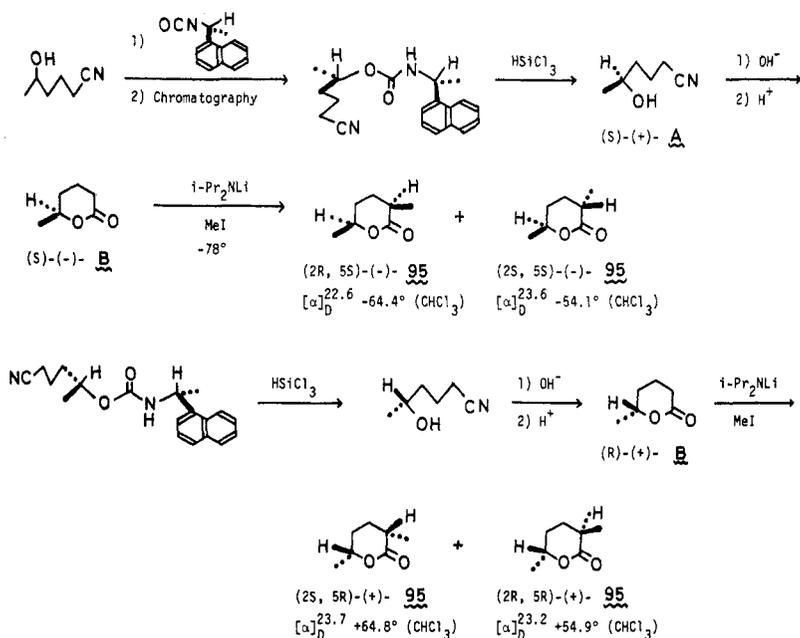

of **94** in the final product, which had to be removed by preparative HPLC and GLC. Bioassay showed that the natural pheromone is (*R*, *Z*)-**94**. Male response was strongly inhibited by small amounts of (*S*, *Z*)-**94**. The racemate of **94** was inactive.

Another synthesis by Mori et al. used resolved intermediates, and the double bond was generated by partial hydrogenation of an acetylenic lactone, which was more stereoselective than the Wittig olefination.⁴⁴⁴ However, the optical purity of the final product was lower than the first synthesis by Tumlinson et al. The route is shown in Scheme 260.⁴⁴⁴

**(2*R*, 5*S*)-2-Methyl-5-hydroxyhexanoic Acid Lactone (2*R*, 5*S*)-95
and Its Stereoisomers (2*S*, 5*S*)-95, (2*S*, 5*R*)-95, (2*R*, 5*R*)-95**

cis-2-Methyl-5-hydroxyhexanoic acid lactone **95** was isolated as the major volatile component of the sex pheromone of the carpenter bee (*Xilocopa hirutissima*).⁴⁴⁵ Its racemate was prepared by Baeyer-Villiger oxidation of 2,5-dimethylcyclopentanone.⁴⁴⁵

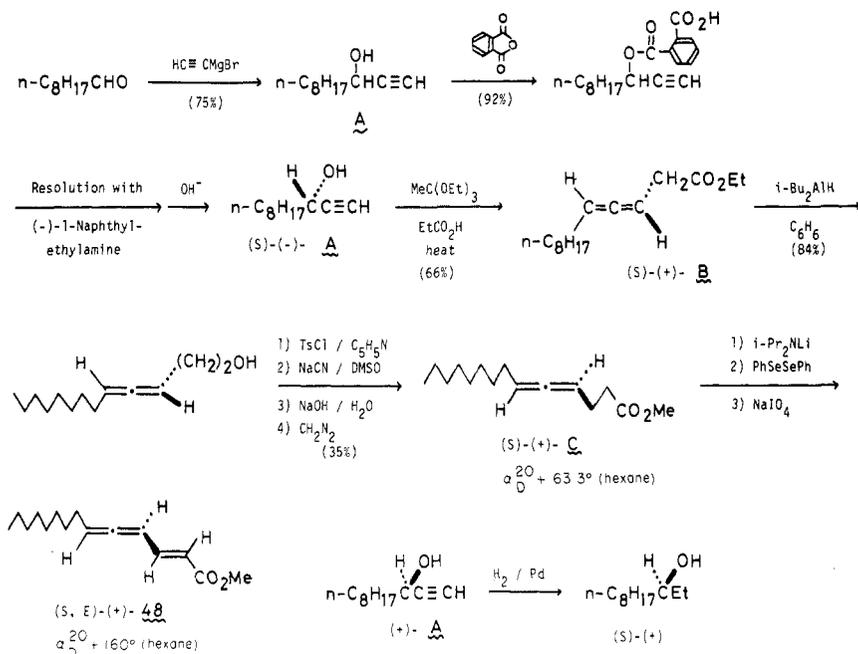

Pirkle and Adams synthesized all four stereoisomers of 2-methyl-5-hydroxyhexanoic acid lactone as shown in Scheme 261⁴⁴⁶. 5-Cyanopentan-2-ol was resolved by chromatographic separation of the diastereomeric carbamate derivatives. Hydrolysis and lactonization of each enantiomer afforded optically pure δ -methyl- δ -valerolactone, which was methylated to give the *cis* and *trans* isomers of **95**, which were separated by preparative GLC.

Methyl (R, E)-(-)-2,4,5-tetradecatrienoate (R,E)-48 and Its Antipode (S, E)-48

This is the pheromone produced by the male dried bean beetle (*Acanthoscelides obtectus*).²¹⁷ The first synthesis of the chiral pheromone **48** was accomplished by Pirkle and Boeder as shown in Scheme 262.⁴⁴⁷ The key intermediates, (*R, R*)- and (*S, R*)-1-ethynyl-3-carbomethoxypropyl *N*-[1-(1-naphthyl)ethyl] carbamates, (*R, R*)-**A** and (*S, R*)-**A**, were separable using liquid chromatography. Subsequently the carbamate moiety of **A** served as the leaving group in the next step. The low-temperature reaction of (*S, R*)-**A** with lithium di-*n*-octylcuprate gave the (*R*)-(-)-form of methyl 4,5-tetradecadienoate [(*R*)-(-)-**B**] and this allene was then converted to (*R*)-(-)-**48**, $[\alpha]_D -98^\circ$ (hexane). The natural phero-

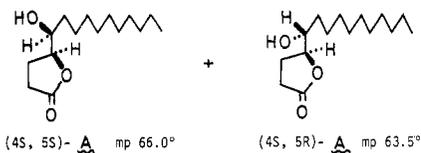
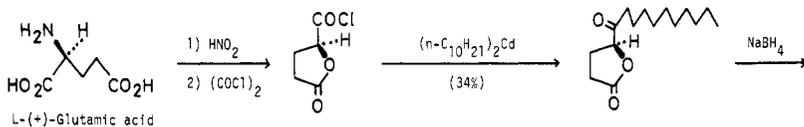

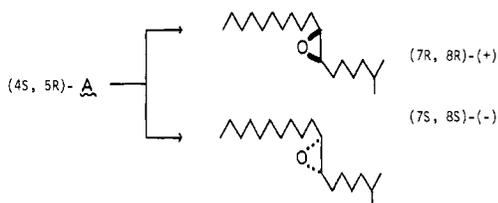
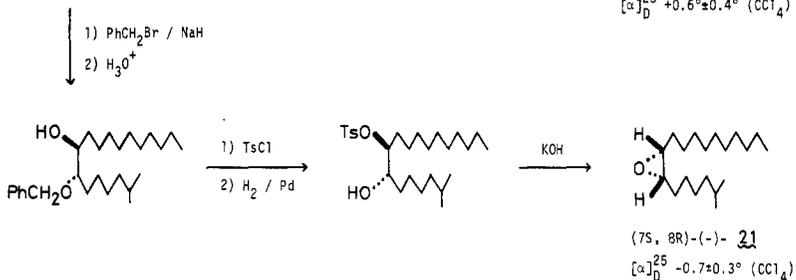
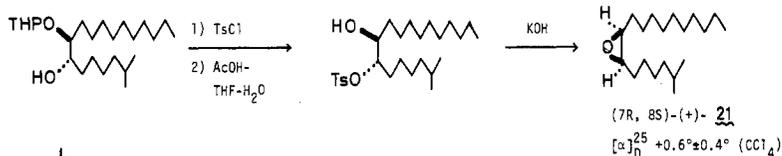
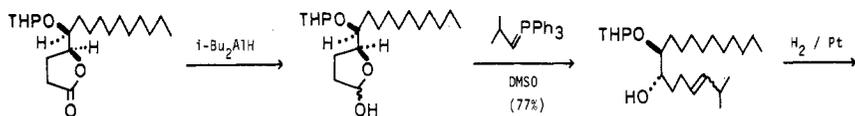
(7R, 8S)-(+)-Disparlure (7R, 8S)-21 and Its Antipode (7S, 8R)-21

This is the pheromone of the gypsy moth (*Porthetria dispar*).¹²¹ The amount of the isolated natural pheromone was so small that its optical rotation could not be determined. The first synthesis by Marumo et al. started from L-(+)-glutamic acid as shown in Scheme 264.³⁷¹ The synthesis, however, was not stereoselective and required the tedious separation of diastereomers at the hydroxylactone A stage. The optical purity of the hydroxylactone A was checked by the NMR method (MTPA ester plus a shift reagent). The hydroxylactone A was shown to contain 5.8% of its enantiomer. Both enantiomers of the *trans*-analog were also prepared. EAG and behavioral responses of the gypsy moth to these stereoisomers revealed that *cis*-(+)-disparlure was the most effective. Racemic disparlure came second, while *cis*-(-)-disparlure inhibited the activity of *cis*-(+)-isomer. Enantiomers of *trans*-disparlure were not significantly different from the control.³⁷²

The second synthesis by Mori et al. was stereoselective and started from L-(+)-tartaric acid as shown in Scheme 265.^{450, 451} An intermediate in the brevicomin synthesis (Scheme 268) was also used in this case. Some intermediates, A, A', B and B', were crystalline, and this was particularly favorable for the purpose of

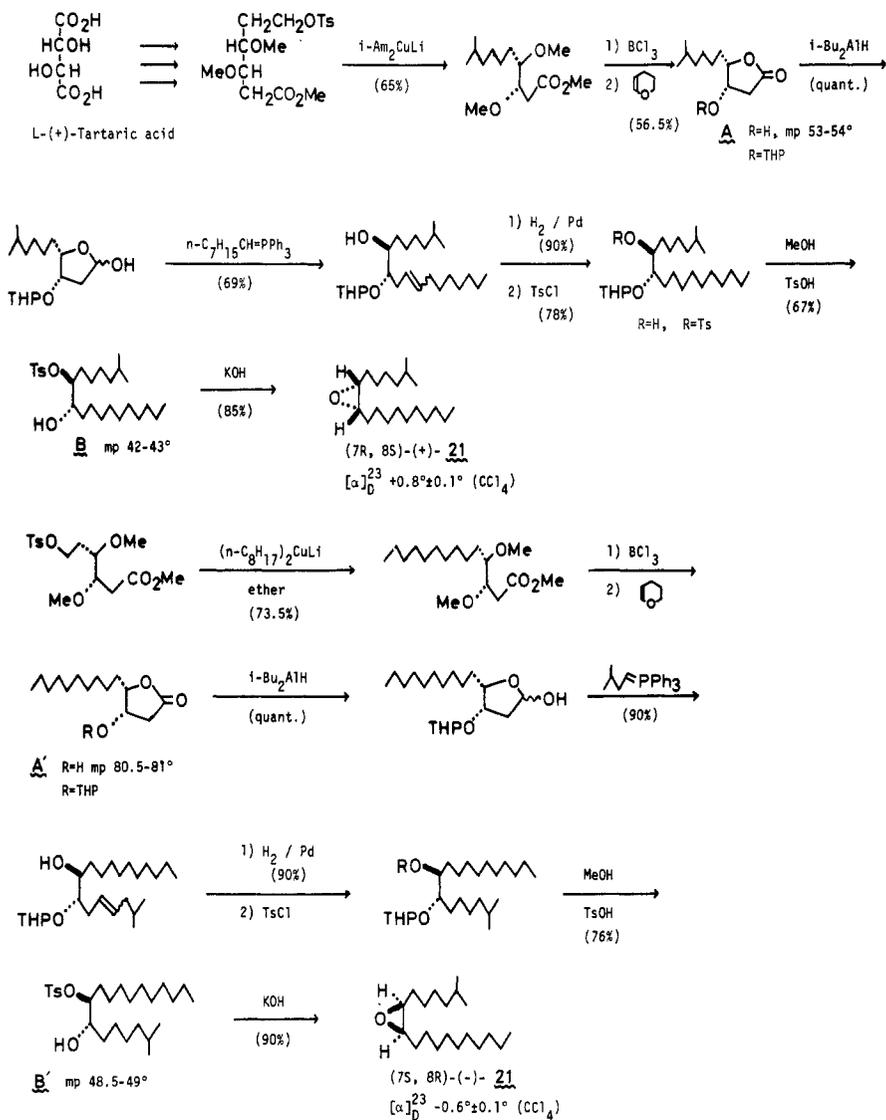

obtaining highly optically pure disparlure enantiomers because they could be purified by repeated recrystallization. The optical purities of **B** and **B'** were checked by the NMR analysis of their MTPA esters in the presence of $\text{Eu}(\text{fod})_3$ and estimated to be >98%. L-(+)-Tartaric acid was converted to both enantiomers of disparlure **21**. Under field conditions males of the nun moth (*Porthetria*

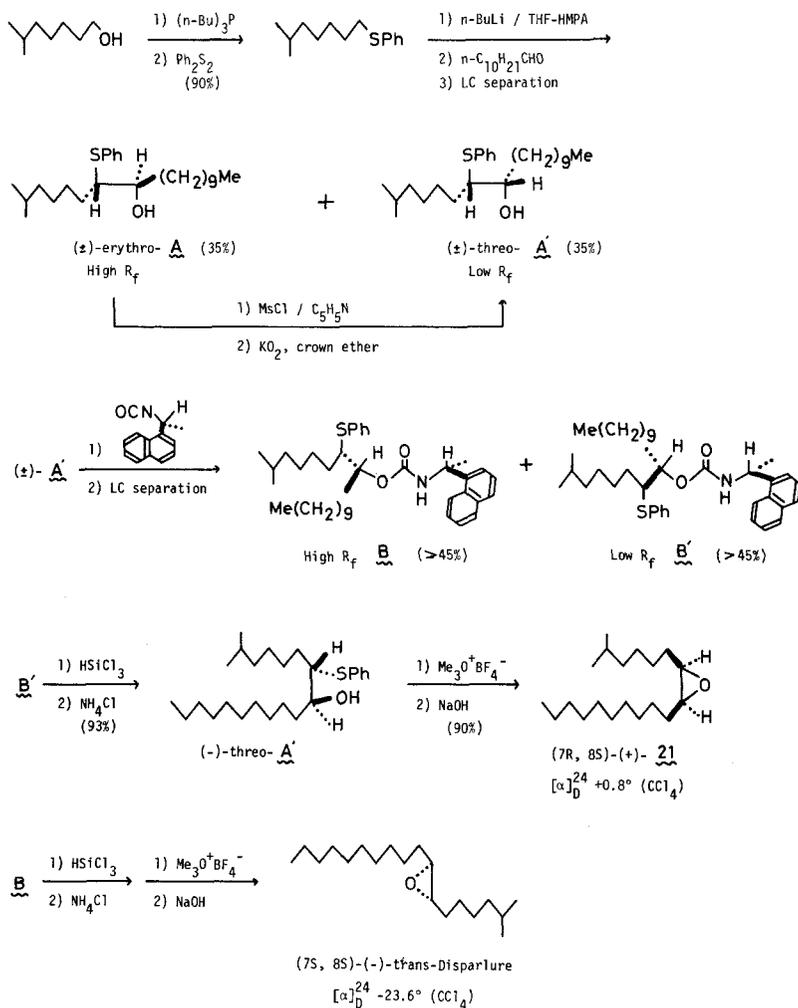
monacha) and males of the gypsy moth (*P. dispar*) responded to (+)-disparlure. However, the addition of (-)-disparlure significantly suppressed response by *P. dispar*, while (-)-disparlure did not have such effect on the response by *P. monacha*.^{452,453} Electroantennogram (EAG) studies using the differential receptor saturation technique suggest the existence of one receptor type having greatest affinity for (+)-disparlure and another type having greater affinity for (-)-disparlure than for (+)-isomer.⁴⁵⁴

The third synthesis by Farnum et al. was shorter than the previous routes and used for large-scale synthesis of optically active disparlure (Scheme 266).⁴⁵⁵ Their synthesis afforded (+)-disparlure in about 15% overall yield in six steps from (-)-menthyl-*p*-toluenesulfinate **A**; 35 g of (+)-**21** was prepared by this method.⁴⁵⁶ The key step was the chromatographic separation of a mixture of diastereomeric hydroxysulfoxides **B** and **B'**. The sulfoxide **B** yielded (+)-disparlure, while the isomer **B'** gave (+)-*trans*-disparlure. When the synthesis was conducted in a slightly modified manner (-)-disparlure was also obtained.

The fourth synthesis by Pirkle and Rinaldi was also quite effective. Enantiomerically pure (+)-*cis*-disparlure **21** was synthesized in 12% yield by a five-step sequence of reactions as shown in Scheme 267.⁴⁵⁷ They separated the (\pm)-*erythro*-**A** from (\pm)-*threo*-**A'** by liquid chromatography. The optical resolution of (\pm)-*threo*-**A'** was also achieved by liquid chromatographic separation of the diastereomeric (*R*)-1-(1-naphthyl)ethyl isocyanate derived carbamates **B** and **B'**. Silanolysis of the low *R_f* diastereomer **B'** provided (-)-**A'**. This was stereospecifically converted to (+)-disparlure **21**. ¹³C-NMR of (-)-**A'**, the immediate precursor to **21**, in the presence of chiral lanthanide shift reagent, allowed the determination of its enantiomeric purity.

(1R, 5S, 7R)-(+)-exo-Brevicomine (1R, 5S, 7R)-6
and Its Antipode (*1S, 5R, 7S*)-6

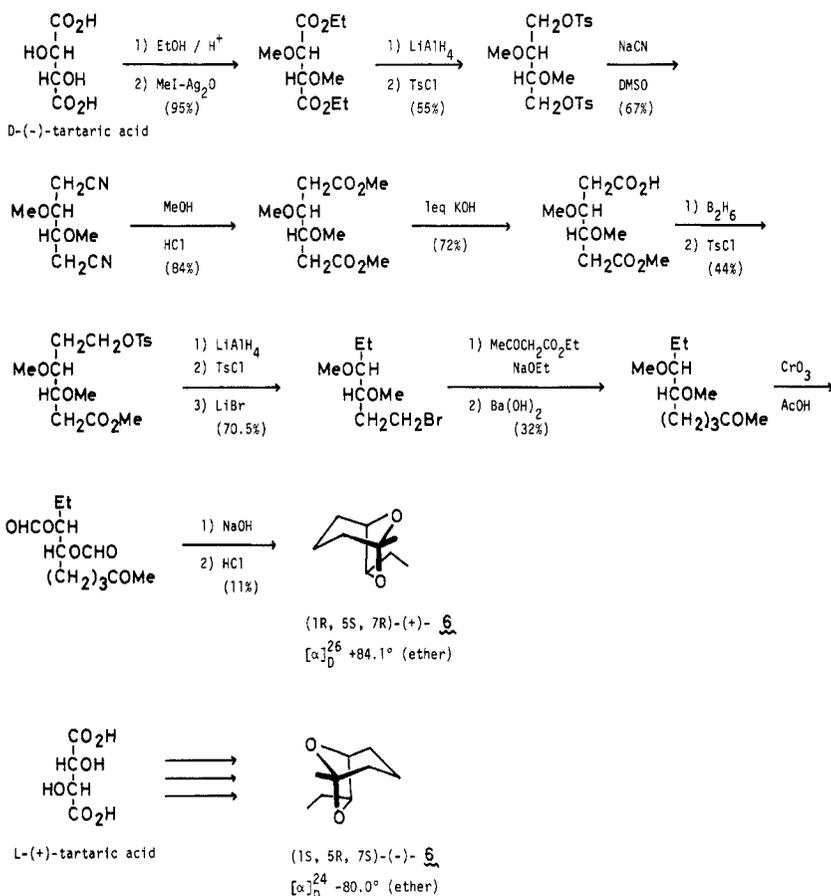
This is the aggregation pheromone of the western pine beetle (*Dendroctonus brevicomis*).¹¹ This pheromone possesses three asymmetric carbon atoms and therefore is a highly dissymmetric bicyclic compound. However, its 0.05% hexane solution was reported to show no optical rotation between 350 and 250 nm.¹¹ This observation hampered further study on the absolute stereochemistry of the pheromone until 1974 when both enantiomers were synthesized by Mori.¹³ The synthesis started from tartaric acid enantiomers. The route to (1*R*, 5*S*, 7*R*)-(+)-*exo*-brevicomine **6** from D-(-)-tartaric acid is shown in Scheme 268.¹³ The (+)-isomer was active on *Dendroctonus brevicomis*, while the antipode was inactive.¹⁵ The notable feature of the synthesis was differentiation of the two carboxyl groups and demethylation by chromic acid oxidation. The demethylation was unsuccessful with boron trichloride.

The second synthesis by Meyer also used L-(+)-tartaric acid as the starting material and (1*S*, 5*R*, 7*S*)-(-)-*exo*-brevicomine (-)-**6** of 81% optical purity was synthesized (Scheme 269).⁴⁵⁸ The key step was the alkylation of a dithiane **B** with a bromide **A** to give a crystalline dithiane **C**. Repeated recrystallization of **C** from methanol did not increase the optical purity.

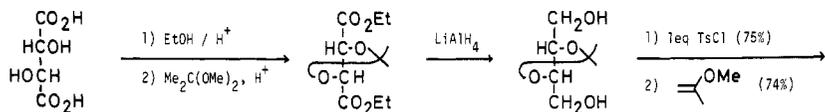

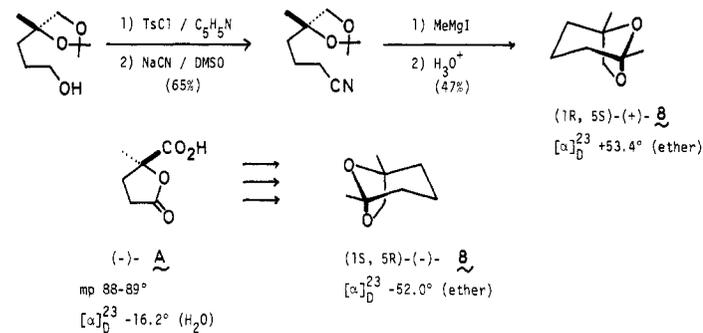
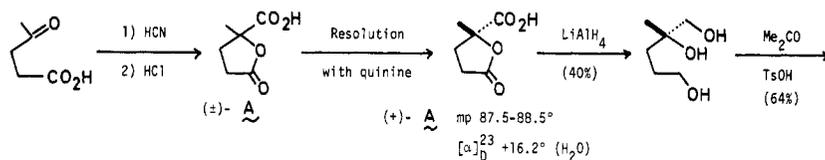
This is the pheromone isolated from the hindguts of the male western pine beetle and possesses two asymmetric carbon atoms.²⁵⁰ Mori's first synthesis started from levulinic acid as shown in Scheme 270.¹⁴ The lactonic acid (\pm)-A was cleanly resolved to optically pure enantiomers and hence the pheromone was obtained in an optically pure state. The absolute configuration of the resolved acids (+)-A and (-)-A was deduced by comparing their CD spectra with that of (*S*)-(-)-2-hydroxypentane-1,5-dioic acid of known stereochemistry.¹⁴ Only (1*S*, 5*R*)-(-)-frontalin **8** was biologically active.¹⁵



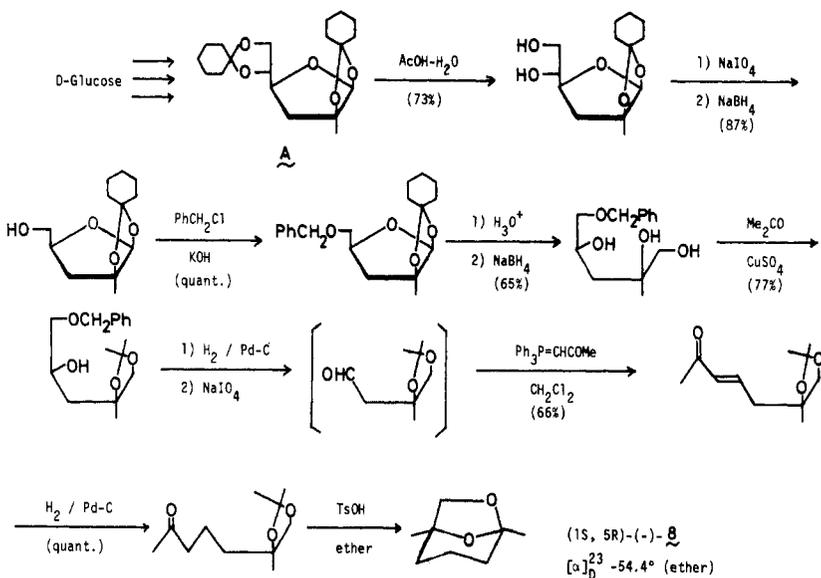

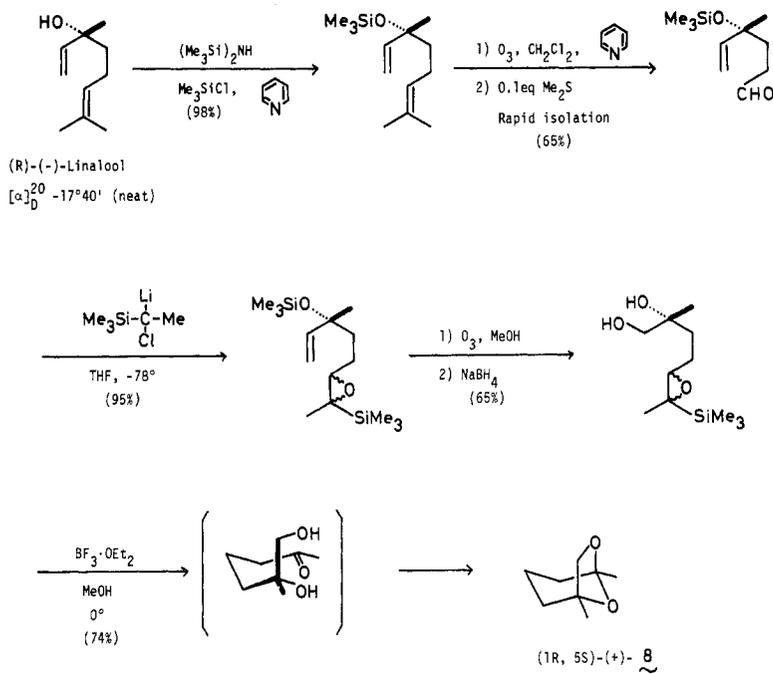

Two syntheses of optically active frontalin appeared subsequently starting from D-glucose. Ohruï and Emoto converted D-glucose into (*S*)-(-)-frontalin **8** as shown in Scheme 271.⁴⁵⁹ 1,2,5,6-Di-*O*-cyclohexylidene-3-deoxy-2-*C*-methyl- β -D-arabinohexofuranose **A**, the starting material, was synthesized from D-glucose by the methods reported by Kawana et al.^{460, 461} Thus the stereochemistry of (-)-frontalin was firmly correlated to that of D-glucose. Hicks and Fraser-Reid converted methyl- α -D-glucopyranoside into frontalin as shown in Scheme 272.⁴⁶² The ketone **A**, derivable from methyl- α -D-glucopyranoside in four steps, was converted into one enantiomer, the other enantiomer, or a mixture of both enantiomers of frontalin in 13% overall yield, and 1 g of optically pure frontalin was obtained from 21 g of methyl- α -D-glucopyranoside.

A Unique synthesis of (*R*)-(+)-frontalin **8** was reported by Magnus and Roy using a new organosilicon reagent (Scheme 273).⁴⁶³ The starting material was (*R*)-(-)-linalool. The overall yield from linalool was 23-29%.

(1S, 2R, 4S, 5R)-(-)- α -Multistriatin (*1S, 2R, 4S, 5R*)-58 α ,
Its Antipode (1R, 2S, 4R, 5S)-58 α , and Stereoisomers

This is a pheromone component isolated from the smaller European elm bark beetle (*Scolytus multistriatus*).²⁶⁵ The natural pheromone was levorotatory ($[\alpha]_{\text{D}}^{25} -47^{\circ}$).⁴⁶⁴ Silverstein et al. synthesized a mixture of (*1S, 2R, 4S, 5R*)-(-)-58 α , (*1R, 2R, 4S, 5S*)-(+)-58 β , (*1S, 2R, 4R, 5R*)-(-)-58 γ and (*1R, 2R, 4R, 5S*)-



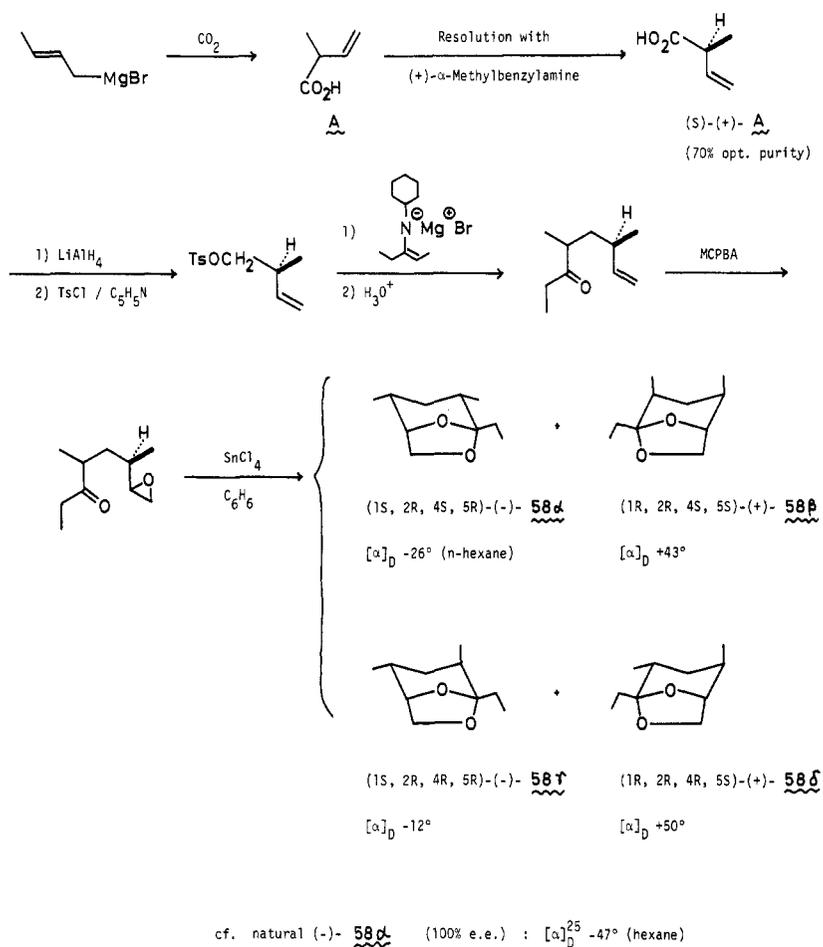

(+)-**58 δ** starting from (*S*)-(+)-2-methyl-3-butenic acid **A**.⁴⁶⁴ This synthesis, as well as that by Mori, established the absolute configuration of natural α -multistriatin to be 1*S*, 2*R*, 4*S*, 5*R*. Starting from (*R*)-(-)-**A**, (+)-**58 α** and its isomers were also synthesized. The synthetic route is shown in Scheme 274. The mixture was separable into four components by preparative GLC. The enantiomeric composition of synthetic (-)- and (+)-**58 α** was determined by ¹³C-NMR with the chiral shift reagent, tris[3-(heptafluoropropylhydroxymethylene)-*d*-camphorato]europium(III).

The second synthesis by Mori started from (*R*)-(+)-glyceraldehyde acetonide as shown in Scheme 275.⁴⁶⁵ In this synthesis all four stereoisomers of **58** was obtained with 1*S*-stereochemistry. Considerable racemization took place during this multistep synthesis.

(*R*)-(+)-Citronellol was used as the chiral starting material in the third synthesis of **58** by Cernigliaro and Kocienski (Scheme 276).⁴⁶⁶

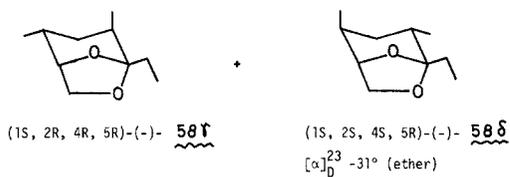
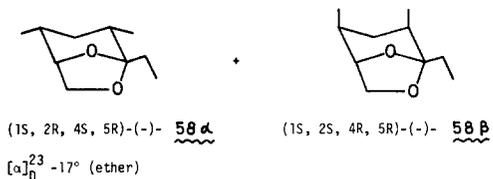
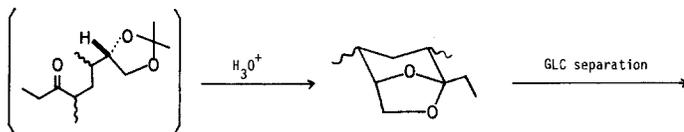
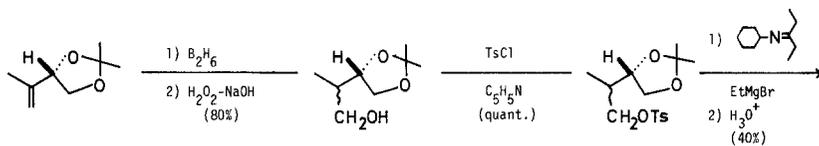
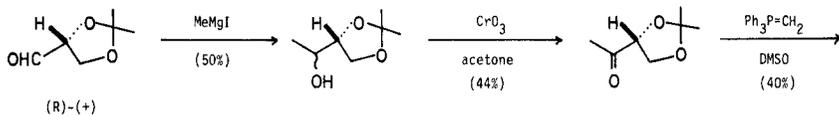
The synthesis of (-)- α -multistriatin by Sum and Weiler was highly stereoselective, giving only pure **58 α** starting from D-glucose (Scheme 277a).⁴⁶⁷ The crucial



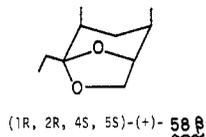
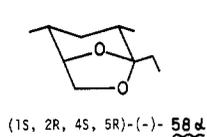
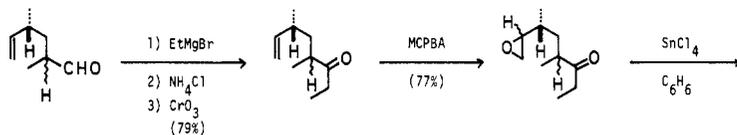
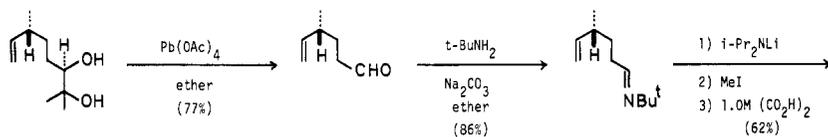
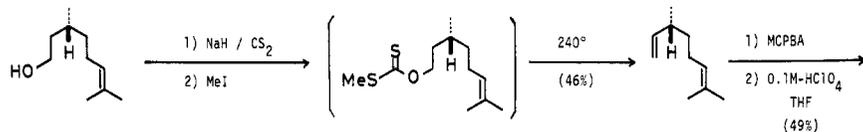

step was the generation of the 1,3-diaxial methyl system of B from A by stereoselective hydrogenation using Wilkinson's catalyst. Alkylation of the dithiane C was also crucial having been successful only with *tert*-butyllithium and ethyl iodide in *n*-hexane-HMPA. The optical purity of the product 58 α was satisfactory (~98%).

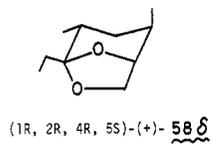
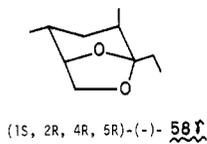
Fried's synthesis of (\pm)- α -multistriatin was extended to a synthesis of the both enantiomers of it by resolving (\pm)-A as shown in Scheme 277b.⁴⁸³ The resolved

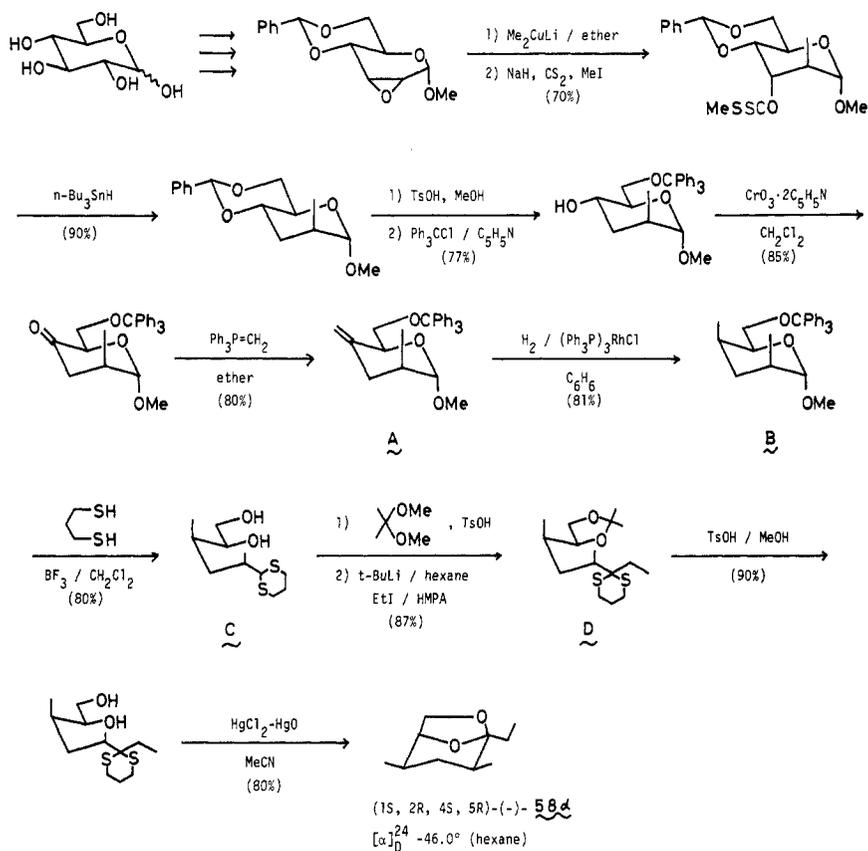

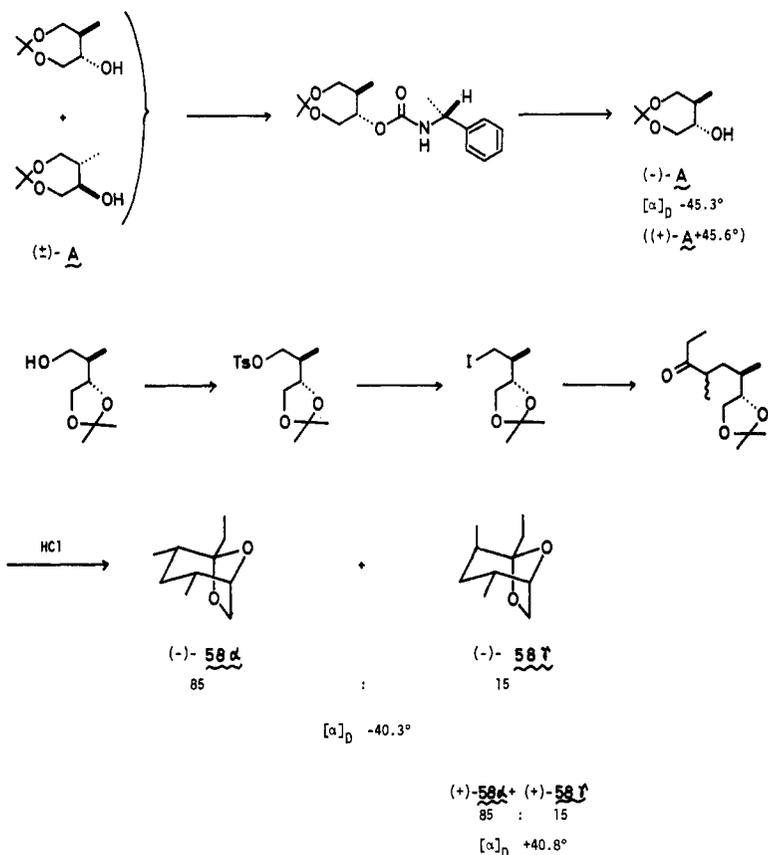

(-)-A gave a mixture of (-)- α -multistriatin **58 α** and (-)- γ -multistriatin **58 γ** (**58 α** : **58 γ** = 85 : 15). The bioactive enantiomer was shown to be (-)-**58 α** , while (+)-**58 α** was no more active than controls in both laboratory and field tests.

A highly stereoselective synthesis of **58 δ** was recently achieved by Mori and Iwasawa as shown in Scheme 278.⁴⁶⁸ The key step was the stereoselective ring opening of an epoxy ester **A** with lithium dimethylcuprate to give **B**. Both enantiomers of **A** were prepared from tartaric acid enantiomers. (-)- δ -Multistriatin **58 δ** , instead of **58 α** , was attractive for the European population of *Scolytus multistriatus*.²⁶⁶

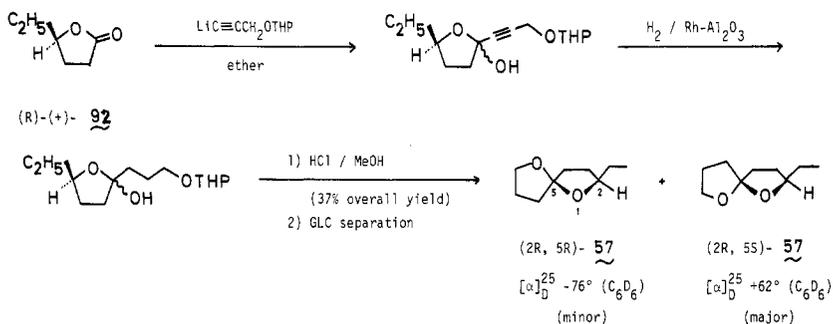

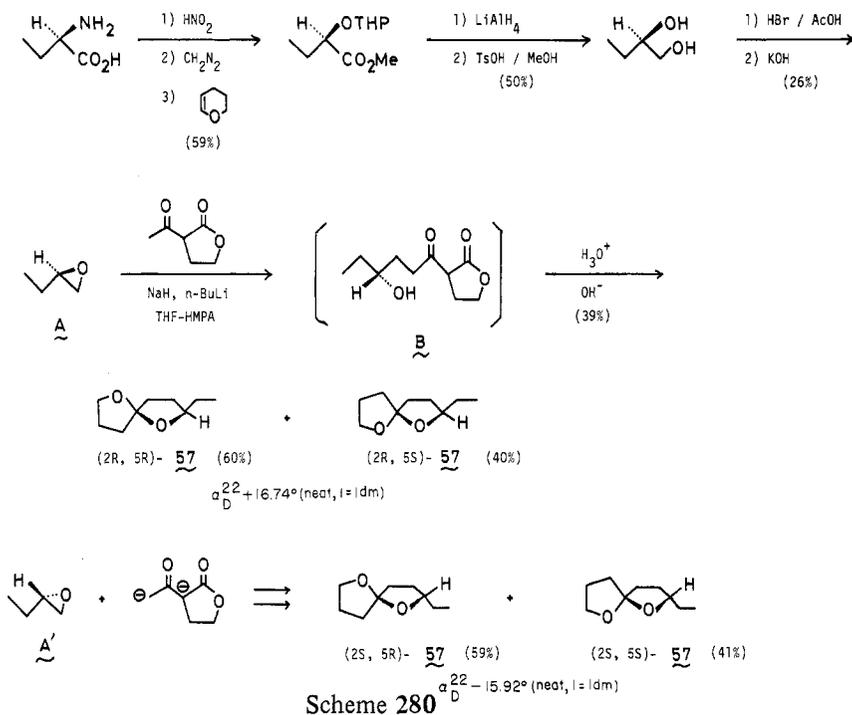
(2R, 5RS)-Chalcogran (*2R, 5RS*)-57 and Its Antipode (*2S, 5RS*)-57

This is the pheromone of *Pityogenes chalcographus*.²⁴⁹ Silverstein et al. synthesized (*2R, 5RS*)-chalcogran 57 from (*R*)-(+)-caprolactone 92 as shown in Scheme 279.⁴⁶⁹ They were able to separate the two stereoisomers by preparative GLC and assigned stereochemistries by ¹³C-NMR with the aid of a chiral shift reagent. The major isomer had a longer GLC retention time.

Mori et al. prepared (*2R, 5RS*)-57 and (*2S, 5RS*)-57 by an entirely different route. They utilized α -amino-*n*-butyric acid as the chiral source. The synthesis proceeded in a simple manner by applying the recent technique of dianion

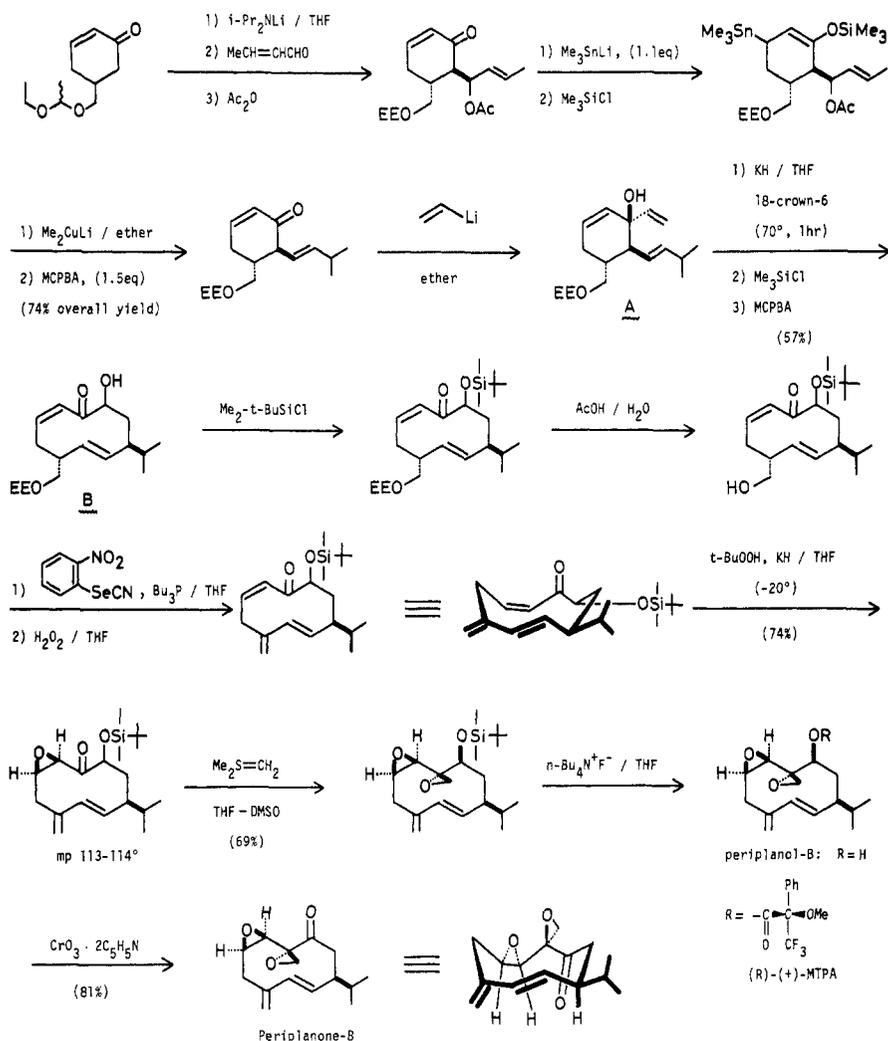

chemistry as shown in Scheme 280.^{470,471} Thus alkylation of a dianion derived from α -acetyl- γ -butyrolactone with chiral epoxides A or A' followed by subsequent hydrolytic decarboxylation and ketalization yielded a mixture of (2R, 5R)-57 and (2R, 5S)-57 or (2S, 5R)-57 and (2S, 5S)-57. No separation of the mixture was attempted, since the natural pheromone itself was a mixture.

Periplanone-B 96

This is one of the two sex pheromone component of the American cockroach (*Periplaneta americana*). About 200 μg of periplanone-B was isolated by Persoons et al. and its structure was proposed to be **96** without stereochemical assignment.⁴⁷²⁻⁴⁷⁴ A synthesis of (\pm)-periplanone-B was achieved by Still as shown in Scheme 281.⁴⁷⁵ The key step was the conversion of **A** to **B** by means

of an oxy-Cope rearrangement.⁴⁷⁶ (\pm)-Periplanol-B was resolved by LC as its (R)-(+)-MTPA ester.⁴⁷⁷ The separated esters were hydrolyzed with sodium hydroxide to give resolved periplanol-B and its enantiomer, which were oxidized with chromic anhydride-pyridine to periplanone-B **96** and its enantiomer. The threshold activity on male cockroaches of synthetic periplanone-B was 10^{-6} to 10^{-7} μ g. The antipode was devoid of activity. The absolute stereochemistry of periplanone-B was determined as **96** by Nakanishi's exciton chirality method.⁴⁷⁷

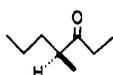
Stereochemistry-Pheromone Activity Relationships

The relationship between pheromone activity and absolute stereochemistry of chiral pheromones is rather complicated. In some cases only one enantiomer is

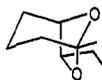

biologically active, but in others both enantiomers are fully active. The situation changes with insect by insect. The results obtained with various insects are summarized in Fig. A-D. The formula indicates the bioactive enantiomer. The name of the senior author who synthesized the pheromone is written under each formula.

In the case of those pheromones listed in Fig. A-1, only one enantiomer is biologically active. No inhibitory action was observed with the inactive antipode. Majority of chiral pheromones seems to belong to this class. Similarly, in the case of pheromones listed in Fig. A-2, only one enantiomer is biologically active. However, the inactive antipode inhibits the action of the correct enantiomer. Especially in the case of the Japanese beetle pheromone, its racemate was inactive due to the inhibitory action of the wrong enantiomer.

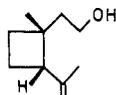

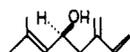
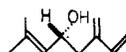
In the case of pheromones listed in Fig. B, insects do not discriminate between stereoisomers. It is indeed surprising that the unnatural grandisol is biologically active.

Ipsdienol (Fig. C) is unique because two different species of *Ips* seem to possess enantiomeric pheromone receptor systems and the chirality of the pheromone is quite important in establishing and maintaining a particular *Ips* species.

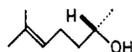

Sulcatol (Fig. D) is the only pheromone both of whose enantiomers are required for pheromone activity. This means that two enantioselective receptors are present in the antennae of *Gnathotrichus sulcatus*. It should be added that Chapman et al. recently demonstrated the presence of chiral dual receptors even for an achiral sex pheromone such as (*Z*)-11-tetradecenyl acetate.^{480, 481} The prochiral character of (*Z*)-11-tetradecenyl acetate is used to good advantage in the receptor system. The red-banded leaf roller has evolved at least two chemoreceptors (one in common with the European corn borer) that accommodate

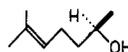

different conformations of the achiral, but prochiral, pheromone. It is therefore now clear that all types of isomerism—structural, geometrical, and optical—are utilized by insects in their chemical communication system.

16. CONCLUSION

In this chapter I have reviewed the synthesis of 96 insect pheromones. The syntheses of 30 chiral pheromones were discussed with special emphasis. Advances in synthetic methodology have made it possible to synthesize both geometrically and enantiomerically pure pheromones and has assisted progress in understanding pheromone perception. Pheromone synthesis is indeed one of the unique areas of research, which firmly ties chemistry and the life sciences. Nature's diversity as revealed by pheromone chemists will continually provide new targets for ingenious syntheses and stimulate new ideas among synthetic chemists.

1. INTRODUCTION

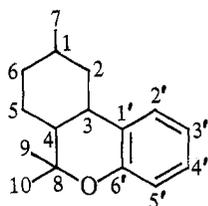
The illicit use of marijuana, which started in a substantial way in the early 1960s, has continued to increase. By 1975 over 36 million Americans had tried the drug, and among the 20-24 age group over 10% were using it on a daily basis. This has caused grave concern to society, and marijuana has become the subject of intense sociopolitical controversy. However, the recent use of marijuana and its active constituent Δ^1 -THC for glaucoma and as an antiemetic in patients undergoing cancer chemotherapy has revived public interest in its therapeutic potential. In other cultures, particularly Chinese, Indian, and Middle Eastern, the therapeutic use of cannabis preparations has been well documented for centuries, and folklore has recorded its use in insomnia, neuralgia, migraine pain, rheumatism, asthma, bronchitis, loss of appetite, and gynecological and obstetrical problems such as dysmenorrhea. Even today its use is widely practiced in the Ayurvedic and Tibbi systems of Indian medicine. The recent discovery of its use in the treatment of glaucoma and as an antiemetic was serendipitous and came out of the drug culture. It was well known among drug users that while "high" on marijuana one could chop onions without the eyes watering. Encouraged by anecdotes like this, ophthalmologists Hepler and Frank¹ in 1971 found that smoking marijuana did indeed decrease lacrimation and also decreased the intraocular pressure (IOP) of the eye. This led to clinical trials with smoked marijuana or Δ^1 -THC in glaucomatous patients.

Similarly, "pot" smokers who had cancer and were undergoing cancer chemotherapy noticed a relief from the nausea that traditionally accompanies this treatment. This was clinically confirmed by Sallan and co-workers² in 1975. These therapeutic aspects are being vigorously pursued at present.

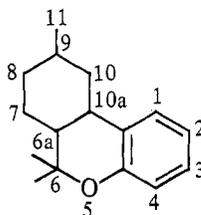
It is unlikely that the natural material marijuana itself will become a marketable product because it is a complex mixture of over 35 known cannabinoids, various terpenes, nitrogen bases, phenolic compounds, sugars, etc. It is possible that its main active constituent Δ^1 -THC could become a viable drug, but it is most likely that the marketable products will come from the synthetic analogs, where the undesirable side effects and physical characteristics of Δ^1 -THC have been modified or eliminated.

The term "cannabinoids" is used for the typical C₂₁ groups of compounds present in *Cannabis sativa* L. (family Moraceae) and includes their analogs and transformation products.

The following two different numbering systems, dibenzopyran and monoterpene, are generally used for cannabinoids. The former is used by *Chemical Abstracts*. In the present article the monoterpene numbering system will be used, as it can be most easily adapted for ring-opened cannabidiol derivatives and isotetrahydrocannabinols (iso-THCs).



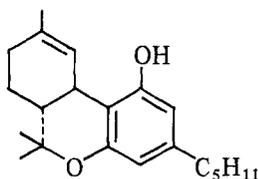

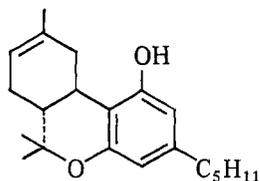

(-)- Δ^1 -3,4-*trans*-Tetrahydrocannabinol (THC)³ is the main physiologically active constituent of hashish or charas, which is the resinous exudate from the female flowers of *Cannabis sativa* L. Numerous preparations of *Cannabis* are known, and they are given different names depending on the country of origin and their mode of preparation. Thus the most potent preparation is the unadulterated resin, which is known as hashish in the Middle East and charas-in India. Marijuana (pot, grass), mostly used in the United States, refers to the dried flowering tops of the plant, which are smoked in a pipe or a cigarette. Bhang, which is used in India, is a concoction made with milk and water from the flowering tops of the plant and is ingested by mouth.

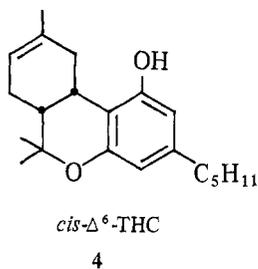
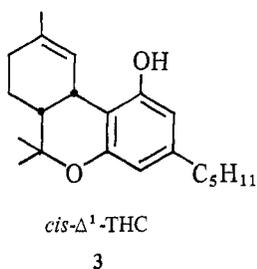
(-)- Δ^1 -3,4-*trans*-THC (1) is a resin that is optically active and is generally referred to as Δ^1 -THC. It is also known as Δ^9 -THC based on dibenzopyran numbering system. The other physiologically active isomer is Δ^6 -THC (2; alternate name Δ^8 -THC) and is found only in a few varieties of the plant. The isomers with a 3,4-*cis* ring junction are *cis*- Δ^1 -THC (3) and *cis*- Δ^6 -THC (4) both of which have been synthesized, but only 3 has been found in the plant so far. On theoretical grounds the *trans* compounds (1 and 2) are expected to be more thermodynamically stable compared to the *cis* compounds 3 and 4. In the *trans* series Δ^6 -THC (2) is more stable than Δ^1 -THC (1), since 1 is easily isomerized to (2) on treatment with acids. The main interest pharmacologically therefore centers around the thermodynamically less stable *trans*- Δ^1 -THC (1) and its various derivatives and metabolites. This has posed many synthetic problems because during chemical reactions the more stable derivatives of *trans*- Δ^6 -THC (2) are mostly formed.

With this background let us now examine the various syntheses for (-)- Δ^1 - and Δ^6 -THCs (1 and 2). No attempt is made to cover the subject exhaustively in this chapter. The examples are chosen to illustrate the strategy used in the synthesis of various cannabinoids.

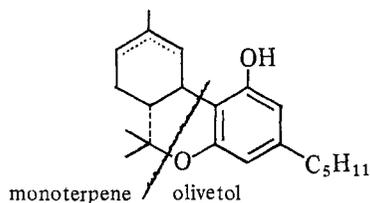
2. STRATEGY IN THE SYNTHESIS OF (-)- Δ^1 - AND Δ^6 -THCS AND THEIR METABOLITES

A. Synthesis of Δ^1 - and Δ^6 -THCs

The syntheses under discussion may be divided into two main categories: stereospecific syntheses and other approaches.

Stereospecific Syntheses

Since the structure of Δ^1 -THC is not complex, the basic strategy can be envisioned as joining of the aromatic and the alicyclic parts of the molecule (as shown) by condensation of olivetol with an optically active monoterpene. Mainly, it is the selection of the monoterpene and the reaction conditions that dictate or control the position of the double bond in the Δ^1 - or Δ^6 - position in the final product.



From Verbenols

In 1967 Mechoulam et al.⁴ described a synthesis of (-)- Δ^6 -THC (2) from a pinane derivative, verbenol (5) and olivetol (6) in the presence of acid catalysts

(Chart 1.1). They visualized that the attack by the resorcinol will be favored from the side opposite the bulky dimethylmethylene bridge in verbenol and will thus provide stereochemical control of the reaction to give mainly *trans* products. Thus in the presence of $\text{BF}_3 \cdot \text{Et}_2\text{O}$, (-)-*cis*- or (-)-*trans*-verbenol (5) condensed with olivetol (6) to give (-)- Δ^6 -THC (2) in 44% yield. The purification of this material proved to be tedious. A better procedure was found to be a two-step sequence. When 5 was allowed to react with 6 in the presence of *p*-toluenesulfonic acid (*p*-TSA) in CH_2Cl_2 , a mixture containing 7 (60%), 8, and 9 was formed from which 7 was isolated by chromatography. Treatment of 7 with $\text{BF}_3 \cdot \text{Et}_2\text{O}$ in CH_2Cl_2 cleanly formed 2 in 80% yield.

The final conversion of Δ^6 -THC (2) to Δ^1 -THC (1) was achieved by the addition of gaseous hydrochloric acid to the double bond of 2 to form 10 followed

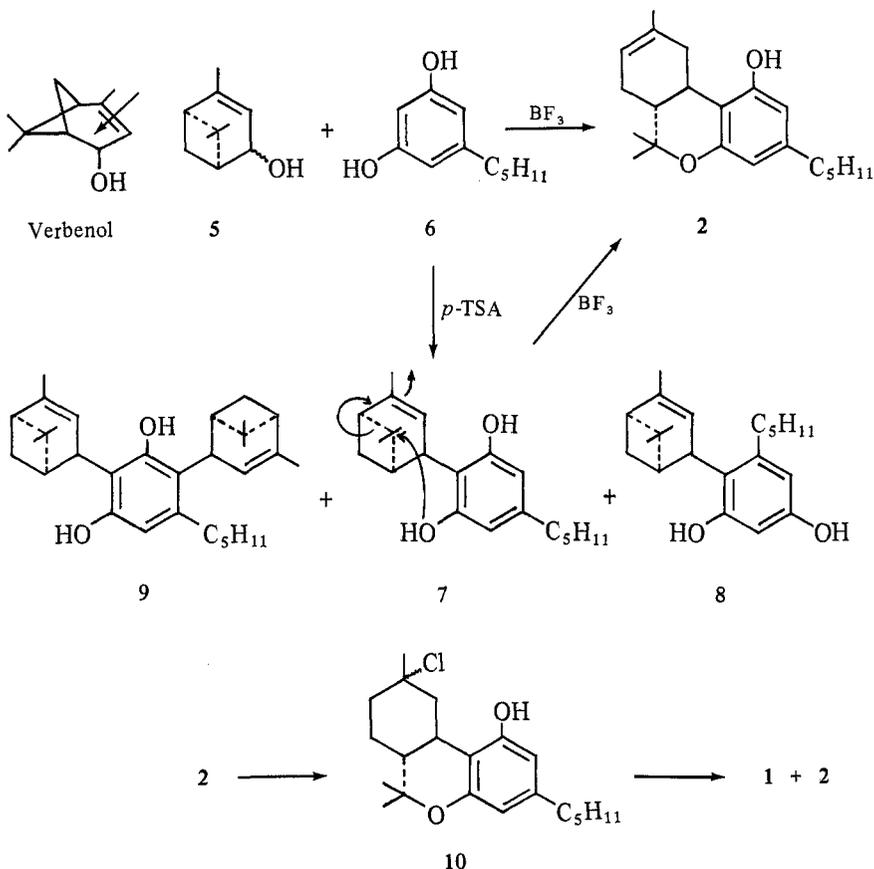

by dehydrochlorination with sodium hydride in THF. A mixture of 1 and 2 was thus obtained, which was separated by careful chromatography.

Following the same sequence of reactions the unnatural (+)- Δ^6 -THC and (+)- Δ^1 -THC were similarly prepared from (+)-verbenol.⁵ Both the isomers were found to be relatively inactive compared to (-)- Δ^1 - and (-)- Δ^6 -THCs in monkeys⁶ and dogs.⁷

Utilizing this procedure various side-chain homologs of (-)- Δ^1 - and (-)- Δ^6 -THC's were synthesized including deuterium-labeled [$3\text{-}^2\text{H}$]- Δ^6 -THC, [$3\text{-}^2\text{H}$]- Δ^1 -THC,⁴ and other cannabinoids⁸ with tritium labeled at unspecified positions.

From Chrysanthenol

It is apparent that the mechanism of the verbenol route (Chart 1.1) is likely to involve a common allylic cation, since both *cis*- and *trans*-verbenols give the same products. However, on mechanistic grounds Razdan et al.⁹ reasoned that, by virtue of the position of the double bond, verbenol can lead only to Δ^6 -THC, since the double bond has to migrate into that position during the ring opening of the cyclobutane ring. On the other hand, on the basis of similar arguments they thought chrysanthenol should lead directly to Δ^1 -THC. This was indeed found to be the case albeit the yield was moderate⁹ (Chart 1.2). Thus (-)-verbenone, on irradiation in cyclohexane gave (-)-chrysanthenone,^{10,11} which on LiAlH_4 reduction formed the (+)-*cis*-chrysanthenol.^{10,12} Treatment with equimolar quantity of olivetol (6) in the presence of 0.1% $\text{BF}_3 \cdot \text{Et}_2\text{O}$ in methylene chloride gave a resin containing $\sim 25\%$ [gas-liquid chromatography (GLC)] Δ^1 -THC, which was separated by chromatography and was found to be identical to the natural material in all respects. The direct synthesis from chrysanthenol

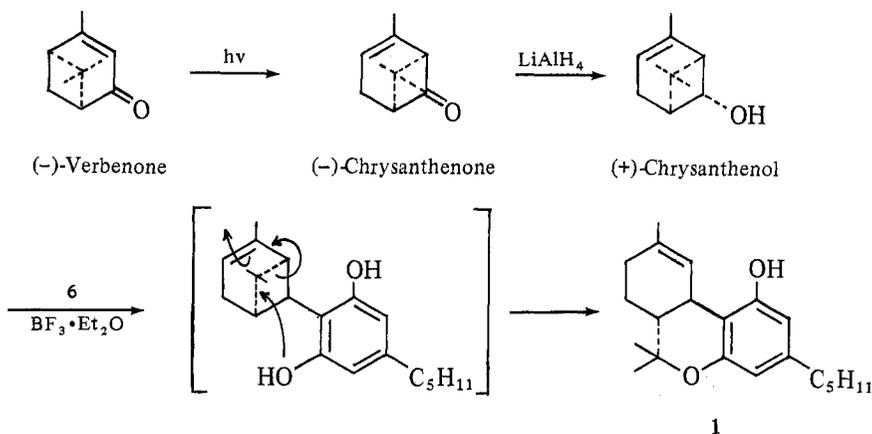

has some biogenetic implications, especially since chrysanthenone and chrysanthenyl acetate¹² have been found to occur naturally, and many publications report¹³ the complete absence of cannabidiol in *Cannabis sativa*. It is therefore suggested that an alternative biogenetic scheme proceeding via the "pinane route"¹⁴ might be operative in certain subspecies of *Cannabis*.

From p-Mentha-2,8-dien-1-ol

About the same time when Mechoulam et al.⁴ reported their synthesis of (-)- Δ^6 -THC from verbenol, Petrzilka et al.¹⁵ in 1967 demonstrated a facile entry into cannabinoids utilizing (+)-*cis*- or *trans*-*p*-mentha-2,8-dien-1-ol (11). By condensing with olivetol (6) in the presence of weak and strong acids they obtained (-)-cannabidiol (12) and (-)- Δ^6 -THC (2), respectively (Chart 1.3). The yield of 12 was 25%, but with a strong acid, *p*-TSA, no cannabidiol (12) was isolated, and Δ^6 -THC (2) was obtained in 53% yield. Presumably 2 was being formed via the intermediates cannabidiol \rightarrow Δ^1 -THC \rightarrow Δ^6 -THC, since both cannabidiol and Δ^1 -THC are known to yield Δ^6 -THC in nearly quantitative yields on treatment with *p*-TSA. The enhanced yield of 2 was rationalized on the postulate that abnormal cannabidiol (*abn*-CBD, 14), which always accompanies cannabidiol (12), undergoes a "retrocondensation" to give "ion c," which in turn forms more cannabidiol and hence Δ^6 -THC.

The Δ^6 -THC obtained by this procedure is accompanied by many by-products, which is typical of all THC syntheses and was purified by very careful column chromatography. Conversion to Δ^1 -THC was carried out by the usual procedure of addition and elimination of HCl (Chart 1.1). But these authors improved the yield of Δ^1 -THC in the dehydrochlorination step, previously reported by Fahrenholtz et al.¹⁶ in the synthesis of *d* Δ -THCs (NaH/THF) and later applied by Mechoulam et al.⁴ in their synthesis of (-)- Δ^1 -THC by the verbenol route. By using potassium-*t*-amylate in benzene, Petrzilka and co-workers¹⁵ reported a 100% yield of 1 from the chloro compound 10.

Because of the commercial availability of the starting terpene, (+)-*cis/trans*-*p*-mentha-2,8-dien-1-ol (11), this route was further developed by Razdan and co-workers¹⁷ for the preparation of kilogram quantities of 1 and 2 at Arthur D. Little, Inc., Cambridge, Massachusetts for the National Institutes of Health. They reported that the dehydrochlorination procedure was very sensitive to reaction conditions and showed (GLC) that under the best conditions a mixture of 95% 1 and 5% (-)- Δ^1 ⁽⁷⁾-THC (13) was always obtained. This new THC (13) was completely characterized¹⁸ by isolation from this mixture by chromatography on silver nitrate-silica gel.

Based on the observation that cannabidiol (12) gives mainly Δ^1 -THC (1) on treatment with $\text{BF}_3 \cdot \text{Et}_2\text{O}/\text{CH}_2\text{Cl}_2$, whereas under the same conditions 11 and 6 give Δ^6 -THC (2), Razdan and co-workers concluded that the formation of 2 and not 1 must be due to the acid being generated from a mole of H_2O and

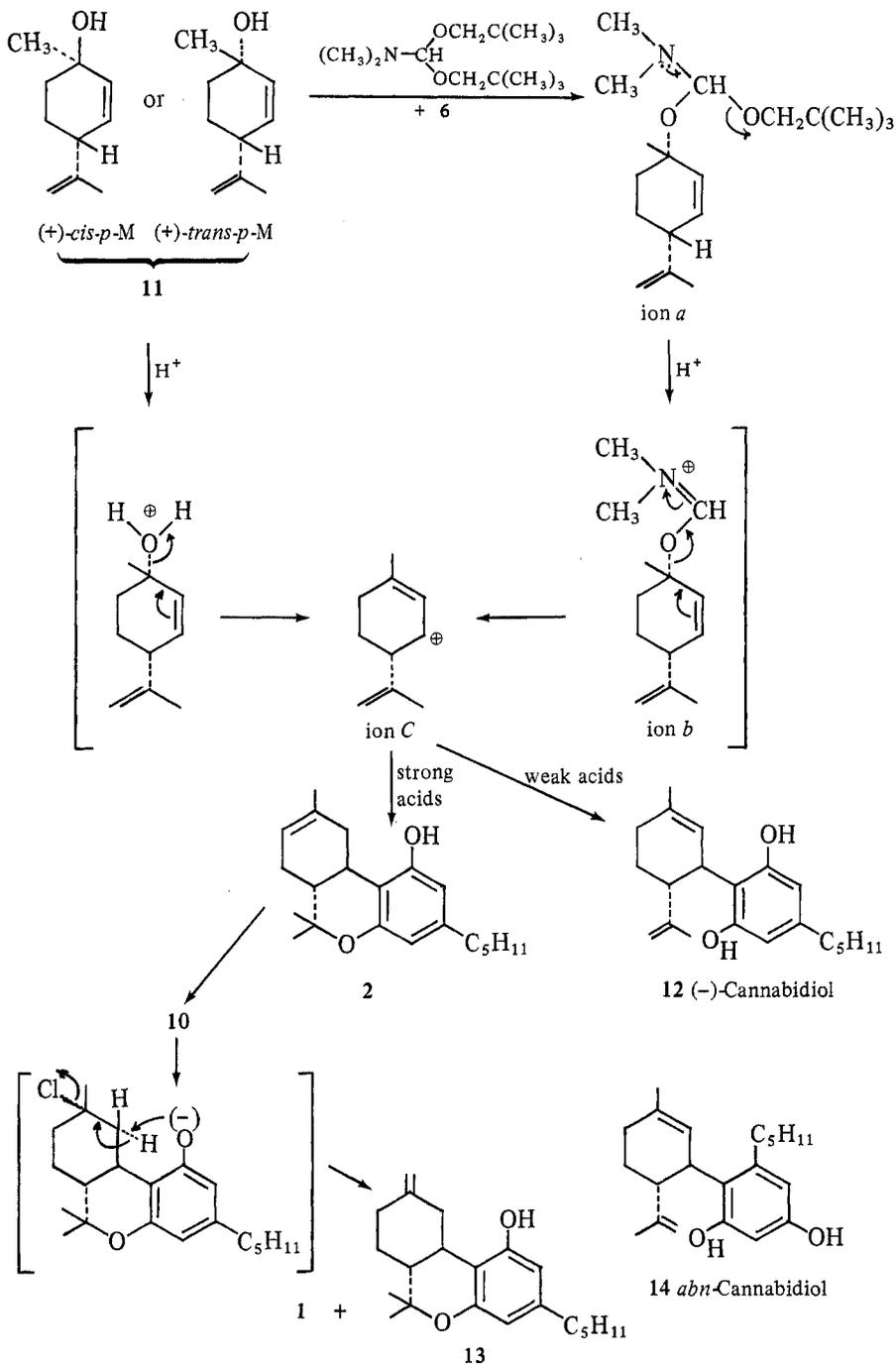

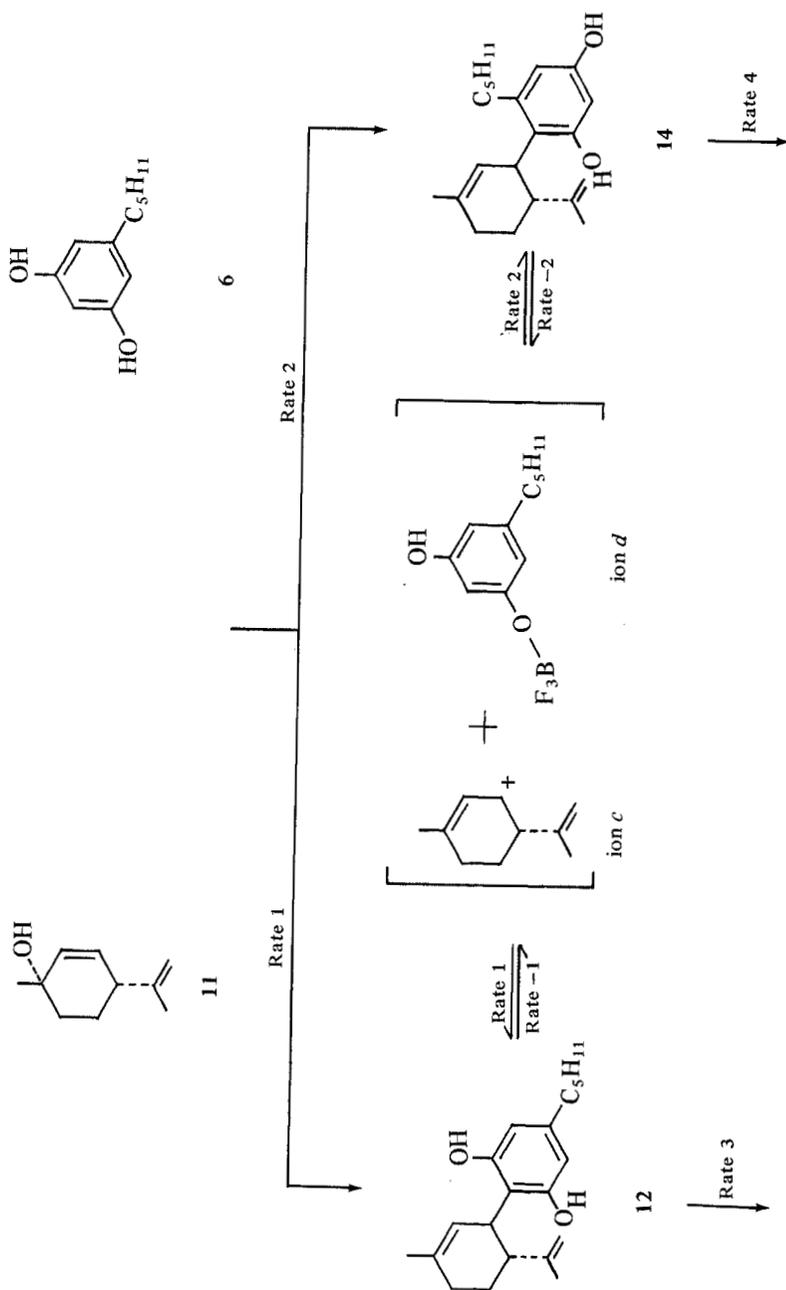
$\text{BF}_3 \cdot \text{Et}_2\text{O}$ in the reaction mixture. With this reasoning Razdan et al.¹⁹ developed a modification of Petrzilka's cannabinoid synthesis utilizing $\text{BF}_3 \cdot \text{Et}_2\text{O}/\text{CH}_2\text{Cl}_2$ in the presence of MgSO_4 as the dehydrating agent. By this process Δ^1 -THC (1) of very high optical purity was formed in a simple one-step synthesis in 50% yield (GLC) and was isolated in 31% yield after a simple and quick column chromatography.¹⁹ The purity of Δ^9 -THC was >96% by GLC and in contrast to Petrzilka's process no Δ^8 -THC (2) is formed under the new conditions. Furthermore, by a slight change in the reaction conditions of the new process, (-)-cannabidiol (12) was obtained on a preparative scale.

On studying this reaction in greater detail, Razdan et al.¹⁹ found (Chart 1.4) that normal cannabidiol (*n*-CBD, 12) and abnormal cannabidiol (*abn*-CBD, 14) were formed first and in a ratio of 1:2. The reaction stopped at this stage if <0.5% $\text{BF}_3 \cdot \text{Et}_2\text{O}$ or wet *p*-TSA was used. This was followed by conversion of cannabidiols 12 and 14 into normal and abnormal THC's (1 and 16) and iso-THCs (15 and 17). Significantly, the ratio of normal to abnormal products was now greater than 3:1, indicating that apparent transformation of *abn*-CBD (14) to normal products was taking place. To elucidate the mechanism they studied the conversion of individual compounds with $\text{BF}_3 \cdot \text{Et}_2\text{O}$ under the reaction conditions and arrived at the following interpretation of their results: (1) reaction rate 2 = twice rate 1, since 12 and 14 are formed in a ratio of 1:2; (2) reaction rate -2 \geq rate 4 because *abn*-CBD (14) is converted into more normal than abnormal products; (3) rate -1 \ll rate -2 because 14 gives 50% normal products, whereas 12 gives no abnormal products and only a small amount of olivetol; and (4) rate 1 > rate 3 and rate 2 > rate 4, since the reaction can give cannabidiols 12 and 14 exclusively.

The different behavior of cannabidiols 12 and 14 can be explained on steric grounds. An examination of Dreiding models shows that in 14, unlike 12, ring closure to abnormal THC 16 results in a large steric interaction between the benzylic methylene of the C_5H_{11} group and the C-2 vinylic proton. This interaction retards the formation of compound 16 and also increases the propensity of 14 to undergo cleavage, probably by forcing a larger contribution of *trans*-diaxial conformation of the cyclohexene ring substituents. This conformation favors ring closure to compound 17 or cleavage to ion c and ion d.

The importance of the steric effect of the 5-alkylresorcinol side chain has been further illustrated by the observation that when the *n*- C_5H_{11} chain in 6 was substituted by a more sterically hindered $\text{CH}(\text{CH}_3)\text{CH}(\text{CH}_3)\text{C}_5\text{H}_{11}$ group, the reaction gave a 3:1 normal to abnormal cannabidiol ratio and subsequent ring closure gave only traces of abnormal products.

The above discussion provides an understanding of the formation of Δ^1 -THC (1) as the main product from 11 and 6.



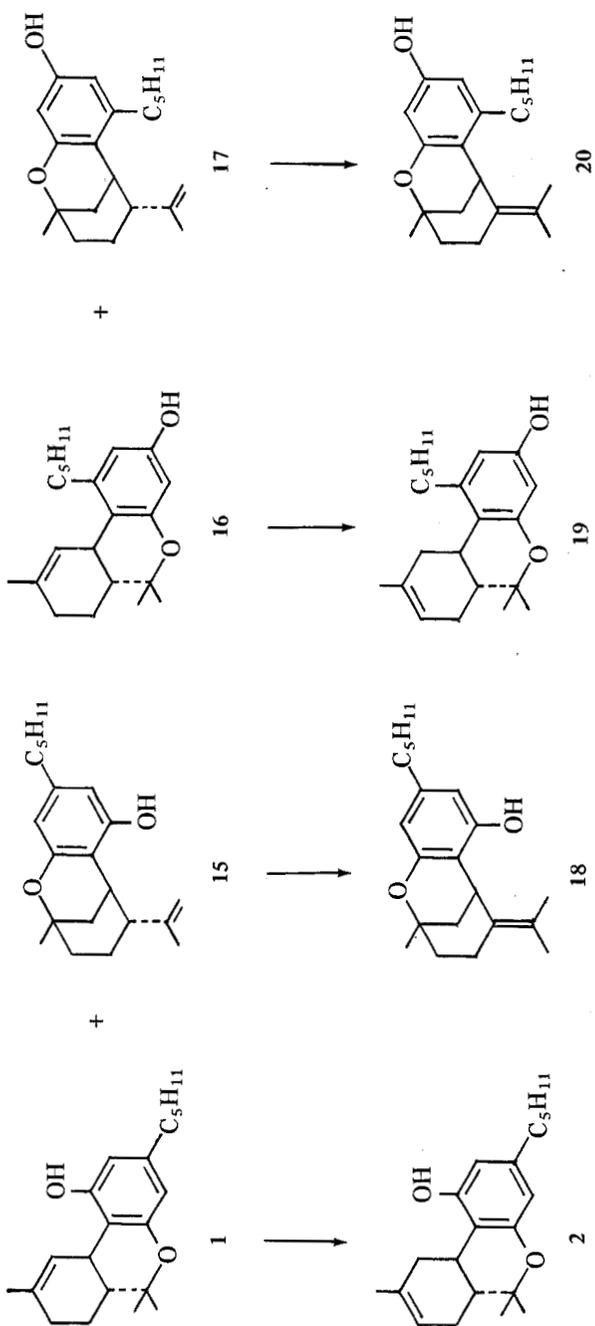

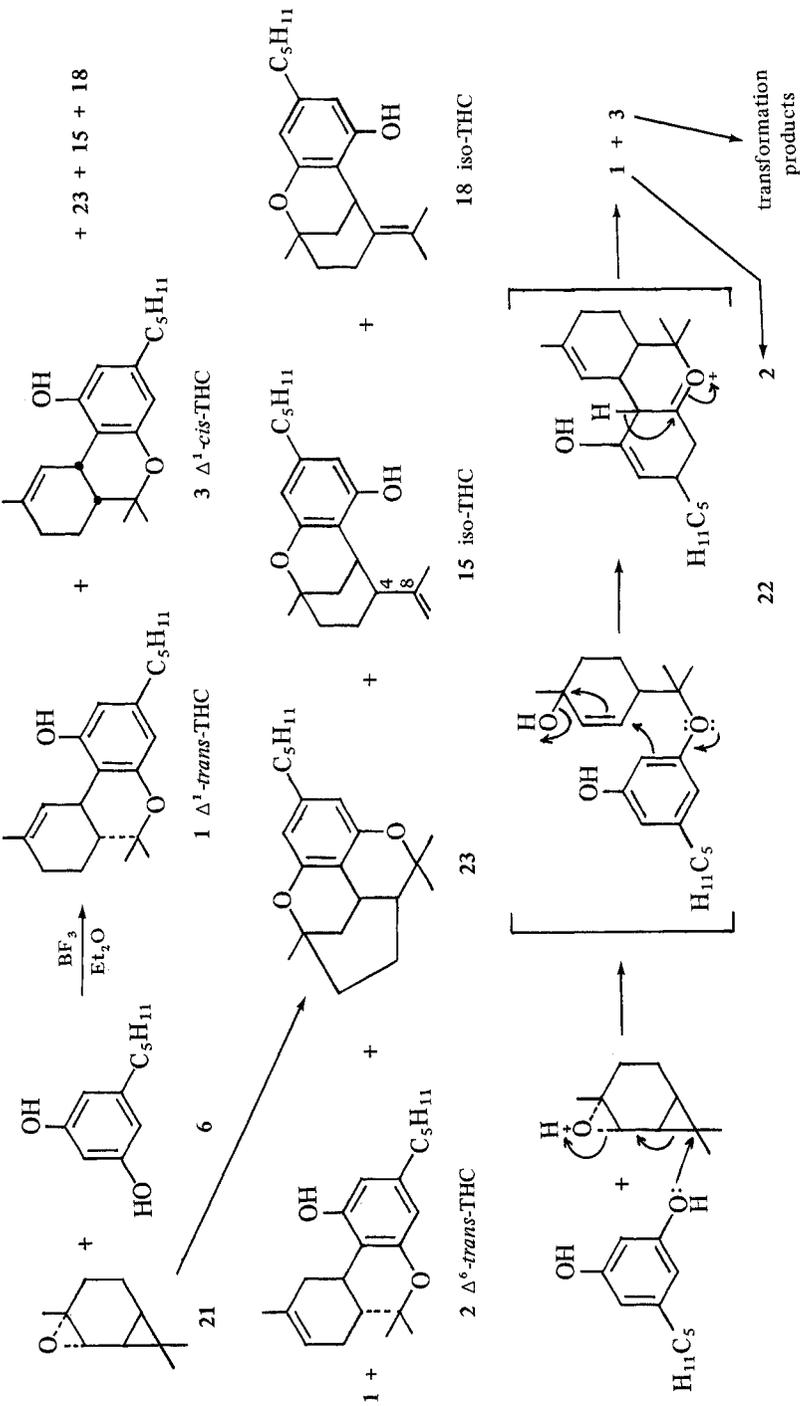

From Carene Epoxides

In 1970 Razdan and Handrick²⁰ reported an entry into cannabinoids from carene derivatives. Treatment of (+)-*trans*-2-carene epoxide (**21**) and **6** (Chart 1.5) in the presence of $\text{BF}_3 \cdot \text{Et}_2\text{O}$ gave mainly a mixture of (-)- Δ^1 -*trans*-THC and (-)- Δ^1 -*cis*-THC (**3**) from which the former was isolated by preparative gas chromatography. As expected, other transformation products like iso-THCs were also formed during this reaction, but no cannabidiol (**12**) was detected. Similar results were obtained by using *p*-TSA when the molar ratio of **21** was increased. However an equimolar quantity of **21** and olivetol (**6**) in the presence of *p*-TSA gave mainly the expected transformation products of Δ^1 -*trans*- and Δ^1 -*cis*-THCs, that is, Δ^6 -*trans*- (**2**) and iso-THCs. These results were interpreted as suggesting that the mechanism is different from the *p*-menthadienol route and that *trans*- and *cis*- Δ^1 -THCs are first formed (Chart 1.5) and are then converted into their transformation products **2** and **23** \rightarrow **15** \rightarrow **18**, respectively.

Recently, Montero has reported in a thesis²¹ that (+)-3-carene epoxide (**24**) and olivetol (**6**) give Δ^6 -THC (**2**) and the corresponding diadduct, on refluxing in benzene with *p*-TSA for 12 hours. He did not isolate any other product from this reaction and postulated the mechanism as proceeding via ion *c*, which seems reasonable under the conditions he carried out the reaction (Chart 1.6).

From *p*-Menth-2-ene-1,8-diol

Handrick et al.²² (Chart 1.7) have recently used another readily available monoterpene *p*-menth-2-ene-1,8-diol²³ (**25**) in the synthesis of (-)- Δ^1 -THC (**1**). This

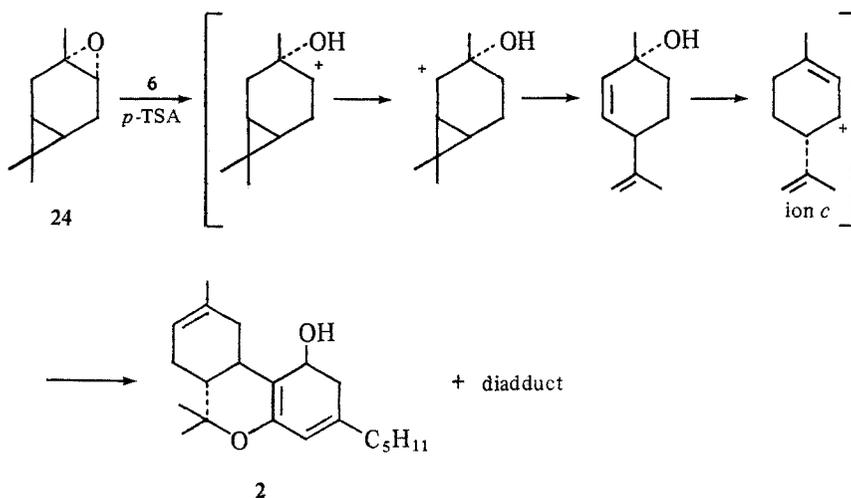

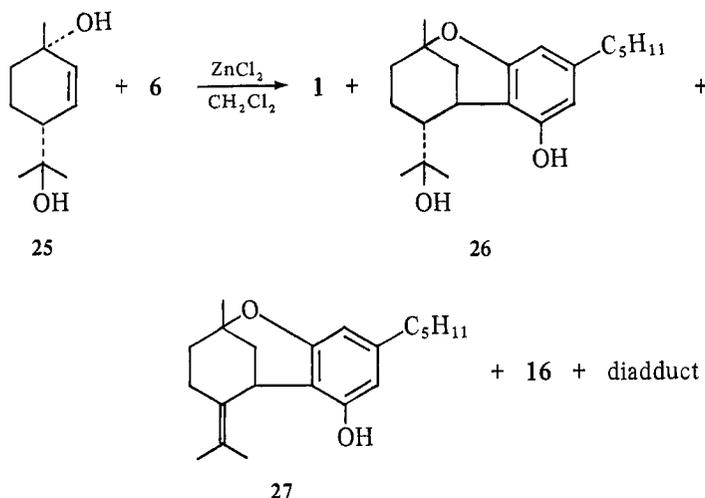

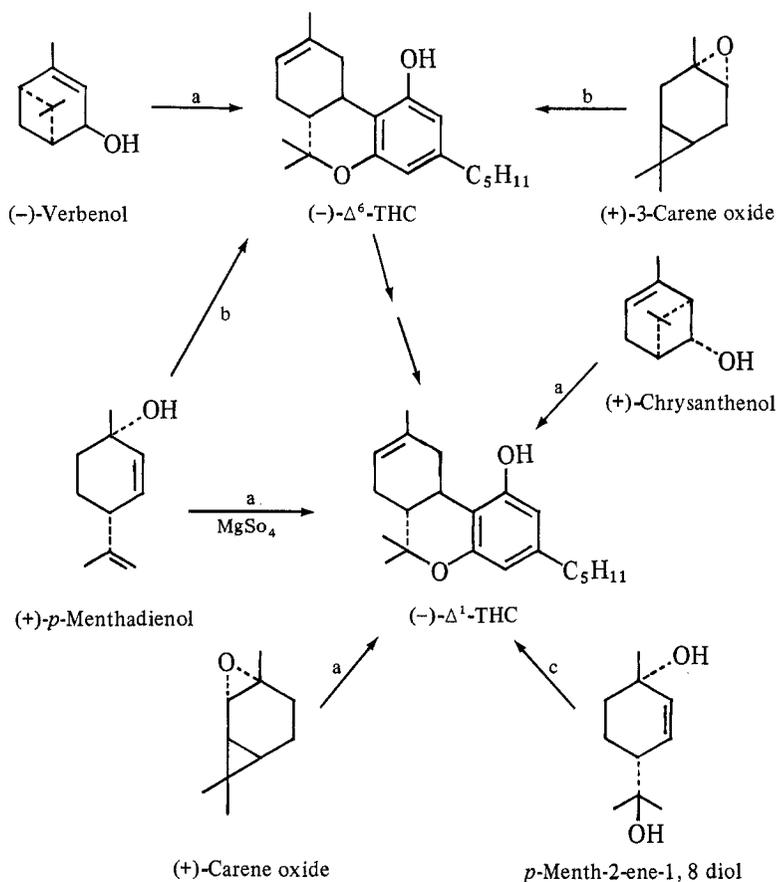
synthon was selected to facilitate the ring formation at C-8 by the presence of a hydroxyl group rather than a double bond as in *p*-mentha-2,8-diene-1-ol (**11**). A variety of catalysts were studied, and the best yield of **1** with the least amount of by-products was found to be with anhydrous $\text{ZnCl}_2/\text{CH}_2\text{Cl}_2$. The material was purified by preparative high-pressure liquid chromatography (HPLC). Although the quality of **1** was excellent, the isolated yield provided no advantage over the *p*-mentha-2,8-dien-1-ol route. It is interesting to note that with Zn halides the reaction stopped at the cannabidiol (**12**) stage with **11** but proceeded to the THC stage with **25** with apparently no isomerization of Δ^1 - to Δ^6 -THC, even during an extended reaction time.

Of all the procedures described above, as stated earlier, Petrzilka's process as developed by Razdan and co-workers¹⁷ is presently used in the large-scale preparation of Δ^1 -THC. Modification of Petrzilka's process ($\text{BF}_3 \cdot \text{Et}_2\text{O}/\text{MgSO}_4$) by Razdan et al.¹⁹ has also been developed²⁴ to produce 50 g lots of **1** of very high purity. The purification is simplified by using Prep HPLC thus avoiding large-scale column chromatography.

Chart 1.8 summarizes the various monoterpenes that have been used for the synthesis of **1** and **2**.

Other Approaches

Various other approaches have been used for the synthesis of Δ^1 - and Δ^6 -THCs and some of these are described below to illustrate this objective.

Diels-Alder Reaction

An entirely different approach, which utilized a Diels-Alder reaction on an appropriately substituted cinnamic acid derivative (Chart 1.9), was developed by Jen et al.²⁵ This approach was originally reported by Adams and co-workers²⁶ but was later abandoned presumably because they failed to demethylate 29. Jen et al.²⁵ deduced the *anti* configuration of 28 from its mode of preparation (Knoevenagel reaction of malonic acid with the corresponding aldehyde) and confirmed it by NMR. Based on the rule governing the retention of configuration of the dienophile constituents in the Diels-Alder reaction, compound 29

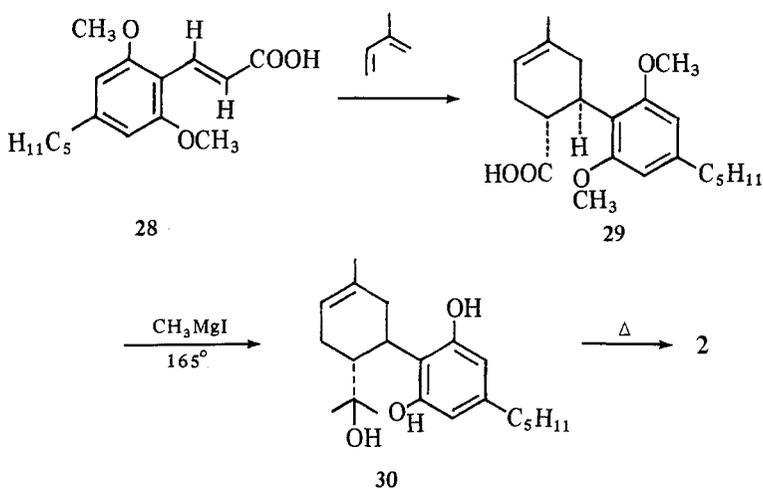

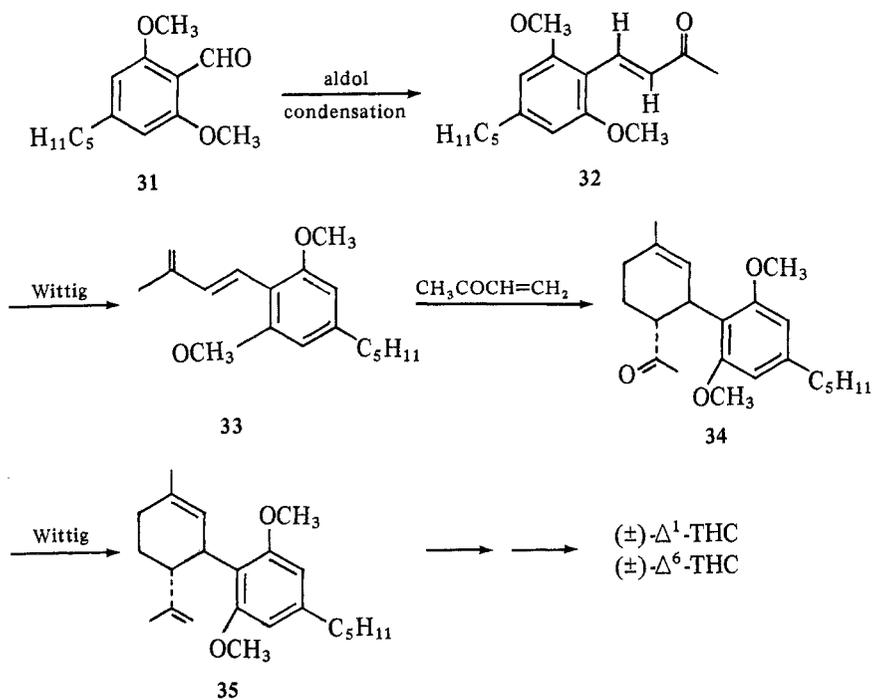

showed the *trans* configuration analogous to that found in THCs. After resolution of racemic **29** and treatment with excess CH_3MgI at 165° , the dimethoxy groups were successfully removed and the carboxyl was converted to a 2-hydroxypropyl group to give the triol **30**. Distillation furnished (-)- Δ^6 -THC (**2**). Similarly the (+)-isomer was also prepared.

Another variation^{27,28} on the Diels-Alder approach is shown in Chart 1.10.

From Citral

A synthesis of (\pm)-THCs, which is of historical interest and patterned along the suggested biogenetic pathway, was published by Mechoulam and Gaoni²⁹ (Chart 1.11). It was the first synthesis of (\pm)- Δ^1 -THC and was achieved from citral (**36**) and the lithium derivative of olivetol dimethyl ether (**37**). A mixture was obtained that was tosylated to yield (\pm)-**35**. The success of the synthesis was due to the fact that **35** could be demethylated under near-neutral conditions to give **12**, since it is known that **12** is sensitive to both acidic and strongly basic conditions. As described earlier (Chart 1.9) the same procedure was used by Jen et al.²⁵ in their synthesis. Acid treatment of **12** gave **1** and **2**.

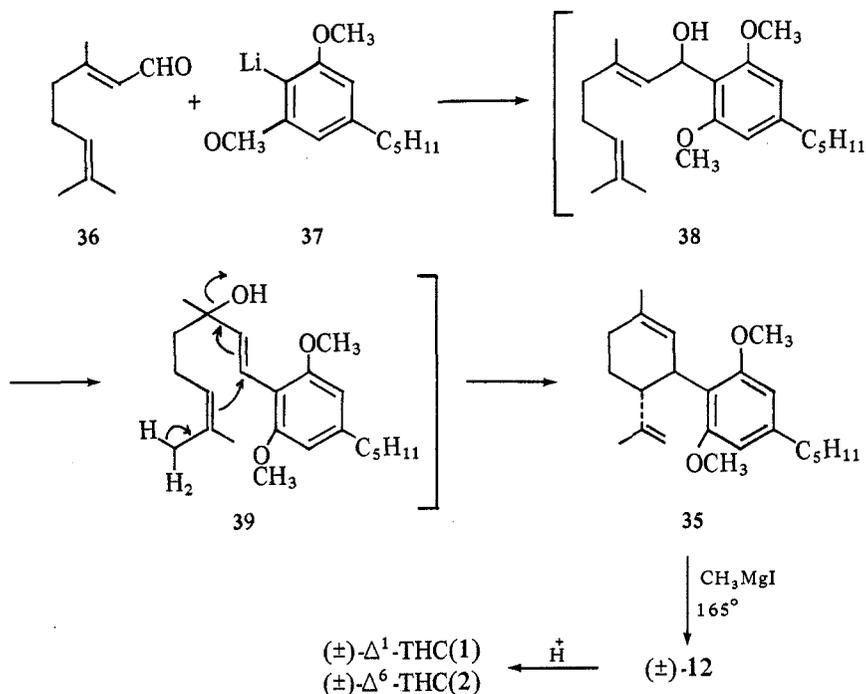

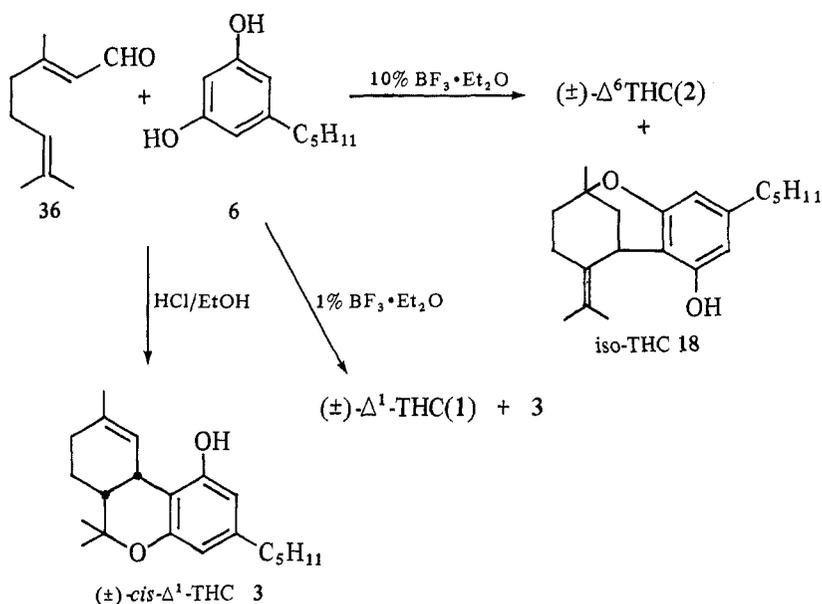

A very facile synthesis and somewhat related to the above synthesis of (\pm) -THCs was reported by Taylor et al.^{30,31} In their approach olivetol (6) and citral were condensed with 10% $\text{BF}_3 \cdot \text{Et}_2\text{O}$ (Chart 1.12). These authors also found that with 0.0005 *N* $\text{HCl}/\text{C}_2\text{H}_5\text{OH}$, $(\pm)\text{-cis-}\Delta^1\text{-THC}$ (3) was formed in about 12% yield together with small amounts of $(\pm)\text{-trans-}\Delta^1\text{-THC}$ (1). Mechoulam et al.²⁹ later improved the yield of 1 to 20% by using 1% $\text{BF}_3 \cdot \text{Et}_2\text{O}$ in CH_2Cl_2 . The mechanism of formation of these compounds has not yet been clearly established.

Pechmann Condensation

A very versatile route based on Von Pechmann condensation was developed by Fahrenholtz et al.¹⁶ By this sequence (Chart 1.13) they prepared racemic Δ^1 -, Δ^6 -, and $\Delta^{1(7)}$ -THCs. In addition the synthesis of $(\pm)\text{-cis-}\Delta^1\text{-THC}$ and $(\pm)\text{-cis-}\Delta^{1(7)}$ -THC (48) was achieved from 46. The Li/NH_3 reduction of 43 gave both the *cis*- and *trans*-ketones 46 and 44, respectively, which were separated. The major product was the *trans*-isomer as expected. The *cis*-ketone 46 was also prepared by catalytic reduction (Raney nickel) under high pressure and temperature of the ketal of 42 followed by treatment with CH_3MgI and acid hydrolysis.

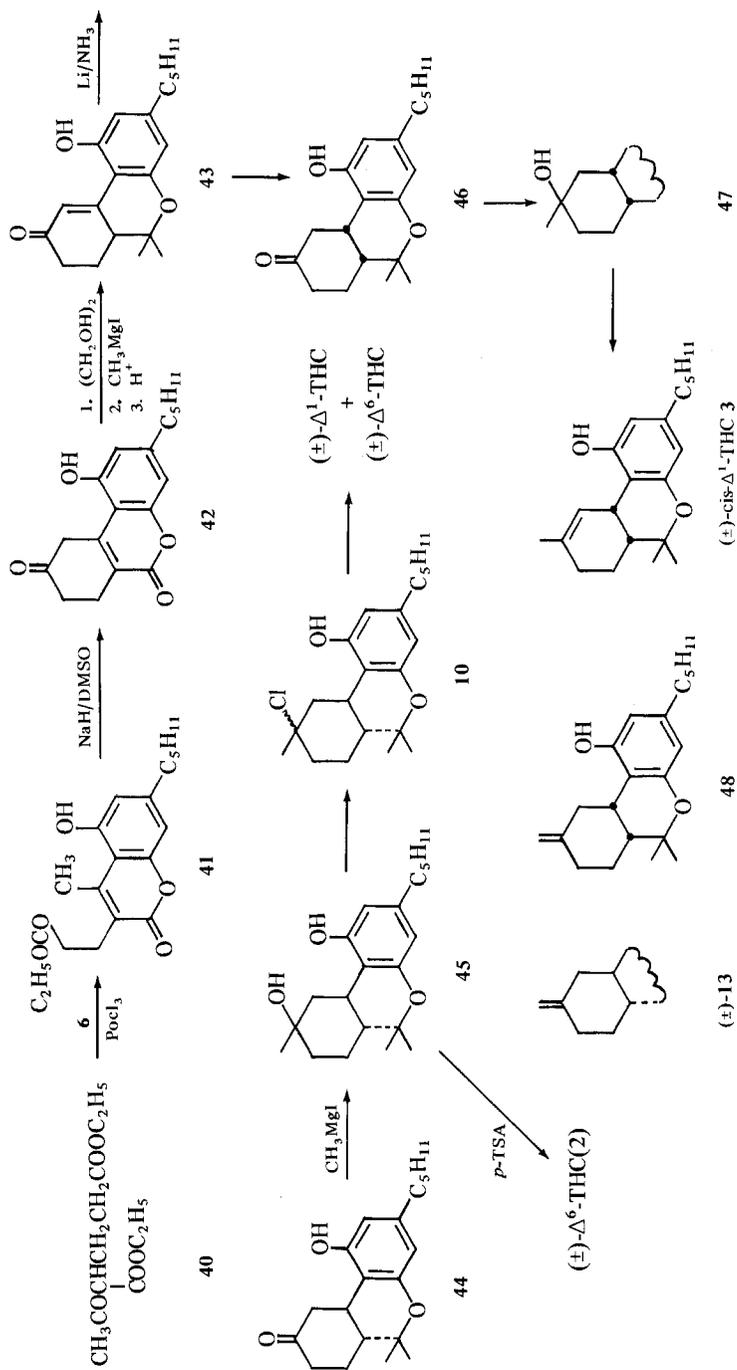
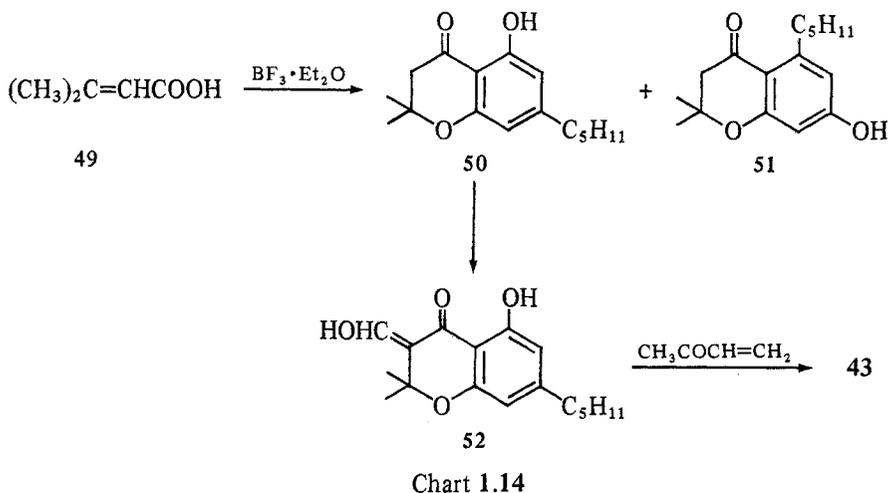

Alternatively the key intermediate **43** was also prepared from **49** (Chart 1.14). The alicyclic ring was built by using the standard Robinson annelation procedure.

B. Synthesis of *cis*-THCs

Of the two *cis*-isomers, that is, *cis*- Δ^1 -THC (**3**) and *cis*- Δ^6 -THC (**4**) only **3** has been found in the plant and that only recently.³² The Δ^1 -isomer **3** is more thermodynamically stable than the Δ^6 -isomer **4**. The former is well characterized, and its formation was observed during some synthetic sequences such as from citral-olivetol reaction (Chart 1.12) as reported by Taylor et al.³⁰ the carene oxide synthesis (Chart 1.5) by Razdan and Handrick²⁰ and a total synthesis by Fahrenholtz et al.¹⁶ (Chart 1.13). Recently another synthesis, utilizing olivetol bis(tetrahydropyranyl ether) homocuprate and dehydrolinalool acetate, has been reported by Luteijn and Spronck.^{32a}

In contrast, the *cis*- Δ^6 -isomer **4** has had a confusing history. The earlier claims³⁰ regarding its synthesis has not been substantiated,³¹ since at one time $\Delta^4,^8$ -iso-THC **18** was erroneously regarded as *cis*- Δ^6 -THC (**4**).

Synthesis of (\pm)-*cis*- Δ^6 -THC

In 1975 the synthesis of authentic (\pm)-**4** by three routes was achieved by Uliss et al.³³

In the first synthesis they utilized the stereospecific intramolecular epoxide cleavage by phenolate anion.³⁴ Thus (Chart 1.15) epoxidation with *m*-chloro-perbenzoic acid at 0° formed **54** from the acetate of (\pm)-*cis*- Δ^1 -THC **53**. Under

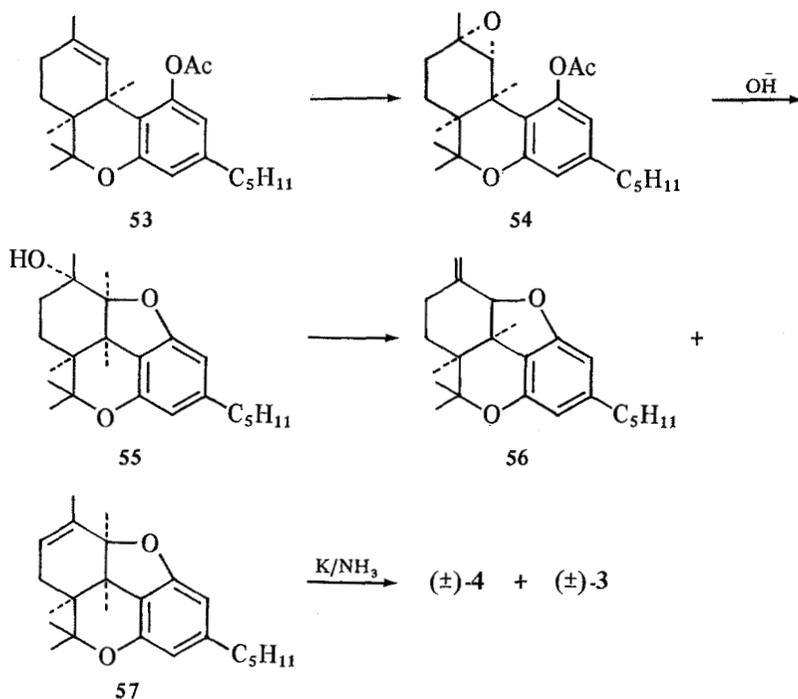

basic hydrolytic conditions **54** gave the benzofuran **55** in 90% yield. Dehydration with HMPA (240°, 0.25 h) gave a 3:2 mixture of **57** and **56**. Treatment of this mixture with K/NH_3 gave a mixture of the two *cis*-THCs, which were separated as their acetates by HPLC and subsequently hydrolyzed to give (\pm)-**4**.

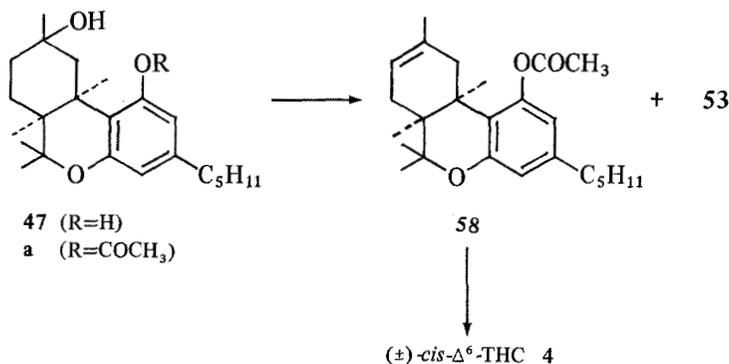

In a second synthesis (Chart 1.16), acetylation of the known *cis*-tertiary alcohol 47¹⁶ gave compound 47a. Treatment of 47a with thionyl chloride/pyridine furnished a mixture of 58 and 53 (2:3 by GLC), which was separated by HPLC. 58 was then hydrolyzed to yield (\pm)-4.

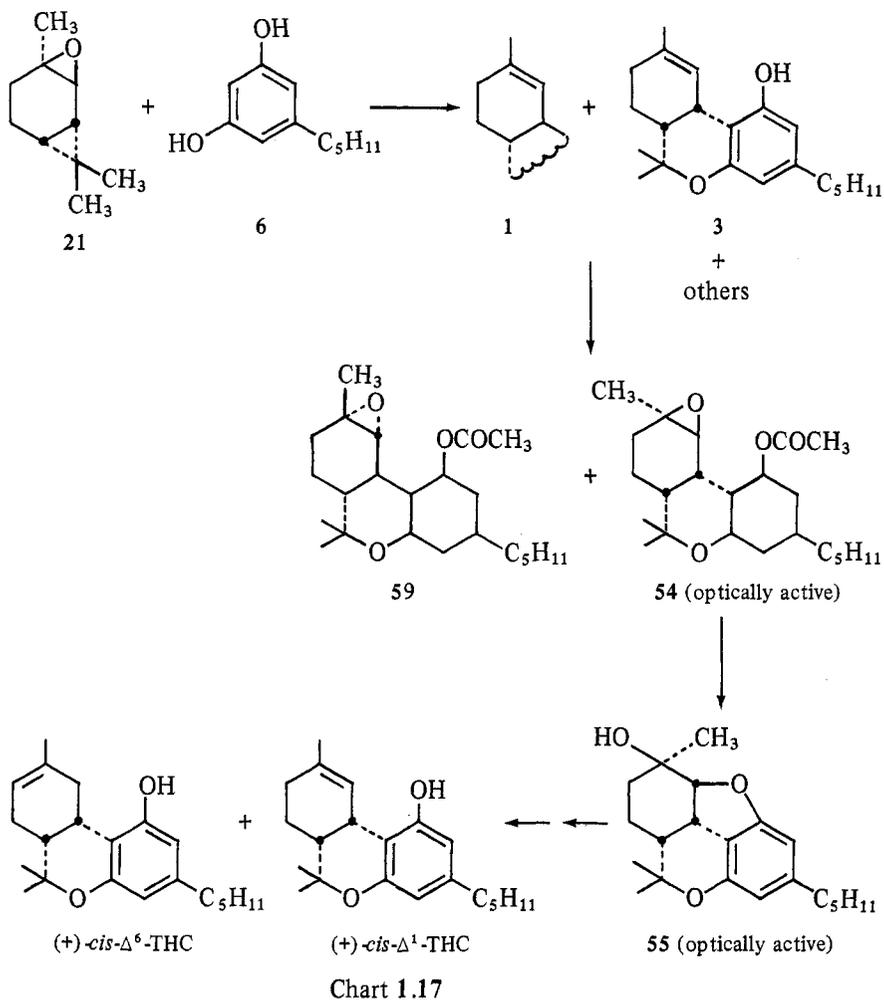
It was found that Δ^1 -*cis*-THC acetate (53) under acid catalysis (*p*-TSA in boiling benzene) provided substantial quantities of the thermodynamically less stable 58 at equilibrium (ratio of 77:23, respectively). This is contrary to results reported in the literature^{31b} and constitutes on hydrolysis the third synthesis of (\pm)-4.

Synthesis of (+)-*cis*- Δ^1 - and Δ^6 -THC's

Razdan and Handrick²⁰ had earlier reported a one-step stereospecific synthesis of (-)- Δ^1 -THC (1) from a carene derivative. In this reaction (Chart 1.5) (+)-*trans*-2-carene oxide (21) and olivetol (6) in the presence of $\text{BF}_3 \cdot \text{Et}_2\text{O}$ gave a complex mixture containing optically active *trans*- and *cis*- Δ^1 -THCs (1 and 3). Since separation of these two isomers proved difficult by chromatography on a preparative scale, a chemical reaction sequence was carried out (Chart 1.17) which allowed the separation of the *cis*-isomers from the *trans*-products. It takes advantage of the observation that *trans*-compounds do not undergo the stereospecific intramolecular epoxide cleavage by phenolate anion because of ring strain. On this basis Uliss et al.³⁵ acetylated the crude mixture and allowed it to react with *m*-chloroperbenzoic acid to presumably give a mixture containing optically active epoxides 54 and 59. Hydrolysis with base was accompanied by an intramolecular opening of the epoxide ring (as in the racemic case, Chart 1.15), which occurred exclusively with the *cis*-isomer 54, resulting in the dihydrofuran derivative 55. After base treatment 55 was easily isolated as a neutral fraction and was then dehydrated, reductively cleaved and purified to give pure (+)-*cis*- Δ^1 -THC and (+)-*cis*- Δ^6 -THC. The natural *cis*- Δ^1 -THC (3) has the opposite configuration to Δ^1 -THC at C₄.³²

C. Metabolites of Tetrahydrocannabinols

Extensive literature^{3b,3c,36} has appeared in recent years describing the various metabolites of THC's isolated from *in vivo* or *in vitro* studies. These have been carried out on a wide variety of animal species and in some cases different animal organ homogenates have been utilized. Important sites of metabolism of Δ^1 - and Δ^6 -THCs are shown in Chart 1.18 with a listing of some specific metabolites. The hydroxylation at the 7-position appears to be the major initial point of attack in nearly every species tested including man. This metabolite, 7-hydroxy- Δ^1 -THC, is pharmacologically equiactive with Δ^1 -THC, and still others are active to different degrees. This has complicated the understanding of



marijuana activity in man. The metabolites of Δ^1 -THC so far identified in man³⁷ are shown in Chart 1.19.

D. Metabolites Functionalized in the Alicyclic Ring

The most important member of this class is the 7-hydroxy- Δ^1 -THC because it is pharmacologically equiactive with Δ^1 -THC. The problems associated with the synthesis of these metabolites in the Δ^1 -series are somewhat similar to those

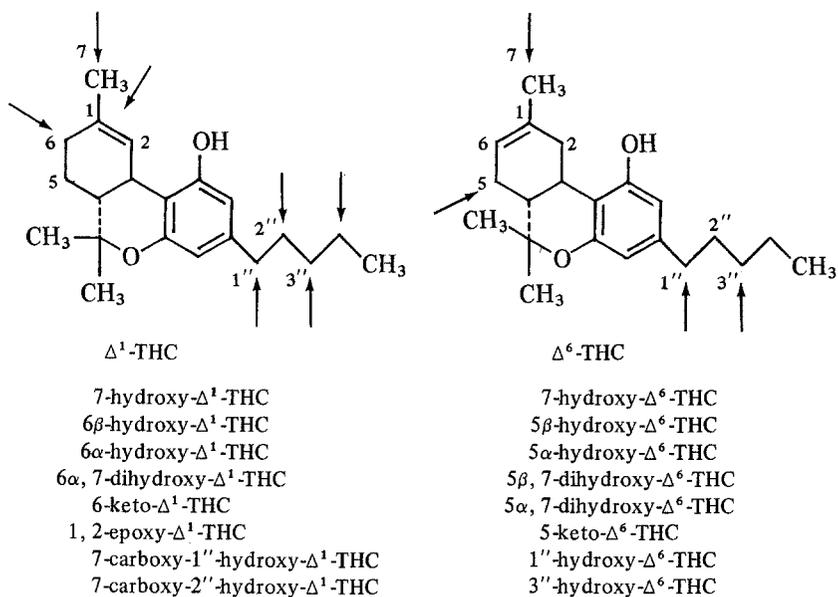

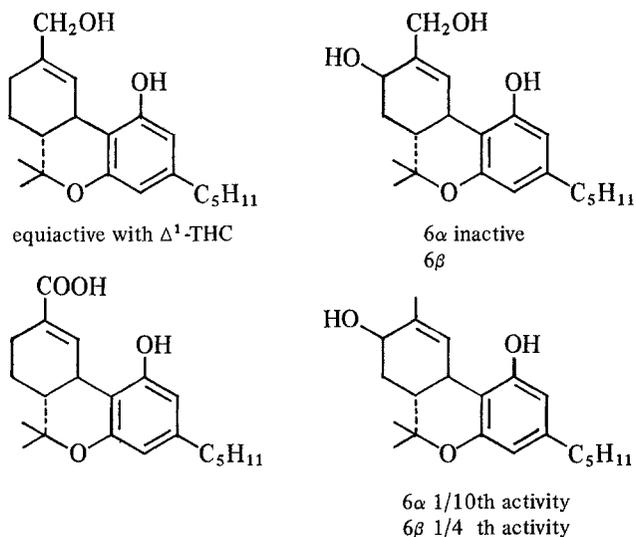

encountered in the synthesis of Δ^1 -THC itself as has already been discussed in the Introduction. Thus a number of synthetic procedures that work satisfactorily in the Δ^6 series prove to be inadequate in the Δ^1 series.

7-Substituted Metabolites

A detailed discussion of the Δ^1 -metabolites, which result from the natural material Δ^1 -THC, is appropriate. Therefore various approaches to the synthesis of 7-hydroxy- Δ^1 -THC, the most important member of this class, are described, and in addition some examples in the Δ^6 -series are included to illustrate other synthetic strategies.

Δ^1 -Derivatives

Pitt et al.³⁸ have developed a regioselective route to some of these metabolites by a base induced epoxide-allylic alcohol rearrangement followed by S_N1' displacement. This procedure provides a new method of derivatizing the allylic 7-methyl group of Δ^1 -THC and the synthetic sequence to 7-hydroxy- Δ^1 -THC **64** from Δ^1 -THC (**1**) is shown in Chart 1.20. Δ^1 -THC acetate was converted to the known α -epoxide **59** which was isomerized to a mixture of the allylic alcohols **60** and **61** in excellent yield by treatment with the lithium salt of an amine in

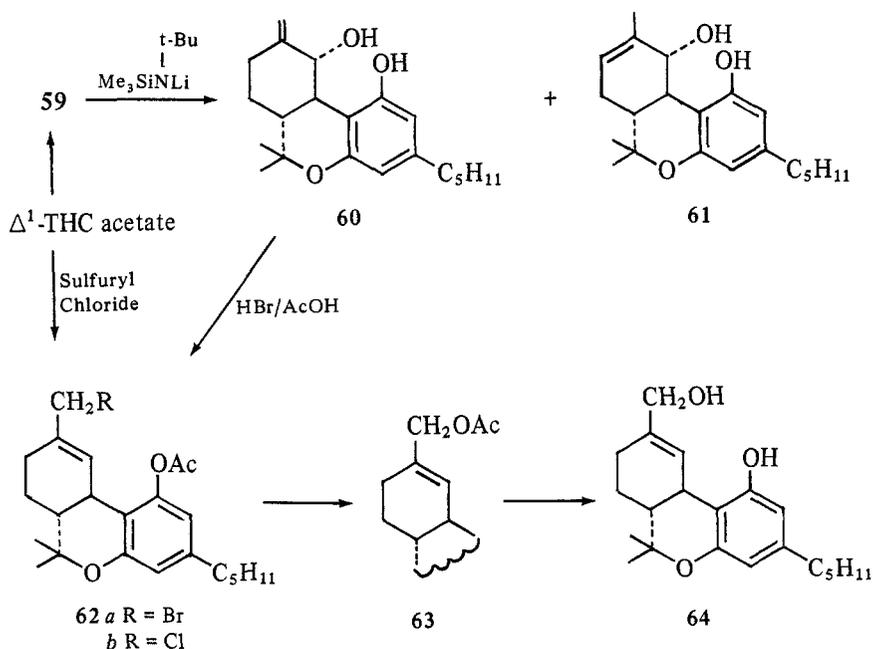

ether. The ratio of **60/61** was controlled by the size of the substituent on the amine. Thus the use of $\text{Me}_3\text{SiNH-}t\text{-Bu}$ gave the best yield of **60**, which was converted to **62a** by 5% HBr/AcOH taking advantage of the thermodynamically controlled SN' isomerization of allylic bromides. Acetolysis with tetramethyl ammonium acetate in acetone followed by reduction with LiAlH_4 converted **62a** to the desired metabolite **64** in $\sim 20\%$ yield. In an alternative procedure³⁸ the phenol in **60** was selectively protected as ethoxymethyl ether and then treated with SOCl_2/Py to give the corresponding 7-chloro derivative. Acetolysis as before, followed by acid-catalyzed removal of the acetyl and ethoxymethyl groups formed the metabolite **64**. The yield was not as good as in the other procedure.

Direct allylic halogenation or oxidation of Δ^1 -THC acetate has also been carried out, but the yields have been unsatisfactory mainly because of the lack of selectivity of attack at the primary and secondary allylic sites of Δ^1 -THC. Pitt et al.³⁹ reported that treatment of Δ^1 -THC acetate with sulfuryl chloride (Chart 1.20) gave a mixture containing **62b**, which, with silver acetate in acetic acid followed by hydrolysis with base, formed **64** albeit in poor yield (5%). The other metabolite 6β -hydroxy- Δ^1 -THC was also isolated (14%) from this synthesis. Reagents like *N*-chloro- and *N*-bromosuccinimide, predominantly halogenate in the C-6 position, and these have been utilized in the synthesis of various 6-substituted metabolites.

Ben-Zvi et al.⁴⁰ reported the SeO_2 oxidation of Δ^1 -THC acetate (Chart 1.21) followed by reduction with LiAlH_4 to give **64** in poor yield (1%), the main product being 7-hydroxycannabinol (**65**). This procedure has proved more successful in Δ^6 -series (Chart 1.25).

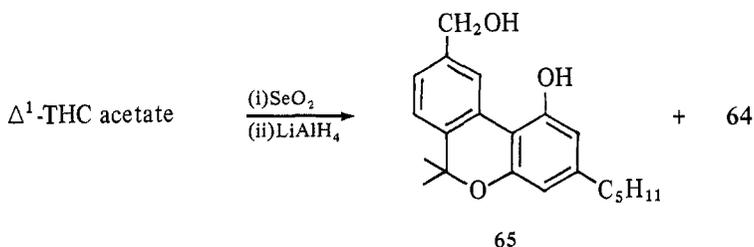

In a different approach, Razdan et al.⁴¹ (Chart 1.22) oxidized the exocyclic double bond of (-)- Δ^1 (ⁿ)-THC acetate (**66**) with *m*-chloroperbenzoic acid to the epoxide **67**, which was hydrolyzed (basic conditions were used to avoid forming the Δ^6 -dehydration products) with 0.3N KOH/DMSO to form the triol **68**. After acetylation, the diacetate alcohol **69** was treated with SOCl_2/Py to give a

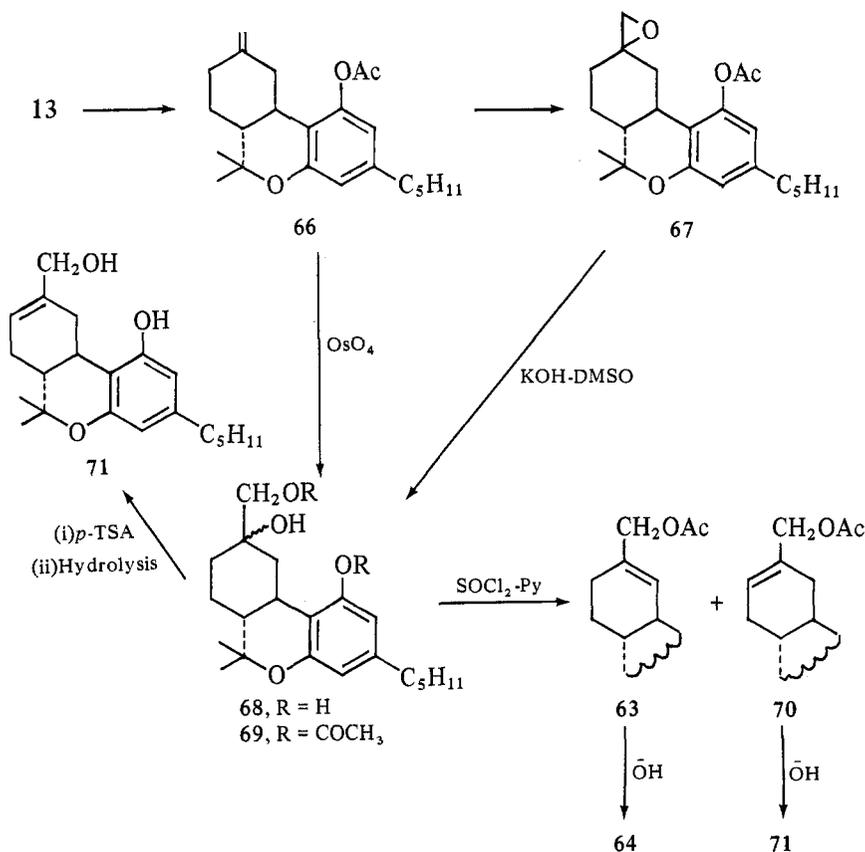

mixture of the two metabolites as their diacetates **63** and **70**. These were separated by HPLC and then hydrolyzed with base to yield 7-hydroxy- Δ^1 -THC (**64**). The overall yield of **64** from $\Delta^1(7)$ -THC (**13**) was 13%. Alternatively **69** was obtained from **66** by hydroxylation of the exocyclic double bond with OsO_4 in ether followed by acetylation. These syntheses were developed because **13** became available in large quantities from the kilogram synthesis of Δ^1 -THC (see Chart 1.3).^{17,18} The intermediate **69** also provided a facile route to the 7-hydroxy- Δ^6 -THC **71**.⁴² This was achieved by treatment with p -TSA followed by hydrolysis in an overall yield of 75% from **13**.

Uliss et al.⁴³ have recently reported a versatile route to 7-substituted Δ^1 -THCs from the novel synthons **75a** and **75b**. This scheme (Chart 1.23) is based on the principal of reversal of reactivity of carbonyl compounds when masked as dithioacetals (i.e., umpolung). Interestingly, this route has resulted in the synthesis of

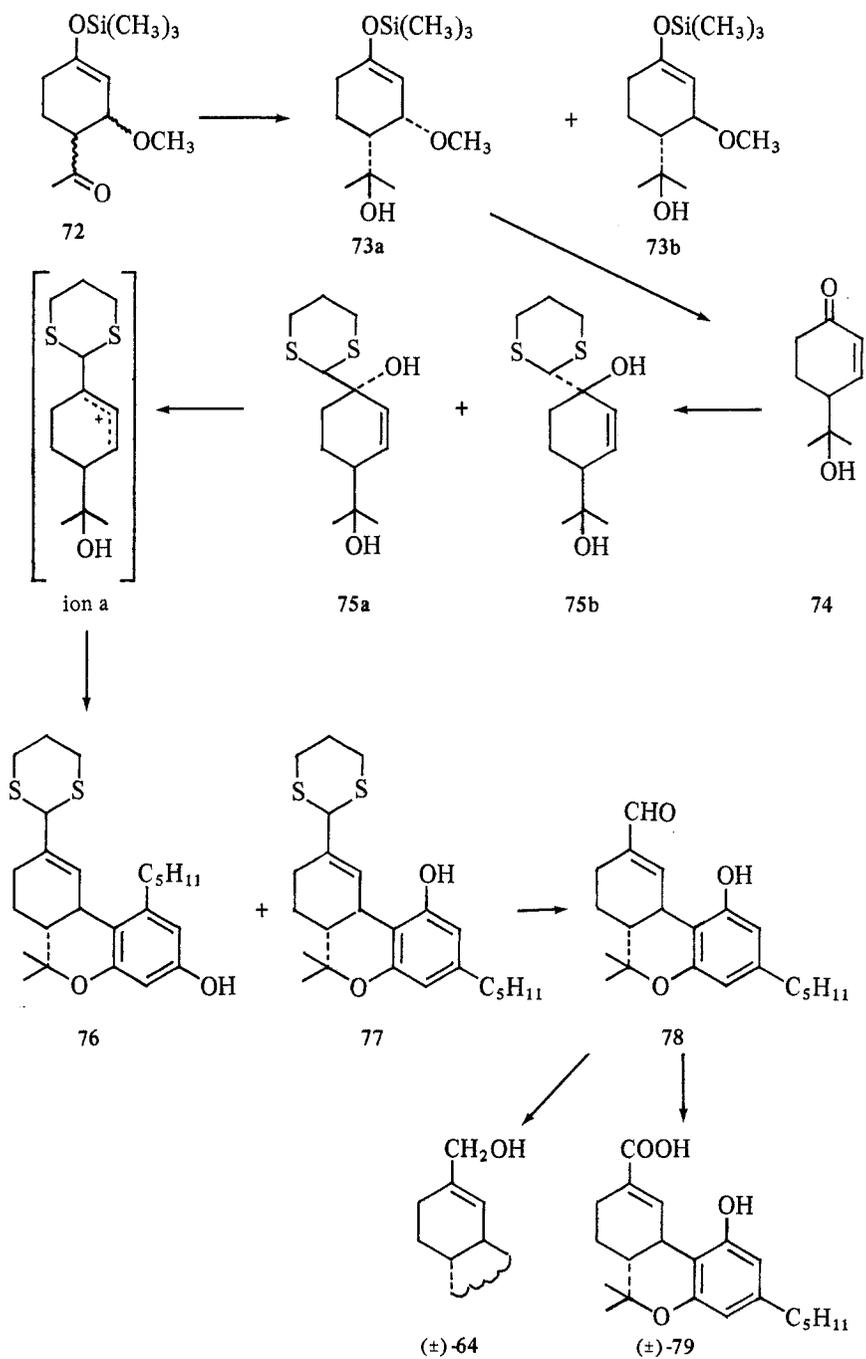
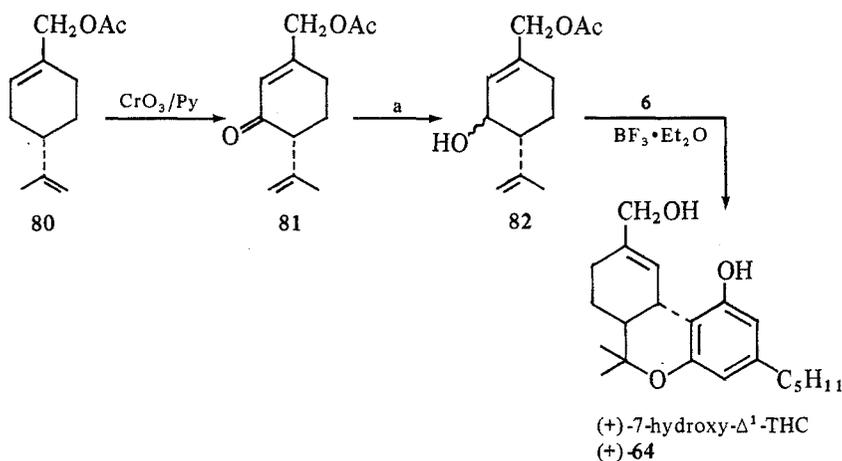

Δ^1 -derivatives specifically, since by introduction of the dithiane moiety into the THC structure, isomerization of the normally labile Δ^1 unsaturation to the Δ^6 isomer is effectively inhibited. The synthons **75a** and **75b** were readily obtained by carrying out a Grignard reaction on the Diels-Alder adduct **72**, thus extending the usefulness of Danishefsky's novel Diels-Alder diene.⁴⁴ This was followed by hydrolysis of the mixture (**73a + b**) to **74** with CCl_3COOH and addition of the Li anion of 1,3-dithiane to **75**. Treatment with olivetol (**6**) in the presence of *p*-TSA gave a mixture of Δ^1 -compounds **76** and **77**, which was separated. The dithiane masking group in **77** was readily removed by $\text{HgO}/\text{BF}_3 \cdot \text{Et}_2\text{O}$ to give the metabolite (\pm)-**78**.⁴⁵ This was converted by LiAlH_4 reduction to the metabolite (\pm)-**64** or oxidized with $\text{MnO}_2/\text{CH}_3\text{OH}$ containing acetone cyanohydrin, to the metabolite (\pm)-**79**.³⁸

(-)-Perillyl aldehyde was converted into perillyl alcohol acetate (**80**) and then to **82** via **81**. On condensation with olivetol Lander et al.⁴⁶ obtained the (+)-7-hydroxy- Δ^1 -THC (Chart 1.24) in low yield.

Δ^6 -Derivatives

In the case of 7-substituted Δ^6 -derivatives the syntheses in general are more straightforward. Thus as described earlier (Chart 1.22) 7-hydroxy- Δ^6 -THC (**71**) is prepared⁴¹ in excellent yield from Δ^1 (⁷)-THC (**13**). Oxidation of Δ^6 -THC acetate (Chart 1.25) with SeO_2 under controlled conditions followed by acetylation gives directly the 7-acetoxy- Δ^6 -THC acetate (**70**), which on reduction provides the metabolite **71**.⁴⁰ By slightly changing the oxidation conditions and

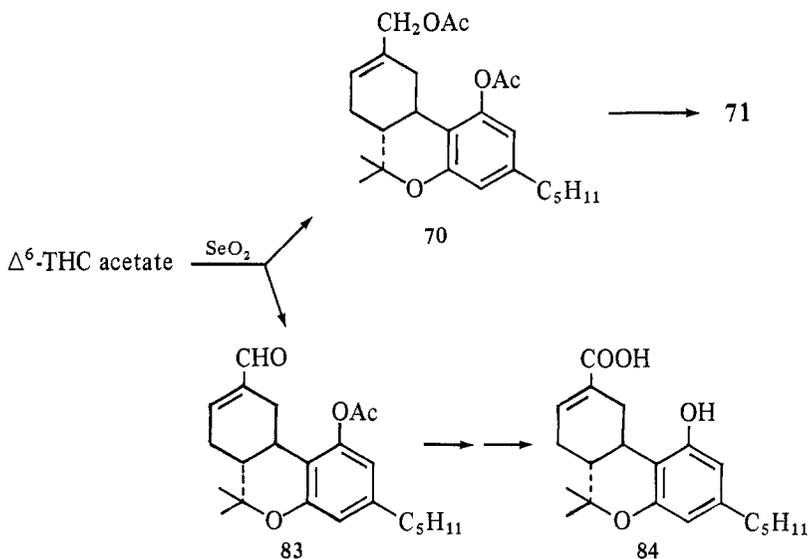

refluxing Δ^6 -THC acetate with SeO_2 for a prolonged period in ethanol, the aldehyde 83 is isolated.^{47,48} On further oxidation with MnO_2/NaCN in CH_3OH followed by hydrolysis 83 was converted to the metabolite 84.⁴⁷ These reactions of Δ^6 -THC acetate with SeO_2 are in contrast to similar oxidation of Δ^1 -THC acetate (cf. Chart 1.21).

In other syntheses of 7-hydroxy- Δ^6 -THC (71), the epoxide 85 of Δ^6 -THC acetate with HClO_4 gave 86 (Chart 1.26), which after acetylation and dehydration (SOCl_2/Py) formed 87. After hydrolysis and allylic rearrangement 87 was converted to the metabolite 71.^{3b}

The base-induced epoxide-allylic alcohol rearrangement was applied by Petrzilka and Demuth⁴⁹ on 88 to give a mixture of allylic alcohols 89 (Chart 1.27). These were acetylated after removal of the tetrahydropyranyl (THP) protecting group to give 87 and then subjected to allylic rearrangement and reduction to form 71. The allylic alcohols 89 were also obtained from Δ^6 -THC acetate by a photochemical rearrangement followed by reduction.

A direct conversion of $\Delta^1(7)$ -THC acetate 66 to 7-bromo- Δ^6 -THC acetate (90) was achieved by Weinhardt et al.⁵⁰ by using *N*-bromoacetamide in the presence of 70% HClO_4 . Treatment with silver acetate/ AcOH gave 70, which on alkaline hydrolysis furnished 71 (Chart 1.28).

The metabolites 84 and 71 were also synthesized by Pitt et al.³⁹ from 91 (Chart 1.29), which has been previously prepared by Wildes et al.⁵¹ The morpho-

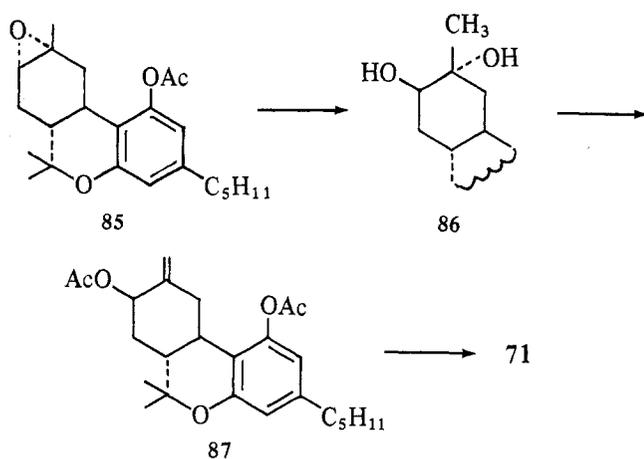
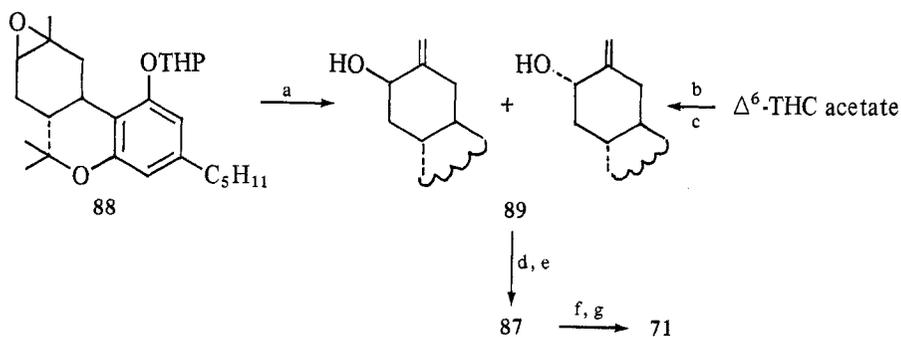

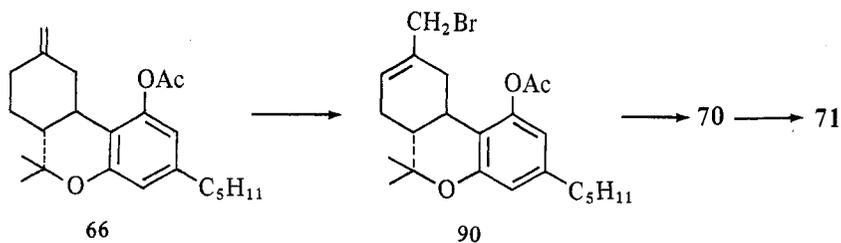

linoenamine of **91** treated with CCl_3COOH gave the α -chloramide **92**. After removal of the benzyl protecting group and conversion to the phenoxide anion to eliminate HCl , only the Δ^6 -amide **93** was obtained. Saponification of **93** gave the metabolite **84**, which was reduced with LiAlH_4 to **71**.

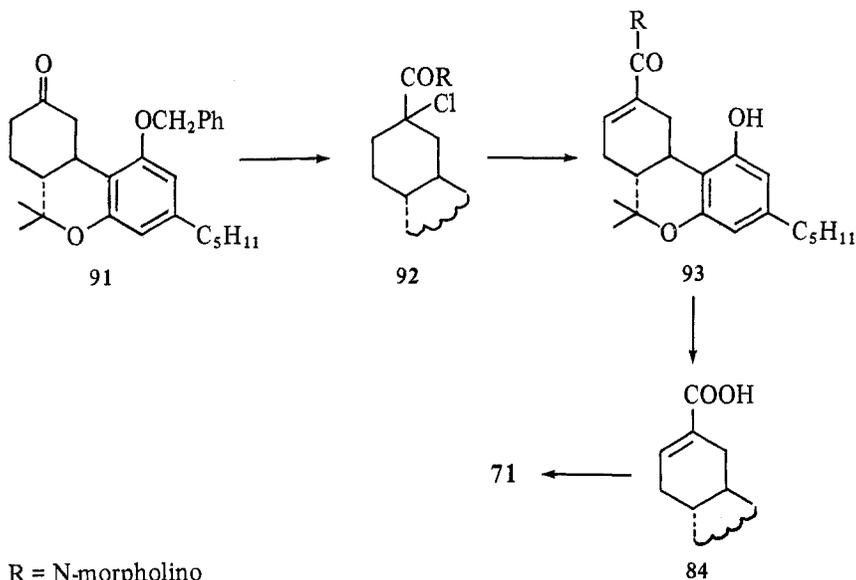

6-Substituted Metabolites

The 6α - and 6β -hydroxy- Δ^1 -THC's are two metabolites that have been identified in man. The latter, **95**, was directly prepared (Chart 1.30) by bromination of Δ^1 -THC acetate with *N*-bromosuccinimide³⁸ or sulfuryl chloride³⁹ followed by acetolysis and hydrolysis. The 6α -metabolite **97** was prepared³⁸ from **95** by selective acetylation of the phenolic group and MnO_2 dioxide oxidation to **96** followed by LiAlH_4 reduction to **97**. It is interesting to note that **96** was also obtained⁵² by SeO_2 oxidation of Δ^1 -THC acetate (cf. Chart 1.21).

5-Substituted Metabolites

The metabolites⁵³ known in this class were synthesized⁵² from Δ^6 -THC acetate as shown in Chart 1.31. Oxidation with *t*-butylchromate gave **98**. It was reduced with LiAlH_4 to give a mixture of the 5α - and 5β -hydroxy- Δ^6 -THCs, **99** and **100**, respectively. These were isolated by chromatography.

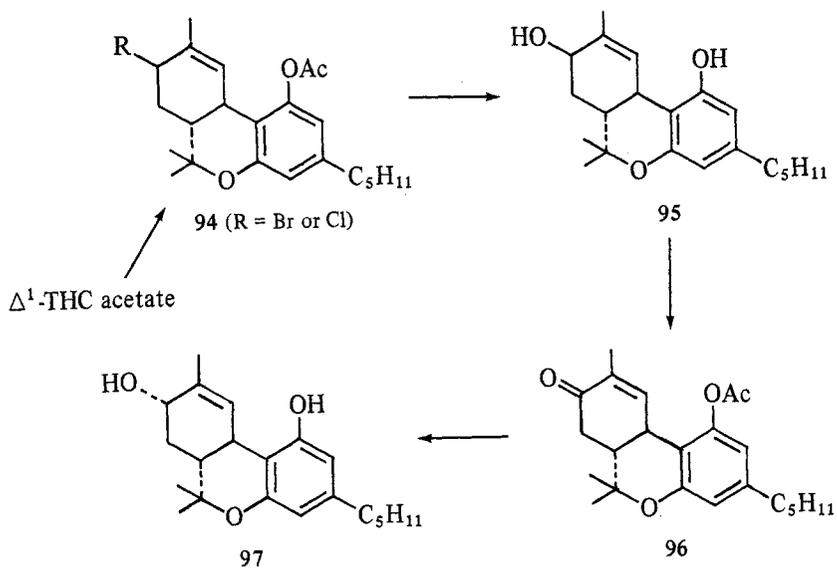

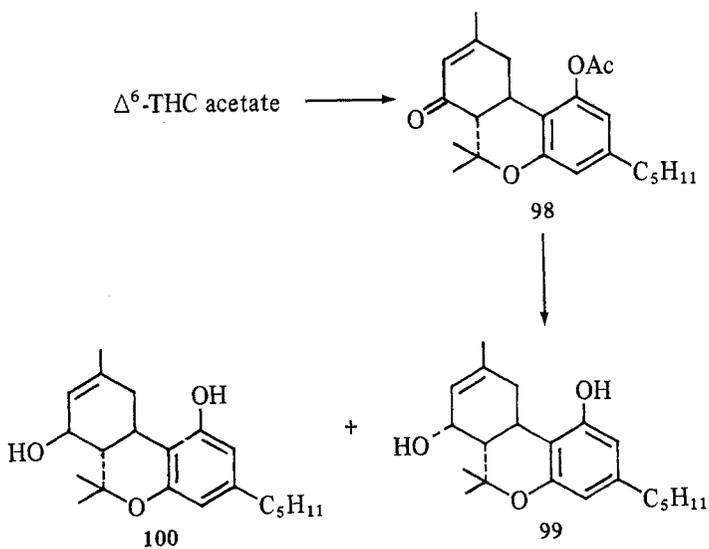
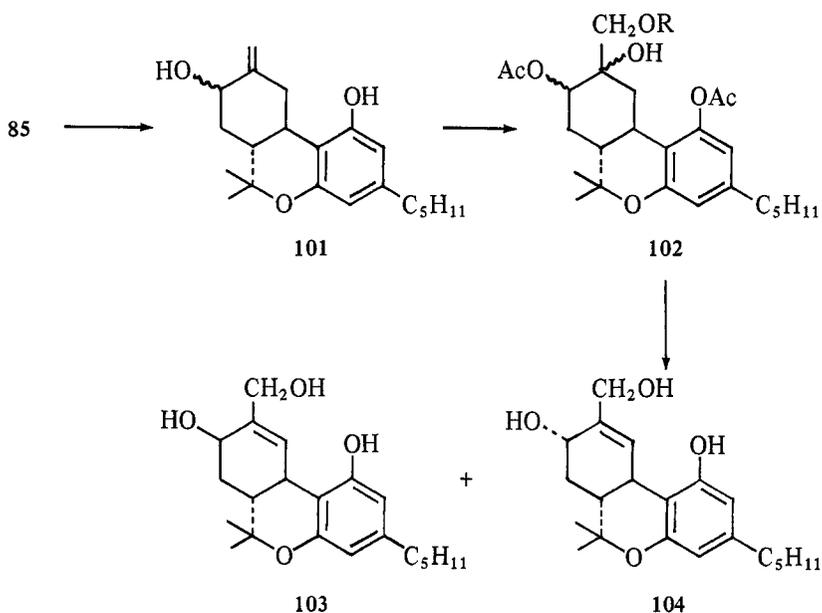

Other Metabolites

The two dihydroxy metabolites **103** and **104** have been found in humans^{37a} and were synthesized by Pitt et al.³⁸ Δ^6 -THC epoxide **85** (Chart 1.32) on treatment with BuLi rearranged to **101** as a 1:1 mixture of epimers at C-6. Diacetylation of **101** and treatment with OsO₄ gave **102** (R = H). Acetylation of the primary 7-hydroxyl group of **102**, dehydration with SOCl₂/Py followed by saponification gave **103** and a lesser amount of **104**. The latter was obtained in much better yield by using the same hydroxylation-dehydration sequence with 7-hydroxy- Δ^6 -THC (**71**).³⁸

Gurney et al.⁵³ reported the isolation of 1,2-epoxyhexahydrocannabinol as a metabolite from an *in vitro* preparation of squirrel monkey tissue. It was synthesized from Δ^1 -THC acetate by epoxidation with *m*-chloroperbenzoic acid.^{52, 53} This metabolite has also been identified in *in vitro* preparations of dog tissue.⁵⁴

**E. Metabolites Functionalized in the Aromatic Ring**

The *n*-pentyl side chain of the aromatic ring is the main site of metabolic attack.⁵⁵ Thus Δ^1 -THC, cannabidiol, and cannabinol give microsomal hydroxylations at carbons 1''-5''. In addition carboxylic acid metabolites, formed by oxidative cleavage of the side chain, have also been identified.⁵⁶

Until very recently none of the Δ^1 -THC metabolites hydroxylated at the *n*-pentyl side chain had been synthesized. Pitt et al.⁵⁷ have now reported an elegant general synthesis of side-chain derivatives of Δ^1 -THC as shown in Chart 1.33. The poorly soluble resorcinol derivative **105a** was made more soluble in organic solvents by converting it to **105b**. This was best achieved by quantitative conversion to the diether and then selective monodesilylation with fluoride ion. Condensation of **105b** with *p*-mentha-2,8-dien-1-ol (**11**) in $\text{CH}_2\text{Cl}_2/\text{BF}_3 \cdot \text{Et}_2\text{O}/\text{MgSO}_4$, using the procedure of Razdan et al.¹⁹ (Chart 1.4), the cannabidiol analog **106** was obtained together with other compounds. Treatment of this mixture with $\text{BF}_3 \cdot \text{Et}_2\text{O}/\text{CH}_2\text{Cl}_2$ at -20° for 48 h gave the Δ^1 -analog **107**, which was purified by chromatography. This key intermediate **107** was then converted to the various side-chain hydroxylated Δ^1 -THCs.

It is interesting to note that Razdan et al.⁵⁸ had previously reported the reaction of the five-membered heterocyclic analog of **105a** [i.e., 2-(3',5'-dihydroxyphenyl)-1,3-dithiolane] with **11** in benzene/*p*-TSA and found that the Δ^6 -analog was formed (see Chart 4.4). It appears that the reaction products are very sensitive to structure and/or reaction conditions in cannabinoids.

The specific synthesis of the metabolite **110** was also achieved (Chart 1.34) recently by Handrick et al.²² by the preparation and condensation of 3'-acetoxyolivetol (**112**) with the monoterpene *p*-menth-2-ene-1,8-diol (**25**). They essentially demonstrated the usefulness of this synthon (**25**, Chart 1.7) for the synthesis of Δ^1 -THC and its metabolites by preparing **110**. 3''-Hydroxy- Δ^1 -THC (**110**) was also reported to be about 3 times more active than Δ^1 -THC in preliminary pharmacological tests in mice.²² Christie et al.^{58a} reported the synthesis of (\pm)-**110** by condensing 1-(3,5-dihydroxyphenyl)pentan-3-one ethylene thioacetal with citral in the presence of $\text{BF}_3 \cdot \text{Et}_2\text{O}$ followed by removal of the thioacetal and reduction with NaBH_4 .

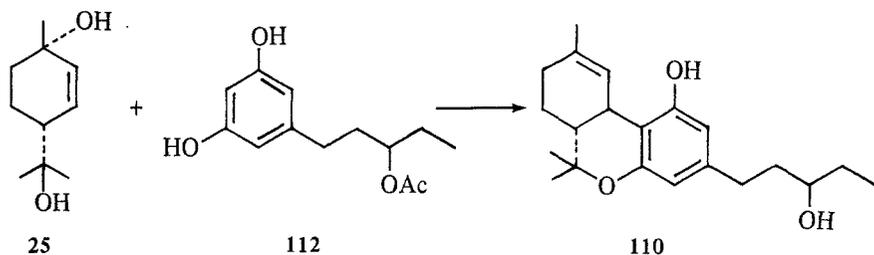

The synthesis in the Δ^6 -series is generally carried out (Chart 1.35) by condensing the appropriate resorcinol or a suitable thioketal derivative thereof, with the monoterpene *p*-menthadienol⁵⁹ **11** or verbenol^{55a} **5**. The direct coupling of

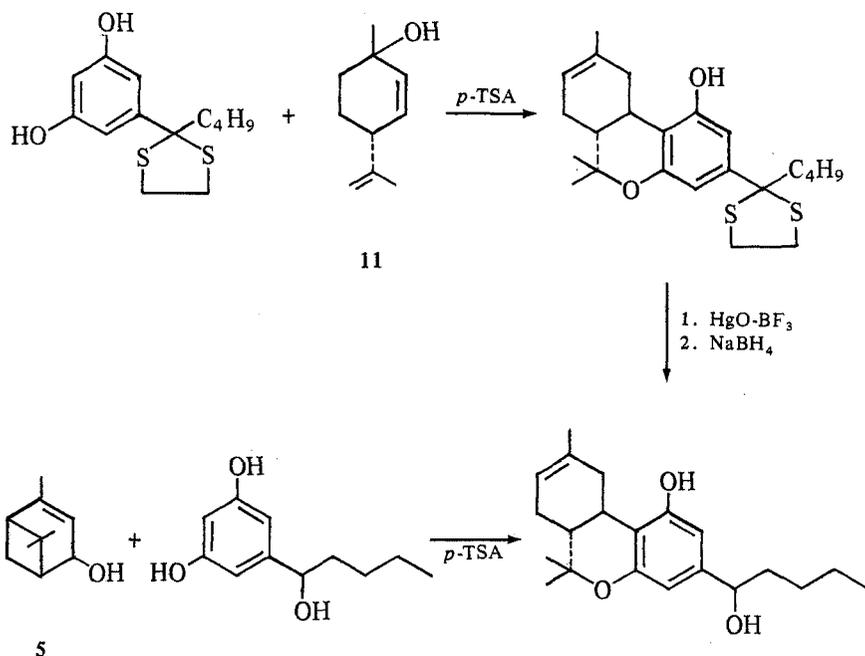

1'- or 3'-hydroxyolivetol or 1'- or 3'-oxoolivetol with 11 failed but worked as their thioketal derivatives.⁵⁹

Recently Lotz et al.⁶⁰ have reported that resorcyllalkyl esters directly condense with *p*-menthadienol 11 to give the corresponding Δ^6 -THC derivatives. These on LiAlH_4 reduction provide Δ^6 -THC analogs with a hydroxyl group, substituted on the terminal carbon of the aromatic side chain. The 5''-hydroxy- Δ^6 -THC was synthesized using this procedure.

In the Δ^6 -THC series the biological activity has been shown to vary with the position of the hydroxyl group in the pentyl side chain. The order of activity⁵⁵ is 3''- > 4''- > 2''- > 1''-hydroxy- Δ^6 -THC. Full details of this work have now been published.^{55a}

3. SYNTHESIS OF OTHER THCS AND RELATED CANNABINOIDS

In this section the synthetic approaches to some of the "unnatural" THC's and the important cannabinoids that occur in the plant *Cannabis sativa* L. will be discussed.

A. "Unnatural" THCs

(-)- $\Delta^1(7)$ -THC (**13**, Chart 1.3) was isolated during Petrzilka's dehydrochlorination procedure by Razdan et al.¹⁸ It was also produced by photoisomerization of Δ^6 -THC⁴² and by dehydrochlorination of 1-chlorohexahydrocannabinol methyl ether with a bulky base followed by demethylation of the ether with potassium thiophenoxide.⁵¹

Cardillo et al.⁶¹ reported a synthesis (Chart 2.1) of cannabidiol (**12**) from *p*-mentha-1,8-dien-3-ol (**113**) and olivetol (**6**) in aqueous acid. These mild condensation conditions were applied in the preparation of "unnatural" Δ^4 -THC derivatives. Thus *p*-menth-4-en-3-ol (**114**) and olivetol gave **115**, which formed the novel cannabinoid **116**. This procedure led to the synthesis of Δ^4 -THC (**118**) by the condensation of olivetol with *p*-menth-4-ene-3,8-diol (**117**).⁶²

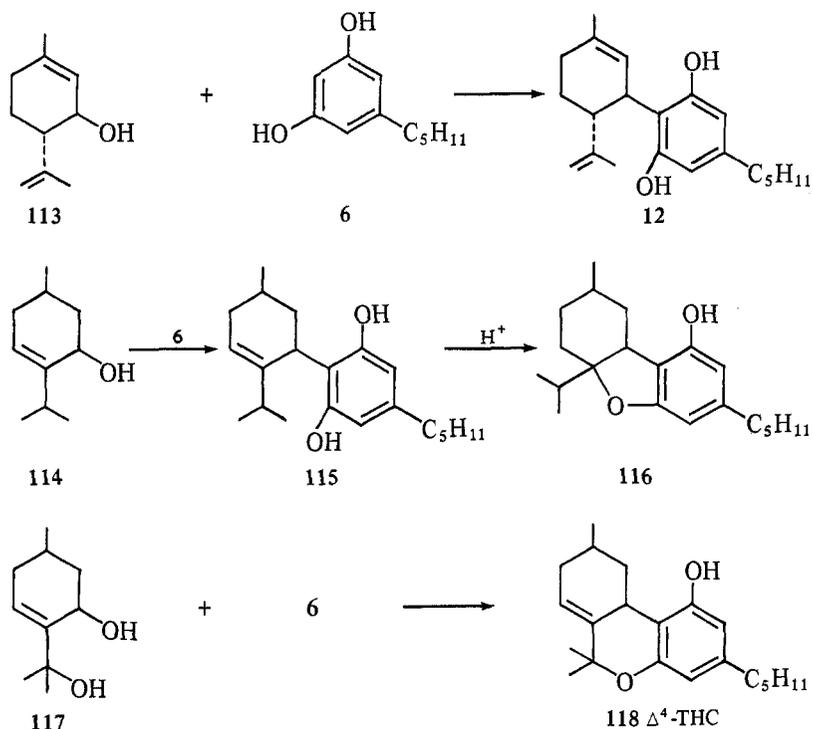

Δ^5 -THC (**120**), another "unnatural" THC, was synthesized⁶³ (Chart 2.2) by hydroboration of Δ^6 -THC to give **119a**, which was tosylated to **119b** and then treated with *K*-*t*-butoxide in benzene.

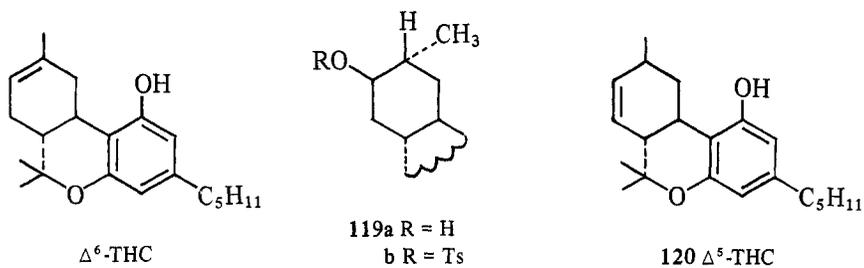

B. Cannabidiols

(-)-Cannabidiol (12, Chart 1.3) is one of the major constituents of the plant. The natural material has a 3,4-*trans* ring junction with a double bond at the Δ^1 position. As discussed earlier, it was synthesized from *p*-menthadienol 11 by the Petrzilka procedure¹⁵ (Chart 1.3) or by the modification of Razdan et al.¹⁹ of Petrzilka's procedure (Chart 1.4). It is also prepared as shown in Chart 2.1 and by condensing 11 and olivetol in the presence of wet *p*-TSA.¹⁹ For the synthesis of (\pm)-cannabidiol see Charts 1.10 and 1.11.

The Δ^6 -isomer of cannabidiol is not known. The two Δ^1 - and Δ^6 -cannabinoids with a 3,4-*cis* junction are "unnatural" and were synthesized (Chart 2.3) recently by Handrick et al.⁶⁴ Thus lactone 122 was prepared from isoprene and 121 by a Diels-Alder reaction accompanied by decarboxylation.^{64,65} Reaction of 122 with CH_3MgI gave the triol 124a; its diacetate 124b was dehydrated with SOCl_2/Py and then saponified to give (\pm)- Δ^6 -3,4-*cis*-cannabidiol 125. The Δ^1 -isomer 126 was obtained by equilibrating the lactone 122 to a 1:1 mixture of 122 and 123. The identical procedure then gave a mixture of Δ^6 - and Δ^1 -*cis*-cannabidiol diacetates. These were easily separated by HPLC and the Δ^1 -isomer was saponified to give 126. In an alternative synthesis by Handrick et al.⁶⁴ the keto lactone 42 (Chart 1.14) was ketalized, reduced with Raney nickel at high pressure,¹⁶ and hydrolyzed to give 127. Reaction with CH_3MgI furnished the tetrol 128a. Its acetate 128b was dehydrated and then saponified to form 125.

C. Cannabinol

This was one of the first cannabinoids to be synthesized in early 1940, as it established the basic skeleton of the THC structure. Δ^1 -THC is readily oxidized to cannabinol on exposure to air.¹⁸

The first synthesis (Chart 2.4) by Adams et al.⁶⁶ condensed 129 with dihydro-olivetol 130 to form the pyrone 131 which on dehydrogenation gave 132. Grignard reaction followed by acid treatment furnished cannabinol 136. It is interesting to note that a similar reaction of 129 with olivetol (6) formed the "abnormal" isomer of 132 resulting from an attack on the 4 position of olivetol.⁶⁷

In a different approach, based on Pechmann condensation, both the British⁶⁸ and American groups⁶⁹ independently arrived at the synthesis of cannabinol using the same sequence. Thus the keto ester 133 and olivetol formed the pyrone 134, which on treatment with CH_3MgI , followed by acid treatment, gave Δ^3 -THC (135). Sulfur dehydrogenation converted 135 to cannabinol. Both groups discovered that the physiological activity of Δ^3 -THCs was similar to the natural material. The American group led by Roger Adams carried out extensive structure activity work in this series, which formed the basis for drug develop-

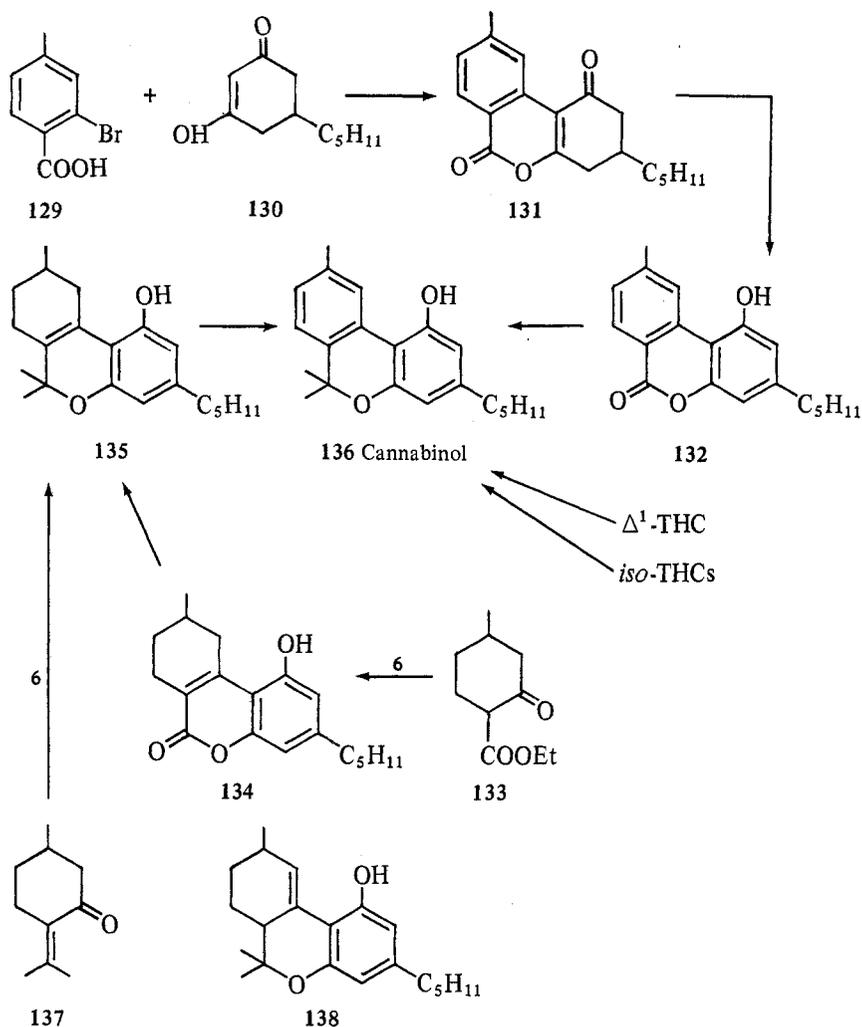

ment in cannabinoids during the late 1960s. This particular aspect will be discussed in a later section. The Pechmann condensation was reinvestigated by Claussen and Korte⁷⁰ and they isolated from this reaction the other isomer Δ^2 -THC (138).

Another synthesis of cannabinol was achieved from pulegone (137) by both Adams et al.⁷¹ and Ghosh et al.⁷² (Chart 2.4). Cannabinol is also formed easily

by chloranil dehydrogenation of Δ^1 -THC.⁷³ In contrast, Δ^6 -THC and *cis*- Δ^1 -THC do not form cannabinol. This has been explained on the basis of stereo-electronic factors.⁷³ The various iso-THCs are easily converted to 136.^{31b}

D. Cannabinoid Acids³

They form an important group of compounds present in the plant.³ These acids are inactive by themselves but are readily decarboxylated on heating (smoking) or on GLC to the parent active THCs. The two methods which have been developed for their synthesis are shown in Chart 2.5. Methyl magnesium carbonate (MMC) carboxylated Δ^1 -THC. Similarly cannabidiolic acid and cannabigerolic acid were synthesized. Petrzilka's procedure¹⁵ was used to prepare 141, but the acid itself could not be isolated, as during hydrolysis it decarboxylated to give 12.

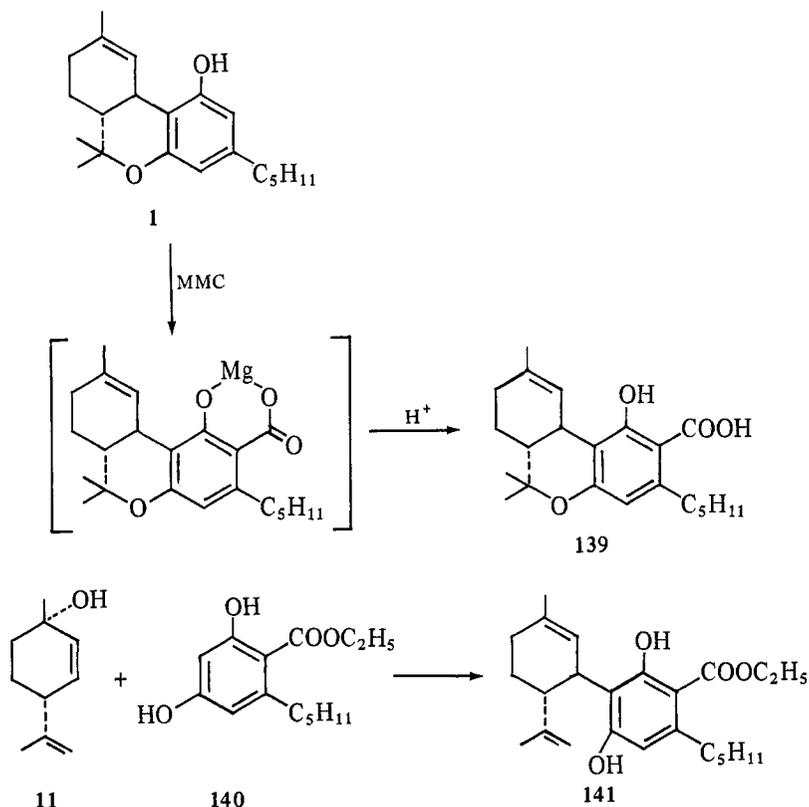
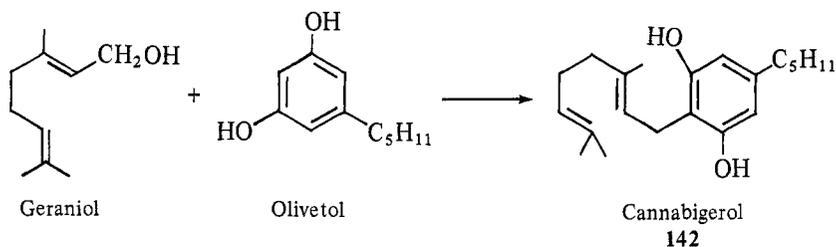

E. Cannabigerol

It is a minor constituent of the plant and was synthesized by condensation of geraniol with olivetol in the presence of *p*-TSA in CH_2Cl_2 .⁷⁵ It was also prepared by a direct alkylation of ethoxycarbonyl olivetol with geranyl bromide followed by hydrolysis.⁷⁶



F. Cannabichromene

It was previously considered to be a minor constituent of the plant, but recent advances in analytical techniques have established that it is no longer a minor cannabinoid. In fact in some variants it is more abundant than cannabidiol.⁷⁷ Two main approaches to the synthesis of cannabichromene have been reported (Chart 2.6). One is based on the dehydrogenation of cannabigerol (142) with chloranil⁷³ or dichlorodicyanobenzoquinone.⁷⁶ With both these reagents the reaction probably proceeds via hydride abstraction but the *O*-quinone methide intermediate 143 has also been proposed.⁷⁶ The other synthesis of 144 was simultaneously and independently reported by Crombie and Ponsford⁷⁸ and Kane and Razdan.⁷⁹ These two groups achieved a one-step total synthesis of cannabichromene 144 and cannabicyclol (148) by heating citral (36) and olivetol (6) in the presence of pyridine. From this reaction the tetracyclic ether (147, also called "cannabicitran") and iso-THCs were also isolated. They showed that the reaction between substituted resorcinols or phloroglucinol and citral in pyridine to form ethers of type 147 is a general one which leads to substituted iso-THC derivatives.^{78b, 79b} The most likely mechanism^{78b, 80} for the pyridine catalyzed reaction appears to be the initial condensation to 145 followed by cyclization to cannabichromene (144). This can either form cannabicyclol (148) or proceed via an intramolecular [2 + 4] cycloaddition within a quinone-methide tautomer 146 of the phenol, to 147. The mechanism of the cyclization of 144 to 147 was previously considered to be ionic but Crombie and co-workers⁸¹ have now shown it to be electrocyclic.

The yield of cannabichromene from citral reaction has been improved by using *t*-butylamine in place of pyridine and refluxing the mixture in toluene.⁸²

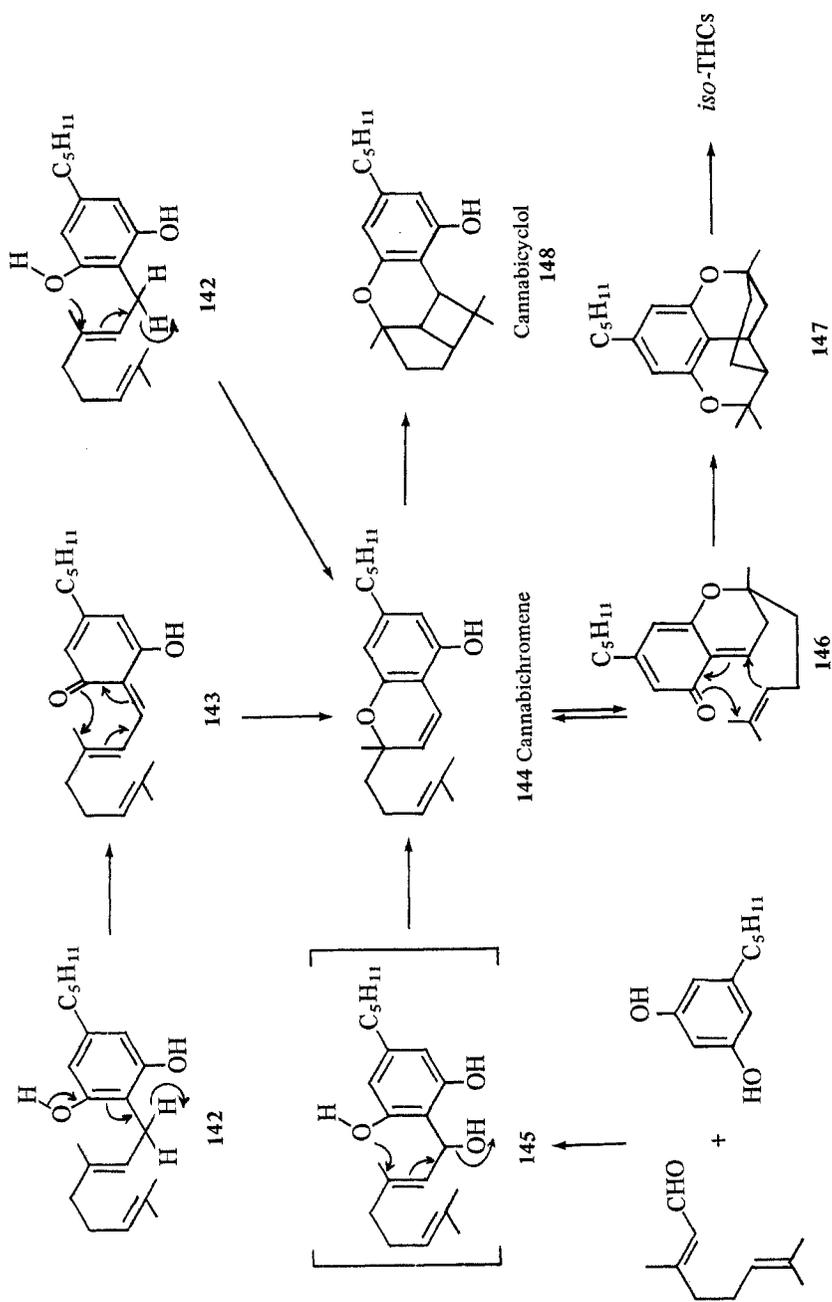

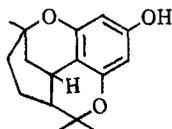
G. Cannabicyclol

It is a very minor compound of the plant and was initially assigned structure 149. Crombie and Ponsford^{78a} revised the structure to 148 mainly on the basis of NMR spectrum where the C-3 proton appears as a doublet being coupled to one proton only. This structure has since been firmly established on the basis of X-ray results published by Begley et al.⁸³ However, reading their paper gives the incorrect impression that we (Kane and Razdan)^{79a} preferred the original structure 149 for cannabicyclol in spite of conclusive evidence. These authors placed our work completely out of context and ignored the fact that most of the evidence they gave appeared after the publication of our paper.^{79a} This clarification* is necessary, as it can be misleading, particularly to those unfamiliar with the field.

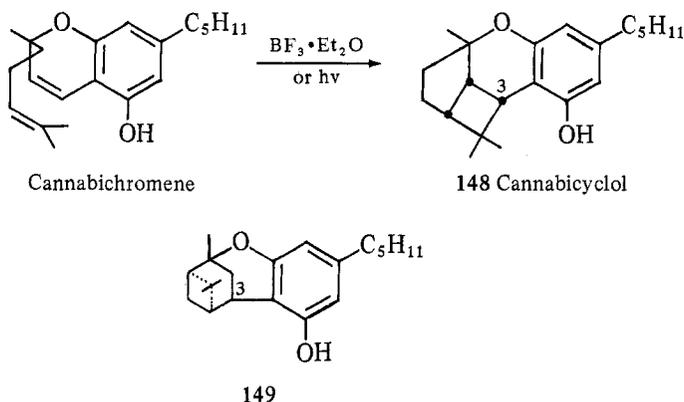
The first synthesis of cannabicyclol was achieved by the pyridine catalyzed condensation of citral and olivetol as described before (Chart 2.6). Treatment of 144 with either $\text{BF}_3 \cdot \text{Et}_2\text{O}$ ⁸⁴ or photolysis in the presence of a sensitizer⁸⁵ (*t*-butanol-acetone) also formed cannabicyclol.

*In 1968 when Crombie and Ponsford's paper^{78a} appeared, in which they had suggested a revision of cannabicyclol structure from 149 to 148, our paper^{79a} had already been submitted and in a footnote we suggested "that in the absence of further experimental data the structure and stereochemistry as suggested by Korte and Mechoulam should not be discarded at the present time." In our subsequent paper^{79b} in early 1969, we depicted structures 149 and 148 for cannabicyclol as either of the structures were acceptable to us in the absence of more definitive evidence. We based our position on the fact that we were unable to convert cannabichromene to cannabicyclol with pyridine, in contrast to Crombie and Ponsford's results.^{78a} The conversion of cannabichromene to cannabicyclol by heat was not mentioned in the reference quoted by these authors and conversion under acid conditions appeared much later. The photochemical conversion in the presence of a sensitizer (*tert*-butanol-acetone) supported structure 148 but did not prove it unequivocally.

Furthermore, the NMR in this series of compounds is very complex particularly in the region where the benzylic proton appears and heavy reliance on this data can sometimes be misleading, e.g., the benzylic proton in



shows up as a sharp singlet (220 Mc/s, CDCl_3 , 2500 Hz sweep width) at 2.8 ppm. However, at a 1000 Hz sweep width it shows signs of an ill-resolved multiplet.²⁴ Another example is the case of iso-THC³¹ which was previously misinterpreted as Δ^6 -3,4-*cis*-THC. Yet another example is the wrong assignment of the benzylic protons in Δ^6 -THC [Archer et al. *J. Am. Chem. Soc.* 92, 5200 (1970)]. It was with this background that at the time we had indicated both the structures for cannabicyclol in the absence of definite proof such as now provided by X-ray.



H. Novel Cannabinoids

Cannabielsoic acids (**151a**, **b**), which have been isolated from hashish,⁸⁶ represent a novel cannabinoid structure. The decarboxylation product of these naturally occurring constituents is cannabielsoin (**152**), which is also the major product obtained by pyrolysis⁸⁷ of cannabidiol in air at 70°C. The synthesis of cannabielsoic acid A (**151a**) was achieved by Shani and Mechoulam⁸⁶ from cannabidiolic acid (**150**) by a novel photooxidative cyclization process (Chart 2.7). A mixture of **151a** and its isomer at C-1 was obtained.

Uliss et al.³⁴ reported (Chart 2.7) a stereochemically unambiguous synthesis of cannabielsoin (**152**) from the epoxide **156**. Thus cannabidiol diacetate **153** gave a mixture of epoxides **154**, **155**, and **156** when allowed to react with *m*-chloroperbenzoic acid. These were separated and the assignment of an α -configuration to the endocyclic epoxides in **155** and **156** was established. Treatment with base at room temperature converted **156** to **152**. This transformation involves an intramolecular trans diaxial cleavage of the α -epoxide at its less hindered site, which fixes the stereochemistry of the fused furan ring at C-2 and C-3 as *cis* and the configuration of the C-1 hydroxyl group as α (axial). This established the stereochemistry of cannabielsoin at C-1 so as to conform to structure **152**. Independently Shani and Mechoulam⁸⁶ arrived at similar conclusions while working on the cannabielsoic acid series. Similar treatment with base gave the novel cannabinoids **157** and **158** from **154** and **155**, respectively. These studies³⁴ have also suggested that the entropy of ring formation is the major factor in determining the product of an intramolecular epoxide cleavage. (-)-8 β -Hydroxymethyl- Δ^1 -THC (**157**)⁸⁸ is equiactive with Δ^1 -THC in biological potency and represents the first example of functionalization in the geminal methyl part of the molecule of Δ^1 -THC.

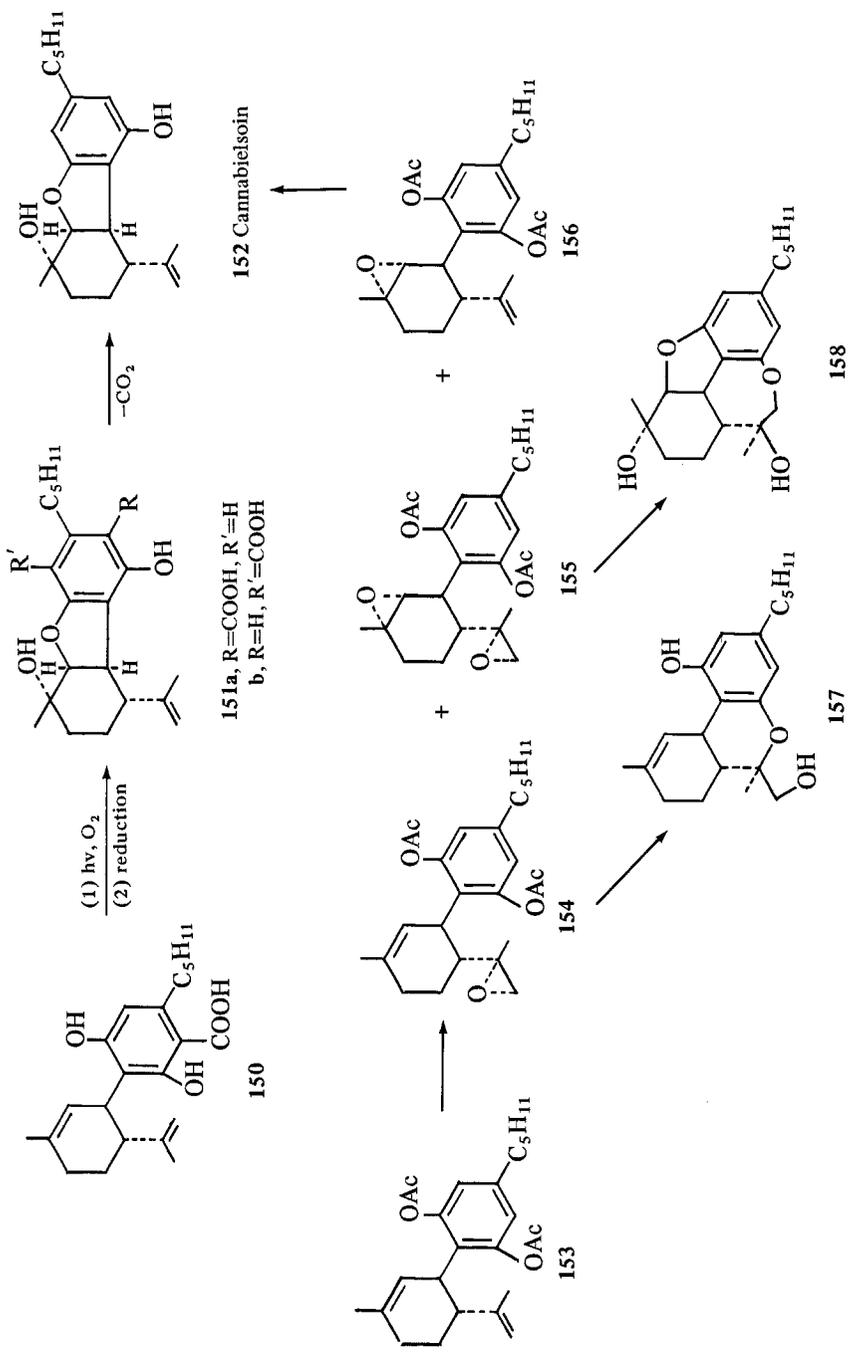

232 The Total Synthesis of Cannabinoids

During their studies on cannabielsoin (**152**) Uliss et al.⁸⁹ also synthesized (Chart 2.8) a novel cannabinoid **159** containing a 1,8-cineole moiety. It was formed in quantitative yield from **152** by an intramolecular cyclization on treatment with a catalytic amount of *p*-TSA. This conversion serves as confirmatory evidence for the stereochemical assignment of the C-1 hydroxyl group as α (axial) in **152**.

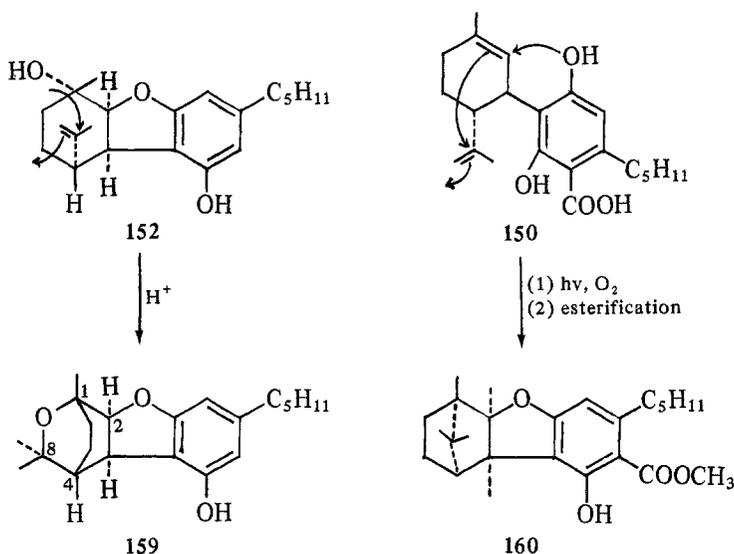

Another cannabinoid containing a camphane moiety **160** was synthesized by Kirtany and Paknikar⁹⁰ by irradiation of **150** in the presence of oxygen followed by esterification (Chart 2.8).

Ciommo and Merlini⁹¹ reported the synthesis (Chart 2.9) of cannabinoid-like benzoxocinols **163** and **164** by condensing *p*-menth-3-en-8-ol (**161**) or *p*-mentha-3,8-diene (**162**) with olivetol (**6**) in the presence of HCOOH. It was shown that the reaction between **161** and **6** proceeds via dehydration of **161** to **162**.

Compound **163** was also synthesized (Chart 2.9) by Houry et al.⁹² from carvone and olivetol using POCl₃ followed by reduction. They also prepared **164** from limonene or pinene. Compound **163** was reported to be biologically active.⁹²

Citronellal and phloroacetophenone were condensed in the presence of pyridine to give hexahydrocannabinoid analogs.⁹³ This reaction is a variation of the citral-olivetol-pyridine reaction discussed earlier (see Section 3F; Chart 2.6).

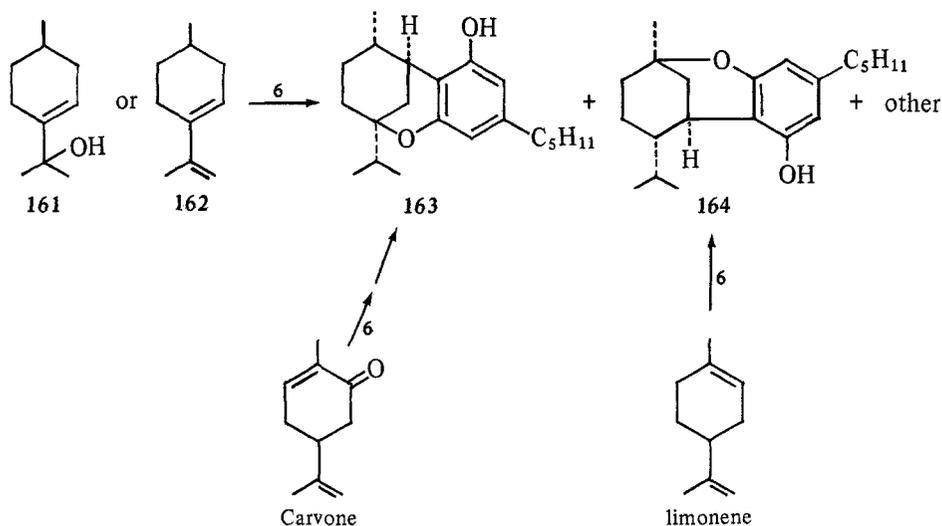

In recent years interest has focused on 1-ketocannabinoids because nabilone,⁹⁴ a member of this class, has been undergoing clinical trials as an antiemetic and antiglaucoma agent. Wilson and May⁹⁵ oxidized the exocyclic double bond of (-)- $\Delta^1(7)$ -THC (13) with OsO₄ and then cleaved it with NaIO₃ to give (-)-167 (R = C₅H₁₁). Archer et al.⁹⁴ prepared nabilone [167, R = C(CH₃)₂C₆H₁₃] from the corresponding $\Delta^1(7)$ -THC by ozonolysis. Since the overall yield was low they developed a different route to 1-ketocannabinoids (Chart 2.10). The known (+)-apoverbenone (166)⁹⁶ was prepared from β -pinene via ozonolysis to nopinone (165) followed by bromination and dehydrobromination. Reaction of 166 with the appropriate resorcinol in the presence of anhydrous AlCl₃ gave (-)-nabilone. Alternatively, 165 was converted to the enol acetate 168,⁹⁷ which on oxidation with lead tetraacetate in refluxing benzene for 2 h gave 170. If the reflux time was extended to 18 h, 169 was isolated. Either of them on condensation with the resorcinol derivative and *p*-TSA formed 171. Stannic chloride treatment converted 171 to 167. On the other hand, 171 on treatment with *p*-TSA gave the optically active *cis*-ketone 172. The transformation of *cis*-172 to *trans*-167 was accomplished by treatment with AlCl₃ at 0°C.

For the preparation of racemic 1-keto cannabinoids the known optically inactive diene 173⁹⁸ was condensed with olivetol or the other appropriate resorcinol in the presence of acid catalysts (Chart 2.11). The products of the reaction varied with the nature of the catalyst, solvent, temperature, and reaction time. Compounds 174 and 175 appear to be intermediates in the formation of the *cis*-ketone 172 following the sequence 174 \rightarrow 175 \rightarrow 172. Since 167¹⁶

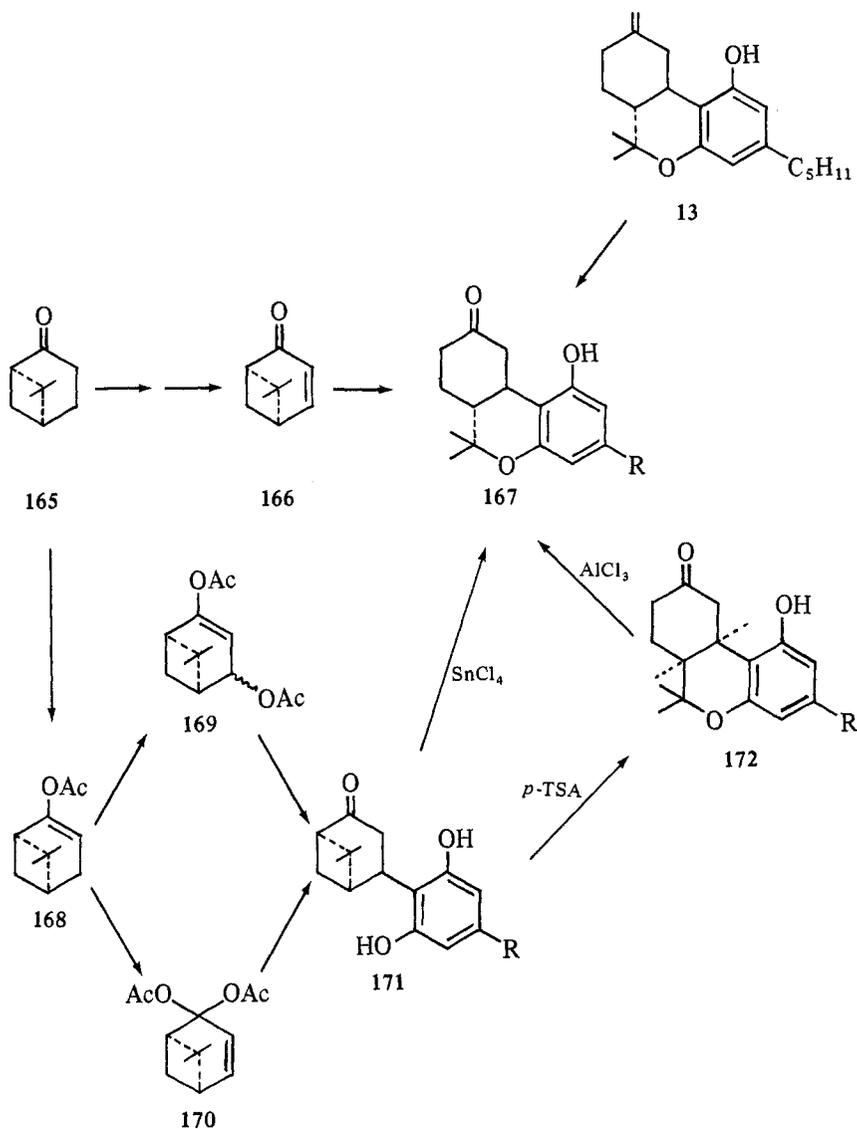
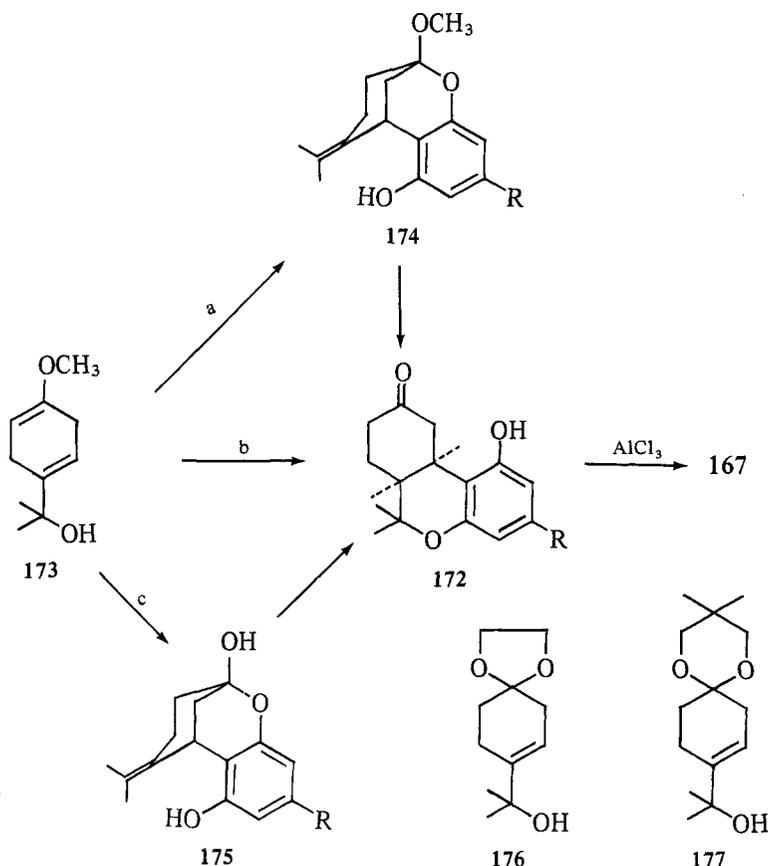

has been previously converted into $(\pm)\text{-}\Delta^1\text{-THC}$ (Chart 1.13) this represents a new synthesis of THC's.

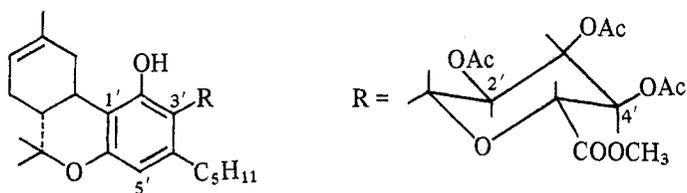
A variation of this scheme included the use of "masked ketones" such as 176 and 177 instead of the diene 173. Both formed 167 ($\text{R} = \text{C}_5\text{H}_{11}$) in 80% yield.

The *C*-glucosidation of Δ^6 -THC in the 3'-position has been reported⁹⁹ previously by treating Δ^6 -THC with β -glucose pentaacetate in benzene containing $\text{BF}_3 \cdot \text{Et}_2\text{O}$. The formation of a *C*-glucoside in the presence of a phenolic group was unexpected but is not surprising in view of the reactivity of THC_s toward electrophilic attack on the aromatic ring (e.g., formation of THC acids using methylmagnesium carbonate; Chart 2.5). Using the same procedure, the *C*-glucuronide of Δ^6 -THC in the 3'-position was prepared.¹⁰⁰ On the basis of the large coupling constant observed ($J = 10$ Hz) for the C-1' H in the sugar moiety it was considered to be a β -glucuronide.

4. NEW CANNABINOID TRANSFORMATIONS

Many interesting isomerizations and transformations have been observed in cannabinoids, due to the presence of double bonds, free phenolic groups and *cis* or *trans* ring junctions. The isomerizations and interconversions in the presence of acid catalysts of Δ^1 - to Δ^6 -THCs in the *trans* series and *cis*-THCs \rightarrow tetracyclic ether (cannabitrin, 147) \rightarrow iso-THCs in the *cis* series, are well established and have been discussed in detail in previous articles.³ In this section some new transformations, which have since appeared, are described.

A. Photochemical

Bowd et al.¹⁰¹ carried out the ultraviolet irradiation of cannabinol (136) in ethanol and showed (Chart 3.1) that cannabinodiol (178), a minor constituent of cannabis, is first formed by a photoinduced ring opening and hydrogen

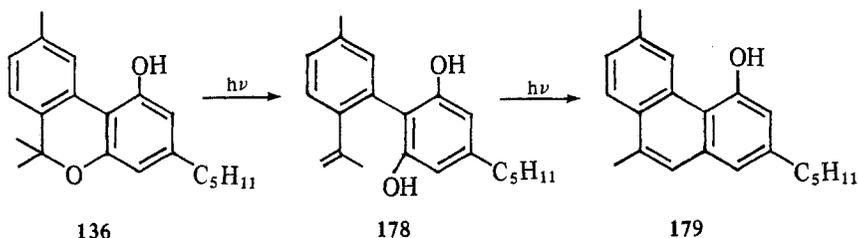

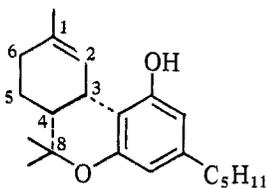
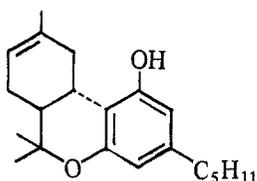
transfer. This in turn undergoes a photoinduced dehydration and ring closure to give the highly fluorescent hydroxyphenanthrene 179. The conversion of 136 to 178 is analogous to a previously reported¹⁰² photochemical transformation of 2,2-disubstituted chromenes.

B. *cis* → *trans* Conversion

Uliss et al.¹⁰³ have elucidated the mechanism of the conversion of 3,4-*cis*- to 3,4-*trans*-cannabinoids. In 1969 Razdan and Zitko¹⁰⁴ reported the first example of the conversion of a *cis*- to a *trans*-THC. They found that (\pm)- Δ^1 -3,4-*cis*-THC (3) was converted to (\pm)- Δ^6 -3,4-*trans*-THC (2) on treatment with BBr_3 . In a more recent example Archer et al.⁹⁴ have reported the conversion of a 3,4-*cis*-1-ketocannabinoid to its *trans* counterpart using AlCl_3 (Chart 2.10).

At the time Razdan and Zitko¹⁰⁴ had proposed that this transformation involved cleavage of the ether bond followed by probable inversion at C-4 rather than at C-3. With the recent availability³⁵ of (+)- Δ^1 -3,4-*cis*-THC (3) of known absolute configuration (3*S*, 4*R*) by synthesis from 1*S*, 2*S*, 3*R*, 6*R*-carene-2-oxide (21, Chart 1.17) and olivetol, the conversion of *cis* to *trans* was reinvestigated. Inasmuch as the products formed by epimerization of 3a at C-3 (Δ^6 -3*R*, 4*R*-THC, 2b) and at C-4 (Δ^6 -3*S*, 4*S*-THC, 2a) are enantiomers, preference for epimerization at either site will be reflected in the sign and magnitude of the optical rotation of the product. Hence a sample of 3a of known optical purity was subjected to BBr_3 treatment and from the rotation of the product (Δ^6 -*trans*-THC, 33% yield) it was found that it corresponds to a mixture of 24% enantiomer 2b and 76% enantiomer 2a. It was thus shown that epimerization at C-4 is the favored process and is accompanied by a lesser amount of C-3 epimerization or racemization. Supportive evidence was also provided, which indicates that the first step is cleavage of the pyran ring (Chart 3.2). The resulting equilibrium is driven to the relatively stable isomer 2a via epimerization at C-4. Friedel-Crafts cleavage of the C-3-C-1' bond in 126a or 180a followed by recombination leads to C-3 epimerization in the former and racemization of the latter.

Similar studies on *cis*-hexahydrocannabinols (HHCs) were also undertaken¹⁰³ to determine if removal of the carbocyclic unsaturation affects the stereochemical outcome of the conversion. It was shown that the conversion of 3,4-*cis*- to 3,4-*trans*-HHCs proceeds with exclusive C-4 inversion.

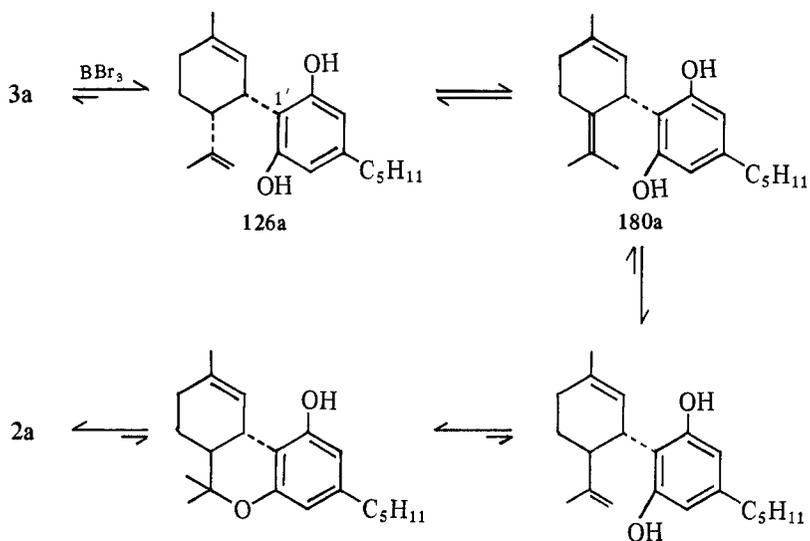

C. Pyrolysis

Since cannabis is generally ingested by smoking, the products formed on pyrolysis of cannabinoids are of general interest. Salemink and co-workers¹⁰⁵ have studied the pyrolysis of cannabidiol in detail and have isolated several

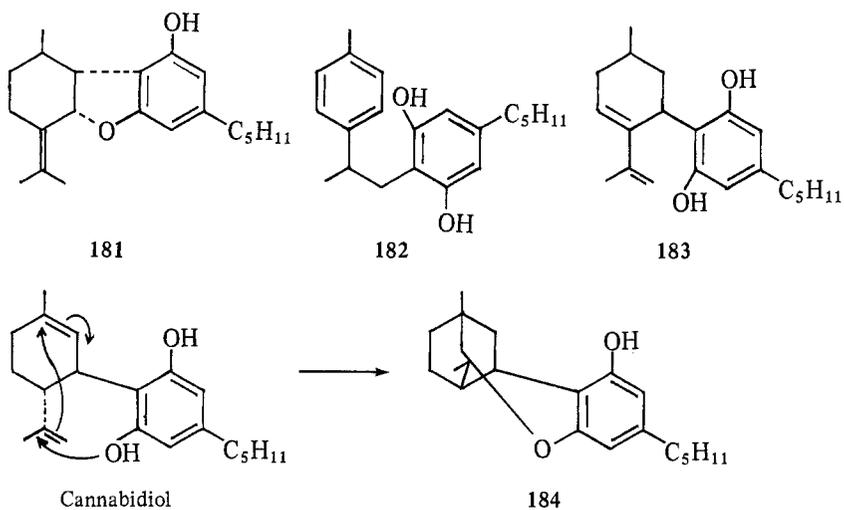

transformation products. They have observed that the nature of the gas phase considerably influences the nature of the pyrolytic products and have identified Δ^1 -THC, cannabinol, several aromatic compounds, for example, olivetol, 2-methylolivetol and 2-ethylolivetol; *abn*-cannabidiol (14); cannabielsoin (152);^{105a} a dibenzofuran 181^{105d} in which there has been a rearrangement of the carbon skeleton (Chart 3.3); 182;^{105e} a new cannabidiol isomer 183^{105b} and the bicyclic cannabinoid 184.^{105b} The structures of 183 and 184 were based on their mass spectral fragmentations only. Supportive NMR evidence was provided for 181 whereas 182 was confirmed by synthesis.^{105f} In addition the isolation of 4-hydroxy-6-pentylbenzofuran and 2,2-dimethyl-5-hydroxy-7-pentylchromene were reported and confirmed by synthesis.^{105f}

5. SYNTHESIS OF THC ANALOGS¹⁰⁶

The cannabis plant, being a complex mixture, is unlikely to be used as a marketable drug; therefore, the future of therapeutic agents from cannabinoids undoubtedly lies in the synthetics.

This has led to intense interest in structural modification of Δ^1 -THC and synthetic Δ^3 -THCs. In addition a large variety of heterocyclic analogs have been prepared. All these modifications have resulted in a series of novel THC derivatives and analogs, which show a wide variety of enhanced activities such as antiglaucoma, antinausea, analgesic, tranquilizer, antihypertensive, etc. Like morphine, lysergic acid diethylamide, and cocaine, which have structurally related analgesics, oxytoxics, and local anaesthetics, respectively, the socially abused cannabinoids may now be on the verge of generating a family of safer and more useful therapeutic agents.

A. Carbocyclic Analogs

Compounds Related to Δ^1 - and Δ^6 -THCs

Some of these compounds are shown in Chart 4.1. Apart from the various metabolites of Δ^1 - and Δ^6 -THCs that have been synthesized, efforts have been directed to modify the THC structure to make water soluble derivatives. This is deemed necessary, since Δ^1 - and other THC's are resinous materials completely insoluble in water, and to carry out pharmacological studies these materials have to be administered in various solvents such as polyethylene glycol, Tween, triton, and alcohol, which are themselves not without pharmacological activity. An aminoalkyl ester derivative of THC's is an obvious choice, but until recently conventional methods of esterification were not successful in its preparation. Razdan and co-workers¹⁰⁷ have shown that water-soluble esters of Δ^1 - and other THC's can be easily prepared with carbodiimide as the condensing agent (Chart

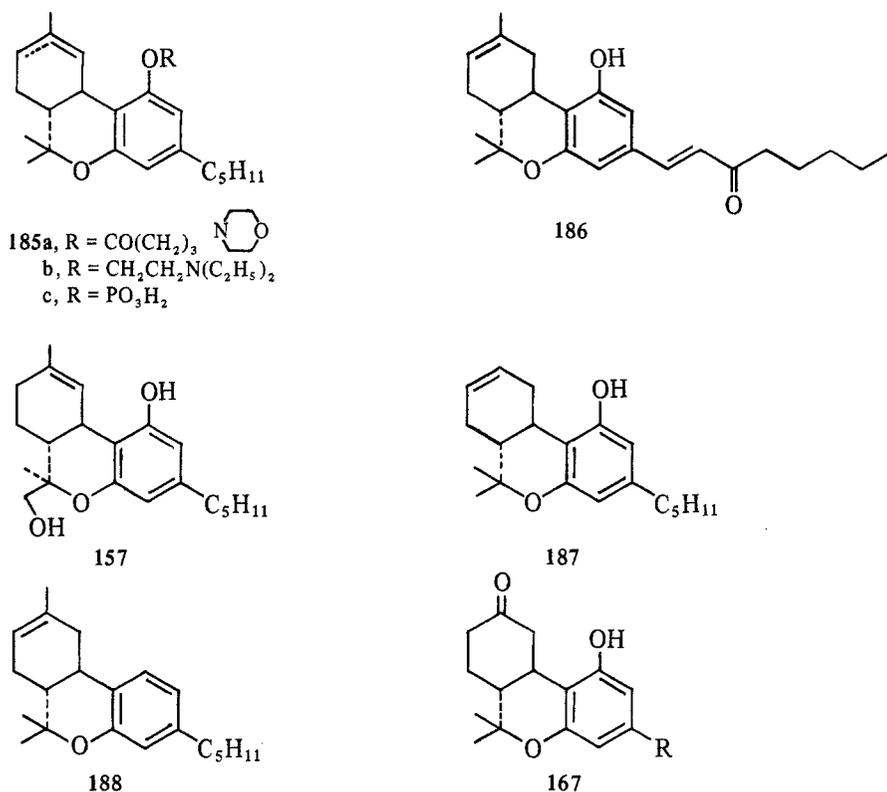

4.2). Thus the γ -morpholinobutyric ester (**185a**·HBr) of Δ^1 -THC is a solid, freely soluble in water and is equiactive with Δ^1 -THC in various pharmacological tests. In contrast, the ether derivative **185b**^{107a} is quite different and does not show the pharmacological profile of Δ^1 -THC.

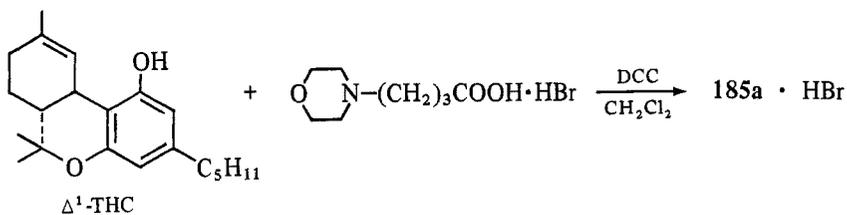

A biologically active, water-soluble phosphate ester of Δ^6 -THC (185c as the sodium salt) has also been reported¹⁰⁸ recently. It was synthesized (Chart 4.3) by treating Δ^6 -THC with phosphoryl chloride in pyridine followed by mild hydrolysis with water. Treatment with alcoholic sodium hydroxide gave the sodium salt of 185c.

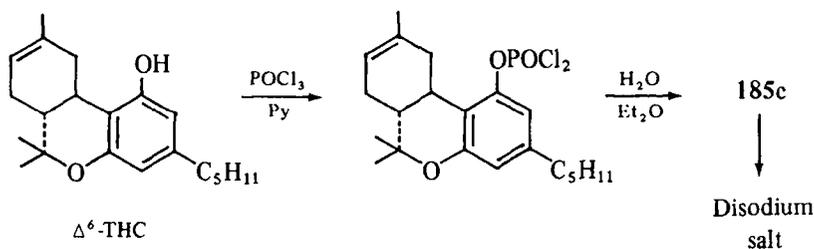

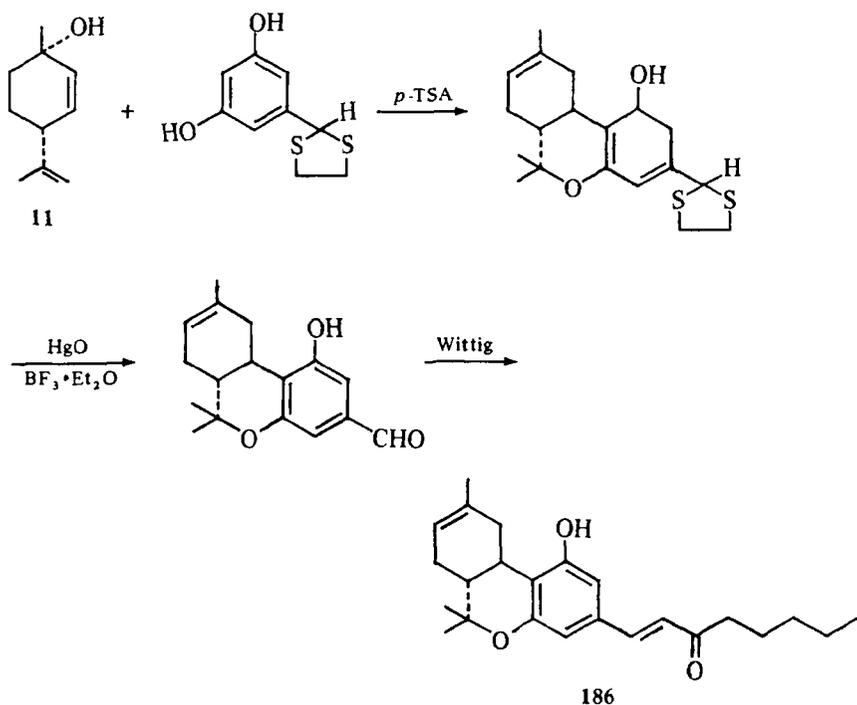

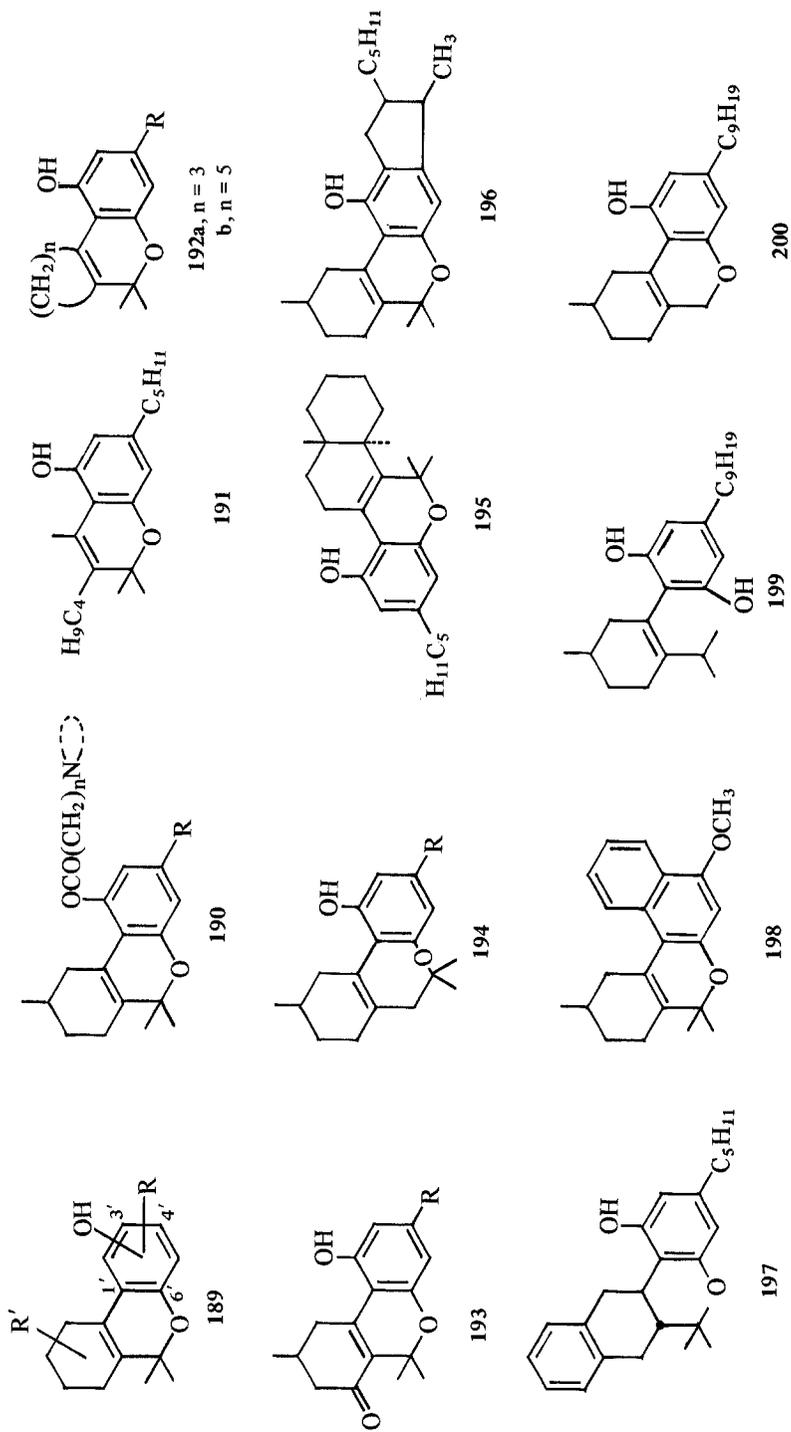

The potent analog **186** was synthesized by Razdan et al.⁵⁸ as shown in Chart 4.4. The resorcinol thioketal was prepared from the corresponding aldehyde.

As described earlier (Section 3H; Chart 2.7) the potent Δ^1 -THC analog **157** was synthesized³⁴ from cannabidiol diacetate.

The Δ^6 -THC analog **187** was synthesized⁹⁵ from the 1-keto compound **167** ($R = C_5H_{11}$) by reduction and dehydration with *p*-TSA. This compound was shown to be equiactive with Δ^6 -THC.⁹⁵ Compound **188** was prepared¹⁰⁹ from Δ^6 -THC by treatment with $C\ell PO(OC_2H_5)_2$ followed by cleavage with Li/NH_3 .

The synthesis of 1-keto **167** has already been described in detail (see Section 3H; Charts 2.10 and 2.11).

Compounds Related to Δ^3 -THC

Some examples of this type are shown in Chart 4.5. These compounds differ from the natural THC's **1** and **2** in the relative position of the double bond and show typical marijuana-like activity in rodents and dogs. They were discovered¹⁰⁶ independently by two groups, Adams and co-workers in the United States, and Todd and co-workers in Great Britain, in the course of their work on the structure elucidation of the active constituents of hashish and marijuana. Todd and Adams in particular carried out extensive structure-activity relationship (SAR) studies in Δ^3 -THCs. Some of these are depicted by the general formula **189**, **191**, and **192** and have been reviewed in detail by Mechoulam^{3b,c} and Pars et al.^{106a} They were synthesized according to the general scheme shown in Chart 4.6. A Pechmann condensation between the appropriate keto ester and

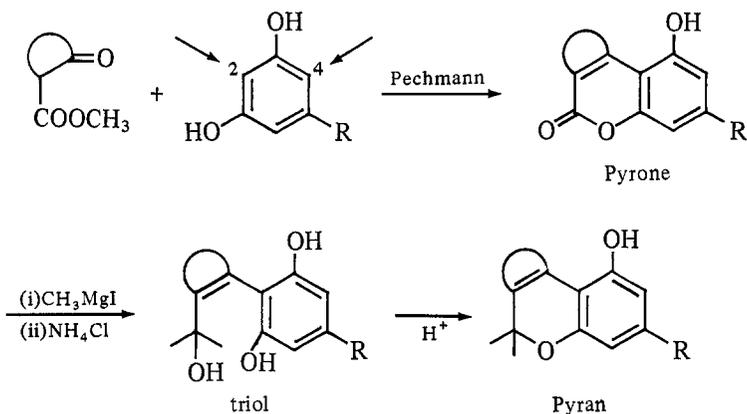

the resorcinol formed the pyrone. Generally the major product was formed by attack on the 2-position of the resorcinol. The isomers (attack on the 4-position) are also formed and their amount depends on the reaction conditions and the

nature of the substituent R in the resorcinol. Treatment of the pyrone with excess CH_3MgI gives the triol, which on treatment with catalytic amounts of acids (e.g., *p*-TSA) ring closes to the pyran.

Various water-soluble alkyl amino esters of type **190** and of the cyclopenteno derivative **192a** were prepared^{107b} from the pyrans by using the appropriate acid and carbodiimide, as in the case of Δ^1 -THC. Compounds of type **193** were prepared by oxidation of the pyrane as its acetate, with ceric ammonium nitrate.¹¹⁰

The novel cannabinoids with a homopyran ring of type **194** were reported by Matsumoto et al.¹¹¹ Their synthesis is shown in Chart 4.7. The pyrone **201** was reduced with Red-Al to the triol **202a**. Under mild alkaline conditions it was converted to the dibenzyl derivative **202b**. After bromination with PBr_3 and further treatment with NaCN/DMSO it formed the nitrile, which was debenzylated under mild hydrogenation conditions to **203**. Conversion of nitrile **203** to the ester **204** proceeded smoothly with HCl/EtOH . Grignard reaction with CH_3MgBr followed by treatment with ethanolic HCl gave the oxepin **194**. Some other related oxepins were also prepared by these authors.

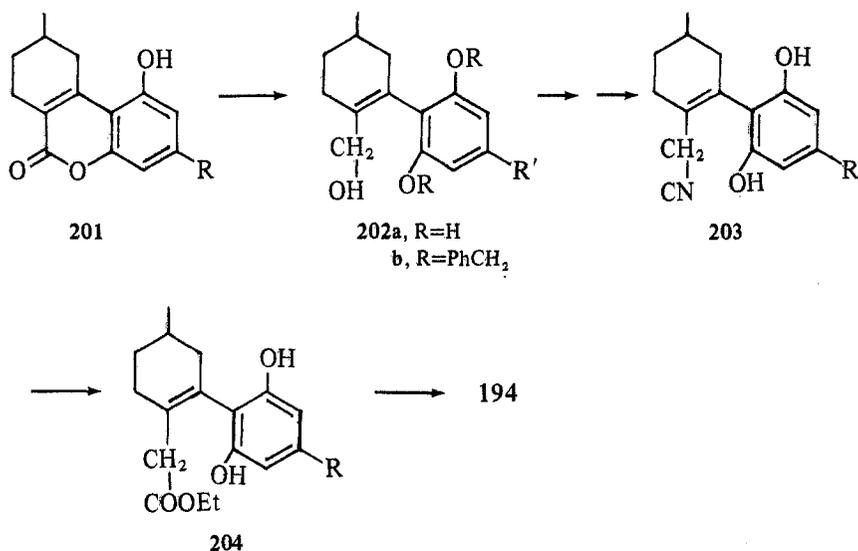

Razdan et al.¹¹² synthesized the steroidal analog **195**. They also prepared **196**.¹¹³ Both these analogs were prepared using the general scheme shown in Chart 4.6. Similarly the analogs **197** and **198** were synthesized by Malik et al.¹¹⁴ In the case of **197**, the corresponding pyrone was first reduced with Li/NH_3 to

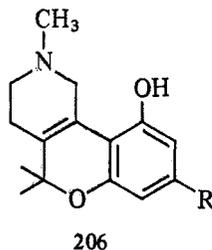
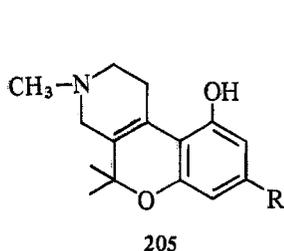
avoid aromatization of the alicyclic ring. Grignard reaction and ring closure with acid gave the desired pyran **197**.

The ring-opened analog **199** was prepared by Razdan et al.¹¹⁵ by Li/NH₃ treatment of the corresponding pyran. The ring opening was unexpected as no reduced pyrans were formed. It shows a very low extinction coefficient in the UV spectrum, $\lambda_{\text{max}}^{\text{EtOH}}$ 275 nm (ϵ 1600), in spite of the conjugation present, indicating that the alicyclic ring is out of plane from the aromatic ring. It has potent marijuana-like activity unlike other ring-opened cannabinoids, for example, cannabidiol.

Loev et al.¹¹⁶ prepared the analog **200** by LiAlH₄ reduction of the corresponding pyrone to the allylic alcohol **202a** (R' = C₉H₁₉) followed by ring closure with *p*-TSA. The biologically active benzoxocinols **163**, **164** have already been discussed (section 3H; Chart 2.9).

B. Heterocyclic Analogs

Interest in preparing nitrogen analogs of THC was stimulated by the observation that THC is one of the very few potent drugs that act on the central nervous system (CNS) yet has no nitrogen in its structure. As long ago as 1946 Anker and Cook¹¹⁷ synthesized the nitrogen analog **205** and its dihydro derivative and found them to be without analgesic activity. Other types of CNS activity were not mentioned in their report. They prepared **205** by following the general scheme as used for the synthesis of Δ^3 -THCs (Chart 4.6).



In 1966 Pars et al.¹¹⁸ reported the synthesis of the nitrogen analog **206**, which showed marijuana-like pharmacological profile. Since that time various nitrogen analogs,^{106,107b,119,120} type **205**, **207** to **212** (Chart 4.8), and sulfur analogs^{106,120-122} (Chart 4.10), all showing varying amounts of CNS activity in laboratory animals, have been synthesized.

The sequence of reactions for the synthesis of **207** (R = C₉H₁₉), shown in Chart 4.9, illustrates the general procedure used in the preparation of *N*-substituted nitrogen analogs of type **207**. The synthetic scheme is an adaptation of the general scheme used for the synthesis of Δ^3 -THCs (Chart 4.6). The pyrone

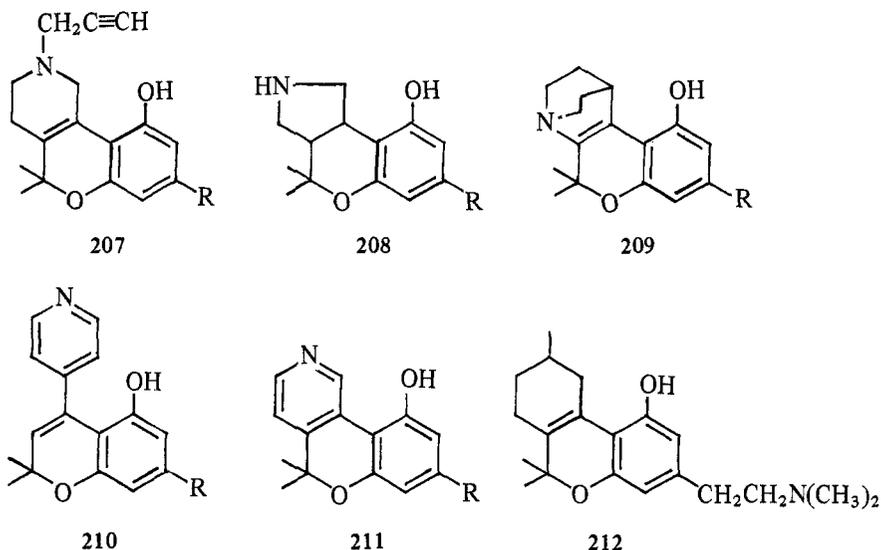

215 was obtained from the keto ester **213** and the resorcinol **214**. Best results in this Pechmann condensation were obtained by using a mixture of $\text{POCl}_3/\text{H}_2\text{SO}_4$. The Grignard addition was carried out in anisole and during workup the pyran **216** was formed. Debenzylation of **216** with Pd/C and H_2 formed the norbase **217**. Alkylation with propargyl bromide- Na_2CO_3 in EtOH furnished the desired compound **207**. A similar sequence was used for the synthesis of analogs **208**, except that during the debenzylation step the double bond was also reduced.

Compounds **209**, **210**, and **212** were prepared following the general scheme in Chart 4.6. Compound **211** was prepared by dehydrogenation of **207** ($\text{R} = \text{C}_9\text{H}_{19}$) with 10% Pd/C in xylene.¹²³

Surprisingly, all these nitrogen analogs as their acid addition salts were not very water soluble. Hence, like the carbocyclic analogs, they were made water soluble by making their alkylamino ester derivatives. A large number of water-soluble derivatives were prepared and studied by Razdan et al.^{107b}

The sulfur analogs^{121, 122} **218** to **222** (Chart 4.10) were prepared according to the general scheme in Chart 4.6. In the sulfur series the Pechmann reaction was best carried out in the presence of HCl/EtOH. The sulfur analog **223** was prepared from **218** by dehydrogenation.

Recently Cushman and Castagnoli¹²⁴ reported the synthesis (Chart 4.11) of biologically active nitrogen analogs **230** having a *trans* ring fusion similar to that

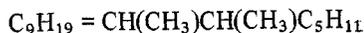
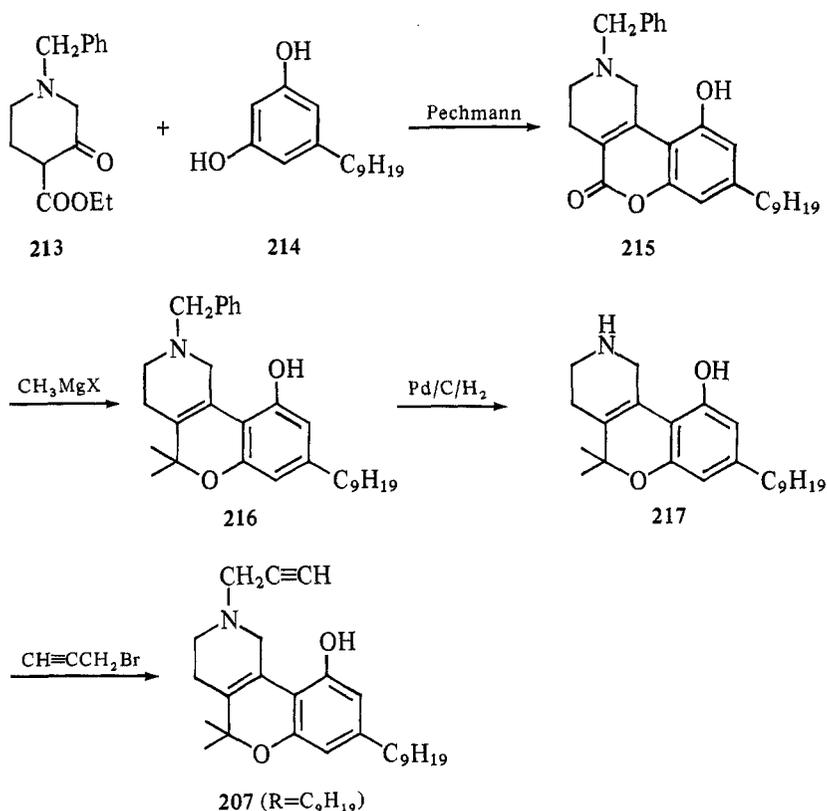
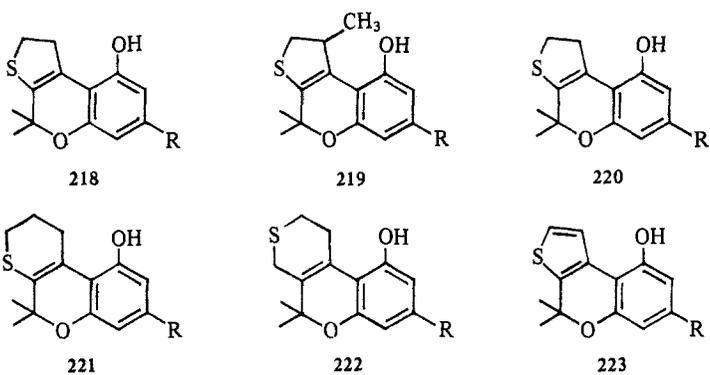

found in the natural THC_s **1** and **2**. Their novel approach to the synthesis of these analogs utilizes the condensation of the Schiff base **225** with glutaric anhydride to give predominantly the *trans*-piperidone **226a**. The ester **226b** on Grignard treatment followed by demethylation with BBr_3 and subsequent dehydrohalogenation, afforded the olefin **227**. After ring closure with $\text{BF}_3 \cdot \text{Et}_2\text{O}$, compound **228** was treated with CH_3MgBr and then dehydrated to form the enamine **229**. Catalytic reduction of **229** gave a diastereomeric mixture of amines **230**. Preliminary pharmacological results showed the mixture to be active.

Several other nitrogen analogs have been prepared, and in most cases their biological activity has not been reported.

Condensation of **231** (Chart 4.12) with benzamidine furnished **232**, whereas condensation with the appropriate diamine followed by thermal ring closure in vacuum gave **233**.¹²⁵ The resorcinols **234** and **235** were condensed with *p*-menthadienol **11** and then reduced to yield **237**¹²⁶ and **238**,¹²⁷ respectively. Similarly **236** (R = CH₃ or C₂H₅) condensed with **11** to give the corresponding ester, which on treatment with dimethylamine followed by LiAlH₄ reduction formed the analogs **239** (*n* = 2 to 5).¹²⁸ The analog **240**¹²⁶ was obtained from **237** on treatment with dimethylaminopropyl chloride in the presence of butyllithium. No biological data were reported for any of these compounds.

Another nitrogen analog **241** (Chart 4.12), where the pyran oxygen is replaced by NCH₃, was synthesized and reported to be inactive.¹²⁹ However, a related analog **242** has been reported¹³⁰ to be very active biologically, but no details of its synthesis have been described.

The novel analog **243** was synthesized¹³¹ according to the scheme in Chart 4.13. The Diels-Alder reaction is used to give the *trans* ring junction as in the synthesis of Δ⁶-THC (see Chart 1.9).

The analogs where the phenolic hydroxy group is replaced by SH (244) or NH₂ (245) were synthesized by Matsumoto et al.¹³² (Chart 4.14). They showed that the amino analogs retained pharmacological activity, but the sulfur analogs were relatively inert.

Other sulfur analogs include 247, 248, and 249. They were prepared¹³³ from pulegone (137) by a base-catalyzed reaction with the thiophenol (Chart 4.15) followed by the ring closure to 246. Demethylation of the methoxyl gave 247, which on dehydrogenation gave the cannabinol analog 248. Sulfones 249 were also prepared by *m*-chloroperbenzoic acid oxidation of 246. No biological data were reported.

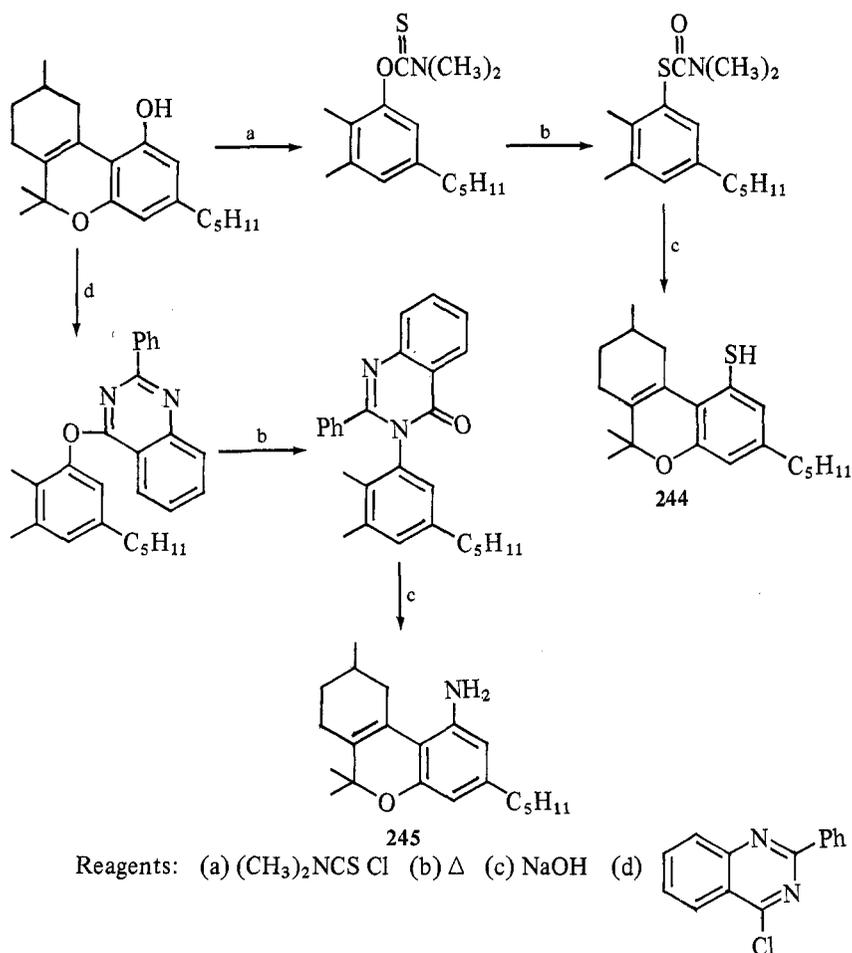

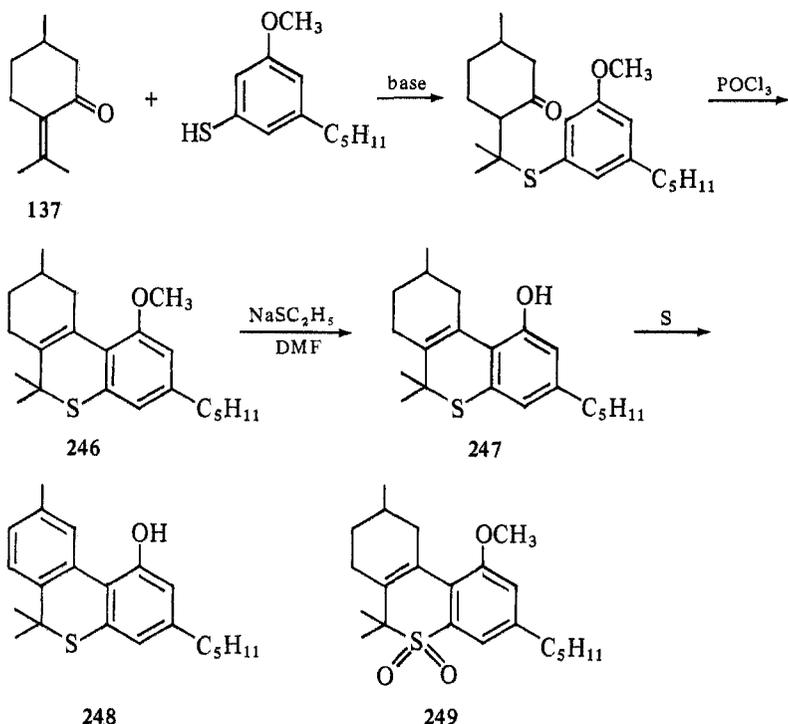


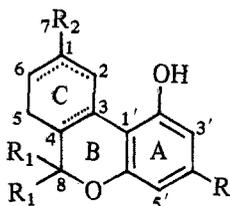

6. OVERALL STRUCTURE-ACTIVITY RELATIONSHIPS IN CANNABINOIDS

In various animals Δ^1 -THC and other synthetic THC's show predominantly central nervous system (CNS) depression and ataxia, which lasts from several hours to days, depending on the dose administered. The characteristic effect of THC's, which distinguishes them from all other psychoactive drugs, is a postural arrest phenomenon with relaxed staring and associated hypersensitivity to external stimuli.¹³⁴ For example, when Δ^1 -THC is given at a dose of 0.2-0.5 mg/kg (i.v.) to dogs, they stand in a trancelike state, sway from side to side, pitch forward and backward, and overreact to a swinging object. When aroused, ataxia is evident for 3 to 4 hours after the injection. It is characteristic for the dogs to urinate and defecate soon after receiving the drug and sleep a great deal for the next 24 hours.

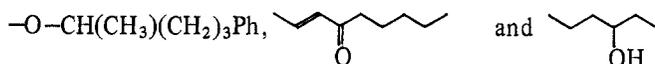
The synthesis and demonstration of CNS activity for a wide variety of cannabinoids has resulted in an expansion of the structure-activity (SAR) conclu-

sions originally put forth by Roger Adams and co-workers.¹³⁵ By using dog ataxia as the basis for THC activity, Adams found that the potency is increased when R is a highly branched alkyl with the 1,2-dimethylheptyl (C₉H₁₉) showing optimum activity. He also showed that when R₁ is methyl the activity is greater than when these (R₁) substituents are higher alkyls. Reduction of the double bond in the C-ring retained activity, and the C-ring could be contracted, expanded or even opened without entirely eliminating activity.



Recent studies of various metabolites and other synthetics have expanded these SAR observations. Thus based on CNS pharmacological profiles in laboratory animals, the SAR picture can be summarized as follows.

1. Essentially a benzopyran structure with an aromatic hydroxyl group at 2'-position and an alkyl or alkoxy group on the 4'-position are a requirement for activity.
2. The position and the environment around the aromatic hydroxyl group are very important for the activity, viz.;
 - a. The OH at position C-2' is in itself necessary for CNS activity.
 - b. Esterification of the phenol retains activity and in some carbocyclic and heterocyclic benzopyrans, can lead to greater selectivity of action. Etherification of the phenol eliminates activity. Replacement of the OH by NH₂ retains, whereas by SH, eliminates activity.
 - c. Methyl substituents at C-2 in the C-ring significantly alter the activity of both carbocyclic and (C-ring) heterocyclic benzopyrans particularly in the case of planar five-membered C-rings.
3. Substitution in the aromatic ring by electronegative groups like carboxyl, carbomethoxyl, acetyl eliminates activity, whereas alkyl groups in C-3' position retain, and in C-5' position reduce, activity.
4. A minimum length of the aromatic side chain is necessary to elicit activity. The branching of the alkyl side chain increases potency. Thus 1,2-dimethylheptyl or 1,1-dimethylheptyl gives the most potent compounds. Similarly *p*-fluorophenyl alkyl and side chains as shown give good activity.



- On ring B the *gem*-dimethyl group at C-8 (R_1) is optimum for activity. Replacement of one of the R_1 substituents on the B ring with a hydroxy-methyl group retains activity. Replacement of pyran O by N and ring expansion of ring B by one carbon can retain activity.
- In the alicyclic ring C, compounds with the double bond in the Δ^1 -, Δ^6 -, or Δ^3 -position are active. A 3,4-*trans* junction increases and a *cis* junction decreases activity. The natural THC's are active in the 3*R*, 4*R* series only. A methyl at C-1 increases activity, but metabolism to the 7-hydroxymethyl is not a prerequisite for THC activity.
- The C-ring can be substituted by a variety of nitrogen and sulfur-containing rings without loss of CNS activity. With the nitrogen and sulfur analogs the most active CNS agents are obtained when the heteroatom is in a phenethyl orientation, e.g., inserted in place of C-1 or C-5.
- Planarity of the C ring is not a necessary criterion for activity. See, for example, the quinuclidine analog (209, chart 4.8) and the benzoxocine compounds (163, 164; Chart 2.9).
- In both carbocyclic and heterocyclic analogs, opening the pyran ring generally decreases activity. An exception is compound 199 (Chart 4.5), which is approximately equiactive with Adams DMHP (Chart 6.1).

7. THERAPEUTIC INDICATIONS AND POTENTIAL OF NEW DRUGS FROM CANNABINOIDS¹³⁶

As discussed in the Introduction, the main therapeutic indications for Δ^1 -THC have emerged from folklore anecdotes. The use of Δ^1 -THC, as an antinauseant to patients undergoing cancer chemotherapy, and its utility as an antiglaucoma agent, is now well established clinically. In many states in the United States and in some foreign countries, a strong movement in favor of legalizing the use of Δ^1 -THC for these purposes has developed. This is mainly because Δ^1 -THC is more effective in controlling nausea than presently available drugs. In the case of glaucoma where patients tend to become refractory to the drug in use, the addition of a new class of drug which presumably acts by a novel mechanism is of great interest. The clinical activity of Δ^1 -THC in these two fields has led investigators to use synthetics for these indications. Presently three such drugs are being actively pursued in the clinic. These are shown in Chart 6.1; a carbocyclic 1-ketocannabinoid, Nabilone,¹³⁷ and two nitrogen analogs, Nabitan,^{107b, 138} a water-soluble derivative, and A-41988.^{139, 140}

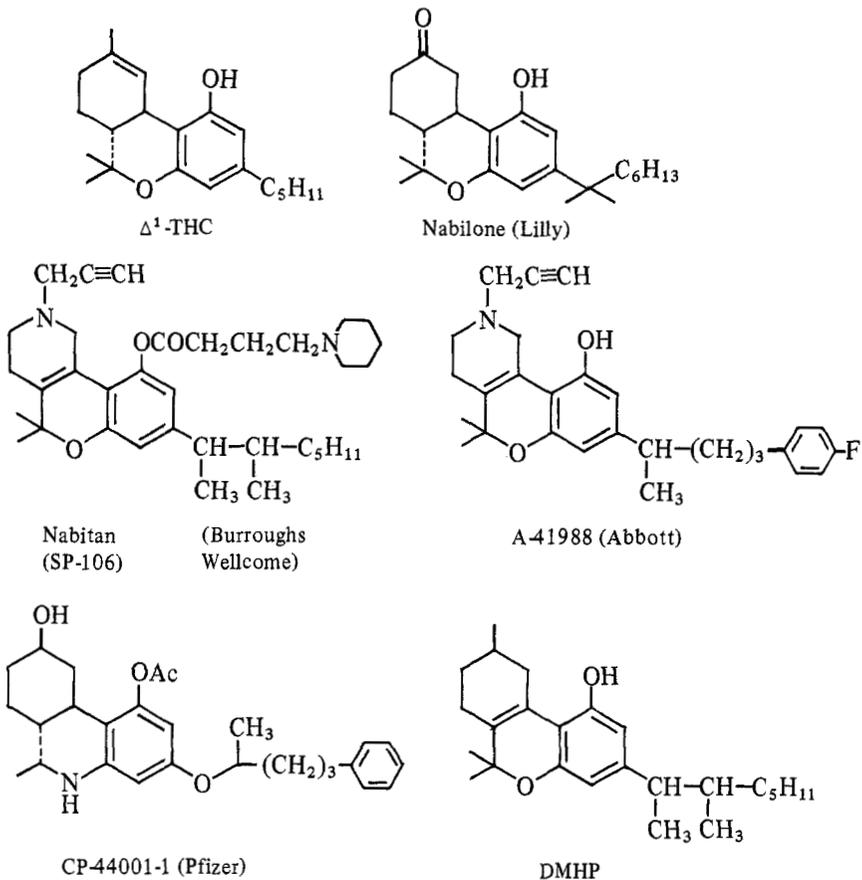

Animal studies to date, both in heterocyclic and carbocyclic analogs, clearly point to therapeutic potential as analgesics. Preliminary studies in man have already given some indication of analgesic potential for both Δ^1 -THC¹⁴¹ and Nabitan (SP-106).¹⁴²⁻¹⁴⁴ Since establishment of a new type of analgesic in the clinic is not simple due to subjective and placebo effects, the studies with Nabitan are continuing and as such the place of cannabinoids as analgesics has not yet been firmly established. Recently another nitrogen analog CP-44001-1 (Nantradol) has been reported¹³⁰ to be a potent analgesic in animals and is presently undergoing clinical trials.

The recent finding^{145, 146} that DMHP, a carbocyclic analog originally synthesized by Roger Adams in the 1940s, shows hypotensive effects at doses where no CNS effects occur, is noteworthy and, it is hoped, will open up a fruitful area for

cardiovascular drugs. In addition a preliminary study has indicated the use of Nabilone as a tranquilizing agent.^{137b}

Based on a few clinical studies with Δ^1 -THC there are indications of its use as an antiasthmatic¹⁴⁷ and as an appetite stimulant.¹⁴⁸

A recent survey¹⁴⁹ suggests a high incidence of marijuana use among young epileptics. Their observations of its efficacy in alleviating their symptoms, like those of the glaucoma and cancer patients, may point to another area where clinical utility should be focused. There is already some indication clinically^{150, 151} to support this view and animal studies clearly point to therapeutic potential in this area.

Other areas of interest, supported by animal pharmacology, are antiinflammatory, antipyretic, antitussive, antispasmodic, antidiarrheal, sedative-hypnotic, antidepressant, anticancer, and treatment of alcoholism and narcotic addiction.

It is obvious that Δ^1 -THC and analogs display a wide range of pharmacological action. The future development of drugs from this area will undoubtedly depend on the success achieved by structural changes to provide selectivity of pharmacological action. However, it should be emphasized that the concept of drug development from THC's and cannabinoids is based on very sound foundations, since Δ^1 -THC has a remarkably low toxicity in animals and humans. In addition, it has practically no respiratory-depressant activity, no or very low physical dependence liability and finally has a unique pharmacological profile compared to other psychoactive drugs.

On reflection, it is surprising that drug development from cannabinoids did not take place sooner.

1. INTRODUCTION

The ability of a molecule to complex an ion, and to assist in the transport of this ion through a lipophilic interface, is the general description of an *ionophore*. The term ionophore, with this functional definition, was first coined by Pressman in 1964.^{1,2} A related adjective, *complexone*, perhaps accentuating more the property of complexation, is employed by Ovchinnikov and co-workers at the Shemyakin Institute to describe the same molecules. Although the ion involved in the complexation-transport process is usually an alkali or alkaline earth metal, other possibilities include iron(III), proton, and protonated organic substrates, such as biogenic amines.

The class of molecules termed ionophores encompasses a diversity of structural types. A common feature of these structures is the presence of heteroatoms capable of acting as ligands for an ion. Equally important is the 3-dimensional capability of an inward orientation of the ligands in an appropriate geometry for the ion, simultaneously exposing a relatively lipophilic exterior. This chapter is organized primarily according to structural types. Included are linear and cyclic peptides, cyclic depsipeptides, macrolides, and the antibiotic polyether monoacids. A group not often included in reviews of ionophores is the siderophores, which are iron-specific ionophores. This group is classified functionally, since it incorporates several different structural types, although many are *N*-hydroxylated peptides (hydroxamates). Its inclusion is based on both the fulfillment of the dual role of ionophore's complexation and transport and the accomplishment of some interesting total syntheses. Within the various groups of ionophores will be some limited descriptions of "synthetic analogs," which mimic that group of natural ionophores structurally and/or functionally.

Most of the naturally occurring ionophores were discovered because of their antibiotic properties. In fact, much of the structure proof, synthesis, and determination of the spectrum of antibiotic activity preceded their definition as ionophores. Although a correlation of specific ion complexation and transport with antibiotic activity is apparent,³ complexation/transport does not constitute a universal mechanism of action. Besides antibiotic activity, other pharmacological effects include cardioregulatory action such as positive inotropic effects and a decrease in coronary resistance. Other effects, including distribution of radio-nuclides, and lowering of intraocular pressure have been noted. These have recently been reviewed by Pressman⁴ and Westley.^{5,6}

The phenomenon of transport through a membrane has several mechanisms: diffusion, carrier-mediated, and active transport. Diffusion-controlled passage is driven simply by thermal molecular motion. In carrier-mediated transport the introduction of a second factor, a mobile component (ionophore), assists in ionic penetration and movement through the membrane. This can occur either

via a free, ion-molecular complex (carrier) or a transporting, relatively stationary complex (channel or pore). Active transport involves operating against an electrical or chemical gradient and therefore requires coupling with an energy source, such as ATP hydrolysis.

Therefore, in simplistic terms ionophore or carrier-mediated transport involves (1) complexation of the ionophore with an ion, requiring a substitution of the ionophore binding sites for the hydration sphere surrounding the ion through the lowest energy (stepwise) mechanism, (2) diffusion of the complex from one membrane interface to the other, and (3) the reverse of the complexation process [step (1)]. Several factors requiring optimization are a best-fit situation of the ion for the ligands, the 3-dimensional lipophilicity of the complex, and the difference between the energies of ligation and solvation. These phenomena and their interrelationships have been reviewed.^{44,45}

The physiochemical and biological criteria for functionally defining ionophores have many facets. In the former case such techniques as bulk phase extraction (aqueous to organic phase),⁴⁶ U-tube experiments (two aqueous phases separated by an organic phase),^{47,48} ionophore impregnated liquid membrane ion selective electrodes,⁴⁹ and specific ion saturated liposomes^{53a} are included. All of these techniques act as models, to one degree or another, for biological membranes. Perhaps the closest model of all are bilayer lipid membranes (BLM; also known as black lipid membranes). Essentially this is a bilayer soap film oriented across an orifice suspended in aqueous media, thus creating an electrochemical cell. The BLM can be utilized to determine passive ion transport, voltage-dependent transport, and ion selectivity.⁵⁰ Oft-employed biological parameters for ionophore classification include mitochondrial swelling and uncoupling of oxidative phosphorylation,^{29,51} Na⁺ or K⁺ depletion of erythrocytes,^{53b} and such Ca²⁺ transport-dependent phenomena as histamine release from rat mast cells,⁵⁴ cortical granule rupture in sea urchin eggs,⁵⁵ serotonin release from, and aggregation of,

blood platelets,⁵⁶ and many others. For reference to ion selectivities cited in the foregoing sections Table 1 includes data on some ionic parameters of pertinent ions.

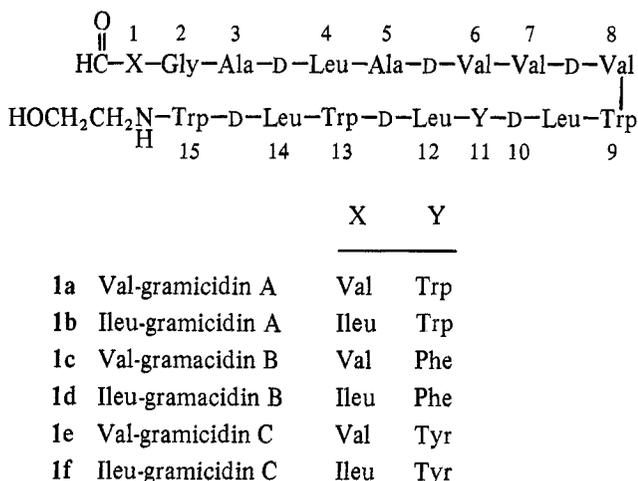
2. THE PEPTIDES

Of the many peptide antibiotics isolated from bacteria, several have been categorized as ionophores. These include the gramicidin complex, alamethicin, and the cyclic peptide, antamanide. From the viewpoint of structural similarity, one might project related peptides as ionophore candidates such as the amphomycins,⁷ the bottromycins,⁸ the antimycins (both cyclic⁹ and linear¹⁰) and probably most of the homomeric homodetic cyclic peptides (gramicidin S, J, tyrocidin A-D, polymixins, viomycins, ilamycins, cyclosporins, and others).

Interestingly, their biosynthesis appears to involve multienzyme complexes independent of the usual protein biosynthesis pathway of ribosomal-, messenger-, and transfer-RNA. The appearance of the many D-amino acids stems from an ATP-dependent racemization within the enzyme complex after amino acid incorporation.¹¹

A. Gramicidins

The linear gramicidins, isolated from *Bacillus brevis*¹² along with the cyclic gramicidins S and J and the tyrocidins,¹³ consist of at least six components (1a-f).^{14a-c} They have in common 13 of 15 amino acids, a formyl blocked *N*-terminal, and ethanolamide *C*-terminals. They differ in the replacement of isoleucine for valine at the *N*-terminal and substitutions of tryptophan, phenylalanine, and tyrosine at position 11.



Evidence has been accumulated which indicates the ion transporting capacity of gramicidin A involves the formation of ion-conducting channels in membranes.

It has been proposed^{16,17} that this pentadecapeptide forms a helical, head-to-head dimeric complex which forms a pore or channel in the membrane with approximately a 4 Å diameter and 30 Å length.¹⁸

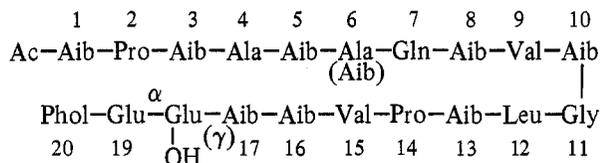
The relative order of transport has been determined as $H > NH_4 > Cs > Rb > K > Na > Li$.¹⁷ Bulk phase extraction and U-tube transport experiments indicate a 1:1 K/gramicidin association ratio with weak binding and poor diffusional transport, thus further supporting the premise of non-carrier-mediated transport.³¹

The structures of gramicidins A-C were elucidated by Sarges and Witkop. They also synthesized gramicidin A(1a,b).¹⁵ Their successful strategy involved the dicyclohexylcarbodiimide coupling of the pentapeptide, Z-Val-Gly-Ala-D-Leu-Ala-OH, constituting positions 1-5 of 1a, with the decapeptide, constituting positions 6-15. The respective fragments were built up from the requisite amino acids, using the mixed anhydride method (EtO₂CCl, Et₃N). The details of the synthesis will not be related here, since they have already been reviewed by Ovchinnikov and co-workers³ and also by Johnson¹⁹ in a previous volume of this series.

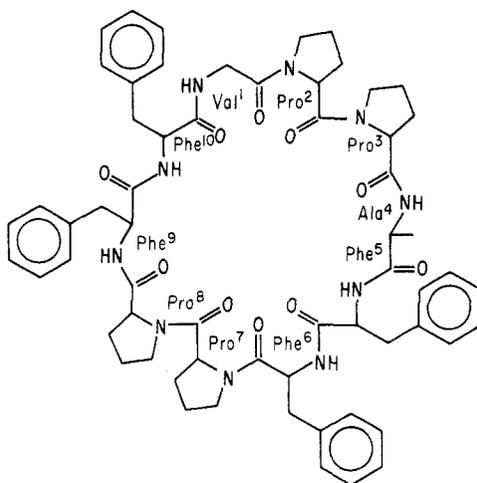
The gramicidin complex exhibits mainly Gram-positive antibacterial activity (gramicidin A constitutes ~75% of the mixture). The syntheses of shorter chain analogs led to the conclusion that excision of more than two amino acids substantially reduced activity.²⁰ A pentadecapeptide model, HCO-(Ala-Ala-Gly)₅-OH, has been proposed, based on conformation analysis, to form ion-conducting channels.²¹ Recently, simplified analogs such as (Trp-D-Leu)₇Trp and Trp-Gly-(Trp-D-Leu)₆Trp have been shown to form cation-permeable channels with properties similar to gramicidin A.¹³⁶

B. Alamethicin

A second linear polypeptide reported to enhance passive ion transport is alamethicin. Isolated from *Trichoderma viride*,²² it was initially believed to be a cyclic octadecapeptide^{23,24} and was accompanied by a closely related polypeptide (alamethicin II). However, recent work with ¹H-NMR spectroscopy has demonstrated alamethicin's linear nature,²⁵ and the combination of ¹³C-NMR with high resolution and field desorption mass spectrometry has yielded a



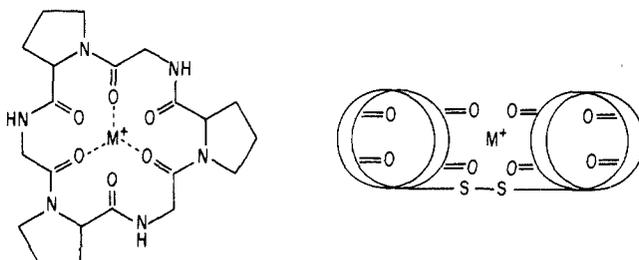

Synthetic cyclopeptides that complex and transport ions have been reported. For example, Blout and co-workers⁴⁰ have synthesized cyclo-(Pro-Gly)₃ and demonstrated selectivity for the smaller cations in both the monovalents (Li⁺ and Na⁺) and the divalents (Mg²⁺, Ca²⁺). In a slightly different approach Schwyzer's group, who had previously synthesized gramicidin S (cyclic),⁴¹ prepared a cysteine (S-S) bridged cyclopeptide.⁴² The strategy was to construct two face-to-face cyclic homodetic peptide rings to act in a sandwich ion-binding fashion. Therefore, they synthesized (Chart 2.1) S,S'-bis-cycloglycyl-L-hemicystyl-glycyl-glycyl-L-proline in 15% overall yield. Ion transport studies employing the liquid membrane electrode method of Simon⁴⁹ established a specificity order of K > Na > Li > Ca.

Other recent entries into the area of synthetic cyclopeptides include cyclo-(Gly-Pro-Gly-D-Ala-Pro),⁴³ which exhibits binding with divalent ions such as

CYCLO-(PRO-GLY)³

Mg²⁺, Mn²⁺ and Ca²⁺, as well as with Li⁺, cyclo-[L-Tyr(OBzl)-Gly]₃ which exhibits K and Na complexation⁷⁴, and cyclo [Glu-Sar-Gly-(*N*-decyl)Gly]₂, which, by virtue of two ionizable Glu-CO₂H groups and a lipophilic chain, exhibits excellent Ca²⁺ selectivity.⁷⁵

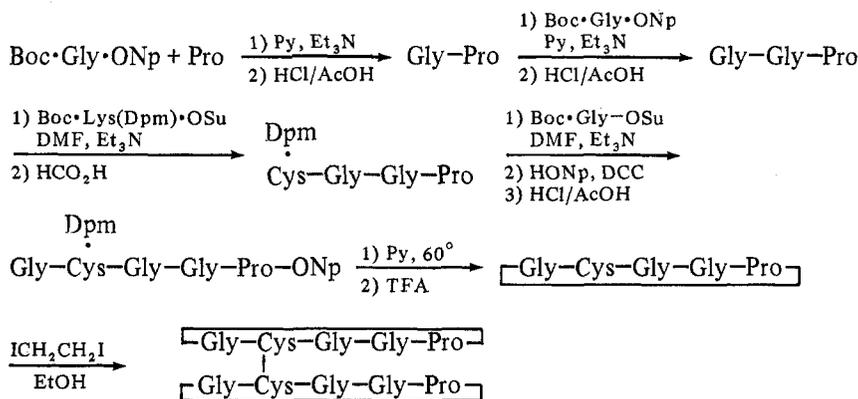


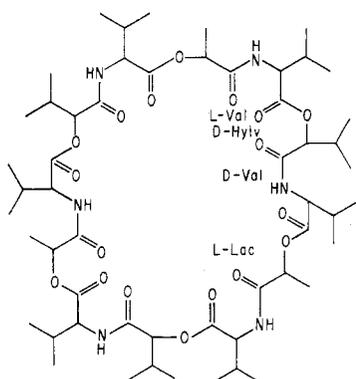

3. CYCLIC DEPSIPEPTIDES

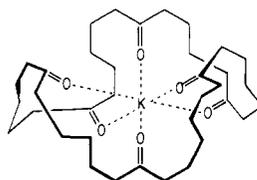
Depsipeptides are characterized by the inclusion of at least one non-amino acid residue (heteromeric). Many of this class of natural products are cyclic in nature, and of these, three have been exploited as ionophores: valinomycin, enniatins, and monamycins.

A. Valinomycin

Valinomycin is a cyclic, regular dodecadepsipeptide of the structure (L-valine-D-hydroxyisovaleric-D-valine-L-lactic acid)₃, produced by several *Streptomyces* sp. Even though valinomycin exhibited rather broad antimicrobial activity including G⁺ bacteria, yeast, and fungi, it has received most of its attention because of its extremely high K/Na selectivity and carrier-mediated transport kinetics (approx. 10⁴ K⁺/valinomycin/sec in BLM). It also forms stable complexes with Rb⁺ and Cs⁺. Numerous studies have been carried out to elucidate the various conformers of valinomycin in solution and in its metal-complexed state.^{3, 58, 61} The evidence indicates that only the ester carbonyls are involved directly as ligands for the metal in a bracelet conformation, stabilized by intramolecular H-bonding between the amide linkages. The X-ray crystal structure of valinomycin has also been elucidated.⁵⁹

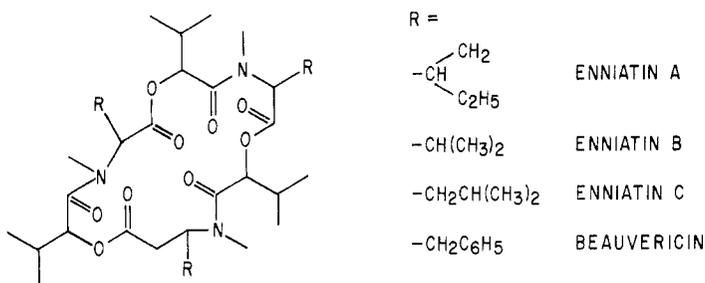
The structure of valinomycin was originally proven by total synthesis by Shemyakin and co-workers.⁶⁰ The preparation of the 36-membered ring began by building up the repeating tetrapeptide unit *Z*-D-Val-L-Lac-L-Val-D-HyIv-*O*-*t*-Bu by amide bond formation between *Z*-D-Val-L-Lac-*OH* and *H*-L-Val-D-HyIv-*O*-*t*-Bu (SOCl₂, Et₃N). The initial acylations of *t*-butyl-L-lactate and D-hydroxyisovalerate with D- and L-valine (*Z*) were carried out with benzene sulfonyl chloride in pyridine. In the original synthesis the initial tetrapeptide was then coupled to the next didepsipeptide; however, in a later approach,³ the tetrapeptides were fashioned into the linear dodecadepsipeptide by amide bond formations with PCl₅/Et₃N followed by ring closure under high dilution conditions with SOCl₂/Et₃N (25% yield). Since activation of the hydroxy acid (Lac, HyIv) *C*-terminal residues with thionyl chloride does not cause extensive racemization, these rarely employed conditions could be utilized. Other syntheses, including Merrifield solid-phase methods, have been reported.⁶² The Shemyakin group has prepared a large number of analogs, most of which have similar or substantially inferior complexing properties, except for one analog that substitutes L-MeAla for L-Lac, exhibiting an even more stable K-complex than valinomycin. Interestingly, there appears to be a very good correlation between ion transport and antibiotic activities with these analogs.⁶⁵ Since the syntheses of valinomycin has been reviewed several times elsewhere,^{3, 63, 64} we will not report the details here.

The syntheses of four cyclic peptides related to valinomycin have recently been completed⁵² employing the Merrifield solid-phase methodology: cyclo-[Pro-Ala-D-Pro-D-Val]₃, cyclo-[Ala-Val-D-Pro-D-Val]₃, cyclo-[Pro-Val-D-Pro-D-Val]₂-Pro-D-Val, and cyclo-[Pro-Val-D-Pro-D-Val]₂. The first 12-membered oligopeptide ring was ~10³ > valinomycin for K⁺ complexation with a selectivity sequence (bulk-phase extraction) of K ~ Rh > Cs > Na > Li. This analog was

substantially better than the other three and was also effective in increasing membrane conductance of sheep red blood cell bilayers in the presence of KCl.

B. Enniatins

Again, as was the case with the previously described gramicidins, a mixture of closely related structures make up the enniatins. Isolated from several *Fusarium* species, three compounds, enniatins, A, B, and C, are the most studied. A closely related cyclodepsipeptide, beauvericin, was isolated from the fungus *Beauveria bassiana*.



The enniatins are cyclic hexadepsipeptides, one half the ring size of valinomycin. They do not exhibit the ion selectivity seen with valinomycin but form disc-shaped complexes (1:1)⁶⁷ with most alkali and alkaline earth metals, ammonium ion, and even some transition metals.^{3, 66} Alternatively, they exhibit a better antimicrobial spectrum of activity, including *M. tuberculosis*, and are significantly less toxic than valinomycin.

As with valinomycin, their structure was first confirmed by total synthesis (enniatin B, (D-HyIv-L-Me_NVal)₃).^{68, 69} The general strategy involved the coupling of the Z(-NO₂)-L-MeVal-D-HyIv-O^t-Bu units together via amide bond formation with PCl₅/Et₃N. The ester linkage of the depsipeptide was formed with the benzene sulfonyl chloride, pyridine mixed anhydride method, or diimidazole carbonyl as exemplified in the beauvericin synthesis (Chart 3.1). Analogous to the valinomycin synthesis, ultimate ring closure was effected with SOCl₂/Et₃N. Numerous analogs were prepared with similar chemistry.³

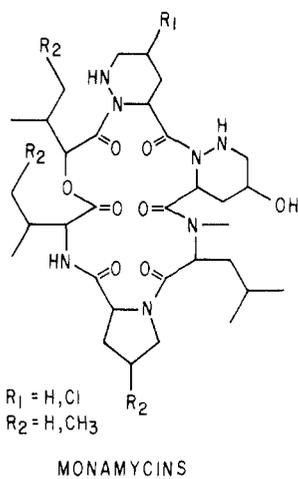
C. Monamycins

The monamycin family of antibiotics, isolated from *Streptomyces jamaicensis*, exhibit G⁺ antibacterial activity and form monovalent ion complexes.⁷¹ Although they are structurally related to the enniatins in that they are 18-membered ring, cyclohexadepsipeptides,^{72, 73} they are considerably more com-

plicated and have, as yet, not been prepared by total synthesis. They are composed of some unusual amino acids such as (3*R*)-piperizinic acid, (3*S*,5*S*)-5-hydroxypiperizinic acid, (3*R*,5*S*)-5-chloropiperizinic acid, D-isoleusine, and trans-4-methyl-L-proline in 15 structural variations.



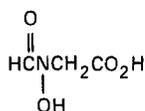
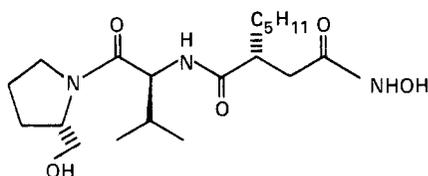
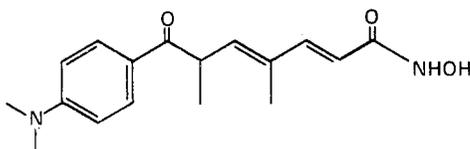
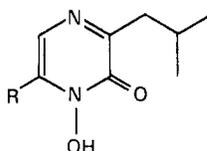
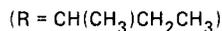
4. SIDEROPHORES

One of the unique aspects of nutrient uptake by microorganisms is the transport of iron utilizing chelating agents.^{76a} Originally termed *siderochromes*, these "ferric ionophores,"^{76b} or *siderophores*, have been grouped into two categories: secondary hydroxamates and catechols.⁷⁷ They are biosynthesized under iron-deficient conditions, secreted into the medium to complex, and thus "solubilize" any iron present, and then apparently transported into the cells to provide iron for the electron transport processes and other requirements. Their coordination chemistry involves high-spin ferric complexes of octahedral geometry.

A. Hydroxamates

The naturally occurring hydroxamic acids represent by far the larger of the two categories of siderophores.^{76c} They range in structural complexity from the simplest, hadacidin, to perhaps the most complex, the mycobactins.

The group of monohydroxamic acids include, among others, hadacidin, actinonin, trichostatin A, and the aspergillic acids. Aspergillic acid structurally represents five closely related *N*-hydroxypyridinones which vary at R from hydroxylated butyryl to propyl side chains. Aspergillic acid was isolated from

Aspergillus flavus by White and Hill⁸² and structure established by Dutcher in 1947.⁸¹ Apparently derived from leucine and isoleucine, the oxidation of the isoleucine-derived nitrogen occurs after cyclization to the deketopiperazinone.⁸³

The parent structure was synthesized by Masaki et al. in 1965.⁸⁴ Their preparation of racemic aspergillic acid began with the alkylation of *N*-leucyl-*o*-benzylhydroxylamine with 1-chloro-3-methyl-2-oximinopentane (Chart 4.1). The oxime was unmasked to the ketone with 3 *N* hydrochloric acid with strict temperature control (41-43°). Catalytic hydrogenation released the hydroxamic acid, which underwent ammonia-catalyzed cyclization with aromatization to the desired product.

Ollis and co-workers reported a synthesis of actinonin,⁷⁹ isolated from *Streptomyces roseopallidus*, in 1974. As depicted in Chart 4.2, regioselective addition of *o*-benzylhydroxylamine on pentylmaleic anhydride was exclusive yielding only isomer 1. Cyclization, however, afforded two isomers with 3 predominating.

Nucleophilic addition of L-valyl-L-prolinol to isomaleimide-3 regioselectively afforded 4, wherein the double bond had apparently isomerized. This was subsequently deprotected and reduced to afford actinonin in unspecified yield.

There are only several examples of the dihydroxamic acid group. By far the most studied is rhodotorulic acid. Isolated from the yeast *Rhodotorula pilimanae*, and characterized by Atkins and Neilands,⁸⁵ this diketopiperazine is biosynthesized from ornithine and δ -*N*-acetyl- δ -*N*-hydroxyornithine.⁸⁶ Studies of its coordination chemistry have established a binding constant at neutral pH of 31.1 (log K_f) with the predominant Fe(III) species as $\text{Fe}_2(\text{RA})_3$.⁸⁷

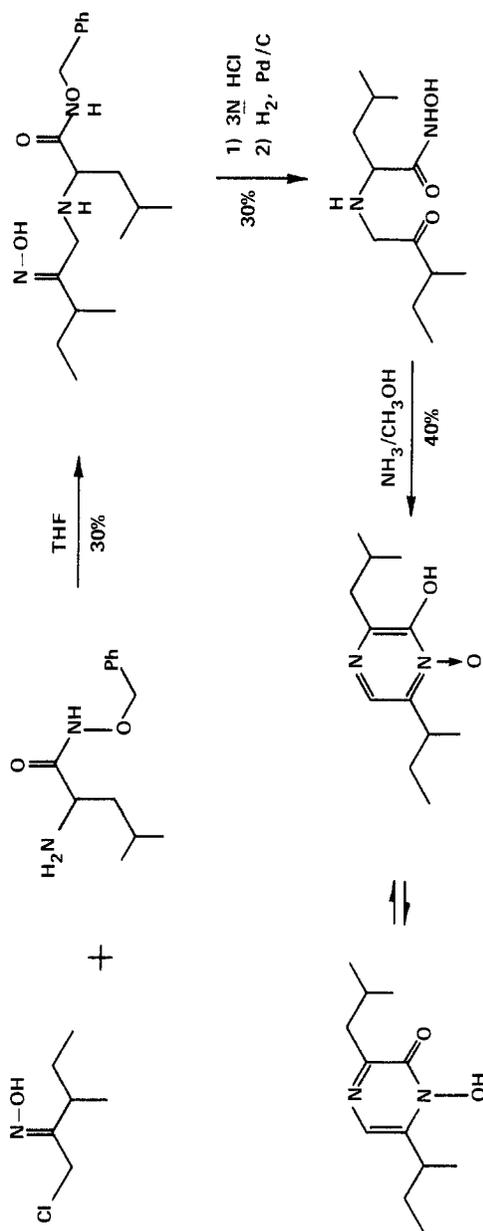

Rhodotorulic acid was synthesized by Y. Isowa et al.⁸⁸ in 1971. Preparation of the requisite ornithine dipeptide intermediate is accomplished by the mixed anhydride coupling of the appropriately protected L-amino acids, **5** and **6**, in 98% yield. Deprotection of the benzylloxycarbonyl protected amine followed by treatment with ammonia yielded the diketopiperazine. Removal of the tosyl groups was effected with acid in the presence of phenol at room temperature, and benzyl group cleavage, subsequent to acetylation, afforded the unmasked

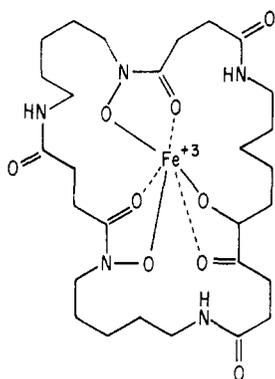
secondary hydroxamates in good overall yield. These workers also prepared the optical antipode of rhodotorulic acid, starting with the D-amino acid. Two other structurally interesting dihydroxamates are schizokinen and aerobactin; however, these have not as yet been prepared by total synthesis. Aerobactin, coordinatively produced by *Aerobacter aerogenes* with the catechol siderophore, enterobactin (vide infra), coordinates Fe(III) with the terminal *N*-acetylhydroxyl amines and the central citric group with a binding constant of 31.7.¹²⁰

SCHIZOKINEN⁸⁹AEROBACTIN⁹⁰

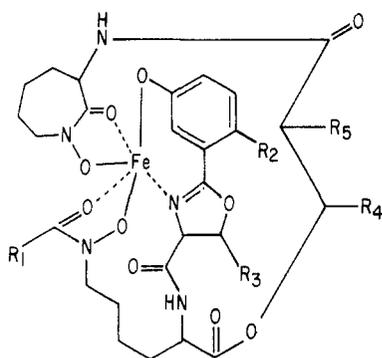
The trihydroxamic acids encompass the largest subgroup of the hydroxamate siderophores. These include the cyclic ferrioxamines (e.g., nocardamin), Desferal, the ferrichromes, and the mycobactins. Some of these are depicted below as their ferric complexes.

Ferrichrome, isolated from the fungus *Sphaerogena*, was the first trihydroxamate siderophore to have been characterized.^{94,98} It is biosynthetically derived from ornithine and glycine in a sequence involving (1) oxidation to ornithine hydroxylamine, (2) acetylation, (3) condensation with glycine, and (4) the incorporation of Fe(III).^{76b} Ferrichrome exhibits an iron binding constant of 29.1,⁹⁵ which competes very favorably with rhodotorulic acid (31.1) and the clinically employed Desferal (30.6).

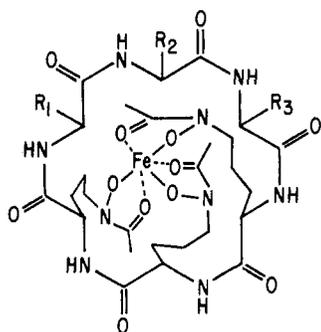
This cyclic hexapeptide was synthesized by Keller-Schierlein and Maurer⁹⁶ in 1969 and by Isowa and co-workers⁹⁷ in 1974. The procedure employed by the earlier group (Chart 4.4) began with L- δ -nitronorvaline [NO₂-(CH₂)₃-CH(NH-CO)-], a masked form of the required ornithine component, and its condensation with the dipeptide, Gly-Gly. The linear hexapeptide was assembled Gly-(L- δ -nitronorval)₃-Gly-Gly-OCH₃ by the mixed anhydride method using *t*-butyloxycarbonyl amine protection. Cyclization of the resulting hexapeptide

was carried out via the active ester, *p*-nitrophenyl, derived by carbonate mediated hydrolysis of the methyl ester precursor and reesterification. Final modifications required reduction of the nitronorvaline residues to the ornithine hydroxylamines and acetylation. An alternate coupling strategy to the linear hexapeptide stage was also carried out to confirm the optical integrity of the deferriligand.

The second group employed a similar synthetic strategy except they employed δ -*N*-tosyl- δ -*N*-benzyloxy-L-ornithine, previously utilized in their rhodotorulic acid synthesis, instead of the nitronorvaline. Amino acid coupling (~80% yields) and cyclization of the linear hexapeptide (41% yield) were carried out with dicyclohexylcarbodiimide/*N*-hydroxy succinimide. Acid-catalyzed detosylation (36% HBr/AcOH/PhOH) followed by acetylation (Ac₂O, py) and catalytic hydrogenation afforded deferriferriochrome in 47% yield.

The mycobactins, isolated from various *Mycobacteria*, are a large group of rather unique siderophores. Iron is bound unsymmetrically with two different hydroxamate ligands and an *o*-hydroxyphenyl isoxazoline; thus, strictly speaking, they are not trihydroxamate siderophores. Incorporating six centers of asymmetry and combinations of five different substituents, these complex ligands have not as yet been synthesized.

The syntheses of several ferrioxamines have been reported by Prelog¹²² and Keller-Schierlein.¹²³ An example of this chemistry is the synthesis of ferrioxamine B [Desferal minus Fe(III)] depicted in Chart 4.5. Beginning with 1-benzyl-

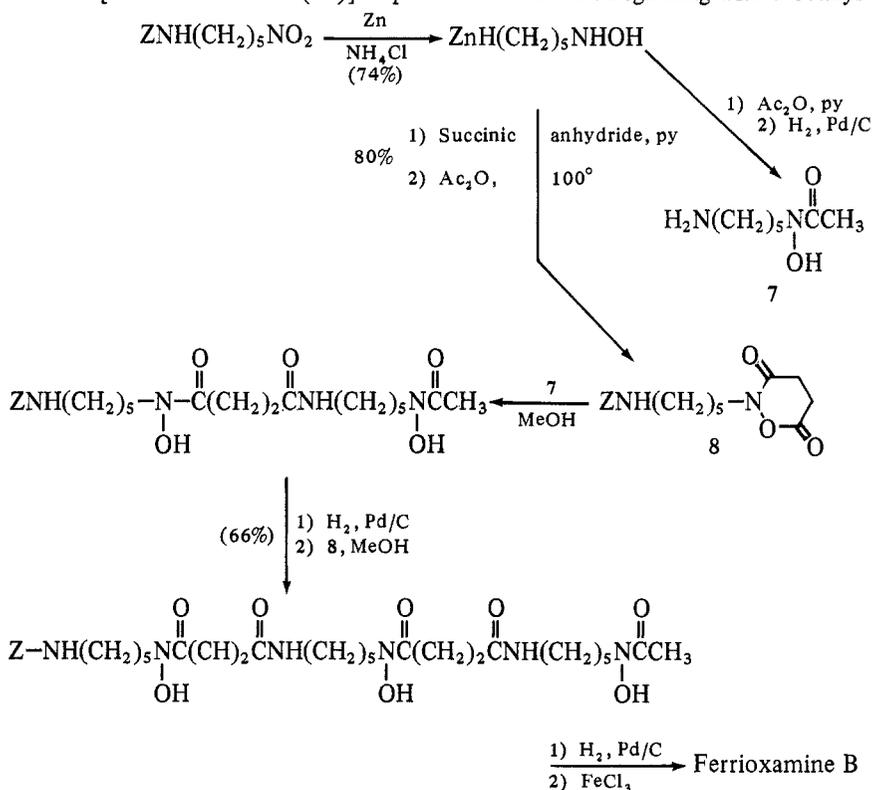
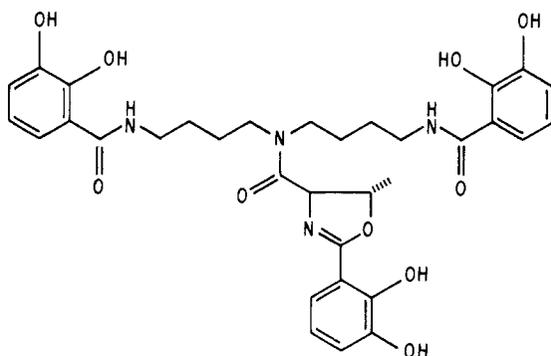

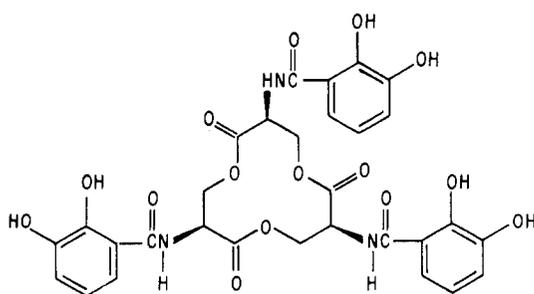
oxycarbonylamino-5-nitropentane, the ϵ -amino-protected hydroxylamine was generated by a zinc reduction. The novel use of succinylation followed by cyclodehydration yielded the internal active ester **8** with the necessary two new carbons. This could be condensed with **7** to give the 15-carbon fragment. Alternatively, condensation with 1-nitropentylamine followed by zinc reduction and acetylation yielded the same intermediate. Reuse of this 15-carbon intermediate in condensation with **8** yielded the benzyloxycarbonyldeferrri ligand. Hydrogenolysis and the introduction of iron(III) gave ferrioxamine B.

B. Catechols

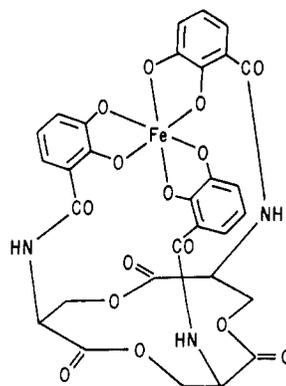
The catechol or dihydroxybenzoyl is a much smaller class^{76d} of natural siderophores than the hydroxamates, and examples to date are 2,3-dihydroxybenzoylglycine (*Bacillus subtilis*)¹⁰⁰, 2-*N*,6-*N*-di-(2,3-dihydroxybenzoyl)-L-lysine (*Azotobacter vinelandii*)¹⁰¹, 2,3-dihydroxybenzoyl derivative of spermidine¹²⁴, agrobactin²³⁶, and enterobactin.

Enterobactin (or enterochelin), isolated from, and characterized as the main iron-transporting species of, *E. coli*,¹⁰² *S. typhimurium*,¹⁰³ and *A. aerogenes*^{76d} is a cyclic trimer of 2,3-dihydroxy-*N*-benzoyl-L-serine. One molecule of enterobactin binds one Fe(III) to give a red complex with a binding constant (52) that is greater than the hydroxamates.¹⁰⁷ Its biosynthesis incorporates the elements of aromatic biosynthesis to give the 2,3-dihydroxybenzoyl grouping through the chorismic acid-iso chorismic acid pathway, as well as the peptide derivation from L-serine.

Enterobactin has been recently synthesized by Corey and Bhattacharyya.¹⁰⁴ Beginning with *N*-benzyloxycarbonyl-L-serine, **1** (Chart 4.6), the hydroxyl was protected as the THP-ether which required, in turn, a carboxyl protection step via the phenacyl ester. Coupling of the deprotected serine residue with **2** was accomplished using the active imidazole thioester. Reductive removal of the phenacyl ester and repetition of this coupling process yielded the linear triester

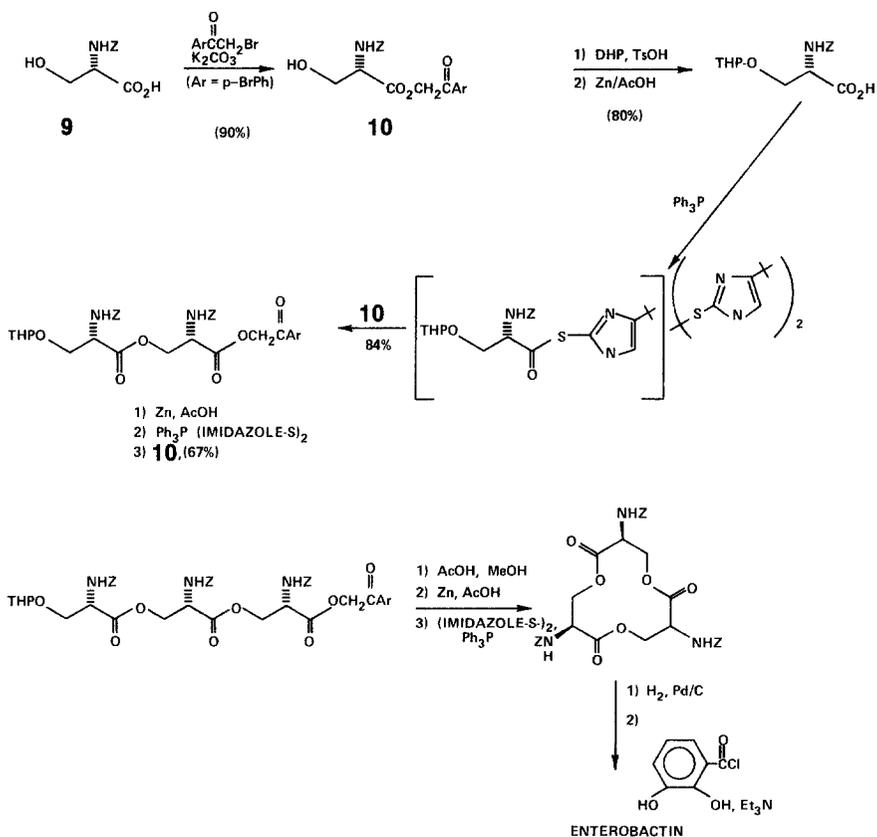
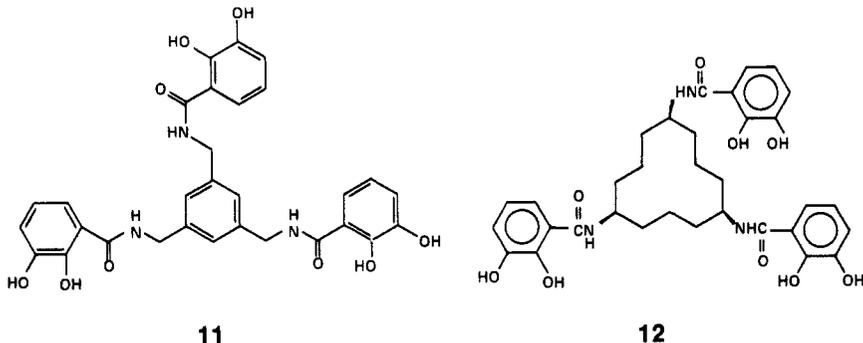

in 45% overall yield from **1**. Cyclization was carried out with the same active thioester procedure in 40% yield after deprotection of the termini (75%). Finally, removal of the *N*-benzyloxycarbonyl groups and replacement with the required 2,3-dihydroxybenzoyl groups¹²⁵ gave the target molecule in unspecified yield.

The severe anemia (Cooley's anemia) associated with the genetic disease β -thalassemia major can only be treated by transfusion therapy. This leads to an iron-overload state, secondary hemochromatosis, since the body retains most of the iron from transfused erythrocytes. Attempts to prevent excessive iron accumulation have involved the use of such siderophores as desferrioxamine (Desferol), rhodotorulic acid, and 2,3-dihydroxybenzoic acid.¹⁰⁸ However, because of several drawbacks with these agents, efforts are underway to synthesize enterobactin mimics. One example is the report of the synthesis and examination of **11** as an isosteric equivalent.¹⁰⁵ This was prepared from 1,3,5-benzenetrialdoxime, generated from the corresponding tri(methyl)carboxylate by diisobutylaluminum hydride reduction, pyridinium chlorochromate oxidation back to the aldehyde stage, and condensation with hydroxylamine. The benzenetrialdoxime was reduced to the tribenzylamine and subsequently benzoylated to give **11**. Binding experiments confirm an iron affinity in the range of enterobactin.



Corey and Hurt have synthesized a carbocyclic enterobactin analog, **12**. Not only was the question relating to iron complexation addressed with this analog, but also the question of the possibility of ester hydrolysis of the cyclic triester, enterobactin, was asked as it relates to a mechanism of iron dissociation after the complex passes into the microorganism. Obviously this mechanism is not possible with **12**.

Chart 4.7 depicts the preparation of this analog.¹⁰⁶ The all-*cis*-cyclodecan-1,5,9-triol, prepared from all-*trans*-cyclodecatriene,¹⁰⁹ was converted to the all-*cis*-triamino analog. Similar chemistry was previously documented by Collins et al.¹¹⁰ Acylation with the protected 2,3-dihydroxybenzoyl chloride, itself pre-

pared from catechol, afforded the desired **12** after acid hydrolysis of the acetanilides. This carbocyclic analog exhibited approximately 75% of the bacterial iron-transporting capacity of enterobactin.

Raymond and co-workers have also recently reported a synthesis of **11**¹¹¹, analogous to that previously described, as well as a preparation of the trisdi-hydroxybenzoyl spermidine derivative **13** (Chart 4.8).¹²¹ Tosylation of spermidine afforded the tritosyl amide (84%), which was converted to the cyclic triamine via alkylation of the terminal dianion (NaH/DMF; 76%) with 1,3-ditosylpropane. Deprotection with concentrated sulfuric acid (100°, 40 h), benzoylation with 2,3-dioxomethylene benzoyl chloride, and unmasking of the catechol (BCl₃, CH₂Cl₂) gave the hexadentate spermidine catechololate ligand **13** (30%).

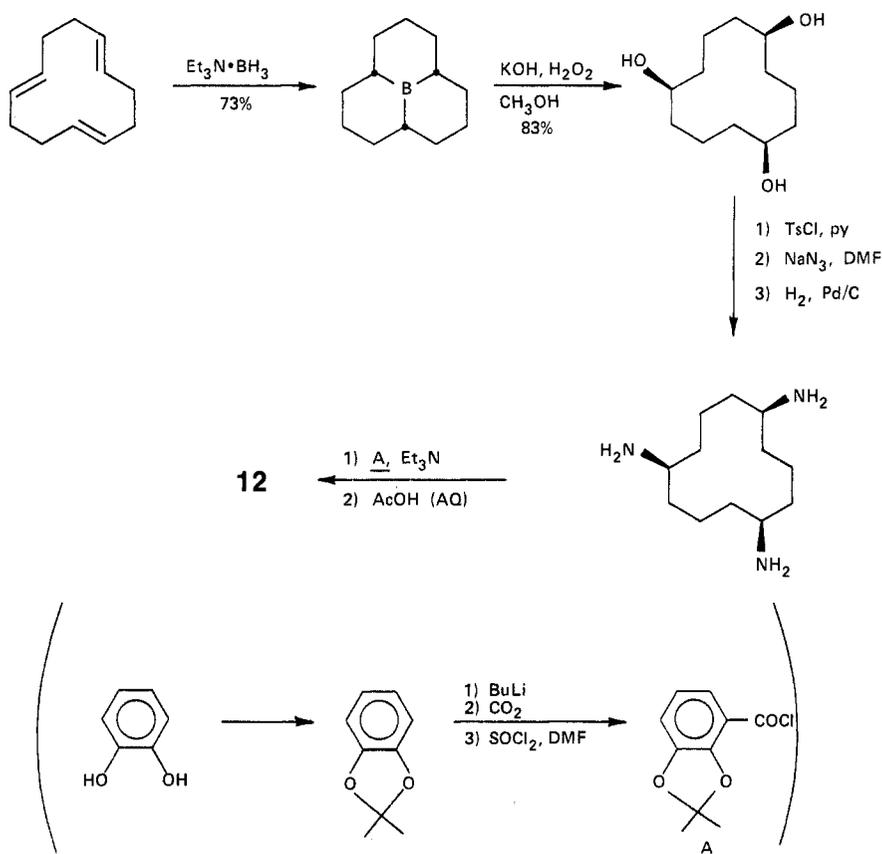

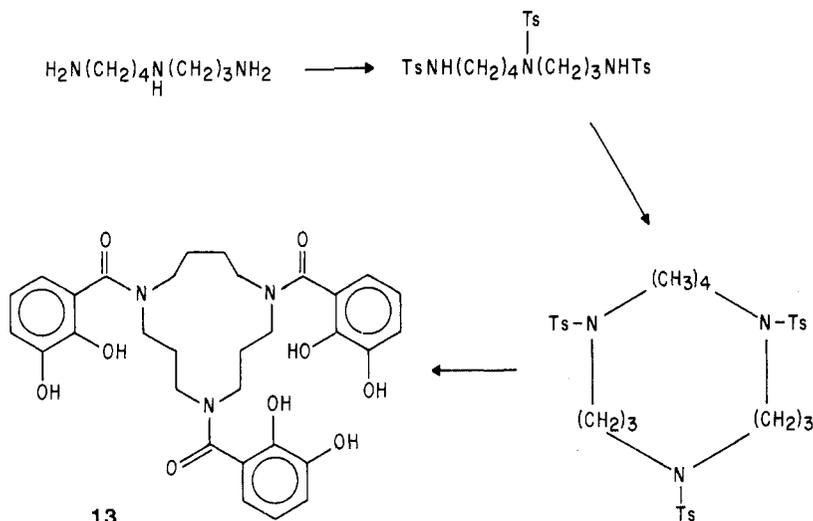

5. OXYMACROCYLES

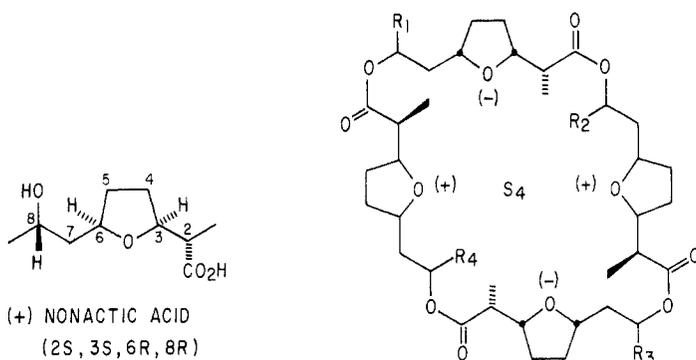
This somewhat nondescript title for molecular classification is in fact distinguished by only three structures in the ionophore domain thus far: the macrotetrolides, the synthetic crown ethers, and a macrocyclic dilactone (boromycin). Since the crown ethers share many common properties with the naturally occurring macrotetrolides, we will consider them as synthetic analogs thereof, although they were not originally prepared for that reason.

A. Macrotetrolides

This group of macrotetrolide antibiotics, of which several are represented by the structure below, was originally isolated from various actinomycetes and structures were elucidated as 32-membered macrocyclic tetraesters (cyclodepsides).¹¹³ Nonactin was isolated in 1955 as the original member of the actin family.¹¹² The compounds exhibit antimicrobial activity (G+, fungi), which increases with increasing length of R, and good insecticidal activity against mites.^{114, 115}

The actins afford one to one complexes with many alkali/alkaline earth metal ions. Specifically, nonactin exhibits a selectivity sequence of $\text{NH}_4^+ > \text{K}^+ \approx \text{Rb}^+ > \text{Cs}^+ > \text{Na}^+ > \text{Ba}^{2+}$.¹¹⁶ The K/Na selectivity is between that observed for valinomycin and the enniatins. The first crystal structure of an ionophore-metal complex was that of the nonactin-potassium thiocyanate complex.¹¹⁷ The

potassium is completely dehydrated with its coordination sphere comprised of the four tetrahydrofuran oxygens and the four ester carbonyl oxygens. This arrangement creates an overall "tennis ball seam" configuration of the carbon framework as it wraps around the metal.

Nonactin is composed of four nonactic acid units with overall *meso* configuration due to the alternating sequence of (+) and (-) nonactic acid diastereomers. Four groups have independently reported syntheses of the basic nonactic acid unit, two of whom have converted the monomer into the cyclic tetramer, nonactin.

Gerlach and co-workers investigated¹¹⁸ two different routes to the nonactic acid building block (Chart 5.1). In the first approach 2-acetylthiofuran was functionalized electrophilically at the 5-position employing chemistry introduced by Eschenmoser et al.¹¹⁹ with *N*-cyclohexyl-*N*-propenylnitrosonium ion. Hydrolysis afforded the 2,5-disubstituted furan with all the required carbons for nonactic acid. After oxidation, the required *cis*-disubstituted tetrahydrofuran was obtained by catalytic hydrogenation over rhodium (palladium affords *cis/trans* mixtures). Sodium borohydride reduction yielded mostly the 8-epinonactic acid.

An alternative approach involved the early establishment of the desired relative stereochemistry at C-6 and C-8 (Chart 5.2). The desired *threo*-1-octen-5,7-diol, generated by terminal alkylation of the dianion of acetylacetone followed by reduction and chromatographic separation, was acetylated and ozonized. Horner-Wittig reaction on the resultant aldehyde afforded an isomeric mixture

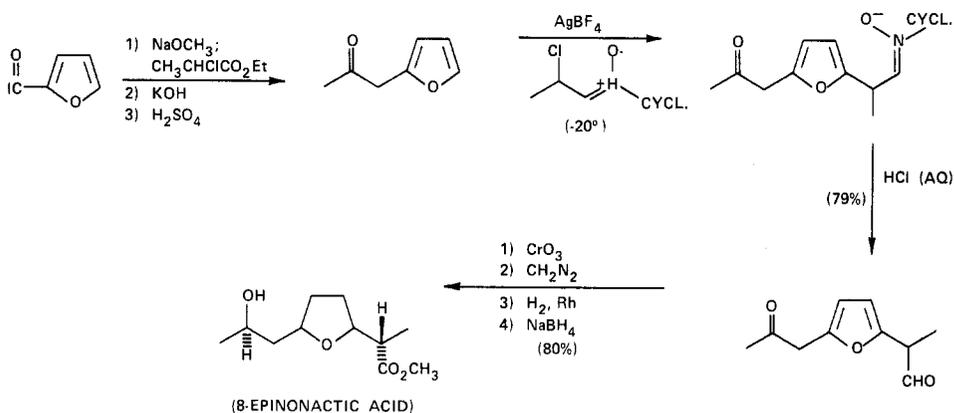

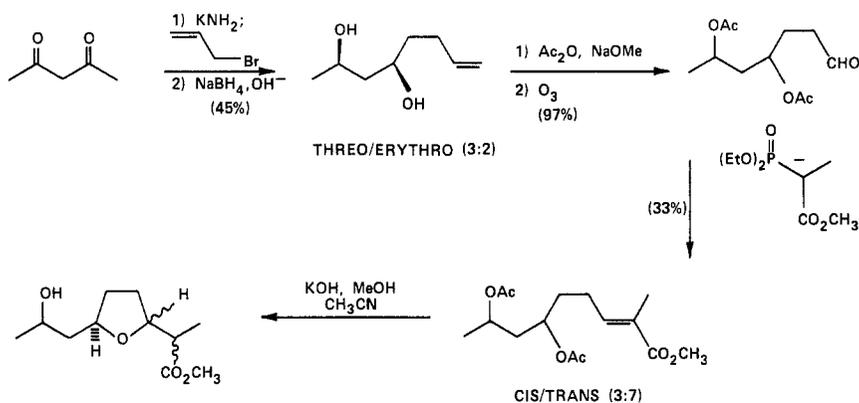

of α,β -unsaturated esters. Base-catalyzed cyclization produced the methyl ester of nonactic acid as the main product (60%).

The "oligomerization" of nonactic acid into the linear tetraester, **6** (Chart 5.3), was accomplished through mixed anhydride methodology. Appropriately protected monomers, **1** and **2**, were prepared by transesterification of the *t*-butyl ester (**1**), and monobenzylation of the dianion to the 8-*O*-benzyl-2. Coupling was achieved with trimethylbenzenesulfonyl chloride in pyridine in good yield. The selective removal of benzyl on a portion of substrate **3** afforded the deprotected diester, **5**, and acid hydrolysis on the remainder of **3** yielded the acid **4**. Coupling and final deprotection gave the penultimate, isolated intermediate, **6**. This linear tetramer was cyclized by the pyridyl thioester method¹²⁶ employing triphenyl-

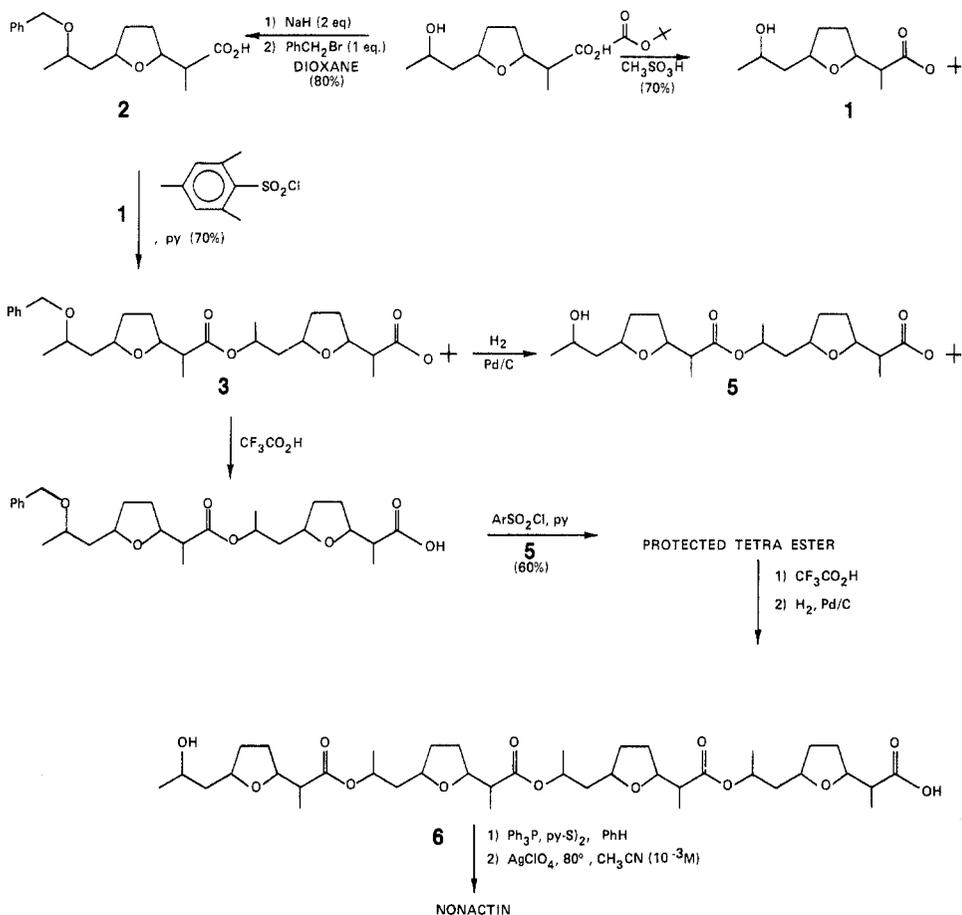
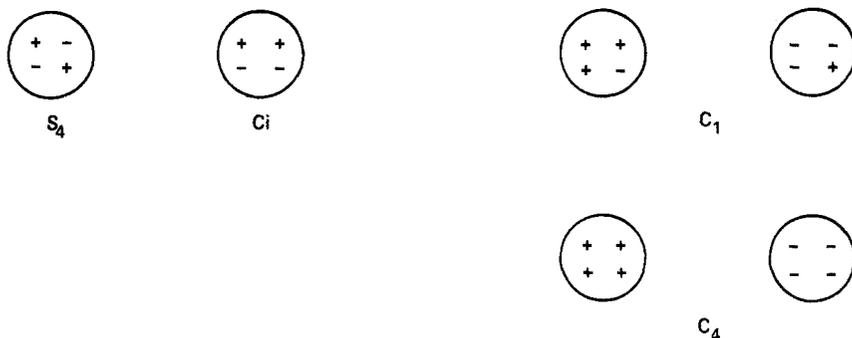

phosphine/dipyridyl disulfide¹²⁷. The thioester intermediate was cyclized with Ag(I) assistance. Since the synthesis was carried out with *rac*nonactic acid, four possible cyclic configurations are possible. Two *meso* forms, the natural configuration with S₄ symmetry as well as C_i, and the enantiomeric pairs with C₁ and C₄ symmetry. Only three of the four possible were isolated and separated chromatographically (40% yield) in 1:5:2 relative proportions. The last component represented authentic nonactin as determined by physical, biological, and spectral properties. The authors assigned the C_i configuration to the initial component and C₁ symmetry to the major isomer, employing primarily NMR characteristics.



The initial synthesis of the nonactic acid diastereomers was carried out by Beck and Henseleit¹²⁸ in 1971. Alkylation of 2-methoxycarbonylmethyl furan with methyl iodide gave the α -methyl derivative in 60% yield (Chart 5.4). The C_7 - C_9 -alcohol fragment was introduced via a Friedel-Crafts alkylation of 2-methylbut-1-en-3-one. After reduction to the *cis*-tetrahydrofuran, this five-carbon fragment was truncated to the required three-carbon group employing Baeyer-Villiger oxidation of the methyl ketone. Hydrolysis afforded the diastereomeric nonactic acids in an overall five-step synthesis.

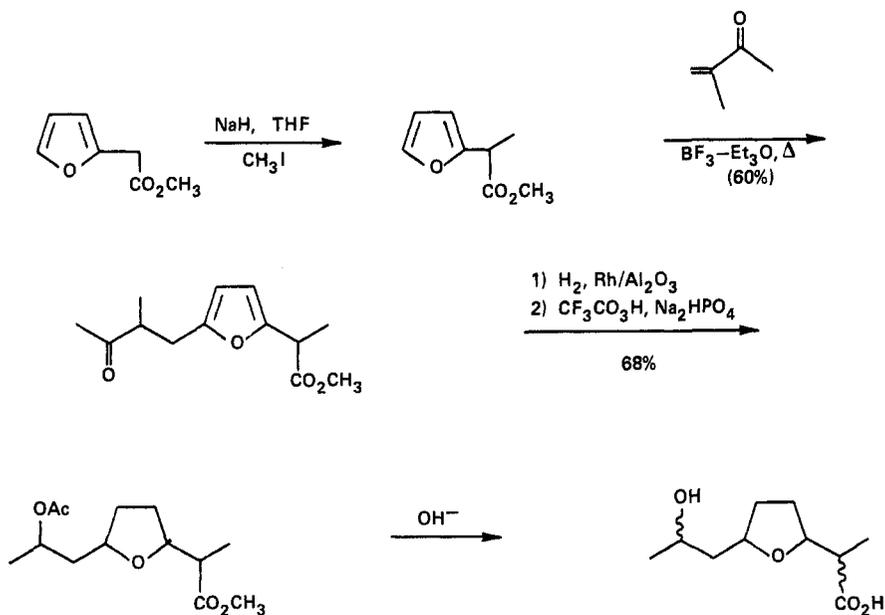

Schmidt and co-workers¹²⁹ have also prepared nonactic acid and carried it on to the cyclic tetraester (Chart 5.5). The reaction of 2-lithiofuran with propylene oxide affords the expected secondary alcohol. The introduction of the three-carbon carboxylic acid unit begins with a Vilsmeier formylation. A Wittig reaction followed by a Rh(III) catalyzed carbonylation completes the assembly. Silver(I)oxide-mediated oxidation to the required acid followed by hydrogenation produces nonactic acid. If (-)-propylene oxide is employed [from (+)-lactic acid], the 8-epimonactic acid is obtained, which can be cyclized to the (+)-nonactic acid by an efficient inversion at C-8 with potassium acetate (DMSO) displacement of the 8-tosylate.

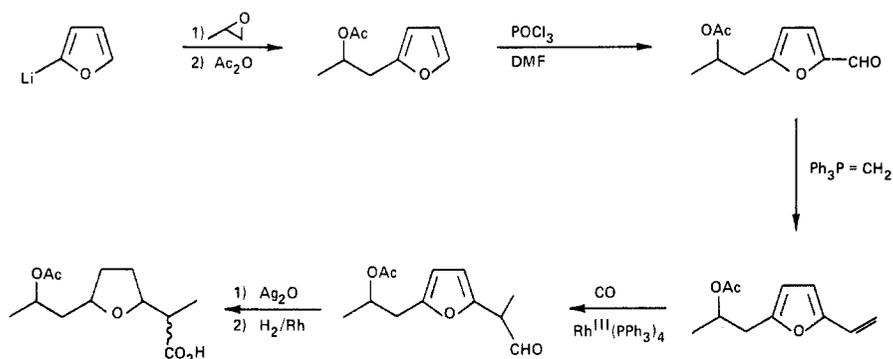

The synthesis of nonactin was completed by coupling potassium (-)-nonactinate with the 8-epitosylate of (+)-nonactic acid benzyl ester (70% yield) to produce (-)-nonactinyl-(+)-nonactic acid benzyl ester (1). The other "diester," 8-epi(-)-nonactinyl-(+)-nonactic acid benzyl ester (2), was similarly prepared. Hydrogenolysis of 1, conversion to the potassium salt with KHCO₃, and reaction with the 8-tosylate of 2 afforded the linear tetraester [(-)•(+)-(-)•(+)-benzyl ester]. Hydrogenolytic deprotection and cyclization with the conditions employed by Gerlach (20%) yielded natural nonactin.

White and coworkers¹³⁰ reported two approaches to racemic nonactic acid (Chart 5.6). Acylation of 1-(2-furyl)-2-propanol, derived via the same chemistry as the Schmidt approach, produced the desired 2,5-disubstituted furan. The incorporation of the last carbon (2-carboxyl) was accomplished via a Wittig reaction and the correct oxidation state by diborane followed by a Jones oxidation. Reduction with lithium tri(*sec*-butyl)borohydride yielded primarily the 8-epinonactic acid, which could be inverted at C-8 with the Mitsunobu reaction.

All the approaches to nonactic acid described thus far have utilized the rhodium-catalyzed hydrogenation of furan to derive the necessary *cis*-2,5-disubsti-

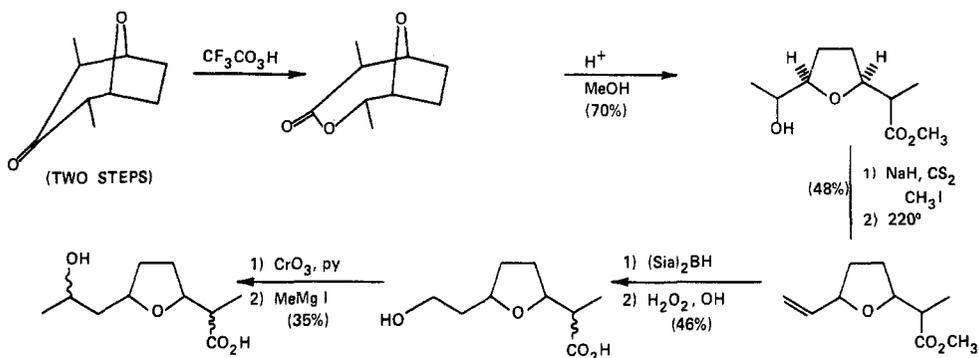
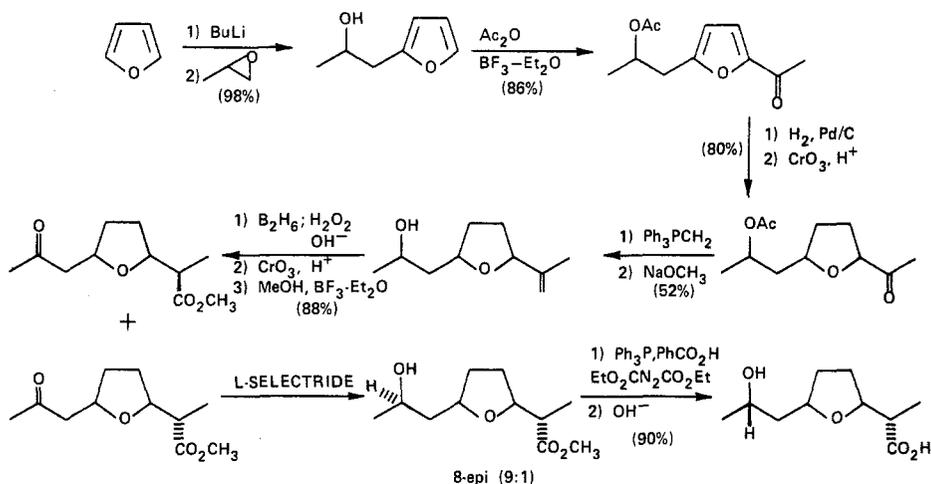

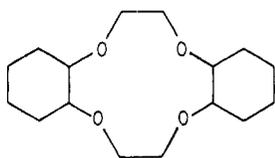
tuted tetrahydrofuran. The second approach by White et al. derives the *cis*-tetrahydrofuran via preincorporation into a bicyclic structure. Employing the chemistry developed separately by Noyori and Hoffman, 2,5-dibromo-3-pentanone was cyclo-added to furan (Zn/Cu). After hydrogenation of the remaining double bond the *cis*-2,5-disubstituted tetrahydrofuran was liberated from the (3.2.1)-bicyclooxipane by a Baeyer-Villiger oxidation followed by a methanolysis. In contrast to the former approach, this route now required the elaboration of the hydroxyl side chain with an extra carbon. Pyrolysis of the methyl xanthate followed by hydroboration with diisoamyl borane yielded the primary alcohol, which had unfortunately lost configurational fidelity at C-2 during this

operation. Collins oxidation followed by a Grignard on the resultant aldehyde gave the diastereomeric nonactic acids.

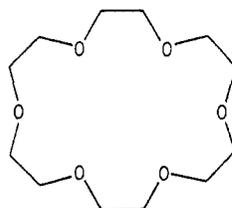
B. Crown Ethers

Cyclic polyethers, or crown ethers, and macrobicyclic polyethers, or cryptands, in a general sense resemble the macrotetrolides in their complexing capabilities. In many cases through the precise tailoring of the cavity size to cation diameter the stability of metal-crown complexes surpasses that of the natural ionophores. This is even more apparent with the three-dimensional ligand cryptands. Because of these aspects the crown ethers and cryptands are superb complexation-solubilization agents of a metal cation in an organic phase, but are poor transport agents¹³⁹ because of high binding constants due to the lack of a stepwise-low energy pathway for the decomplexation process,^{131a} a feature also in common with siderophores.

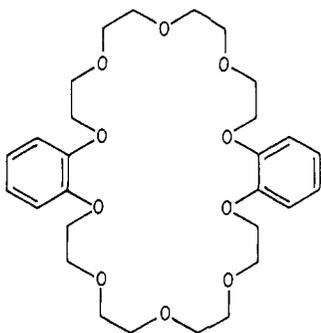
Several examples of crown ethers and cryptands are depicted below. The pioneering work of Pederson reported in 1967 first opened up this extremely interesting area. Most of the synthetic operations employed for assembling the cyclic ethers involved modified Williamson ether syntheses. Many cyclization



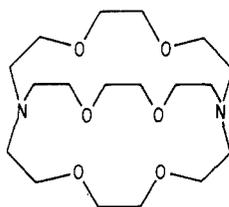

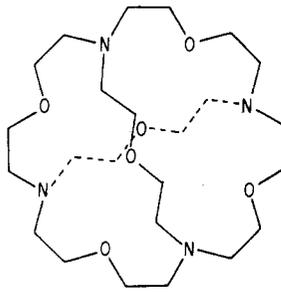


yields are remarkably high with the appropriate choice of the counter metal cation, presumably through a "template" effect. Since most of this work has been reviewed we will not incorporate it here.^{3,131-136} Dicyclohexyl-12-crown-4 indicates a complexation preference of $\text{Na} > \text{K}$ whereas the larger dicyclohexyl-18-crown-6 is more selective for potassium ($\text{K} > \text{Rb} > \text{NH}_4 > \text{Na} \sim \text{Li}$)^{131,137}. The concept of chiral crown ethers, such as the binaphthyl-18-crown-6, as resolving agents for amino acids and chiral catalysts for asymmetric synthesis,¹⁴⁰ has been notably exploited by Cram's group,¹⁴¹ Stoddart and co-workers,¹⁴² and others.¹⁴³

Although having investigated the properties of some crown ethers,¹³⁸ Lehn and colleagues have been primarily responsible for fashioning the interesting bicyclic ligands, the cryptands.¹⁴⁴ With the tertiary nitrogen as the focal point of the three-dimensional array of ligands, the synthetic chemistry involves amide bond formation to this incipient amide nitrogen followed by reduction to the amine. Also prepared have been the cylindrical and spherical molecular cryptands 7 and 8. These represent excellent topology for binuclear cryptates in the cylindrical case and complete envelopment in the spherical case yielding activation energies for dissociation > 16 kcal/mol. The bicyclo-2,2,2-cryptand exhibits a selectively ordering of $\text{K} > \text{Rb} > \text{Na} > \text{Cs} > \text{Li}$.



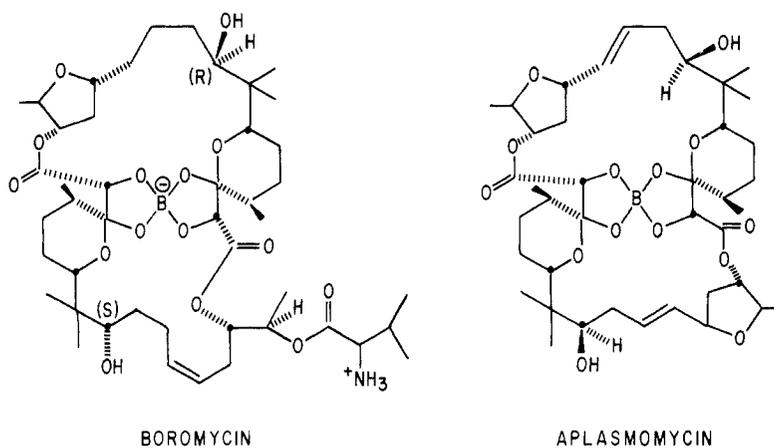

C. Boromycin

In 1971 Dunitz et al. reported the structure of the first boron-containing natural product,¹⁹⁰ boromycin. Isolated from *Streptomyces antibioticus*,¹⁹² its structure was established by X-ray crystallography of the Rb^+ salt of the compound after the removal of D-valine. Boromycin forms a cup-shaped ligand around the rubidium with interactions with the two hydroxyls as well as the three ether oxygens of the tetrahydrofuran/pyrans and the valine esterified oxygen. Boromycin is a monovalent ionophore which induces K^+ loss from cells¹⁹³ and induces a cortical granule discharge in hamster eggs to prevent spermatozoa binding.¹⁹⁴ It also exhibits G⁺ antibacterial and antifungal activity.



A closely related dilactone from a marine isolate belonging to *Streptomyces griseus* was recently identified. Named aplasmomycin,¹⁹¹ since it exhibited *in vivo* antiplasmodium activity as well as G⁺ antibacterial activity, it is a symmetrical macrocyclic ligand encompassing boron. The structure was ascertained by X-ray crystallography of the Ag^+ salt. Coordination included the two hydroxyls as well as two oxygens of the borate and one water molecule.

An approach to a total synthesis of boromycin with its 17 asymmetric centers by White and co-workers¹⁹⁴ involves a strategy of preparing the two halves resulting from lactone bond disconnections. Specifically (Chart 5.7), the preparation of the "southwestern" unit proceeds from the morpholine enamine of isobutyraldehyde (9). After acylation, the unmasked aldehyde was protected as the dimethyl acetal and the acyl ketone was reduced and protected. Application of the tiglolate dianion, reported by Katzenellenbogen and Crumrine,¹⁹⁵ in an aldol fashion at the β -methyl of tiglic acid on the deprotected aldehyde gave 10. After hydrogenation of the double bond, 10 was converted to the δ -lactone, 11 (this was using "old" PtO_2 ; a "new" lot also removed the benzyl group). Intro-

duction of the second hydroxyl group for ultimate boronate formation, as well the adjacent macrolide lactone carbon, was achieved on the δ -lactone carbonyl by the chemistry recently reported by Meinwald and co-workers.¹⁹⁶ Condensation with the protected α -lithioglycollate followed by acetonide protection afforded **12**. This unit was subsequently elaborated to the complete carbon framework of the lower half of boromycin, **18**, through alkylation of the ketone **17**, derived via debenzylation and oxidation of **12**, with the allyl bromide **16**.

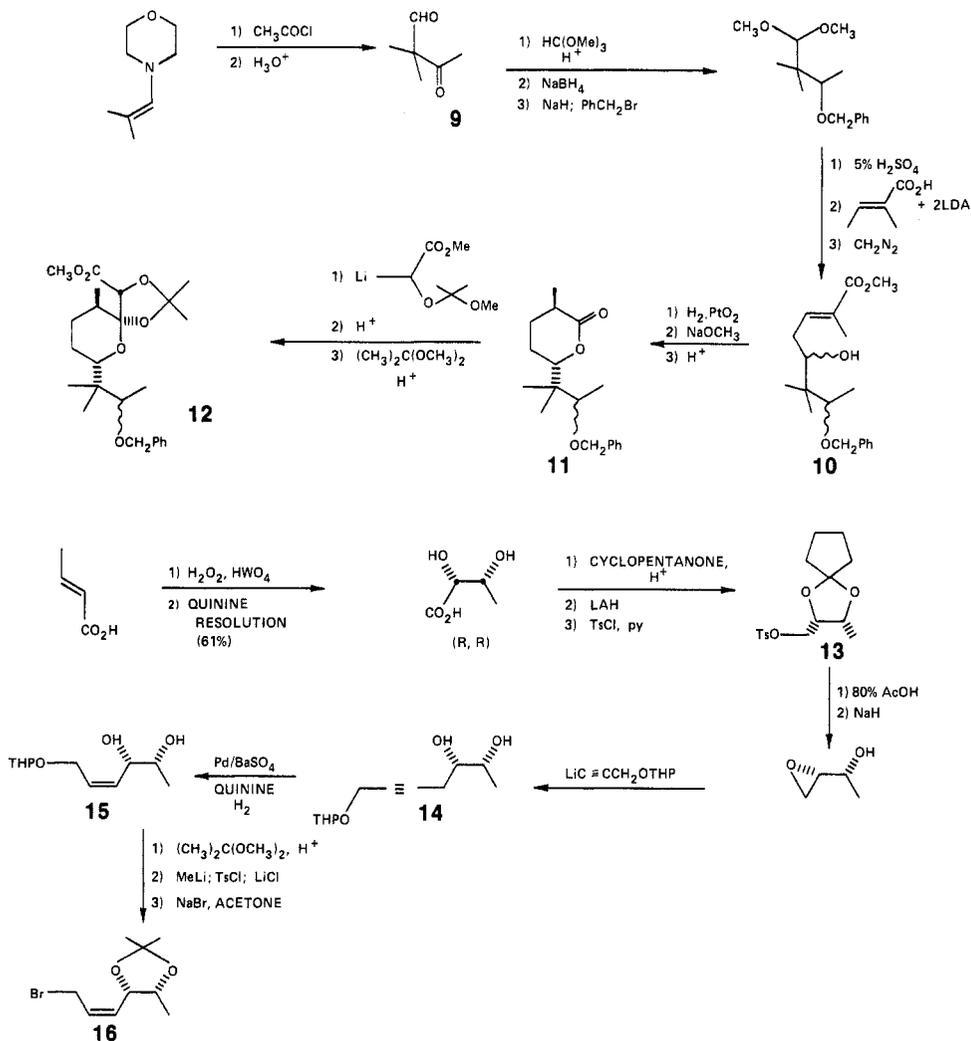

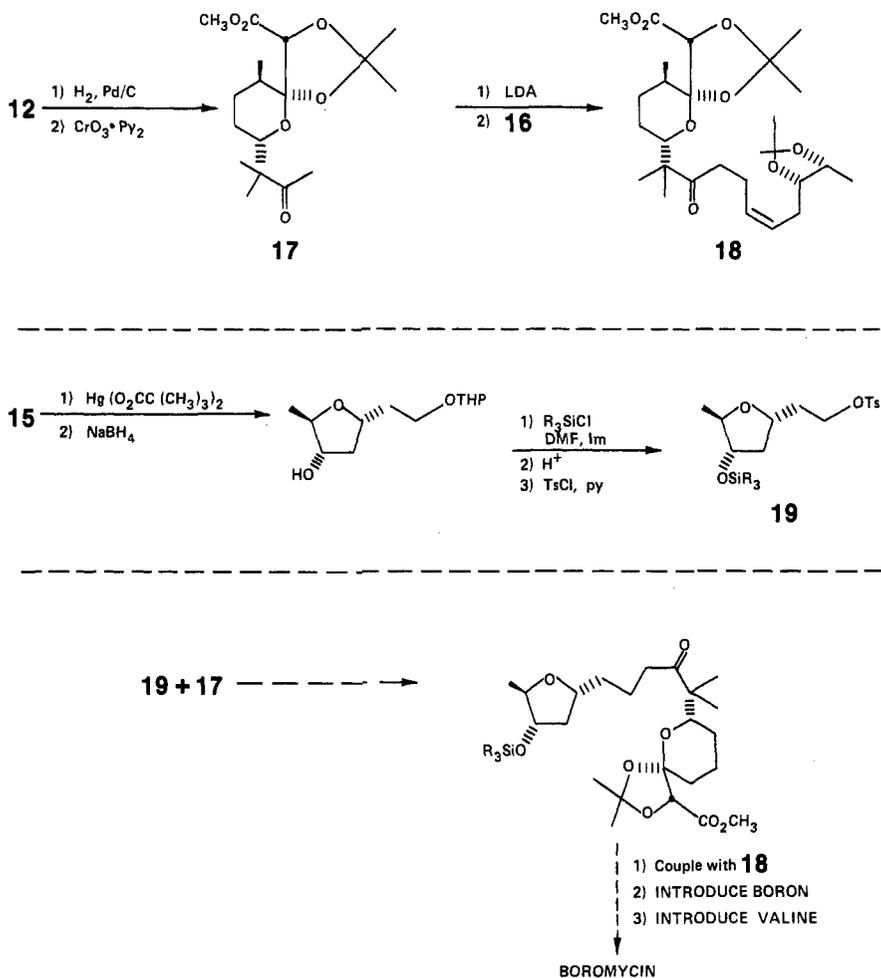
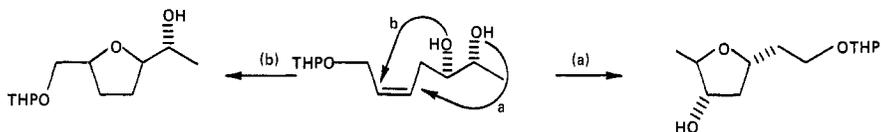

This allylic bromide, **16**, was prepared by oxidation of crotonic acid followed by quinine resolution. The *R,R*-isomer diol was protected and the acid converted to the tosylate. Acetic acid hydrolysis followed by base afforded the terminal epoxide, which was opened regioselectively with the anion of propargyl alcohol tetrahydropyranyl ether. It was noted that this regioselective epoxide opening was only successful with the adjacent hydroxyl unprotected. Limited hydrogenation afforded the *cis* olefin which was then converted to the allyl bromide **16** with standard chemistry. The synthesis of **15** actually served two purposes in that it also provided the precursor for the furan grouping (**19**) in the upper

half of boromycin. Olefin-15 could be converted to a mixture of *cis*- and *trans*-2,5-disubstituted tetrahydrofurans in 85% yield by treatment with Hg(II) followed by borohydride reduction of the organomercury. The reaction with the bulkier mercuric pivalate was more stereoselective than with the acetate of Hg(II).

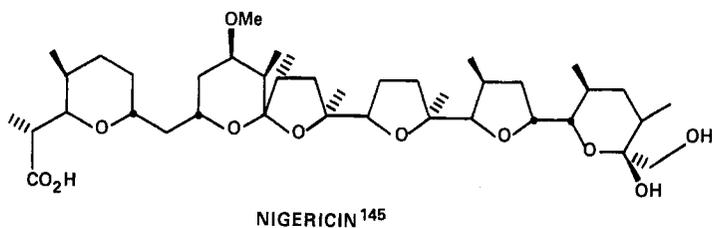


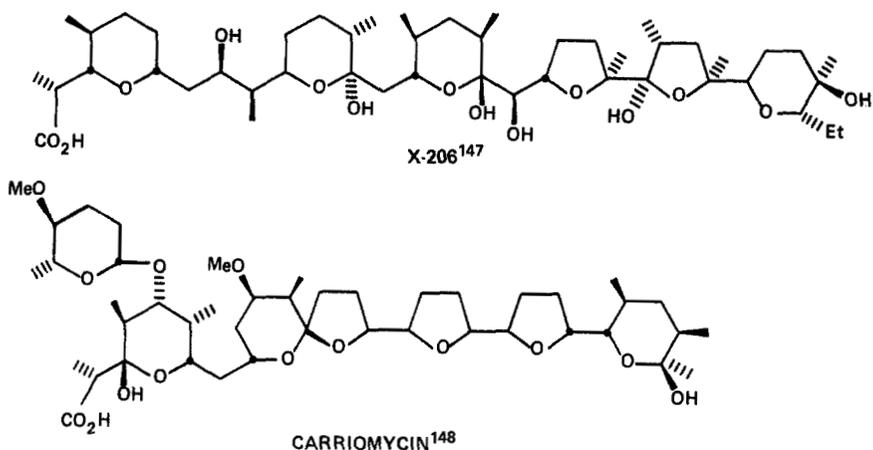
The preferred regioselectivity results from pathway a (*exo*-5-*trig*) as opposed to the alternative b pathway (*endo*-5-*trig*; disfavored). The THP-ether can be hydrolyzed and converted to the tosylate leaving group as depicted in structure 19.

The strategy for completion of the synthesis involves the alkylation of 17 with 19 to give the upper half and its subsequent coupling with the lower half, perhaps with the assistance of boronate formation.

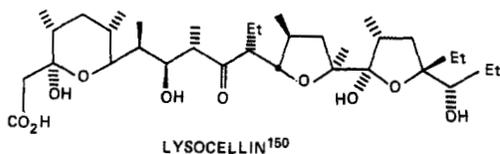
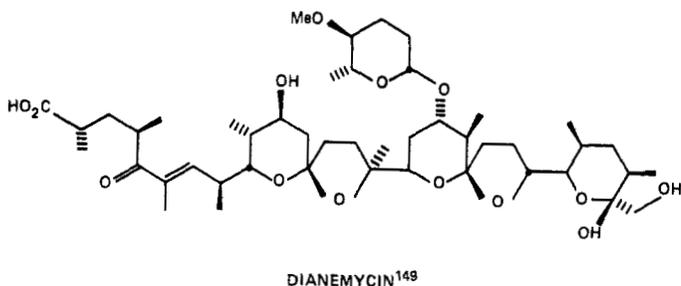
6. POLYETHER ANTIBIOTICS

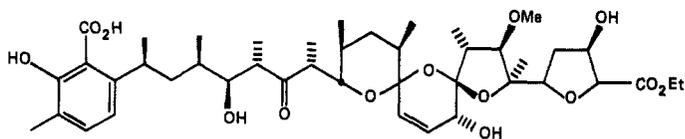
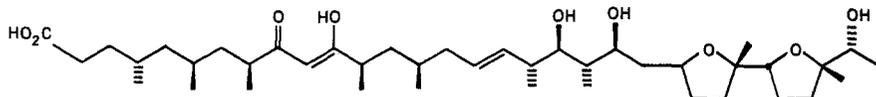
One of the most recent entries into the field of ionophores is the polyether class. Although the first example of this class was isolated as early as 1950 (nigericin), structural elucidations have only been reported in the last ten years. This most recent class of ionophores has been growing dramatically both in numbers (now over 40) and uses.





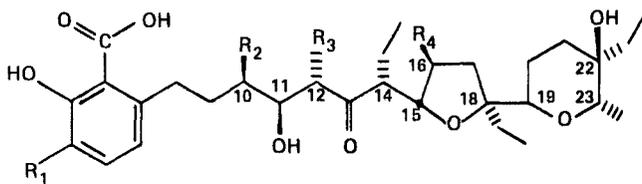
As a class they are distinguished by a linear carbon framework containing many tetrahydrofurans and pyrans, multiple centers of asymmetry, and a structure often terminating in a carboxylic acid. Several representative structures are depicted below: a more complete, though by now dated, list is given in Westley's review on polyether antibiotics (1977).⁶ Another feature distinguishing these ionophores from those discussed earlier is their excellent transport of divalent ions. In many cases these are 2:1 ligand to metal complexes. As is evident from their complex structures, the process of structure elucidation and, particularly, synthesis is difficult, and only very recently have successful synthetic approaches been completed with three representatives: lasalocid, monensin, and calcimycin.



NOBORITOMYCIN A¹⁵¹IONOMYCIN¹⁷⁵

A. Lasalocid

Coisolated with X-206 and nigericin from *Streptomyces* in 1951 by Berger¹⁵² et al., the structure of lasalocid (X-537A) was determined in 1970 by X-ray crystallography.^{153,154} Relative to the other polyether antibiotics at the time, lasalocid was the smallest and unique in that it possessed an aromatic ring. Four homologs have also been identified as minor components of the lasalocid complex (4-16%).¹⁵⁶ The X-ray structure revealed an unsymmetrical 2:1 complex (Ba^{2+}), wherein one lasalocid forms a cyclic ligand donating the carboxyl oxygen and terminal hydroxyl (tetrahydropyran) together with a molecule of water for coordination. The other lasalocid ligand employs both of these heteratoms as well as the other four "internal" oxygens for the complex. This unusual sandwich complex (with Ba^{2+}) also appears to be preferred in solution as well, as determined by NMR studies.¹⁵⁵

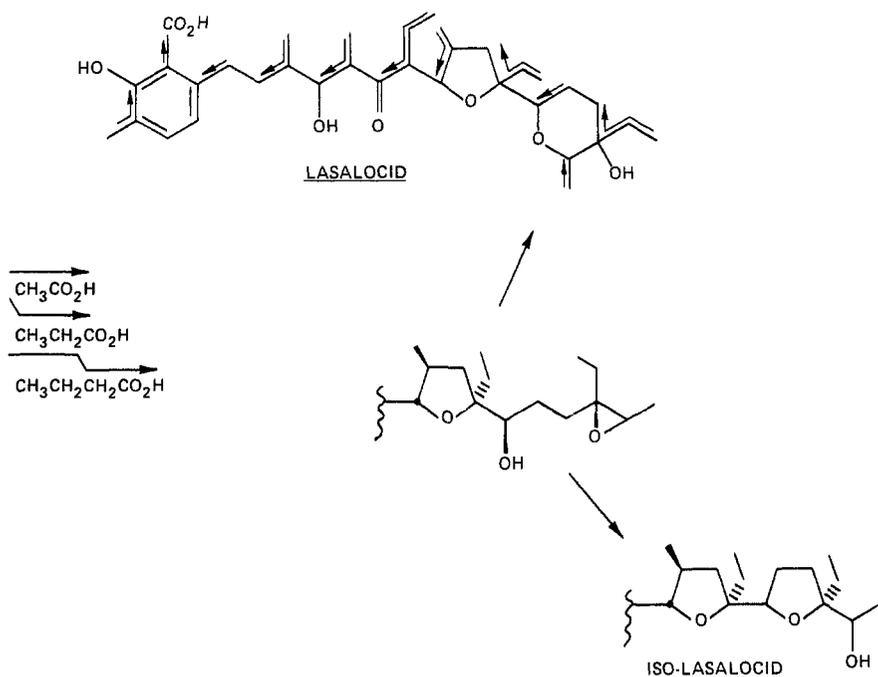

The complexes of lasalocid that have been examined (Ag^+ , Na^+ , Ba^{2+}) exhibit irregular coordination. Lasalocid is unremarkable in its ion specificity, for it complexes and transports all alkali/alkaline earth metals, lanthanides, Th(IV), and organic amines,^{29,48,157} with Cs^+ being the most preferred ($\text{Cs} > \text{Rb} \approx \text{K} > \text{Na} > \text{Li}$; $\text{Ba} > \text{Sr} > \text{Ca} > \text{Mg}$).¹⁵⁸

Biogenetically, lasalocid is derived from acetate, propionate, and butyrate in the pattern depicted below.⁶ It is speculated that isolasalocid, a co-occurring isomer, is produced by a regioselective opening of an intermediate epoxide to produce the five-membered tetrahydrofuran ring in conjunction with the six-membered tetrahydropyran of lasalocid.



Besides its antimicrobial activity, lasalocid also exhibits coccidiostat activity (for which use FDA approval has been obtained) and improved ruminant feed utilization in cattle.^{5,6} Additionally, an extensive amount of investigation has been carried out primarily by Pressman and co-workers¹⁵⁹ and, independently, Schwartz¹⁶⁰ et al. on the inotropic effects of lasalocid. Beneficial effects in stimulating myocardial contractility include a decrease in the coronary resistance and the peripheral vasculature. Initially attributed to Ca^{2+} mobilization or catecholamines, the mechanism of action now appears considerably more complex.⁴

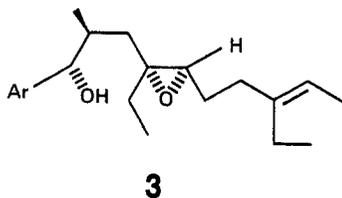
The total synthesis of lasalocid A¹⁶¹ reported in 1978 by Kishi and co-workers represents the first synthesis of a polyether antibiotic. Some synthetic work had preceded this chemistry, including mostly aromatic analogs derived from lasalocid, as well as some degradative work demonstrating a *retro*-aldol cleavage,¹⁶² the mode of final bond formation chosen by Kishi.

The synthesis began with the assembly of an appropriately substituted 1,5-diene as the substrate to form the right half (tetrahydrofuran and pyran) of the molecule. The preparation of the first 1,5-diene depicted in Chart 6.1 employed the Claisen rearrangement approach, popularized by Johnson¹⁶³ and co-workers, to *trans*-trisubstituted olefins. The initial orthoester gave a monoolefin which was converted to the second allylic alcohol and then elaborated through a second orthoester-Claisen to **1**.



In chemistry presumably similar to that employed in the Claisen rearrangement sequence to prepare it, **1** was converted to the aldehyde (Chart 6.1) and then to the phenyl ketone via a Grignard followed by a Jones oxidation. A highly stereospecific reduction with a complexed aluminum hydride recently reported by Mukaiyama et al.,¹⁶⁴ lithium aluminum hydride and 2-(*o*-toluidino-methyl)pyrrolidine, gave the alcohol shown, in a preponderance (as predicted by Cram's rule) of 10:1 over its isomer. Resolution of the 1- α -methylbenzyl urethane via HPLC gave the (-)-alcohol, **2**.

Elaboration of the trisubstituted olefins to the tetrahydrofurans was accomplished with the Sharpless epoxidation procedure to give epoxide **3**.¹⁶⁵ This



epoxide was opened with acetic acid to the tetrauran **4** as an 8:1 ratio of stereoisomers. Reepoxidation afforded the undesired epoxide of the terminal double bond, so inversion was required. Acid-catalyzed opening to the diol followed by formation of the secondary tosylate and base-catalyzed closure gave the inverted

epoxide. This was transformed with acetic acid to the ditetrahydrofuran **6**, after protection as the methoxymethyl ether, with a stereoisomer preference of 5:1.

The aromatic ring carried along thus far served as a latent α -ethyl, ethyl ketone required for the right half. Birch reduction afforded the cyclohexa-1,4-diene. This was ring-opened via epoxidation and periodate cleavage. Reduction produced bishomoallylic alcohol **7**. Conversion to alkene was accomplished via reduction of the ditosylate. Diborane followed by Jones oxidation served to introduce the ketone from the olefin.

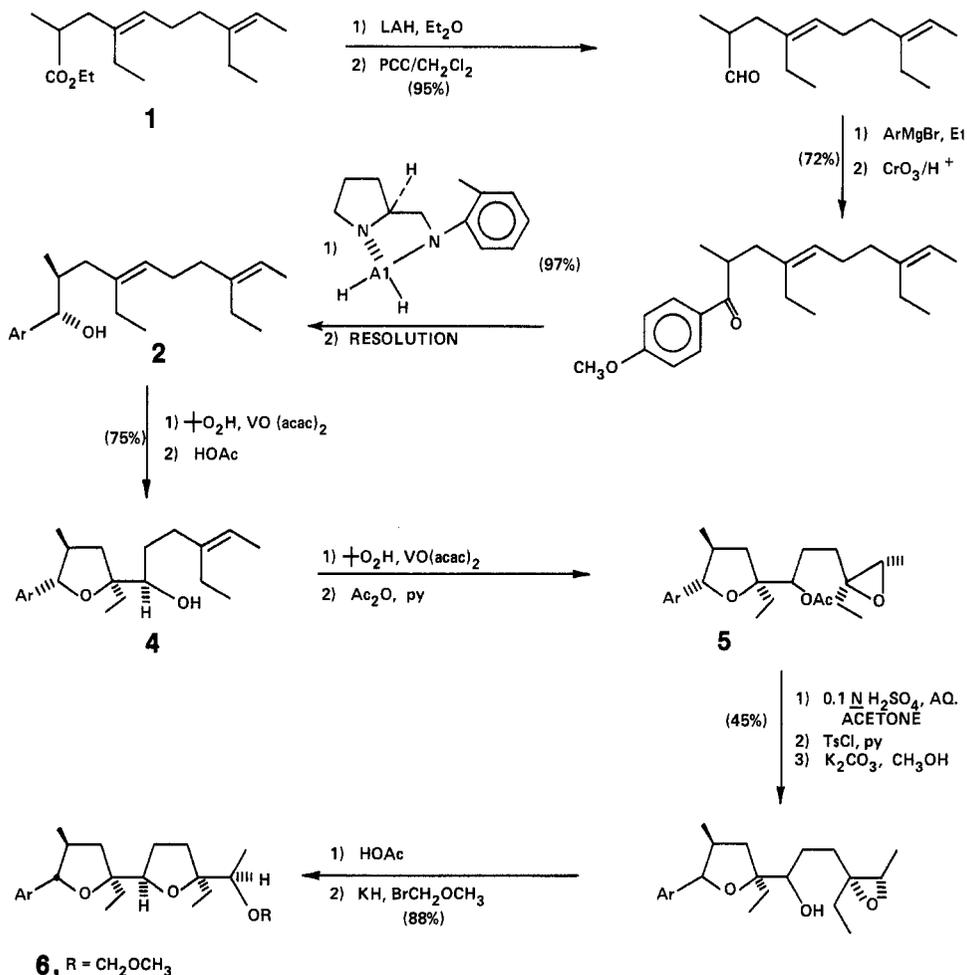


Chart 6.1. Right half of lasalocid.

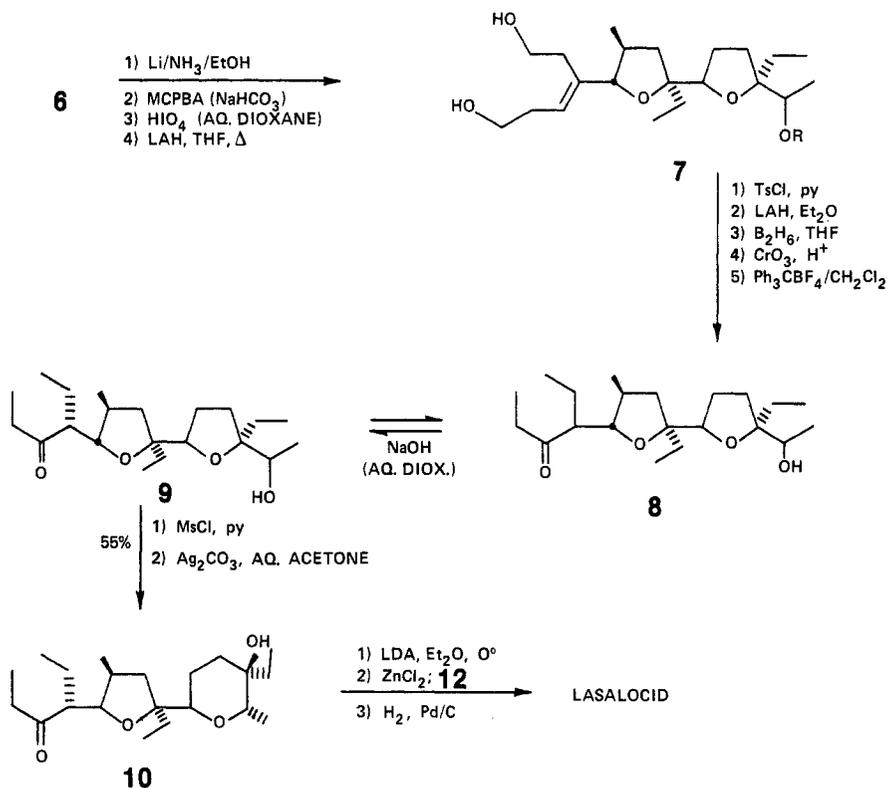

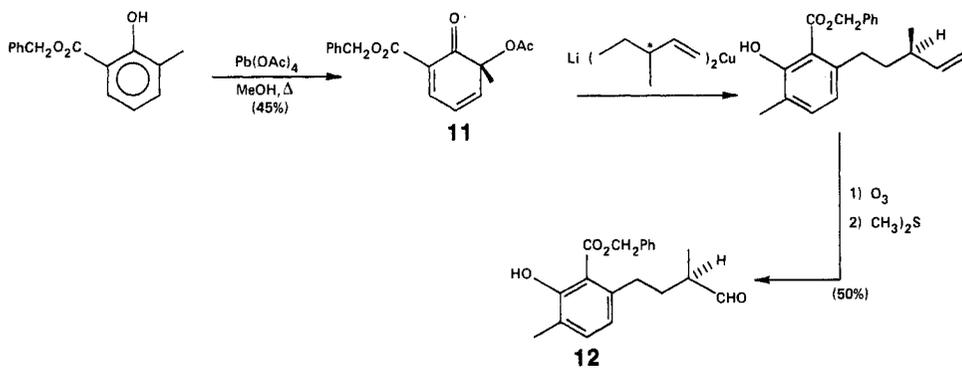
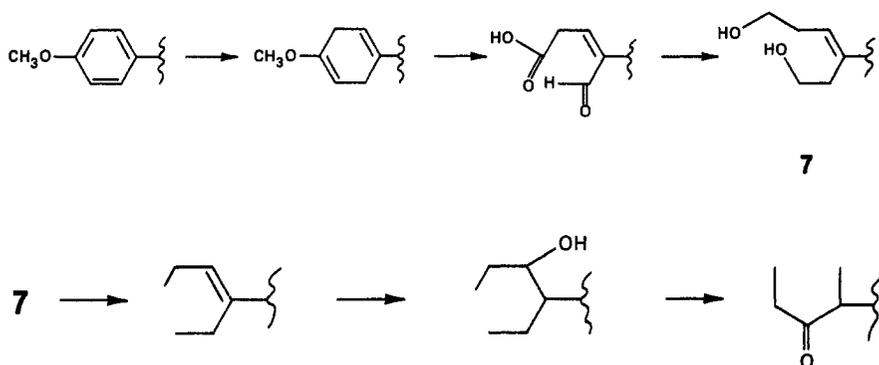


Chart 6.2. Left half of lasalocid.



Deprotection of the methoxymethyl ether with the Barton procedure afforded **8** in 13% overall yield from **6**. Ketone **8** gave a 1:1 equilibrium mixture under basic conditions with the desired isomer, **9**. Ketone **9** was shown to be identical with the right half of lasalocid, derived via a *retro*-aldol of the natural product. Silver(I) mediated solvolysis to the lasalocid series, **10**. The preparation of the salicylate right half (Chart 6.2) began with the *m*-methylsalicyclic acid, benzyl ester, which was oxidized to the cyclohexadienone, **11**.¹⁶⁶ Conjugate addition with lithium di(*l*-3-methyl-4-pentenyl) cuprate and *in situ* rearomatization followed by oxidative cleavage of the double bond yielded the left-half aldehyde, **12**, required for the final aldol bond connection with the right half, **10**.

After surveying a number of conditions, Kishi's group found that the zinc-enolate chemistry of House provided four aldol products (67% yield) in a 40:10:7:3 ratio. The major product, after debenzoylation, was identical with natural lasalocid. Better stereoselectivity was found with DME as solvent but the efficiency of condensation was much lower.

An alternate preparation of the lasalocid ketone, **8**, was concurrently reported out of Kishi's group (Chart 6.3).¹⁶⁷ Beginning with enone **13** this alternate approach served to prepare the terminal tetrahydrofuran first. After the epoxidation, reduction, and cyclization conversion of **13** to the tetrahydrofuran, **14**, it was resolved at this stage, in a manner similar to that described in Chart 6.1. Addition of the optically active Grignard to the aldehyde introduced the required carbon skeleton for the adjacent tetrahydrofuran. Ozonolysis produced the cyclic hemiacetal to which was added the magnesium enolate of 3-hexanone. Acid-catalyzed recyclization followed by debenzoylation gave **8** in a 10% overall yield, 11-step sequence from **13** (compared to 23-step-3.3% yield in the earlier approach starting from **1**).

Ireland and colleagues have embarked on a total synthesis of lasalocid A.²³¹ The overall synthetic plan is convergent at two points: the joining of the tetra-

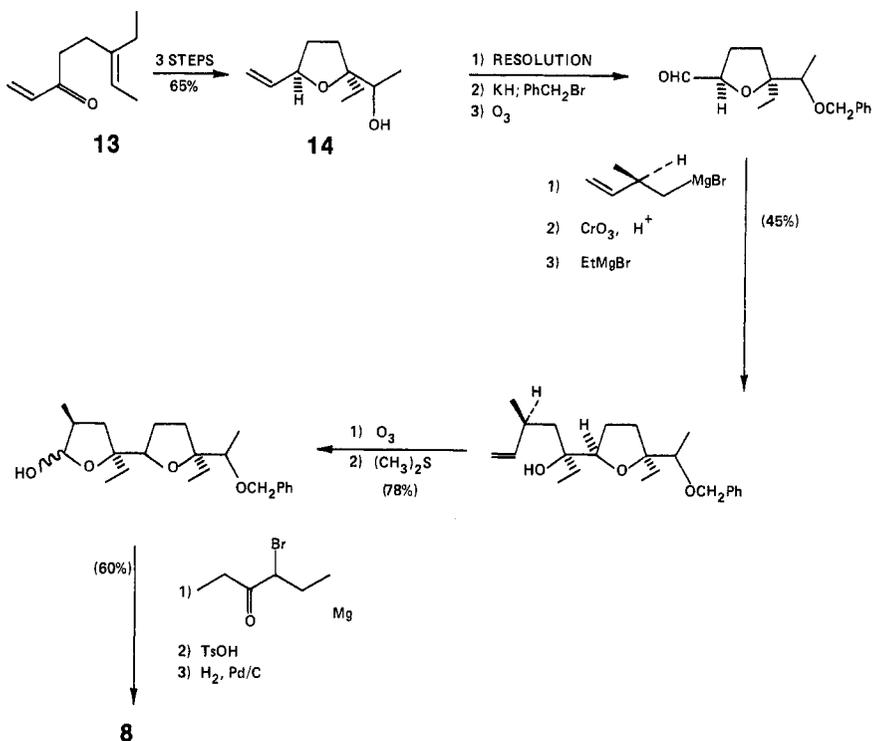
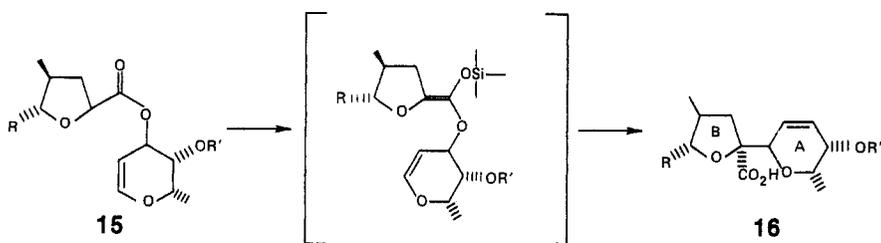

hydropyran A-ring to the tetrahydrofuran B-ring and the coupling of this assemblage to the aromatic left half. The approach relies on a stereoselective ester enolate Claisen rearrangement to accomplish the former and the precedented aldol condensation for the latter. Specifically, the tetrahydrofuran/pyran bond formation involves a Claisen rearrangement of allyl ester **15** to a stereochemically correct precursor of the A and B rings, **16**. To secure the required tetrahydrofuran/pyran building blocks in chiral form for **15**, the Ireland group utilized monosaccharide starting materials.



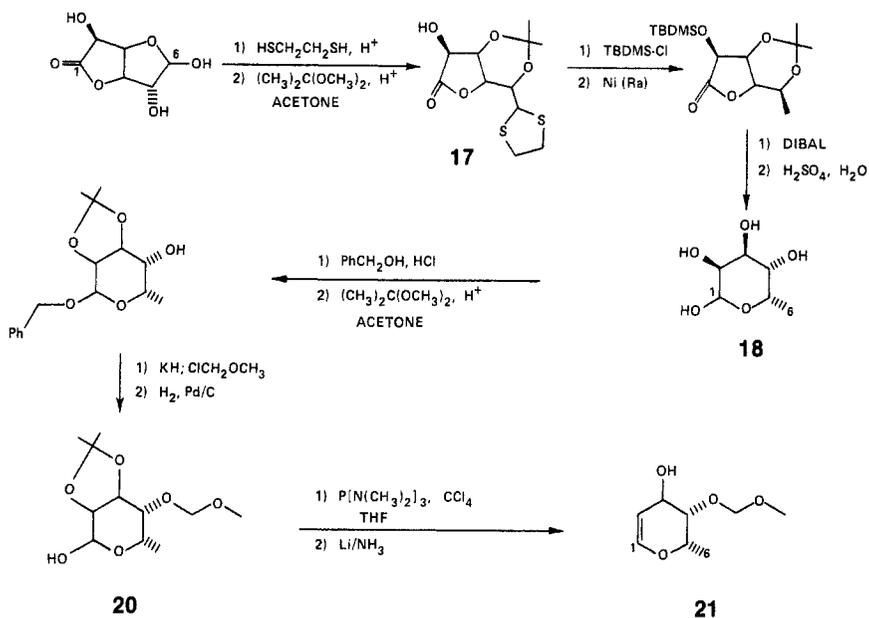

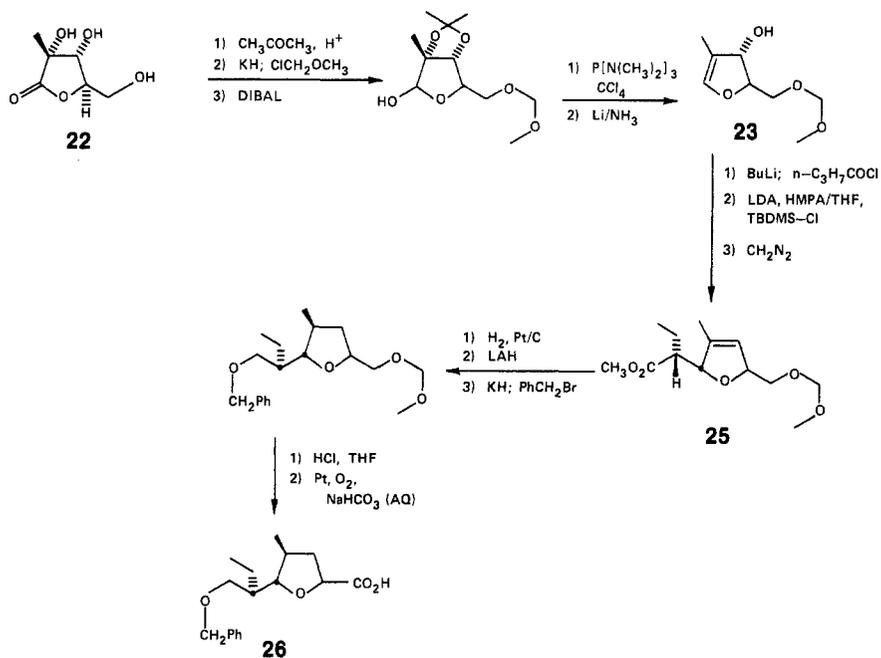
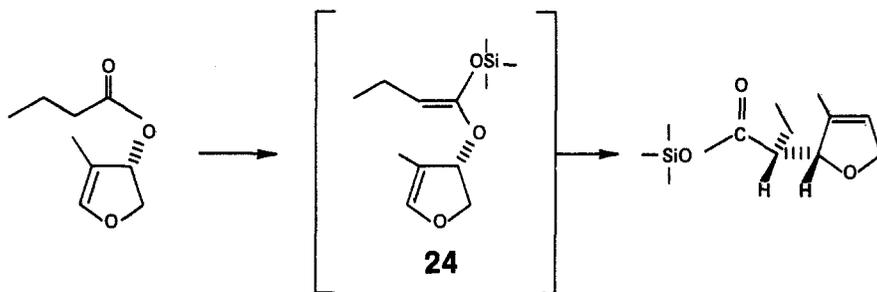

The preparation of the requisite pyran ring system, glucal **21** (Chart 6.4), began with D-glucurono- γ -lactone. Required manipulations were C-6 deoxygenation (sugar numbering), ring expansion, and vicinal dehydroxylation. The glucuronolactone was converted to the dithiane **17**, which was reductively desulfurized to afford the required 6-deoxymethylactone. After reduction to the lactol, the acetonide was liberated allowing ring expansion to the pyranose, 6-deoxy-L-gulose (**18**). The anomeric hydroxyl was temporarily protected by exchange with benzyl alcohol and then unmasked to give **20** after the 2-, 3-, and 4-hydroxyls were differentially protected. The anomeric hydroxyl was then converted to the chloride which provided the route for a reductive β -elimination to glucal-**21**.

The tetrahydrofuran B-ring was derived from **22** (Chart 6.5), readily available by $\text{Ca}(\text{OH})_2$ treatment of invert sugar (hydrolyzed sucrose). Lactone-**22** was protected via acetonide and methoxymethyl groups, reduced to the furanose, and subsequently converted to dihydrofuran **23** through the reductive elimination chemistry previously described for **21**. The reason for this chemistry was to incorporate the R-group (structure **15**) at the anomeric carbon (C-15, lasalocid numbering) with the desired *erythro* stereochemistry through an *E*-ester enolate Claisen rearrangement. The required stereochemistry was achieved via the *Z*-ketene acetal, **24**, which is favored in the mixed solvent system of hexamethylphosphoric triamide/tetrahydrofuran.^{230, 232} After the thermal Claisen rearrangement the product was converted to the methyl ester **25**. This *trans*-2,5-disubstituted dihydrofuran was then elaborated to the tetrahydrofuranic acid, **26**, through several protecting group manipulations and oxidation/reduction.



The first point of convergence was realized with the acylation of the lithium salt of **21** with the acid chloride of **26** to give allylic ester **27**. Generalized in structure **15**, intermediate **27** was submitted to the previously discussed Claisen rearrangement to afford **28**.

To complete the conversion to the right half of lasalocid, compound **28** required the extension of the methyl ester to an ethyl group, the introduction of the C-22 ethyl group, and the oxidation and two carbon elaboration of C-12.

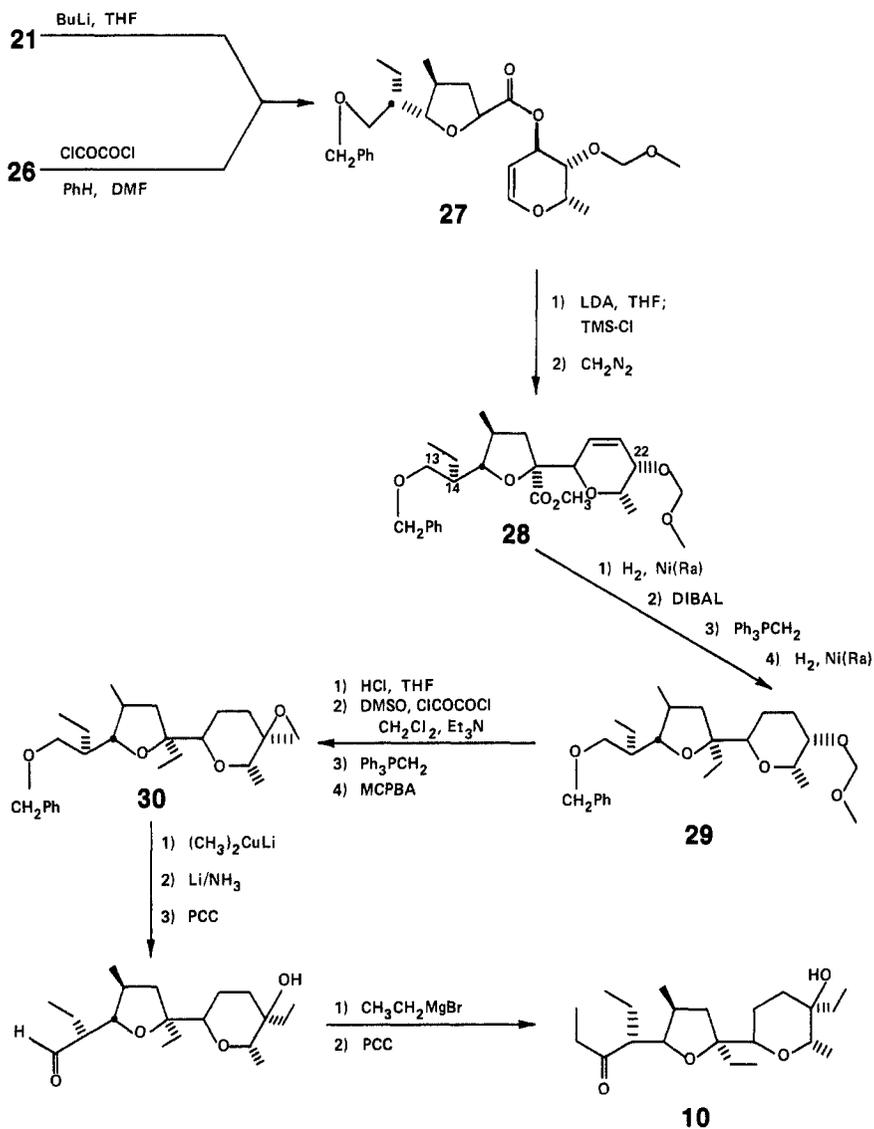

This was accomplished sequentially by hydrogenation to the tetrahydropyran over Raney nickel to preserve benzyl ether protection at C-13, followed by limited reduction of the ester, a Wittig, and a second hydrogenation of the resultant olefin to yield 29. Standard manipulations at C-22 afforded epoxide 30, which yielded the required C-22 tertiary alcohol with methyl cuprate in ether/

pentane. Subsequently, a four-step sequence gave the desired **10**, apparently without any epimerization at C-14 (for example, isolasalocid epimerization, Chart 6.1).

The left-half, aromatic portion of lasalocid was secured by synthesis from nonaromatic precursors (Chart 6.7). Pentenyl bromide-**31**, prepared in four steps from 2-buten-1-ol, underwent a conjugate addition as its Grignard salt to pyrone-**32**. The resulting dihydropyrone was oxidized to pyrone-**33**. An regioselective ynamine cycloaddition with extrusion of CO₂ yielded the dibenzylaniline, **34**. Vicinal hydroxylation of the terminal olefin with osmium tetroxide/*N*-methylmorpholine-*N*-oxide interestingly afforded the diol acetonide directly.²³³ After hydrogenolytic *N,N*-debenzylation and deesterification of the methyl ester with *n*-propyl mercaptide, the resulting amino acid was esterified and diazotized. Subsequent periodate treatment of the liberated diol yielded the left-half aldehyde,

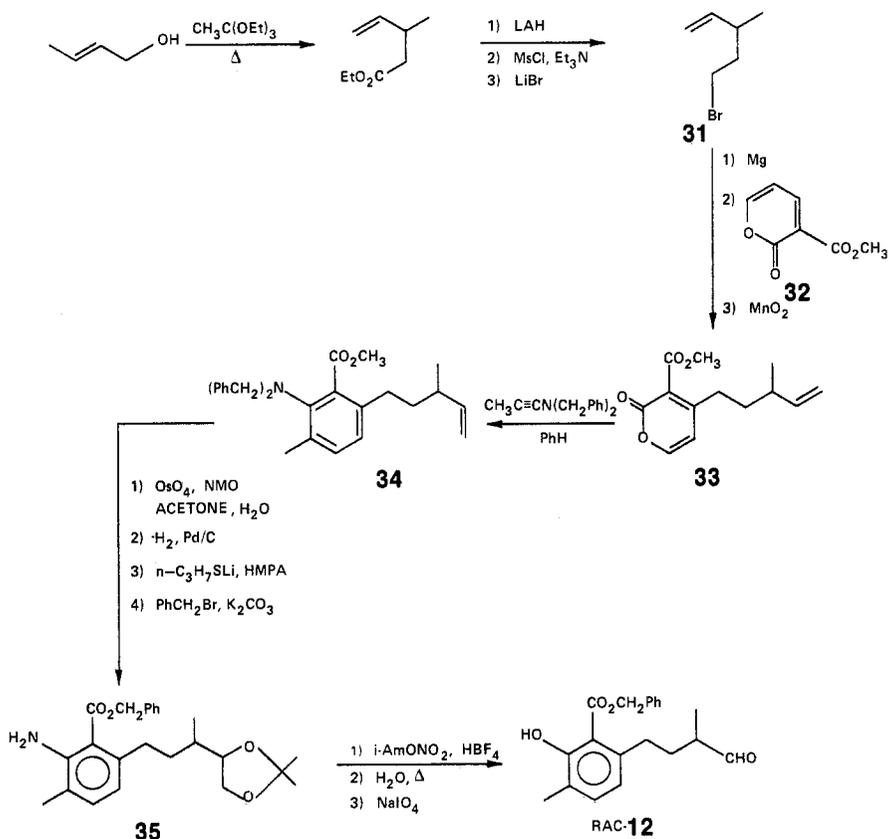
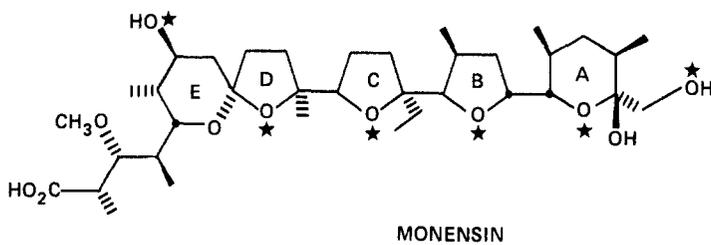

12, currently in racemic form. The chemistry remaining for the completion of the total synthesis involves preparation of optically active 31 and the aldol coupling of the two halves. The latter has actually been accomplished with the *retro*-aldol fragments from natural lasalocid employing the zinc enolate of the right half in dimethoxyethane at 0° and a 4-min reaction time with aldehyde 12.

B. Monensin

Isolated in 1967 from *Streptomyces cinnamomensis*, the structure of monensin was established by X-ray crystallographic analysis of its silver salt¹⁶⁸ and later of the free acid.¹⁶ Monensin, like lasalocid, is accompanied by several homologs in



the fermentation isolate; however, in contrast, it can be produced in unusually high titer by this streptomycete. The X-ray data depicts an irregular hexacordinate ligand array (starred oxygens) around silver and hydrogen bonding between both oxygens of the carboxylic acid and the two hydroxyls of the A-ring. Examination of the solution phase conformation both potentiometrically and spectroscopically¹⁷⁰ have revealed a structure nearly identical to the solid state.¹⁷¹

Monensin gave quite a high Na/K selectivity ratio^{47,172}, varying from 7 to 13 as a function of solvent, and exhibited a selectivity sequence of Na >> K > Rb > Li > Cs.¹⁵⁷ The biosynthetic origins of monensin parallel lasalocid in that it is derived from five acetates, seven propionates, and one butyrate. The methoxymethyl originates from methionine.¹⁷³

Although monensin exhibits weaker antimicrobial activity than its structurally similar relative, nigericin, it also displays activity as a coccidiostat. It has been a successful drug in the control of coccidia infections in poultry since its 1971 market introduction. However, even greater sales have been realized as a feed additive for the improvement in the efficiency of feed utilization in cattle. Monensin has also been popular in the study of polyether-mediated cardio-regulatory effects. It exhibits a fivefold greater inotropic potency than lasalocid.¹⁷⁴ Interestingly, its Ca²⁺ transporting capability relative to lasalocid is only 10⁻⁴ and norepinephrine transport is 1/300th, yet its sodium transport is 30 times greater.⁴

In a structural comparison with lasalocid, monensin contains 17 asymmetric centers compared to lasalocid's 10, and it is devoid of an aromatic chromophore and a formal aldol unit. However, utilizing methodology developed in their synthesis of lasalocid, Kishi's group has successfully completed a total synthesis of monensin.¹⁷⁸ This remarkable effort in fact involves a convergence of a right half (rings A-C) and a left half, in an aldol condensation to form the dioxospirane-D,E rings, the deketalization of which reveals the aldol unit.

The left half¹⁷⁶ was prepared starting from 2-furylacetonitrile (Chart 6.8). As will become evident, the furan is a latent methylcarboxylate group. The 2-furylacetonitrile was converted to 2-(2-furyl)propionaldehyde, seen earlier as an intermediate in the Schmidt nonactic acid synthesis, which was subjected to a Wittig reaction with carboethoxyethylidene triphenylphosphorane to give the *trans* (*E*) ester with approx. 5% *cis* (*Z*). The first diastereomeric centers were

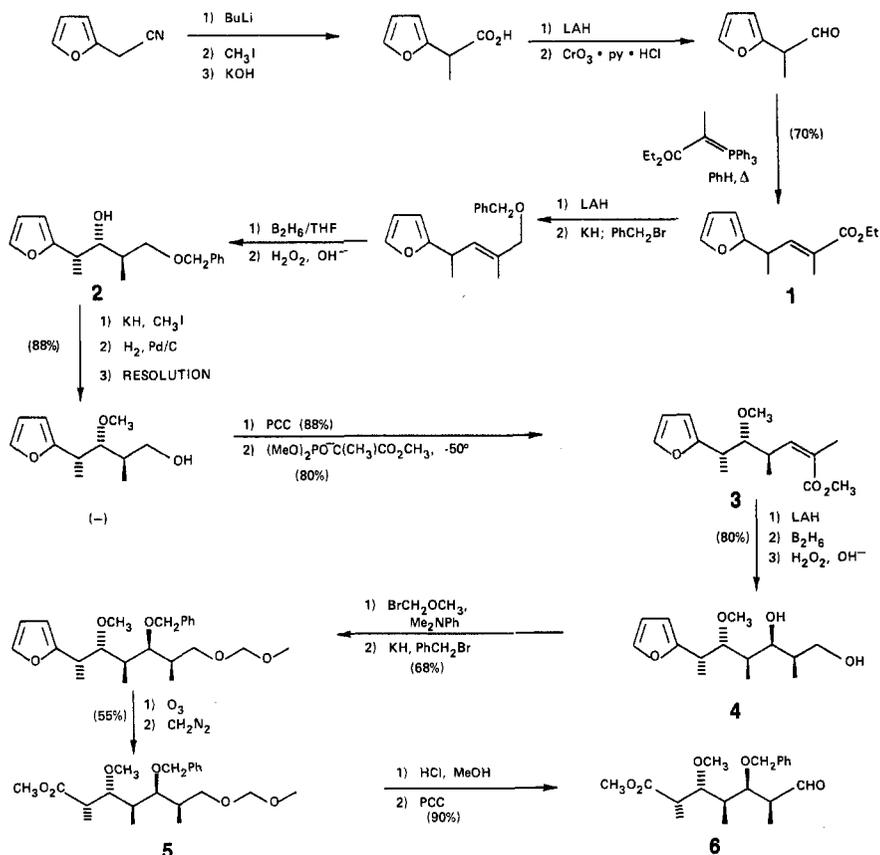
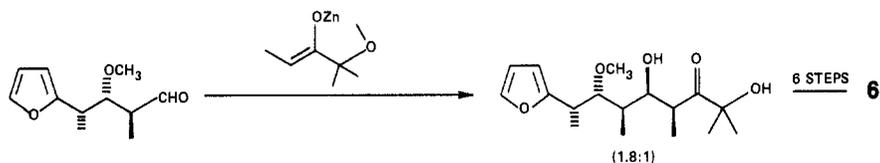

introduced by an unusual hydroboration of the protected alcohol analog of **1**. This hydroboration proceeded with excellent stereospecificity from the sterically less hindered α -face (furyl vs methyl) of the double bond to produce **2**, in 85% overall yield from **1**, in a ratio of 8:1 relative to the other diastereomer. At this point structure assignment was based on literature precedent.¹⁷⁹ After protection of the 2°-alcohol and deprotection of the 1°-alcohol, resolution was achieved, as in the lasalocid synthesis, via HPLC separation of the diastereomeric urethanes.

Cognizant that the Horner-Emmons modification of the Wittig reaction produces *cis*-stereoselectivity as a function of solvent, anion, and temperature, they converted the alcohol to the aldehyde and secured the *cis*-ester, **3**, in 64% yield from the alcohol (<98% *cis*) with the dimethylphosphonate anion at -50° in THF. Repetition of the hydroboration sequence on olefin-**3** gave the diastereomeric diol, **4**, as a 12:1 mixture. After differential protection of the 1°- and 2°-alcohols, the furan was oxidatively cleaved to the carboxylate. Removal of the methoxymethyl protecting group and pyridinium chlorochromate oxidation produced aldehyde **6** ready for the aldol with the right half. The structure was confirmed by comparison with a sample obtained via alternate chemistry wherein an intermediate was correlated with a degradation product of monensin. This alternate approach to **6** involved an aldol between a furylbutyaldehyde and



2-methyl-2-hydroxy-3-pentanone zinc enolate. However, since the diastereomeric selectivity was much poorer in this approach, the approach in Chart 6.8 was chosen.

The preparation of the 19-carbon backbone right half¹⁷⁷ (Chart 6.9) employs 2-allyl-1,3-propane diol, **7**, prepared from malonate and an allylic halide, as the building block. Monobenylation was achieved by reduction of the benzyl acetal with the mixed alane, $\text{LiAlH}_4\text{-AlCl}_3$. Urethane resolution gave the *S*(-) alcohol, correlated in four steps with (-)-2-methylpentanoic acid. Elaboration of **8** was through the Johnson orthoester Claisen chemistry on substrate **9**. After reduction of the ester and oxidation back to the aldehyde, a Grignard with *p*-methoxyphenylmagnesium bromide followed by oxidation and deprotection gave the homoallylic alcohol, **10**. Because of its symmetry, the *S*(+) alcohol could also be used in the preparation of **10** by a salvage process of debenylation of **8** after protecting the other alcohol and then carrying through the same chemistry as on *S*(-) **8**.

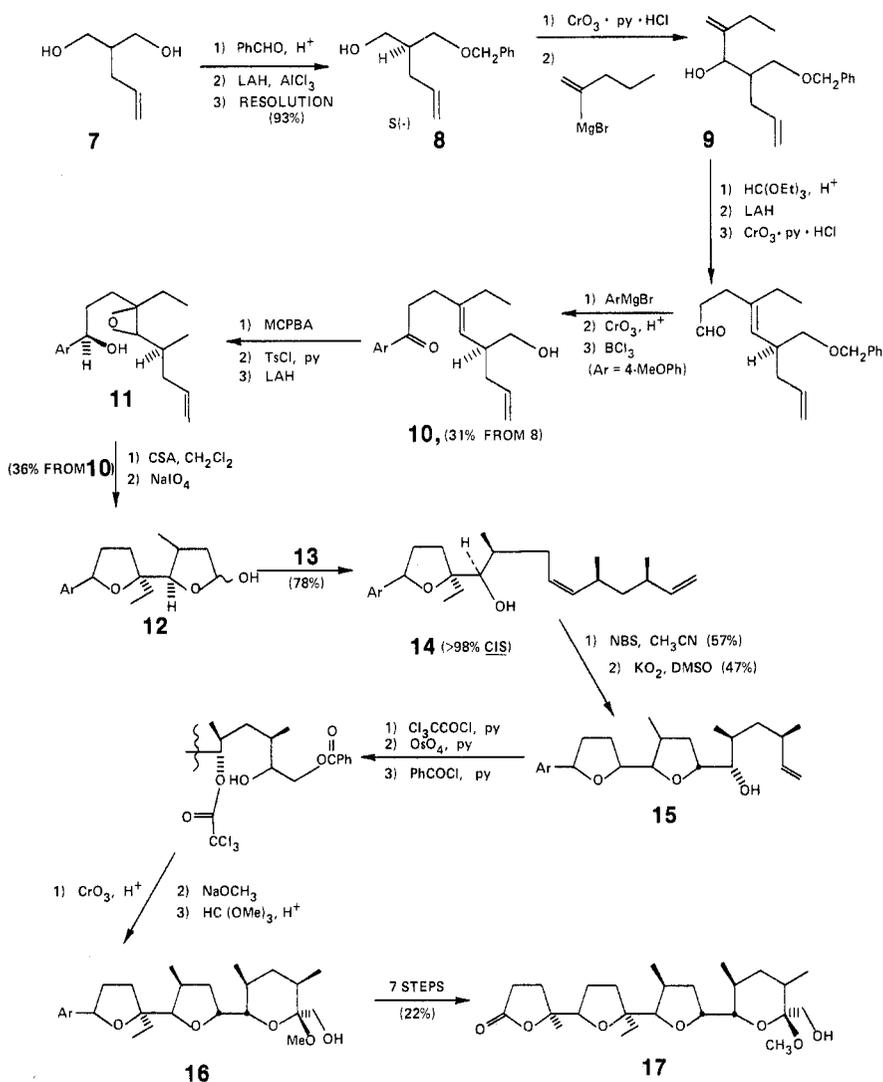


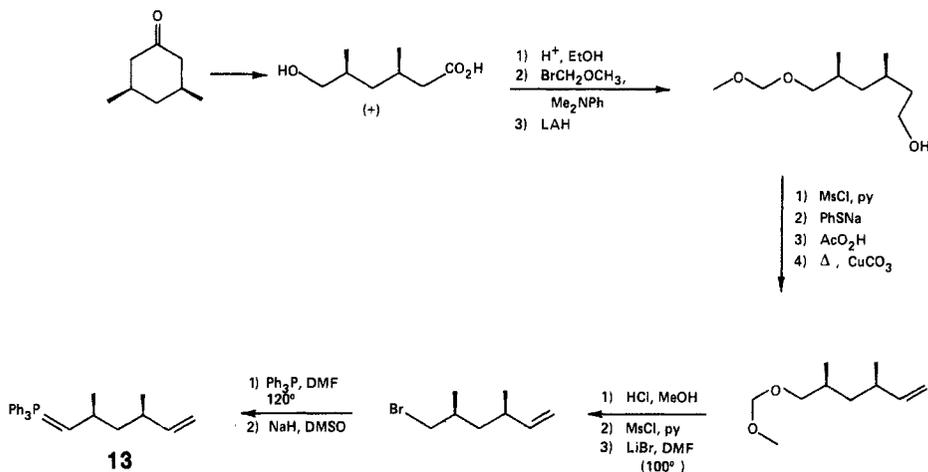

Epoxidation with *m*-chloroperbenzoic acid produced only the mono- β -epoxide, presumably due to alcohol directed oxidation from the β -face of the proximate, more nucleophilic double bond, wherein the least steric repulsion exists between the vinyl ethyl group and the terminal allyl unit. Since the alcohol was no longer needed, it was removed by LAH reduction of its tosylate ester to give the benzylic alcohol 11. Camphor sulfonic acid catalysis produced the tetra-

hydrofuran in a 7:2 diastereomeric ratio and periodate cleavage of the terminal olefin yielded the internal hemiacetal, **12**.

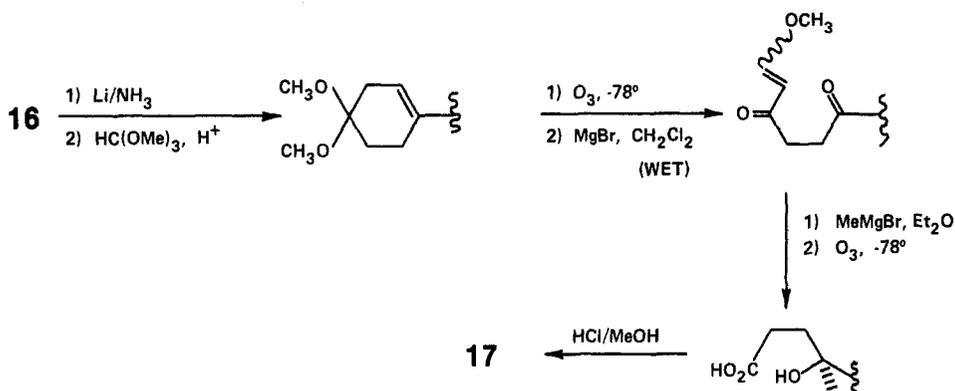
This was reacted with ylid **13** to give the diene **14** containing the skeleton for the monensin A-ring. The preparation of the required phosphonium salt originated (below) from 3,5-dimethylphenol. Raney nickel hydrogenation followed by sodium dichromate gave *cis*-dimethylcyclohexanone. Baeyer-Villiger oxidation followed by basic hydrolysis and resolution via the α -methylbenzylamine



salt gave the (+)-hydroxy acid. After protecting the alcohol, the acid group was converted to a vinyl group via pyrolysis of the terminal sulfoxide. The alcohol was then deprotected and converted to the phosphonium salt from which ylid **13** was generated by NaH in DMSO.

Since the bishomoallylic alcohol, **14**, could not be epoxidized with the Sharpless procedure employed in the lasalocid synthesis, the tetrahydrofuran was formed with *N*-bromosuccinimide and the resultant bromide converted with inversion to the alcohol **15** with superoxide in 27% overall yield. The terminal tetrahydropyran A-ring was then formed by osmium tetroxide oxidation of the terminal olefin sandwiched between two protecting procedures. The resulting 2°-alcohol was oxidized, methoxide liberated the protecting groups affording a single hemiketal, and trimethylorthoformate gave the cyclic ketal, **16**, in 53% yield from **15**.

In contrast to the lasalocid syntheses where the *p*-methoxyphenyl functioned as a latent α -ethyl, ethyl ketone, this aromatic residue in **16** was converted in a series of seven steps to a γ -methylfuranone. This was accomplished by first a Birch reduction from which the resultant 1,4-dienol ether was converted to the dimethyl ketal. Ozonolysis and subsequent treatment with magnesium bromide



afforded the enol ether of the β -keto aldehyde. Stereospecific addition of CH_3MgBr to the ketone adjacent to the furan followed by a second ozonolysis afforded the precursor to **17** from which two aromatic ring carbons had been excised. Acid catalysis gave the furanone **17**, which was converted in quantita-

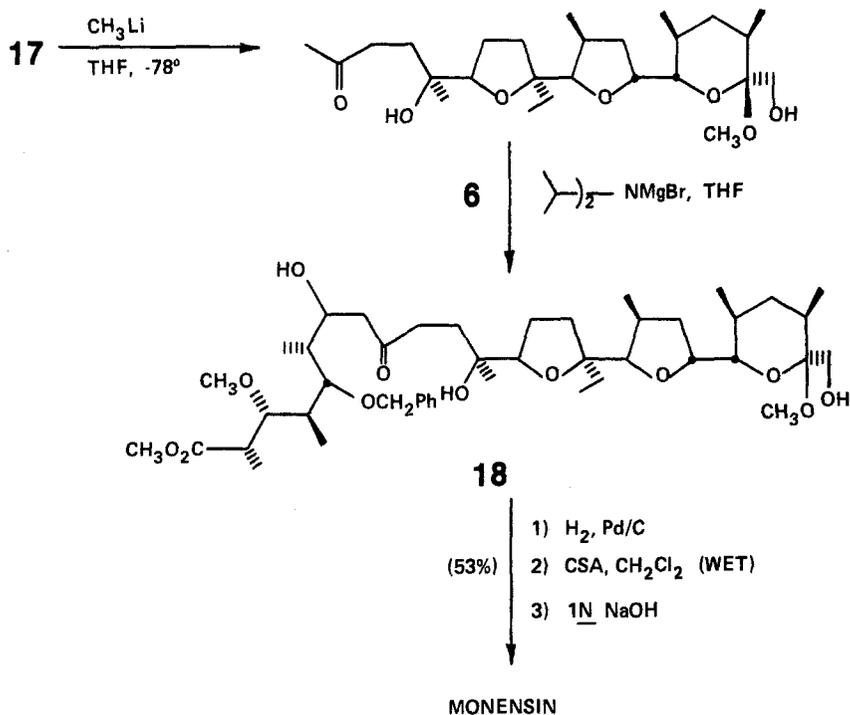


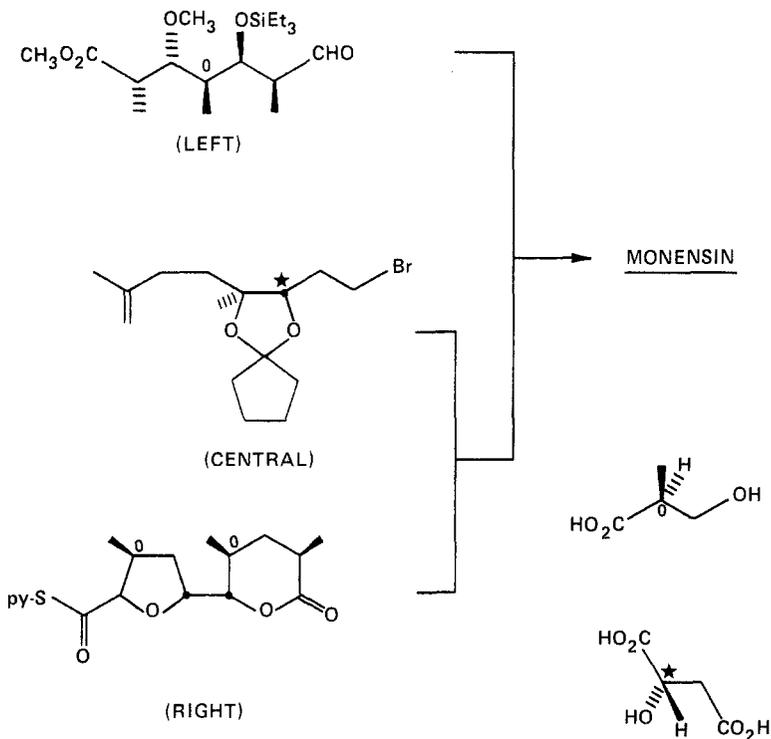

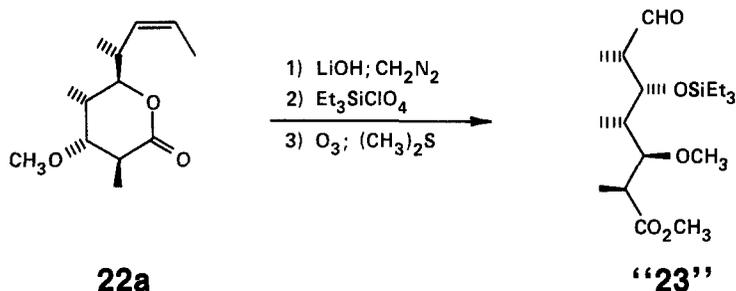
tive yield with CH_3Li to the methyl ketone required for the aldol joining of the right and left halves.

This critical coupling reaction was accomplished with diisopropylamine magnesium bromide in 21% yield at -78° with the desired aldol, **18**, in an 8:1 preponderance over the undesired diastereomer, whereas a 71% yield was obtained at 0° with a 1:1 ratio. Hydrogenolytic debenzoylation liberated dihydroxy ketal. When exposed to acid, the desired dioxospirane, the isomer with the thermodynamically more stable tetrahydrofuran C-O bond (D-ring) of the spiroketal axial, was produced. These conditions also served to hydrolyze the A-ring methoxy ketal. Base hydrolysis of the methyl ester completed the synthesis of monensin.

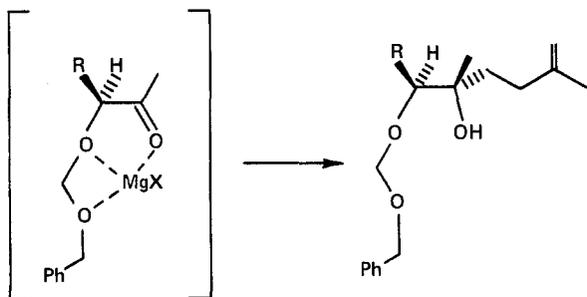
As noteworthy as the first total synthesis of monensin has been, with its structural and stereochemical complexity, an equally notable, yet distinctive second total synthesis has just recently been successfully completed by Still and co-workers.²³⁴ This group pursued a different strategy regarding the choice of various subfragments for a convergent total synthesis, although the final bond connection was an aldol analogous to the Kishi approach. It was envisioned that left, central, and right portions could be combined in the manner depicted to

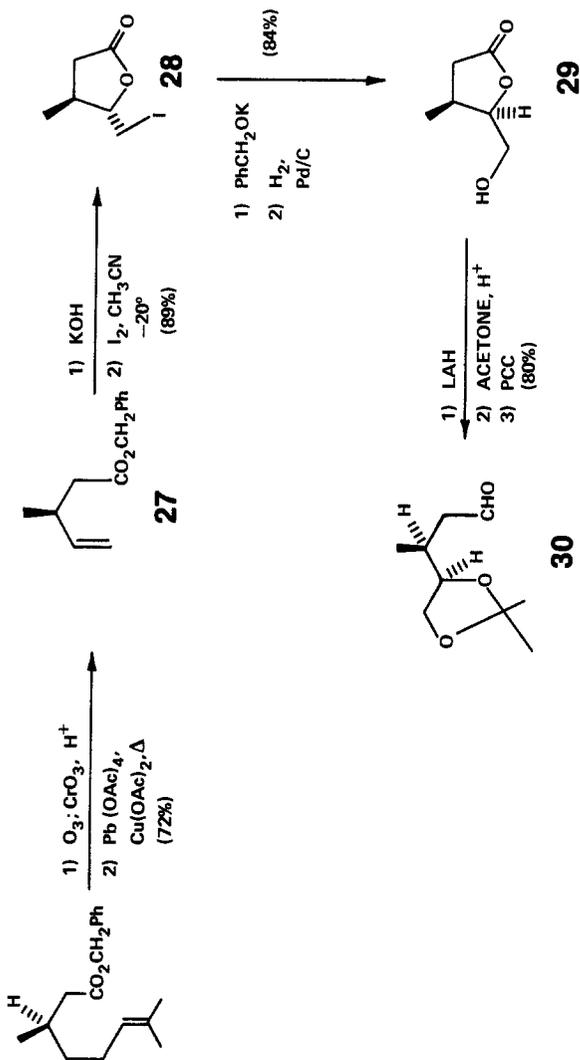


biological oxidation of isobutyric acid. This aldehyde, **19**, was condensed with Heathcock's enolate to yield, after oxidative cleavage of the resultant α -hydroxy-ketone, a 5:1 mixture of **20** and **21**. The postulated rationale for the predominance of the anti-Cram product, **20**, is the chelation control effect of the proximate benzyloxymethoxy group with the magnesium salt directing the attack of the E-enolate syn to the α -methyl group. A later example of this same phenomenon was found in the synthesis of the central fragment (*vide infra*). The major isomer **20** was di-*O*-methylated, deprotected, and oxidized to an aldehyde, which in turn was subjected to a second aldol with the *E*-zinc enolate this time. The expected ("Cram") product **22** was reduced and oxidatively cleaved to provide the second three-carbon addition needed for the left fragment, **23**. Since conversion of **22** to **23** proceeded in less than acceptable yield, an alternative procedure was devised. In a manner conceptually related to the allyl chromium chemistry of Hiyama, *et. al.*,²³⁸ reaction of the aldehyde derived from **20** with 4(*2-cis*-pentenyl)diethylaluminum afforded upon workup and flash chromatography, **22a**, in high yield as the predominant (3:1) isomer. This could in turn be converted to silyl-**23** by hydrolysis, esterification, and silylation followed by ozonolysis to generate the required aldehyde.



The route to the central fragment (Chart 6.13) proceeded from the acetonide of *l*-malic acid to the γ -lactone **24** ($\text{R} = \text{CH}_2\text{OCH}_2\text{Ph}$). After CH_3MgBr and silylation, a second highly stereospecific Grignard with isopentenyl magnesium





bromide afforded diastereomer **25** in a 50:1 ratio over the alternate isomer. This is the second example of "chelation control," wherein in this case addition is directed *cis* to the α -hydrogen with the benzyloxymethoxy group one carbon closer than the earlier example. The diol was then protected as the labile cyclopentylidene derivative with concomitant desilylation. Conversion of the primary alcohol to a bromide gave **26** as the central fragment.

The right fragment resulted from a convergent approach beginning with benzyl citronellate and another form of β -hydroxyisobutyric acid (Chart 6.14). The former was oxidatively degraded to olefin **27** which upon iodolactonization afforded the γ -lactone **28** with a 20:1 preponderance of the isomer depicted. The newly created chiral center was inverted to the *erythro* stereochemistry of

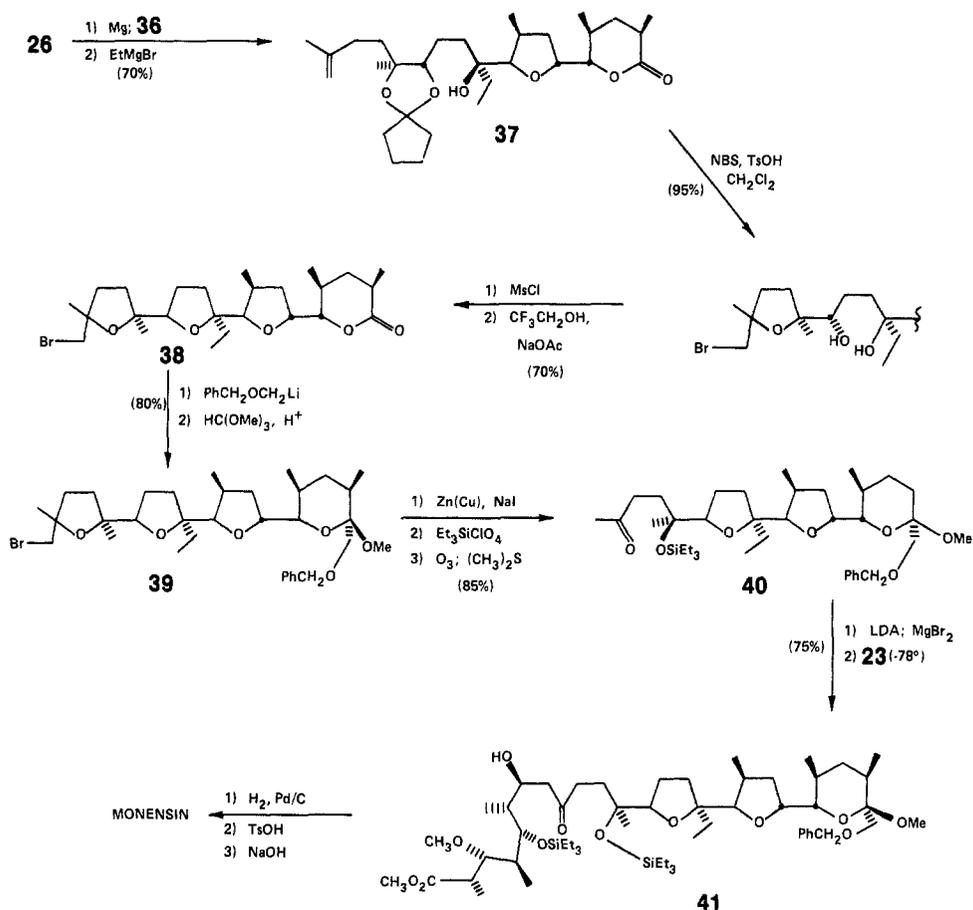


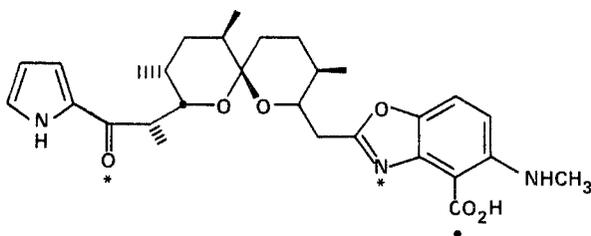
Chart 6.15. Convergence of fragments.

29 via an intermediate epoxybenzyl ester. Standard chemistry gave synthetic intermediate 30. A fragment to be condensed with 30 to afford the right-hand fragment was prepared from another form of the chiral isobutyric acid building block. Condensation with the lithium enolate of ethylpropanoate followed by acid-catalyzed cyclization yielded a δ -lactone. Reduction of the double bond yielded the isomer shown in a 10:1 preponderance and the resultant lactone was opened to iodide 32 with brief HI treatment. Direct alkylation of Ph_3P was achieved without solvent and the phosphonium salt condensed with aldehyde 30 in DMSO to give the *cis*-olefin 33. A second iodolactonization followed by a silver(I)-mediated solvolysis produced the D- and E-ring portions of monensin, 35. For coupling to the central fragment 35 was converted to the active ester 36.

Sequential treatment of 36 with the magnesium Grignard of 26 and then ethylmagnesium bromide gave only isomer 37, a product of chelation stereocontrol during the second Grignard. The terminal olefin was functionalized as the bromoether and the C-ring tetrahydrofuran formed by buffered solvolysis of the 2°-mesylate to give 38. Addition of benzyloxymethyl lithium followed by trimethylorthoformate gave the thermodynamic methyl ketal 39. The required methyl ketone for the forthcoming aldol coupling was liberated by reductive elimination to the terminal isopropene followed by ozonolysis. It was found that the subsequent aldol with the left fragment 23 required protection of the hindered 3°-alcohol of 40, so this was achieved via silylation with the perchlorate. Condensation with 23 proceeded in good yield to give a 3:1 ratio of the desired to undesired diastereomers. Deprotection, acid-catalyzed spiroketal formation, and hydrolysis, as described previously in the Kishi approach, afforded monensin.

C. Calcimycin (A-23187)

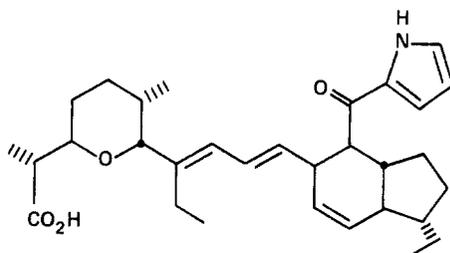
One of the more recent entries into the polyether-carboxylic ionophores is A-23,187 or calcimycin. Isolated from *Streptomyces chartreusensis*, its structure was divulged in 1974 as a benzoxazole and an α -ketopyrrole bridged by a 1,7-dioxospiro(5.5)undecane ring system.¹⁸⁰ This ionophore is unique not only

from a structural perspective but also because of its selectivity for divalent over monovalent cations. Particularly because of its excellent Ca^{2+} specificity and transport, its use has been cited in well over two thousand publications during its relative short history.¹⁸¹

Calcimycin forms a 2:1 complex with Ca^{2+} in a distorted octahedral array (starred atoms are liganding sites).¹⁸² Interligand H-bonds occur in the crystalline state between the pyrrole and carboxyl, and an intraligand H-bond exists between the methylamino and carboxyl. Its structure in solution is apparently very similar.¹⁸³ This is the only known polyether-carboxylic acid-type ionophore to employ a nitrogen in a binding site, although recently a new pyrrole-containing ionophore (X-14547A) was reported,¹⁸⁶ which transports divalent cations, forms a dimeric ammonium salt, and, in addition to its antibacterial properties, exhibits hypotensive activity in animals.

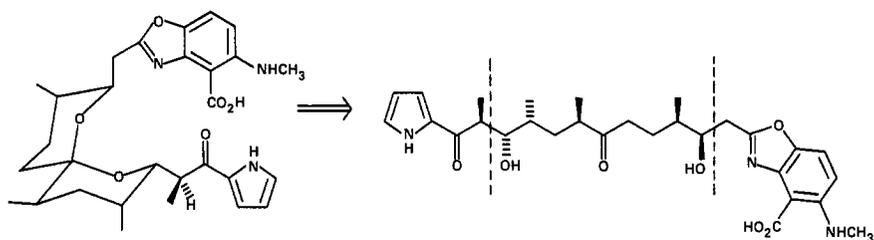

Its ion selectivity is reported to be $\text{Mn} > \text{Ca} > \text{Mg} > \text{Sr} > \text{Ba}$ and $\text{Li} > \text{Na} > \text{K}$,^{184,185} however, as in all cases previously cited, this is a function of which model is employed, ionophore concentration, pH, and other factors. For example, the transport kinetics for Ca^{2+} are different than for Mg^{2+} in isolated mitochondria with a turnover number of 45/sec for Ca^{2+} (calcimycin)₂.¹⁸¹

Calcimycin has been extremely instrumental in helping to understand the role of Ca^{2+} as a cellular control mediator and second messenger in hormonal processes. Essentially any Ca^{2+} -dependent phenomenon ranging from histamine release in mast cells to platelet aggregation to release of biogenic amino neurotransmitters has been examined with the aid of this ionophore. It also exhibits inotropic effects on isolated heart but appears to depress overall cardiovascular functions in the intact animal.

The first total synthesis of calcimycin was recently completed by Evans and co-workers.¹⁸⁷ Their approach was based on the proposition that the acyclic ketone diol form of the spiroketal would close under thermodynamic, dehydrative conditions to the required arrangement of calcimycin dioxospirane.

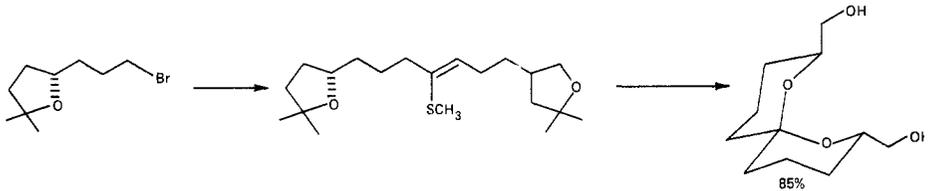
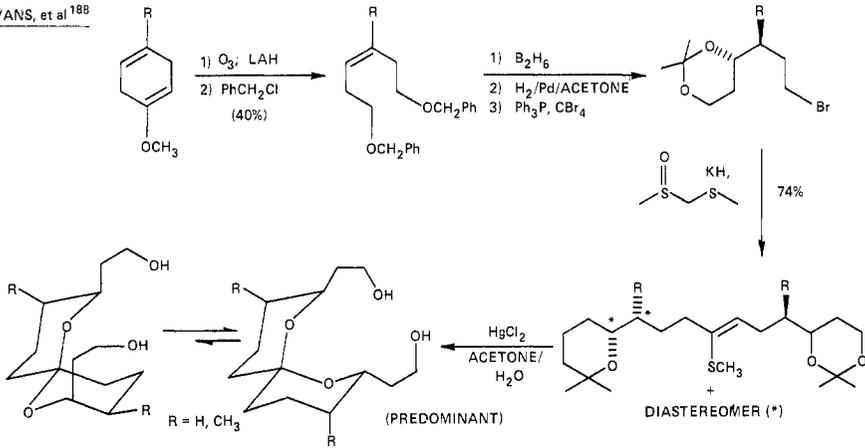


This belief, initially based on the axial vs equatorial stabilizations of the anomeric effect (2.3 kcal/mol), was born out in some initial model studies¹⁸⁸ (Chart 6.16). Selective ring-cleavage of the dihydroanisoles with ozone followed by alkylation with benzyl chloride afforded the protected bishomoallylic alcohols. Hydroboration (90%) gave a monoalcohol, which was then converted to the bromide. An interesting bisalkylation of the carbonyl anion equivalent, potassium methylthiomethylsulfoxide, yielded the vinyl ethers (*E*- and *Z*-isomers) in good yield as a presumed 1:1 diastereomeric mixture. This reaction, presumably involving bisalkylation of the central carbon followed by *syn*-elimination of CH_3SOH , was preferred over 1,3-dithiane methodology in this case. Although hydrolysis of the mixture could lead to four possible dioxospiropanes, only two were produced ($\text{R} = \text{H}$) and the desired isomer predominated. These results were indicated by the expected C_2 -symmetry of the predominant isomer as evidenced by ^{13}C -NMR and confirmed by X-ray crystallography. Analogous results were obtained with the dinor-model as depicted. Sondheimer and co-workers in an independent model study also reported the predominance of the desired dioxospiroundecane system. A double Grignard on methyl formate followed by a Jones oxidation gave the symmetrical ketone (Chart 6.16). Bromohydrin formation with acid-catalyzed ring closure yielded a 2.5:1 mixture of spiroketals.

With this background, the ultimately successful strategy employed by the Evans' group in the total synthesis involved aldol-type bond disconnections as depicted in the acyclic precursor. The benzoxazole chromophore was elaborated from the protected 2-amino-5-hydroxycarboxylate, **2** (Chart 6.17). Nitration afforded a 2/1 mixture of nitrophenols with the desired isomer predominating. After reduction to the amine, the oxazole was formed with acetyl chloride and the amine methylated in standard fashion.

The ketodiols-functionalized carbon framework for the spiroketal was constructed from a central acetone unit and two 3-carbon alcohol units. The latter units were prepared from fermentation derived (*S*)-(+)- β -hydroxyisobutyric acid, a building block previously noted in Still's synthesis of monensin. One 3-carbon unit (**4**) was generated by silylation followed by reduction with diisobutylaluminum hydride. The alcohol was then converted to iodide **4**. Enroute to **5**, benzyl-

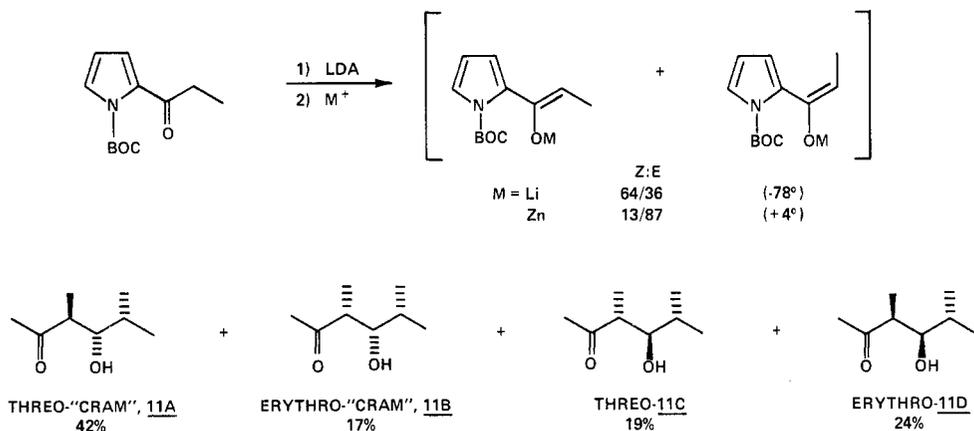
ation of the acid produced the dibenzyl derivative which afforded the monoalcohol upon reduction with lithium aluminum hydride. Hydroxyl for iodide interchange gave **5**.

Using the dimethylhydrazone of α -phenylthioacetone, successive monoalkylations were performed on the more substituted potassium salt first with methyl iodide and then by **4**. Reductive cleavage of the thiophenylether followed by

alkylation with **5** on the other acetone terminus gave the desired central carbon framework **6** in greater than 60% overall yield.

After exchange of the dimethylhydrazone for the dimethylpropanediol ketal, the terminal benzyl ether was cleaved by forming the benzylic anion with butyllithium followed by oxidation to the labile hemiacetal. The resultant alcohol was oxidized to the aldehyde with the pyridinium chlorochromate. Due to the relative instability of the benzoxazole α -methyl anion (**3**), the aldol with **7** required low temperatures. These conditions afforded the desired diastereomer (predicted by Cram's rule) as the predominant isomer (33% from **6**). Oxalic acid treatment served to convert the ketal to the internal enol ether (**8**) as well as isomerize the central ketone α -methyl to the desired, thermodynamic β -epimer. Removal of both the diphenyl-*t*-butylsilyl group and the trifluoroacetyl group was achieved with tetrabutylammonium fluoride.

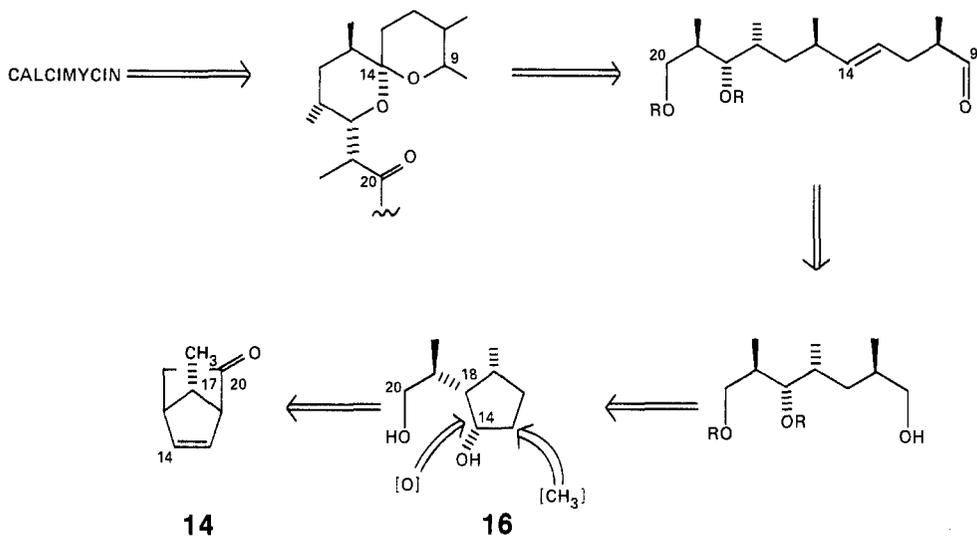
The aldehyde, **9**, from pyridium chlorochromate oxidation, was treated with the *N*-*t*-butyloxycarbonyl-protected pyrrole enolate **10** to yield the aldol **11a** as the predominant diastereomer among three others. The zinc enolate afforded a predominance of the desired *E*-isomer which in turn leads to threo (thermodynamic) products, whereas the lithium enolate slightly favored the *Z*-isomer. Resin



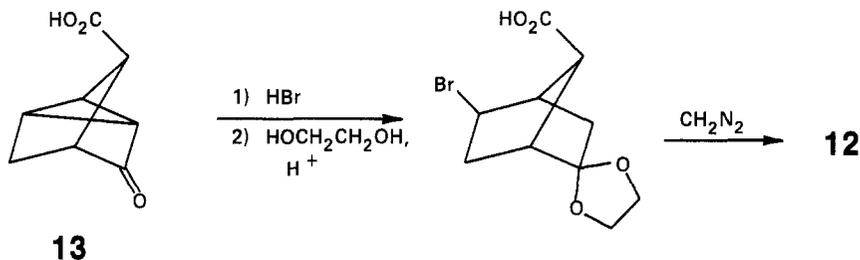
sulfonic acid treatment generated the dioxaspirane system and the methyl ester was cleaved with mercaptide to give the natural product in 23% overall yield from **9**.

An alternate approach to the total synthesis of calcimycin by Grieco and colleagues²²⁸ originates with a suitably functionalized bicyclo[2.2.1]heptane. The strategy involves the incorporation of pyrrole and C₈-methylbenzoxazole at the end of the synthesis. The required C₉-C₁₉ carbon backbone (calcimycin numbering) with the appropriate stereocenters is assembled by a series of oxida-

tions and one- to three-carbon additions, beginning with a functionalized equivalent of norbornenone-14, as depicted in the *retro*-synthetic diagram below.



The synthesis and elaboration of **14**^{229a} in the total synthesis of calcimycin is detailed in Chart 6.18. Bicycloheptane-12, derived from the tricycloheptane carboxylic acid **13**, was dehydrohalogenated and reduced to the epimeric-7-methanol. Carboxylic acid **13** is available in racemic or optically active form and



readily obtained from norbornadiene in two steps ((CH₂O)_n, HCO₂H; CrO₃/H⁺)^{229b}. Reduction of the corresponding tosylate was achieved in good yield with lithium triethylborohydride. After deprotection **14** was submitted to Baeyer-Villiger oxidation conditions to give a bicyclo[3.2.1] lactone, which underwent Lewis acid-catalyzed rearrangement to γ -lactone **15**. After a highly stereoselective methylation, the lactone was reduced to diol **16**. Selective protection of the primary alcohol allowed for a second Baeyer-Villiger oxidation on the cyclopentanone analog of **16** to afford a δ -lactone.

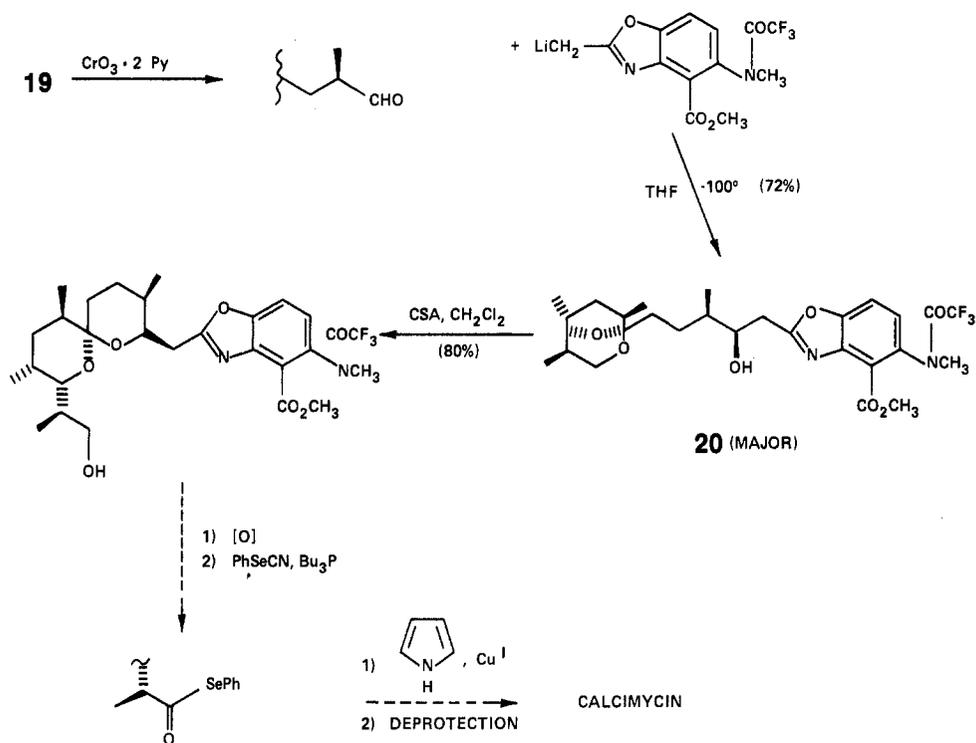
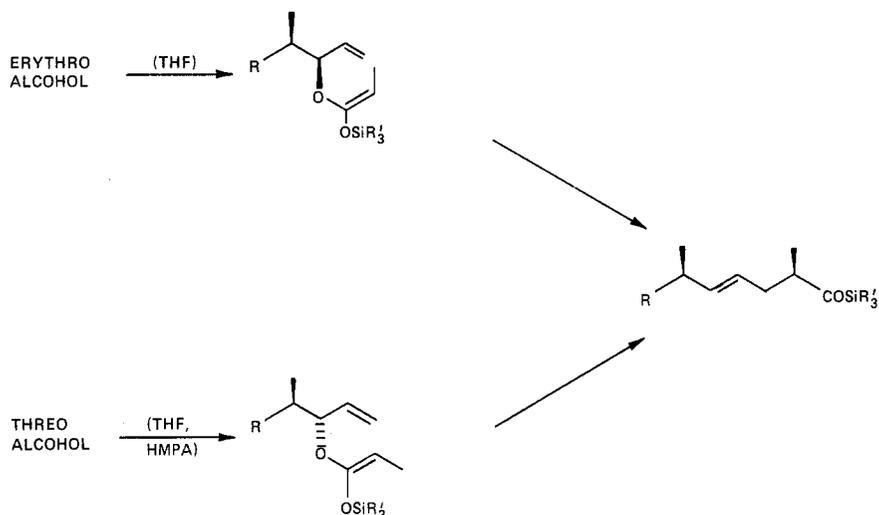

Here again α -methylation proceeded with a high degree of stereoselectivity to give **17**, a stereoisomer of which was previously employed by Grieco to synthesize the Djerassi-Prelog lactone and methynolide.^{229a} After reduction and protecting group exchange to the 1,3-acetonide, the resulting primary alcohol was oxidized with Collins' reagent and converted with vinyl Grignard to a 3:1 mixture of allylic alcohols. These were elaborated by three carbons to ester-**18** employing the ester enolate Claisen rearrangement. This is another example of the chemistry of Ireland²³⁰ involving solvent effects on enolate geometry (vide supra: lasalocid synthesis). Specifically, the erythro alcohol in THF yields the *Z*-enolate which rearranges to the β -methyl ester. The minor *threo*-alcohol isomer can also be employed by generating the *E*-enolate with HMPA cosolvent to afford the same β -methyl ester.

Reaction of **18** with osmium tetroxide followed by pyridinium chlorochromate served to introduce the "C-14" ketone. Reductive cleavage of the oxygen of the γ -lactone α to the ketone was effected with calcium in liquid ammonia. Internal transketalization and reduction then gave the bicyclic ketal **19**.



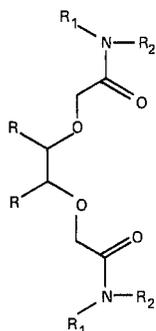
Compound 19, after conversion to the corresponding aldehyde, was condensed with the lithium salt of the benzoxazole to afford alcohol-20 as the major product.

The heterocycle was prepared in an analogous fashion to the previously described Evan's synthesis except that nitration was carried out in nitromethane (92%). Acid catalyzed equilibration of 19 yielded the thermodynamically more stable dioxospirane system of calcimycin. It is anticipated that conversion to the natural product can be achieved, as depicted, by oxidation and acylation of pyrrole.

D. Synthetic Analogs

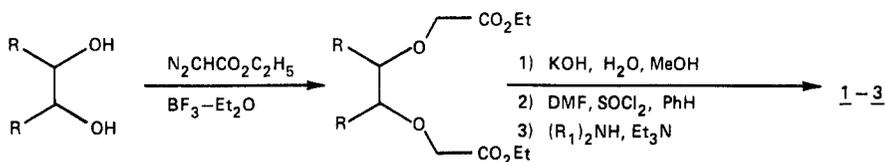
A strategy for preparing noncyclic ligand systems, which might particularly mimic the polyether ionophores, must include a recognition that there is a greater than 2.3×10^4 reduction in binding capacity between the cyclic 18-crown-6 and its acyclic counterpart.¹⁹⁷ Thus, in approaching an appropriate balance between efficient complexation and transport, other structural constraints must be introduced to overcome the large entropy barrier in ion envelopment by an acyclic ligand framework.

The initial work in the area of noncyclic ligands was by Simon¹⁹⁸ and co-workers, who reported on a variety of diglycolic acid diamide ligands as ionophores, determined by incorporation in liquid membrane electrodes.¹⁹⁹ Several of these neutral ligands, including 1-3, exhibited excellent selectivity for Ca^{2+} over other ions.²⁰⁰ These amides were prepared²⁰¹ by the bisalkylation of the appropriate glycol with ethyl diazoacetate. The diester was hydrolyzed,

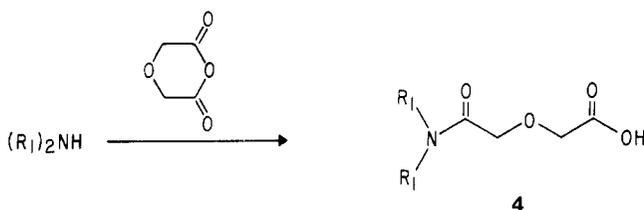

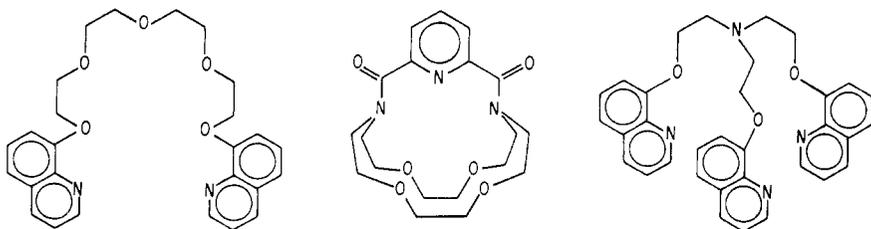
converted to the acid chlorides and condensed with the appropriate secondary amines.



Recently, very similar ligands were reported wherein $R = H$ and R_1 was a variety of lipophilic residues.²⁰² These workers also reported on a series of diglycolamic acids, **4**, which exhibited excellent Ca^{2+} transport in U-tube experiments.

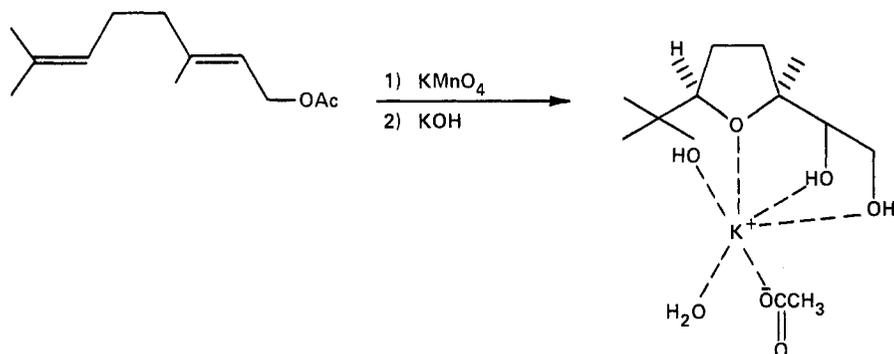


Vögtle, Maass, and co-workers have prepared and examined a large number of "open chain crown" ligands.²⁰³ These directed, polyether ligand systems often contain rigid end groups, which can function as additional donor centers. Several



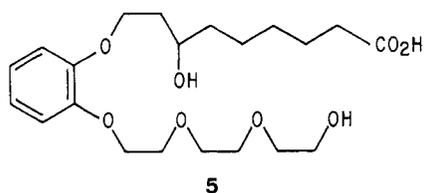
examples are shown below. A variety of alkali metal ion complexes have been prepared and the ion translocation processes of some of the ligands have been examined in isolated heart cells.²⁰⁴

Relatively modest ligands have proven capable of alkali metal complexation. For example, the permanganate oxidation of geranyl acetate affords a diol,²²⁵ which, when treated with potassium hydroxide, yields an isolable potassium complex.²²⁶ This interesting chemistry is currently being exploited to prepare



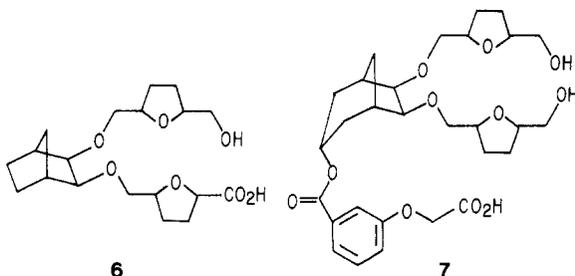
stereospecifically from 1,5-dienes, variously substituted tetrahydrofurans,²²⁷ which are ubiquitous units in the polyether ionophore antibiotics.

Two examples of polyether carboxylic acid ligand systems are the work of Gardner and Beard²⁰⁵ and Wierenga and co-workers.²⁰⁶ The former workers described the synthesis of a variety of analogs of **5**, however, they failed to form



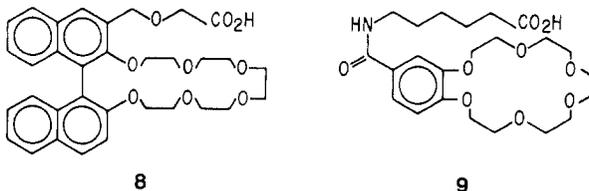
organic soluble salts and no properties were reported which would distinguish these compounds as ionophores. Wierenga's attempts culminated in two structures (**6**, **7**), which compared favorably to lasalocid and calcimycin in transporting Ca^{2+} in the U-tube experiment.

The synthesis of **7** (Chart 6.19) is representative. Employing the Noyori cycloaddition chemistry, the bicyclo[3.2.1]octenone was prepared from cyclopentadiene. Stereoselective reduction to the *endo*-alcohol of this bicyclic building unit was achieved with lithium tri-*sec*-butyl borohydride. Sodium borohydride in methanol afforded a 4:1 *endo* to *exo* ratio. After protection of the alcohol, the



olefin was transformed to the *exo*-diol with catalytic osmium tetroxide and *N*-methylmorpholine-*N*-oxide (18% overall yield from cyclopentadiene). The *cis*-diol was bisalkylated (88%) with the difunctional furyl chloride, **8**, prepared in 78% yield from hydroxymethylfurfural. Deprotection followed by acylation (90%) with the metasubstituted benzoyl chloride (prepared in three steps from *m*-hydroxybenzaldehyde) served to incorporate the third, directing ligand system. Pyruvic acid removed the acetal protecting groups and reduction to a diastereomeric mixture of *cis*-tetrahydrofurans was achieved with hydrogen over Raney nickel. Selective hydrolysis of the relatively unhindered methyl ester gave **7**. Examination of the C-P-K models of **7** indicated a directional tetrahydrofuran-ligand array with 2.0-2.6 Å diameter and the third ligand juxtaposed beneath the "noncyclic crown" to provide pole-dipole interactions with the metal ion.

It should be noted that certain crown ethers have been modified to afford ligands for divalent ion complexation and transport. Two examples are **8**, prepared by Cram and co-workers,²⁰⁷ and **9**, of Smid et al.²⁰⁸ However, at least



in the former case, these are not as efficient as **7** in Ca^{2+} transport.²⁰⁶ Also, Brown and Foubister recently reported some anticoccidial activity for several related benzo-15-crown-5 polyethers.²³⁷

7. MISCELLANEOUS IONOPHORES

The inclusion of several structural classes in the last section is either for the reason that no chemical synthesis has been achieved or that the classification as an ionophore is not unambiguously established.

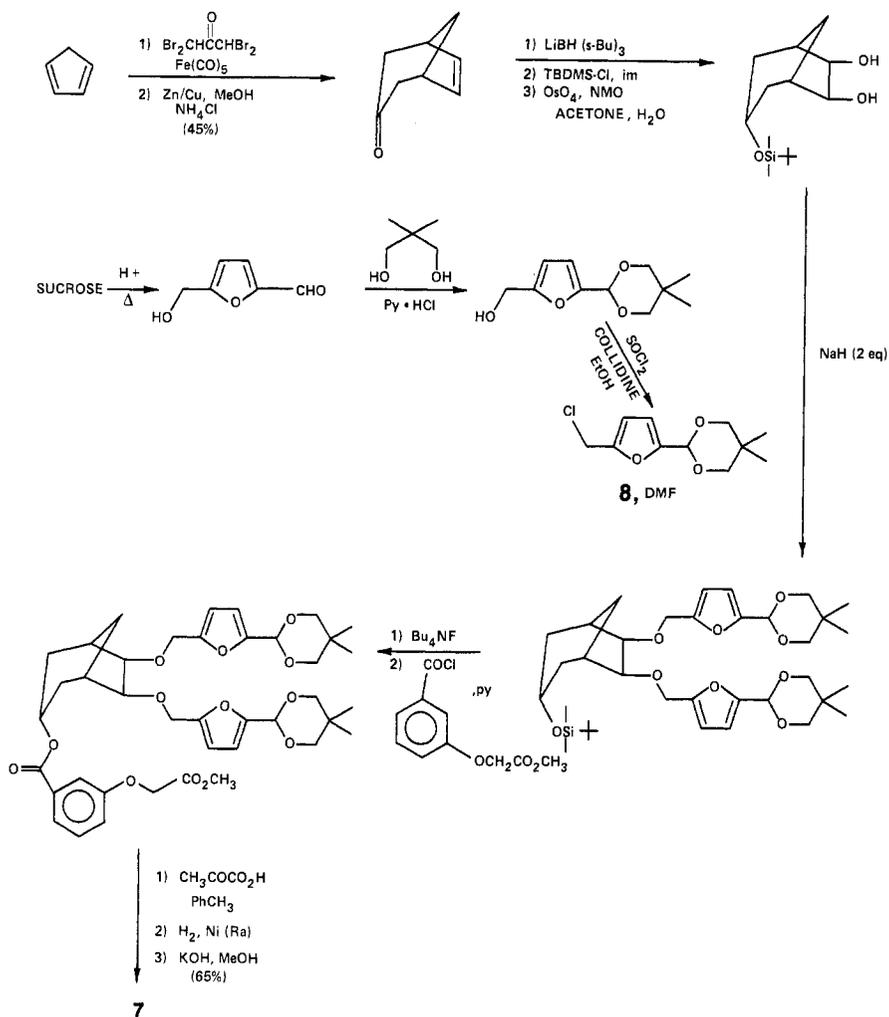
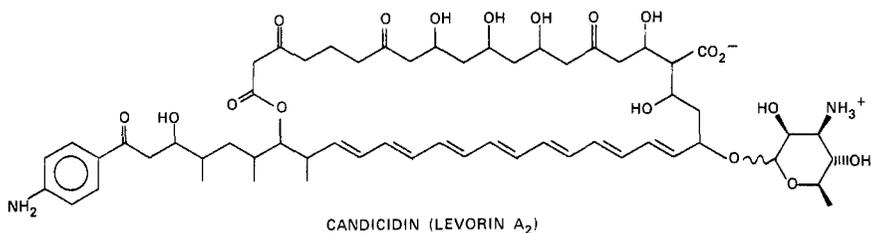
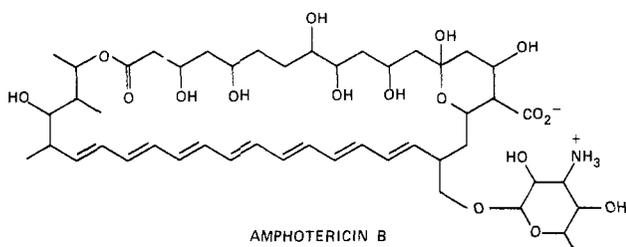


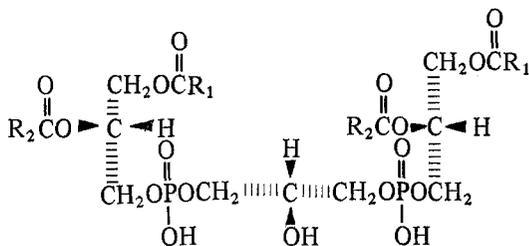

In the former category are the polyene antibiotics. These antifungal antibiotics include amphotericin B, filipin, nystatin, lienomycin, candidin, pimarinin, etruscomycin, and others. Although the absolute and relative configurations are not known, the basic structures have been ascertained and two examples are depicted below. There has been a substantial amount of work on their effects on membrane permeability²⁰⁹ and ionophoric properties.²¹⁰ All of the structures include a macrocyclic lactone of various sizes with a polyene half and a polyol half. Attached to the macrolide is usually the amino sugar, mycosamine. The



effects of these ionophores have suggested both a carrier and a pore-forming mechanism for ion transport.

A second structure class includes the phospholipids such as lecithin, cephalin, and cardiolipin.²¹¹ These phosphoglycerides, constituents of cellular membranes, particularly nerve tissue, transport Ca^{2+} in the U-tube system with good efficiency.²¹²

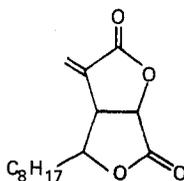
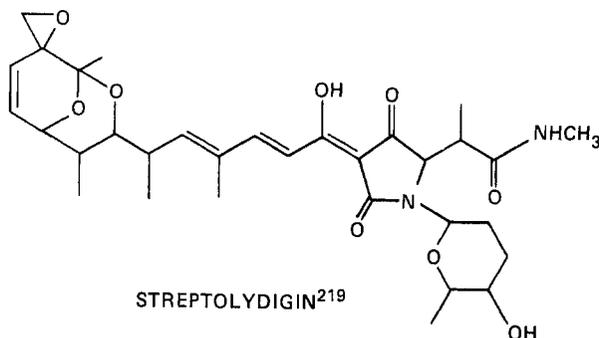


Cardiolipin (R_1 = steric, R_2 = oleic)

Related to these are the prostaglandins. There have been reports both claiming ionophoric properties for certain prostaglandins (such as PGB_2 ²¹³ and PGA_2 ²¹⁴) as well as disclaiming ionophoric action.²¹⁵ Effects of prostaglandins on intestinal zinc absorption have been attributed to a PGE_2 liganding effect.²¹⁶ The

concept of thromboxane A_2 (TxA_2) transport of Ca^{2+} as an integral feature of platelet aggregation has been reported based on studies which include TxA_2 -assisted Ca^{2+} transport in aqueous to organic phases.²³⁵

Several isolated structures have been reported to exhibit ionophore-like properties but have received little study. These include streptolydigin,²¹² several isomeric octadecadienoic acids (e.g., 13-hydroxyoctadecadienoic acid),²¹⁷ and avenaciolide.²¹⁸ Although avenaciolide has been synthesized by three different

groups,²²⁰⁻²²² its lack of structural similarity with any of the well established ionophores and absence of multiple binding sites for metal ions argues against its incorporation at this time.¹⁸¹

Lastly, work is ongoing in the search for and identification of *in vivo*, "natural" ionophores. For example, mitochondrial Ca^{2+} transport appears to be carrier-mediated²²³ and $Ca^{2+} + Mg^{2+}$ -ATPase from sarcoplasmic reticulum has an ionophore component. Recent results describe the isolation of a low molecular weight (ca. 3000) Ca^{2+} carrier protein from the inner mitochondrial membrane, called calciphorin.²²⁴ Such results as these strongly suggest such future possibilities as the design and synthesis of "natural" ionophores to effect tissue and ion-selective transport in vertebrates to correct ionic imbalances or enhance the biochemical understanding of energy transduction through membranes.

ADDENDUM

In 1980 Bartlett and Jernstedt disclosed an alternative synthesis of (\pm) nonactic acid,²³⁹ the subunit of nonactin (Section 5A). This approach intersects with the second synthesis of Gerlach¹¹⁸ at the octene diol (Chart 5.2); however, the Bartlett route affords the *erythro* diol exclusively, starting with dimethyl-1,7-octadien-4-yl phosphate. This is converted regio- and stereospecifically to the terminal monoepoxide by treatment with iodine followed by methoxide (intramolecular monoepoxide cyclization). Lithium aluminum hydride gives the diol. This diol is converted to the aldehyde analogous to the Gerlach chemistry and then departs by performing a TiCl_4 -mediated aldol with $\text{CH}_3\text{CH}=\text{C}(\text{OCH}_3)\text{-OSi}(\text{CH}_3)_3$ followed by Jones oxidation to give the β -ketoester equivalent of the Gerlach α,β -unsaturated ester. The β -ketoester is cyclized with dehydration to the *epi*-2,3-dehydrofuran which is reduced ($\text{Rh}/\text{Al}_2\text{O}_3, \text{H}_2$) to give a high yield of the 8-epinonactic acid methyl ester. Inversion of hydroxyl as described by White¹³⁰ gave (\pm)-nonactate in 25% overall yield.

An interesting synthetic model for nonactin was described by Samat, et al.²⁴⁰ This was a dimeric, 32-membered macrocycle composed from the $-\text{CH}_2\text{CH}_2\text{-OCOCH}_2\text{CH}_2\text{OCH}_2\text{CH}_2\text{CH}_2\text{OCH}_2\text{CH}_2\text{CO}_2\text{CH}_2-$ subunit.

Ireland and coworker have reported a chiral synthesis of the aromatic left-half of lasalocid²⁴¹. The basic route follows the chemistry depicted in Chart 6.7 for the earlier racemic synthesis. The required absolute stereochemistry is derived from optically active pentenyl bromide-31. Both enantiomers were independently derived from (-) citronellene. A discrepancy was noted between the optical rotations observed and those reported in the earlier Kishi synthesis¹⁶¹ (Chart 6.2). These were attributed to incomplete resolution in the Kishi chemistry. A further complication is that the final aldehyde (**12**) exhibits instability problems. A reinvestigation of the isomeric outcome of the final aldol coupling with **12** to lasalocid is in progress.

1. INTRODUCTION

Since the review of this topic in a previous volume¹, there has been a flood of literature on the synthesis of prostaglandins. However, the outpouring witnessed during the 1970s has begun to abate, and it appears to be an appropriate time to review the progress made during the decade.

It is difficult to imagine that only a decade ago the prostaglandins were scarce and difficultly obtainable materials, and that in the 1960s a veritable arsenal of modern ultramicroanalytical techniques had to be deployed by Bergström to unravel the structure of these substances, which were then available only in milligram quantities. The advances in total synthesis have altered all that, and today the natural prostaglandins are relatively abundantly available. Much of the

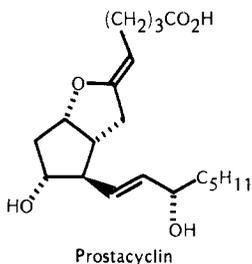
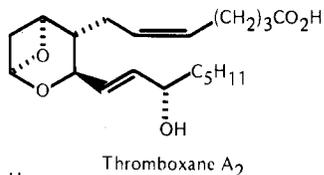
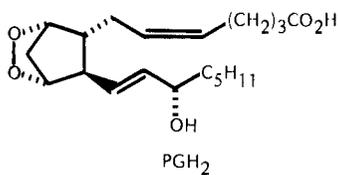
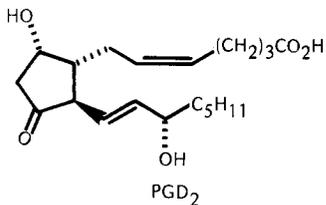
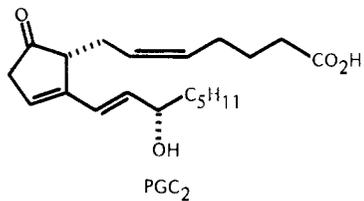
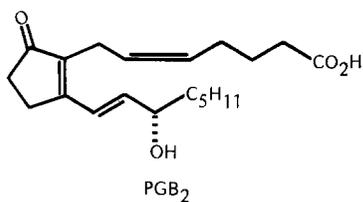
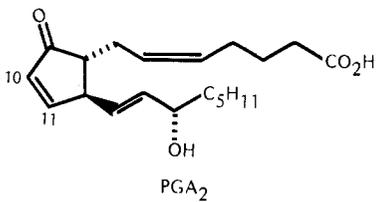
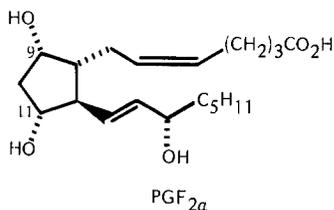
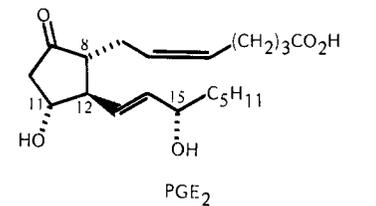
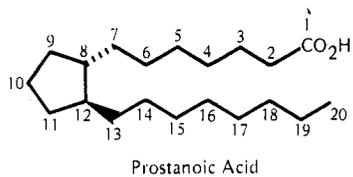


Chart 1.1. Structure and nomenclature of prostaglandins and thromboxanes.

credit for synthetic accomplishments in this field belongs to Professor E. J. Corey, who pioneered the early successes, and whose synthetic approaches continue to dominate the field.

The arachidonic acid cascade, to which the prostaglandins belong, has yielded several new members, some with striking biological activity. Notable among these are the thromboxanes and prostacyclins, which play an important role in the regulation of platelet aggregation. Though not strictly prostaglandins, the syntheses of these substances have been included in this chapter for review.

During the late 1970s there has been a clear shift away from devising syntheses of natural prostaglandins toward the synthesis of analogs possessing greater stability and selectivity of activity. Several analogs are in advanced stages of development. No attempt is made in this chapter to catalog the chemistry of these modified prostaglandins, or of the isomeric prostaglandins. Prostaglandin analogs are legion. Interested readers are referred elsewhere for a detailed review.² This chapter attempts to update the earlier article¹ by reviewing some of the major advances in prostaglandin chemistry from 1971 to the end of 1979.

Several books,²⁻⁵ reviews, and proceedings of symposia⁶⁻¹⁰ are available and provide details on many aspects of prostaglandin chemistry that may have been excluded or are only briefly mentioned here. The nomenclature of prostaglandins has been reviewed in detail (Chart 1.1).²⁻¹¹

2. PROSTAGLANDIN SYNTHESSES

A. Approach to Prostaglandin Synthesis

Two major problems encountered in the synthesis of prostaglandins are stereochemistry and sensitivity of the functional groups present in these molecules. For example, prostaglandin E₂ has four chiral centers, a labile β -ketol function in the five-membered ring, and two double bonds in the side chains. Three of the four chiral centers, those at positions 8, 11, and 12, are contiguous on the cyclopentane nucleus and are mutually *trans*. Since this is the more stable preferred arrangement, it does not offer any obstacles, and is relatively easily established. Stereochemical control of the fourth center at C-15, however, placed in a conformationally mobile side chain, and at a considerable distance from influence of the ring, poses a much more difficult problem.

The F prostaglandins possess an additional center of asymmetry at C-9. However, this additional complexity is more than offset by the much greater stability of the F prostaglandins, making them quite attractive synthesis targets. Oxidation of F-type precursors selectively protected at the 11- and 15-hydroxyl functions, followed by deprotection affords a convenient access to PGEs. Several protecting groups (e.g., tetrahydropyranyl and silyl ethers) are available, which

can be removed under conditions to which E prostaglandins are stable. Since the E prostaglandins in turn can be readily converted to any other members of the same class, the E and F prostaglandins are primary synthetic targets of the more important and promising general approaches to prostaglandins.

The strategic use of blocking or masking groups and latent functionality, as well as the use of neighboring groups for influencing or establishing chiral centers elsewhere in the molecule is all important in prostaglandin synthesis. Effective employment of these strategies is most evident in the syntheses devised by E. J. Corey and R. B. Woodward, and in the 1,4-addition approaches, notably in the work of C. J. Sih, G. Stork, and the Syntex group.

B. Classification of Syntheses

Prostanoid syntheses may be divided into three major classes (Chart 2.1): (1) syntheses in which the cyclopentane ring is formed from acyclic precursors, (2) syntheses which commence from precursors containing a preformed cyclopentane nucleus, and (3) syntheses in which a bicyclic system is used to introduce an additional element of stereochemical control. The first two approaches are characteristically beset by difficulties in controlling stereochemistry and problems of selective protection and manipulation of functional groups. There is one exception, however: the 1,4-addition approach, which is completely stereospecific and allows for excellent control over the C-15 center. The third general class of syntheses relies on the relatively easier proposition of controlling stereochemistry in rigid cage-like structures. Bulky reagents are effectively employed to attack from predetermined directions, and one or more rings are subsequently

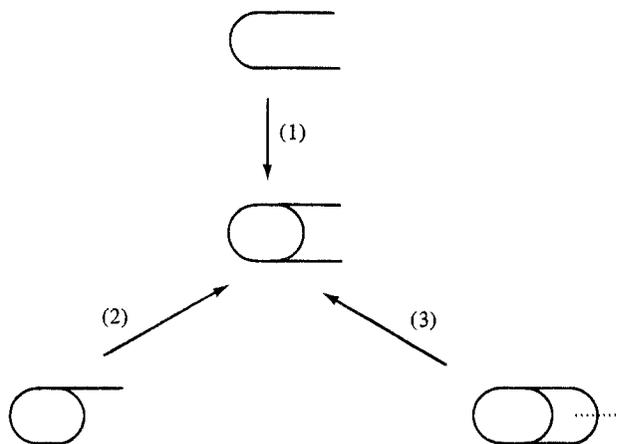


Chart 2.1. Classification of prostanoid syntheses.

cleaved during the synthesis to unravel latent functionality, to establish the desired stereochemistry. An excellent illustration of this approach is Corey's bicycloheptane synthesis discussed separately in Section 8.

C. Commercial Feasibility

A desirable prostaglandin synthesis would be adaptable for production of all the primary prostaglandins and analogs in optically active form from a single precursor. Resolution must be accomplished at an early stage, as has been done in the Corey synthesis, or optical activity must be conferred by the use of chiral reagents. Microbial transformations offer a promising alternative for production of optically active compounds without resorting to chemical resolution. Alternatively, the synthesis could commence from readily available, optically active starting materials.

From the commercial point of view the synthesis should be of the converging type, involving a relatively small number of steps. Furthermore, the synthesis should be adaptable to large scale, although in the synthesis of such complex polyfunctional molecules it is very difficult to avoid using sophisticated and expensive reagents, some of which can be quite hazardous and difficult to handle even at the pilot-plant scale. Many of the syntheses that have been developed thus far require chromatographic separations at one stage or another. However, chromatographic separations, which are perfectly acceptable in the laboratory, often make the process quite undesirable on a larger scale and therefore, syntheses involving a minimum number of chromatographic separations are preferred. In spite of the various handicaps of the present approaches to prostaglandins, there is no doubt in the author's mind that a practical synthesis can be speedily tailored today for production of a specific prostaglandin analog, once it is identified.

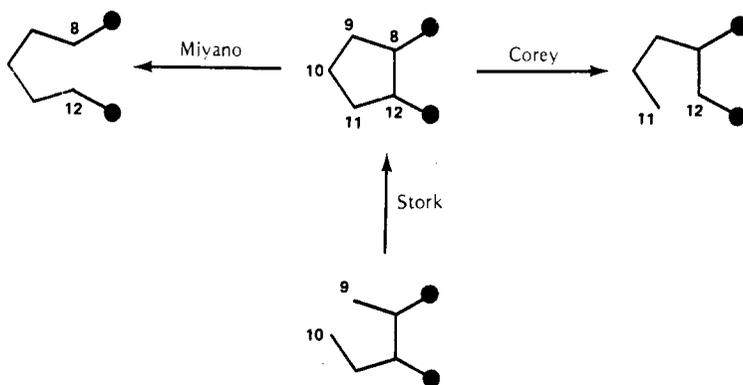
D. Outline of Discussion

In the discussion that follows, syntheses of the primary prostaglandins, the E and the F prostaglandins, are discussed first in Sections 3 to 11. Of special interest to the reader looking for practical laboratory approaches to prostaglandins are the 1,4-conjugate addition (Section 5) and Corey's bicycloheptane (Section 8) approaches. The A, B, C, D, and H-type prostaglandins and the prostacyclin and thromboxanes are treated individually in Sections 12 to 18. Readers interested in 11-deoxyprostaglandins, which have often served as models for synthesis of more complex prostaglandins and are interesting biological substances in their own right, are referred to a detailed review elsewhere².

3. ACYCLIC PRECURSORS

One of the earliest approaches to prostaglandins have involved closure of the cyclopentane ring from acyclic precursors, usually by an aldol condensation. In general, however, the cyclization approaches have been limited by the rather formidable problems involving stereochemical control of ring substituents and selective protection of functional groups. Successful syntheses of natural prostaglandins using the cyclization approach were achieved by Corey and his associates at Harvard, Miyano at G. D. Searle, and by Stork and his group at Columbia. The Harvard Syntheses represent the first total synthesis of optically active natural prostaglandins, while Miyano's work is appealing because of its direct simplicity, and may have considerable potential in the manufacture of analogs. The synthesis of $\text{PGF}_{2\alpha}$ from D-glucose, developed by the Columbia group is a noteworthy example of the approach to natural products using carbohydrate-derived "chiral templates."¹²

Operationally, formation of the cyclopentane ring may be accomplished in a variety of ways: Miyano's approach involves formation of the $\text{C}_8\text{--C}_{12}$ bond, while Corey forges the $\text{C}_{11}\text{--C}_{12}$ bond. Syntheses involving $\text{C}_{10}\text{--C}_{11}$ and $\text{C}_9\text{--C}_{10}$ bond formation have also been described and noteworthy among these is the Columbia approach. No examples involving $\text{C}_8\text{--C}_9$ bond formation have been reported.



A. $\text{C}_{11}\text{--C}_{12}$ Bond Formation

Corey's syntheses, utilizing the cyclization approach, were reported in 1968. In these syntheses the five-membered ring was formed either by an aldol condensation, or a vinylogous aldol from open-chain precursors (Chart 3.1),

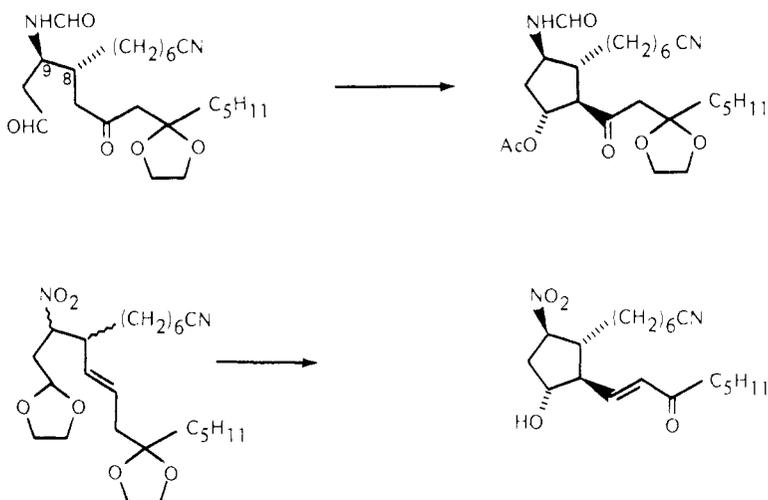


Chart 3.1. Corey's cyclization approaches.¹³ a. b.

and have been reviewed earlier.^{1, 2, 13} Although far from practical, Corey's syntheses were the first significant breakthroughs to natural prostaglandins and triggered the entry of several industrial laboratories into the search for therapeutically useful analogs. These syntheses were quickly supplanted by more practical approaches and are now only of historical interest.

B. C₈-C₁₂ Bond Formation

Miyano's Syntheses

The synthesis of PGE₁ and PGF₁ developed by Miyano and co-workers at Searle involves formation of the C₈-C₁₂ bond, thus proceeding through PGB-type intermediates (Chart 3.2). Although this approach has not been extended to prostaglandins of the two series, the relatively small number of steps involved, and good yields make this synthesis quite attractive for analog synthesis.

The synthesis, as originally disclosed by Miyano and Dorn,¹⁴ was not entirely stereoselective and subsequently had to be modified.¹⁵ The cyclopentane nucleus was formed by two aldol-type condensations starting with the β -ketoacid **1** and styryl glyoxal **2** readily available by selenous acid oxidation of benzalacetone. Cleavage of the styryl double bond in **4**, using osmium tetroxide and periodate, afforded the unsaturated aldehyde **5**. Prior to the key reduction step, which establishes the relative stereochemistry of C-8, C-11, and C-12 substituents, one face of the molecule was made less accessible to approach by the reducing species by anchoring the relatively bulky tetrahydropyranyl ether

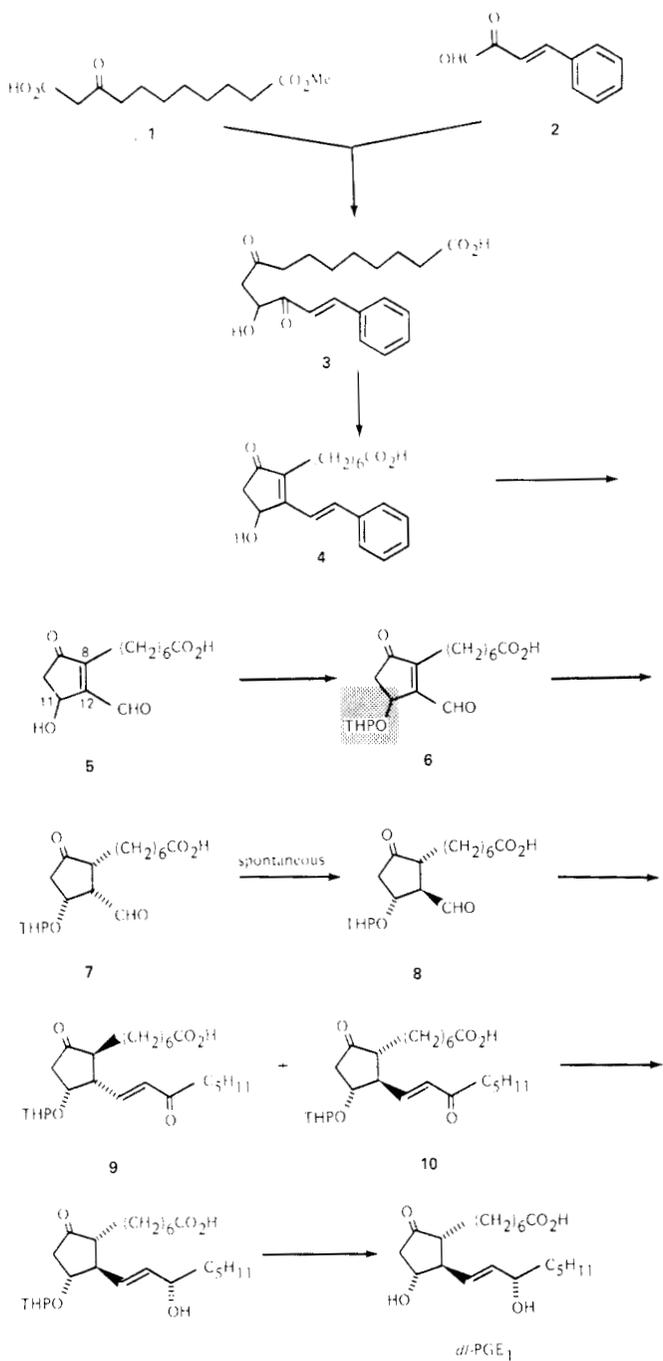


Chart 3.2. Miyano's synthesis.¹⁵

group to the C-11 hydroxyl. Reduction was accomplished using aqueous chromous sulfate solution and the resulting aldehyde **8** was subject to the Wittig reaction for introduction of the ω -chain, furnishing **10** as the major product, and with less than 20% contamination by the undesired 8,12-bisepiisomer (**9**). Isomerization of **7** to **8** appears to have occurred spontaneously during workup of the reduction mixture. The 15-dehydro-PGE₁ THP ether (**10**) was obtained in 25-30% overall yield from the unsaturated aldehyde **5**. Reduction of **10** with lithium thexyl tetrahydrolimonyl borohydride preferentially introduced the 15(*S*)-hydroxyl (4:1 ratio), and was followed by deprotection to furnish *dl*-PGE₁. It is noteworthy that the key styryl intermediate **4** has been resolved microbiologically¹⁶ and chemically via the (*R*)-(-)- α methoxyphenylacetic esters¹⁷. The (-)-4(*R*)-isomer was converted as described above into (-)-PGE₁.¹⁵

Kojima-Sakai Syntheses

Another example of the C₈-C₁₂ bond formation approach is the general route to prostaglandins developed by Kojima and Sakai at Sankyo Co., Japan.^{18,19} The synthesis (Chart 3.3) involves as its key step the base-catalyzed cyclization of a diketoester **2** to afford the functionalized cyclopentenone **3**. Introduction of three of the asymmetric centers (C-8, C-9, and C-12) on the cyclopentane ring is achieved simply by hydrogenating **3** over palladium on charcoal to give the *trans-cis*-cyclopentanone **4**, while the fourth center (C-11) is introduced under influence of the already established C-8 and C-9 centers by reduction with sodium borohydride (**4**→**5**). Stereochemistry of the key intermediate **4** has been rigorously established by chemical and spectral means.²⁰ The synthesis has been utilized for synthesis of PGF_{1 α} ¹⁸ as well as PGE₁.¹⁹ This approach is rather lengthy, and the overall yield is poor. While the yield of **4** from the starting ketoester is quite good (37%), the remaining steps from **4** to PGF_{1 α} proceed in a total yield of only 6.7%.

Johnson's Synthesis

The utility of PGB-type intermediates generated by forging the C₈-C₁₂ bond is further illustrated by Johnson's chiral synthesis of the key prostaglandin intermediate **9**, starting from (*S*)-(-)-malic acid (Chart 3.4).²¹ The lactone **9** is a key intermediate in Corey's bicycloheptane approach and has been transformed into a variety of prostaglandins.

Treatment of (*S*)-(-)-malic acid with acetyl chloride gave *S*-(-)-2-acetoxysuccinic anhydride **1**, which was converted to the corresponding succinyl chloride **2** with dichloromethyl ether in presence of zinc chloride. Bishomologation using the dianion of methyl hydrogen malonate furnished the unstable dimethyl (*S*)-(-)-4-acetoxy-3,6-dioxosuberate (**3**), which was cyclized to a mixture of cyclopentenones **4** and **5**. The fact that **5** was obtained predominantly is probably due

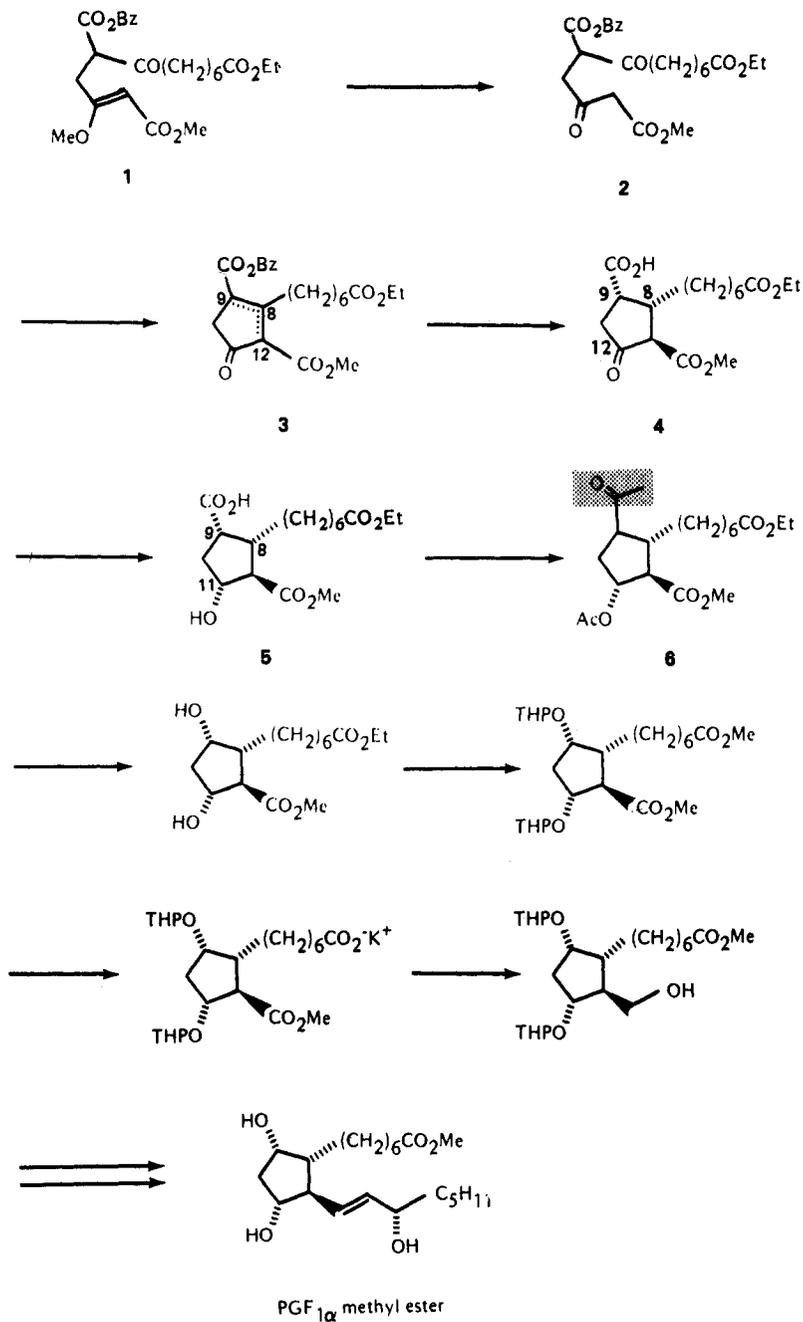
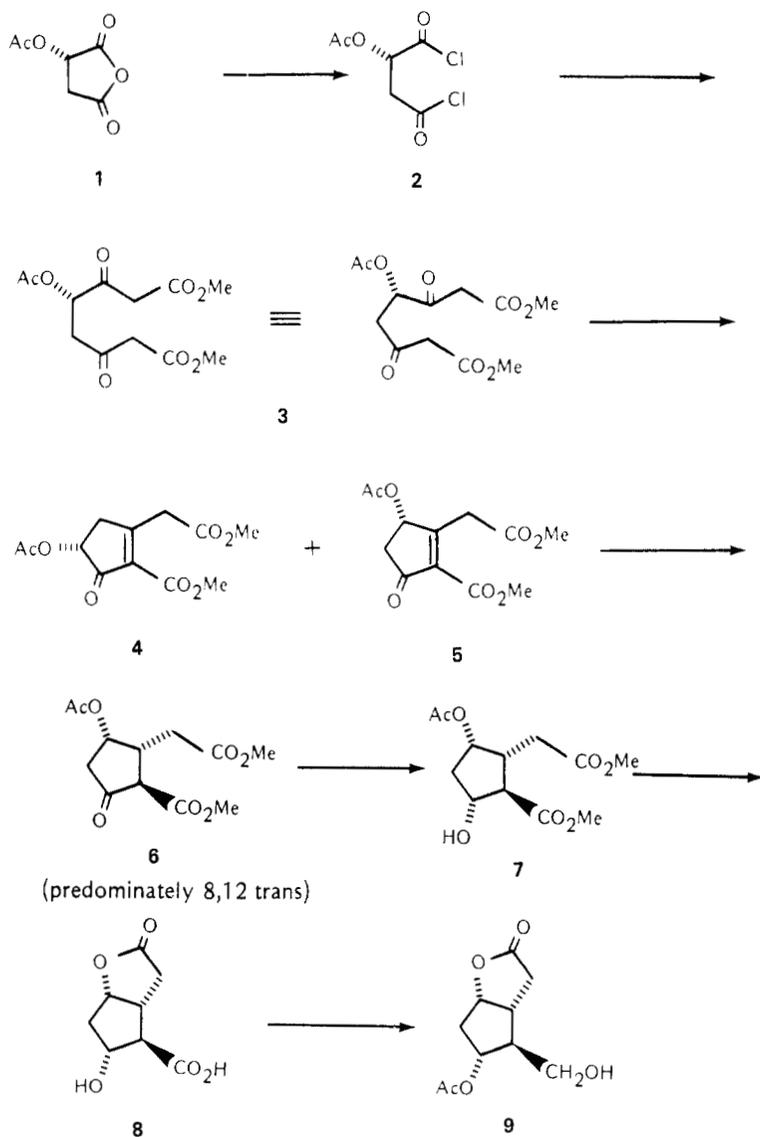
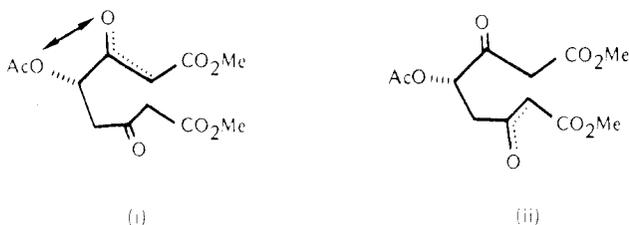


Chart 3.3. Synthesis of PGF_{1α} by Kojima and Sakai.

to the fact that the enolate ion (1) leading to 4 is destabilized with respect to (2) because of an interaction between the acetoxy group with the enolate oxygen atom. In any event pure 5 was obtained by direct crystallization from the reaction mixture, and the overall yield of 5 from 2 was 50%.



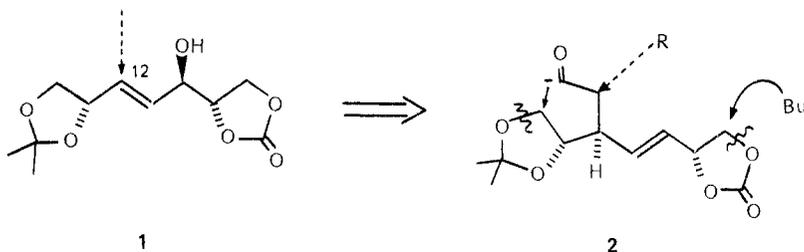
Catalytic reduction of **5** afforded predominantly the cyclopentanone **6**, containing the thermodynamically stable *trans*-stereochemistry. Reduction of **6** with sodium borohydride in buffer followed by hydrolysis of the crude reduction product with KOH in methanol, and subsequent acidification led to the carboxylactone **8**. Reduction of the carboxyl group in **8** was accomplished, after protection of the hydroxyl group as the acetate, by converting it to the acid chloride and treatment with borohydride. The overall yield of optically active **9** from (*S*)-(-)-malic acid is impressive, exceeding 30%.

Stork's Synthesis

An interesting example of the C₈-C₁₂ bond formation approach, using an intramolecular thermal ene reaction (3→4) to construct the cyclopentane ring has been reported by Stork and Kraus (Chart 3.5).²² The resulting enone **7**, which was also synthesized by a different procedure has been converted to PGF_{2α} (Section 5.6).

C. C₉-C₁₀ Bond Formation

Undoubtedly the most successful and elegant resolution of problems of the cyclization approach to prostaglandins was accomplished by Stork and co-workers²³ in their synthesis of PGF_{2α} from an acyclic chiral precursor (Chart 3.6). The chiral building block in this synthesis is D-glucose, which already contains the future C-11 and C-15 hydroxyl groups in the correct absolute stereoarray. The remaining centers of asymmetry in the molecule are systematically introduced under influence of existing chirality (1→2). Establishment of the



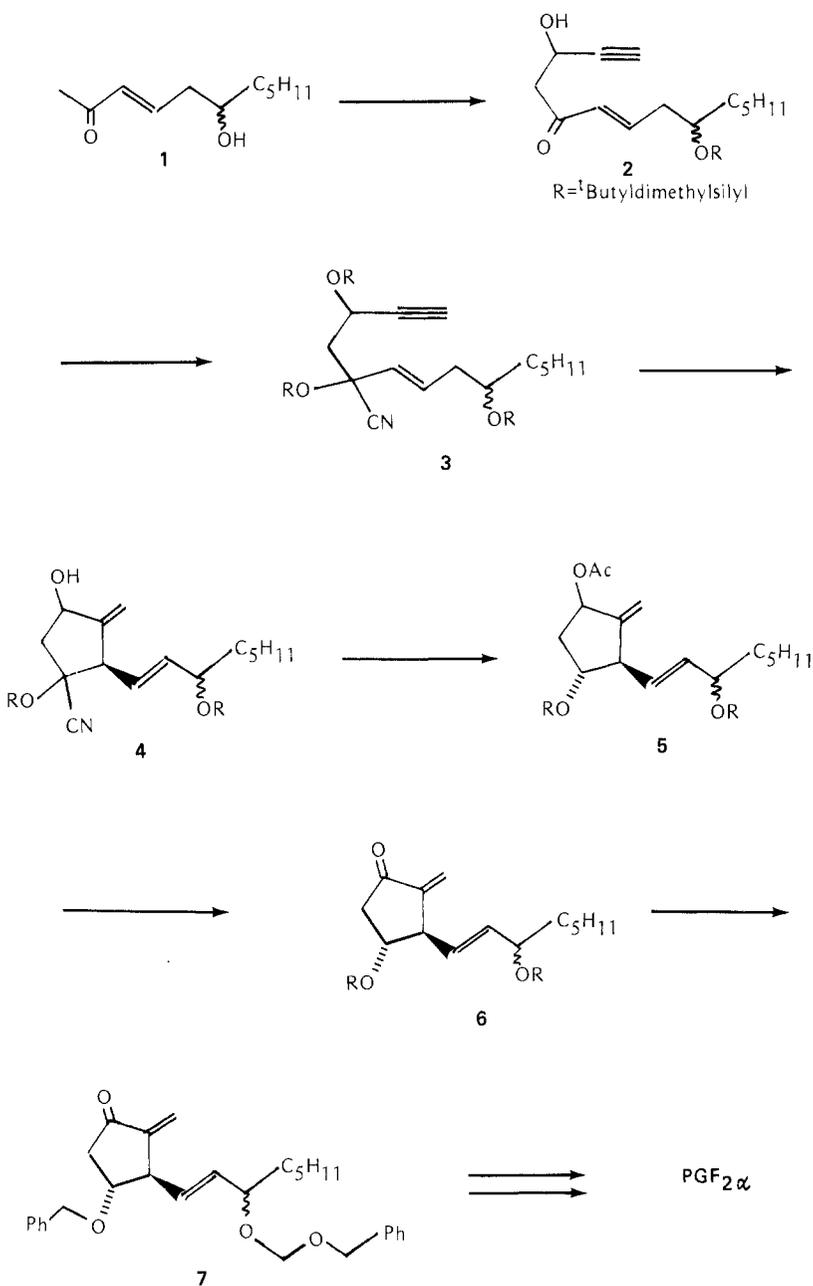


Chart 3.5. The ene reaction for synthesis of 3-hydroxycyclopentanones.²²

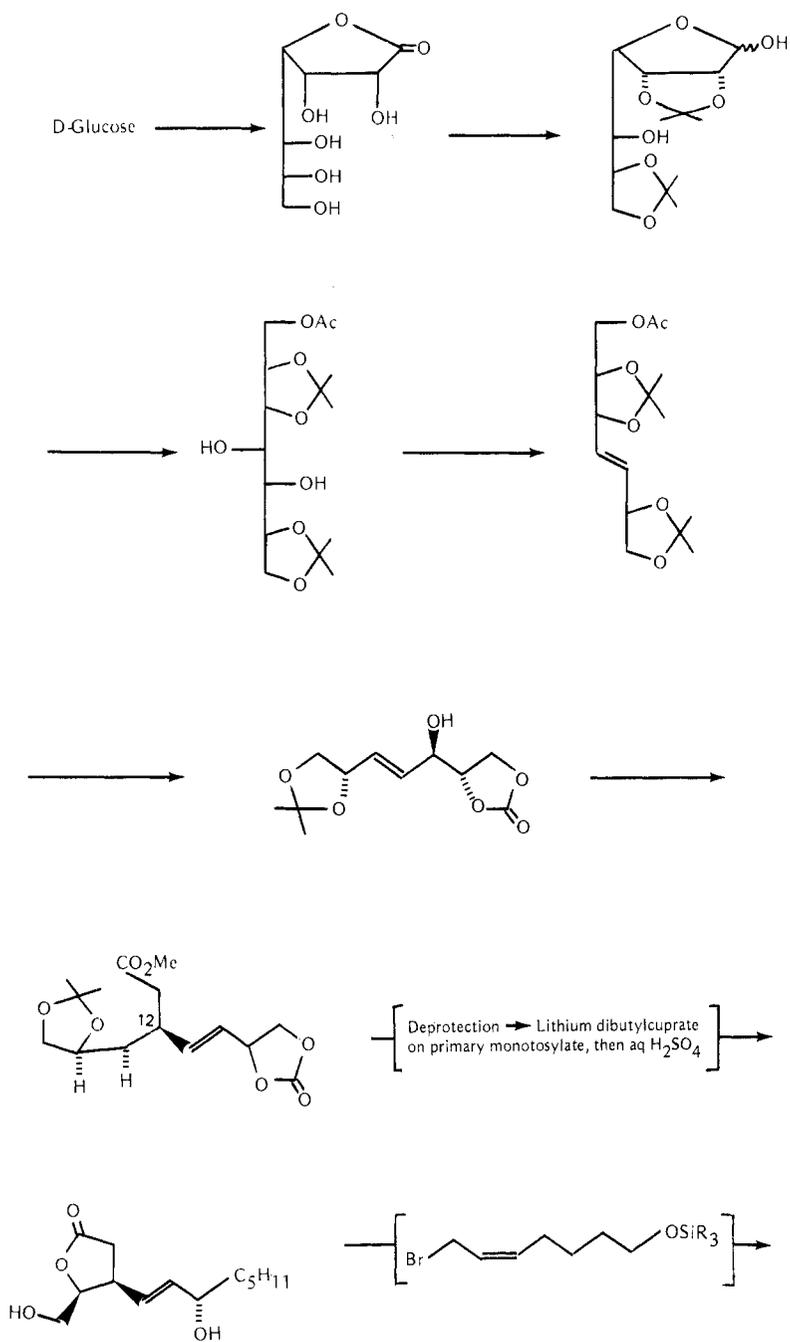


Chart 3.6. Chiral synthesis of $\text{PGF}_{2\alpha}$ from D-glucose.²³

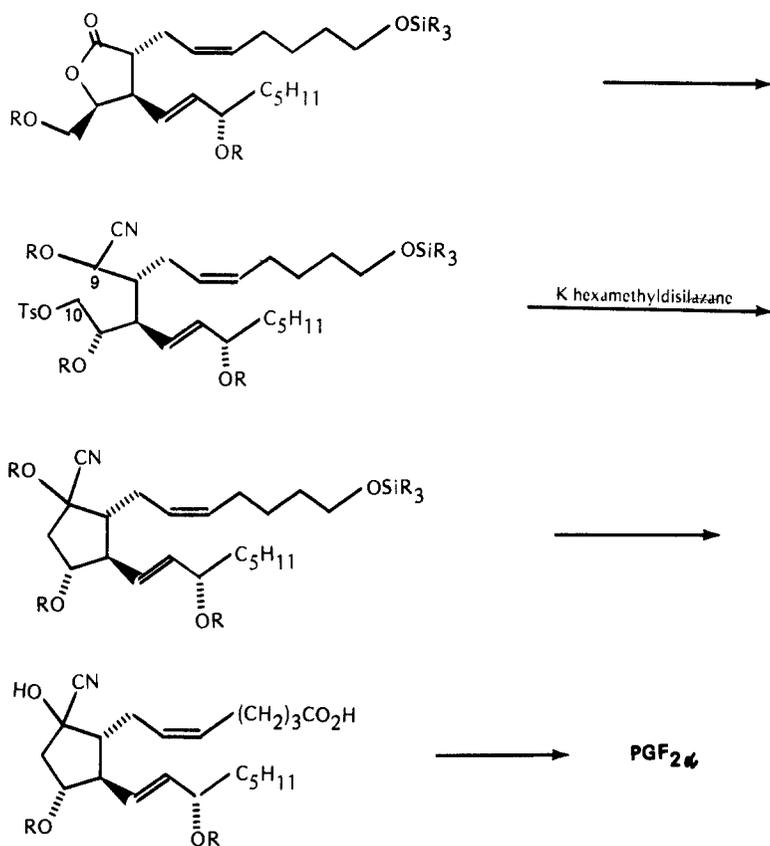

proper chirality at the eventual C-12 center was effected by the orthoester Claisen method. Construction of the cyclopentane ring involves formation of the C₉-C₁₀ bond and was carried out using the protected cyanohydrin method.²⁴

A synthesis of *d,l*-PGE₁, involving formation of the C₉-C₁₀ bond of the cyclopentane nucleus was reported by Finch and coworkers at Ciba-Geigy.²⁵ Although the synthesis, commencing from readily available starting materials, is characterized by good overall stereochemical control, it suffers from the lack of a suitable protecting group for the C-9 carbonyl, which is generated very early in the synthesis.

D. C₁₀-C₁₁ Bond Formation

This approach was utilized by Strike and Smith²⁶ of Wyeth laboratories for synthesis of a stereoisomeric mixture of 13,14-dihydro-PGE₁s. In this approach

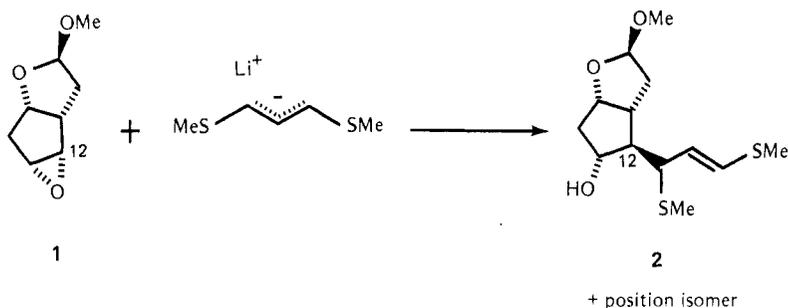
the cyclopentane ring is formed at a relatively late stage in the synthesis by a thermodynamically controlled intramolecular aldolization to give an A-type prostaglandin. Epoxidation and catalytic hydrogenation introduces the 11-hydroxyl group to furnish 13,14-dihydro-PGE₁ as a difficultly separable mixture containing all of the four possible C-11 and C-15 epimers.

4. CYCLOPENTANE PRECURSORS

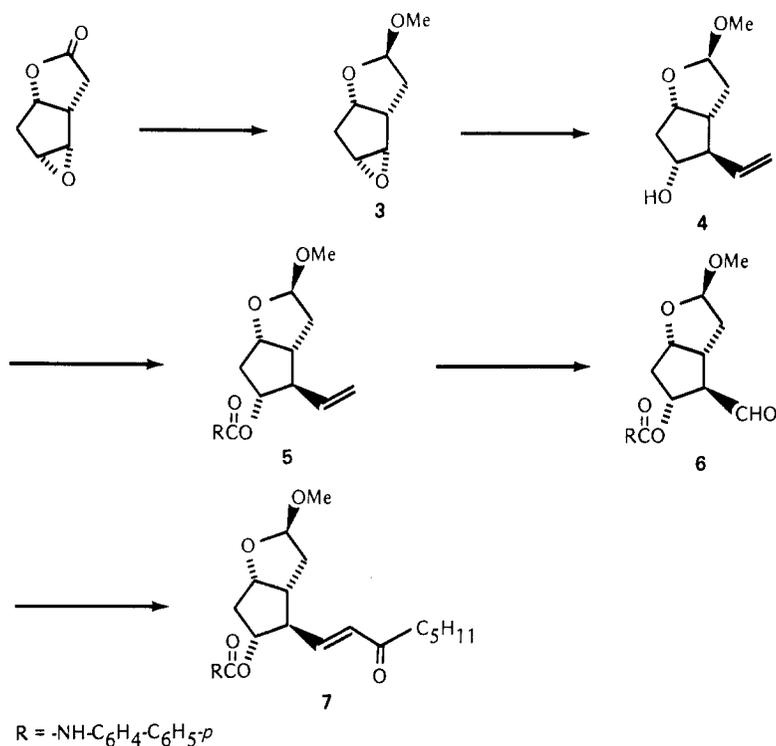
Several promising and convenient approaches to prostaglandins commence with a preformed cyclopentane nucleus bearing requisite functionality for elaboration of at least one of the side chains. The second chain may be attached by a variety of methods, which are summarized in this section. However, by far the most successful variant of this general approach involves the conjugate addition of elements of the ω -chain to a cyclopentenone precursor, as discussed separately in the next section.

A. Epoxide Opening – Corey's Approach

The synthesis of PGF_{2 α} in which the ω -chain is attached to the five-membered ring by epoxide displacement (1→2), using the latent β -formylvinyl anion bis(methylthio)allyllithium, with simultaneous generation of the C-11 hydroxyl, was described by Corey and Noyori in 1970.²⁷ Although this route to



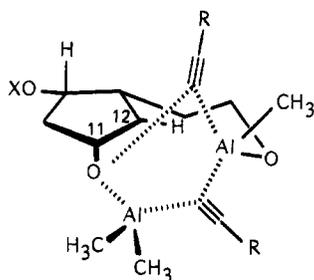
PGF_{2 α} was attractive by virtue of its directness, the low regioselectivity exhibited during the epoxide opening step make it impractical. Later work by Corey et al.²⁸ showed that the problem of lack of regioselectivity observed during opening of the epoxide could be overcome by the use of divinylcopperlithium (vinyl Gilman reagent). Thus reaction of 3 with vinyl Gilman reagent gave a 94% yield of 4 as the major product, together with only a minor amount of the undesired position-isomer resulting from attack at C-11 (Chart 4.1). The

aldehyde **6** has been converted, via the enone **7**, to various prostaglandins by well-established pathways.

B. Epoxide Opening – Fried's Approach

A general synthesis of prostaglandins involving epoxide displacement with dialkylalkynylalanes was developed by Fried and co-workers at the University of Chicago.²⁹ In this synthesis the fully functionalized lower side chain, in optically active form, is introduced on the oxidocyclopentane as an ethynylalane reagent. Like Corey's initial approach, described in the last section, this synthesis too suffers from a lack of stereospecificity during the key epoxide opening step. Subsequent work by Fried and co-workers³⁰ showed the regiospecificity of the alane-epoxide reaction is dependent on (1) composition of the alane reagent, and (2) the presence of a suitably placed carbinol function elsewhere in the molecule capable of forming a covalent aluminum-oxygen bond to ensure intramolecular alkylation at C-12 (cf. 1). Maximum regiospecificity was achieved

with the octynylmethoxymethylalane generated by the use of methoxy-methylchloroalane (MMCA).

The final improved synthesis of E and F prostaglandins using the regiospecific alane-epoxide reaction is outlined in Chart 4.2. Reaction of 4 with the alanate 8, prepared from (*S*)-3-*t*-butyloxy-1-octyne and MMCA, gave exclusively the triol 5a. The latter was debutylylated with trifluoroacetic acid to give 5b and

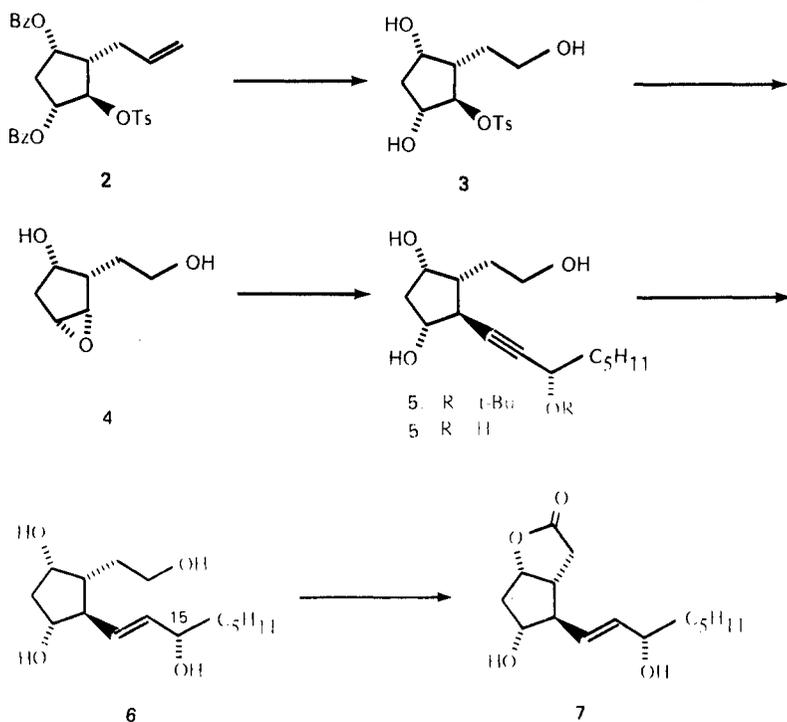
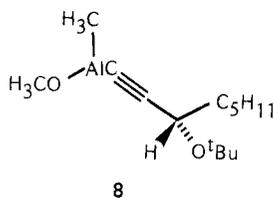


Chart 4.2. Fried's regiospecific opening of the epoxide.^{30,31}



reduced with lithium aluminum hydride to **6** and converted to the Corey lactone **7** in several steps³¹ or directly, using a novel selective dehydrogenation of **6** with platinum and oxygen.³⁰

C. Asymmetric Synthesis of Prostaglandin Intermediates

Partridge et al. at Hoffman-La Roche³² developed an ingenious asymmetric synthesis of the epoxy diol **6**, an important intermediate in Fried's general prostaglandin synthesis. The key to this approach is an asymmetric hydroboration, which proceeds in reasonable yields to furnish the product in high optical purity, without having to resort to a chemical resolution (Chart 4.3).

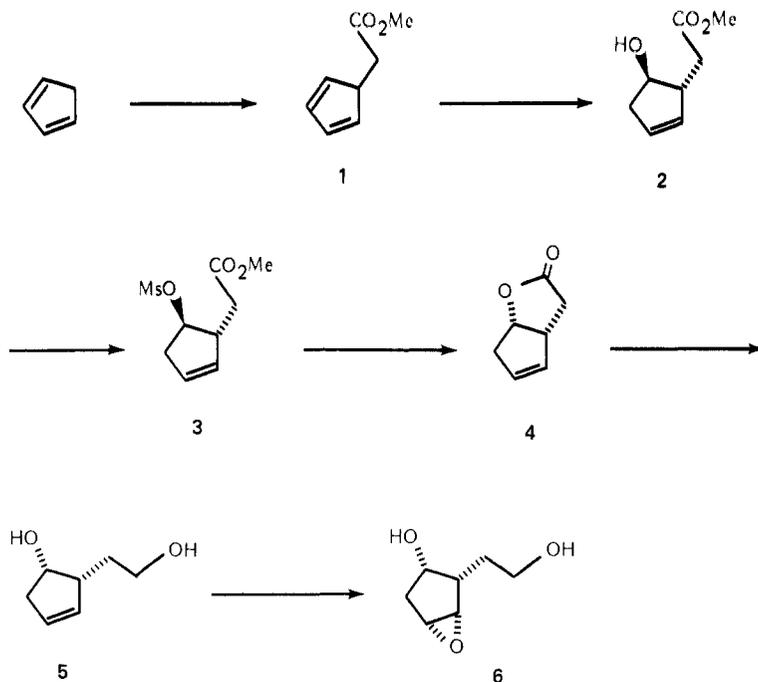
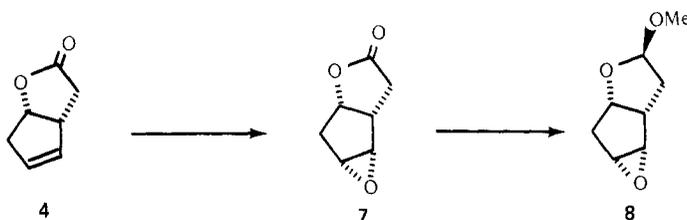


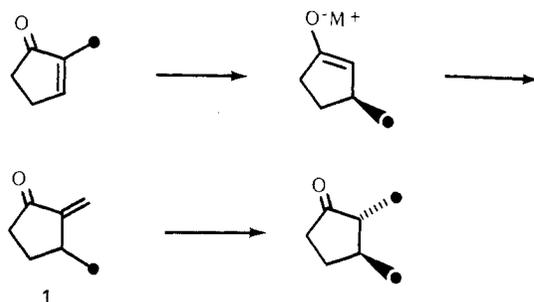
Chart 4.3. Chiral synthesis of prostaglandin intermediates.³²

The diene **1** was generated *in situ* by treatment of the sodium salt of cyclopentadiene with methyl bromoacetate in tetrahydrofuran. Asymmetric hydroboration with (+)-di-3-pinanylborane followed by alkaline hydrogen peroxide oxidation yielded the optically active hydroxy ester **2**, in 45% yield. The product thus obtained was at least of 96% optical purity. The hydroxy ester **2** was converted into the mesylate **3**, which afforded the optically pure lactone **4** upon treatment with base. The overall yield of **4** from cyclopentadiene was 40%. The lactone **4** was reduced with lithium aluminum hydride and converted to the desired epoxydiol **6**. Alternatively, the lactone **4** may be converted to the *cis*-epoxylactone **7**, and reduced directly to **6** with lithium aluminum hydride. This short asymmetrically induced synthesis also provides access to the epoxyacetal **8**, which has been converted into PGF_{2α} by Corey et al.²⁸



D. Stork's Approach

A novel general approach to prostaglandins via methylene cyclopentanone intermediates already bearing the ω -chain has been developed by the Columbia group.³³ Methylene cyclopentanones (cf. **1**) are readily prepared using a procedure developed by Stork and D'Angelo,³⁴ involving trapping of regio-



cally generated enolates with formaldehyde. Introduction of the remaining elements of the top chain in **1** is accomplished through conjugate addition to the α,β -unsaturated ketone. The synthesis is outlined in Chart 4.4.

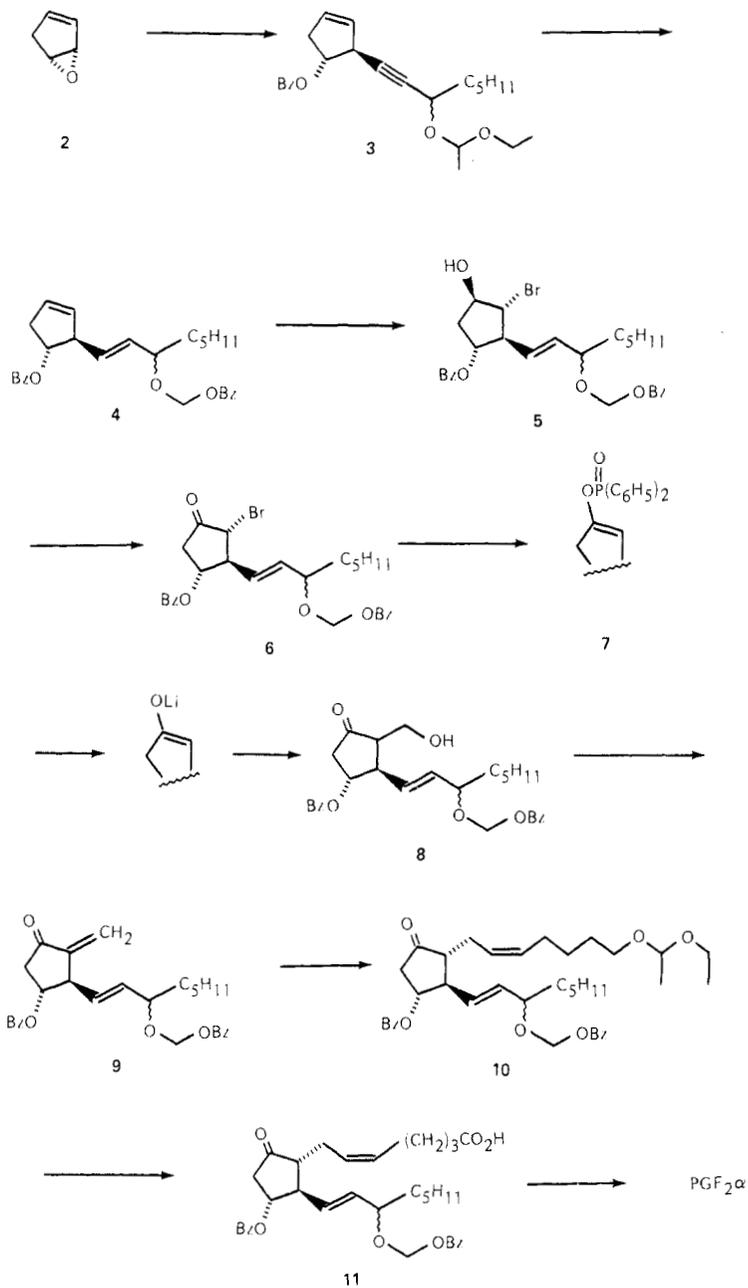
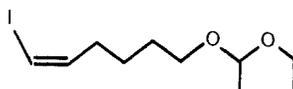


Chart 4.4. Stork's methylenecyclopentane approach to PGF₂α.³³

Introduction of the ω -chain on cyclopentadiene oxide (2) by epoxide opening with the lithium salt of 2-ethoxyethyl ether of 1-octyn-3-ol, followed by reduction to *trans*-vinylcarbinol and protection gave 4. The choice of protecting groups in 4 was critical to the success of the synthesis. The groups had to be stable to acid conditions, especially during deprotection of the primary alcohol in 10. The protecting group at C-15 had to be as electron-withdrawing as possible, while the reverse had to be true for the C-11 hydroxyl to prevent its elimination by base during the conversion of 8 to 9. Finally, both protecting groups had to be removable without harm to the C-15 allylic alcohol function.

Addition of the elements of hypobromous acid to 4 proceeded regiospecifically to give the bromohydrin 5. The observed regiospecificity was a consequence of the kinetic α -bromonium ion being displaced at the less hindered site, away from the side chain. Oxidation of the bromohydrin 5 with Jones reagent gave the bromoketone 6, which was reduced with methyl diphenylphosphinite to the enol phosphinate 7. Cleavage of the enol phosphinate with *t*-butyllithium smoothly afforded the corresponding lithium enolate, which was trapped with formaldehyde to give the hydroxymethylcyclopentanone 8 in excellent yield. Dehydration of 8 via the corresponding mesylate furnished the key methylenecyclopentanone 9 in 60% overall yield from 5.

For addition of the top chain, the divinylcuprate prepared from the vinyl iodide 12 was reacted with 9 to provide 10. Removal of the protecting group and oxidation gave the cyclopentanone acid 11, which was converted to PGF_{2 α} and its C-15 epimer. The two epimers, as the corresponding methyl esters, were separated by high pressure liquid chromatography.

E. Syntheses via Organoboranes

Several groups of workers have attempted boron-mediated cross-coupling reactions³⁵ for the addition of a carbon fragment or a fully functionalized ω -chain to cyclopentene precursors for generation of prostanoid structures. However, since only one of the carbon ligands attached to the boron is utilized during the cross-coupling process, such an approach is wasteful of one of the reaction components. The use of "mixed" dialkylboranes where one of the boron-bound carbon ligands (e.g., thexyl) has a low migratory aptitude is not entirely satisfactory, because migratory aptitude of ligands is both reaction-specific and substrate-dependent, and therefore not entirely predictable. Thus, while initial

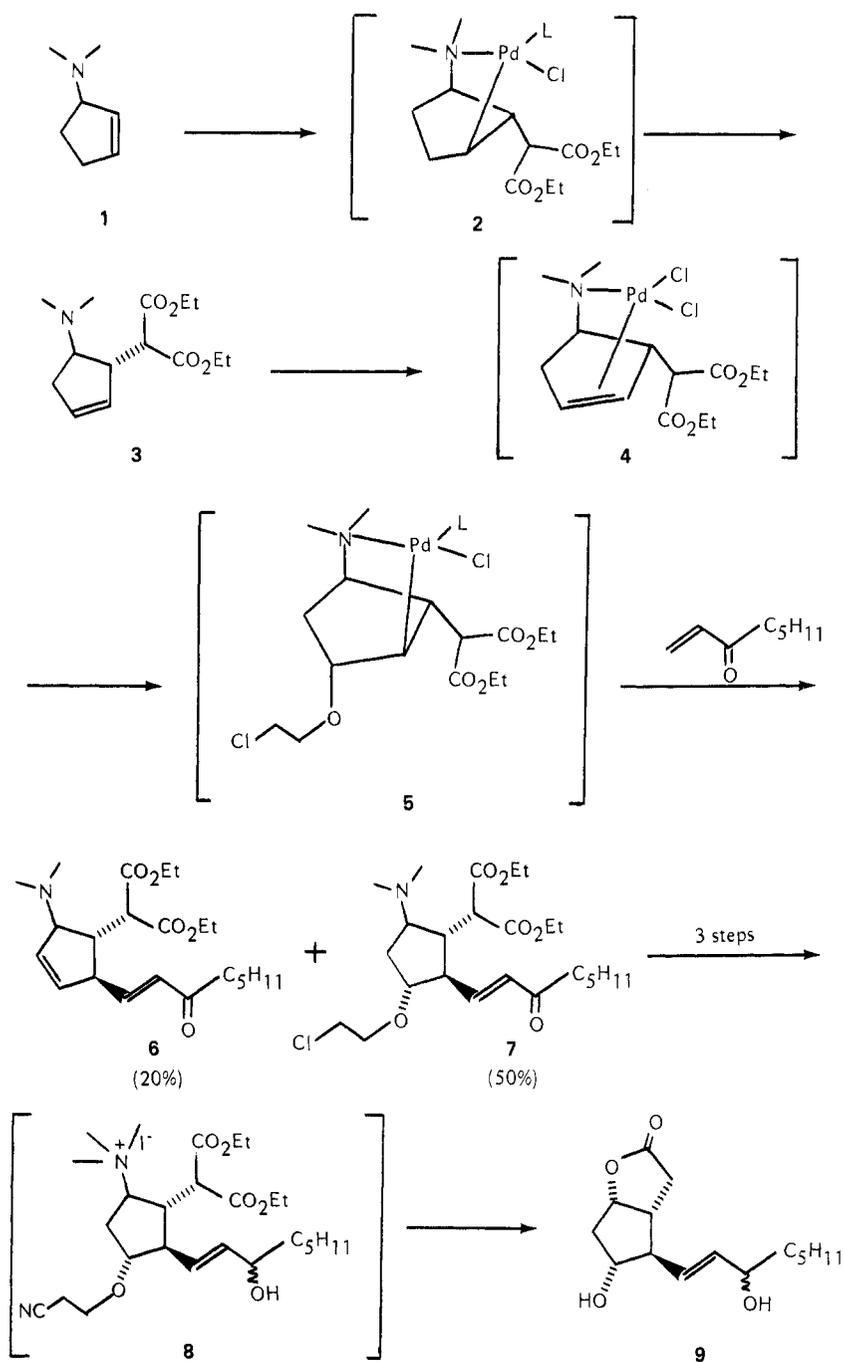


Chart 4.5. Holton's carbopalladation approach to PGF₂α.³⁸

studies with model systems have established the feasibility of this approach,³⁶ it has not been extended to the synthesis of a natural prostaglandin.

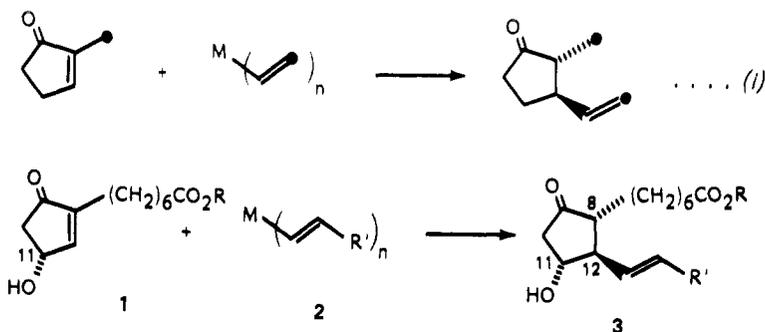
Evans et al.³⁷ have explored the use of boronic esters for the synthesis of prostanoids. Since oxygen ligands do not compete with carbon in the rearrangement of boronate complexes, boronic esters offer a promising alternative to "mixed" dialkylboranes as a means to conserve the carbon ligands attached to boron during the cross-coupling process.

F. Syntheses via Carbopalladation

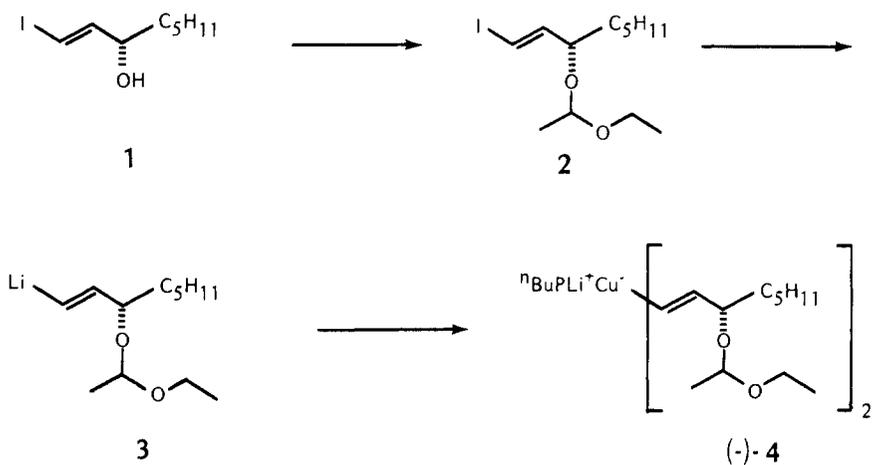
A novel approach to prostaglandins via carbopalladation has been described by Holton (Chart 4.5).³⁸ The synthesis involves direct attachment of the two side-chain fragments to the unactivated double bond of an appropriately substituted cyclopentene. In Holton's synthesis the four contiguous stereocenters about the cyclopentane ring are established from a single amine directing functionality. Following the dehydrocarbopalladation of **1**, the homoallylic alkoypalladation-retrovinylation of **3** occurs *trans* to the sterically bulky diethyl malonate group. Although the production of **7** from cyclopentadiene is achieved in three chemical steps and in 44% overall yield, the synthesis is handicapped by formation of 20% of the unwanted enone **6** along with the desired enone **7**. The alcohol **9** is the Corey lactone diol, which has been converted to PGF_{2α}.

5. CYCLOPENTANE PRECURSORS: CONJUGATE ADDITION APPROACHES

The conjugate addition of organometallic derivatives to α -substituted cyclopentenones provides an attractive, convergent approach to prostaglandins (i). This concept has been successfully applied, notably by Sih and co-workers at Wisconsin and a group at Syntex, to develop synthetic routes to PGE₁, PGE₂, 11-deoxyprostaglandins, and related compounds.

b. Preparation of PGE₁:

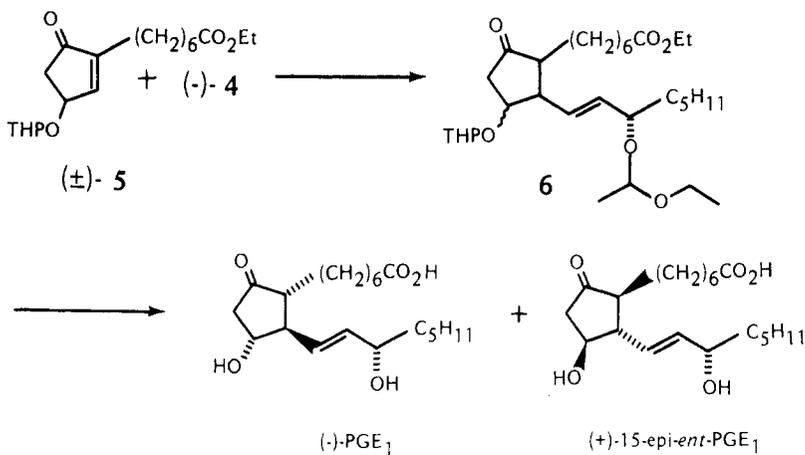


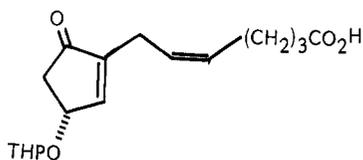
Chart 5.1. Synthesis of PGE₁ by Sih et al.

Ample precedent exists for the efficient and stereospecific transfer of a vinyl group from vinyl-ate complexes to the β -carbon atom of conjugated enones to provide γ,δ -unsaturated ketones.³⁹ Moreover, addition of the vinyl species 2 is expected to proceed from the less-hindered side of the "C-11" hydroxylated cyclopentenone 1, giving rise to a vinylated cyclopentanone (e.g., 3) in which the two side chains are in the thermodynamically more stable *trans* relationship. The cyclopentanone 3 thus has the desired prostaglandin configuration at all three of its asymmetric centers. An intriguing feature of this approach is that once configuration of the single asymmetric center at C-11 in 1 has been established, it dictates the eventual configurational outcome at C-8 and C-12, thus making possible a highly stereospecific and concise synthesis of prostaglandins.

A. Conjugate Addition of Vinylcopper Reagents

The conjugate addition of a vinyl copper reagent to an α -alkylated cyclopentenone for the synthesis of a prostanoid, 15-deoxy-PGE₁, was first reported in 1972 by Sih and co-workers⁴⁰. This was followed shortly afterward by a synthesis of PGE₁ (Chart 5.1) involving the addition of fully functionalized cuprate 4, complexed with tri-*n*-butylphosphine, to 2-(6-carbethoxyhexyl)-4-(2-tetrahydropyran-yloxy)cyclopent-2-en-1-one (5).^{41,42}

When the optically active cyclopentenone (-)-5 was used for the coupling, only (-)-PGE₁ methyl ester (65-70% yield based on 5) was isolated from the reaction mixture, thus providing a highly stereospecific synthesis of (-)-PGE₁.^{43,44} Similarly, using the optically active cyclopentenone 7, which incorporates the future 5,6-double bond in its side chain, Sih et al. accomplished a completely stereospecific synthesis of (-)-PGE₂.^{44,45}

An almost identical approach to PGE₁ was developed independently by a Syntex group.⁴⁶ However, the yield obtained by these workers, in contrast to the Wisconsin group, was very low, and has been attributed to choice of trimethyl phosphite as the complexing ligand. A variant of this approach, also developed at Syntex,⁴⁷ involves conjugate addition of divinylcopperlithium instead of the fully functionalized side chain. The vinyl group introduced in



this manner serves as a latent aldehyde and is used as a handle for elaborating the lower side chain.

B. Alanate Additions to Cyclopentenones

A group at Lederle Laboratories^{48,49} explored the utility of conjugate addition of lithium *trans*-alkenyltrialkylalanate reagents to cyclopentenones for prostaglandin synthesis. *trans*-Alkenylalanates undergo selective transfer of the alkenyl ligand with retention of configuration,⁵⁰ 1,2-addition of the alkenyl group to the unsaturated carbonyl is observed, and there is no reaction at the ester function. Furthermore, the alkyl ligands do not appear to add to carbonyl function of the cyclopentenone **4**. The approach has been utilized for a synthesis of *dl*-PGE₁ (Chart 5.2).⁴⁹ The alanate required for the synthesis was initially prepared from a propargylic ether via hydroalumination, but later an improved

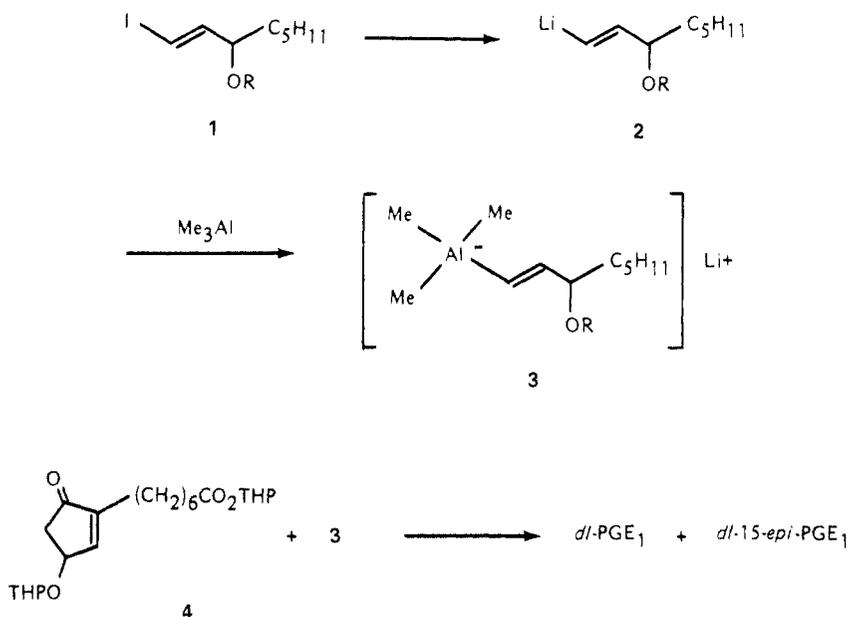


Chart 5.2. Lederle synthesis of prostaglandins.

procedure was developed. The process involved preparation of the 3-oxy-*trans*-1-alkenyllithium by an exchange reaction, followed by treatment of the alkenyllithium with trialkylaluminum to generate the ate complex (2→3).⁵¹

C. Copper(1) Catalyzed Conjugate Addition of Grignard Reagent

Copper(1) catalyzed conjugate addition of the Grignard reagent prepared from 3-trityloxy-*trans*-1-bromide (1) to an appropriate cyclopentenone precursor has also been used for synthesis of PGE₁ (Chart 5.3).⁵² Like the alanate reagents, the Grignard conjugate addition process also makes efficient use of the β-chain precursor (1), unlike the corresponding cuprate procedures in which half of the precursor cannot be utilized.

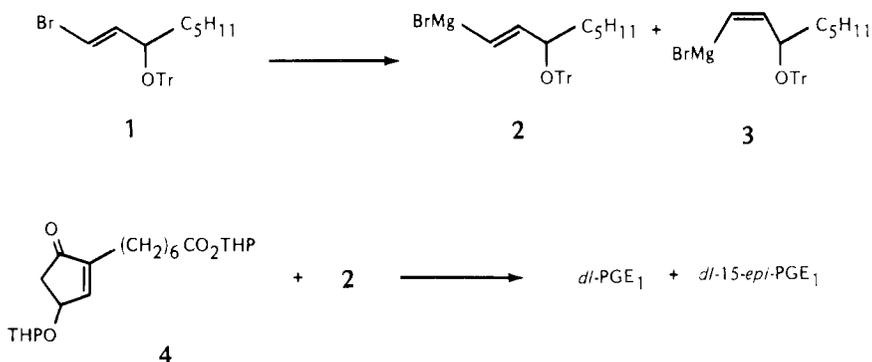


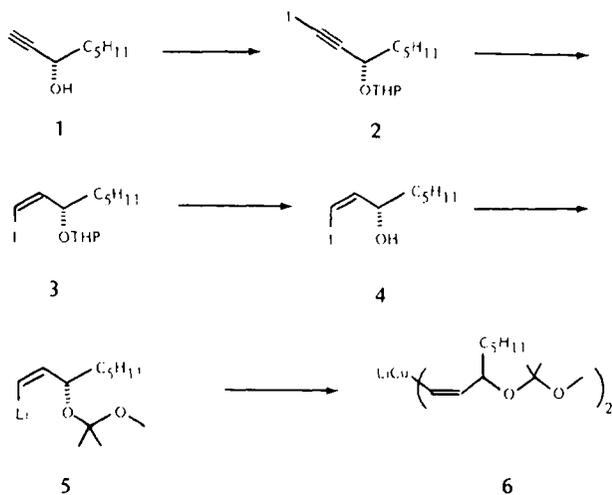
Chart 5.3. Synthesis of PGE₁ via conjugate addition of a Grignard reagent.⁵²

D. The *cis*-Vinyl Route to PGE₁

Extending their studies on the conjugate addition approach to prostaglandins, the Syntex group also examined the addition of *cis*-divinylcuprates to cyclopentenones.⁵³ In marked contrast to the corresponding *trans*-divinylcuprates, the condensation of *cis*-divinylcuprates proceeded with high stereoselectivity and in excellent yields to furnish 9-oxo-13-*cis*-15β-prostenoic acids. Subsequently, Miller et al.⁵⁴ found that the 13-*cis*-prostenoic acid could be efficiently converted to the corresponding 13-*trans*-prostenoic acid via a highly stereospecific sulfenate-sulfoxide rearrangement, thus completing an ingenious new total synthesis of prostaglandins (Chart 5.4).

When the 11-THP ether 8, derived from 7 and 6, was treated with *p*-toluenesulfonyl chloride in presence of triethylamine it gave a sulfenate ester (9), which

b. Preparation of *PGE*₁ methyl ester:

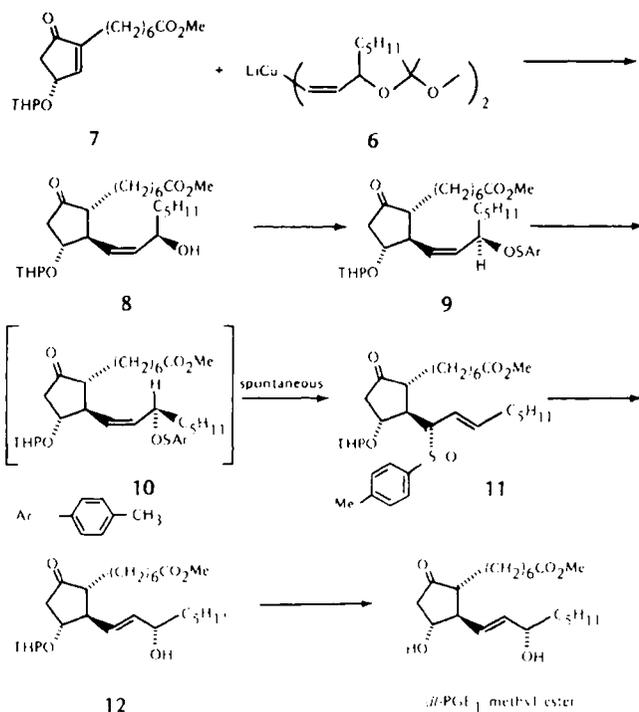


Chart 5.4. Synthesis of prostaglandins via stereospecific sulfonate-sulfoxide transformations.

spontaneously underwent [2,3]sigmatropic rearrangement to the sulfoxide **11** in 81% yield. It should be noted that rearrangement of the sulfenate ester proceeds through the thermodynamically more stable transition state, which resembles the conformer **10** more than **9**. Treatment of the sulfoxide **11** with trimethylphosphite gave the ketol **12**, which was subjected to acid hydrolysis to furnish *dℓ*-PGE₁ methyl ester. The approach has also been extended for the preparation of natural PGE₁,⁵⁵ and for the synthesis of *dℓ*-19-hydroxy-PGE₁.⁵⁶

E. Preparation of the Cyclopentyl Synthone

Several practical syntheses of the key α -alkylated cyclopentenone, 2-(6-carbomethoxyhexyl)-4-hydroxycyclopent-2-en-1-one (**5**), the PGE₁ precursor synthone, and the corresponding precursor for PGE₂ synthesis have been developed.

PGE₁ Precursor Synthone

One approach to the PGE₁ precursor synthone is based on the well-known^{1,2,44} 1,2,4-cyclopentane trione acid **1**. Conversion of the triketone **1** into **5** (Chart 5.5) has been accomplished by Sih, using the sequence: (1) asymmetric reduc-

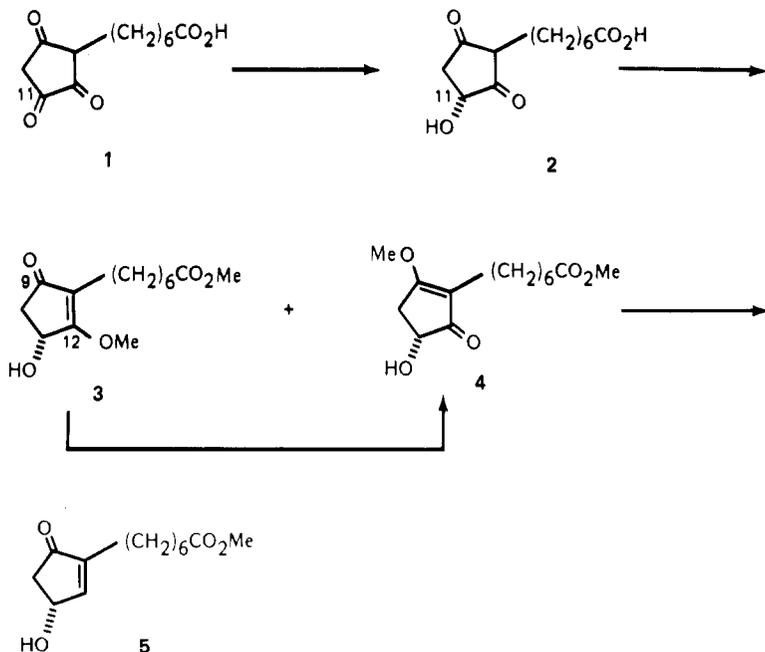
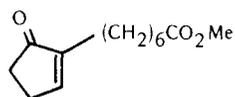


Chart 5.5. Synthesis of PGE₁ precursor synthone by Sih et al.

tion of the C-11 carbonyl to yield the (*R*)-alcohol 2; (2) conversion of 2 into the enolate 3; and (3) reduction of the C-9 carbonyl followed by allylic rearrangement to yield 5.

Monoreduction of 1 to give racemic material is readily achieved chemically by hydrogenation over palladium catalyst, but asymmetric reduction is best accomplished by a wide variety of microorganisms.⁴⁴ Although not entirely satisfactory, partial asymmetric catalytic hydrogenation of 1 has also been carried out using a soluble rhodium catalyst in the presence of chiral phosphine ligands. The diketone 2 was converted to a mixture of methyl enol ethers 3 and 4. Since the enolate at C-9 is sterically less crowded than at C-12, treatment of 3 with a trace of acid gave 4, which was reduced to 5. Pappo et al.⁵⁷ have reported a novel resolution of racemic 5. The hydroxycyclopentenone 5 has also been prepared by either allylic^{46,49} or microbial⁵⁸ hydroxylation of the readily available cyclopentenone 6. Sih and co-workers^{40,42} also developed an ingenious synthesis of the cyclopentenone 5 utilizing the 1,4-cycloaddition

of singlet oxygen to an appropriately substituted cyclopentadiene (Chart 5.6). The chiral synthesis of the enone 5 from D-glyceraldehyde by Stork and Takahashi is also noteworthy (Chart 5.7).⁵⁵

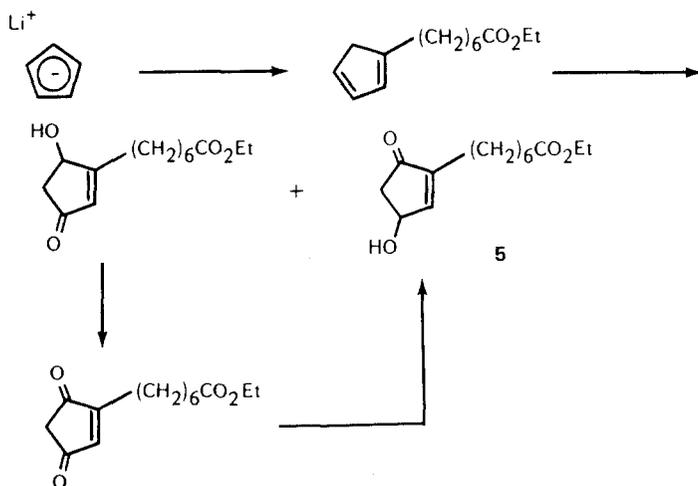
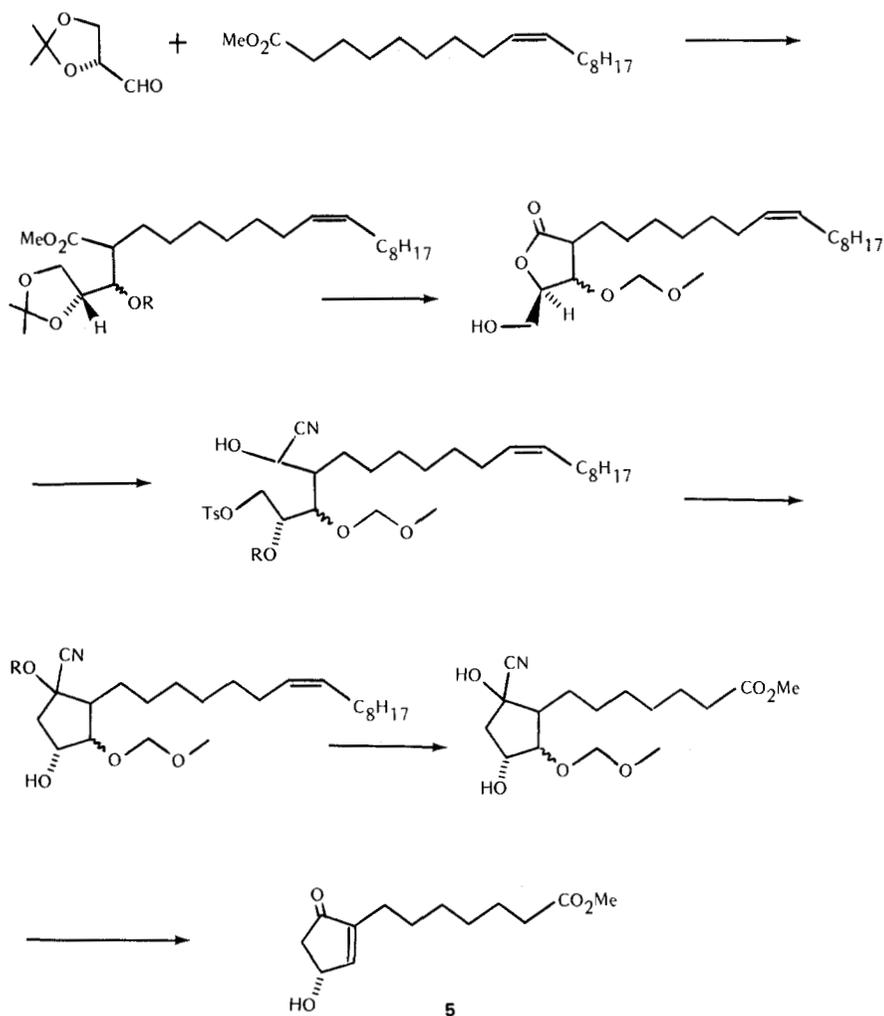


Chart 5.6. The 1,4-cycloaddition approach to PGE₁ precursor synthon.

Synthesis of the PGE₂ precursor, 2-(6-carbomethoxy-*cis*-2-hexenyl)-4(*R*)-hydroxy-2-cyclopenten-1-one (1), reported by Sih et al.,^{44,45} is patterned after their earlier general approach to the corresponding PGE₁ precursor. The overall synthesis, however, is rather lengthy and has been superseded by other, more convenient, approaches.

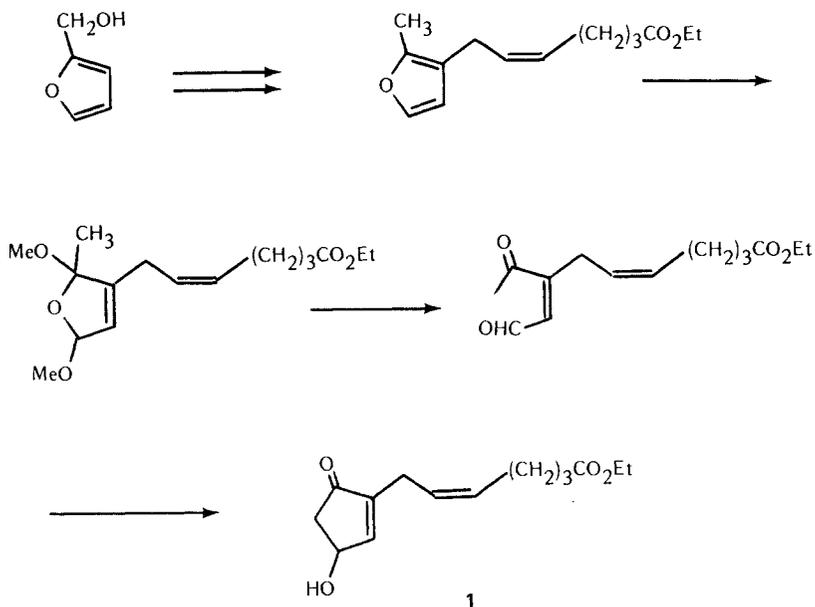


Chart 5.8. Synthesis of hydroxycyclopentenones from furfuryl alcohol.⁵⁹

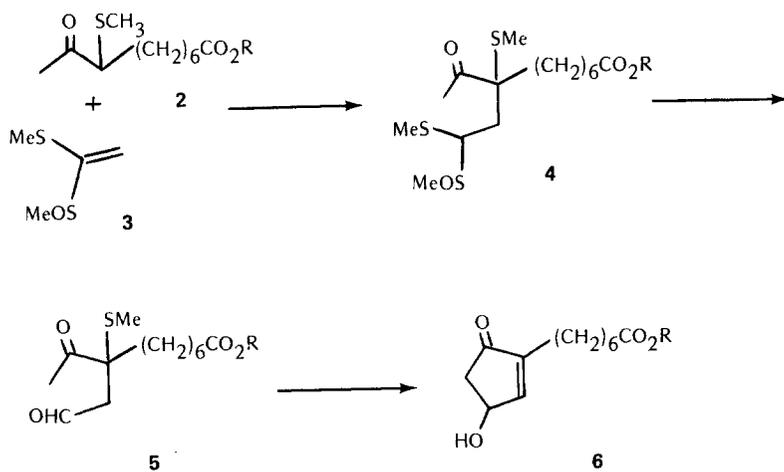
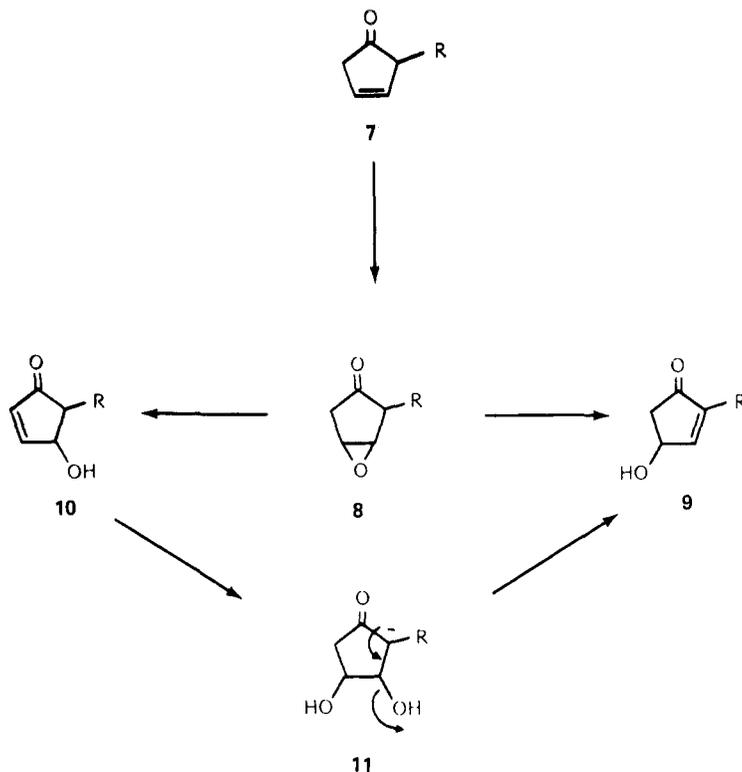


Chart 5.9. Cyclization approach to hydroxycyclopentenones.⁶⁰

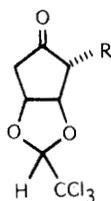
Two recent noteworthy cyclization approaches to the hydroxycyclopentenones involve intramolecular aldol condensation of open-chain precursors generated from the dihydrofuran **1** (Chart 5.8)⁵⁹ or constructed by the addition of the enolonium ion equivalent **2** to the ketone enolate **3** (Chart 5.9).⁶⁰

Several practical approaches to the PGE₂ precursor synthon commence from the readily accessible cyclopent-3-ene-1-ones (**7**). Stork et al. and a Lederle group have shown that epoxyketones of the type **8**, obtained from **7**, are readily isomerized to the desired 4-hydroxycyclopentenones **9**, while Gruber et al. obtained the same products from the isopropylidene derivative of the diol **11**. The epoxyketone **8** can a priori undergo base-catalyzed elimination in two



possible directions to give either **9** or **10**. However, treatment of **8** with base gives rise to a mixture of **9** and **10** in which the latter, the product of kinetically formed (less substituted) enolate, predominates. Isomerization of **10** to the more stable **9** requires rapid hydration of **10** to the diol **11**, which then undergoes dehydration. Stork et al.⁶¹ found that making the hydration step effectively intramolecular, by the addition of chloral during treatment of **10** with base,

rapidly and efficiently produced isomerization of **10** to **9**, presumably via the acetal intermediate **12**. Thus the key epoxyketone **13**, obtained by Stork⁶¹

using the route outlined in Chart 5.10, upon treatment with triethylamine followed by chloral, furnished a 69% yield of the desired enone **14**. Equilibration of a mixture of the corresponding α - and β -epoxyketones in aqueous sodium

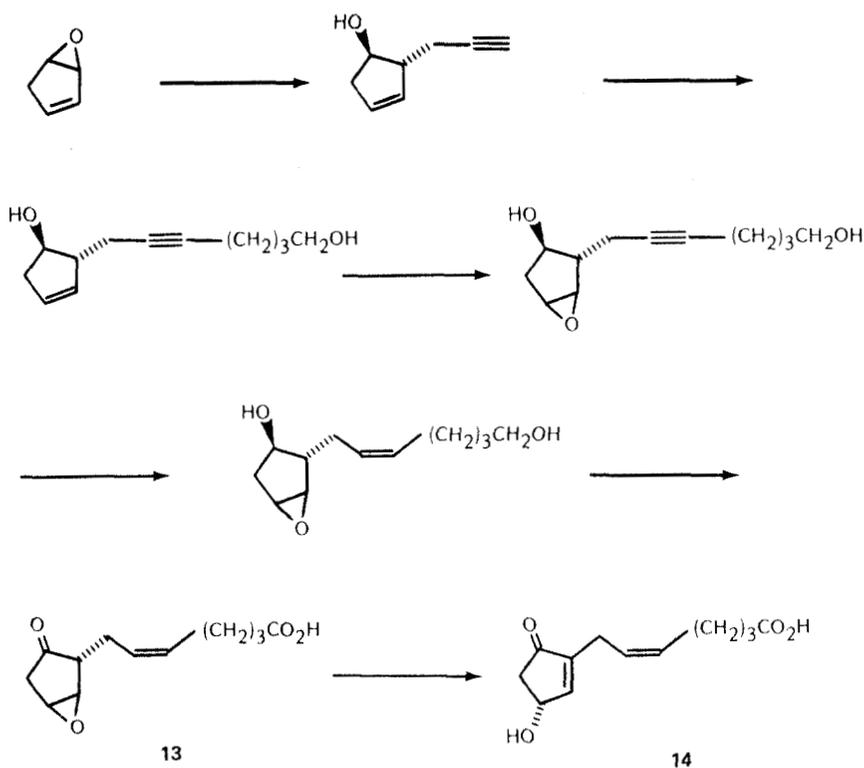
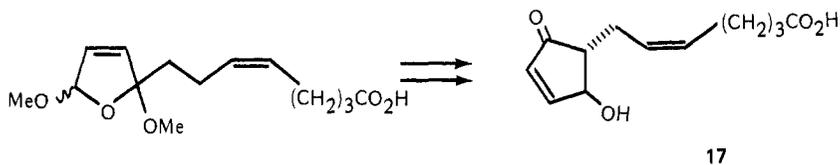


Chart 5.10. Stork's synthesis of PGE₂ precursor synthon.

Rearrangement of cyclopentenols of the type **10** to **9** also provides a convenient access to the PGE₂ precursor synthon. The requisite cyclopentenol **17** may be obtained from furyl precursors via a dimethoxyfuran⁶⁵ or directly by an acid-catalyzed rearrangement of a furyl carbinol.⁶⁶



F. Conjugate Addition – Enolate Trapping Approach

A converging approach to prostaglandins would be available if the regiospecific cyclopentane enolate **2**, generated by the conjugate addition of organocopper reagent, can be trapped by alkylation with the fully functionalized top chain, or

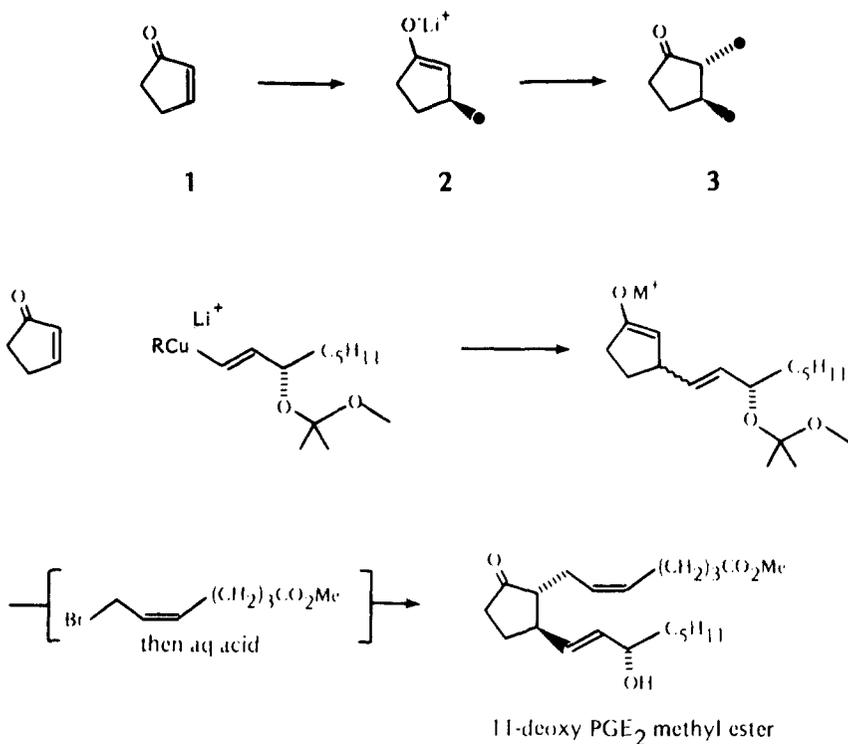


Chart 5.12. Conjugate addition-enolate trapping approach to prostaglandins.

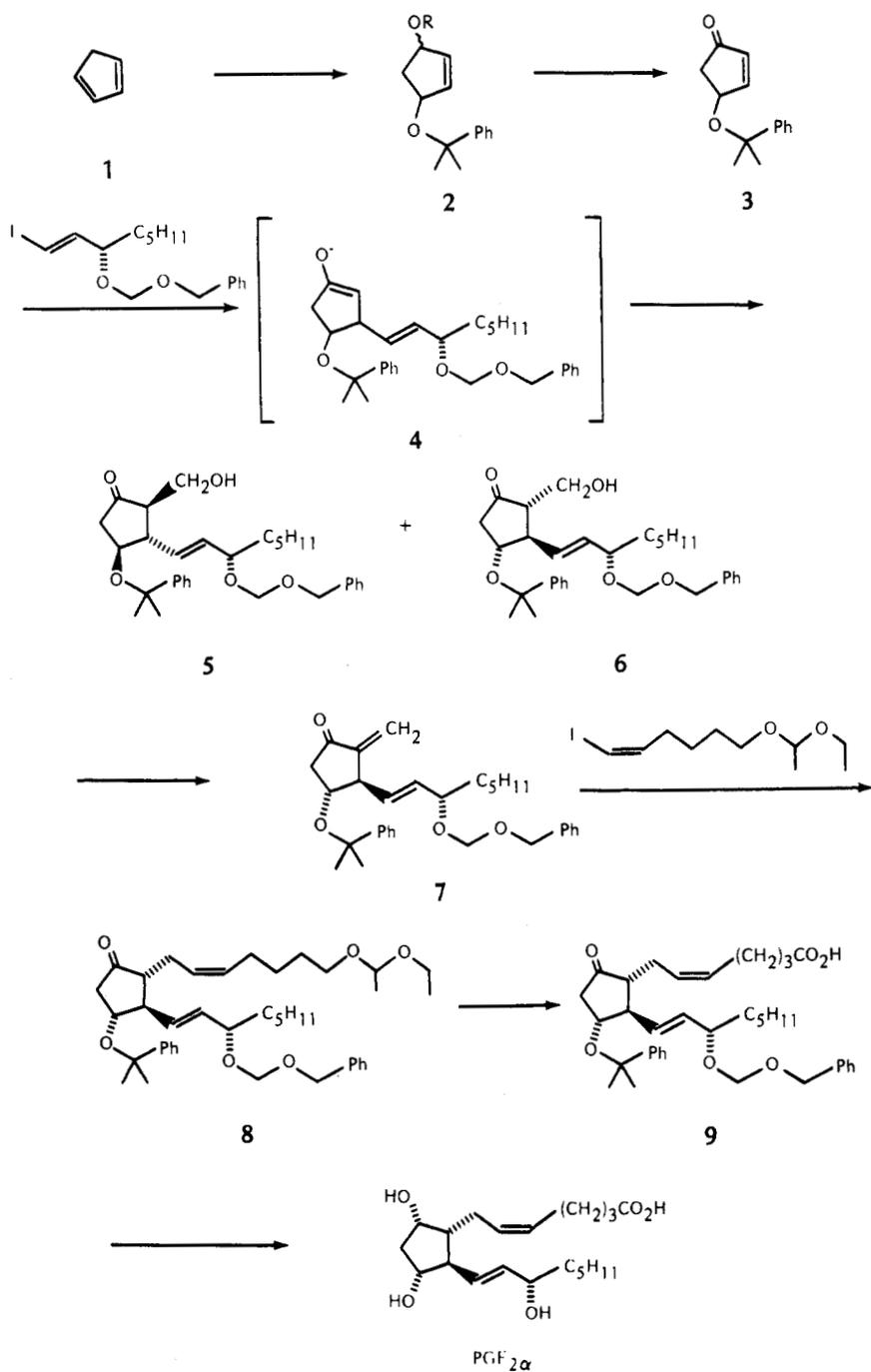


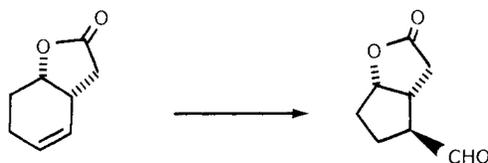
Chart 5.13. Methylene-cyclopentanone approach to prostaglandins.⁶⁹

a group that would provide a handle for its attachment. Patterson and Fried⁶⁷ reported just such a synthesis of 11-deoxyprostaglandins from cyclopenten-2-one (Chart 5.12), but were unable to extend it to E prostaglandins. Model studies, using this approach have also been described by Posner.⁶⁸

Stork and Isobe⁶⁹ successfully applied this approach for the synthesis of natural prostaglandins (Chart 5.13). The regiospecific enolate **4** was efficiently trapped by monomeric formaldehyde to give a hydroxymethylcyclopentanone **6**, which provides the necessary functionality for further elaboration of the top side chain. The crucial 1,4-addition formaldehyde-trapping sequence reproducibly afforded yields of 50-60% for the conversion of **4** to **6**. Conversion of the hydroxymethylcyclopentanone **6** to a mesylate followed by elimination gave the key methylenecyclopentanone **7**, to which the remainder of the top chain was grafted by the addition of a divinylcuprate.⁷⁰ It is noteworthy that this remarkably short synthesis provides pure (+)-PGF_{2α} in only eight steps from 4-cumyloxy-2-cyclopentenone (**3**) in approximately 9% overall yield.

6. CYCLOHEXANE PRECURSORS

An important approach to prostaglandins involves contraction of six-membered carbocyclic precursors for production of the appropriately functionalized cyclopentane nucleus. The strategy has proved quite effective, owing to the large variety of efficient ring contraction procedures available to the organic chemist. Both Woodward and Corey used pinacolic deaminations to effect the key ring contraction step in their syntheses. In another approach, which has proven exceptionally successful for synthesis of 11-deoxyprostaglandins, Corey utilized a thallium(III) promoted semipinacolic ring contraction to establish the five-membered ring.⁷³



A. The Woodward Synthesis

The stereospecific synthesis of PGF_{2α} developed at the Woodward Research Institute, Basel,^{71, 72} is noteworthy for its ingenious use of functional groups as internal protecting agents and their applications to exert stereochemical control during synthetic operations. As pointed out earlier, the key step in this synthesis

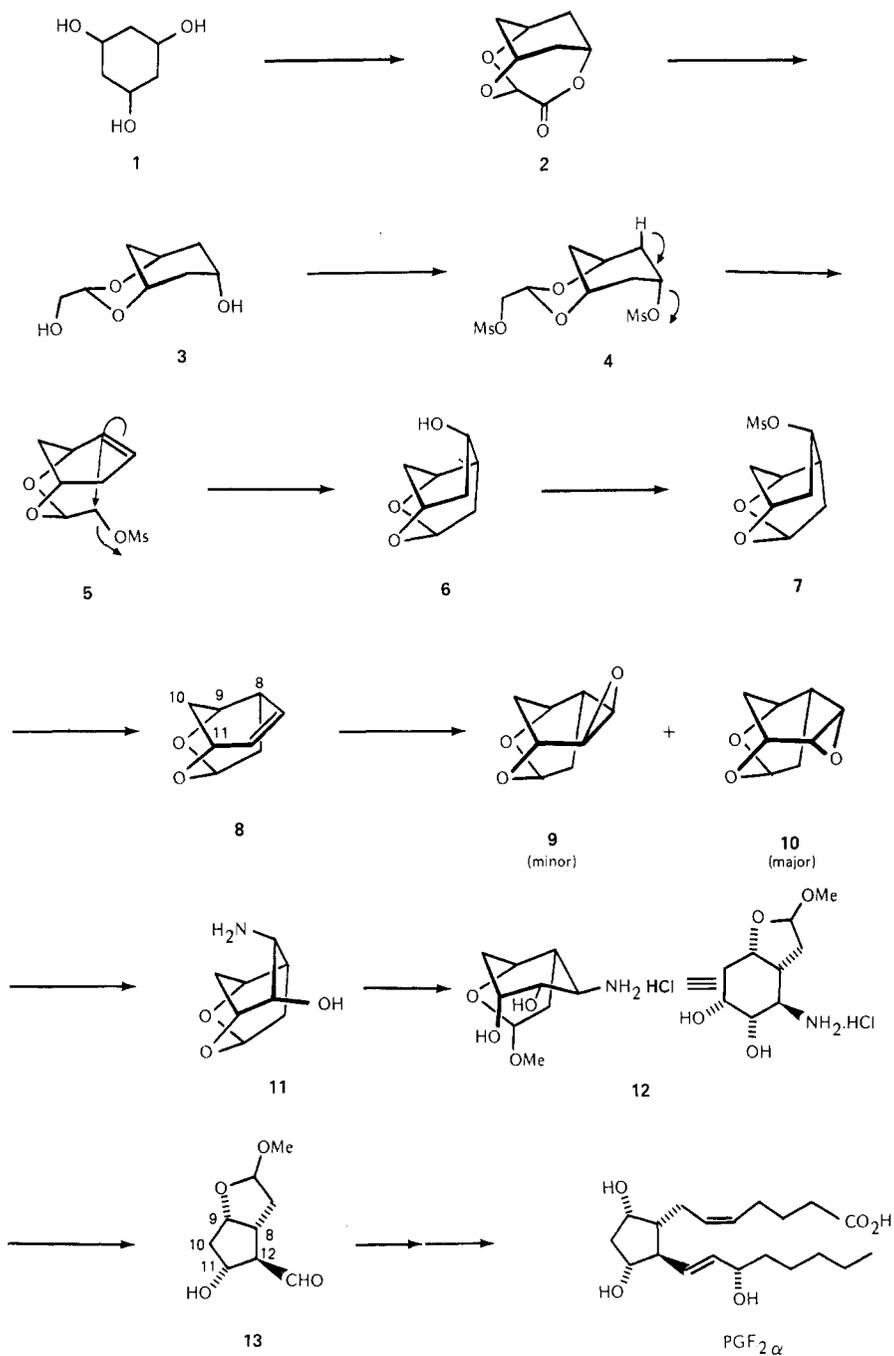


Chart 6.1. Woodward's synthesis of $\text{PGF}_2\alpha$.^{71,72}

is the pinacolic deamination-ring contraction of the cyclohexyl aminohydrin **12**, which efficiently establishes the prostanoid cyclopentane nucleus (Chart 6.1).

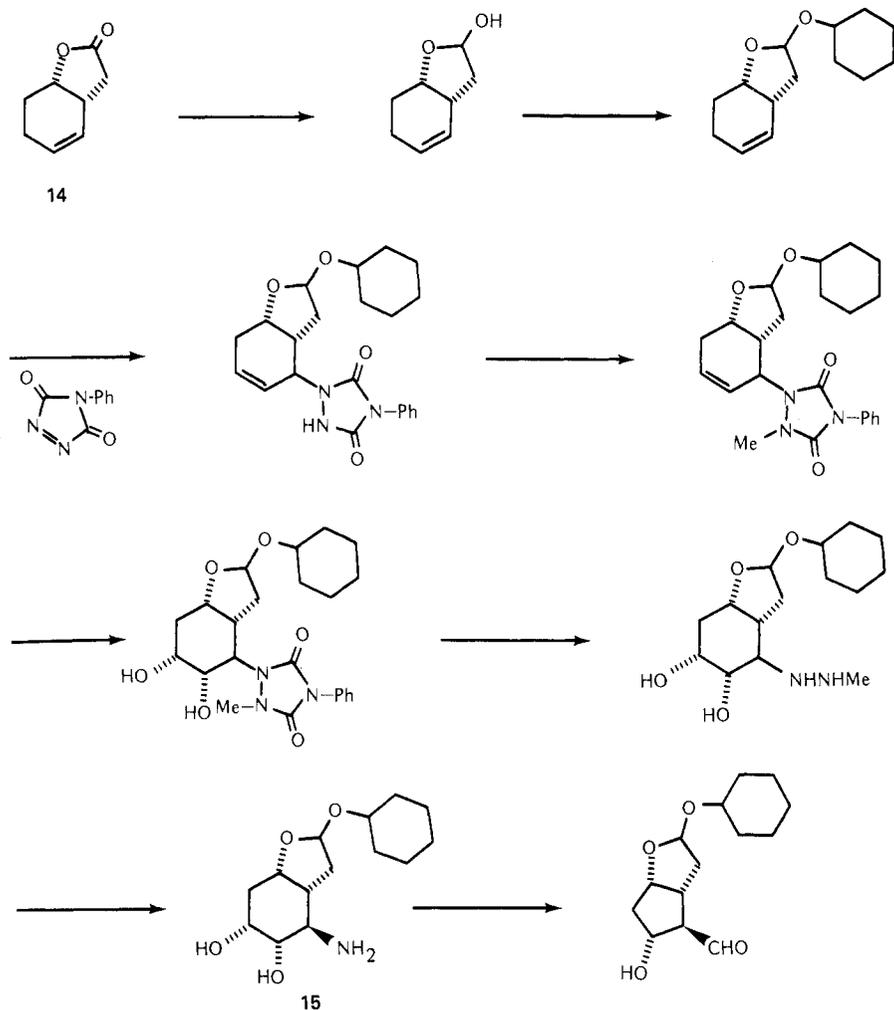
The synthesis commences with *cis*-cyclohexane-1,3,5-triol (**1**), which was converted to the crystalline tricyclic lactone **2** with glyoxalic acid, and subjected to sodium borohydride reduction for production of the diol **3**. The dimesylate **4** was treated with base to yield a bicyclic olefin mesylate **5**, which furnished the crystalline tricyclic carbinol **6** after solvolysis. Mesylation of **6** followed by treatment with refluxing isopropanolic potassium hydroxide solution gave the key tricyclic olefin **8**, which contains the 11-hydroxyl group and the γ -lactol moiety of **13** in a mutually and internally protected form. In addition, the double bond in **8** also provides a handle for effecting the 6 \rightarrow 5 ring contraction sequence with simultaneous introduction of the C-12 aldehyde function. Epoxidation of **8** gave a 62% yield of **10**, the product of preferential attack on the double bond from the concave side of the molecule, along with a 25% yield of the undesired epoxide **9**. After separation from **9**, ammonolysis of **10** furnished the aminoalcohol **11**, which was then converted to the dihydroxyaminoacetal hydrochloride **12**. In contrast to the rigid tricyclic system of **11**, which forces the amino group to orient axially, **12** has a flexible skeleton that allows it to undergo a conformational change, such that the amino function destined to serve as a leaving group is equatorially positioned. The key ring contraction step was accomplished by diazotization in aqueous acetic acid and followed by neutralization with mild base to give the desired hydroxyaldehyde acetal. The synthesis is completed by attachment of the lower side chain to the free aldehyde group in **13**, reduction of the C-15 carbonyl, and attachment of the top chain to the aldehyde function masked as the acetal in **13**, to give PGF_{2 α} .

Corey and Snider⁷⁴ used a similar pinacolic deamination for the key ring contraction step in their synthesis (Chart 6.2). The starting cyclohexylaminohydrin **15** was obtained from the readily available lactone **14**, by allylic functionalizing via the "ene" reaction with *N*-phenyltriazolinedione followed by cleavage to give the allylic amine.

B. The Hoffmann-La Roche Synthesis

The synthesis of prostaglandins developed by Rosen and co-workers at Hoffmann-La Roche⁷⁵ utilizes an interesting Favorskii-type ring contraction of 2-chloro-2-alkylcyclohexane-1,3-diones to establish the cyclopentane nucleus. The ring contraction sequence was originally developed by Buchi and Egger⁷⁶ in connection with their synthesis of methyl jasmonate. Another noteworthy feature of this synthesis is the use of a novel carboxy-inversion reaction⁷⁷ for generation of the C-11 hydroxy group (Chart 6.3).

Acid-catalyzed reaction of 5-carboxy-1,3-cyclohexanedione with allyl alcohol gave **2**, which rearranged to the enol acetate **3**. Treatment of the corresponding

dione **4** with *tert*-butyl hypochlorite gave the chloro derivative **5**, which rearranged to the ring-contracted cyclopentenone **6**. Conjugate addition of the anion from nitromethane to **6** gave **7**, which was oxidized to the keto acid **8**. Reduction of the C-9 carbonyl followed by lactonization afforded the *cis*-fused lactone **9**. After transformation of the nitro group in **9** to an aldehyde, introduction of the lower chain, the carboxy inversion procedure and deprotection afforded the known lactone diol **13**, which has previously been converted to E and F prostaglandins by Corey.

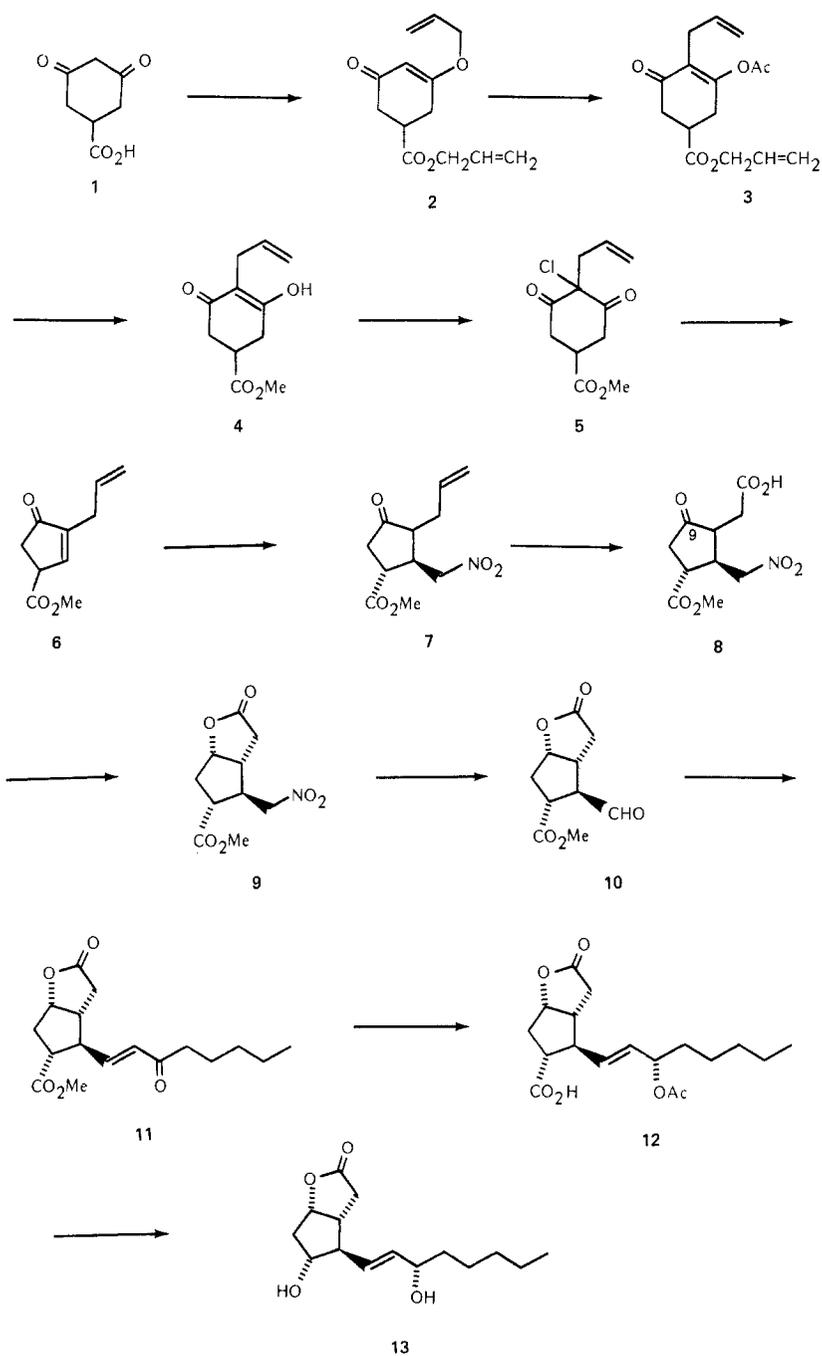


Chart 6.3. Hoffman-La Roche approach.⁷⁵

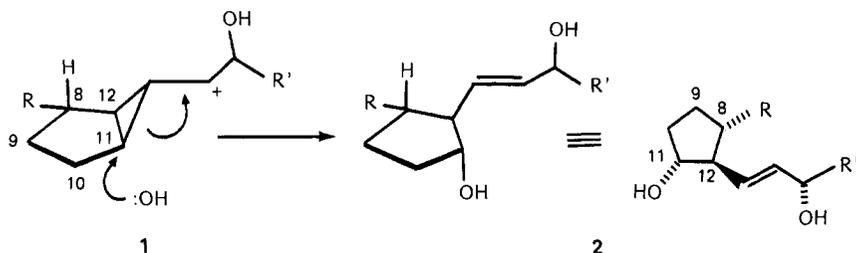
C. The Merck Synthesis

A synthesis of PGE₁ developed at Merck⁷⁸ utilizes oxidative cleavage of a cyclohexene intermediate followed by cyclization of the resulting diacid to generate the desired functionalized cyclopentanone nucleus. The synthesis is stereoselective, but nonetheless, quite lengthy.

7. BICYCLOHEXANE PRECURSORS

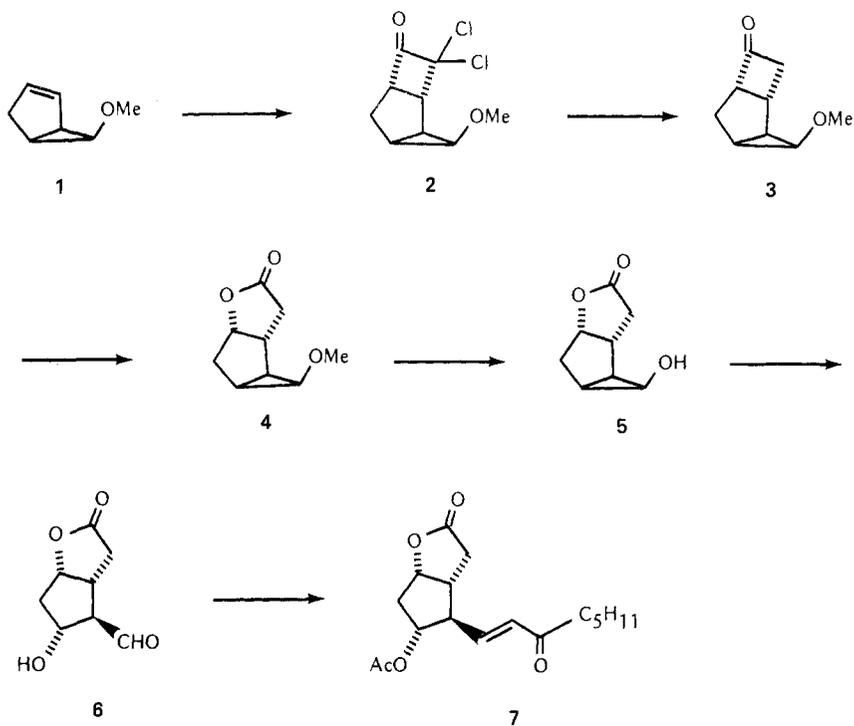
A. Bicyclo[3.1.0]hexane Approach

The use of bicyclo[3.1.0]hexane precursors for prostanoid synthesis has been reviewed in an earlier volume.¹ Essentially, the approach is based on the expectation that the prostanoid C-11 and C-15 hydroxyl functions, along with the *trans*-13,14-double bond, could be simultaneously generated by solvolysis of an appropriate cyclopropylcarbinyl cation **1**, for instance, derived from an epoxide. Attack by water on the cation **1** is expected to occur at C-11 because of steric interference at C-12 by elements of the top-chain attached at C-8. Formation of the *trans*-13,14-olefinic linkage is expected from a consideration of the most favorable disposition of substituents during the ring-opening sequence.

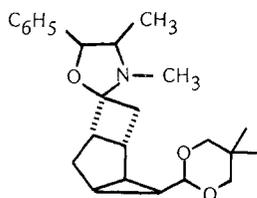


B. Combined Bicyclohexane-Bicycloheptane Approach

In 1970 Corey described a useful variant of the bicyclo[3.1.0]hexane approach in which he combined elements of the bicyclo[3.2.0]heptane approach for introduction of 8,9-substituents on the cyclopentane nucleus (Chart 7.1).⁷⁹ This synthesis, however, was not very efficient because the key solvolysis step proceeded in rather low yield. The strategy was later adapted by Kelly and Van Rheenen (Chart 7.2),⁸⁰ who combined it with the Upjohn solvolysis approach and used it to develop an efficient synthesis of the key, optically active, prostaglandin lactone diol **17**, which has previously been converted to natural prostaglandin by Corey. Resolution of the ketone **11** was effected using a novel

procedure involving the oxazolidine **19**.⁸¹ Oxidation of the olefin **14** may be accomplished via the epoxide, which is subject to several cycles of solvolysis with formic acid to produce the desired 15α -diol **17** in 45% overall yield based on the epoxide **15**. Alternatively, the olefin **14** may be directly converted to the *cis*-glycol **16** using an improved catalytic osmium tetroxide oxidation with tertiary amine oxides as the oxidant.⁸² Solvolysis of the cyclopropyl carbinyl system to furnish **17** is best accomplished via the orthoester **20** (Chart 7.3).⁸³ In another approach, the aldehyde **13** was converted to a masked mixed acyloin



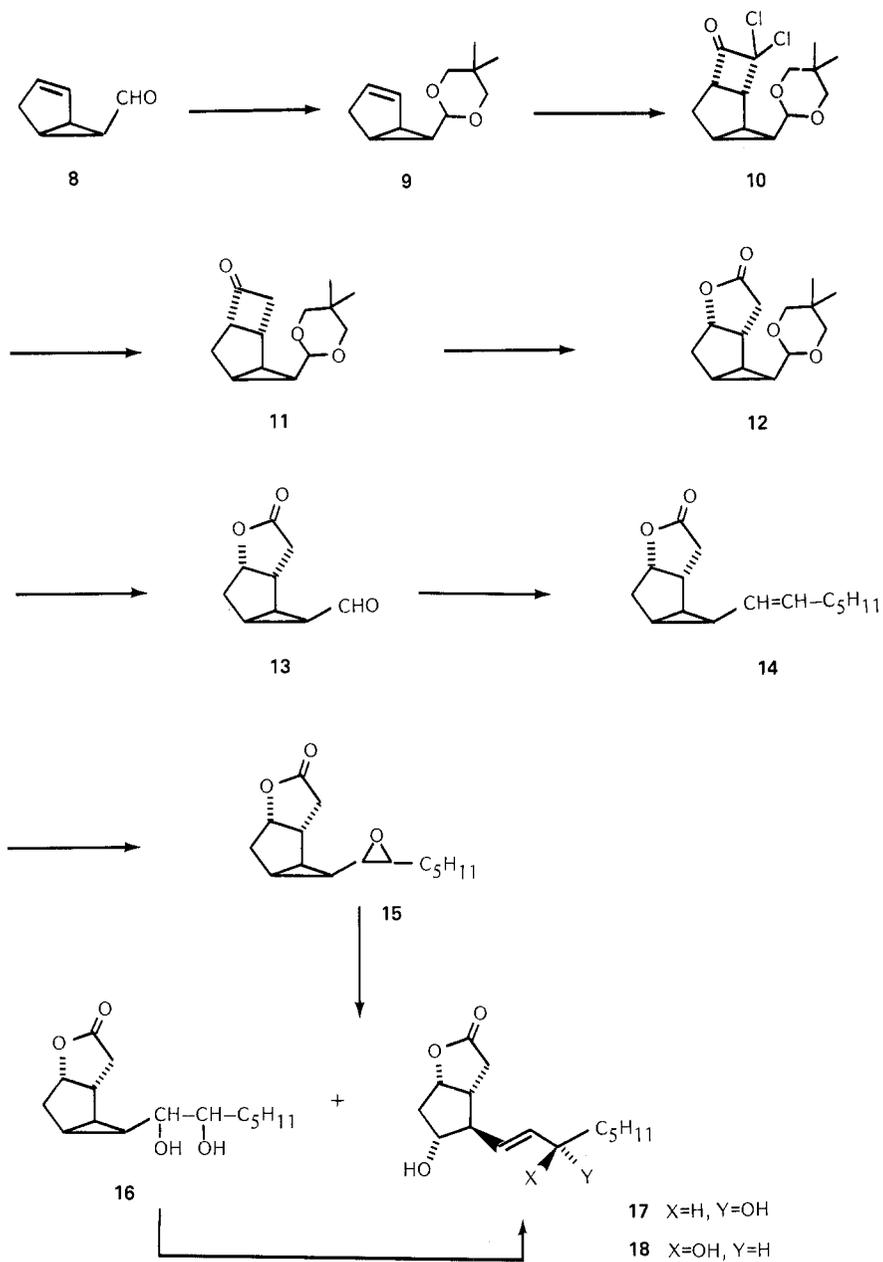
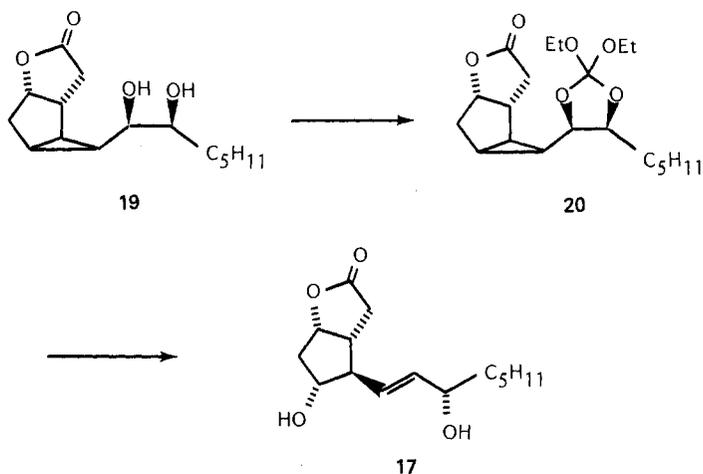


Chart 7.2. Kelly's synthesis of bicyclohexane intermediates.

21 which could be solvolyzed to a masked enone (as the cyanohydrin) (**Chart 7.4**). Unmasking and reduction of the enone **23** gave **17**.⁸⁴ The diol **17** was identical with material prepared by Corey et al. and has been converted to natural prostaglandins.

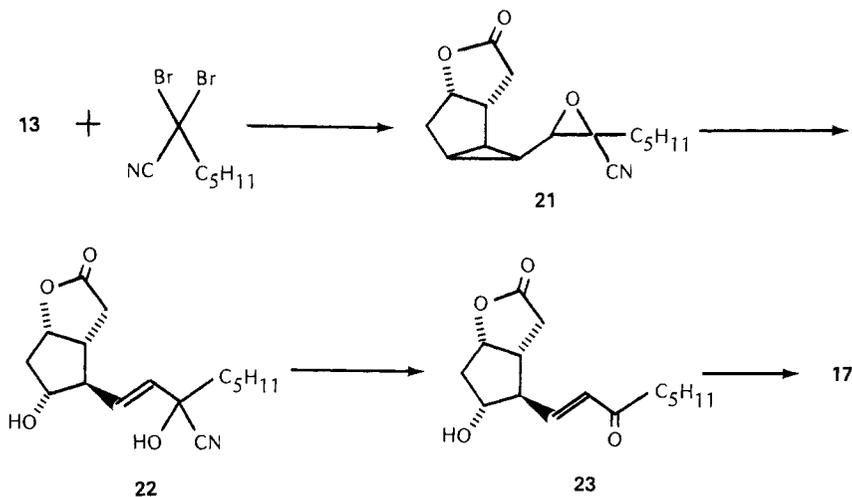
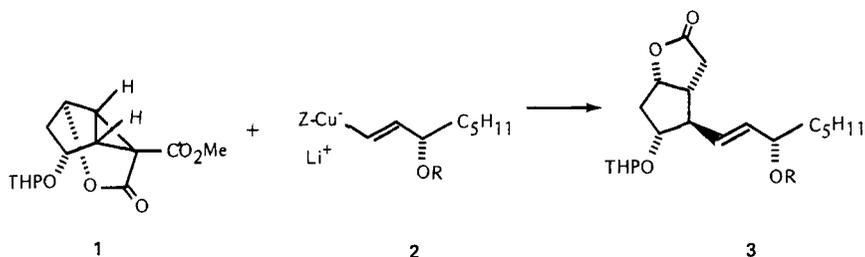


Chart 7.4. From Ref. 84.

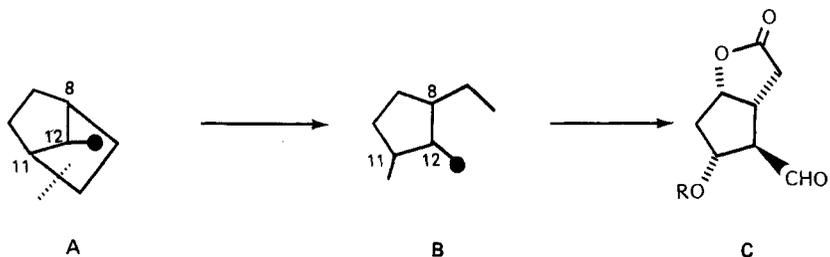
C. Miscellaneous Bicyclohexane Approaches

Cleavage of bicyclohexanes by organocopper reagents also provides a promising approach to prostanooids.⁸⁵ This reaction is of potential interest for direct production of **3** by the homoconjugate addition of the (*S*)-vinylcopper reagent **2** to optically active **1**.



8. BICYCLOHEPTANE PRECURSORS: COREY'S SYNTHESIS

A versatile approach to prostaglandins, based on the bicyclic lactone aldehyde **C**, was developed by Corey and his associates at Harvard during 1969. This synthesis, generally known as the bicycloheptane approach, derives its name from the fact that the cyclopentane nucleus, along with its latent functionalities and key stereochemical centers is embedded in a bicyclo[2.2.1]heptane ring system. Scission of one of the bicycloheptane rings generates the latent functionalities, which are then elaborated into the ring appendages in a step-wise fashion (A→B):



The synthesis is stereospecific and has been used for preparation of E and F prostaglandins of the one, two, and three series. It has also been modified to yield A, C, and D prostaglandins as well as numerous prostaglandin analogs. By changing the phosphonate and/or phosphorane Wittig reagents used for intro-

duction of the side chains, it has been possible to prepare modified prostaglandins, which display greater metabolic stability and selectivity of biological effects (section 19). Although the synthesis is quite lengthy, the overall yield for the 17-step sequence from cyclopentadiene to racemic PGE_2 and $\text{PGF}_{2\alpha}$ is quite acceptable. The synthesis competes favorably with biosynthetic procedures, and in addition has the distinct merit of offering much greater flexibility in analog synthesis. Since optical resolution can be carried out at an early stage and the reactions are amenable to scale-up, the synthesis has been varied and extended, not only at Harvard and other academic laboratories, but also in several industrial laboratories where it has been adapted for pilot plant production.

Corey's synthesis has been outlined in an earlier volume,¹ and has been discussed in detail elsewhere.² The overall synthetic plan is summarized in Chart 8.1 and is discussed briefly below. Corey's own account of the early Harvard work is summarized in a lecture delivered to the National Academy of Sciences in 1971.⁸⁶ A noteworthy feature of the Corey synthesis is the use of a Diels-Alder reaction for construction of the key bicyclic intermediate **4** in which four

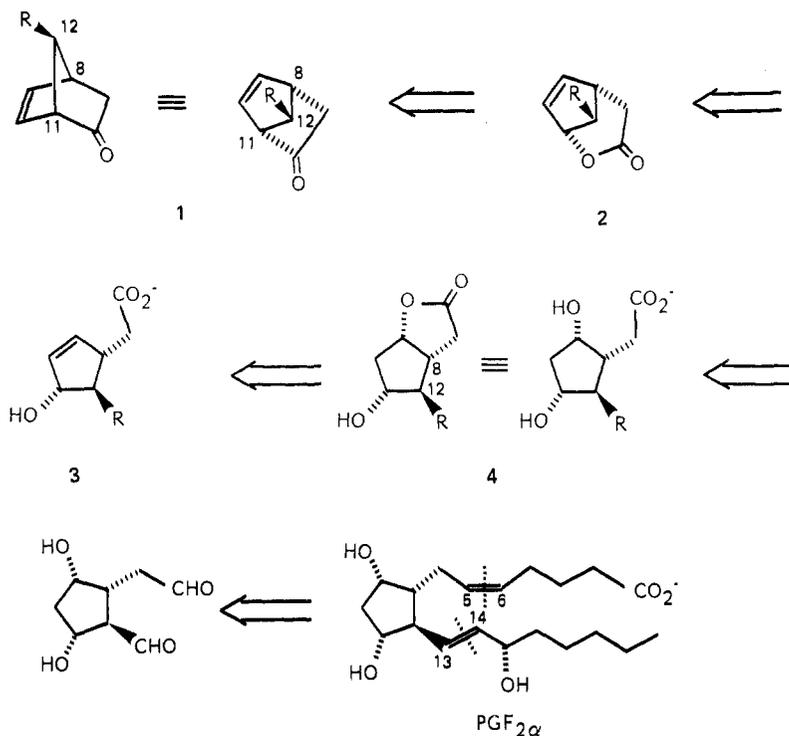


Chart 8.1. Corey's overall synthetic plan—antithetic (retrosynthetic) analysis of $\text{PGF}_{2\alpha}$.

of the ring appendages and chiral centers of the basic prostaglandin nucleus are established efficiently and with complete stereospecificity. The Diels-Alder addition assures the correct *trans-trans* relationship at C₈-C₁₂ in **1**, while introduction of the ring hydroxyls is smoothly accomplished by a Baeyer-Villiger oxidation of the ketone functionality to a lactone (**1**→**2**). This is followed by saponification and iodolactonization for placement of the fourth contiguous asymmetric center on the cyclopentane ring (**3**→**4**). This use of a neighboring group not only serves to establish the *cis* relationship between the 9-hydroxyl and the C-8 substituent but also facilitates the selective protection of the carbonyl functions required for sequential introduction of C-12 and C-8 side chains. The *cis*- Δ^5 and *trans*- Δ^{13} linkages are established using modified Wittig reactions to complete this versatile synthesis. The choice of tetrahydropyranyl ether-protecting groups, which are labile to mild acid hydrolysis, overcomes the difficulties associated with masking and unmasking of the sensitive β -ketol system of the E prostaglandins. Alternative protecting groups have since been developed and have found application in newer prostaglandin syntheses. Minor modifications of the synthesis lead to the synthesis of other primary prostaglandins.

A. Modifications of the Corey Synthesis

Several improvements in the Corey synthesis have been reported by the Harvard team and others.² The synthesis as originally described involved the use of a number of toxic and hazardous reagents, not suited for large-scale preparations. Another problem was isomerization of the diene observed during the initial Diels-Alder cycloaddition, which resulted in the desired bicycloheptene being contaminated with its isomer, requiring chromatographic purification. The use of thallos cyclopentadiene gives a product less prone to isomerization,⁸⁷ but offers special problems on a large scale owing to the highly toxic nature of thallium.

2-Chloroacrylonitrile, which served as the ketene equivalent during the cycloaddition in the early syntheses, has been replaced by other dienophiles. α -Chloroacrylyl chloride has been used,⁸⁸ and reacts with 5-benzyloxymethyl cyclopentadiene without prototropic rearrangement, but requires the use of sodium azide for unmasking the carbonyl function (Chart 8.2). The use of thallium or catalysts during the cycloaddition, and base-catalyzed isomerization of the intermediate 5-monoalkylated cyclopentadiene is best avoided by using acrylic acid as the dienophile (Chart 8.3). Conversion of the resulting bicyclic acid **2** to the ketone **3** is smoothly accomplished using a novel oxidative decarboxylation procedure developed by Trost and Tamura.⁸⁹ Wasserman and Lipshutz⁹⁰ have also reported an efficient oxidative decarboxylation, which appears suited for effecting the conversion **2**→**3**. Synthesis of the optically active

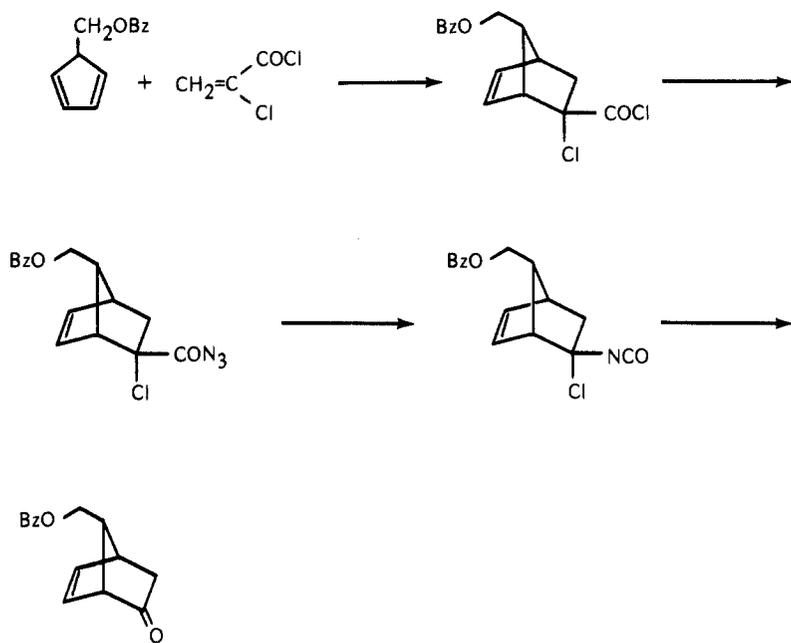


Chart 8.2. Improved synthesis of the bicyclic ketone.⁸⁸

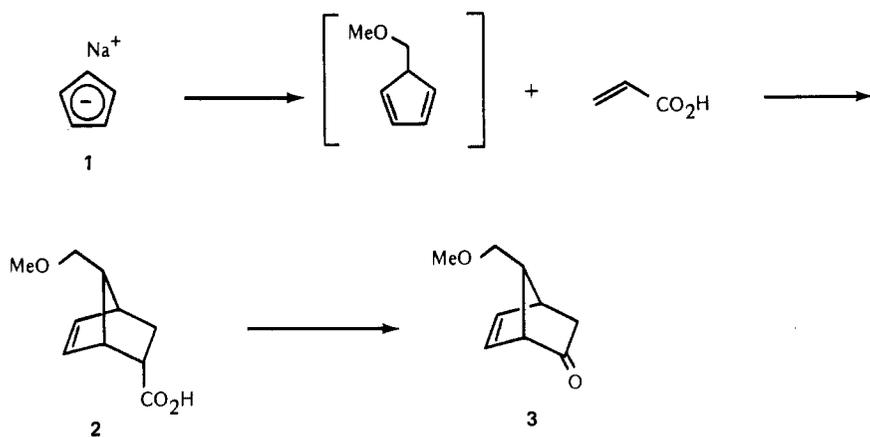
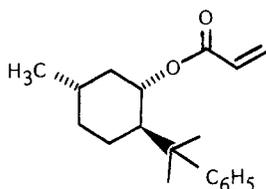


Chart 8.3. Oxidative decarboxylation approach to Corey's bicyclic ketone.

bicyclic ketone has been accomplished by asymmetric induction using the chiral acrylate **4**, prepared from (*S*)-(-)-pulegone.⁹¹

Another promising approach to the bicyclic ketone, developed by Ranganathan et al.,⁹² utilizes nitroethylene as the ketene equivalent (Chart 8.4). The highly reactive nitroethylene makes it possible to replace the undesirable thallium cyclopentadienide with the corresponding sodium derivative for preparation of the nitronorbornene **5**. The nitronorbornene \rightarrow norbornenone transformation (**5** \rightarrow **3**) utilizes the mild titanium-catalyzed nitro to ketone conversion developed by McMurry and Melton.⁹³ The nitroethylene approach has been further extended by Bartlett and co-workers.⁹⁴

Several operational improvements have been reported in various steps of the Corey syntheses, and have been reviewed in detail elsewhere.² Particularly noteworthy is the use of *p*-phenylphenylcarbamoyl-protecting group and lithium trialkylborohydrides for stereospecific generation of the 15*S* configuration.⁹⁵

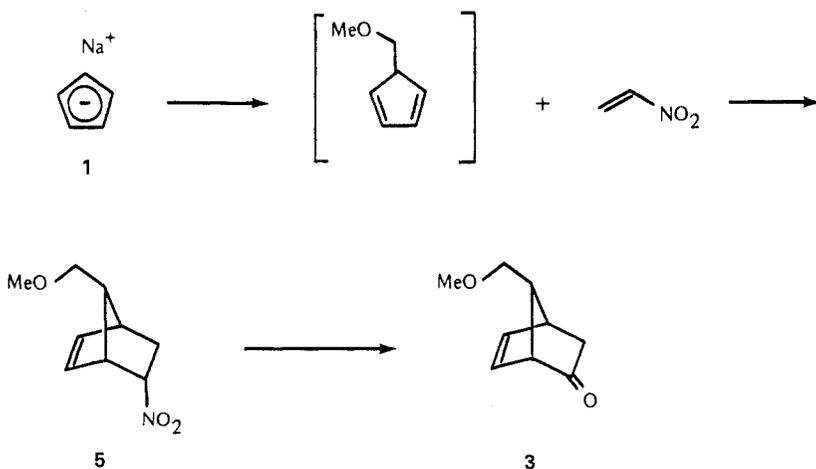


Chart 8.4. Ranganathan's approach to the Corey bicyclic ketone.

A promising, short synthesis of the Corey aldehyde, involving a regioselective Prins reaction on the readily available lactone **1**, has been described by a Hungarian team (Chart 8.5).⁹⁶ Addition of formaldehyde in glacial acetic acid gave a 75-85% yield of the diacetate **2**. While selective unmasking of the primary hydroxyl group could not be successfully achieved in **2**, the diacetate was readily hydrolyzed to the known lactone diol **3**, and then selectively oxidized to the hydroxyaldehyde **4** with the thioanisoe-chlorine⁹⁷ or more conveniently by the Pfitzner-Moffat reagent. Attachment of the ω -chain to the crude unstable hydroxyaldehyde, followed by *p*-phenylbenzoylation, gave the known bicyclic enone **5** in good overall yield.

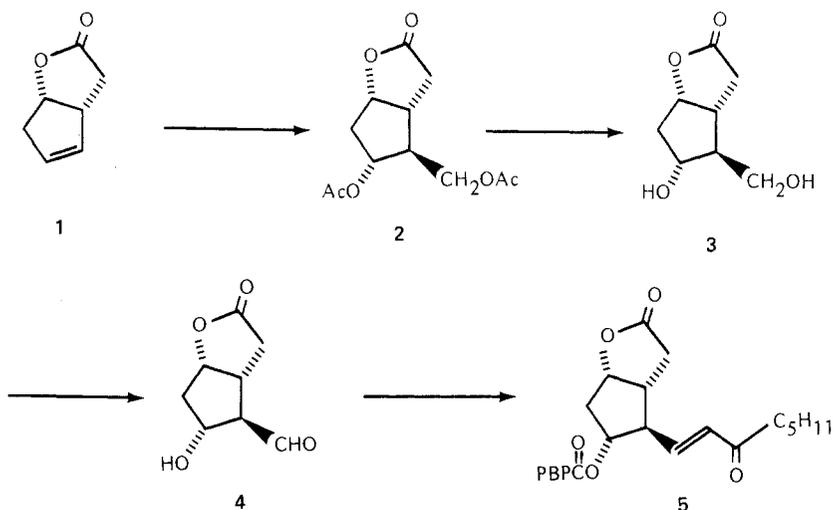


Chart 8.5. From Ref. 96.

B. The Nortricyclane Approach to Corey Intermediates

An alternative approach to the Corey alcohol **9**, starting with Prins reaction of norbornadiene, was independently developed at Pfizer⁹⁸ and by Peel and Sutherland at the University of Manchester.⁹⁹ The Pfizer synthesis is outlined in Chart 8.6.

Reaction of norbornadiene (**1**) with paraformaldehyde in formic acid containing a catalytic amount of sulfuric acid gave the nortricyclane diformate **2** in good yield. Oxidation of **2** with Jones reagent led directly to the keto acid **3**, which was readily secured in the correct absolute configuration required for prostaglandin synthesis by resolution with L-(-)- α -methylbenzylamine. Reaction of the (+)-acid **3** with aqueous hydrochloric acid cleanly produced the chloro

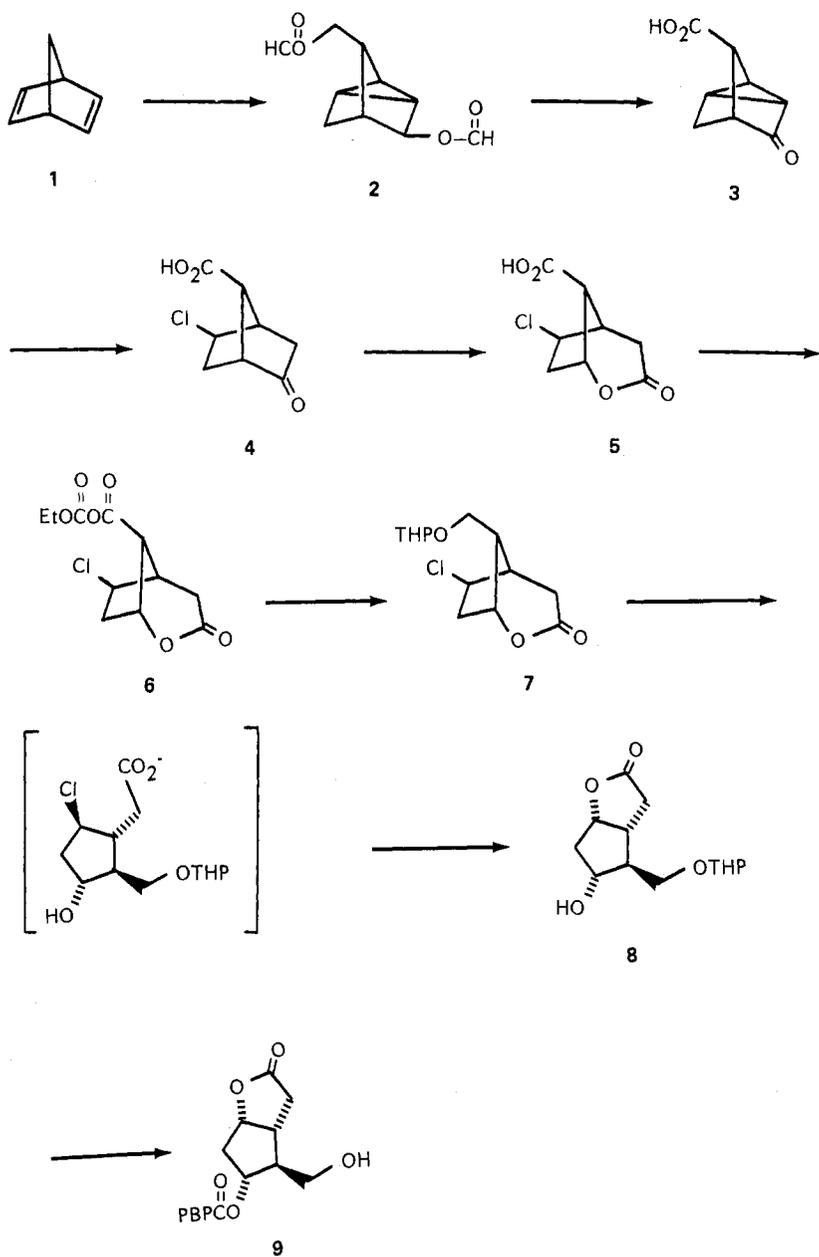
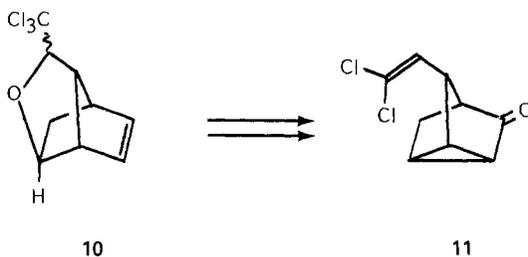


Chart 8.6. Pfizer's nortricyclane approach.⁹⁸

acid **4** which underwent Bayer-Villiger oxidation to give the chlorolactone acid **5**. Reduction of the carboxyl function, followed by protection of the resulting primary alcohol function as the tetrahydropyranyl ether gave **7**. The key displacement reaction establishing the γ -lactone proceeded in aqueous base buffered with 30% hydrogen peroxide to give **8**. Acylation with *p*-phenylbenzoyl chloride followed by acid cleavage of the tetrahydropyranyl group gave the known lactone alcohol **9**. Conversion of the racemic **3** to **9** was accomplished by the Manchester group by a slightly different route.⁹⁹

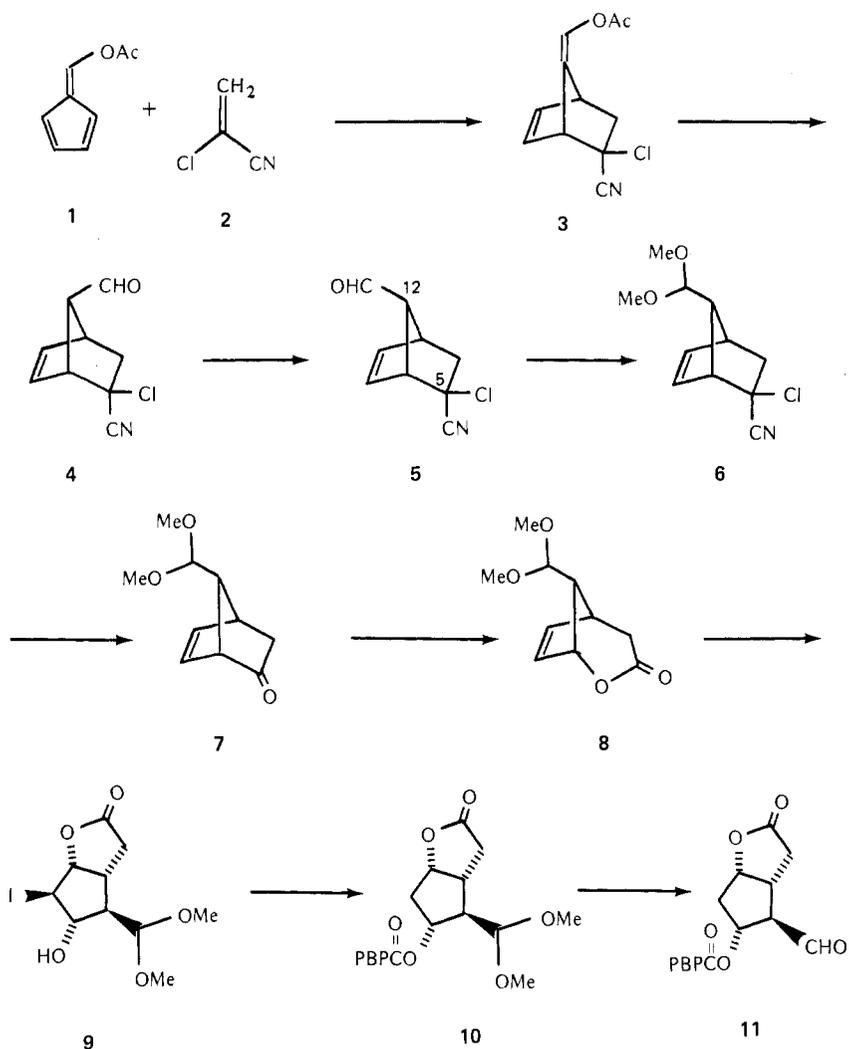


The tricyclic compound **10**, prepared from norbornadiene and chloral in the presence of aluminum chloride, provides another entry to the Corey aldehyde via nortricyclane intermediates.¹⁰⁰

C. The Acetoxyfulvene Approach

ICI workers have developed a short and practical synthesis of the Corey aldehyde.¹⁰¹ The synthesis avoids toxic thallium reagents and has been successfully operated on a large scale for the manufacture of prostaglandin analogs, cloprostenol and fluprostenol. The synthesis commences with 6-acetoxyfulvene in which isomerization of the 1,3-diene system is precluded by presence of an exocyclic enol acetate group. Another advantage of this approach is that the formyl group at C-12, required for attachment of the lower side chain, is introduced at the correct oxidation level at the very outset, viz., the enol acetate grouping in 6-acetoxyfulvene (**1**) (Chart 8.7).

Acid-catalyzed hydrolysis of the enol acetate **3** gave the *anti*-aldehyde **4** (product of kinetic control), which is isomerized to the more stable *syn*-aldehyde **5** upon prolonged treatment with acid at 84°C or via the Schiff's base with *p*-chloroaniline. The aldehyde **5**, which now contains the appropriate stereochemistry at C-12 for synthesis of **11**, is readily protected as the dimethylacetal prior to conversion of the chloronitrile moiety to give the ketone **7**. The ketone **7** may be resolved at this stage via *d*-amphetamine salt of hemiphthalate ester of the corresponding *endo*-alcohol. The latter is reoxidized to the ketone after the resolution. Conversion of the acetal ketone **7** to aldehyde **11** proceeds

smoothly, using essentially the sequence developed earlier by Corey. The synthesis has been modified for preparation of PGE₂.¹⁰²

In a variant of this approach, early attachment of the lower side chain avoids the need for protecting and deprotecting the aldehyde. This strategy has been employed by Brown and Lilley to develop a short efficient synthesis of PGF_{2α}.¹⁰³ Reaction of aldehyde **5** with the lithio derivative of dimethyl-2-

oxoheptylphosphonate furnishes the *trans*-enone **12**, which, after reduction and hydrolysis of the chloro-cyano group, gives the bicyclic ketone **13** in 56% overall yield from **5**. $\text{PGF}_{2\alpha}$ is obtained in five additional steps from **13** (Chart 8.8).

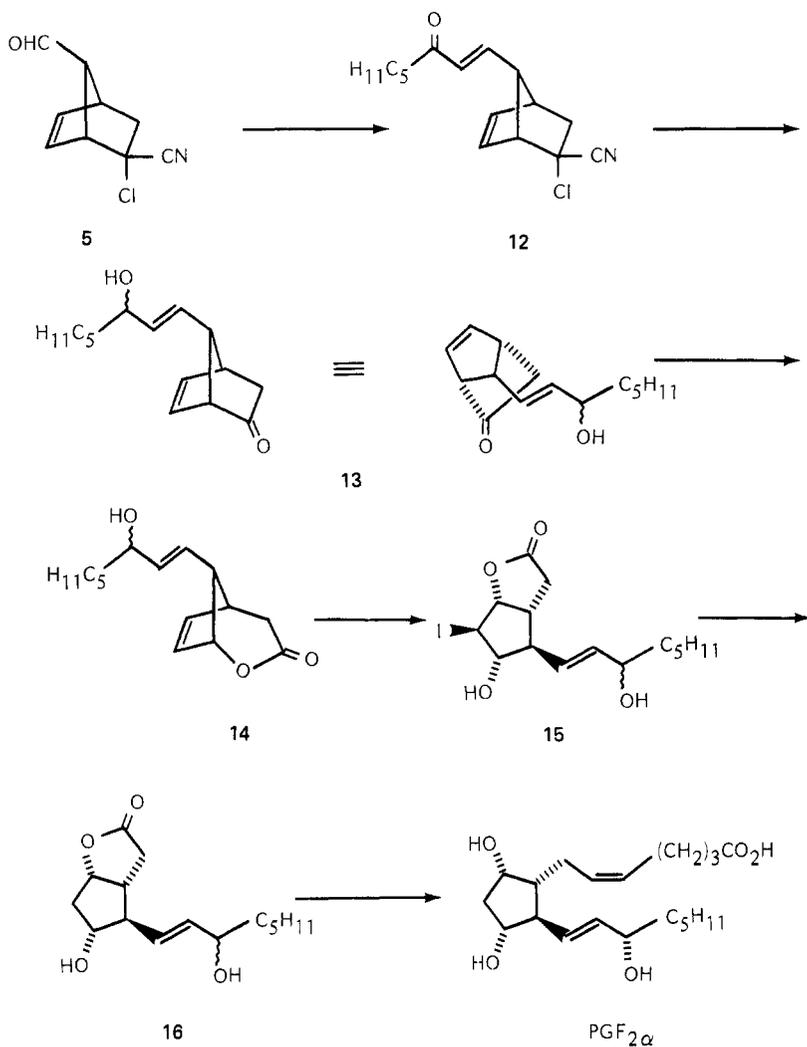


Chart 8.8. ICI synthesis of $\text{PGF}_{2\alpha}$.¹⁰³

D. Bicycloheptane Intermediates from a Tricyclo[3.2.0.0^{2,7}]-heptanone

Roberts in collaboration with an Allen and Hanburys team¹⁰⁴ developed a facile synthesis of bicycloheptane intermediates, suitable for preparation of prostanooids, involving the homoconjugate addition of organocuprates to the readily available tricyclo[3.2.0.0^{2,7}]heptanone **4**. Reaction of the known bicycloheptenone **1** with *N*-bromoacetamide in aqueous acetone proceeds stereospecifically

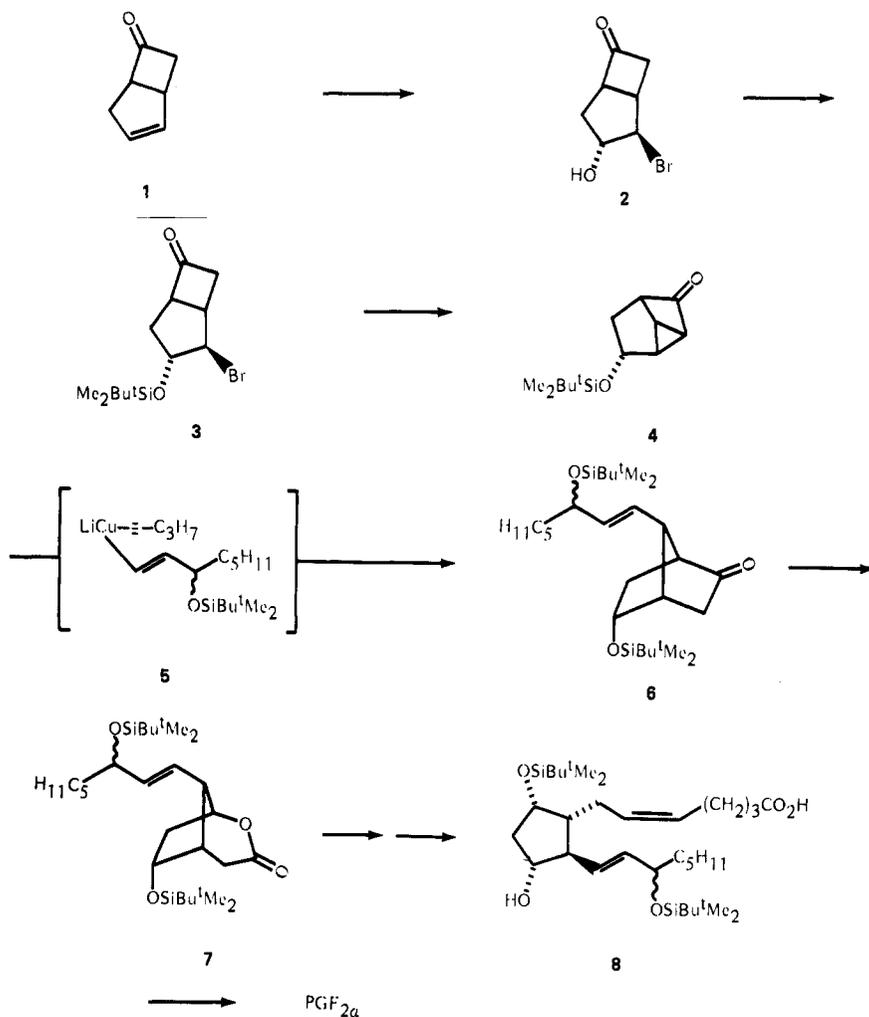
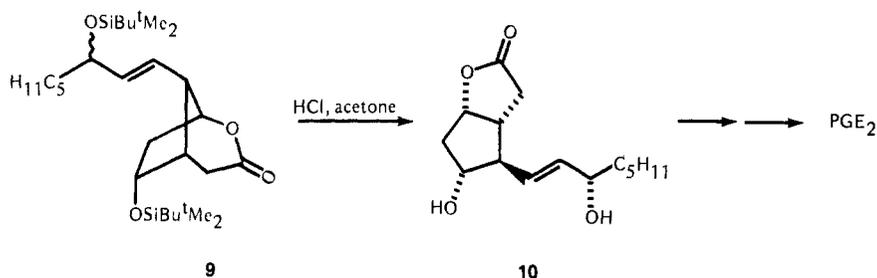

to yield the crystalline bromohydrin 2. Protection as the *t*-butyldimethylsilyl derivative followed by treatment with base gave the key tricycloheptanone 4. Opening of the strained cyclopropyl ketone in 4 proceeded smoothly with a mixed organocuprate (5) to furnish the norbornenone 6. The latter was converted to PGF_{2α} along lines of the ICI approach (Chart 8.9).

Acid-catalyzed rearrangement of the δ-lactone 9 to the γ-lactone 10 provides an entry into the PGE₂ series.¹⁰⁵



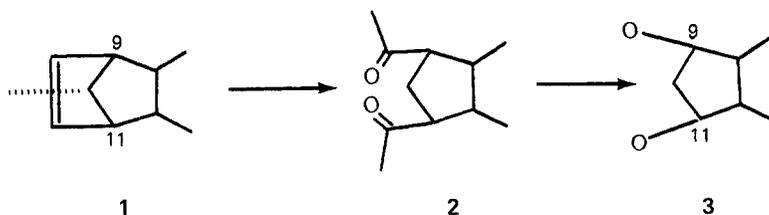
E. The Inverse Approach

In the original Corey synthesis of prostaglandins the eight-carbon lower chain is attached first, followed by elaboration of the carboxyl-containing top chain. A modification of this approach consists of reversing the order in which the two chains are attached to the cyclopentane ring. Since in this approach the carboxylic acid side chain is added first, opportunity is presented for reduction of the 5,6-double bond prior to introduction of the lower side chain, thus allowing the preparation of prostaglandins of the one-series. Schaaf and Corey¹⁰⁶ used this approach for synthesis of PGE₁ and PGF_{1α}. Doria et al.¹⁰⁷ developed a similar approach to PGE₁ and PGF_{1α}, differing only in the choice and timing of removal of the protecting groups at C-9 and C-11.

9. BICYCLOHEPTANE PRECURSORS: MISCELLANEOUS APPROACHES

A. Norbornane Precursors

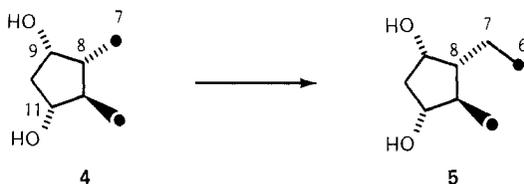
A second bicycloheptane approach to prostanoid synthons utilizes oxidative cleavage of substituted norbornene derivatives for introduction of the *cis*-9,11-dihydroxy groups. Thus the double bond, readily incorporated into the norbornene system (1) by means of a Diels-Alder addition reaction with cyclopentadiene, serves as a latent source of two carbonyl functions, which in turn provide the 9,11-oxygen functions by a C—O inversion procedure.



This strategy was first developed by Katsube who utilized it for a nonstereospecific synthesis of the PGF_1 skeleton,¹⁰⁸ and later adapted it for a nonstereospecific synthesis of the Corey lactone.¹⁰⁹

The ICI Syntheses

In a variant of the oxidative cleavage approach developed at ICI, Jones et al.^{110,111} commenced with an unsymmetrically substituted norbornene derivative (2) bearing two differentially protected one-carbon pendants destined to become the C-8 and C-12 substituents. After oxidative cleavage and generation of the *cis*-9,11-dihydroxy groups, the C-8 pendant was selectively unmasked and homologated to a two-carbon residue (4→5). However, the homologation step,



as originally planned, was complicated by a competing 1,3-acetate shift involving C-9 and the newly unmasked C-8 functionality. The synthesis was subsequently modified,¹¹¹ commencing with a symmetrically substituted norbornene derivative 6 (Chart 9.1). After cleavage and the C–O inversion sequence, which gave the diacetate 8, the benzyl groups were removed by catalytic hydrogenation to furnish, after equilibration, a mixture (3:2) of the primary acetate (10) and the secondary acetate (9). Thus the previously troublesome 1,3-diacetate rearrangement was used to an advantage as a means of distinguishing between the two primary alcoholic functions on the α - and β -faces of the cyclopentane ring. A sequence of reactions, following addition of the C-6 one-carbon unit as a nitrile (12→15), afforded the lactone diol 16, which has earlier been converted to natural prostaglandins by the Harvard group.

The Hoffmann-La Roche Synthesis

A practical, but nonetheless lengthy synthesis of Corey's bicyclic lactone 18 in optically active form has been developed at Hoffmann-La Roche, Basel, using

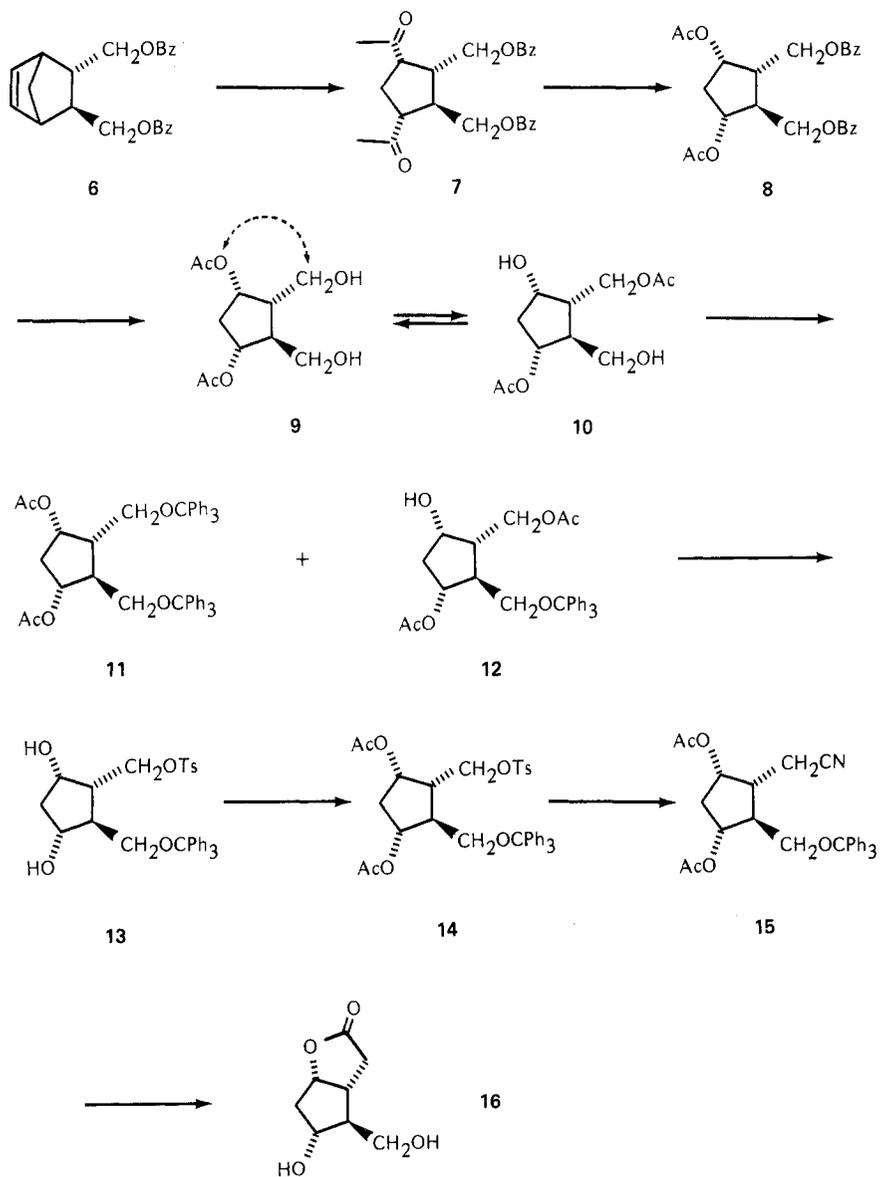


Chart 9.1. The ICI oxidative-cleavage approach.¹¹¹

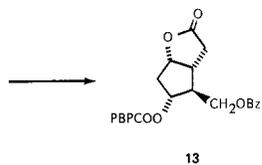
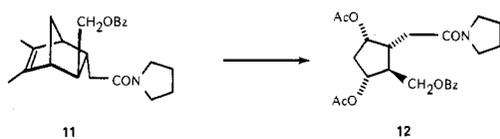
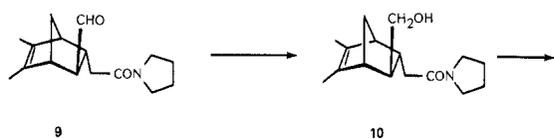
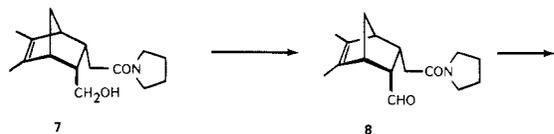
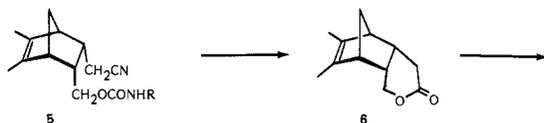
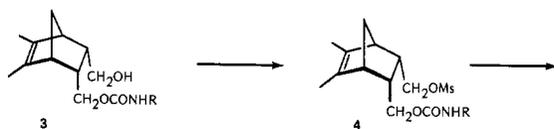
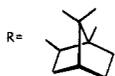
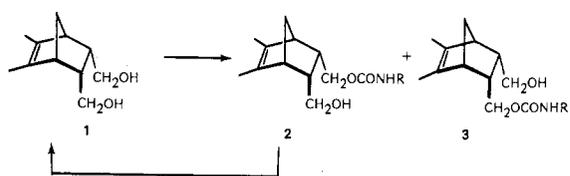

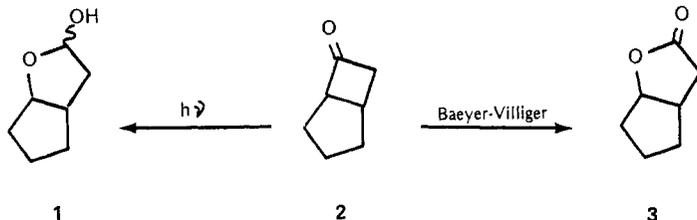
the oxidative cleavage approach (Chart 9.2).¹¹² The synthesis commences with a symmetrically substituted norbornene derivative (1), but unlike the ICI synthesis utilizing almost identical starting material, cleavage of the double bond has been deferred until after elaboration of the two side-chain precursor pendants. Resolution is carried out early in the synthesis by fractional crystallization of the *meso*-intermediate (1), which is asymmetrically substituted with a chiral moiety. Since the undesired enantiomer is readily recycled, the chiral efficiency of this synthesis is very high. Moreover, it is possible to prepare both enantiomeric configurations of prostaglandins simply by interchanging the sequence of reactions by which the pendant chain is elongated and the 8,12-*trans* relationship is established.

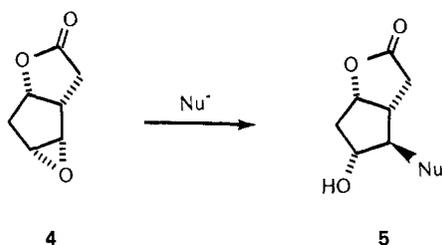
The *meso*-alcohol 1 is reacted with phosgene to give a seven-membered cyclic carbonate, which is readily attacked by isobornylamine to furnish a mixture of diastereomers 2 and 3 separable by fractional crystallization. The undesired enantiomer is hydrolyzed back to 1 and recycled.

The hydroxyurethane 3 was homologated to the cyanourethane 5, and saponified to a hydroxy acid, which spontaneously lactonized to 6. Ring opening of the tricyclic lactone 6 with pyrrolidine furnished a hydroxy amide 7 in which the primary alcoholic function was transformed to an aldehyde using the Pfitzner-Moffatt oxidation procedure. Isomerization of the resulting *endo*-aldehyde 8 to the *exo*-aldehyde 9 established the desired *trans* relationship between the two side chains. After reprotection of the aldehyde function by reduction and benzylation, the tetrasubstituted double bond in 11 was ozonized and the intermediate ozonide converted with dimethyl sulfide to a labile bismethyl ketone. The latter was subjected, without purification, to Baeyer-Villiger oxidation to give the diacetoxyamide 12, which has the desired *cis-trans* orientation of substituents on the cyclopentane ring. Saponification, lactonization, and reaction of the intermediate hydroxylactone with *p*-phenylbenzoyl chloride furnished the desired bicyclic lactone 13.

B. Bicyclo[3.2.0]heptane Precursors

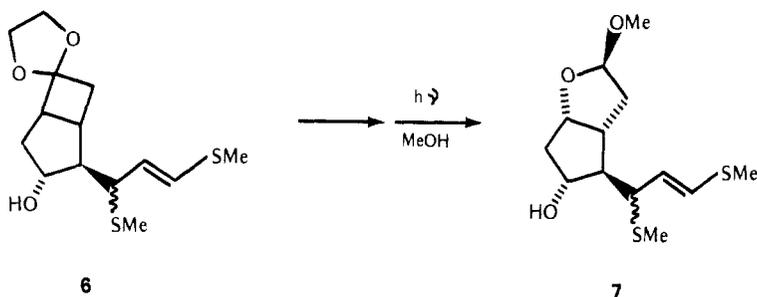
The oxidative cleavage of bicyclo[3.2.0]heptanes provides an efficient way for simultaneous generation of the C-9 oxygen function on the cyclopentane





nucleus along with the two-carbon precursor of the carboxylic chain at C-8 via Bayer Villiger ring expansion¹¹³ or photolytic conversion of the cyclobutanone to a γ -lactol.¹¹⁴

Some of the early routes to prostaglandins were based on nucleophilic opening of the bicyclic epoxide **4**, readily available from bicyclo[3.2.0]heptane precursors. This approach, however, suffered from a lack of selectivity during the crucial ring-opening step. Newton and Roberts recently discovered that the S_N2 attack by carbanions on the protected epoxybicycloheptane **11** proceeds in excellent yield and with a high degree of regioselectivity.¹¹⁵ This strategy was applied for preparation of the bis(methylthio)propenyl derivative **6**, which was converted to the known prostaglandin precursor **7**.



Regiospecific addition of the cuprate **15** to **11** furnishes, in 65% yield, the hydroxyketal **12**, which may be converted to PGE_2 ,¹¹⁵ or photolytically transformed to the known γ -lactol **14**, which has been converted to $\text{PGF}_{2\alpha}$ (Chart 9.3).¹¹⁶

10. BICYCLOOCTANE PRECURSORS

Cleavage of one of the rings in a suitably functionalized bicyclo[3.3.0]octane precursor (**2**) may be used to generate the prostanoic cyclopentane nucleus bearing substituents at C-8 and C-12, suitable for further elaboration of the α

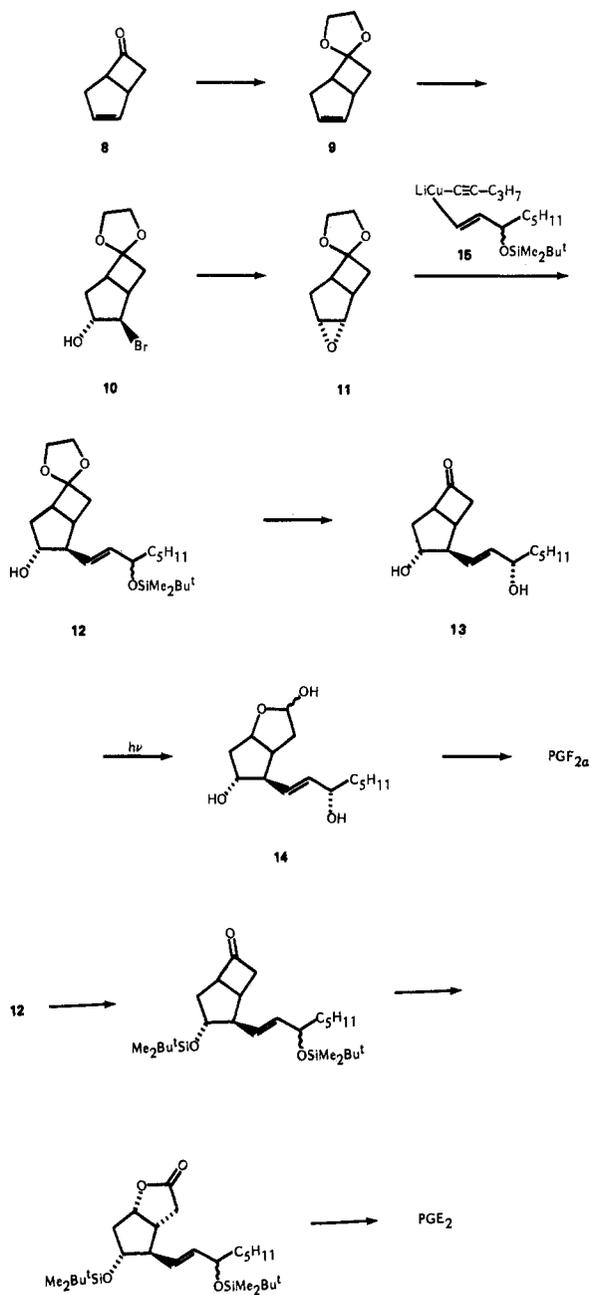
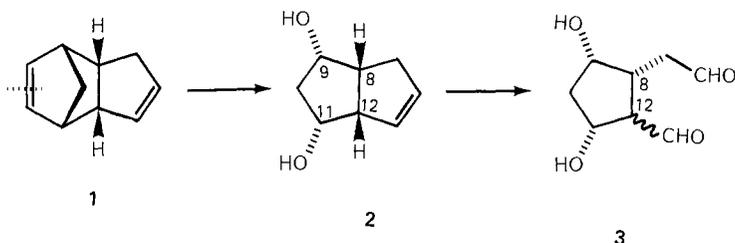


Chart 9.3. From Ref. 116.

and ω side chains. This approach was utilized by Turner et al.,¹¹⁷ who prepared the key aldehydic synthon **3** from the bicyclo[3.3.0]octane **2** in a relatively short number of steps and converted it to PGF_{2 α} . Even though the latent C-12 functionality in **2** is initially in the wrong configuration, it can be readily cor-



rected by epimerization adjacent to the C-12 aldehyde group once it is generated. The 9,11-*cis*-disposed hydroxy groups on the cyclopentane nucleus have been obtained by oxidative cleavage of a norbornene ethylene bridge, a strategy discussed in the preceding section. Turner's synthesis¹¹⁷ commences with endodicyclopentadiene **1** readily obtained by crystallization from inexpensive commercial dicyclopentadiene. Cleavage of the norbornene double bond of dicyclopentadiene proceeds selectively, since it is the more reactive of the two double bonds present in the molecule. However, the overall yield of PGF_{2 α} by this synthesis, starting from dicyclopentadiene is less than 0.1%.

11. BICYCLONONANE PRECURSORS

Two syntheses of PGE₁ involving cleavage of a hydrindane precursor for generating the ring appendages were developed by workers at Merck Sharp & Dohme. In both these syntheses oxidative cleavage of the key *cis*-hydrindenone **2** furnishes elements of the lower side chain and the C-11 hydroxyl group. Epimerization of the resultant acetyl function in **3** serves to establish the proper *trans*, *trans* geometrical disposition of substituents about the cyclopentanone ring (cf. **4**).¹¹⁸ Subsequently, the Merck workers developed an alternative route to the key hydrindenone intermediate (**1**) from the Diels-Alder adduct of *trans*-piperylene and maleic anhydride.¹¹⁹ An improved two-carbon degradation sequence was also developed for shortening of the C-12 three-carbon side chain in **4**. Although these syntheses exhibit a fair amount of stereocontrol, they are quite lengthy (over 25 steps), involving a large number of protection and deprotection steps (Chart 11.1).

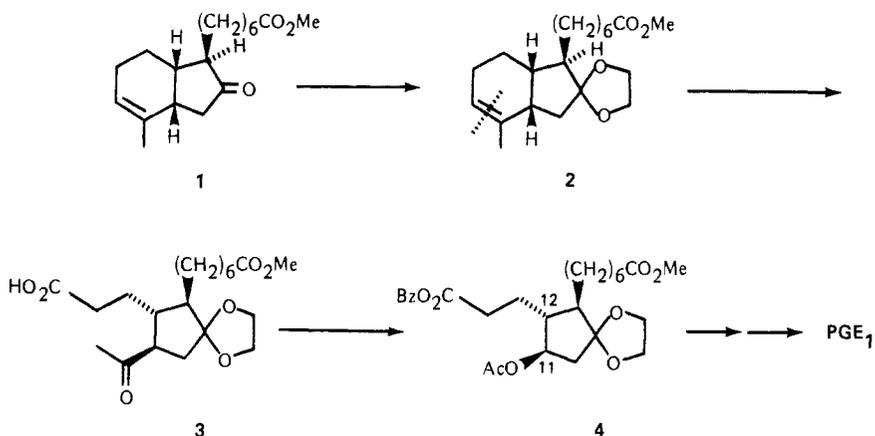


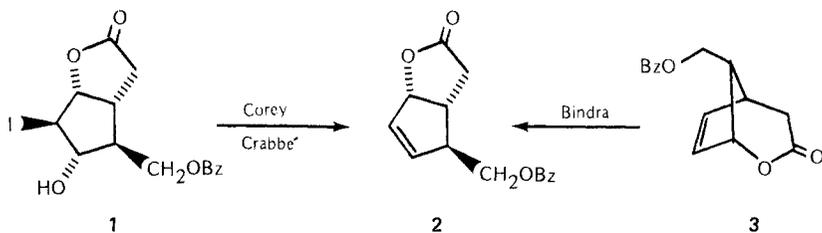

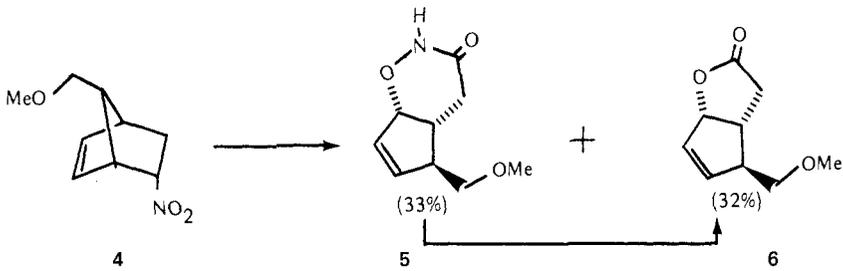
12. A PROSTAGLANDINS

Corey's bicyclo[2.2.1]heptane route to primary prostaglandins is readily modified to provide a convenient access to A prostaglandins. Cyclization approaches also appear to be particularly suited for preparation of PGAs, and a number of successful pathways have been described.

A. Syntheses from Bicyclo[2.2.1]heptane Precursors

The unsaturated bicyclic lactone **2** is a key starting point for synthesis of A prostaglandins modeled after Corey's bicycloheptane route.^{120,121} The lactone is readily available from the known iodolactone **1**,^{120,122} or directly by a cationic rearrangement cyclization sequence from the lactone **3**.¹²³ Alternatively, the bicyclic lactone may be prepared by an abnormal Nef reaction of the nitro norbornene **4**, readily available from Diels-Alder addition of nitroethylene to 5-methoxymethylcyclopentadiene.¹²⁴





A modification of Corey's bicyclo[2.2.1]heptane route for synthesis of A prostaglandins has been reported by Corey and Moinet.¹²⁵ The synthesis incorporates several of the improvements and reagents developed in the primary approach, but differs from it essentially in avoiding the lactonization step until after introduction of the lower chain. Two noteworthy features of this synthesis are the use of the biphenylurethano group to facilitate the key lactonization step (7→8) and the unusually facile resolution step, which is accomplished early in the sequence. The synthesis is outlined in Chart 12.1.

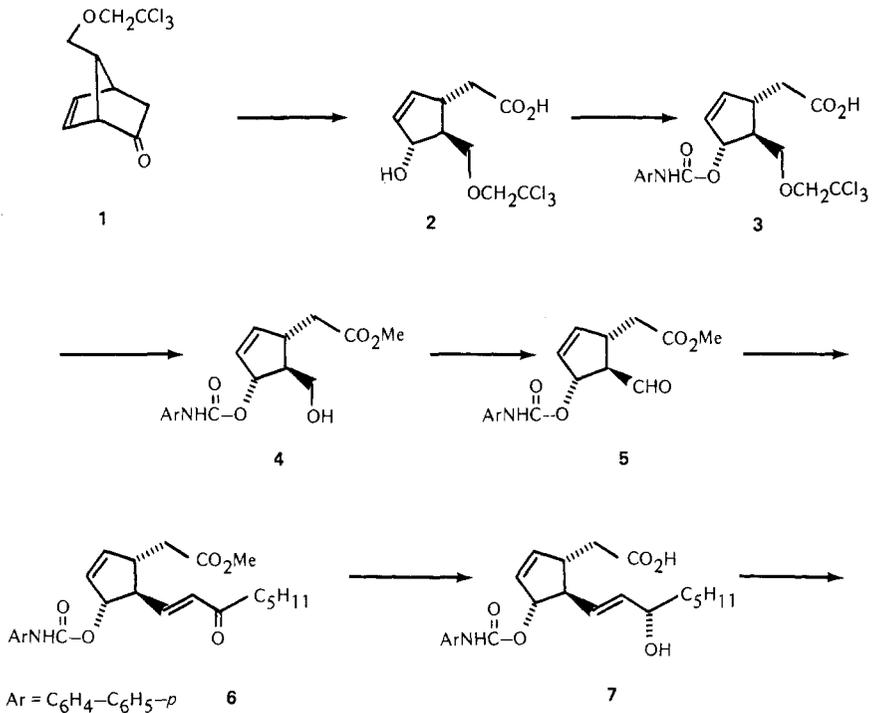
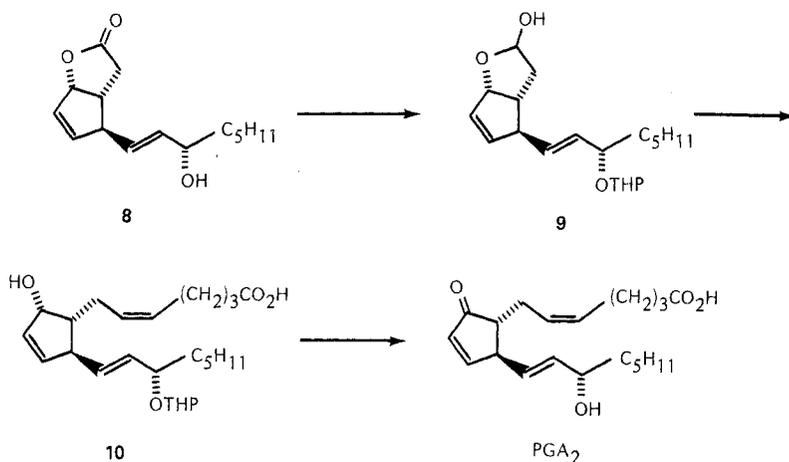
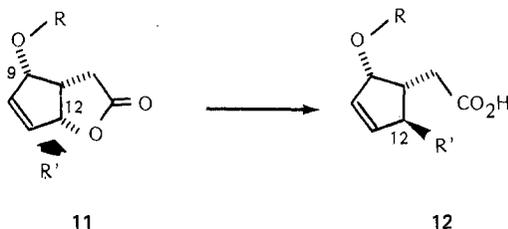


Chart 12.1. Synthesis of PGA₂ by Corey and Moinet.¹²⁵



The racemic carbamate carboxylic acid **3** was prepared essentially as described in the general bicyclo[2.2.1]heptane approach. Resolution of **3** with (+)-amphetamine afforded (-)-**3**, which was converted to the hydroxyurethane **4** in two steps, viz., esterification of the carboxyl group in **3** followed by removal of the trichloroethyl group with zinc-copper couple. Collins oxidation of the primary hydroxyl group in **4** gave the aldehyde **5**, which was converted to the enone **6** by Wadsworth-Emmons condensation with sodiodimethyl 2-oxoheptylphosphonate. Selective reduction to the 15(*S*)-alcohol (91%, together with 9% of 15(*R*)-isomer) followed by saponification of the methyl ester with base gave the acid **7**. Heating a solution of **7** in aqueous dimethoxyethane buffered to pH 7 produced the hydroxylactone **8**. The synthesis was then completed by protection of the secondary alcohol function as a tetrahydropyranyl ether, reduction to the lactol **9**, followed by Wittig reaction to give the oily hydroxy acid **10**. Collins oxidation of **10** and cleavage of the protecting group cleanly afforded (+)-PGA₂.

An alternative synthesis of the alcohol **8**, developed by Corey and Mann¹²⁶ (Chart 12.2), involves the attachment of ω-chain to the cyclopentane nucleus



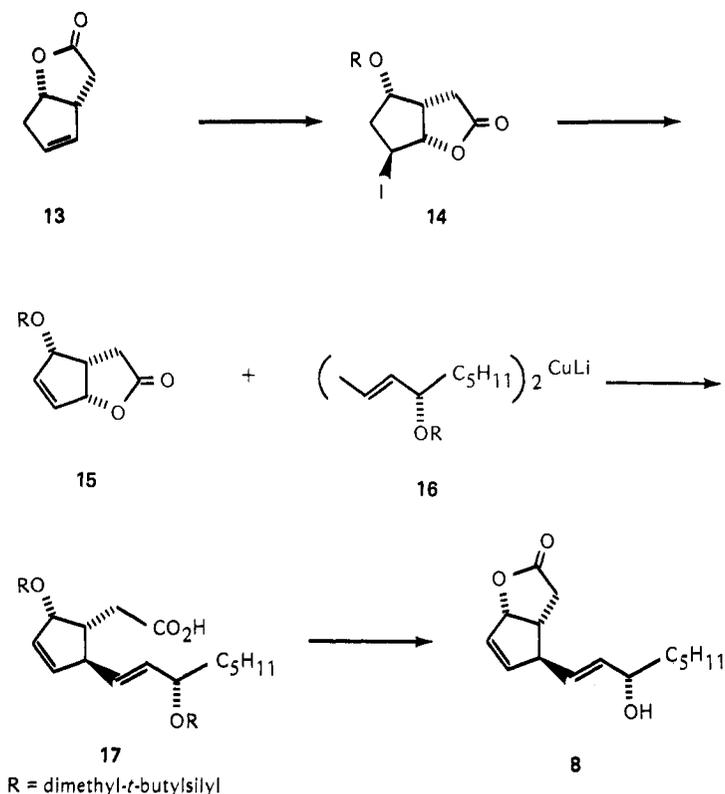


Chart 12.2. From Ref. 126.

by cross-coupling of a vinylic copper reagent with the allylic electrophilic site at C-12 (prostanic acid numbering) as shown in **11**. The second possible site of attachment on the allylic substrate (C-9) is effectively screened by a bulky dimethyl-*t*-butylsilyl group during the coupling.

Another noteworthy approach to PGA_2 has recently been described by Roberts and Newton.¹²⁷ This synthesis, commencing from the bicyclic lactone **18**, involves addition of the heterocuprate **22** to an allylic epoxide **21** as the key step (Chart 12.3).

B. The Roussel-Uclaf Approach

The stereoselective total synthesis of *d,l*- PGA_2 described by the Roussel-Uclaf group¹²⁸ is outlined in Chart 12.4. The synthesis involves as its key step the cyclization of the γ,δ -epoxyolefin keto ester **2** to furnish the cyclopentanone

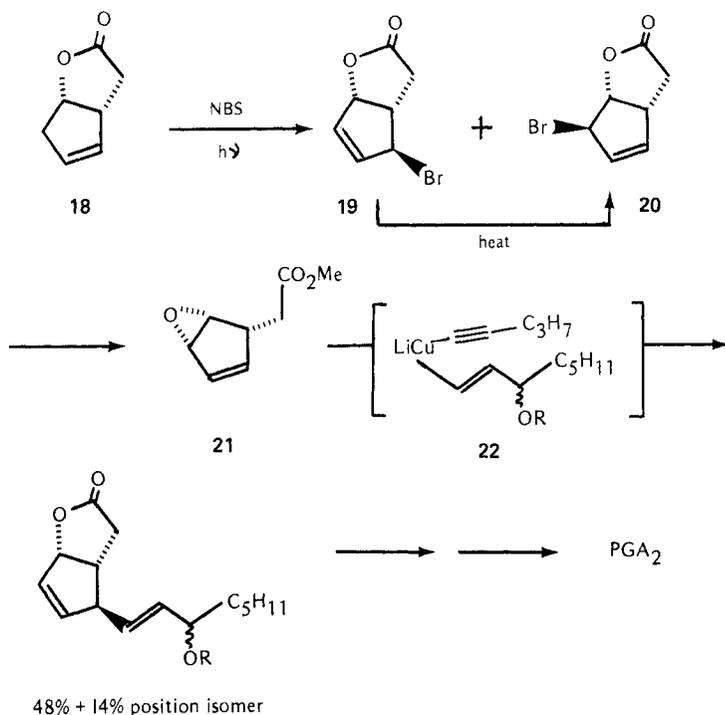


Chart 12.3. From Ref. 127.

3, with simultaneous generation of the desired relative stereochemistry at C-12 (*R*) and C-15(*S*). An examination of various transition states leading to the cyclized product suggests that the latter is obtained only if the precursor 2 has either the *cis-trans* or *trans-cis* configuration. These workers chose the *cis-trans* configuration for 2, electing to generate the *cis*-olefin by partial hydrogenation of an acetylenic linkage, and the *trans*-epoxide using Cornforth's epoxide synthesis.¹²⁹ Following cyclization and protection of the C-15 hydroxyl, introduction of the top chain is accomplished by alkylation of the enolate of 3 with 7-bromohept-5-enoate to give the prostanoid 4. Treatment of 4 with sodium ethoxide causes *retro*-Dieckmann and recyclization of 5. Introduction of the 10,11-double bond is then carried out by bromination of the enol ether 6 in methanol to give a bromoacetal 7, which dehydrobrominates to PGA₂.

C. Biogenetically Patterned Synthesis of PGA₂

An interesting biogenetically patterned synthesis of the key PGA precursor 6 (Chart 12.5) has been described by Corey et al.¹³⁰ The PGA ring has been con-

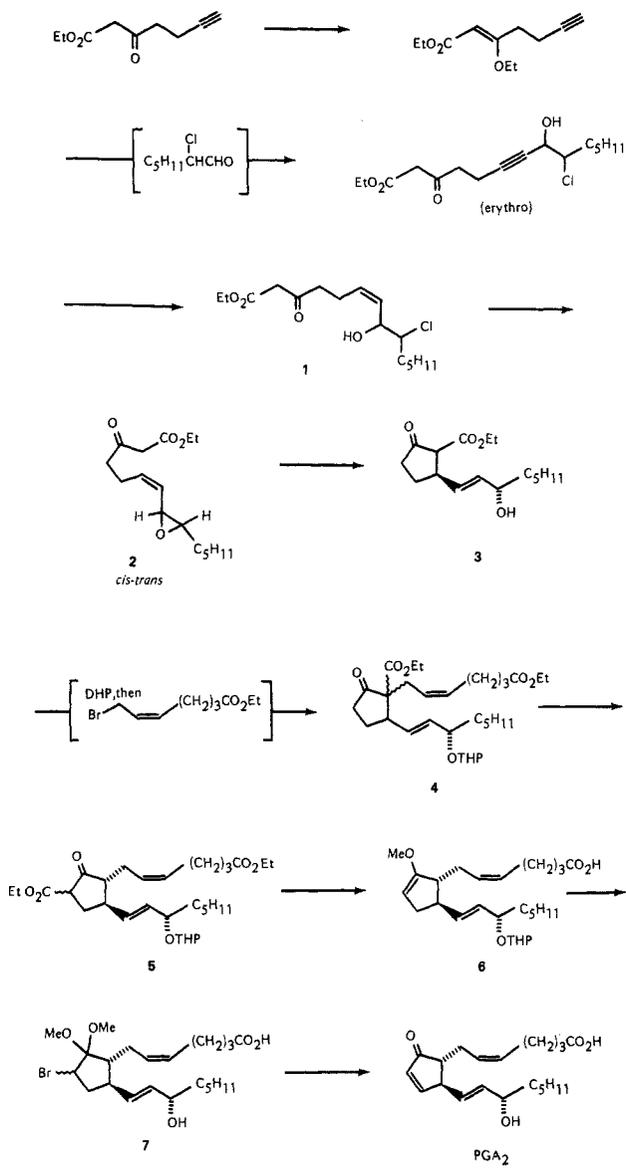


Chart 12.4. Roussel-Uclaf synthesis of PGA_2 .¹²⁸

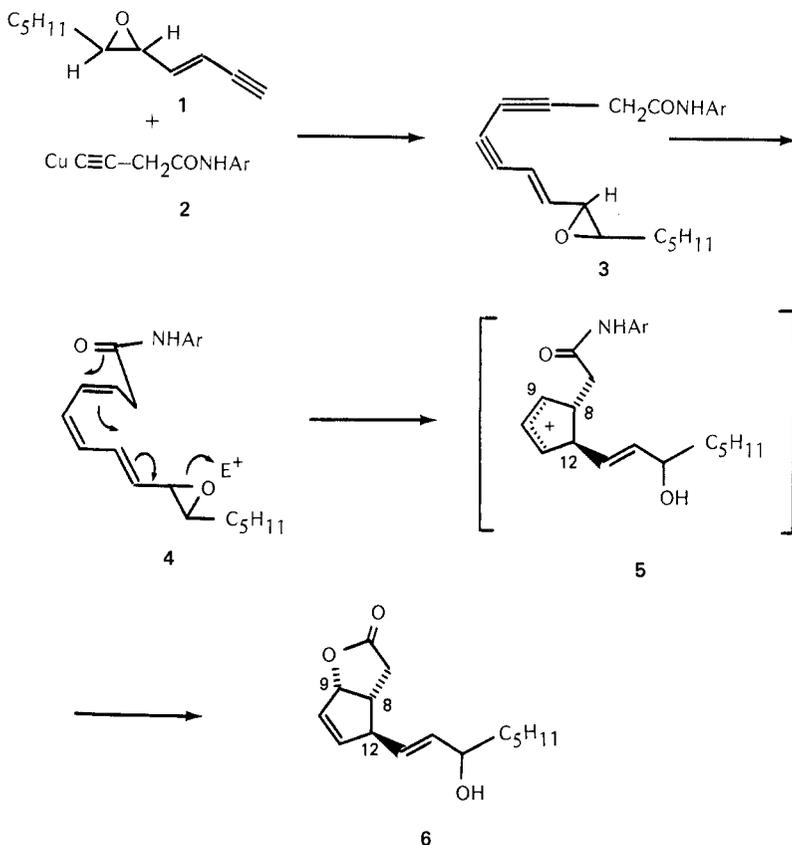


Chart 12.5. Corey's biogenetically patterned synthesis of PGA₂.¹³⁰

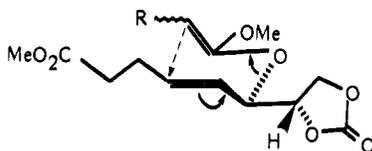
structed from the triene-amide-oxide **4** by a cationic cyclization process of the pentadienyl cation → cyclopentenyl cation type.¹³¹ The acetyl amide chain in the intermediate allylic cation **5** is effectively situated to deliver an oxygen functionality specifically to C-9 with simultaneous establishment of the *cis* arrangement of C-9 and C-8 substituents. *trans* Orientation of substituents at C-8 and C-12 was expected on thermodynamic and kinetic grounds.

Coupling of the cuprous acetylide **2** with the lithium salt of the acetylene **1** gave the enediyne **3**, and catalytic hydrogenation furnished the desired *trans*-*trans*-*cis*-triene epoxyamide **4**. The cyclization was carried out in a mixture of 2-nitropropane and 1-nitropropane at -104° by treatment with boron trifluoride. After hydrolysis of this mixture the lactone **6** was obtained along with an equal amount of its C-15 epimer in about 15% yield. The lactone **6** has previously been converted into PGA₂ in five additional steps.

D. The Columbia Approach

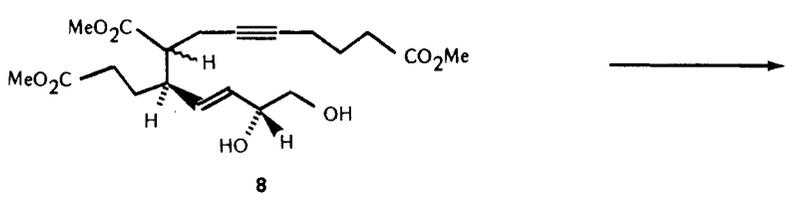
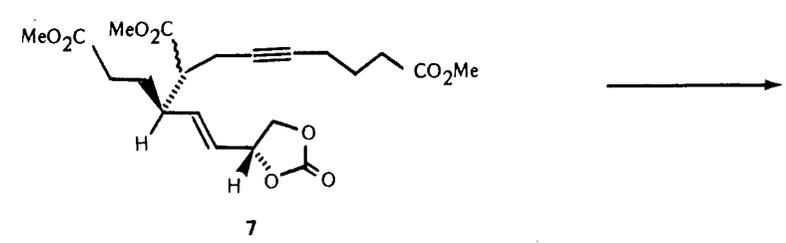
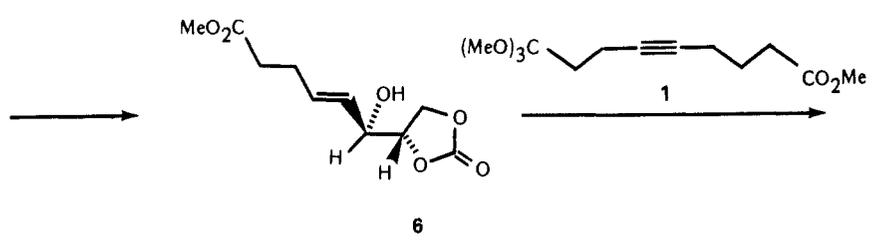
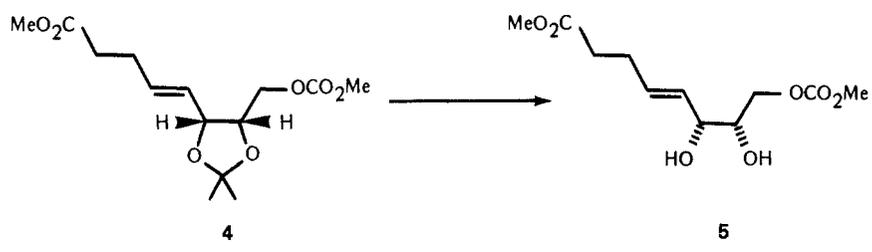
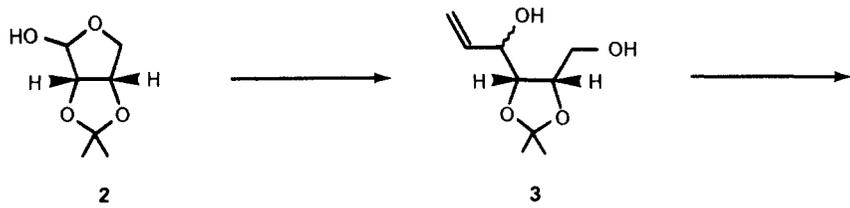
The synthesis of PGA_2 by Stork and Raucher,¹³² outlined in Chart 12.6, is an elegant example of chiral synthesis of prostaglandins from carbohydrates pioneered at Columbia. The synthesis commences from a readily available optically active sugar, L-rhamnose, already incorporating the C-15 asymmetric center. An interesting feature of the synthesis is construction of the key open-chain precursor (10) with the use of two Claisen rearrangements: one for production of the necessary *trans* geometry of a double bond (3→4), and the other as a means of transferring the chirality of the carbon-oxygen bond at C-14 to the carbon-carbon bond at C-12 (6→7).

2,3-Isopropylidene-L-erythrose (2), upon treatment with vinyl magnesium chloride, gives the vinyl carbinol 3. Protection of the primary alcohol in 3 as the methyl carbonate, followed by Claisen rearrangement gave the unsaturated ester 4. Hydrolysis of the acetonide group in 4 with aqueous acetic acid serves to unmask the allylic alcohol function required for the next Claisen rearrangement. Treatment of 5 with triethylamine gave the allylic alcohol cyclic carbonate 6, which was submitted to Claisen rearrangement with the orthoester 1 to give the trimethyl ester 7. The cyclic carbonate function in 7 was hydrolyzed with potassium carbonate in methanol and furnished the diol 8 in 59% overall yield from the acetonide 4. The crucial transfer of chirality during the transformation 6→7 occurs with the carbonate ring equatorial in the chair transition state 13. However, since the side chain R in 13 has no special steric preference, the product is a mixture of epimers at C-8, but the latter center is readily epimerized to the correct arrangement at the end.

Partial hydrogenation of the triple bond in 8, selective tosylation, followed by protection of the secondary hydroxyl group, gave the monotosylate 9. The latter coupled with lithium di-*n*-butylcuprate to give the desired 10 in 67% yield. The feasibility of carbon-carbon σ -bond formation by coupling of monotosylates of vicinal diols with lithium dialkylcuprates was examined in model studies.¹³³ Dieckmann cyclization of 10, followed by hydrolysis and acidification, gave the 11-deoxy-PGE₂ derivative 11 in 77% yield (18% overall from 2). Final transformation to natural PGA_2 was carried out by selective introduction of the α -phenylseleno group with phenyl selenyl chloride on to the dianion of 11



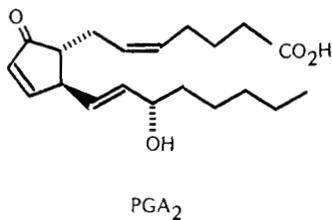
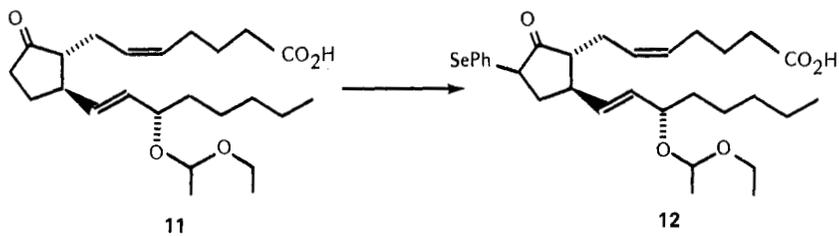
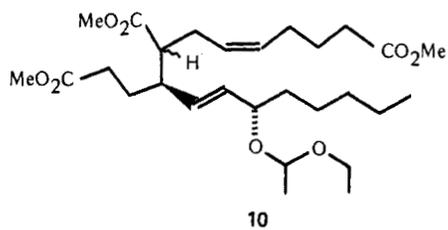
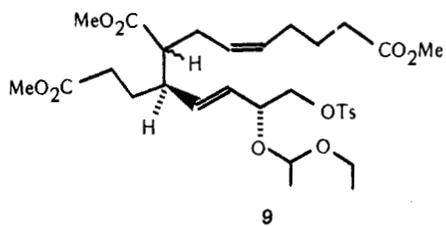


Chart 12.6. Columbia synthesis of PGA₂.¹³²

generated with lithium diisopropylamide. Oxidation of **12** with sodium *meta*-periodate and removal of the ethoxyethyl protecting group gave (+)-PGA₂ in 46% overall yield from **11** or 7.7% overall yield from **2**.

13. B PROSTAGLANDINS

The synthesis of PGBs attracted some attention briefly during the 1960s, but shortly afterward emphasis shifted to the synthesis of more challenging and biologically interesting prostaglandins of the E, F, and A series. The synthesis of B prostaglandins was discussed in Volume 1,¹ and no significant new developments have occurred since then. Interested readers may wish to consult recent reviews dealing with the synthesis of jasmone and related cyclopentenones, which are regarded as models for PGB compounds.^{134, 135}

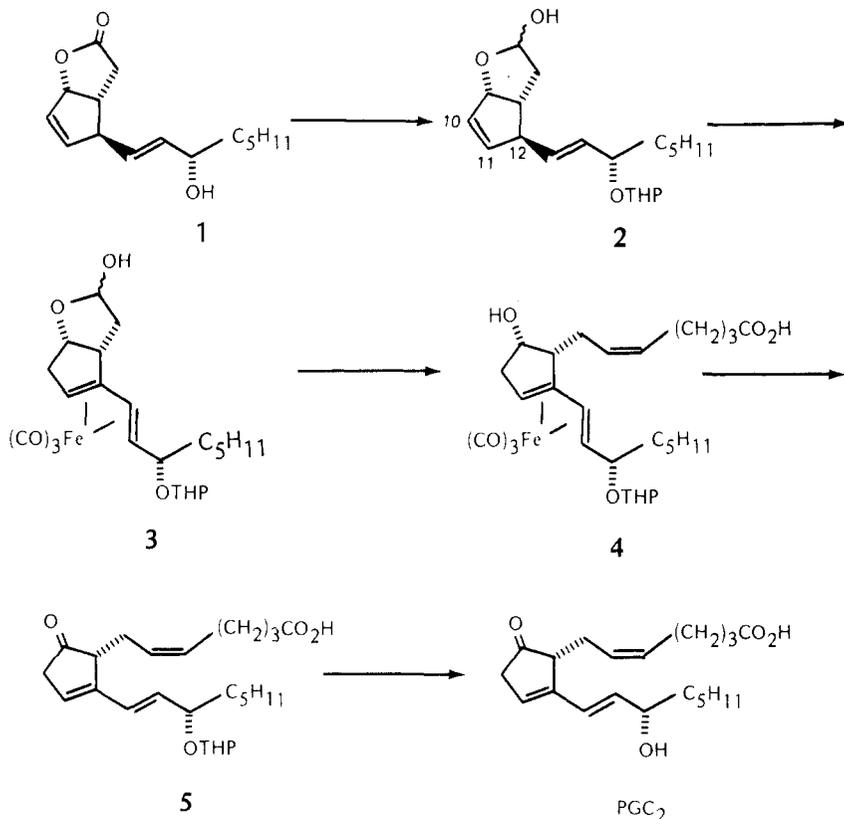


Chart 14.1. Synthesis of PGC₂ by Corey and Moinet.¹³⁷

14. C PROSTAGLANDINS

Prostaglandins of the A type are deactivated in mammalian blood by enzymatic conversion to an 11,12-double bond isomer, PGC, which is subsequently isomerized by base to the inactive PGB.¹³⁶ The C prostaglandins have powerful blood pressure-lowering activity and are therefore of considerable biological interest.

A. Syntheses from Corey's Intermediates

The synthesis of PGC₂, described by Corey and Moinet,¹³⁷ is based on a controlled triiron carbonyl-catalyzed isomerization of the 10,11-double bond in the known lactol 2 to the 11,12-position (Chart 14.1). Since PGC₂ is extremely sensitive to traces of acid or base, an extremely mild method was required for the removal of iron from 4. This was accomplished in 80% yield by reaction of 4 with excess Collins reagent, with simultaneous oxidation of the C-9 hydroxyl, to give the 15-tetrahydropyranyl derivative of PGC₂ (5). Cleavage of the THP group followed by reverse-phase chromatography gave PGC₂.

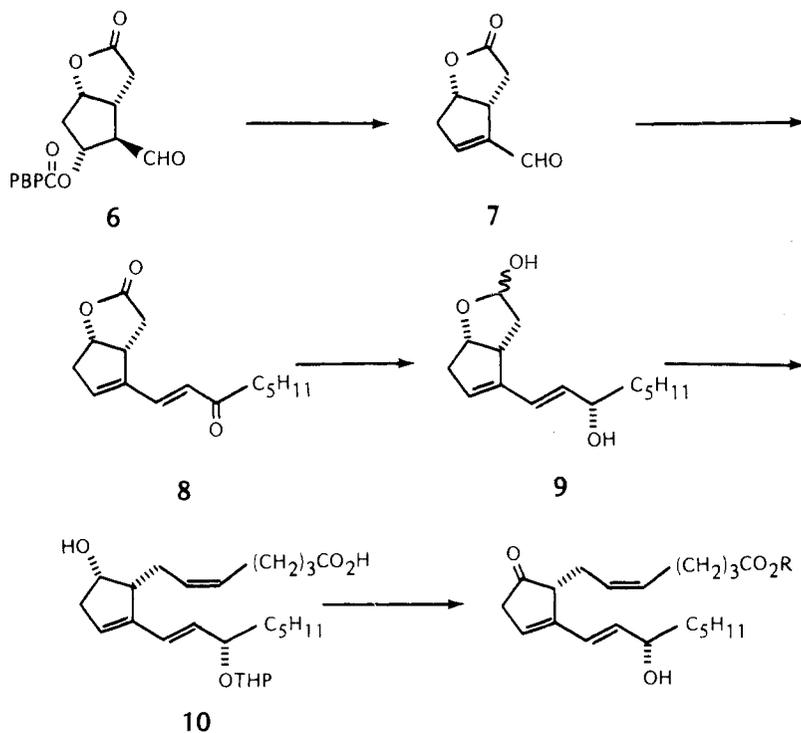
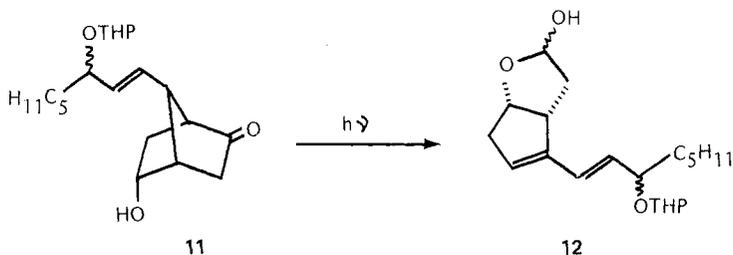


Chart 14.2. From Refs. 138 and 139.

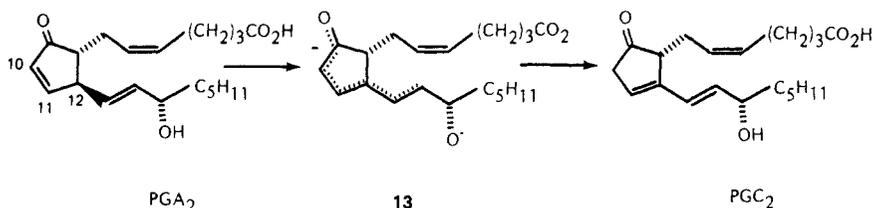

Two almost identical syntheses of PGC_2 closely modeled after Corey's bicycloheptane approach and proceeding via the key lactol **9** have been described by Kelly et al.¹³⁸ and by Crabbe's group (Chart 14.2).¹³⁹ An efficient photosynthetic route to the lactol **12** has been described recently by Roberts and Newton.¹⁴⁰



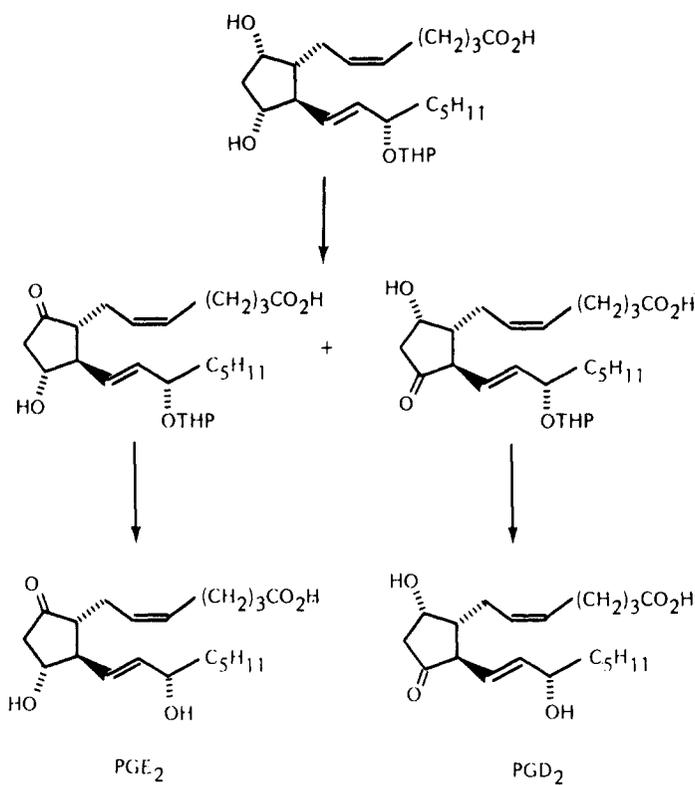
B. Synthesis from PGA_2

In view of its highly sensitive nature, PGC_2 is probably most conveniently prepared from PGA_2 rather than by total synthesis. Corey and Cyr¹⁴¹ have described a practical method for the conversion of PGA_2 to PGC_2 . The process involves generation of a γ -extended enolate ion **13** by proton abstraction from C-12 in PGA_2 , followed by α -protonation at C-10 under carefully controlled conditions to give PGC_2 .



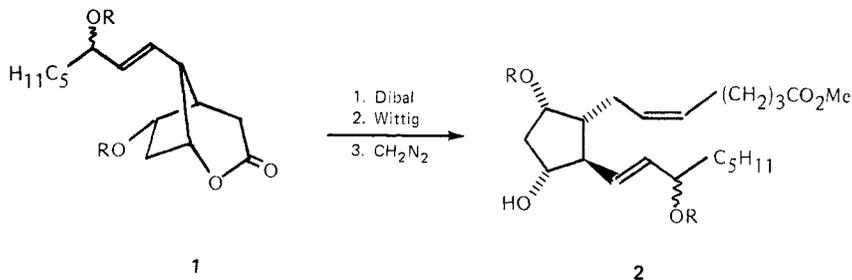
15. D PROSTAGLANDINS

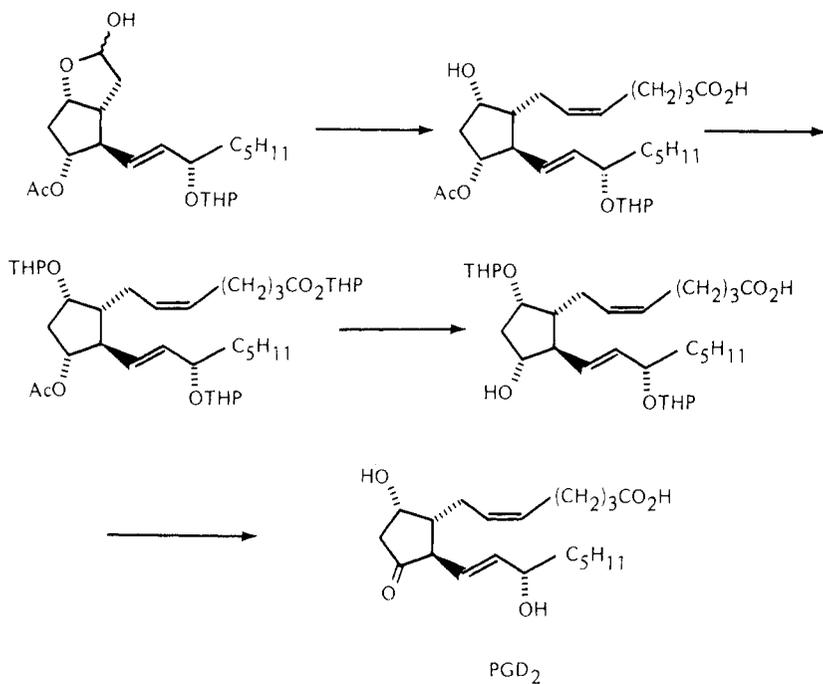
Two groups of workers have described total syntheses of PGD_2 , commencing from known intermediates of Corey's bicycloheptane approach. The shorter and simpler of the two syntheses is by Hayashi and Tanouchi,¹⁴² and affords a 2:1 mixture of 15-OTHP derivatives of PGD_2 and PGE_2 , which are separated chromatographically (Chart 15.1). The synthesis by a Ciba-Geigy group in Basle¹⁴³ is based on selective unmasking and oxidation of the C-11 hydroxyl

group in a differentially protected PGF intermediate and furnishes a 3:1 mixture of PGD₂ and PGE₂ (Chart 15.2).

By far the cleanest synthesis of PGD₂ has been reported by a Glaxo group,¹⁴⁴ who obtained the requisite differentially protected PGF derivative **2** from the lactone **1**.

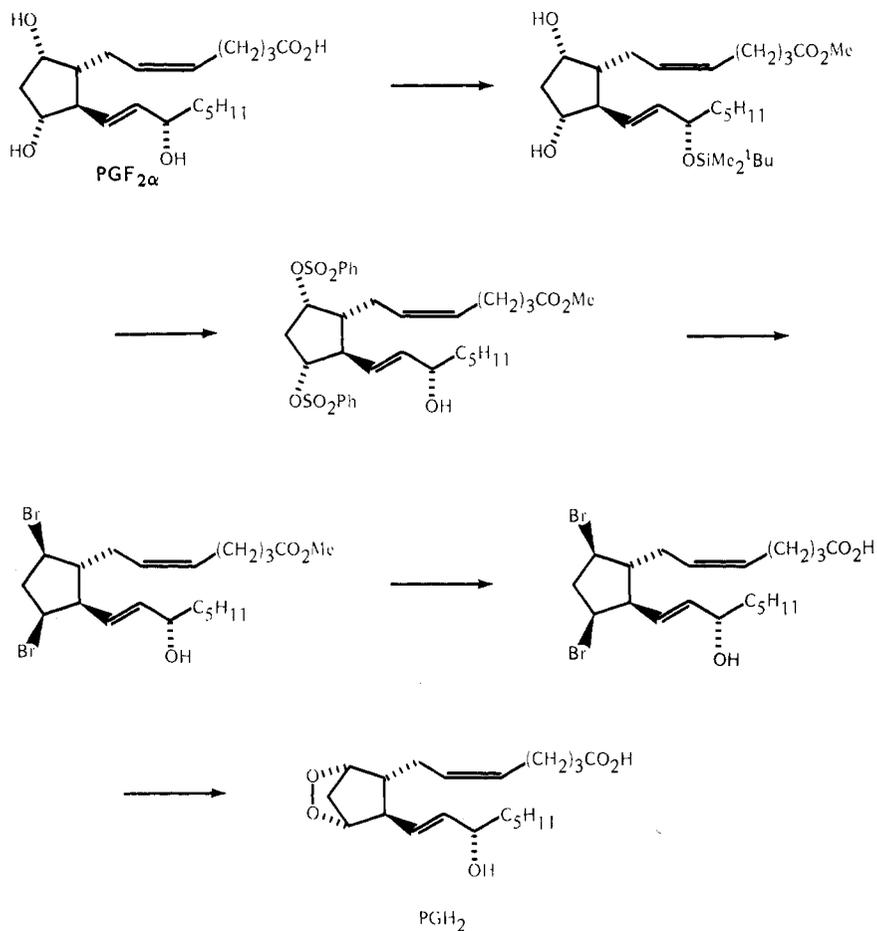


Chart 15.2. Ciba-Geigy synthesis of PGD₂.¹⁴³

16. H PROSTAGLANDINS

The prostaglandin endoperoxide (PGH₂) lies at a crucial biochemical branch point in the arachidonic acid cascade.¹⁴⁵ It may be converted to either thromboxane A₂ or prostacyclin, which exert diametrically opposite actions on platelet aggregation and vascular smooth muscle.¹⁴⁶

An Upjohn group reported the synthesis of PGH₂ methyl ester in 3% yield from 9β,11β-dibromo-9,11-dideoxy prostaglandin F_{2α} methyl ester by S_N2 displacement of bromide by hydroperoxide anion.¹⁴⁷ Subsequently, based on model studies with *cis*-1,3-cyclopentane dibromide, Porter and co-workers¹⁴⁸ prepared PGH₂ methyl ester in 20-25% yield from the dibromide using silver salts and hydrogen peroxide. The method has been extended successfully for the preparation of PGH₂ in overall 2-3% yield from PGF_{2α} (Chart 16.1).¹⁴⁹ Porter's approach opens the way for the preparation of analogs of prostaglandin endoperoxide that have previously been difficult or impossible to obtain by biochemical routes. Analogs of PGH₂ in which the peroxide linkage has been replaced by other atoms have been extensively investigated.¹⁴⁹

17. PROSTACYCLIN

Prostaglandin endoperoxides, PGH_2 and PGG_2 , are enzymatically transformed into prostacyclin (PGI_2), a substance with potent vasodilatory and antiaggregatory properties.^{146, 150}

Several simple and efficient syntheses of prostacyclin have been reported, and involve addition of halogens to $\text{PGF}_{2\alpha}$ derivatives for formation of the 5-membered ring ether involving C-6 and the C-9 oxygen. Corey et al.¹⁵¹ (Chart 17.1) reacted the 11,15-bis-THP derivative of $\text{PGF}_{2\alpha}$ with *N*-bromosuccinimide

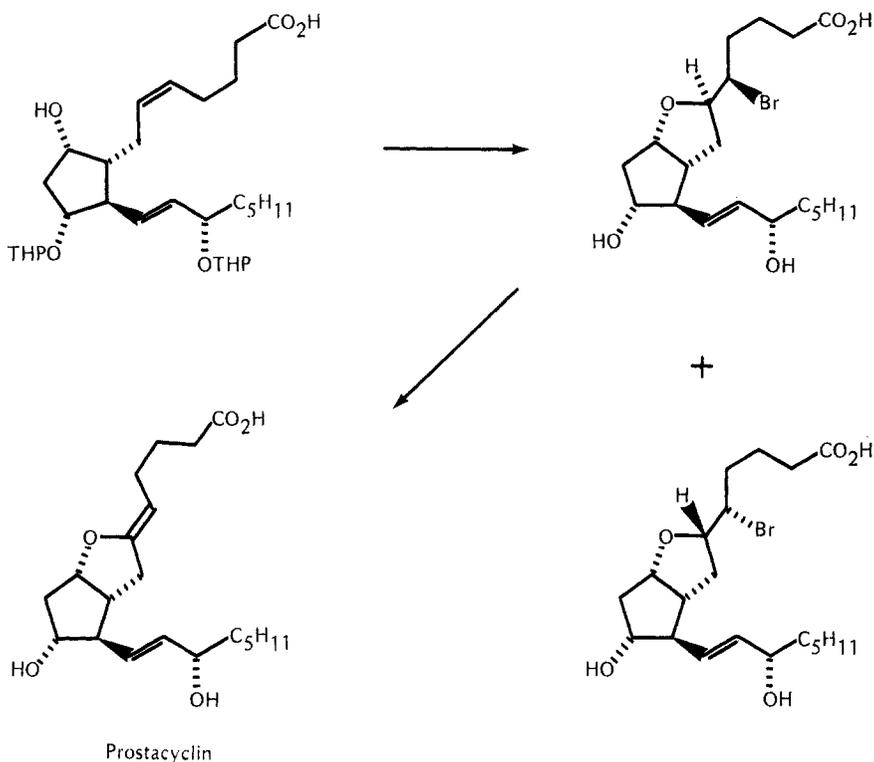
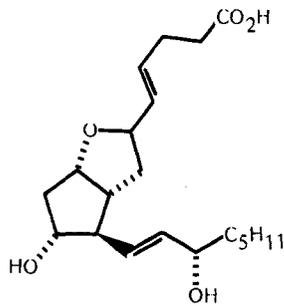


Chart 17.1. Synthesis of prostacyclin.

to obtain diastereomeric bromoethers, which were separated after depyranylation, and the major isomer treated with potassium *tert*-butoxide to furnish PGI₂. In the procedure developed by Nicolaou et al.^{152, 153} the methyl ester of PGF_{2α} was converted with iodine in methylene chloride in the presence of potassium carbonate to an iodoether, which was dehalogenated with sodium ethoxide for production of prostacyclin. Dehalogenation with DBU furnishes the prostacyclin methyl ester.¹⁵³ Using phenylselenium chloride as the electrophilic reagent furnishes a phenylselenoether, which eliminates to give the (4*E*)-isoprostacyclin isomer **1**.¹⁵⁴ Similar methodology was employed by Upjohn workers in their synthesis of prostacyclin.¹⁵⁵

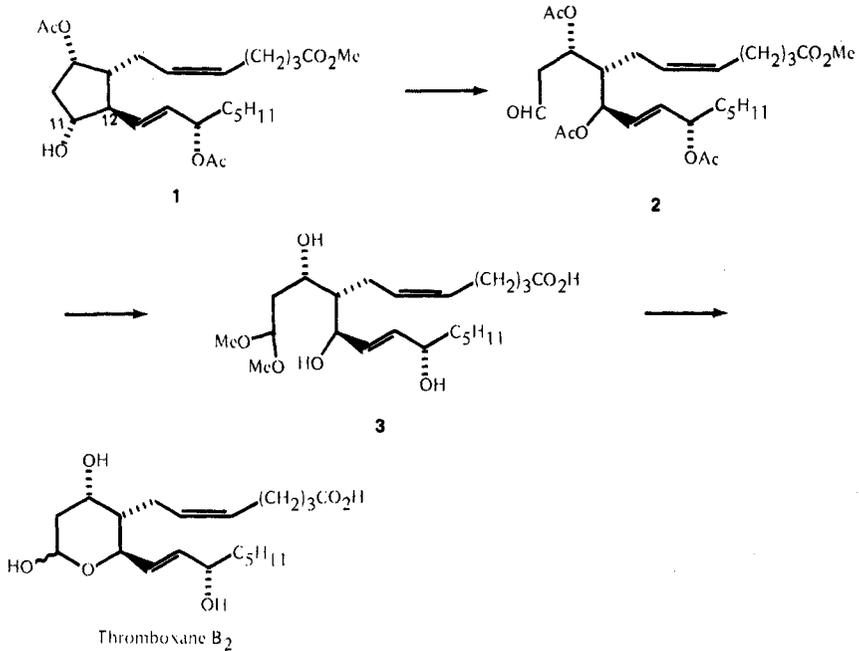
Because of the striking biological activities of prostacyclin, which make it a potential drug for treatment of thrombosis, stroke, and heart attack, the synthesis of prostacyclin analogs has attracted considerable interest, and a large variety of analogs have been prepared. Interested readers should consult the excellent review by Nicolaou et al.⁶

18. THROMBOXANES

The labile thromboxane A_2 , formed from the endoperoxides PGG_2 and PGH_2 , is a potent inducer of platelet aggregation and is a profound constrictor of vascular smooth muscle. Thromboxane A_2 is rapidly inactivated to thromboxane B_2 . While the unstable thromboxane A_2 has not yet been synthesized, several syntheses of thromboxane B_2 have been reported.

One of the first synthesis reported by an Upjohn group¹⁵⁶ involves cleavage of the 11,12-bond in 9,15-diacetoxy PGF_{2α} (**1**) to provide a direct access to thromboxane B₂ (Chart 18.1). Rupture of the cyclopentane nucleus using lead tetraacetate is facilitated by the homoallylic alcohol functionality in **1**. The unstable aldehyde obtained in this manner is protected as the dimethyl acetal. Removal of the acetate groups and hydrolysis of the acetal with aqueous phosphoric acid affords thromboxane B₂.

Two alternative routes to thromboxane B₂ developed at Upjohn are based on cleavage of the cyclopentane nucleus in known prostanoid intermediates. The

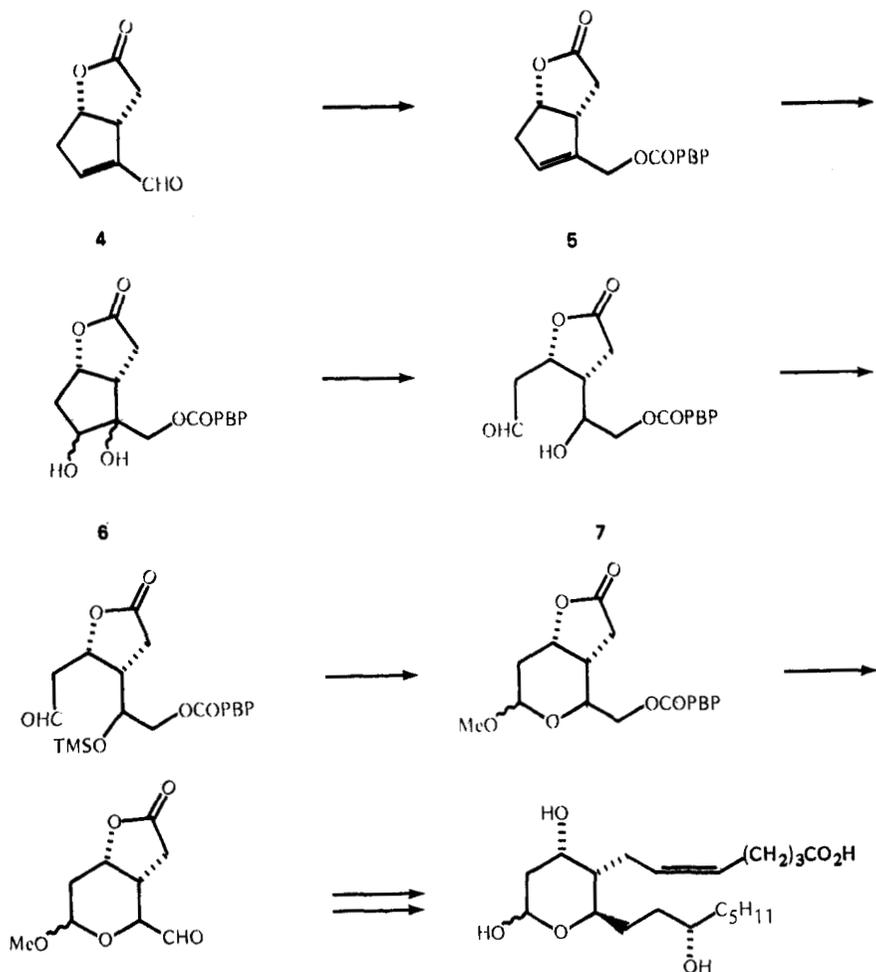
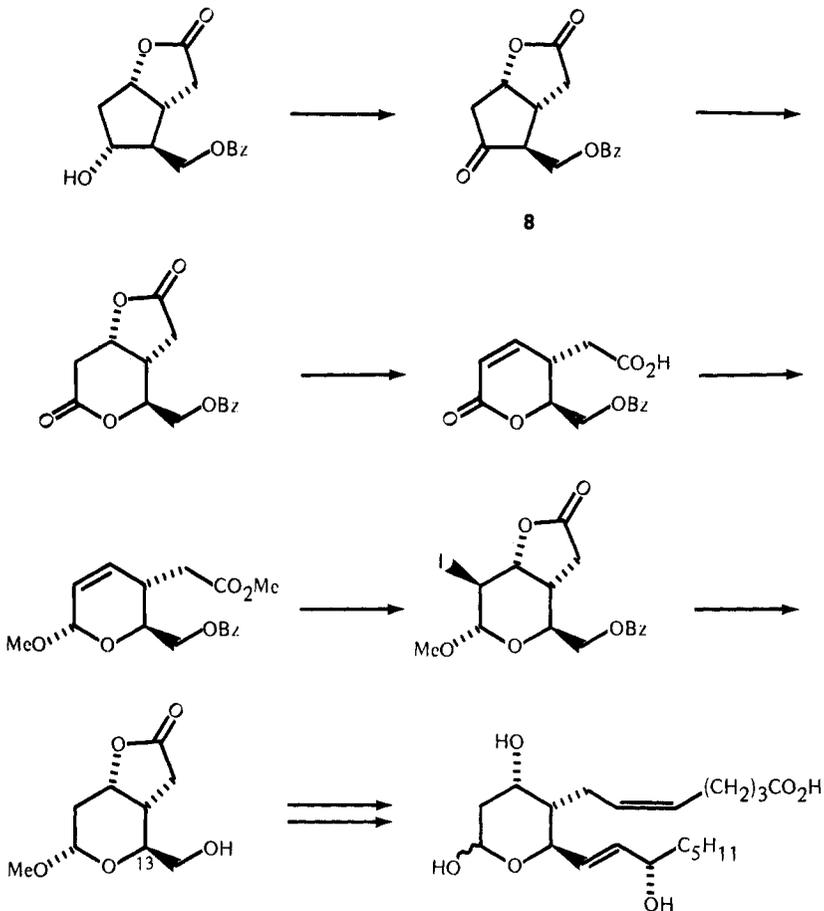

key step in the synthesis by Nelson and Jackson¹⁵⁷ is based on periodate cleavage of the 11,12-bond of 4 to give the unstable aldehyde 7, which furnishes the desired pyran nucleus (Chart 18.2). A variant of this strategy involves cleavage of the 5-membered ring via a Bayer-Villiger oxidation of the cyclopentanone 8 (Chart 18.3).¹⁵⁸ Treatment of the resulting dilactone with base, followed by reduction with diisobutylaluminum hydride and protection of the hemiacetal, allows unmasking of the C-13 aldehyde functionality for attaching the ω -chain.

A particularly elegant approach to thromboxanes involves their total synthesis from optically active monosaccharides. Hanessian's synthesis¹⁵⁹ is based on the systematic and stereospecific introduction of substituents on the chiral framework of a 2-deoxysugar derivative readily available from D-glucose (Chart 18.4).



Corey's stereocontrolled synthesis of the key bicyclic lactone **4** (Chart 18.5)¹⁶⁰ is based on Claisen rearrangement of the unsaturated sugar derivative **6** with *N,N*-dimethylacetamide dimethylaminal to the dimethylamide **7**. Iodo-lactonization and deiodination furnishes the desired hydroxylactone **4**.

A total synthesis of thromboxane B₂ from a nonprostanoid, acyclic precursor was also developed by Corey et al.¹⁶¹

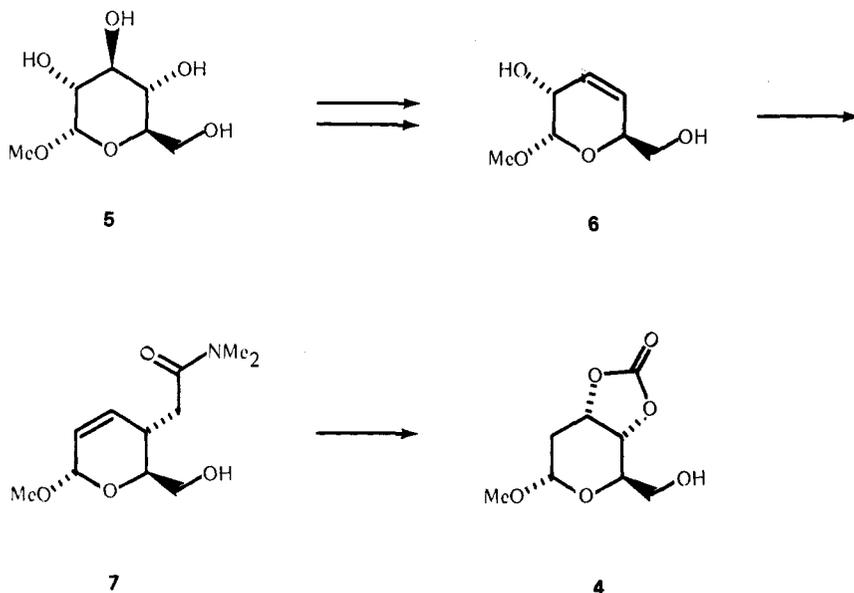


Chart 18.5. Corey's approach to thromboxane B₂.¹⁶⁰

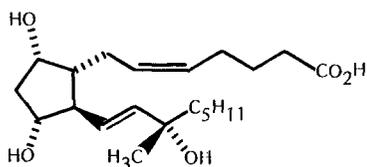
19. THERAPEUTIC PROSPECTS

Progress during the last ten years in the art of prostaglandin synthesis can only be described as phenomenal. All of the natural prostaglandins are now readily available by total synthesis, and the chemist interested in a specific analog can choose from any number of practical approaches to his target. Progress toward developing prostaglandin analogs with useful therapeutic properties has been disappointing, however. Breeding selectivity into these molecules and taming side effects has been altogether a difficult proposition. Only a few from among the handful of analogs described below are expected to find application in medical use during the near future.

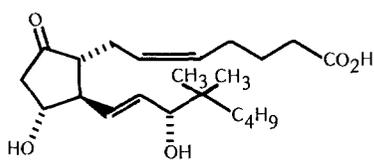
Not unexpectedly, some of the earliest and most promising practical applications of prostaglandins have been in obstetrics and gynecology.¹⁶² Natural

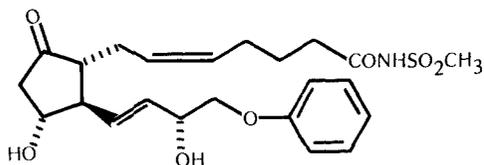
PGF_{2α} (dinoprost) and PGE₂ (dinoprostone) were introduced in the United States by Upjohn as early as 1973 for hospital use for the induction of labor at term, and on a limited basis for termination of second trimester pregnancy. The use of natural prostaglandins in the clinics, however, is severely limited by their short duration of action and a high incidence of side effects that are undoubtedly related to their relatively poor target organ specificity, and a number of analogs have appeared designed to alleviate these problems. Upjohn's 15-methyl-PGF_{2α} (carboprost) and 16,16-dimethyl-PGE₂, designed to enhance metabolic stability, exhibit greater potency and longer duration of action on the human uterus than the parent prostaglandins.



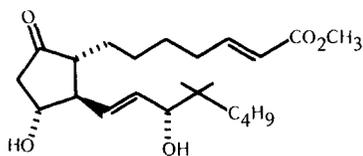

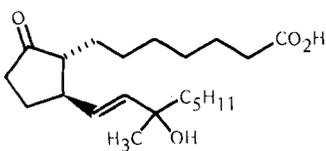
Sulprostone, which is being developed by Pfizer and Schering AG, was also designed to be metabolically more stable. Pharmacological studies indicate that sulprostone is one of the most selective prostaglandin uterine stimulants known. Clinical trials confirm that sulprostone combines high efficacy and low incidence of side effects when used for pregnancy termination.¹⁶³



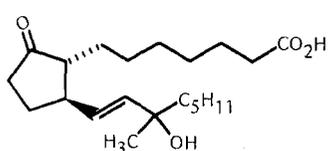

Encouraging results have been reported in studies with ONO-802 and Upjohn's 9-deoxy-16,16-dimethyl-9-methylene-PGE₂ (1) for termination of first and second trimester pregnancies. Cloprostenol (Estrumate) and fluprostenol (Equimate) are phenoxypstaglandins introduced into the United Kingdom in 1975 and 1976, respectively, by ICI as veterinary luteolytics for synchronization of estrus in animals and for treatment of infertility in horses. The allenic prostaglandin analogs, prostalene and fenprostalene, are under study as luteolysins by Syntex.

Doxaprost (15-methyl-11-deoxyprostaglandin E₁) and the corresponding 13,14-dihydro analog, deprostil, are under study by Ayerst as bronchodilator and gastric antiseecretory agents. Other antiseecretory and antiulcer analogs of interest include Upjohn's 15-methyl-PGE₂ analog arbaprostil and 16,16-dimethyl-PGE₂. Searle's SC-29333 (15-deoxy-16-hydroxy-16-methyl-PGE₁, antiseecretory), Yamanouchi's YPG-209 (a 16-methyl-20-methoxy-PGE₂ analog, bronchodilator), and Ono's ONO-358 (coronary vasodilator) appear promising based on animal pharmacology tests. Clinical work with prostacyclin and prostacyclin analogs is as yet at a preliminary stage.

1. INTRODUCTION

Perhaps the best beginning to a second edition of the synthesis of monoterpenes would be a list of errata from the first edition! This list is at the end of this section.

The first edition (Vol. 2) has been described by Hoffmann as “wissenschaftlich.”¹ If this means “theoretical” as opposed to “industrial,” it is not because the industrial syntheses were ignored in the first edition – on the contrary, they are nearly all there (but see citral, p. 471 in this edition) – but rather because the proportion of published work is small. Much of it is in the patent literature, about which some academics still take the attitude that it is not “publication” in the true sense of the word. (To illustrate how wrong this idea is, one might read the reviews of Hoffmann¹ or Nürrenbach.²) Since the proportion of published industrial to academic synthesis has possibly even decreased recently, this edition may appear even more “theoretical.” Nevertheless, the supply situation of natural products is not improving, and industry keeps a “weather eye” on academic synthesis.

In this chapter an attempt is made to present those syntheses that introduce

some novel aspect in preparing the natural products, even though they may not be economically practical. Multistage syntheses of common products are mentioned, but not generally discussed, since these are usually of interest only in cases where labeling is required.

There are, in fact, two quite different types of synthesis associated with monoterpenoids, and these different types are linked with specific classes of monoterpenoids. Generally speaking, the syntheses of dimethyloctane derivatives fall into "industrial" if not "classical" patterns, as do syntheses associated with menthanes. The other extreme is represented by the iridoids. Syntheses are long and highly complex, and it is not difficult to see that one must always attach a higher price label to compounds like this, which are characterized by an increased number of asymmetric centers, and furthermore have few readily available members of the class from which others may be made. In this they differ from most of the bicyclic monoterpenes, which, apart from being derivable from menthanes at least on paper, nearly all have one or more members available in large amounts, with the possible exception of the thujanes.

Phenolic monoterpene synthesis has not been discussed in this chapter.

Concerning the occurrence in nature of monoterpenoids, we do not pretend that this chapter gives a complete list of natural products, although an attempt has been made to be precise about whether a given synthesis leads to a natural product or not. A useful list of monoterpenoids (and other materials) occurring in natural aromas is given by Ohloff.³

Literature is complete up to approximately October 1979, with occasional later references.

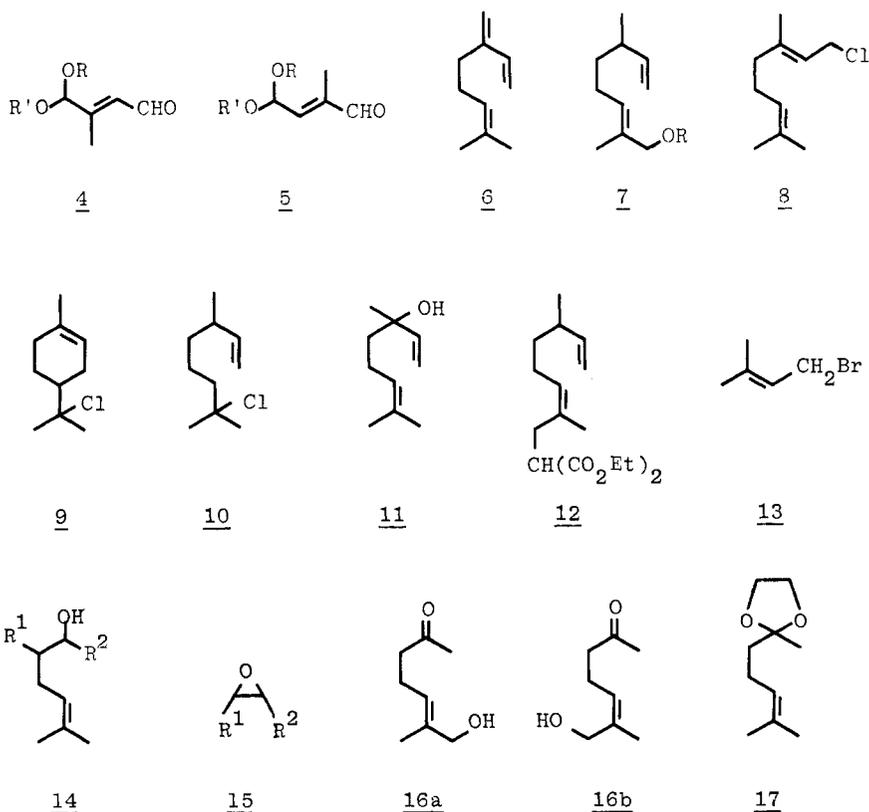

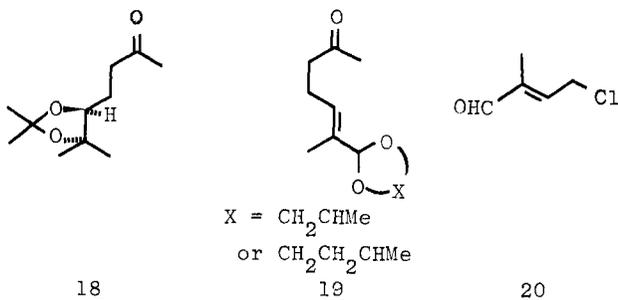
Some C_5 acetals, 4, 5, have been prepared in stereochemically pure form (though not from isoprene), and these could be very useful for terpene synthesis.¹⁴

The telomerization of isoprene produces a very large literature, but few of the papers report highly specific synthesis of natural products. Use of sodium and

secondary amines can lead to fairly efficient syntheses of myrcene (**6**)¹⁵, while palladium catalysts with alcohols can be made to give either tail-to-tail dimers,¹⁶ or head-to-tail dimers,¹⁷ one system [PdCl₂-C₆H₅CN + (C₆H₅)₃P and NaOR] leading mainly to **7**.¹⁸ Dimerization with Pd-phosphine complexes and CO₂ also gives mostly tail-to-tail isomers.¹⁹ Stannic chloride telomerization can produce, in addition to tail-to-tail isomers, up to 61% of (*E*)- and (*Z*)-isomers of geranyl chloride (**8**),²⁰ the (*Z*)-isomer cyclizing under these conditions to the 8-chloromenthene (**9**).²¹ The dimerization of isoprene using lithium naphthalene has also been studied.²²

Use of these mixtures has been made to synthesize monoterpenes, for example, treatment of the mixture of dimers obtained from isoprene and formic acid in the presence of triethylamine and various palladium catalysts with hydrochloric acid yields a chloride **10**, which can be separated from other dimers. *t*-Butyl peracetate oxidation of **10** in the presence of cuprous bromide, followed by lithium aluminum hydride reduction and heating yields linalool (**11**).²³ A few further papers on the subject might be quoted: head-to-tail dimeri-





zation can be favored in the presence of nickel catalysts,²⁴ and Baker has used this fact to prepare 12.²⁵

Prenyl bromide (13) (and other prenyl halides) are excellent functionalized isoprenes; further examples of their use will be found later, but a few general reactions are given here. With CrCl_3 and LiAlH_4 in tetrahydrofuran, 13 mostly yields tail-to-tail dimers.²⁶ Treatment with the anion of a functionalized dithiane enables the bromine atom to be replaced by an alkyl group,²⁷ and the Grignard reagent, well known to react in the allylically rearranged form, reacts in the unrearranged form (to give 14) with epoxides 15 in the presence of 10% cuprous iodide.²⁸

The anodic oxidation of isoprene has been studied, but yields (in methanol at -25°) are very low, with ca. 10% head-to-tail dimers.²⁹

3. 6-METHYL-5-HEPTEN-2-ONE

In Vol. 2 of this series (p. 7), it was briefly mentioned that this vital intermediate for terpene synthesis could be made from prenyl chloride and acetone. Improvements in the method consist in carrying out the substitution using solid alkali in the presence of an organic amine and/or ammonia,³⁰ a reaction which also forms higher ketones. The latter can be cracked by water at $230\text{-}310^\circ$, resulting in greatly increased yields of methylheptenone.³¹

The preparation of hydroxylated methylheptenones, specifically (*E*)- (16a) and (*Z*)- (16b), using selenium dioxide oxidation of the acetal 17 for 16a,^{32,33} and Wittig reaction (the "cis-modification") of the aldehydoacetal obtained by ozonolysis of 17 for 16b has also been described.³³

Attention is drawn to the preparation of a methylheptenone in which the double bond is protected by a chiral group, 18.³⁴ This was prepared from (*S*)-phenylalanine, and can in principle be used to synthesize chiral terpenes.

A functionalized methylheptenone 19 has been made from 20 (one method for the preparation of which is described in Ref. 8) by acetoacetate ketone synthesis on the acetal of 20.³⁵

4. 2,6-DIMETHYLOCTANE DERIVATIVES

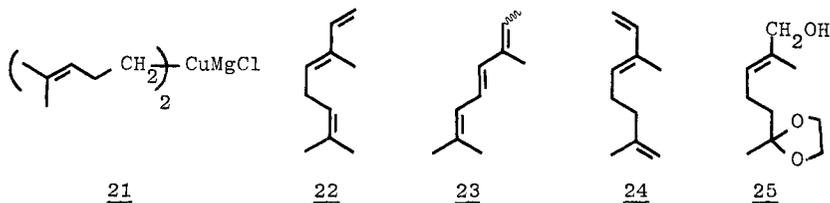
A. Hydrocarbons

There is very little new work in the synthesis of naturally occurring hydrocarbons of this series. What is practically a one-step synthesis of myrcene (6) by addition of 1-buten-3-yne to the organocuprate **21**,* is reported,³⁶ but myrcene is still readily available from pinene (Vol. 2, p. 8) by pyrolysis. It has been reported that the problem of the isomerization of (*E*)-ocimene (**22**) to alloocimene (**23**) occurring extensively under these conditions can be circumvented by rapid cooling of the pyrolysate.³⁷ Vig et al. have synthesized myrcene from ethyl acetoacetate³⁸ and from ethyl 5-methyl-4-hexenoate,³⁹ and α -ocimene (**24**) from **25**.⁴⁰ All these syntheses are straightforward, and all involve Wittig reactions.

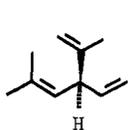
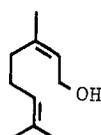
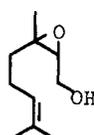
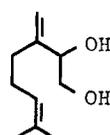
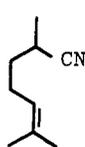
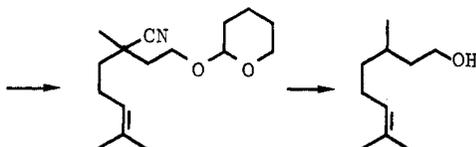
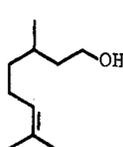
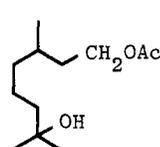
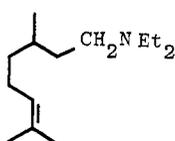
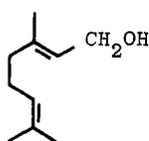
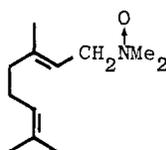
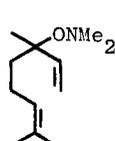
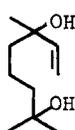
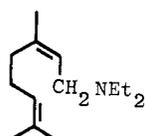
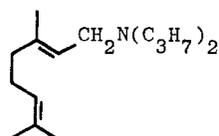
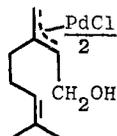
"Achillene" is not the compound **26** synthesized by Schulte-Elte (Vol. 2, p. 12)⁴¹, but is identical with santolinatriene (**27**).⁴² Although Schulte-Elte was unable to obtain from the Russian authors a direct comparison of his synthetic product, this has not stopped Dembitskii et al. from correcting their work without reference to either Schulte-Elte, or to the original publication⁴³ of the NMR spectrum of their "achillene" (**26**).⁴² The name should now be deleted from the literature.

Nerol (**28**) has been converted into myrcene (**6**) by Yasuda et al. It is first epoxidized with *t*-butyl hydroperoxide and vanadium(IV),⁴⁴ and the trimethylsilyl ether of the epoxide **29** is treated with 2,2,6,6-tetramethylpiperidine diethylaluminum. This reacts stereospecifically to yield the diol **30**, which was converted to myrcene (**6**) by cuprous bromide and phosphorus tribromide at -78° followed by zinc. Following the same route, geraniol gives (*E*)-ocimene (**22**).⁴⁵

A review of the marine terpenoids, a large number of which are halogenated myrcenes, but very few of which have been synthesized, has been published by Faulkner.⁴⁶

B. Alcohols

Citronellol

The synthesis of natural (-)-citronellol is still as reported in Vol. 2 (p. 14), but a new synthesis of the racemate has been achieved by reaction of 4-methyl-3-pentenyl bromide with the anion of propionitrile in hexamethylphosphoramide. The resulting nitrile **31** is allowed to react in the form of its anion with 2-chloroethanol tetrahydropyranyl ether, and the product **32** is reduced with potassium and *t*-butanol in hexamethylphosphoramide to citronellol (**33**).⁴⁷

Treatment of 3,7-dimethyloctyl acetate with ozone adsorbed on silica gel at -78° (the technique of Mazur⁴⁸), leads to a mixture of oxygenated substances, 65% of which is the hydroxylated citronellyl acetate (34).⁴⁹ The diethylamine 35 corresponding to citronellol has been isolated from Réunion geranium oil and synthesized from citronellal oxime.⁵⁰

Linalool (11), Nerol (28), Geraniol (36)

The wide occurrence of these alcohols and their esters precludes a list of natural products, but we cannot resist mentioning that neryl formate is an alarm pheromone of the cheese mite *Tyrophagus putrescentiae*,⁵¹ and wondering, in view of the fact that it is used in perfumery,⁵² what the effect of a perfumed hand over a dish of doubtful cheese would be!

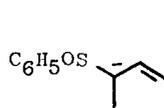
Because geranic esters are readily converted to 28 and 36 their synthesis is included in this section. The novel "reverse" allylic rearrangement from the dimethylamine oxide 37 to the hydroxylamine 38 occurs on heating, and Rautenstrauch has used this fact to make very pure linalool (11) by reduction of 38 with zinc in acetic acid.⁵³ Takabe et al. have repeated this work⁵⁴ using diethylgeranylamine prepared from isoprene,¹⁵ also making the diol 39 by the Rautenstrauch route after hydroxylating the amine with aqueous sulfuric acid.⁵⁴ Rautenstrauch also found that if the linalyl hydroxylamine 38 was heated, it reverted to the geranyl hydroxylamine, zinc-acetic acid reduction of which yielded geraniol and nerol (2:1).⁵³ This has also been repeated by Takabe et al.⁵⁵ The reverse transformation can also be carried out by reduction of the mesylate of geraniol epoxide with sodium (or calcium) in liquid ammonia.⁵⁶ Using the nerylamine 40 prepared by the action of lithium or butyllithium on isoprene and diethylamine, Takabe et al. prepared nerol via the chloride (obtained with ethyl chloroformate and 40) and neryl acetate.⁵⁷ They have also shown that when myrcene (6) is treated with lithium and dipropylamine, the geranylamine 41 is obtained, which can be converted to geraniol (36) by the same route.⁵⁷

Of the various publications concerning the complexes of myrcene with palladium,^{58,59} one is particularly interesting. The complex in question 42 is formed from myrcene (6) and $(\text{CH}_3\text{CN})_2\text{PdCl}_2$ in hexamethylphosphoramide and water (10:1). When it is treated with sodium methoxide in methanol it yields 45% of nerol (28), 36% of citral (below), but no geraniol.⁶⁰

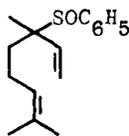
One type of synthesis of dimethyloctane alcohols employs activated anions (cf. the early work, Vol. 2, p. 54, in a synthesis of chrysanthemic acid⁶¹). Two groups adopted this approach: Evans et al. used the 4-carbon unit phenyl sulfide anion 43, adding isohexenyl iodide to obtain the sulfoxide 44, readily convertible to a 9:1 mixture of geraniol (36) and nerol (28).⁶² Julia used the phenyl sulfone (45) anion,⁶³ which, together with prenyl bromide (13), yields the sulfones 46. Reduction of this mixture gave esters having the geranic acid

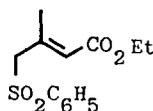
(47) and lavandulic acid (48) skeletons. The condensation step can be carried out under phase-transfer conditions, which leads to a considerable improvement in the accessibility of geraniol by this route.⁶⁴ Julia has since developed the principle further by using the anion of a prenyl phenyl sulfone, which, with



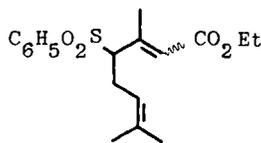

isoprene epoxide (2), gives the sulfone 49 derived from linalool (11). Reduction of 49 by either sodium amalgam or lithium in ethylamine leads to a mixture of linalool (11) and its unnatural double-bond isomer 50.⁶⁵ One of the synthons mentioned in Table 1⁵ is closely related to a sulfone 51 that Julia et al. made from isoprene. The dianion of this sulfone 51 can be condensed with a prenyl halide (they used the chloride corresponding to 13) to yield a sulfone 52 derived from geraniol. Reduction of the latter sulfone with sodium amalgam leads to (*Z*)- and (*E*)-ocimene (22), but with lithium in ethylamine, geraniol is obtained.⁶⁶ Prenyl bromide (13) has also been condensed with the dianion of 3-methyl-3-butenol (53), the isobutylene-formaldehyde Prins product (see a new industrial citral synthesis below). This reaction leads to the methylene isomer (54) of geraniol,* which has been converted to a mixture of the geometrical isomers of geranic acid.⁶⁷

A group of C₅ + C₅ syntheses of geraniol and nerol has dealt with the selective formation of a (*Z*)- or (*E*)-double bond. One approach consists in the addition of prenyl bromide (13) to the dianion of 3-methyl-2-butenic acid (55, "senecioic acid"), followed by methyl iodide. Esters of geranic acids (*E*-56, and *Z*-56) and the ester corresponding to lavandulol (57, R = OH) are obtained, the presence of a cuprous salt, added before the halides, markedly increasing the proportion of the products of γ -addition 56.⁶⁸ Katzenellenbogen and Crumrine also found a 9:1 ratio of γ - to α -regioselectivity (with 45:55 (*Z*):(*E*)-isomers of 43 esters) from the reaction of the ethyl ester of 55 and prenyl bromide (13) in the presence of cuprous iodide.⁶⁹ Another C₅ + C₅ synthesis is the copper-catalyzed Wurtz-type reaction between the Grignard reagent of a prenyl halide (e.g., 13 — care is needed to avoid allyl rearrangement) and the chloroalcohol 58.⁷⁰

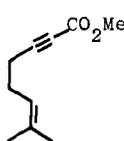
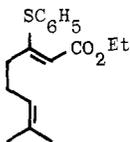
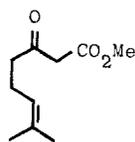
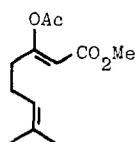
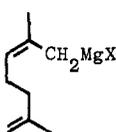
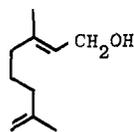
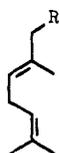
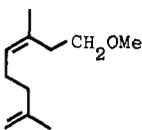
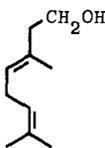
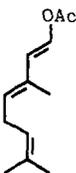
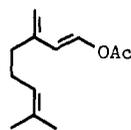
Related to these syntheses are some C₅ + C₄ + C₁ types. One, leading to highly stereoselective (*Z*)-56, consists in prenylating (with 13) the dianion of 2-butyric acid (made from the acid with lithium diisopropylamide). This leads to the acetylenic ester 59, to which lithium dimethylcuprate adds very stereoselectively, yielding the (*Z*)-ester of 56 which can be reduced to nerol (28) with lithium aluminum hydride.⁷¹ An alternative route from 59 to ethyl geranate consists in treating the acetylenic ester (actually the ethyl ester was employed) with thiophenol and sodium ethoxide. The resulting thioester 60 is methylated (99% stereospecific) with methylmagnesium iodide and cuprous iodide.⁷²

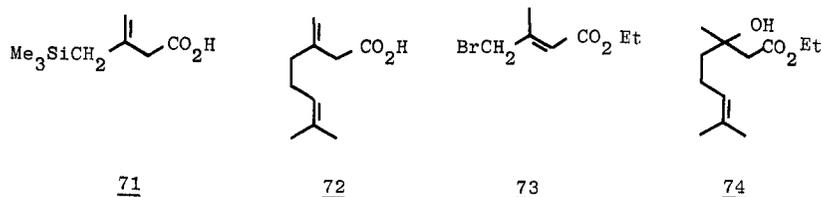
The dianion of methyl acetoacetate⁷³ can also be prenylated, forming the ketoester 61. Isopropenyl acetate gives an enol acetate 62 with the latter, and 62 can be converted into geranic ester with lithium dimethylcuprate, reduction

yielding geraniol (36).⁷⁴ This reaction becomes stereoselective if advantage is taken of the fact that when the formation of the enol acetate **62** is carried out using isopropenyl acetate in the presence of *p*-toluenesulfonic acid it is mainly the (*Z*)-isomer (as written in **62**) that is formed (20:1 ratio), while with acetyl chloride and triethylamine in hexamethylphosphoramide, the (*E*)-isomer of **62** is formed (1:12 ratio). The stereoselectivity is even higher in the case of the enol benzoates.⁷⁵ Isoprene reacts with Grignard reagents in the presence of diethyltitanium dichloride. The use of methallyl chloride as starting material gives the Grignard reagent **63**, which can be treated with formaldehyde to give α -geraniol (**64**), or with carbon dioxide to give the corresponding acid (erroneously called "geranic acid" in the publication).⁷⁶

A further method of joining isobutenyl bromide to isoprene is to use morpholine in the presence of catalytic amounts of palladium acetate. Treatment of the reaction mixture with methyl chloroformate replaces the morpholine in the adduct thus obtained **65** (as the major adduct, 54%) by chlorine, and conversion to isogeranic ester **66** was effected by carbonylation with carbon monoxide and ethanol over a palladium chloride catalyst, but in poor yield.⁷⁷

Use of the C_6 synthon (1) in Table 1⁷ only means that the units have been joined together in a different way ($C_5 + C_1 + C_4$), and the Grignard reagent from methallyl halide reacts with this synthon 1 to give α -isogeranyl methyl ether (67).⁷⁸ The same synthon 1 reacts with isoprene in the presence of titanium tetrachloride, dechlorination of the product this time giving the α - and β -isomers of isogeranyl methyl ether.⁷⁹

The same authors made (*E*)- β -isogeraniol (68) stereospecifically by reducing citral enol acetate (69) with sodium borohydride, when the other citral enol acetate (70) remained unchanged.⁷⁹

The organometallic isohexenyl derivative (21, in the form of its lithium complex) adds to the dimethylacetal of 2-butyne to yield the dimethylacetal of citral in high yield.⁸⁰ The magnesium bromide complex (21, Br) will also add to the trimethylsilyl ether of 3-butyne; after aqueous workup 54 is obtained (for which the authors of the method employ the unacceptable name "myrcenol").⁸¹

Reaction of diketene with $\text{Me}_3\text{SiCH}_2\text{MgCl}$ in the presence of nickel chloride in tetrahydrofuran gives the functionalized isoprene 71. In the form of its dicopper dienolate (made with lithium diisopropylamide and cuprous iodide in tetrahydrofuran), this can be prenylated with prenyl bromide, and after removal of the silicon, the product is the methylene isomer 72 of geranic acid. The latter is obtained on treatment of 72 with strong base.⁸² With nickel carbonyl, prenyl bromide (13) yields a nickel complex, and the latter reacts with the bromoester 73 to form ethyl geranate.⁸³

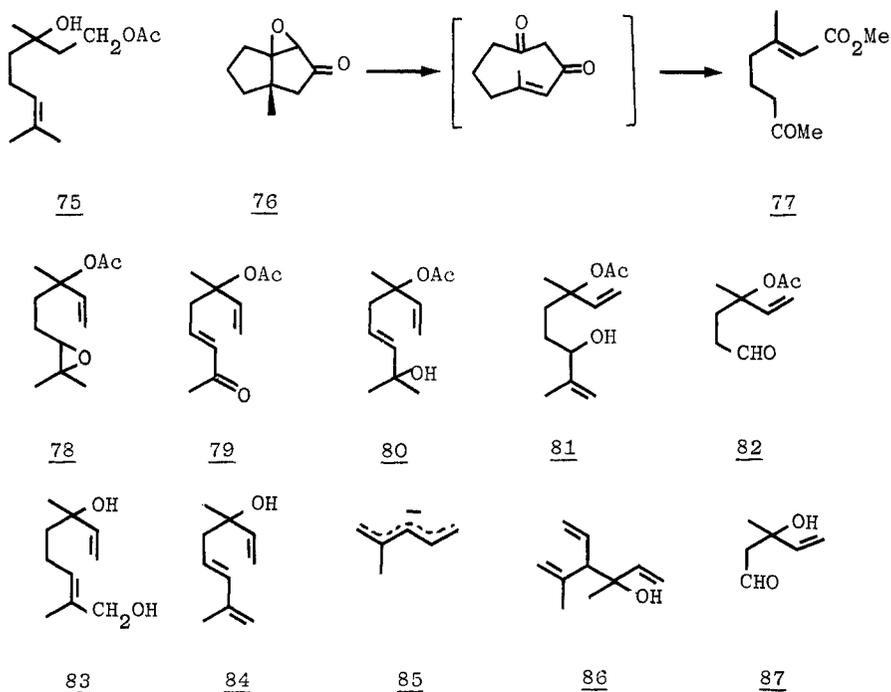
The lithium enolate of ethyl acetate adds to 6-methylhept-5-en-2-one, thus constituting a new $C_8 + C_2$ route, but the hydroxyester 74 obtained did not undergo dehydration with aluminum diethoxychloride and lithium diisopropylamide so stereoselectively as had been hoped (the hope having been based on studies with model compounds).⁸⁴

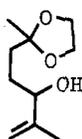
6-Methylhept-5-ene, made from prenyl bromide (13) and 2-propynylmagnesium bromide can be converted to geranic esters via addition of ethyl chloroformate to the anion (giving 59) and following the routes given above.^{71, 72} Alternatively, treatment with the complex $\text{Me}_3\text{Al}-\text{Cl}_2\text{Zr}(\text{C}_5\text{H}_5)_2$ in dichloroethylene yields an aluminum complex which gives geraniol after adding butyllithium and formaldehyde, or ethyl geranate after adding ethyl chloroformate.⁸⁵

A mixture of prenyl pyrophosphate and isopentenyl pyrophosphate gives nerol (**28**) pyrophosphate in the presence of farnesyl pyrophosphate synthetase,⁸⁶ such biosynthetic routes being commonly supposed to pass through a carbenium ion equivalent. When prenyl acetate and isopentenyl acetate (excess) are heated with lithium perchlorate in acetic acid (solvent), a reaction resembling the biosynthesis occurs, but the products obtained are only minor amounts of neryl and geranyl acetates, the major products being the acetates of **54** and the two geometrical isomers of **68**.⁸⁷ Isopentenyl acetate (**53**-acetate) with excess 2-methyl-3-buten-2-ol in the presence of trifluoroacetic acid yields the acetate **75** by a similar reaction.⁸⁸

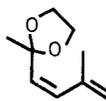
Perhaps the fact that the epoxyketone **76** undergoes a unique ring opening to the ketoester **77** on treatment with sodium carbonate in methanol, and that **77** is readily converted to methyl geranate⁸⁹ can hardly count as an economic approach to geraniol (**36**), but it certainly involves the most original route published in recent years.

Among the labeled geraniols that have been synthesized, leading references can be found in papers referring to the preparation of [7-¹⁴C]-,^{90,91} [7',8-¹⁴C]-,⁹¹ [7',8-³H]-,⁹¹ and [3'-¹⁴C]-geraniol.⁹² Geraniols and linalools labeled with fluorine have been prepared,^{93,94} and 2-fluorogeraniol was converted into its pyrophosphate for studies on the biogenesis of farnesyl pyrophosphate.⁹⁴

Oxidized Linalools, Hotrienol, Dehydrogenated Nerol, and Geraniol

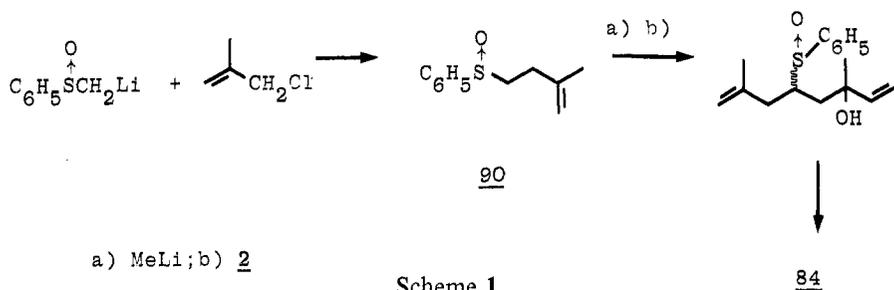
A number of oxidized linalyl acetates, 78-82, occur in lavandin oil, possibly as artifacts; these can be made by the photooxygenation of linalyl acetate.⁹⁵ The photooxygenation of linalool (11) has also been reexamined.⁹⁶ Compound 81 occurs in lavender and lavandin with the acetoxy and hydroxy groups interchanged.⁹⁷ The diol 83,* found in Greek tobacco, was synthesized from linalool by selenium oxide oxidation,⁹⁹ and the glucosides of the two possible geometrical isomers of 83 have been found in *Betula alba* bark and the fruits of *Chaenomeles japonica* (Rosaceae),¹⁰⁰ although no synthesis of the (*Z*)-isomer has been reported.

The acetate of the aldehyde corresponding to 83 has been identified in lavandin oil.⁹⁵ More recent reports of hotrienol (84) in grape and wine flavor¹⁰¹ and in nutmeg oil have appeared.¹⁰²

Pentadienyl anions can be made from pentadienes and butyllithium in tetrahydrofuran.¹⁰³ The 2-methylpentadienyl anion (85) exists in a mixture of conformations,¹⁰³ but with methyl vinyl ketone, it yields about 35% of hotrienol (84) in one step, accompanied by the alcohol 86, also in about 35%.¹⁰⁴ This synthesis of Wilson's has also been adapted to prepare another natural monoterpenoid alcohol (below).

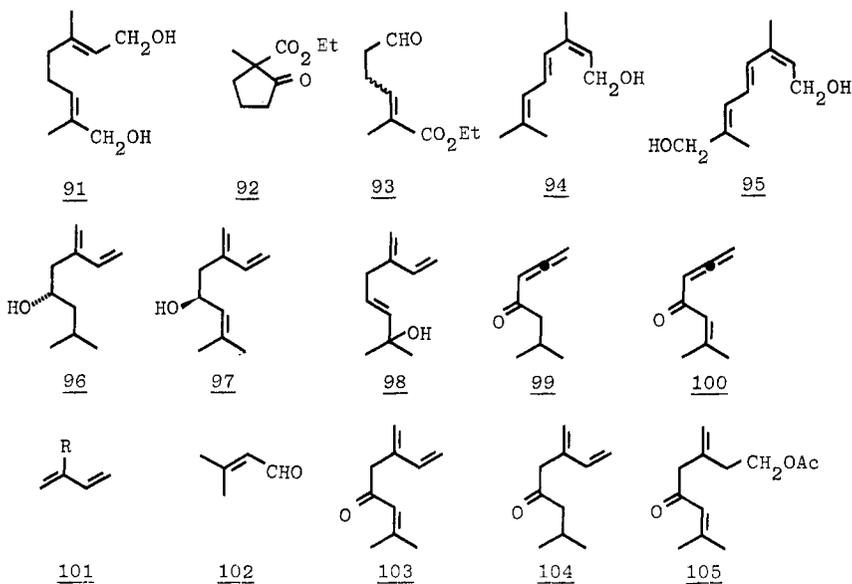
The aldehyde 87 has been prepared from the acetal of acetylacetaldehyde (3-oxobutanal), and Wittig reaction leads to the (\pm)-trienol 84.¹⁰⁵ Another synthesis involves potassium permanganate fission of the double bond of the acetal (17) of methylheptenone,¹⁰⁶ but the most interesting of this series by Vig et al. is his claim to have made the (*Z*)-isomer of hotrienol by dehydration of the photooxygenation product 88 of methylheptenone acetal (17). Using phosphorus oxychloride in pyridine, this is said to yield the (*Z*)-diene 89, from which (*Z*)-hotrienol is readily made by deacetalization and Grignard reaction.¹⁰⁷ Julia's synthesis of the (\pm)-(*E*)-isomer compares favorably with the earlier ones and depends on the formation of the sulfoxide 90; this can again form a carbanion from which isoprene epoxide (1) yields the hotrienol skeleton, the phenylsulfoxide group being removed in refluxing toluene (Scheme 1).¹⁰⁸

*This diol is also formed by microbial hydroxylation of *Nicotiana tabacum*.⁹⁸



The diol **91** occurs in the hairpencils of the Monarch butterfly, and has been synthesized by Kossanyi et al. The key step of the synthesis is a Norrish Type I photolysis of the cyclopentanone **92** to yield the aldehydes **93**. The latter were easily converted to the diol **91**.¹⁰⁹

The isovalerate of dehydronerol (**94**) was isolated from *Anthemis montana* (Compositae),¹¹⁰ and synthesized from 2-methylhepta-2,4-dien-6-one by the Horner-Wittig reaction to the esters (*2Z*, *4E*)- and (*2E*, *4E*) corresponding to **94**. After separation of these (thin-layer chromatography), the natural product was obtained by reduction of the (*Z*)-isomer with lithium aluminum hydride and esterification.¹¹¹ Bohlmann and Zdero have also isolated the most oxidized dimethyloctane monoterpene alcohol **95** in the form of various esters from another Compositae, *Schkuhria senecioides*,¹¹² but the synthesis is not yet reported.

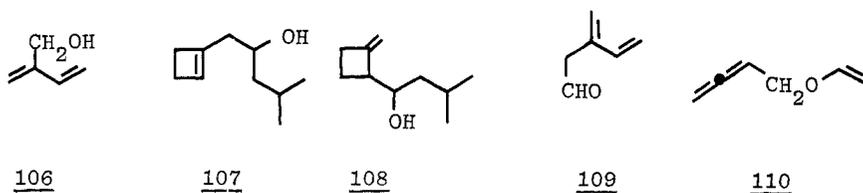


Ipsenol (96), Ipsdienol (97), 2-Methyl-6-methylen-3,7-octadien-2-ol (98)

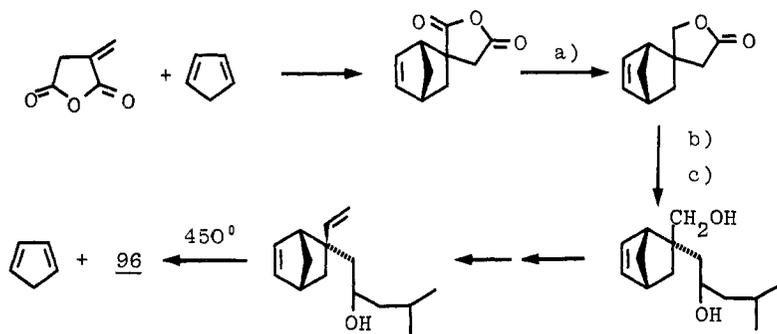
The sex attractants of *Ips confusus* (Vol. 2, p. 26) and other beetles¹¹³ have received considerable synthetic attention. The natural products **96**, **97** have the (*S*) configuration, that is, have opposite stereochemistries,^{114, 115} and are usually accompanied by the allyl isomer **98** of **97**, which also occurs in *Pinus ponderosa*¹¹⁶ and *Ledum palustre*.¹¹⁷ Ipsdienol (**97**) is the biosynthetic precursor of ipsenol (**96**), the transformation being effected only by male *Ips* beetles.¹¹⁸

If the starting material were readily available, a simple synthesis of both **96** and **97** starts from metallated allene. (Metallated allenes can be made either by direct lithiation of allenes with butyllithium in tetrahydrofuran, or by metal exchange of bromoallene.) The metallated allene is treated with an amide of 3-methylbutyric acid (for **96**), or 3-methyl-2-butenic acid (for **97**). The products (respectively **99** and **100**) can be vinylated with vinyl cuprate in ether, yielding ipsenol (**96**) or ipsdienol (**97**) as racemates.¹¹⁹ A number of other syntheses also involve organometallic reactions. The straightforward Grignard reaction of the butadienylmagnesium chloride (**101**, R = MgCl) on 4-methyl-1-pentene epoxide gives a 72% yield of ipsenol (**96**).¹²⁰ Similarly straightforward is the reaction of the bromoisoprene (**101**, R = CH₂Br) with 3-methyl-2-butenal (dimethylacrolein or senecia aldehyde, **102**) and zinc,¹²¹ although the bromo compound is not available at a low price. Another functionalized isoprene used in a similar way for making the ipsenol series is the trimethylsilyl derivative (**101**, R = Me₃SiCH₂), made by the reaction of the Grignard reagent from chloromethyltrimethylsilane and 2-chlorobutadiene. In the presence of a Lewis acid (AlCl₃ or TiCl₄), this silane will react with 3-methylbutanal to give (±)-ipsenol (**96**), or with the acid chloride of 3-methyl-2-butenic acid (**55**) to give the ketone **103** corresponding to ipsdienol (**97**) to which it can be reduced by metal hydrides. Alternatively, the reagent **101** (R = Me₃SiCH₂), can react with 3-methylbutyryl chloride to give the ketone **104** corresponding to ipsenol (**96**), into which it is converted with dibutylaluminum hydride.¹²² A similar reaction has been used to prepare the tagetenones (see below). The ketone **103** has also been prepared by Garbers and Scott by treatment of the anhydride of senecioic acid (**55**) and isopentenyl acetate (the acetate of alcohol **53**) with boron trifluoride in dichloromethane. The major product of the mixture of double bond isomers thus obtained has an *exo*-methylene group **105**, and pyrolysis of this gives mainly **104**, together with a small amount of cyclized (menthane) material.¹²³

Katzenellenbogen and Lenox have shown that ipsenol can be obtained by treatment of 3-methylbutanal and the mesitoate of alcohol **106** with zinc in tetrahydrofuran.¹²⁴



Methylenecyclobutane can be lithiated with butyllithium in tetramethylethylenediamine, and the anion reacts with 3-methylbutanal to give the cyclobutene alcohol **107** together with **108**. Pyrolysis of **107** at 150° yields **96**.¹²⁵ Wilson has recently improved this method by using the trimethylsilane obtained from the methylenecyclobutenyl anion. With 3-methylbutanal and titanium tetrachloride, **107** is obtained without contamination by **108**.¹²⁶ However, the price of methylenecyclobutane at present places these syntheses out of economic feasibility. Care must be taken in any method employing pyrolysis in the last step, since at high temperatures, ipsenol (**96**) undergoes fission to isoprene and methylbutanal, as Haslouin and Rouessac found in the last step of their somewhat lengthy synthesis from itaconic anhydride (Scheme 2).¹²⁷ Ipsdienol is also unstable to temperatures above 100°, when it is converted into the allylically rearranged isomer **98**.¹²¹



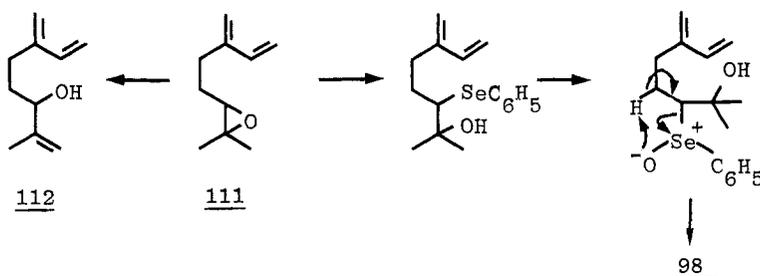
a) NaBH_4 ; b) Bu_2AlH ; c) $i\text{-BuMgBr}$

Perhaps the most straightforward Grignard synthesis of all is the reaction of an isobutyl (C_4) unit on 3-methylene-4-pental (109). The problem here is the preparation of the aldehyde, but, based on the Cope reaction of 1,2,6-heptatriene,¹²⁸ Skattebøl showed that the vinyl ether (**110**) of 2,3-butadien-1-ol undergoes a Claisen reaction to yield **109**,¹²⁹ **110** being available in two steps from 2-butyne-1,4-diol.¹³⁰ This reaction has been carried out again with

minor variations (and without acknowledgment of Skattebøl) by Bertrand and Viala.¹³¹ Clearly **96** and **97** may be directly prepared from **109**.

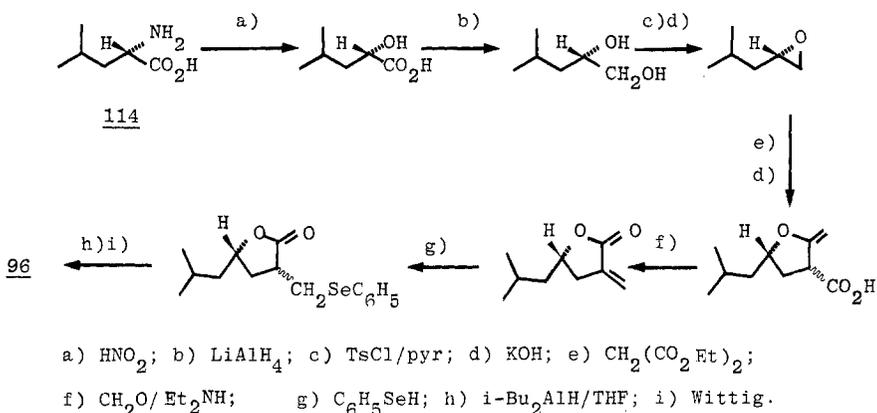
Three methods are available for the oxidation of myrcene (**6**) that lead to the ipsenol group of alcohols. Myrcene epoxide (**111**) is generally opened in the base-catalyzed reaction with attack on the proton of the methyl group (leading to **112**),^{132, 133} but Sharpless has developed a method consisting in the addition of diphenyl diselenide to **111**, followed by sodium borohydride and hydrogen peroxide (Scheme 3).¹³³ Alternatively, photooxygenation of myrcene (**6**) yields, after reduction of the hydroperoxides, two alcohols **112** and **98**; **112** is, however, the major product, and is used as an intermediate in the synthesis of certain furanoid monoterpenes (see below).¹³⁴ Mori has converted the alcohol **98** into the allylically rearranged, more valuable pheromone **97** by treatment of the two



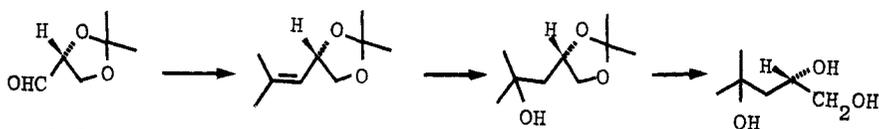

corresponding chlorides (obtained by the action of thionyl chloride on **98** with silver oxide in acetic acid). The proportion, however, was 3:1 in favor of the acetate of **98**, and the alcohols obtained after metal hydride reduction had to be separated by reacetylation, only the secondary alcohol **98** reacting with acetic anhydride in pyridine.¹³⁵ Myrcene (**6**) also adds benzene sulfonyl chloride specifically to the isopropylidene terminus, and the product **113** has been converted to ipsdienol (**97**) in 25% yield.¹³⁶

Although Skattebøl induced some optical asymmetry into his synthesis by using an equimolar amount of (2*S*, 3*S*)-(+)-*N,N,N',N'*-tetramethyl-1,4-diamino-2,3-dimethoxybutane during the Grignard step,¹²⁹ the first synthesis of (-)-ipsenol was carried out starting from L-(+)-leucine (**114**) by Mori (Scheme 4).¹³⁷ This was followed by a synthesis, similar in the later stages, of (+)-ipsdienol from **115** (Scheme 5). While these syntheses were very valuable for confirming the absolute configurations of the molecules, it cannot be pretended that they are applicable for large-scale preparation. More likely from the latter aspect, is the preparation (although not a synthesis really, since it starts ultimately from pinene) of both isomers of ipsdienol (**97**) by Ohloff and Giersch from (+)- and (-)-verbenone (**116**).¹³⁸ Deconjugation of the double bond with sodium

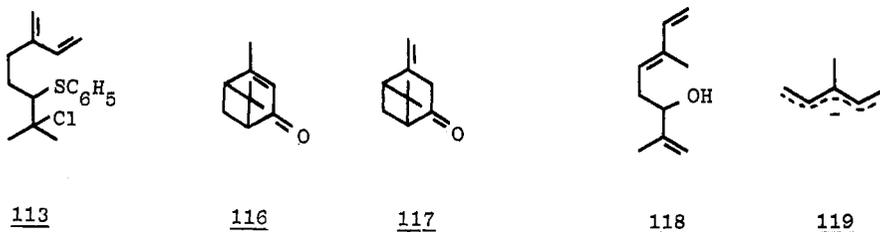

borohydride and quenching with boric acid¹³⁹ gave the ketones **117**, which were reduced to the corresponding alcohols; after flash pyrolysis, these yielded the ipsdienols (**98**). Each ketone **117** gave two alcohols (*cis* and *trans*), and each of the optically active ipsdienols was thus available from an optically active verbenone (**116**), thus providing a double proof of configuration.¹³⁸

2,6-Dimethyl-1,5,7-octatrien-3-ol (**118**)

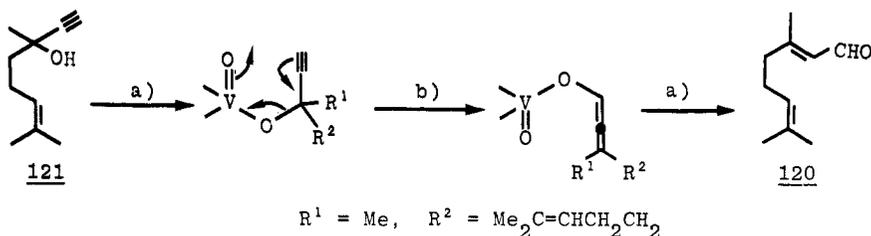
This alcohol was isolated from *Ledum palustre* without precision of the stereochemistry,¹¹⁷ although the published data would seem to fit (*E*) stereochemistry better. The alcohol was synthesized by Wilson et al. by treating the anion of 3-methylpentadiene (**119**), which has been shown by ¹³C NMR spectrometry to exist almost exclusively in the W-conformation,¹⁴⁰ with methylacrolein, yielding 65% of **118**. It would be desirable to clear up the double-bond geometry.



C. Aldehydes and Ketones

Citral (120)

The conversion of dehydrolinalool (121) to citral (120) is an important commercial process (Vol. 2 p. 28), and is now carried out using vanadium catalysts,¹⁴¹ improvements being achieved with catalysts incorporating silicon,¹⁴² a particularly effective one and easy to handle in air, being a polymer formed from sodium orthovanadate and diphenyldichlorosilane.¹⁴³ The mechanism of the reaction is believed to be as shown in Scheme 6.^{144, 145}

Both prenol (122) and 3-methyl-2-butenal (102) are available from the reaction between isobutylene and formaldehyde (leading initially to 53). Their condensation under various conditions, usually in presence of acid,^{146, 147} leads directly to citral, as does the condensation of the acetal diacetate of dimethylacrolein and prenol.¹⁴⁸ The most important industrial preparation of citral (120), however, is probably by dehydrogenation of geraniol (36), usually over copper catalysts.¹⁴⁹

On a less industrial level, linalool (11) can be converted to citral (120) by forming the thiocarbamate 123 using butyllithium followed by thiocarbamyl chloride. Mercuric chloride and calcium carbonate in tetrahydrofuran then give citral in 65% yield by this route, with a majority of the (*E*)-isomer.¹⁵⁰ Takabe's geranylamines¹⁵ undergo conjugation of the double bonds (to 124) with powerful bases (NaH, KNH₂, etc. in ethylenediamine), and in the presence of acid, the latter are hydrolyzed to dihydrocitral (125).¹⁵¹

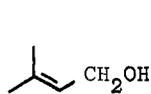
Addition of a one-carbon unit to the epoxide 126 can be carried out using the anion of dithiane. This leads to the dithiane 127, from which citral is readily obtained. The compound 127 was actually made to synthesize pyrans (see below).¹⁵²

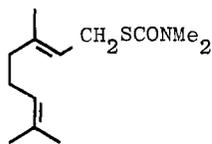
This compound occurs as its 7-hydroxycoumarin ether 128 in *Capnophyllum peregrinum*, and has been synthesized by oxidizing the tetrahydropyranyl ether

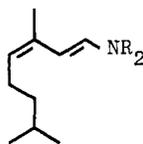
of linalool (11) with selenium dioxide, and effecting the allyl rearrangement on the product with phosphorus tribromide. The resulting bromide 129 is then readily etherified with 7-hydroxycoumarin.¹⁵³



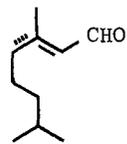

Dihydrotagetone (130), Tagetones (131), Ocimenones (132), and Related Compounds

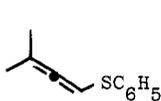
Apart from the isolation from numerous *Tagetes* sp.¹¹³ (+)-dihydrotagetone (130) constitutes 97% of the essential oil of *Phebalium glandulosum*,¹⁵⁴ an Australian Rutaceae, in which it occurs with high optical purity, compared with

that reported from the *Tagetes* sp. This question of optical purity was examined in the course of a synthesis from (+)-3-methylcyclopentanone (133). Irradiation of this gives 20% of 3-methyl-4-pentalenol (134) with some racemization, from which (+)-dihydrotagetone (130) was obtained in 83% optical purity by Grignard reaction and oxidation,¹⁵⁵ about the same as the optical purity of the Australian natural product.

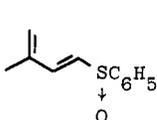
(±)-Dihydrotagetone has also been made by a Carroll reaction of ethyl 3-oxo-5-methylhexanoate (135) and 2-butenol.¹⁵⁶ Another method involves treatment of the trimethylsilyl ester of 3-methylbutyric acid with lithium diisopropylamide, a proton is abstracted, and the resulting lithium derivative reacts with the mixed anhydride 136 made from 3-methyl-4-pentenoic acid. The resulting acid 137 is very readily decarboxylated on heating, giving 66% of racemic dihydrotagetone (130).¹⁵⁷

Both the (*Z*)- and (*E*)-tagetones (131) and ocimenones (=tagetones, 132) are naturally occurring. A recent synthesis of the former is that of S. Julia, which is actually a C₅ + C₅ type.¹⁵⁸ Starting from 3-chloro-3-methylbutyne (138), addition of benzenethiol under phase-transfer conditions gives the allenic sulfide 139, readily isomerized to the thioenol ether, peracid oxidation of which yields the corresponding sulfoxide 140. The latter was allowed to react with the protected cyanohydrin anion (141)¹⁵⁹ derived from 3-methylbutanal, and the resulting derivative 142 yields a mixture of (*Z*)- and (*E*)-tagetones (131) after 1 hour in contact with sodium hydroxide. Shorter periods remove the ketone protecting groups, but not the phenylsulfoxide.¹⁵⁸

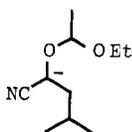
In 1971 de Villiers et al. showed that isoprene and the chloride of seneciolic acid (55) react in the presence of antimony pentachloride, when a mixture of (*Z*)- and (*E*)-ocimenones (132) is obtained.¹⁶⁰ When the reaction was carried out with stannic chloride at -78°, Adams et al. isolated the intermediate chloro-ketone 143, and they also synthesized the two tagetones (131) by substituting the acid chloride of 3-methylbutyric acid for that of seneciolic acid.¹⁶¹ The latter work is important also for the synthesis of filifolone (144) (see below) from ocimenone. Indeed, the relationship between chrysanthenone (145), filifolone (144), and ocimenone (132) is well known, since it has been shown in 1958 that 132 is obtained from chrysanthenone (145) by the action of water at 150°.¹⁶²



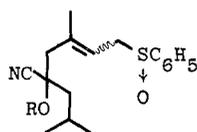

Another $C_5 + C_5$ synthesis arose from the intermediate **105** of Garbers and Scott's synthesis of ipsdienol. When this intermediate acetate was treated first with triethylamine in tetrahydrofuran, then with strong base, the main products were the ocimenes (**132**).¹²³

A $C_6 + C_4$ route consists in the addition of methyl vinyl ketone to the anion of mesityl oxide (prepared with lithium diisopropylamide in tetrahydrofuran at -78°). The resulting hydroxyocimene (**146**) can be dehydrated with acid to a mixture of the ocimenes.¹⁶³ Tagetone (**131**) was made by the same route but starting from 4-methyl-2-pentanone instead of mesityl oxide.¹⁶³ Vig et al. have also prepared the tagetonol (**147**) from 4-methyl-2-pentanone by a somewhat longer route.¹⁶⁴ This tagetonol (the (+)-enantiomer) is a constituent of *Cinnamomum camphora*.¹⁶⁵

5. SUBSTANCES RELATED TO CHRYSANTHEMIC ACID

The relationship between natural *trans*-chrysanthemic acid (148 R = CO₂H) and the santolinyl, artemisyl, and lavandulyl skeletons was described in Vol. 2, p. 34, and the biogenetic implications have been reviewed by Epstein and Poulter¹⁶⁶ (see also the first comment that the lavandulyl skeleton does not necessarily have to arise after a chrysanthemyl precursor, while the other two must pass through chrysanthemyl¹⁶⁷). The solvolysis of the chrysanthemyl carbenium ion leads mainly to artemisia alcohol (149) or its allyl isomer yomogi alcohol (150), depending on the conditions, with only very little of the substances derived from the santolina skeleton.¹⁶⁸ Dihydrochrysanthemyl alcohol (151) can, however, be converted to a dihydrosantolinyl alcohol (152),¹⁶⁹ a conversion that established the relationship of the absolute configuration between chrysanthemic acid (148) and santolina alcohol (153), isolated from *Ormenis multicaulis*.¹⁷⁰ Other conversions of chrysanthemyl derivatives to lavandulyl¹⁷¹ and santolinyl¹⁷² compounds are published, but most of these cannot really be classed as "syntheses," with the exception of a recent synthesis of natural (*S*)-lyratol (154, R = H) from (-)-148 (R = CO₂H) (see below).

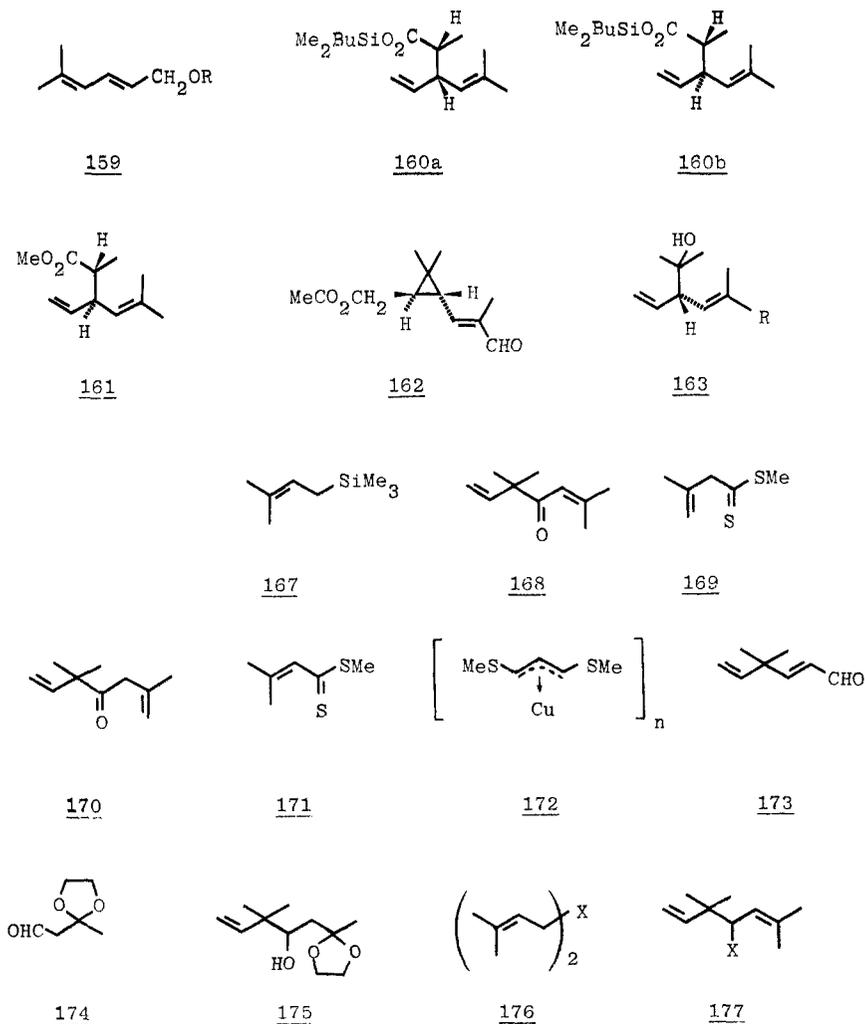
A. The Santolinyl Skeleton

New natural products in this group have been isolated from sagebrush, *Artemisia tridentata*, methyl santoninate (155)¹⁷³ and the epoxide 156, in which the (3*R*) chirality is contrary to that expected if (1*R*, 3*R*)-chrysanthemyl pyrophosphate (151-pyrophosphate) is precursor, although from another location a diastereoisomeric mixture was isolated.¹⁷⁴ Four stereoisomers of the lactone (santolinolides, 157) have also been found in *A. tridentata*.¹⁷⁵ The epoxide 156 is converted by formic acid in 15 minutes at room temperature to the ether arthole* (158), also a constituent of *Artemisia tridentata*.¹⁷⁶ (Only one of the epoxides 156 gives arthole with Lewis acids; the other diastereoisomer rearranges to the corresponding aldehyde.) "Achillene," isolated from *Achillea filipendulina*,⁴¹ (see comments, p. 457) is the same as santolinatriene (27). The full paper of

*The history of this compound is confused. It seems to have been first isolated in 1973,¹⁷⁷ and again isolated, with an incorrect structure assignment, in 1977,¹⁷⁸ although the correct structure was published (with the name arthole and a mass spectrum, but no other commentary) in 1976¹⁷⁹ and appears in *Chemical Abstracts* under this name and with the correct structure in 1976. In 1977 the same group that had used the name arthole published the reasoning that led to the correct structure 158, but proposing the name "artemesole," without even referring to their earlier name.¹⁷⁶ Meanwhile, Banthorpe and Christon had synthesized one of the earlier incorrect structures, and supported the structure 158.¹⁸⁰ It would be preferable to keep the original name, arthole, particularly as this has penetrated to sciences beyond the strictly chemical context.¹⁸¹

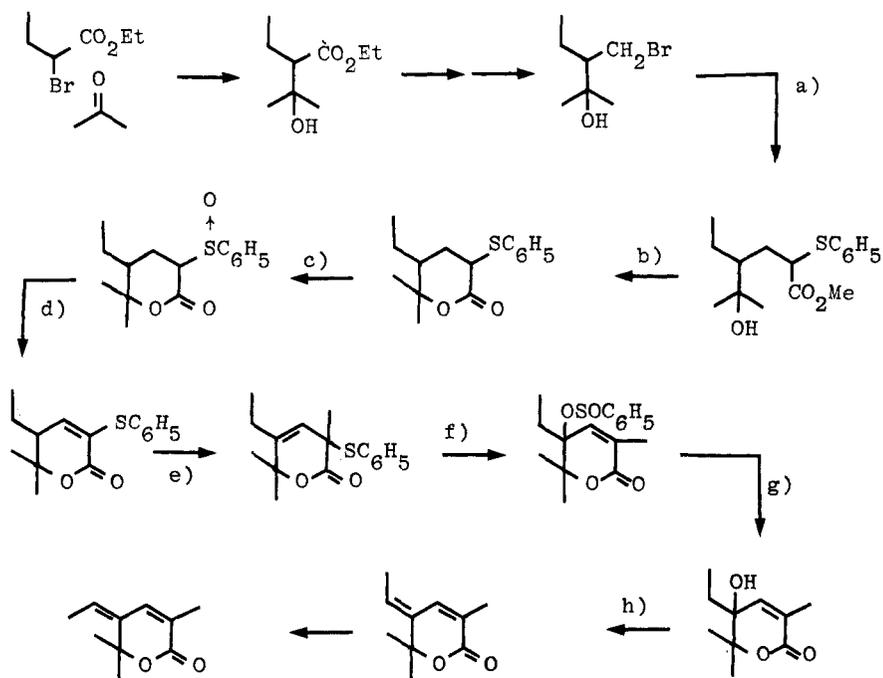
syntheses in the artemisyl-santolinyll group described in Vol. 2, p. 38 has appeared.¹⁸²

Methyl santolinate has been synthesized from 5-methyl-2,4-hexadienol (**159**, R = H) readily available from senecialdehyde (**102**). The propionate **159**, (R = COEt) was converted to its lithium enolate with lithium isopropylcyclohexylamide, then to the enol silyl ether **159**, (R = MeCH=C-OSiMe₂-*t*-Bu). The latter rearranged after 3 hours at 65° to a mixture of the silyl esters **160a** and **160b**, which were converted by hydrolysis with acetic acid and methylation with diazomethane to the natural sagebrush ester **161** and its isomer **161**.¹⁸³



Sucrow's original synthesis of lyratol (154, R = H, Vol. 2, p. 39) produced the racemate, now Gaughan and Poulter have synthesized the natural (*S*)-isomer from chrysanthemic acid. The latter was reduced to the (1*R*, 3*R*)-alcohol 148 (R = CH₂OH), and the acetate was oxidized with selenium dioxide to 162. Treatment of the mesylate corresponding to the acetate 162 with sodium bicarbonate in aqueous acetone yielded the ring-opened unstable hydroxy-aldehyde 163 (R = CHO), which was immediately reduced with sodium borohydride to the diol 163 (R = CH₂OH). Dehydration of the acetate 163, (R = CH₂OAc) with thionyl chloride in pyridine gave lyratyl acetate (154, R = Ac).¹⁸⁴

Some years ago, a lactone 164 with the santoliny skeleton was isolated from *Chrysanthemum flosculosum*,¹⁸⁵ and this has now been synthesized (Scheme 7).¹⁸⁶

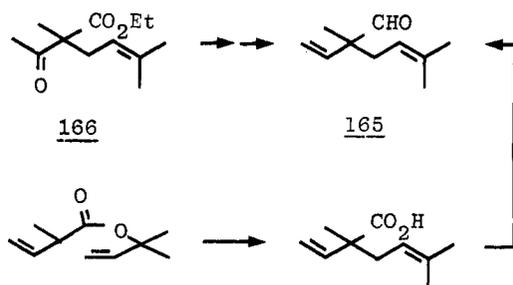

B. The Artemisyl Skeleton

The aldehyde **165** has been isolated from verbena¹⁸⁷ and neroli¹⁸⁸ oils. This aldehyde was synthesized by Corbier and Teisseire¹⁸⁸ by a modification of a reaction described in Vol. 2, p. 44, but before being identified as a natural product, it had already been prepared by Re and Schinz.^{188a} Condensation of prenyl bromide (**13**) with methylacetoacetic ester gave a product **166**, which already had the desired skeleton, and conventional steps led to the aldehyde **165**.

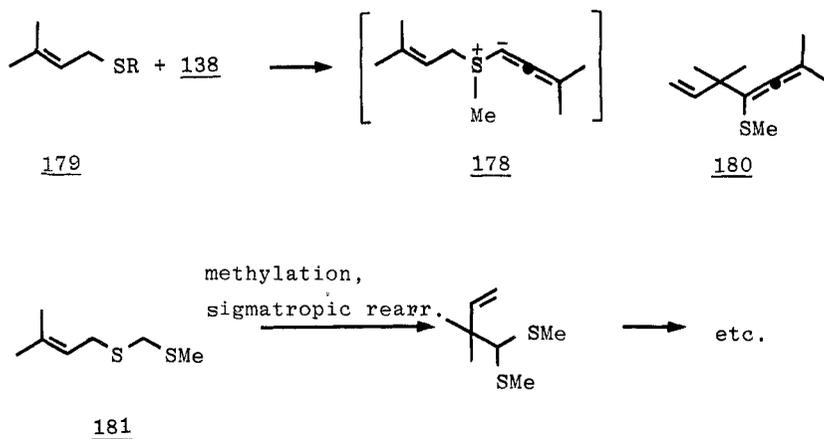


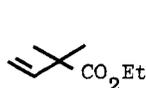
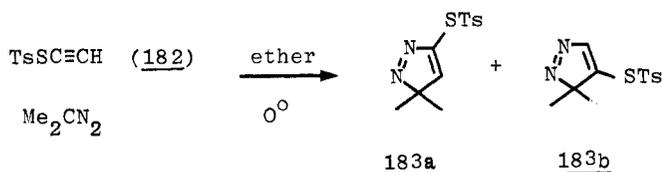
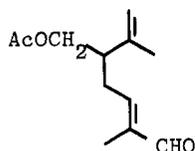
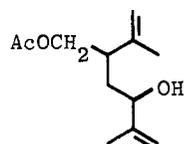
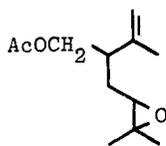
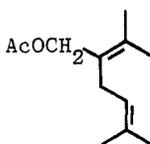
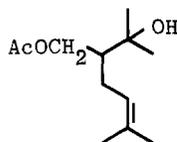
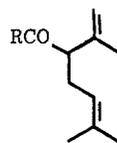
The most straightforward route to the skeleton is by coupling of two prenyl units (Vol. 2, p. 42). The Grignard reagent from prenyl bromide (**13**) generally reacts in the allylically rearranged form (Vol. 2; see also Ref. 189), but several improvements have been suggested to effect this reaction. The Grignard reagent can be converted with trimethylsilyl chloride to the silane **167**, and the latter reacts with senecioic acid (**55**) chloride to yield artemisia ketone (**168**).¹⁹⁰ The prenyl Grignard reagent also reacts with the thioester **169** to yield the dithioketal of isoartemisia ketone (**170**), into which it is converted by silver nitrate solution and cadmium carbonate. Base treatment of isoartemisia ketone yields the conjugated ketone **168**, which can be obtained by the same route (though in poorer yield) from the isomeric thioester **171**.¹⁹¹ Prenyl bromide and senecia aldehyde (**102**) give a 91% yield of artemisia alcohol (**149**) when passed over a heated zinc column,¹⁹² an alternative way of carrying out this coupling is using chromous chloride.¹⁹³ It should not be forgotten, however, that artemisia alcohol (**149**, like yomogi alcohol, **150**) is not a good intermediate for the ketone because the oxidation proceeds so badly. To obtain yomogi alcohol (**150**) from prenyl bromide (**13**) via an organometallic route is a little longer; addition to a three-carbon unit (in the form of the copper complex **172**) leads to the aldehyde **173**,¹⁹⁴ or addition (using chromous chloride) to the C₄ unit **174** leads to the protected ketone **175**, which can be dehydrated and deacetalized with polyphosphoric acid. From this product¹⁹³ or the aldehyde **173**, yomogi alcohol is obtainable by Grignard reaction (two stages in the case of **173**).

New developments in the [2,3] sigmatropic approach to the skeleton (Vol. 2, p. 41) are the use of a chiral base to effect the rearrangement of the sulfonium salt **176** ($X = \overset{\ominus}{S}Me$) to the thioether (**177**, $X = SMe$), when only 12% optical yield was achieved,¹⁹⁵ and the rearrangement of the ammonium salt **176** ($X = \overset{\oplus}{N}Me_2$) to the amine **177** ($X = NMe_2$).¹⁹⁶ A series of papers by S. Julia's group has shown how a similar reaction may be carried out by forming what is probably the allenic zwitterion **178** from prenyl thioether (**179**, $R = Me$) and 3-chloro-3-methylbutyne (**138**). When **138** is employed as its lithium salt, the allene **180** is the product isolated, which can be converted into artemisia ketone (**168**) by hydrolysis ($HgCl_2$). Alternatively use of sodium hydroxide in a protonating solvent leads to the thioether **177** ($X = SMe$).¹⁹⁷ A route involving the use of the formaldehyde dithioacetal (**181**) has also been developed.¹⁹⁸ (These papers should be compared with Raphael's allenic carbene synthesis of chrysanthemyl alcohol described below.)

An original synthetic route by Franck-Neumann and Lohmann consists in building a prenyl group into a pyrazole by the reaction between the tosylthioacetylene (**182**) and dimethyldiazomethane. The product is a 41:1 mixture of two pyrazoles (**183a** and **183b**), irradiation of which in the presence of the prenyl thioether (**179**, $R = Et$) gave a mixture of thioacetals from which artemisia ketone (**168**) could be obtained by the action of silver nitrate. The mechanism conceivably involves reaction of a vinyl carbene, $Me_2C=CC\dot{-}STs$, with the prenyl thioether.¹⁹⁹

Using the ester **184** (obtained by dehydration of the alcohol corresponding to ethyl dimethylacetoacetate), Vig et al. prepared the corresponding β -ketoester, which they converted to artemisia ketone (**168**) by means of a Grignard reaction and dehydration.²⁰⁰

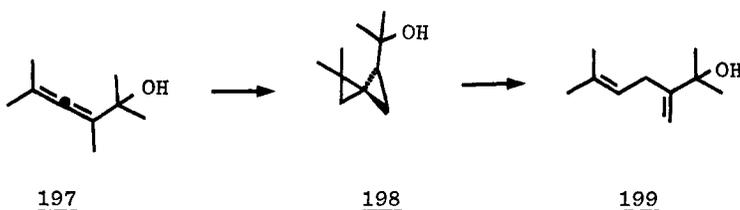
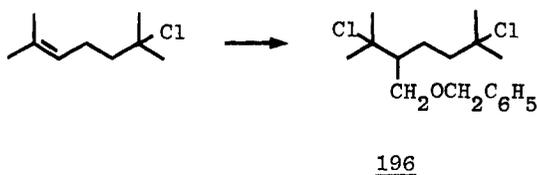
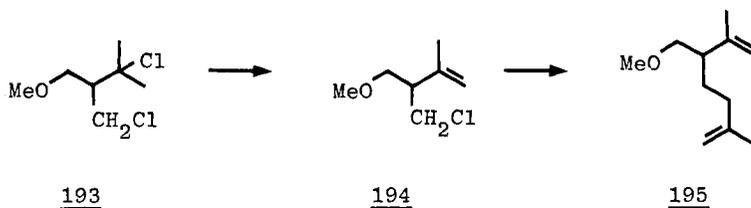
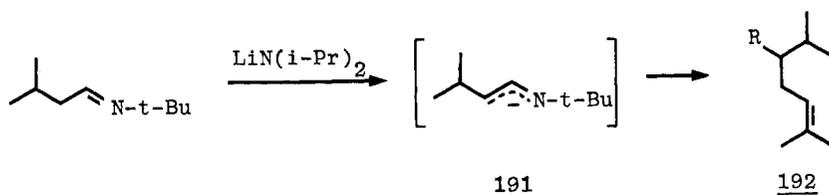
If one is fortunate enough to have a supply of 3,3-dimethylpent-1-en-4-yne,²⁰¹ it is a simple matter to convert it to yomogi alcohol (**150**) by addition of acetone to the lithium derivative, followed by partial reduction (lithium aluminum hydride) of the triple bond.²⁰²

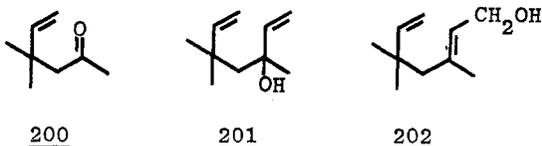
C. The Lavandulyl Skeleton

The aldehyde **185** has been identified in lavandin,²⁰³ but not yet synthesized. Photooxygenation of lavandulyl acetate (**57**, R = OAc) leads to a hydroxyacetate (**186**), which occurs in lavender,²⁰⁴ together with a number of related compounds.²⁰⁵ Epoxylavandulyl acetate (**187**) occurs only in lavandin, not lavender.²⁰⁵

The direct coupling of two molecules of dimethylallyl acetate (=prenyl acetate, 122-acetate) to give lavandulyl acetate (**57**, R = OAc) has been in the literature for some time (see, e.g., Ref. 206), together with related reactions. Recently M. Julia et al. have studied the reaction of dimethylallyl acetate and lithium perchlorate systematically, obtaining good yields of lavandulyl acetate (**57**, R = OAc) and isolavandulyl acetate (**188**)²⁰⁷, and have drawn attention to the

synthesis of lavandulyl acetate using dimethylallyl acetate and isoprene,²⁰⁸ where they feel that the reaction does not depend on the presence of the latter. Julia et al. were also able to isolate a hydrated lavandulyl acetate **189** from the reaction between dimethylallyl acetate and 3-methyl-1-buten-3-ol in the presence of trifluoroacetic acid.²⁰⁷ The enolates of the dialkylamides of senecioic acid (**55**) react with prenyl halides to yield the amides of lavandulic acid [**190**, R = N(alk)₂], which can be readily converted to lavandulol (**57**, R = OH).²⁰⁹ This reaction is somewhat reminiscent of the addition of prenyl halides to the carbanion **191** from the *t*-butylimine of 3-methylbutanal, leading to the imine **192** (R = C=N-*t*-Bu) of dihydrolavandulal (**192**, R = CHO).²¹⁰ Takabe et al. have attempted to carry out Lewis acid-catalyzed condensations of thio analogs of dimethylallyl acetate, but the yields of thiolavandulyl and thioisolvandulyl acetates were low, the main product being the sulfide **176**. (X = S).²¹¹





Addition of lithium dimethylcuprate to the allenic ester, ethyl 2,3-butadienoate gives the lithium enolate of ethyl 3-methyl-3-butenoate, which, on quenching with prenyl bromide in dimethoxyethane at -30° , gives the ethyl ester of lavandulic acid (**190**, $R = OEt$), but the yields reported are not above 50%.²¹²

A $C_5 + C_1 + C_4$ route has been investigated. It consists in the addition of chloromethyl methyl ether to 3-chloro-3-methyl-1-butene (this is the compound first obtained by HCl addition to isoprene, which rearranges to prenyl chloride during workup unless precautions are taken) yielding the dichloride **193**. Loss of HCl leaves a primary chloride **194** from which a Wurtz reaction using isobutylene chloride gives the methyl ether **195**.²¹³

The Prins approach ($C_9 + C_1$, Vol. 2, p. 46) has been improved,²¹⁴ and another $C_9 + C_1$ route, starting from 2-chloro-2,6-dimethyl-5-heptene has been used by Garbers et al. Addition of benzyl chloromethyl ether yields the dichloro-ether **196**, the benzyl group being replaceable by acetate with acetic anhydride and boron trifluoride etherate.²¹⁵ Very different is the $C_9 + C_1$ synthesis of Maurin and Bertrand. Addition of carbene to the allene **197** gave the spiro-alcohol **198**, acid treatment of which led to the alcohol **199**. This was converted to the known lavandulyl bromide (**57**, $R = Br$) with phosphorus tribromide, from which isolavandulyl acetate (**188**) is readily obtained.²¹⁶

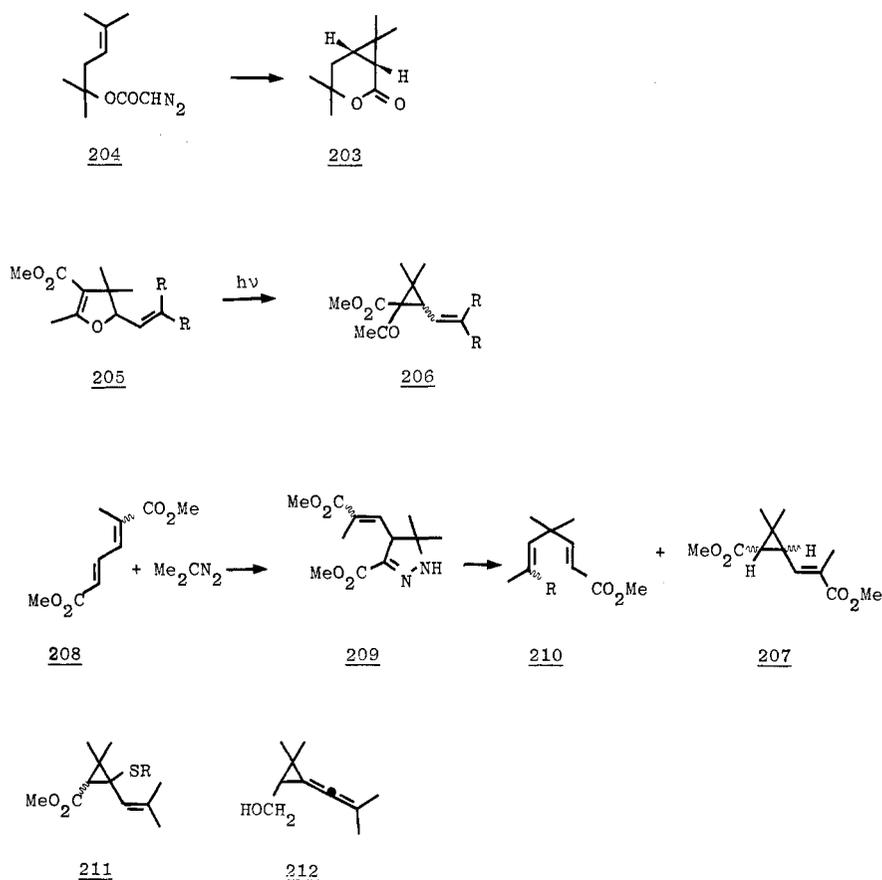
One of the by-products from the methylheptenone synthesis starting from acetone and acetylene (Vol. 2, p. 5-6) is 4,4-dimethyl-5-hexen-2-one (**200**). This can be treated with vinylmagnesium bromide to yield the divinyl alcohol **201**, also obtainable from mesityl oxide by a copper-catalyzed double Grignard reaction. Rearrangement of **201** to the primary alcohol **202** or its acetate is straightforward, and both **202** and its acetate undergo a thermal Cope reaction to give, respectively, lavandulol (**57**, $R = OH$) or its acetate.²¹⁷

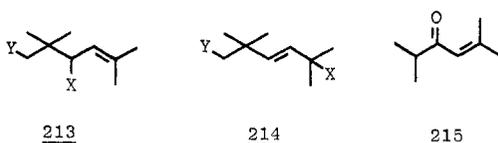
D. Chrysanthemic Acid and Related Substances

It is not in the scope of this chapter to list the vast literature concerning the synthesis of putative insecticidal homologs and analogs of chrysanthemic acid. The original synthesis of chrysanthemic acid²¹⁸ by reaction of diazoacetates on 2,5-dimethyl-2,4-hexadiene has been improved by using asymmetric copper complexes as catalysts, when optically active chrysanthemates are obtained.²¹⁹ A related synthesis of chrysanthemolactone (**203**) from **204** in 34% optical yield using a chiral copper complex has been published.²²⁰

Replacement of Cu catalysis by Rh(II) is reported to give a higher *cis:trans* ratio of cyclopropane carboxylic esters.²²¹ Poulter et al. have prepared a homolog (without the *gem*-dimethyl group on the cyclopropane ring) by the original diazoacetate route, but resolving the racemic acid with quinine, this lower acid being proposed as an intermediate in the biosynthesis.²²² Another method for functionalizing 2,5-dimethyl-2,4-hexadiene is by treatment with methyl acetoacetate in the presence of manganese(III) acetate and acetic anhydride. The product **205** (R = Me) yields the cyclopropane **206** on irradiation (the reaction works more smoothly when R = Cl), from which methyl chrysanthemates [(±)-**148**, R = CO₂Me] can be obtained (when R = Me) with potassium *t*-butoxide.²²³

The synthesis of Martel and Huynh⁶¹ described in Vol. 2, p. 53 has been adapted for an undergraduate experiment.²²⁴



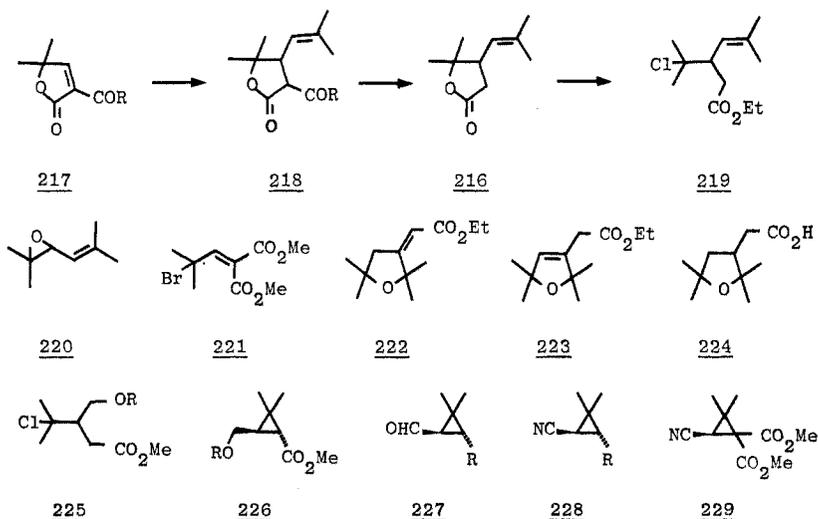


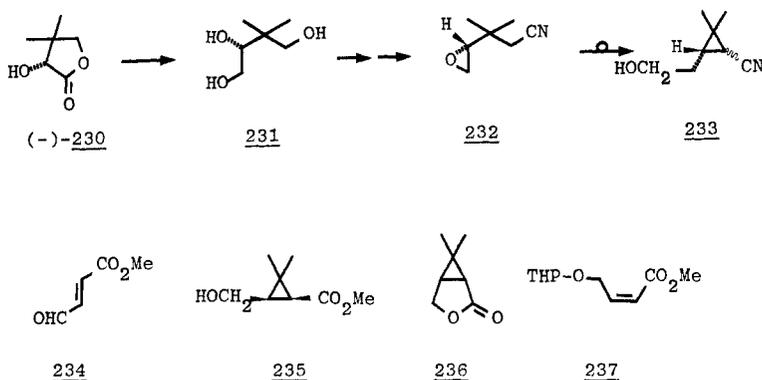
An older synthesis of chrysanthemum dicarboxylic acid methyl ester (=pyrethric acid, **207**) was not described in Vol. 2,²²⁵ perhaps this is not too serious, since Scharf and Mattay have reexamined it, after the necessary starting material, dimethyl 2-methyl-2,4-hexadienedicarboxylate (**208**) became more readily available.²²⁶ Reaction with diazoisopropane gives the pyrazoline **209** (different from the pyrazoline reported earlier²²⁵), thermolysis of which leads mainly to the esters **210** (R = CO₂Me), the chrysanthemyl skeleton forming only 11-17% of the products.²²⁶

It is possible to pass from **210** (R = Me) to chrysanthemic acid by irradiation,^{227, 228} but there are several by-products, and the starting material must be made.²²⁸ The (*E*)-isomer (but not the (*Z*)-isomer) of **210** (R = Me) gives methyl chrysanthemate ((±)-**148**, R = CO₂Me).²²⁷ Despite the relatively modest yield, Franck-Neumann has extended his photochemical synthesis involving the pyrazole **183a** to lead to the thiolated chrysanthemic esters **211**, obtained when **183a** is irradiated in the presence of methyl 3-methyl-2-butenolate (**55**, methyl ester). Raney nickel quantitatively removes the thiol group, and an interesting feature of the synthesis is that the *cis*-chrysanthemate always predominates, whichever isomer of **211** is used.²²⁹ This synthesis probably involves a vinyl-carbene (see above), and carbene addition is also proposed in the synthesis of Raphael et al. of chrysanthemyl alcohol ((±)-**148**, R = CH₂OH) by treatment of chlorobutene (**138**) and prenil (**122**) with potassium *t*-butoxide, when the allene **212** is obtained. This allene can be reduced with sodium in liquid ammonia to *trans*-chrysanthemyl alcohol ((±)-**148**, R = CH₂OH).²³⁰

One approach to the chrysanthemate skeleton discussed in Vol. 2 (p. 52) is by base treatment of compounds such as **213** (where X may be OCOR and Y, CN or CO₂R) and **214** (where X is frequently halogen). Most of these routes are actually attempts to prepare the starting material (i.e., **213** or **214**) more easily, and can be illustrated by the synthesis of Ficini and d'Angelo. They reduced the ketone **215** (made by the Lewis acid-catalyzed addition of isobutyryl chloride to isobutylene then HCl elimination) to the corresponding alcohol, which reacts with ethyl orthoacetate in the presence of acid to give 70% yield of **214** (X = H, Y = CO₂Et). *t*-Butyl phenylperacetate then gives **214** (X = OCOC₆H₅, Y = CO₂Et), which cyclizes under the influence of lithium diisopropylamide to a 1:1 mixture of *cis*- and *trans*-ethyl chrysanthemates.²³¹ Very similar is the synthesis of Kondo et al., except that in order to introduce the function X they treat **214** (X = H, Y = CO₂R) with *N*-bromosuccinimide. Actually, this work was intended

as a synthesis for analogs of chrysanthemates rather than the chrysanthemates themselves.²³² The syntheses passing through pyrocine (216, the pyrolysis product of chrysanthemic acid) also involve a 1,3-elimination by base. For example, Takeda et al. treated the lactone 217 (R = OC₆H₅) with 2-methyl-1-propenylmagnesium bromide in a copper-catalyzed addition, and from the product 218 (R = OC₆H₅), obtained pyrocine (216) by hydrolysis. This was then treated with thionyl chloride and ethanol to give the chloroester 219, from which ethyl *trans*-chrysanthemate ((±)-148, R = CO₂Et) is obtained by treatment with lithium diisopropylamide in hexamethylphosphoramide.²³³ Three other syntheses of pyrocine (216) are relatively straightforward, particularly that of De Vos and Krief. They treated the monoepoxide (220) of 2,5-dimethyl-2,4-hexadiene with diethylmalonate carbanion, obtaining 218 (R = OEt), later steps being as before.²³⁴ From a mixture of isobutanal and dimethyl malonate with *N*-bromosuccinimide, the bromoester 221 can be obtained. Torii et al. prepared the methyl ester 217 (R = OMe) by pyrolysis of 221 (or its chloro analog), following the same path afterwards, although the hydrolysis of 218 (R = OMe) to 216 was carried out by the unusual method of sodium chloride in wet dimethyl sulfoxide at 170°,²³⁵ 2,2,5,5-Tetramethyltetrahydrofuran-3-one has also been converted into pyrocine (216).²³⁶ The Horner-Wittig reaction yields a mixture of two unsaturated esters 222, 223, reduction and hydrolysis of which lead to the acid 224. Action of boron trifluoride etherate then leads to pyrocine. Alternatively, thionyl chloride gives with the ester of 224 a dichloride (corresponding to 219 + HCl), the conversion of which to chrysanthemic acid is known.²³⁶ A related paper deals with the asymmetric hydrogenation of 222 + 223.²³⁷



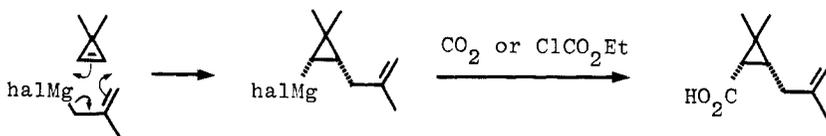


Garbers et al. constructed chloroesters **225**, corresponding to **219** but without the isopropylidene group, by reaction of methyl 4-methyl-3-pentenoate and chloromethyl alkyl ethers in the presence of a Lewis acid. The chloroesters **225** can be cyclized by base, and the product **226** was converted into chrysanthemic acid via the aldehyde **227** ($R = \text{CO}_2\text{Me}$).²³⁸

The ready availability of **221** induced De Vos and Krief to develop a one-pot synthesis of the nitrile **228** ($R = \text{CO}_2\text{H}$) from it using sodium cyanide in dimethyl sulfoxide.²³⁹ The intermediate diester **229** was known to be decarboxylated by sodium cyanide in dimethyl sulfoxide, but the others of this work²⁴⁰ seem to have the wrong configuration for the product **228** ($R = \text{CO}_2\text{H}$). Using borane-dimethyl sulfide, **228** ($R = \text{CO}_2\text{H}$) can be converted to the alcohol **228** ($R = \text{CH}_2\text{OH}$), then oxidized to the aldehyde **228** ($R = \text{CHO}$), from which chrysanthemic nitrile can be obtained by a Wittig reaction.²³⁹ The optically active nitrile **228** ($R = \text{CH}_2\text{OH}$, opposite isomer to that shown) was used to make (+)-*trans*-chrysanthemic acid (+)-(148). The starting material was optically active (-)-hydroxylactone **230**. Lithium aluminum hydride reduction gave the triol **231**, conventional steps then leading to the epoxide **232**, from which the nitriles **233** (position carrying the CH_2OH group defined) were obtained. (+)-Chrysanthemic acid was then made by known steps from **233**.²⁴¹

Sorbic esters can be selectively ozonized, and the aldehyde **234** thus obtained in yields reported to be over 80% reacts with 2.4 equivalents of isopropylidene-triphenylphosphorane to give methyl *trans*-chrysanthemate in over 60% yield. Alternatively, protection of the aldehyde group as an acetal enables preparation of **227** ($R = \text{CO}_2\text{Me}$) acetal, from which both chrysanthemate and pyrethric acid esters are accessible.²⁴² Another series of syntheses involve the *cis*-substituted cyclopropane **235**. This was prepared by reaction of isopropylidenediphenylsulfurane on various substrates: butenolide gives **236**, and **237** the tetrahydropyran ether of **235**. A second reaction of isopropylidenediphenylsulfurane on the aldehyde **239** leads to methyl *cis*-chrysanthemate.²⁴³

The original idea of adding both substituents to dimethylcyclopropene in a one-pot process was carried out by Lehmkuhl and Mehler by adding it to 2-methyl-2-propenylmagnesium bromide (Scheme 8), then carbonating the resulting Grignard compound. The ethyl *cis*-isochrysanthemate thereby obtained can be converted to chrysanthemolactone (203) by acid or to *cis*- or *trans*-chrysanthemates by other known methods.²⁴⁴



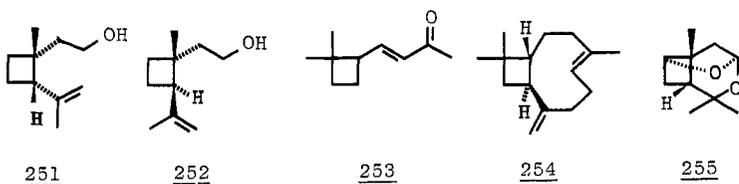
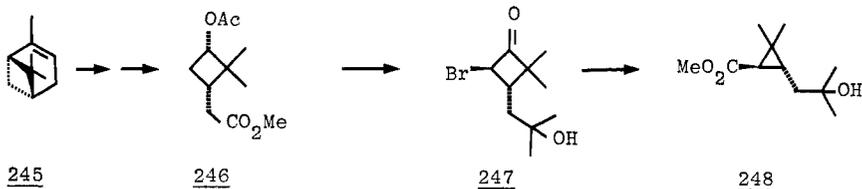
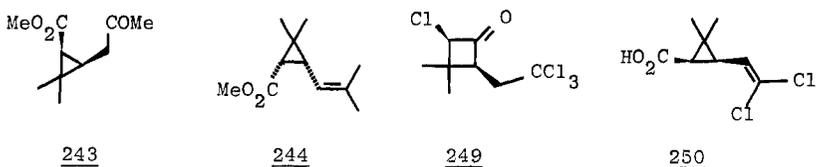
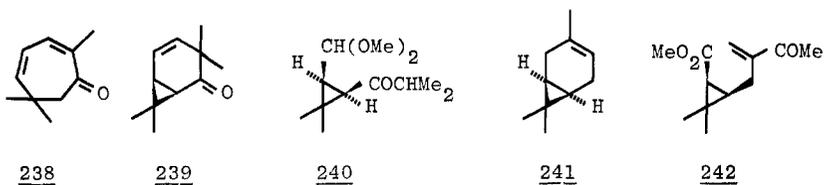
The conversion of other monoterpenes to chrysanthemic acids has also received attention, particularly since this type of synthesis contains a built-in chiral center in most cases. One that does not contain such a center starts from eucarvone (238), methylation of which followed by treatment with osmium tetroxide and sodium chlorate yields the methylcarone (239). Ozonolysis of 239 gives the *cis*-chrysanthemic skeleton in the form of the acetal 240, which can be converted to chrysanthemic acids by conventional techniques.²⁴⁵ Apart from the cost of the steps in this synthesis, eucarvone is usually prepared from compounds having a chiral center (like carvone), and it is unsatisfactory to destroy this when the product is to be a chiral molecule. Improvements to the known methods are available from (+)-3-carene (241) (particularly those of Sukh Dev²⁴⁶ to the method beginning with oxonolysis²⁴⁷), and a new method has been described by Cocker et al. In the course of an investigation on the Prins reaction of (+)-3-carene they prepared 242,²⁴⁸ which was converted in four steps to the ketoester 243, from which methyl (-)-*cis*-chrysanthemate (244) is obtained by Grignard reaction and dehydration.²⁴⁹

Mitřa and Khanra have carried out a synthesis of methyl *trans*-chrysanthemate from α -pinene (245). The first stages (ozonolysis, Baeyer-Villiger reaction and esterification with diazomethane) lead to the ester 246, and after Grignard reaction, oxidation to the cyclobutanone, and bromination, the bromoketone 247 undergoes ring-contraction on treatment with sodium methoxide in dry ether, to 248.²⁵⁰

Some optically active chrysanthemic acid derivatives have been synthesized from a pyranoside.^{250a}

Although it does not lead to a natural chrysanthemic acid, attention is drawn to another Favorskii ring contraction, that of the chlorocyclobutanone 249 (made by a very ingenious and rapid method from acrylic acid), which yields exclusively the *cis*-acid 250 with potassium hydroxide at 90°.²⁵¹

Tritiated *trans*-chrysanthemate has been synthesized from (-)-*cis*-chrysanthemate.²⁵²



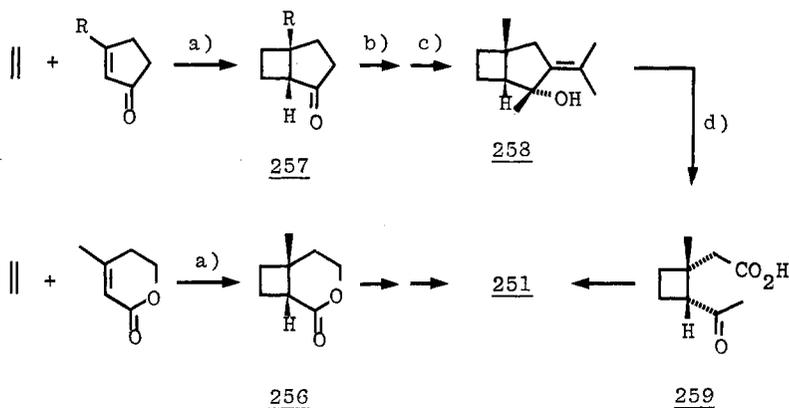
6. CYCLOBUTANE MONOTERPENES

Besides grandisol (**251**; see Vol. 2, p. 58) and its stereoisomer fragranol (**252**, isolated from *Artemisia fragrens*),²⁵³ junionone (**253**) has been isolated from the oil of *Juniperus communis*.²⁵⁴ Although junionone (**253**) has been prepared by degradation of caryophyllene (**254**),²⁵⁴ there is no total synthesis so far recorded. An acetal, lineatin (**255**) has been isolated from the frass of the

Douglas fir beetle, *Trypodendron lineatum*,²⁵⁵ and its synthesis (see below) has confirmed the structure.

Because of the commercial interest in grandisol as part of the sex hormone system of the male boll weevil (*Anthonomus grandis*), considerable effort has been devoted to its synthesis, and reviews have already appeared.²⁵⁶

The original synthesis²⁵⁷ of grandisol (**251**) had as its key step the photochemical addition of ethylene to 4-methyldihydropyranone to yield **256**²⁵⁸, and this is also the principle of a more recent synthesis which used slightly different steps in the later stages.²⁵⁹ Cargill and Wright also used a photoproduct **257** (R = Me) in order to form the cyclobutane (Scheme 9). Grignard reaction on the isopropylidene ketone then gave an alcohol **258**, which was ozonolyzed to **259**. This could then be transformed conventionally to grandisol (**251**).²⁶⁰ The same approach was used by Mori to make both optically active forms of grandisol, except that he had to use an intermediate that would permit resolution. In

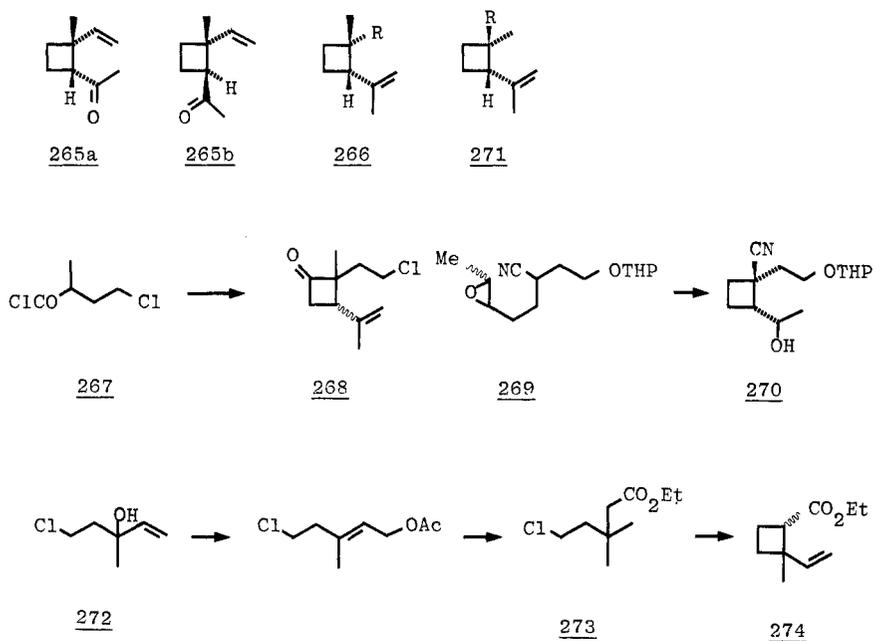


a) $h\nu$; b) acetone-base; c) MeMgI; d) O_3

fact he used the ester (R = CO₂Et), resolving the acids after the photochemical stage and hydrolysis **257** (R = CO₂H).²⁶¹ With optically active **257** (R = CO₂H) he then converted the acids to optically active **257** (R = Me) and followed Cargill and Wright's route to make both (+)-grandisol, the naturally occurring one (**251**) and (-)-grandisol,²⁶¹ which also turned out to be biologically active.²⁶² Mori has also adapted this approach to synthesize lineatin (**255**), obtaining the isomer **260** at the same time (see Scheme 10),²⁶³ which had originally been considered as an alternative structure to **255**.²⁵⁵ Full details have not been included in Scheme 10, but it should be noted that the final steps unfortunately gave poor yields.

trans-isomer **265b** into the other isomer, fragranol (**252**), unknown as a natural product at the time the work was carried out.²⁶⁷ The other route from isoprene involves dimerization on a catalyst of bis(1,5-cyclooctadiene)nickel and tris(2-biphenyl)phosphite, when **266** (R = CH=CH₂) is formed in 12-15% yield, together with many other products, and can be converted to grandisol (**251**) by hydroboration-oxidation.²⁶⁸ Isoprene reacts with the acid chloride **267**



(obtained from 3-methylbutanolide and thionyl chloride) in triethylamine solution in an autoclave to yield the carbon skeleton of grandisol, but it was not found possible to convert the product **268** to the alcohol.²⁶⁹

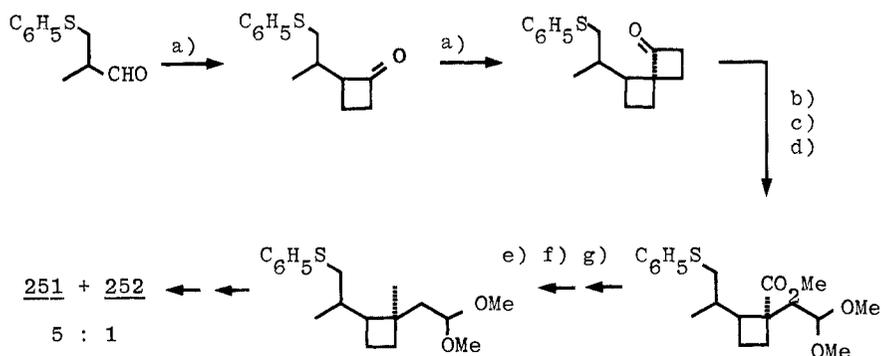
If four- or five-membered rings are alternative cyclization products of epoxy-nitriles, Stork has found that the four-membered ring is always preferred, and synthesized grandisol from **269** by this principle. The cyclobutane thus obtained **270** (from **269** and hexamethyldisilazane) was converted to grandisol by conventional means.²⁷⁰

Cyclobutanecarboxylic acid is commercially available (although expensive), and, by a somewhat tedious route, involving bromination-dehydrobromination to cyclobutenecarboxylic acid; this is then alkylated, first with isopropenyl-magnesium bromide in a copper-catalyzed reaction at -70° , then with methyl iodide and lithium diisopropylamide to yield a mixture of the esters **266** and **271** (R = CO₂Me). The (desired) acid **266** (R = CO₂H) was converted via the

diazoketone to the ester **266** ($R = \text{CH}_2\text{CO}_2\text{Me}$); the acid chloride **266** ($R = \text{COCl}$) cyclized to a lactone. From **266** ($R = \text{CH}_2\text{CO}_2\text{Me}$), grandisol (**251**) is easily prepared.²⁷¹

1-Chloro-3-butanone, a methyl vinyl ketone equivalent, is readily obtainable, and reacts with vinylmagnesium chloride to yield the chloroalcohol **272**. Acetylation proceeds with allyl rearrangement under acid conditions, then hydrolysis and reaction of the alcohol under Claisen conditions with ethyl orthoacetate yields the key intermediate **273**. The latter compound cyclizes to a mixture of diastereomers **274** under basic conditions. The subsequent transformations to grandisol and fragranol are conventional, but still somewhat lengthy. A full paper on this synthesis, particularly the key cyclization step is promised.²⁷²

Trost has used his method of cyclobutanone formation (1-lithiocyclopropyl phenyl sulfide, then *p*-toluenesulfonic acid at reflux) to make a grandisol-fragranol mixture (**251** + **252** = 5:1, Scheme 12).²⁷³



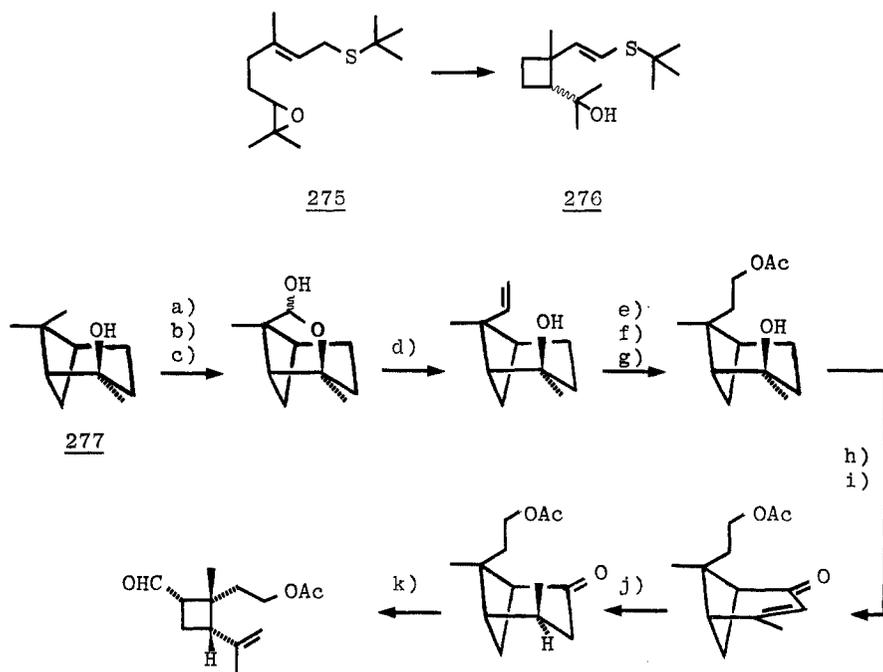
a)  ; b) pyr. perbromide; c) NaOMe; d) AgNO₃; e) LiAlH₄;

Starting from other monoterpenoids is always an attractive means of access to the more difficult ones; undoubtedly the quickest route on paper for the transformation of readily available monoterpenoids into grandisol and fragranol is that of Rautenstrauch, who found that treatment of the *t*-butyl sulfide corresponding to geraniol epoxide (i.e., **275**) with butyllithium in *N,N,N',N'*-tetramethylethylenediamine followed by hydrolysis led to the *t*-butyl sulfides **276**, related to grandisol and fragranol. Unfortunately this idea remained there,

for Rautenstrauch found no method of converting 276 to the desired products.²⁷⁴

 i) CrO₃-pyr-CH₂Cl₂; j) H₂/Pd-C; k) hv.

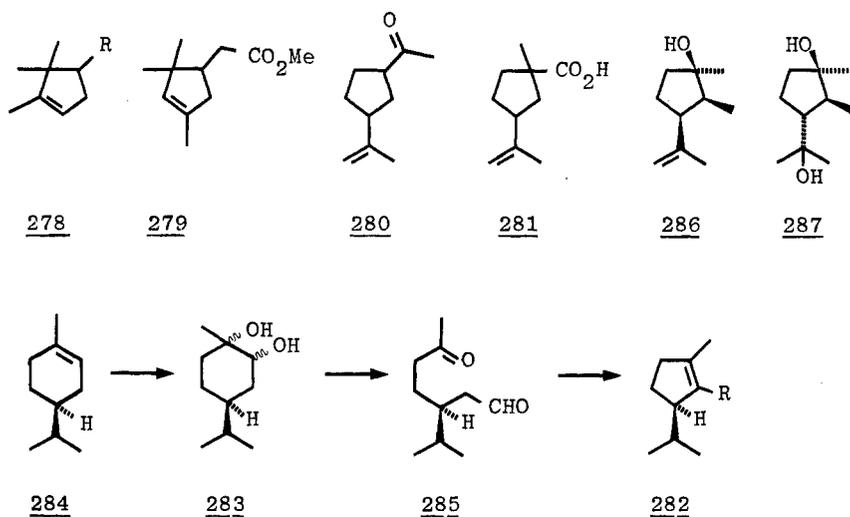

Magnus's synthesis of (+)-grandisol, despite its length, is of great importance, in that it was the first synthesis of the optically active substance from a clearly defined starting material (*trans*-pinan-2-ol, 277, derived from β -pinene). It is shown in Scheme 13,²⁷⁵ and it is noteworthy that Mori's synthesis, described above,^{261,263} arrived at chiral isomers with rotations comparable with the earlier ones of Magnus.

7. CYCLOPENTANE MONOTERPENES

Campholenic derivatives (278, R = CO₂Me, R = CH₂CO₂Me, 279) have been found in *Cistus ladaniferus*²⁷⁶ and *Aden olibanum*,²⁷⁷ but there is no novelty

about the synthesis. There are a number of cyclopentane monoterpenoids occurring as minor components of tobacco, **280**²⁷⁸ and **281**,²⁷⁹ for example, and one, **282** (R = CO₂H),²⁸⁰ that is of somewhat more interest in view of the use of the corresponding aldehyde **282** (R = CHO) in syntheses of higher molecular weight compounds. The synthesis consists in ring-opening the glycol **283** derived from menth-1-ene (the (-)-(*S*)-isomer (**284**) is shown), yielding the ketoaldehyde **285**.²⁸¹ The unsaturated ketoaldehyde (derived similarly from limonene) had been shown earlier²⁸² to cyclize to a ketone with potassium hydroxide; alternatively, using piperidine acetate²⁸³ an unsaturated aldehyde was obtained. Now **282** has been prepared in both (*R*)-²⁸⁴ and (*S*)-²⁸¹ forms, and it can be oxidized (silver oxide) to the acid.²⁸⁰



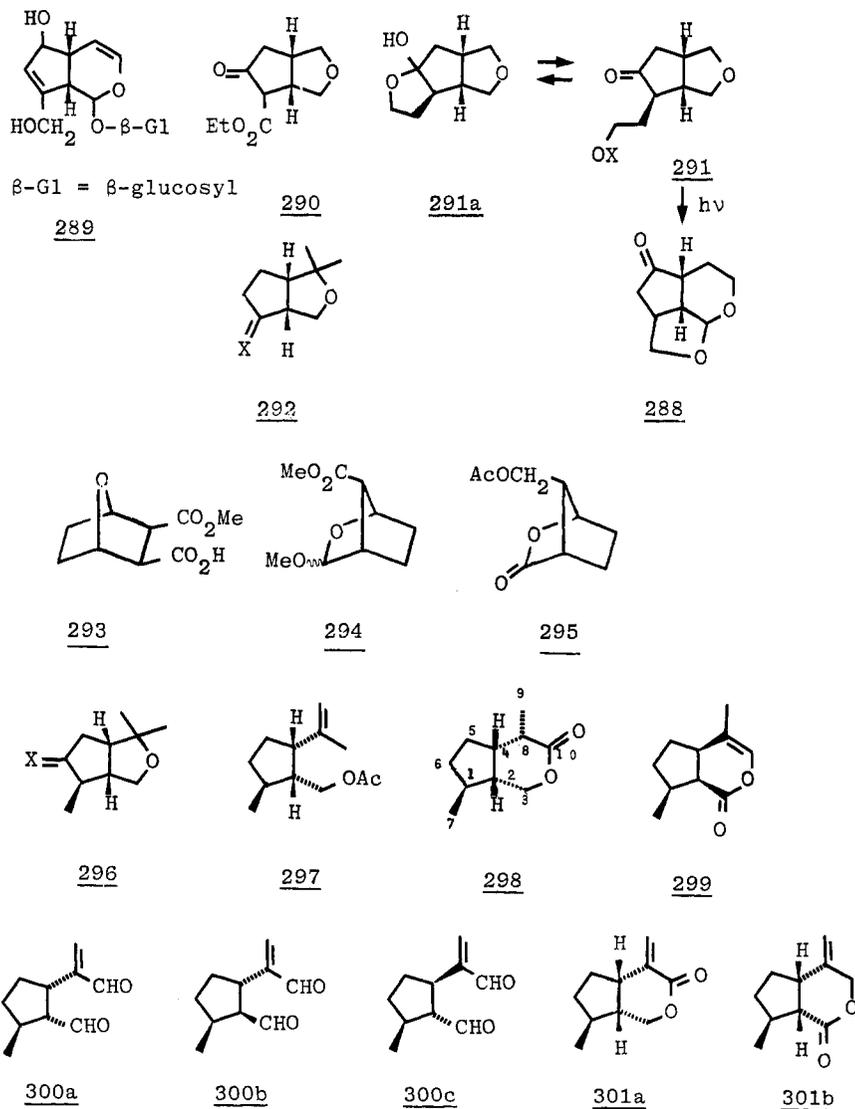
The thermal cyclization of linalool (**11**, Vol. 2, p. 61) yields plinol C (the *cis*, *cis*-isomer, **286**) as the major product. Now it has been shown that the cyclization of linalool (**11**) with mercuric salts favors formation of the *cis,trans*-diol **287**, corresponding to plinol A.²⁸⁵

Iridoids

It is no longer possible to give a list of the iridoids isolated from natural sources because of the enormous number described in recent years.²⁸⁶ This section will be restricted to recent syntheses of simple iridoids, proceeding to loganin and some related secoiridoids.

The acetals tetrahydroanhydroaucubigenone (**288**) and tetrahydroanhydroaucubigenin (the β -alcohol corresponding to **288**), known for many years as being related to aucubenin (**289**), noriridoids that are widely distributed in the

Scrophulariaceae), have recently been synthesized as racemates for the first time.²⁸⁷ The starting material **290** is obtained from Dieckmann condensation of diethyl tetrahydrofuran-*cis*-3,4-dicarboxylate,²⁸⁸ and the key step is the irradiation of the nitroso compound **291** (X = NO) obtained from the alcohol **291** (X = H), which exists in equilibrium with its cyclic acetal **291a**.²⁸⁷ Metal hydride reduction of **288** was already known,²⁸⁹ although in their total synthesis Obara et al. employed sodium in moist ether to effect this reduction.²⁸⁷



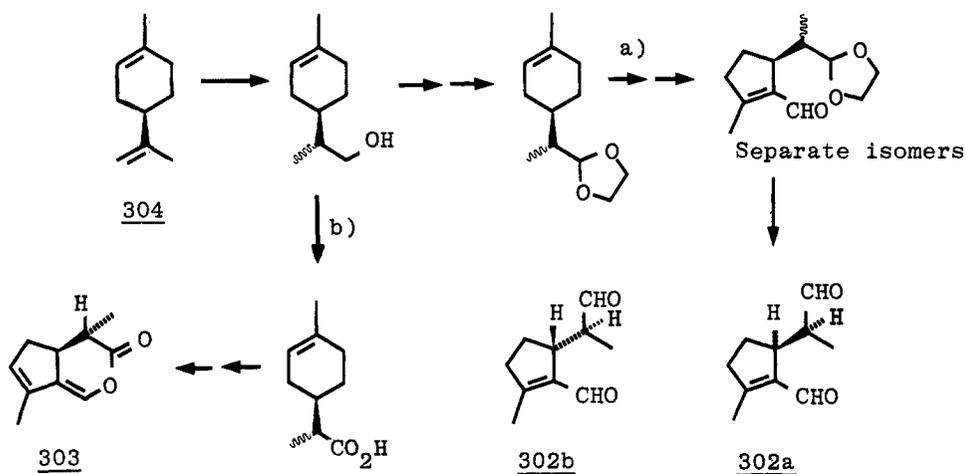
The length of this synthesis (about 10 steps) is characteristic of syntheses of quite simple iridoid systems. For example, hop ether (**292**, X = CH₂) (occurring in Japanese hop oil) is one of the simplest iridoids derivable directly from a geraniol precursor, but its first synthesis dates from 1979.²⁹⁰ The starting material is the monoester **293**, accessible by well-known Diels-Alder methods from furan. A key step is the anodic oxidation of this material,²⁹¹ which leads to what is actually a protected 2-substituted 3-formylcyclopentanol **294**. Lithium aluminum hydride reduction, then acetylation followed by *m*-chloroperbenzoic acid oxidation lead to the lactone **295**, which is converted to the ketone **292** (X = O) by Grignard addition and oxidation (Collins reagent).²⁹⁰ The methylene group **292** (X = CH₂) was added using the CH₂Cl₂-Zn-TiCl₄ reagent.²⁹²

A novel approach to the bicyclic ether skeleton of **292** by Yamada et al. involves the cyclization of geraniol (**36**) with Tl(III) salts, leading to the stereo-isomeric mixture **292** (X = Me, OH). By conventional means, they then prepared the ketone **296** (X = O)²⁹³ which was converted in turn to **296** (X = H₂), then with acetic anhydride in pyridine-HCl to the acetate **297**,²⁹⁴ from which iridomyrmecin (**298**) was available by a route described by Wolinsky.²⁹⁵ Both stereoisomers (at C(8)) of *cis,cis*-**298** have been made from all-*cis*-nepetalactone (**299**) with lithium aluminum hydride followed by oxidation, and the structures determined by X-ray analysis.²⁹⁶

The dolichodials (**300a**, **300b**, Vol. 2, p. 78) have been isolated from *Teucrium marum* (*L. abiatæ*), together with the related lactones **301a**, **301b**, which were suggested as possibly arising from biogenetic Cannizzaro reactions,²⁹⁷ and the *trans*, *trans*-isomer **300c** has been reported from *Iridomyrmex humilis*.²⁹⁸ The well-known synthesis of these aldehydes (Vol. 2, p. 78) has recently been described again,²⁹⁹ but otherwise there has been little synthetic work.

Isomeric with these aldehydes are chrysomelidial (**302a**, present, together with plagiolactone (**303**), in the defense secretion of *Plagioderia versicolara*³⁰⁰ and alone from *Gastrophysa cyanea*³⁰¹) and dehydroiridodial (**302b**), isolated from *Actinidia polygama*.³⁰² The synthesis of **302a** was effected from (+)-limonene (**304**) (Scheme 14),³⁰³ a similar route from (-)-limonene leading to **302b**.³⁰² While it will be remarked that this scheme is based on that of Wolinsky's earlier method for nepetalactone²⁸² (Vol. 2, p. 73), it includes the important modification that C(9) of the limonene skeleton is functionalized before ozonolysis.

A method from monoterpenoids not involving ozonolysis (further ozonolysis methods are discussed below) involves treatment of carvone epoxide (**305**) with sodium ethoxide. This yields the cyclopentanecarboxylic acid **306** directly, and Asaka et al. converted the latter into the tosylate **307** by standard techniques. They had been hoping to convert this substance into the diiridoid jasminin (**308**) by condensing it with the secoiridoid **309**, which they obtained from jasminin (**308**). Although this partial synthesis was not successful, since

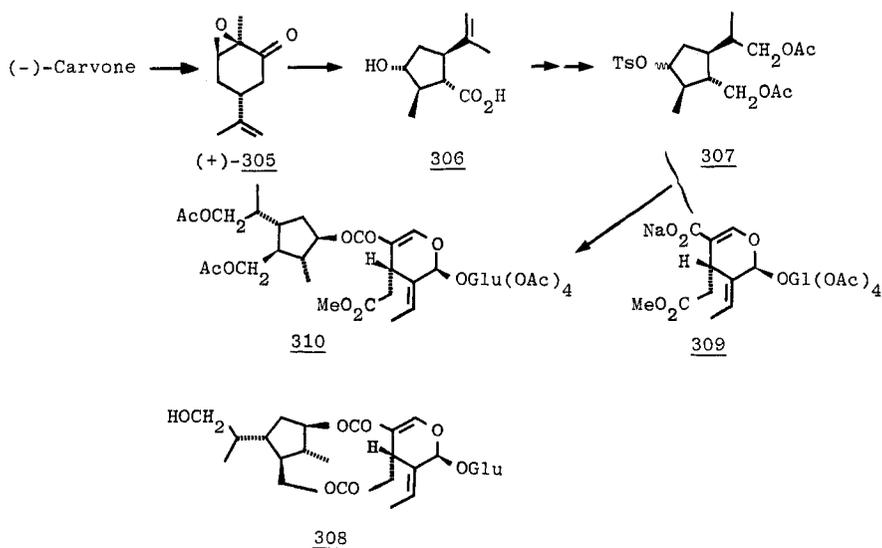


a) O_3 then piperidine; b) CrO_3

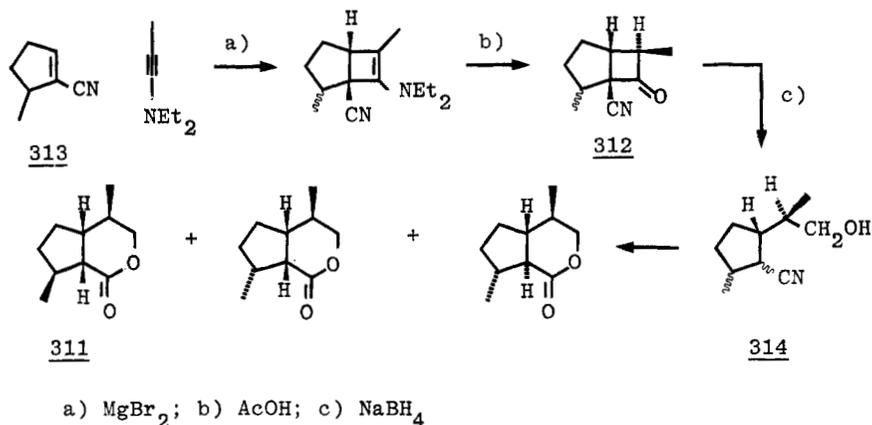

it led to **310**, the authors were able to prove the structure of jasminin by their results.³⁰⁴

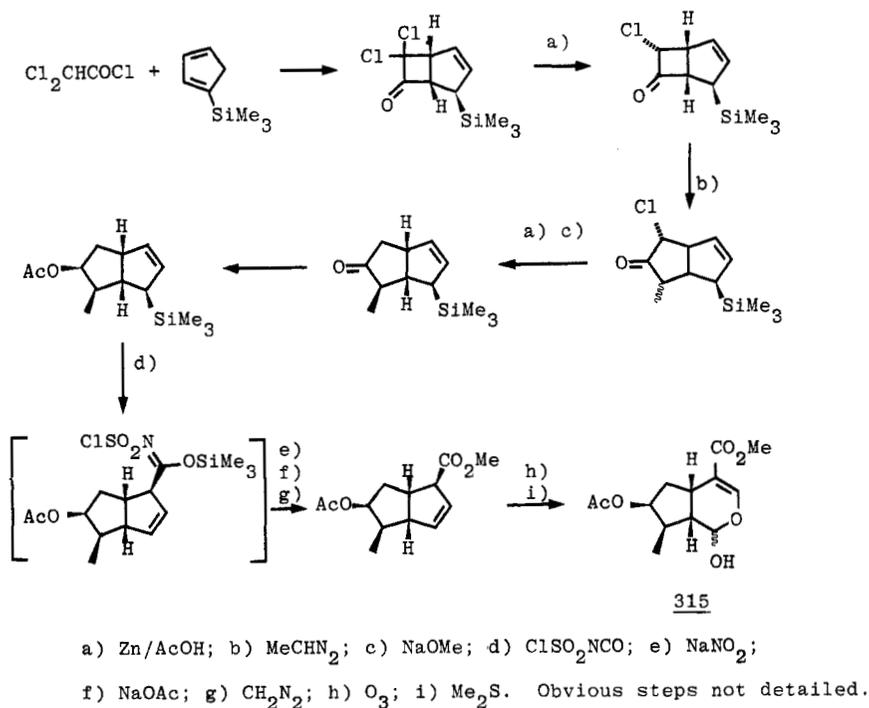
A fairly short route to isodihydronepetalactone (**311**), together with some of its isomers, was developed by Ficini using her ynamine reaction. The first step



is the creation of a bicyclo[3.2.0]heptane system **312** from 5-methyl-1-cyclopentenecarbonitrile (**313**). Reaction of borohydride on **312** gives the alcohol **314** when hydrolysis yields finally a mixture of lactones, 50% of which is **312**. (Scheme 15).³⁰⁵ Au-Yeung and Fleming also pass through a bicyclo[3.2.0]-heptene (Scheme 16) to make loganin aglucone acetate (**315**), but this is in order



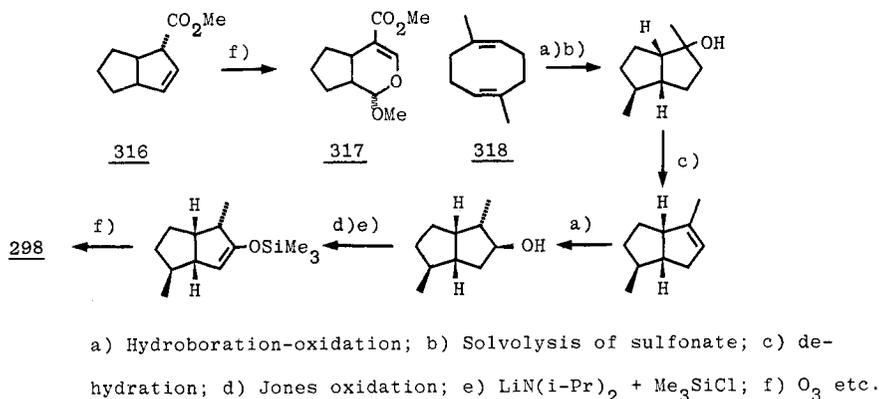

to make a bicyclo[3.3.0]octene, which, when suitably substituted, can be ozonized to prepare iridoids,³⁰⁶ a method extensively studied by Whitesell (see next paragraph).

The syntheses of Whitesell et al. all depend on this ozonolysis of a suitable bicyclo[3.3.0]octene; a typical example being the ozonolysis, followed by borohydride and acidic methanol, of the ester **316**, which leads to the simple iridoid model **317**, as a mixture of anomers³⁰⁷ previously prepared by Tietze³⁰⁸ as an extension of the loganin syntheses discussed later. In the case of his synthesis of iridomyrmecin (**298**), Whitesell made the bicyclic ring system from 1,5-dimethylcycloocta-1,5-diene (**318**) by a transannular solvolysis shown in Scheme 17.³⁰⁹

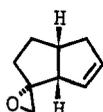
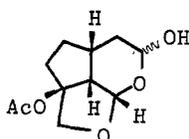
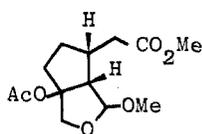
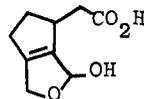
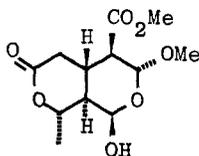
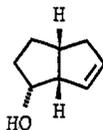
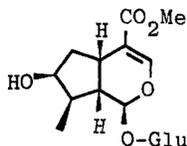

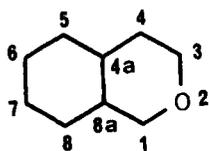
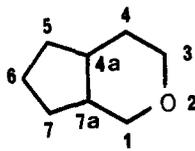
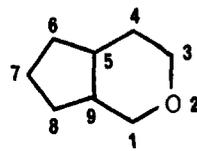
Following similar lines, several unsuccessful attempts were made to synthesize genipic acid (**319**).^{*} For example, ozonolysis of the epoxide **320**, followed by zinc/acetic acid reduction gave the acetal **321**, and this could be converted to **322**, but no way was found to carry out the last stages to **319**.³¹⁰ A report of the total synthesis of the secoiridoid xylomollin (**323**), isolated from an East African tree, and reported to have antifeedant activity,³¹¹ depends on the ozonolysis of the alcohol **324**,³¹² but full information is not available at time of writing. The structure of xylomollin (**323**) was revised, and it is the first natural iridoid with a *trans*-ring junction to be described, although the epimerization was suggested to be possibly due to the method of isolation.³¹³ A partial synthesis of the *cis*-fused isomer of **323** from loganin (**325**) has also been carried out.³¹³

One of the finest achievements of the bicyclo[3.3.0]octene approach is Whitesell's synthesis of sarracenin (**326**).³¹⁴ (The numbering of secoiridoids

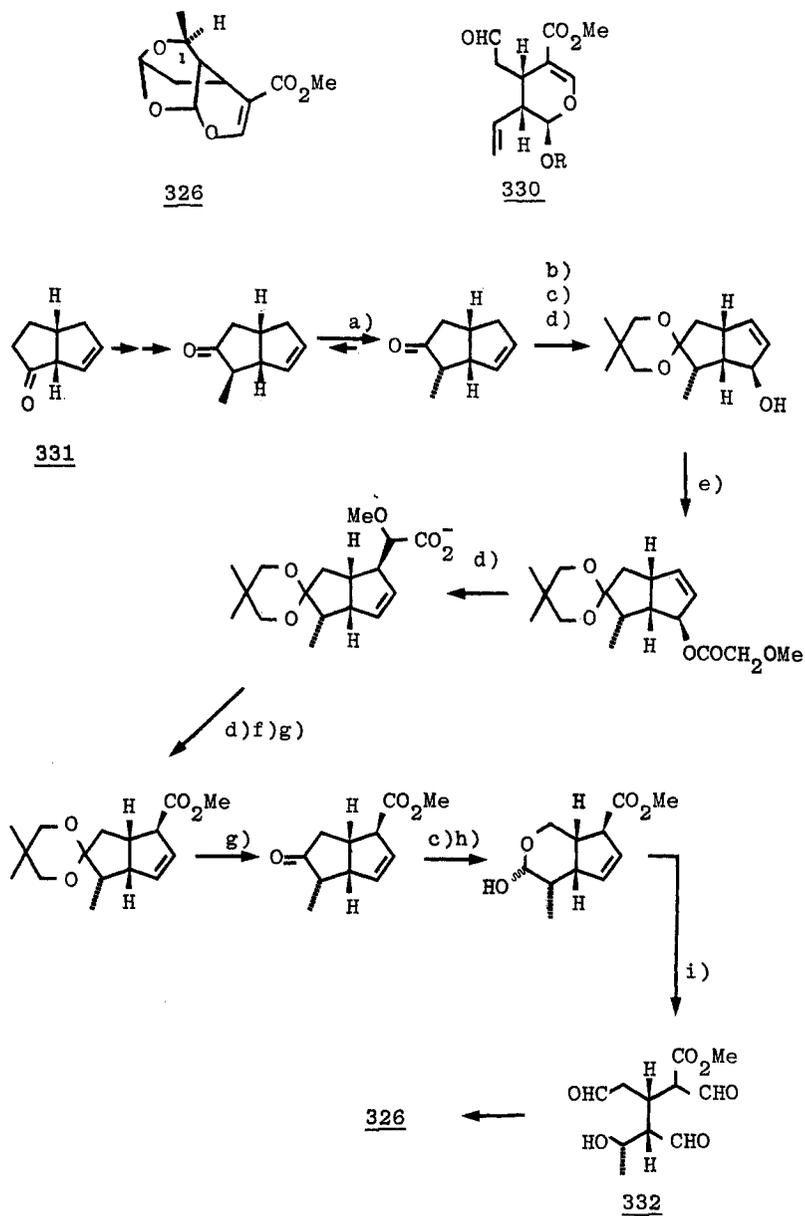

always presents a problem. Iridoids are generally numbered as on formula 298, following the menthanes and other cyclic monoterpenoids. Secoiridoids thus have a broken C(6)–C(1) bond. The Ring Index numbering follows 327 and 328, a system used by some authors, see Ref. 247, for example. Nakane et al.³¹³ prefer a different system, 329, which, coincidentally, leads to C(8) being the same atom as C(8) in the regular bicyclo[3.3.0]octane numbering used by Whitesell, and apparently extended to sarracenin.³¹⁴ Most authors avoid numbering secoiridoids, and Nakanishi et al. seem to have no system at all!³¹⁵)

Sarracenin (326) was isolated from *Sarracenin flavia*, an insectivorous plant growing in the Okefenokee swamp. It has been suggested that it may represent a route to the indole alkaloids that is complementary or alternative to secologanin (330),³¹⁶ especially since the absolute configuration at C(1) (monoterpene numbering) is the same as that of the corresponding carbon atom of ajmalicine and reserpine, and which is not chiral in secologanin (330, R = β -glucosyl).

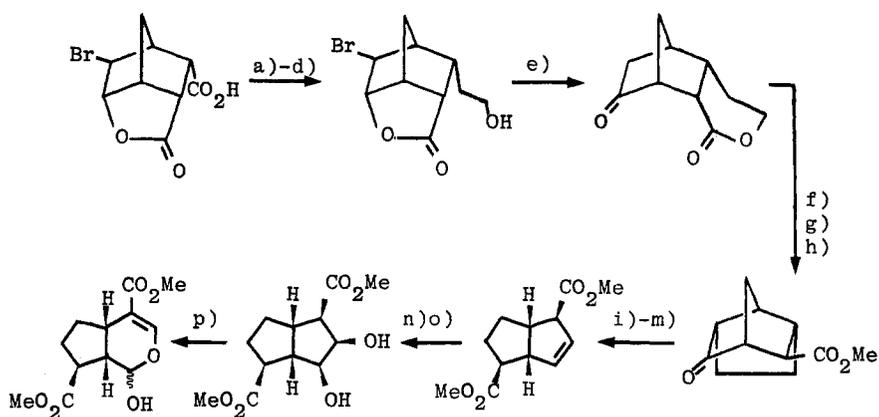

The functionalization of the starting material, bicyclo[3.3.0]oct-7-en-2-one (331) is carried out first, on the carbonyl-containing ring, then an ester is introduced on the cyclopentene side, prior to Claisen rearrangement to bring it into the correct position (Scheme 18). Cleavage of the cyclopentanone is effected by the Baeyer-Villiger reaction, the other ring then being ozonolyzed, yielding the precursor 332 of sarracenin (326).³¹⁴

In their synthesis of the dimethyl ester of forsythide (333)³¹⁷ Furuichi and Miwa open a bicyclo[3.3.0]octene system with osmium tetroxide followed by lead tetraacetate. The bicyclic system was here constructed from the more readily available bicyclo[2.2.1]heptanes (Scheme 19).³¹⁸ The same authors have also reported the synthesis of sweroside aglucone *O*-methyl ether (334) from a

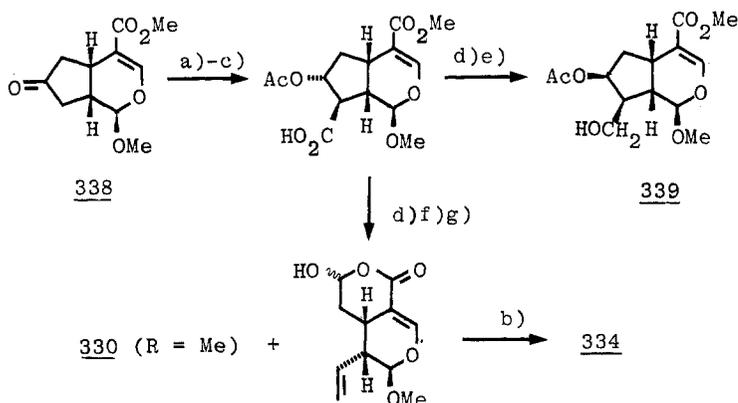

bicyclo[2.2.1]heptane system (Scheme 20), in which the key step is the Norrish Type 1 fission of the substituted norcamphor 335.³¹⁹

It will be recalled that Büchi's loganin (325) synthesis (Vol. 2, p. 82, full details of which were published in 1973³²⁰) depended on the photochemical coupling of a protected cyclopentene and the ester enol 336. Partridge's improvement consists in placing a methyl group of the correct absolute configuration on the cyclopentene side of the molecule 337 before the photo-

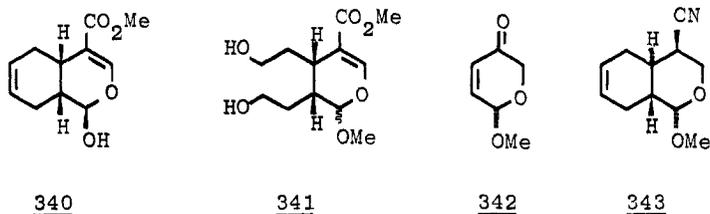
although **339** was glucosylated to hydroxyloganin.³²³ The difficulties of glucosylation have also been discussed.³²⁵



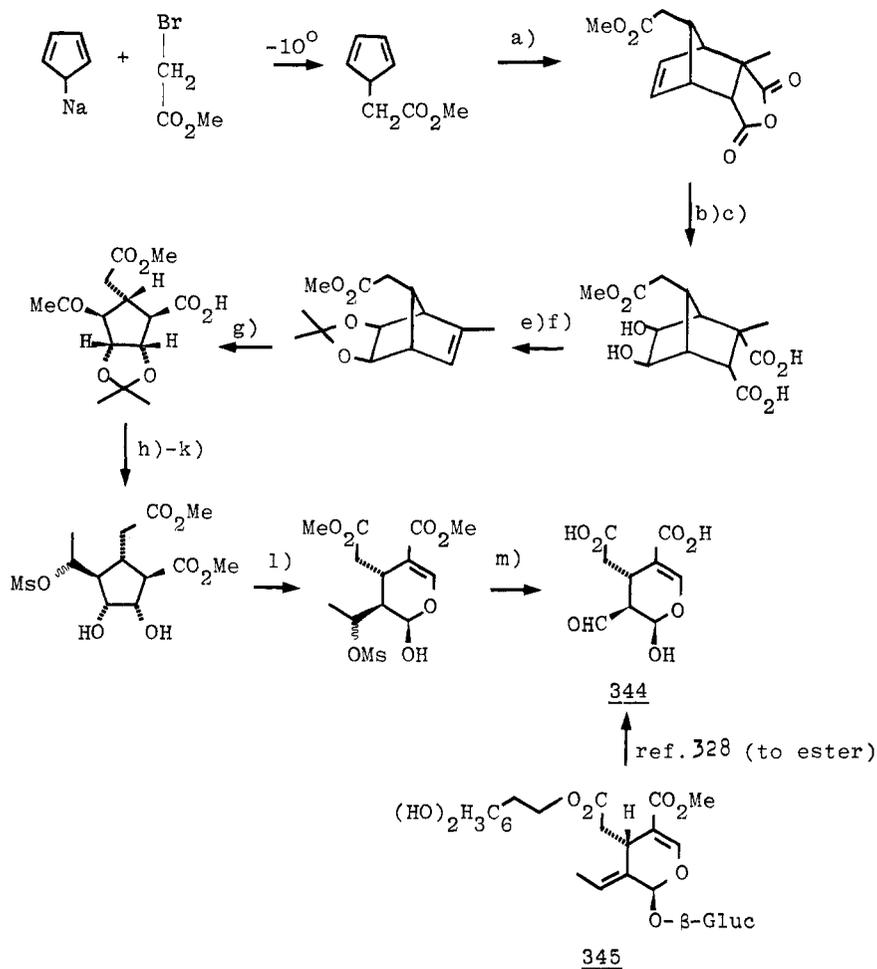

The photochemical reaction involving ester **336** does not have to have a cyclopentene as the other component. Reaction with 1,4-cyclohexadiene under the influence of light yields 62% of the *cis*-fused bicyclic compound **340** (with only 5% of the *trans*-fused isomer). After methylation of the hydroxyl group and fission at the double bond, the glycol **341** can be converted into sweroside aglucone methyl ether (**334**), or secologanin aglucone methyl ether (**330**, R = Me) straightforwardly.³²⁶ Another approach to the bicyclic type of compound like **340** involves a Diels-Alder reaction of butadiene with **342**, the product being converted to **343** before ring opening.³²⁷ So far, these routes give only racemates.



The hydrolysis product, elenolic acid (**344**), from oleuropein (**345**)³²⁸ has been synthesized following Scheme 22 by Kelley and Schetter.³²⁹



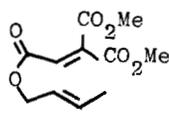
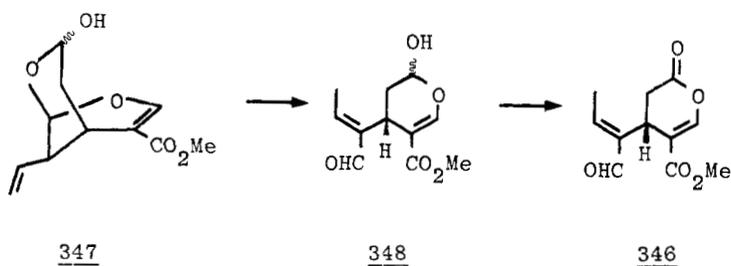
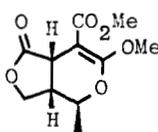
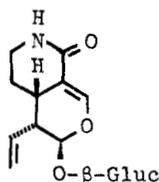
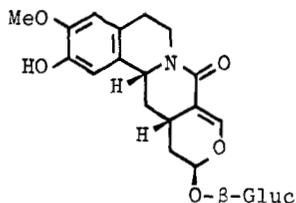
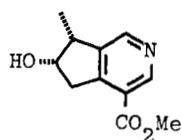

Elenolide (346) was isolated from *Olea europea* at the same time as secologanin (330, R = β-glucosyl),³³⁰ and Tietze has now shown that a connection is possible by converting secologanin into elenolide (which thus constitutes a synthesis of the latter).³³¹ Enzymatic cleavage of the glycoside bond of secologanin gives 347, which yields the acetal 348 on treatment with HCl in ether.

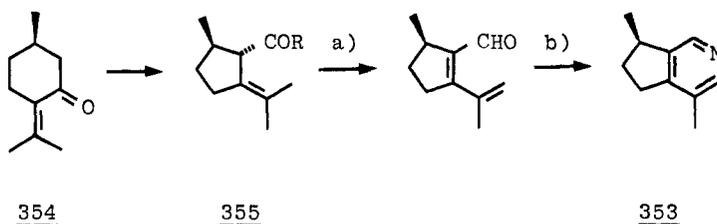
Pyridinium chlorochromate oxidation in the presence of sodium acetate then gives elenolide (**346**).

It has recently been found that one of the products of heating the butenyl ester **349** at 135° for 200 hours is a lactone **350** closely related to elenolic acid (**344**), and experiments are said to be in progress for the conversion of **350** to **344**.³³²

The relationship between secologanin (**330**, R = β-glucosyl) and the indole alkaloids is well known [see discussions,^{316, 333} and a more recent conversion of secologanin to corynanthé alkaloids via elenolic acid (**344**)³³⁴] but there is a small group of alkaloids that are much more clearly monoterpenoid in nature. One of the most directly related is bakankosin (**351**), isolated from *Strychnos vacacoua*,³³⁵ and for which the structure proposed³³⁶ was not confirmed before

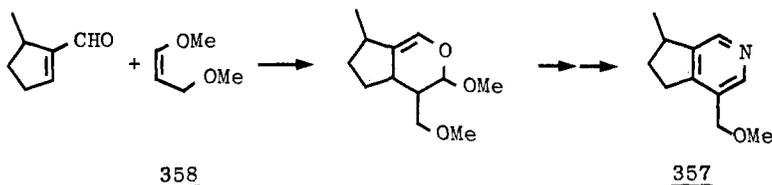
its synthesis from secologanin (**330**, R = β -glucosyl). The synthesis was effected by Tietze³³⁷ in fairly low yield by direct reductive amination (ammonium acetate and sodium cyanoborohydride in methanol³³⁸); secologanin tetraacetate has also been converted to bakankosin tetraacetate.³³⁹ Another alkaloid directly derived from secologanin, alangiside (**352**),³⁴⁰ has been synthesized as its methyl ether from secologanin.³⁴¹ Secologanin has been converted into useful synthons for alkaloid synthesis using similar reductive amination to that of Lane³³⁸ as the key step.³⁴² Related to loganin (**325**) rather than the seco compound are the alkaloids of the actinidine series. (+)-Actinidine [**353**, the natural compound is the (-)-isomer] has been synthesized from (+)-pulegone (**354**) via pulegenic acid (**355**, Scheme 23 and Vol. 2, p. 72).³⁴³ Cantleyine (**356**) may be formed from

loganin and ammonia,³⁴⁴ but there is not yet a total synthesis. Valerianine (**357**), isolated from *Valeriana officinalis*, has been synthesized by a route in which the key step is a Diels-Alder reaction between 5-methyl-1-cyclopentene-carbaldehyde and **358**.³⁴⁵



8. THE *p*-MENTHANES

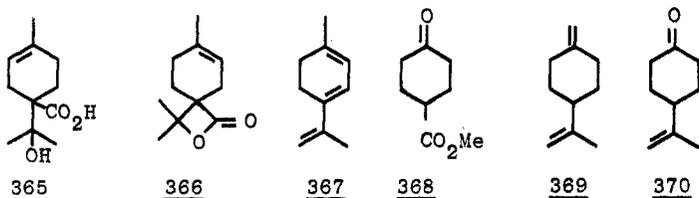
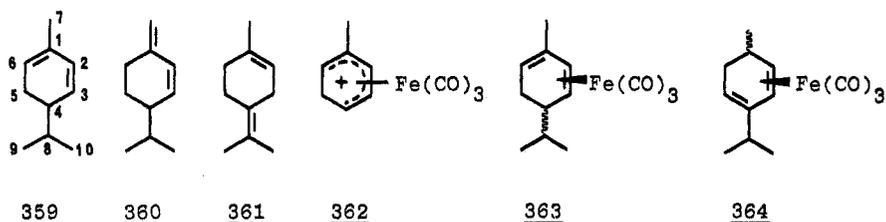
A. Hydrocarbons

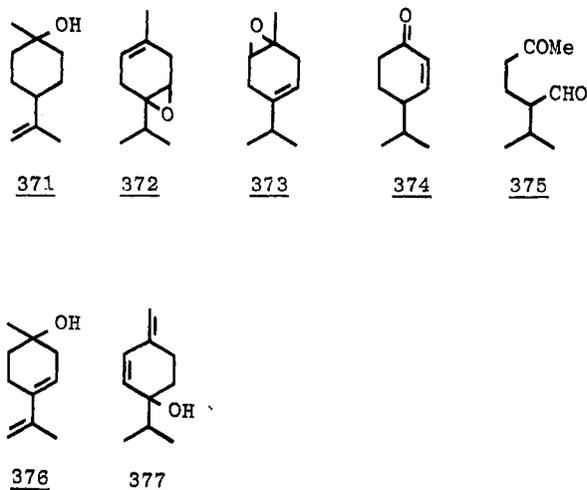
A careful study of the (mostly classical) methods of preparation of the more common menthadienes, prepared in high purity and of which the NMR spectra are given, has been published.³⁴⁶ The phellandrenes (**359** and **360**) were not included in this study.

Methods for the synthesis of α - (359) and β -phellandrene (360) are interesting because there is only a limited supply available from natural sources. A conventional, though effective way of preparing a mixture of phellandrenes is by Singaram and Verghese, employing bromination and debromination of 1-menthene (284). The debromination was effected by silver nitrate in dimethyl sulfoxide, and separation of the phellandrenes depended on the fact that only α -phellandrene (359) reacts with maleic anhydride.³⁴⁷ A similar method was employed for making terpinolene (361).³⁴⁸ β -Phellandrene (360) is obtained in 89% yield on pyrolysis of sodium 1-menthene-7-sulfonate.³⁴⁹

A multi-step synthesis of terpinolene (361) from 1-(4-methylphenyl)-1-methyl-ethylmagnesium halide involves a Birch-type reduction of trimethylsilyl derivative,³⁵⁰ and, while it may be useful for preparing other compounds, it must be recalled that terpinolene is one of the cheapest of monoterpenes, and no synthesis of more than one step is economically justifiable.

Introduction of an isopropyl or isopropenyl group into a suitably substituted cyclohexane remains one of the most common ways of synthesizing menthanes. Hydroboration of 1-methyl-1,4-cyclohexadiene is, however, not stereospecific. Using borabicyclo[3.3.1]nonane followed by isopropenyllithium and iodine, the ratio of 1,4- to 1,3-menthadienes was 43:57.³⁵¹ Birch found that the iron tricarbonyl complexes of cyclohexadienes can be alkylated with zinc or cadmium alkyls. Thus from the ion 362, derived from 2-methyl-1,3-cyclohexadiene, the α -phellandrene iron tricarbonyl complexes (363) can be obtained.³⁵² These are rearranged to 364 by acid,³⁵³ but can be converted to α -phellandrene (359) by cupric ion.³⁵⁴





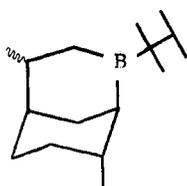
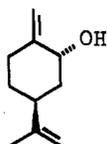
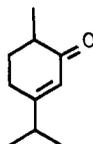
Addition of acetone to the dilithium derivative of 4-methyl-3-cyclohexene-carboxylic acid leads to a hydroxy-acid **365**, which lactonizes with benzenesulfonyl chloride, the lactone **366** giving terpinolene (**361**) on heating.³⁵⁵

When 1-methyl-1,3-cyclohexadiene is treated with isopropenyl bromide and piperidine in the presence of palladium acetate and triphenylphosphine, 39% of 1,3,8-menthatriene (**367**) and 13% of another (uncharacterized) triene are obtained.³⁵⁶ While **367** and the 1,4,8-isomer³⁵⁷ (Vol. 2, p. 91) are well known and characterized, menthatrienes are occasionally reported in the literature without adequate characterization. For example, 1,5,8-menthatriene, for which only scanty NMR data are published³⁵⁸ is reportedly available from carveol³⁵⁹, or carene oxides,³⁶⁰ or α -pinene epoxide,³⁶¹ and there are two reports of 1(7),2,4(8)-menthatriene³⁶² for which we are unaware of any NMR data.

An interesting new application of the Wittig reaction has been discovered by Uijttewaal, Jonkers, and van der Gen. In dimethyl sulfoxide, esters react with excess methylenetriphenylphosphorane to yield, after hydrolysis, the corresponding isopropenyl compounds.³⁶³ Thus treatment of the ketoester **368** with excess of the phosphorane yielded 78% of 1(7),8-menthadiene (**369**), and by protecting the ketone group as an acetal before the reaction then removing the protecting group, 4-isopropenylcyclohexanone (**370**) could be obtained—a convenient route to β -terpineol (**371**),³⁶⁴ a compound belonging to the following section.

9-¹⁴C-Limonene has been synthesized.³⁶⁵

One of the epoxides (**372**) of γ -terpinene was reported to occur in *Origanum heracleoticum*, this same epoxide being said to be the sole product from monophtalic acid epoxidation of the hydrocarbon.³⁶⁶ Other work has shown that

The radicals from the 2-menthenes with *t*-butyl perbenzoate in the presence of cupric octanoate react with lithium aluminum hydride to give mixtures containing the *t*-alcohols,³⁷⁶ but the method does not seem to be readily adaptable for synthetic use.

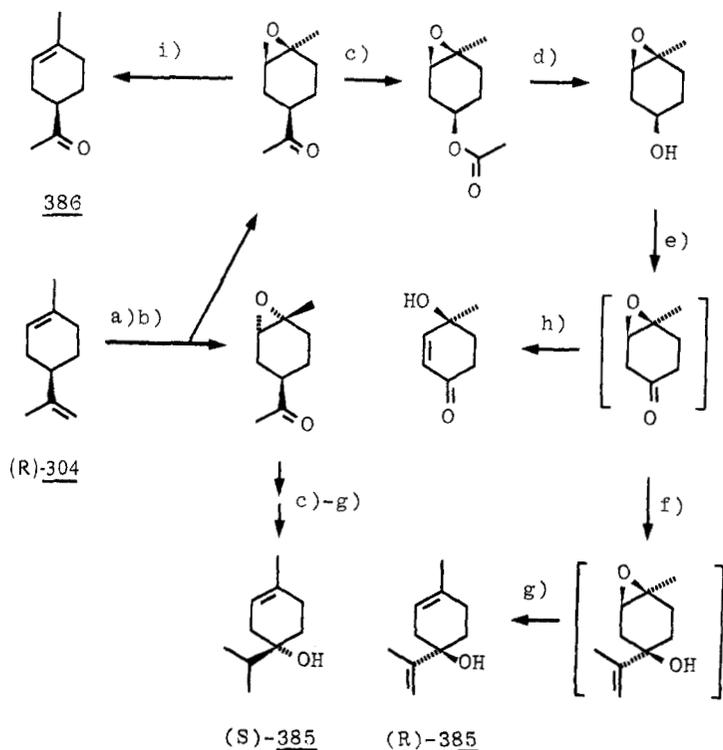
Pyrolysis of the silane obtained from methylenecyclobutane (discussed in a previous section)¹²⁶ leads to a substituted isoprene 381, which, in a Diels-Alder reaction with methyl acrylate yields an 8:2 mixture of the adducts 382 and 383. The former can be converted to δ -terpineol (384) with methyl-lithium and acid, the last two reactions being carried out in either order.¹²⁶

In Vol. 2, p. 100, the preparation of 1,8-menthadien-4-ol (385) was discussed. It was not mentioned, however, that the easiest route is probably from terpinolene (361), the epoxide of which is converted to 385 directly by *p*-toluenesulfonic acid at 25-30°. ³⁷⁷ Another very simple route is the Grignard reaction of 4-methyl-3-cyclohexenone,³⁷⁸ which has been repeated without acknowledgment.³⁷⁹ Sharpless has carefully reinvestigated the selenium dioxide oxidation of limonene (304),³⁸⁰ because, although this should give a racemate, at least one report³⁸¹ claimed optically active products. There is no doubt that the compound obtained from optically active limonene in this reaction is racemic, any optical activity detected being due to impurities.³⁸⁰ Although the naturally occurring 1,8-menthadien-4-ols are still of unknown absolute configuration, Delay and Ohloff have prepared both optical isomers from (+)-(*R*)-limonene (*R*-304) by the routes shown in Scheme 24.³⁸² In this connection, the ozonolysis of optically active limonene epoxides and the subsequent reduction (Zn-NaI) to optically active 386 has been thoroughly described.³⁸³

1-Menthanol labeled with deuterium at C(2) have been synthesized.³⁸⁴

The 2-Oxygenated Menthanes

Two syntheses of 2-methyl-5-isopropenylanisole (387, Vol. 2, p. 103) have been reported. The first of these includes the bad first stage (20% yield) of converting 2-amino-4-chlorotoluene to 2-hydroxy-4-chlorotoluene, then methylating the phenol and inserting the isopropenyl group with lithium diisopropenylcopper.³⁸⁵ The other synthesis relies on compound 388, an intermediate in the original

synthesis, using Grignard addition and dehydration to put in the methylene group. This method necessitates care in the final step to avoid dimerization.³⁸⁶

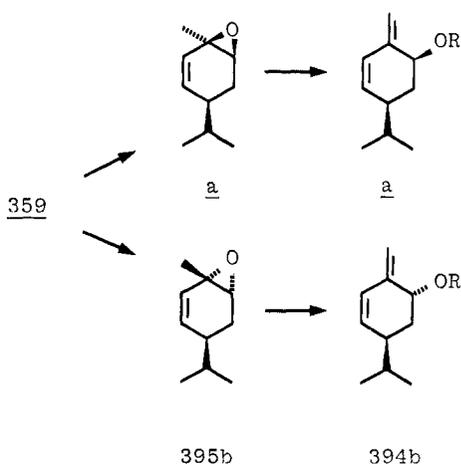
One of the most economical ways of approaching C(2) oxygenated menthanes is from limonene, as we have noted in Vol. 2, p. 108. Direct hydroboration of limonene gives mixtures,³⁸⁷ but Brown and Pfaffenberger have developed a method for producing a single configuration about the ring. Thus oxidative hydroboration of (+)-(*R*)-limonene produces a 70:30 mixture of the diols 389 and 390 (they were unable to separate the *threo* and *erythro* isomers at C(8), which are called "*cis*" and "*trans*" in the paper) but under certain conditions, particularly distillation of the product obtained with thexylborane, a

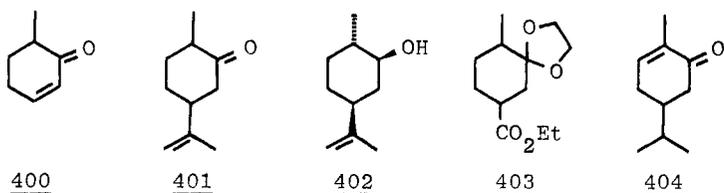
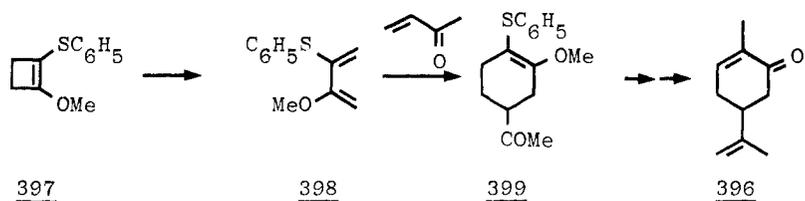
cyclic borane **391** was obtained, from which a 83% yield of the pair of compounds (-)-(1*R*,2*R*,4*R*)-carvomenthol (**389**) was obtained.³⁸⁸

Oxidation of limonene generally is less specific, anodic oxidation giving, for example, mixtures of stereoisomers of 2-oxygenated 1(7),8- and 5,8-menthadienes, together with a small amount of 7-oxygenated limonene.³⁸⁹ Ring-opening of limonene epoxide (Vol. 2, p. 108) also gives mixtures, but one of us has examined the various conditions leading to either 2-substituted **392** or 7-substituted compounds very carefully.³⁹⁰ Ring-opening of the *cis*- and *trans*-menthene-1,2-epoxides over various catalysts has been examined by Arata et al., and gives mixtures of 2-oxygenated menthanes with ring-contracted products.³⁹¹

Dehydrolinalool (**121**) acetate can be cyclized with zinc chloride to a mixture containing carvenone (**393**), its enol acetate, a 2-carone enol acetate and a pyran derivative.³⁹²

Concerning the syntheses of specific natural 2-oxygenated menthanes, new natural products derived from 1(7),5-menthadien-2-ol have been found. The two alcohols **394a**, **394b** (R = H) were reported in *Cinnamomum japonicum*,³⁹³ and one isomer (not determined) in pepper oil.³⁷² They were suspected to be present in angelica (*Angelica archangelica*) root oil,³⁹⁴ and when Escher et al. showed clearly that both alcohols and one of the acetates **394b** (R = Ac) were present in this oil, they synthesized both isomers stereospecifically from α -phellandrene (**359**). Direct epoxidation yielded the *trans*-epoxide **395b**, the *cis*-epoxide **395a** being prepared by the action of *N*-bromosuccinimide (to the bromohydrin) and sodium hydroxide. The alcohols were then obtained by the action of lithium diisopropylamide on the corresponding epoxides.³⁹⁵





A review of the synthesis of carvone has been published.³⁹⁶

A synthesis of carvone (396) was the vehicle Trost used to demonstrate how cyclobutanone might be used. Thiophenylation and conversion to the enol ether gave 397, which was pyrolyzed to the diene 398. In a Diels-Alder reaction, the latter yielded the cyclohexenyl ketone 399, which was converted conventionally to carvone (396).³⁹⁷

2-Methylcyclohexanone has been converted to carvone (396) in an overall yield of only 28%, but by a very attractive route on paper. The trimethylsilyl enol ether of 2-methylcyclohexanone is first oxidized to the unsaturated ketone 400 with dichlorodicyanobenzoquinone and collidine, and the isopropenyl side chain is introduced using a copper-catalyzed Grignard addition. The dihydrocarvone (401) thus obtained was converted to carvone by the same oxidation as before, with DDQ/collidine on the trimethylsilyl ether. Piperitone (see below) has been made by a similar oxidation of menthone trimethylsilyl enol ether.³⁹⁸

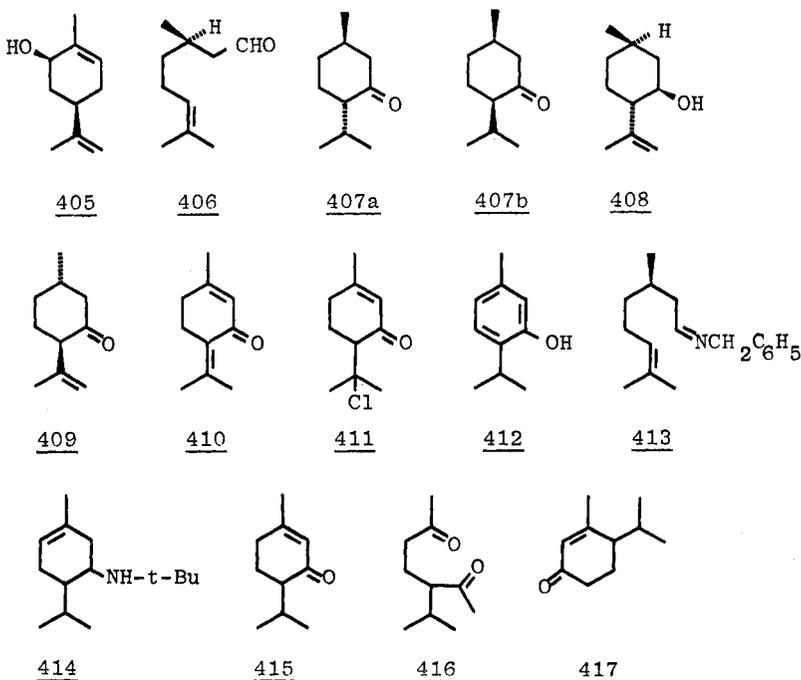
Vig has synthesized dihydrocarveol (402) conventionally from 4-methyl-3-cyclohexenyl methyl ketone,³⁹⁹ and dihydrocarvone (401) from the ester 403.⁴⁰⁰ It should be noted that carvotanacetone (404), the synthesis of which is described in *Organic Syntheses*,⁴⁰¹ is wrongly listed there as "dihydrocarvone."

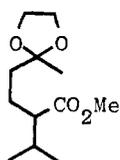
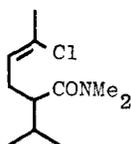
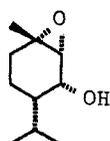
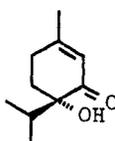
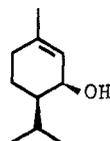
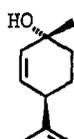
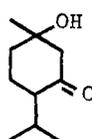
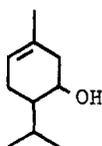
Various deuterium-labeled dihydrocarvones, dihydrocarveols, and carvomenthols have been prepared.^{384, 402}

The scheme used by Rao (Vol. 2, p. 107, and Ref. 403) to convert one optical antipode of carvone to the other has been applied to the examination of the very different odors of the two naturally occurring antipodes.⁴⁰⁴ Yasuda et al. have used the metal-ammonia reduction of the mesylate of *cis*-carveol epoxide (derived from the (2*R*,4*R*)-isomer, 405) to prepare the (2*S*,4*S*)-isomer of 405.⁴⁰⁵

The 3-Oxygenated Menthanes, Menthofuran, and Other 3,7-Oxygenated Derivatives

The cyclization of open-chain monoterpenoids to 3-oxygenated menthanes is well known (see Vol. 2, pp. 116, 120), and the literature is large; we shall confine this aspect to a few selected recent developments. The use of tris-(triphenylphosphine)chlororhodium or stannic chloride in the cyclization of citronellal leads to different amounts of the isopulegol isomers.⁴⁰⁶ A pulegol ester can be obtained by heating 3,7-dimethyloctane-1,7-diol above 200° in the presence of an acid anhydride.⁴⁰⁷ Simultaneous cyclization and reduction can lead directly from citronellal (406) to menthone (407a) and isomenthone (407b).⁴⁰⁸ Cyclization is most easily carried out using zinc bromide in benzene (toluene?) when the optical activity of the citronellal (406) is retained in the isopulegol (408) obtained (in 70% yield with 96% optical retention).⁴⁰⁹ This same cyclization can be carried out with retention of optical activity by treatment of citronellol (33) with pyridinium chlorochromate (obtaining isopulegone 409).⁴¹⁰ Cyclization of the acid chloride of (*Z*)-geranic acid (*Z*-56) in the presence of a Lewis acid yields a mixture of piperitenone (410) and its hydrochloride (411). Lithium chloride in dimethylformamide converts 411 to 410, and treatment of the mixture with lithium in ethylenediamine yields thymol (412).⁴¹¹

The oxygenated thymols are discussed in the section on 9-oxygenated menthanes.

Imines of open-chain compounds have been used in two ways to synthesize menthanes. (+)-(*R*)-citronellal benzylimine **413** is cyclized at 25° in benzene to a mixture of 8-menthenylamines with retention of configuration at C(1); catalytic reduction gives a mixture of 3-menthylamines.⁴¹² These were not well characterized in the preliminary note, and it is to be hoped that the full paper makes the proportions of the stereoisomers quite clear. 3-Methylbutanal *t*-butylimine reacts with isoprene in the presence of sodium in an autoclave at 40° to give the menthenylamine **414**.⁴¹³

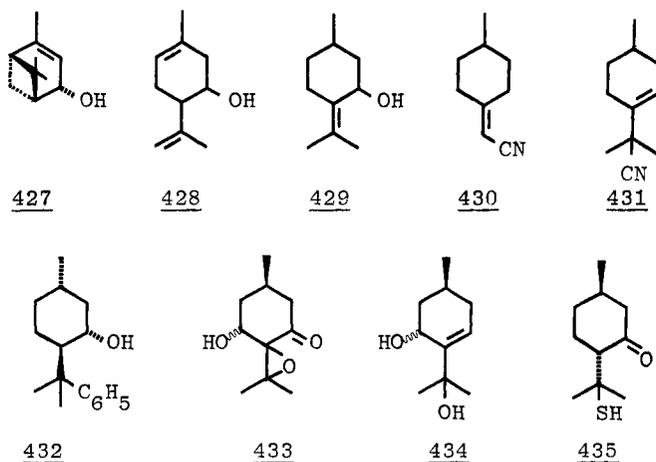
Piperitone (**415**) is accessible by cyclization of the diketone **416** (Vol. 2, p. 119), but some of the alternative *o*-menthenone (**417**) is formed at the same time.⁴¹⁴ Actually, piperitone "unzips" even during dienamine formation, and dienamines corresponding to **417** and its double bond isomers are always found among the products.⁴¹⁵ Two methods have been described for making **416**; one involves the protected ketoacid **418**, converting the ester group to a methyl ketone using the dimethyl sulfoxide anion and reduction with aluminum amalgam,⁴¹⁴ the other consists in making the chloroamide **419** (from the enol of *N*-dimethyl-3-methylbutyramide and ClCH₂CH=CClMe), forming the methyl ketone with methyllithium, then hydrolyzing the vinyl chloride with acid.⁴¹⁶

A certain number of piperitone derivatives are present in various mint species (cf. Vol. 2, p. 136), and more recently, *trans*-piperitol epoxide (**420**)⁴¹⁷ and the 4-hydroxy compound **421**⁴¹⁸ have been identified in the wild Japanese mint, *Mentha gentilis*. The former must be accessible from *cis*-piperitol (**422**), but we have not been able to find a clear synthetic description of either. The piperitols

themselves have been made from 2-carene epoxide (423) by Prasad and Sukh Dev (who inexplicably say that they were not described earlier—relevant references are in Vol. 2, p. 120, and include a detailed description of the NMR spectra⁴¹⁹). The route they used consists in ring opening with metatitanic acid to the menthadienol 424, rearrangement (acetic acid) and reduction (tristriphenylrhodium chloride).^{*421}

Still has shown how the trimethylstannyllithium reagent can be added to cryptone (374) and the product oxidized to yield 1-hydroxy-3-menthone (425).⁴²² Unfortunately he does not mention the stereochemistry of the product, although both isomers of 425 are well described.⁴²³ An acetate of 425 occurs in *Mentha gentilis*⁴²⁴ (which was also not compared with the known 425).

The isomer of piperitol, 1-menthen-5-ol 426 has been found in pepper oil.³⁷² The authors do not publish a stereochemistry, but it was probably *trans*.⁴²⁵ Once again, although these compounds 426 have been in the literature for some time, it is difficult to pin down a good synthetic description. The first description of one of the isomers was by Read and Swann in 1937, who prepared it as a by-product of the catalytic reduction of piperitone (415) epoxide.⁴²⁶ Among the products of the thermolysis of *trans*-verbenol (427) is 30% of a mixture of *cis*- and *trans*-1,8-menthadien-5-ols (428). Separation of these and catalytic reduction leads to the isomers of 426.⁴²⁷ Marshall and Babler have mentioned the mesylate of *trans*-426 without comment on its preparation.⁴²⁸ The unconjugated ketone, 1-menthen-5-one has also been described,^{415, 427, 429} indeed, Read and Swann comment on the difficulty of oxidation of the alcohol 425,⁴²⁶ but it has not yet been reported in nature.



*The ring opening to 424 using peracetic acid was already described by Ohloff and Giersch,⁴²⁰ but is contested by Prasad and Sukh Dev.

The pulegols (429) have been synthesized by Marshall et al. from 4-methylcyclohexanone. Condensation with diethyl sodiocyanomethyl phosphate yields 430, which can be methylated to 431 with lithium diisopropylamide and methyl iodide in hexamethylphosphoramide. Epoxidation (peracid) and treatment with sodium in ammonia yield a 2:1 ratio of *trans*:*cis*-429. The oxidation of the pulegols was studied at the same time. Manganese dioxide oxidation of *cis*-429 yields pulegone [(±)-354] in 80% yield, but the other isomer leads to the epoxide. The pulegone epoxides are also discussed.⁴³⁰

The compound 432 is a good chiral director, and a synthesis of it now exists from the cheaper (+)-(*R*)-pulegone (354).⁴³¹ Before this, however, it was necessary to start from (-)-(*S*)-pulegone, which is not of easy access. The conversion of the (*R*)- to the (*S*)-antipode was carried out by Ensley and Carr. Photooxygenation (with reduction) followed by peroxidation of the α,β -unsaturated ketone leads in 70% yield to the epoxides 433. Treatment of the latter with hydrazine gives the diols 434; catalytic reduction of the double bond, oxidation of the carbinol group, and dehydration with iodine then give (-)-(*S*)-pulegone [(-)-354].⁴³² This series of reactions is reminiscent of an earlier conversion of (-)-(1*R*,4*S*)-menthone (407a) to the antipode, required for the synthesis of optically pure citronellols.⁴³³ (-)-(*S*)-Pulegone can also be prepared by the classical cyclization of (*S*)-citronellal, recent improvements being the use of (*S*)-citronellol (generally of better optical purity than the aldehyde) and pyridinium chlorochromate, which yields optically active (*S*)-isopulegol directly, it remaining only to isomerize the double bond with base.⁴³⁴

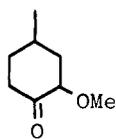
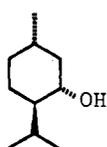
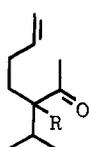
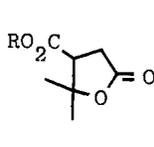
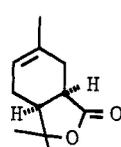
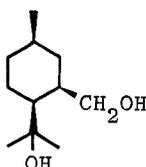
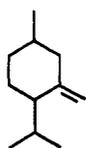
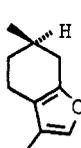
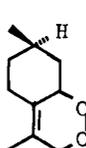
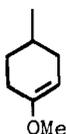
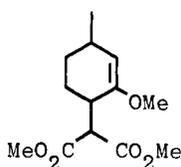
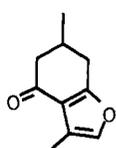
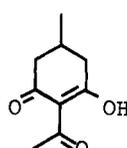
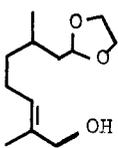
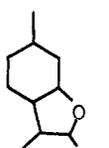
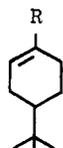
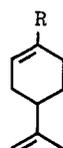
Hydrogenation of piperitenone (410) with chiral homogeneous rhodium catalysts gives pulegone with up to 38% optical purity.⁴³⁵

A synthesis of isopulegone (409) from ethyl 2-keto-4-methylcyclohexanecarboxylate has been described.⁴⁰⁰

The thiol 435 is an interesting pulegone derivative; it is made by treatment of pulegone with hydrogen sulfide in triethylamine, and it occurs naturally in Buchu oil and black currants (*Ribes nigrum*).⁴³⁶ The corresponding thioacetate also occurs in Buchu oil.⁴³⁷

Owing to the economic importance of menthone (407a) and the menthols there is a great deal of literature. Few recent syntheses, however, can be considered economically justified. (See Leffingwell's review⁴³⁸ on the synthesis of optically active menthol.) The following are, however, worthy of mention. A fairly simple approach starts from the enol acetate of 4-methylcyclohexanone. Treatment with methanol under phase-transfer conditions (with tetraethylammonium *p*-toluenesulfonate) gives the methoxyketone 436, Grignard reaction on which gives menthol (437) directly via a 1,2-carbonyl transposition.⁴³⁹ By a double alkylation of ethyl acetoacetate, first with 4-bromobutene then with isopropyl iodide, Conia et al. prepared the β -ketoester 438 (R = CO₂Et). This may either be hydrolyzed and decarboxylated (NaCN and dimethyl sulfoxide)

to the ketone **438** ($R = H$), pyrolysis of which leads to menthone and isomenthone (**407**), or pyrolyzed directly. At 300° the cyclization occurs without decarboxylation, but after 2 hours at 350° , menthones are formed.⁴⁴⁰

One method which appears superficially of only academic interest has nevertheless given rise to a patent. This is based on the fact that α -butenolides carboxylated in the β -position, **439**, are dienophiles, and the acid **439** ($R = H$) reacts with isoprene to give 91% of the *cis*-adduct **440**. After catalytic reduction,

ring-opening with lithium aluminum hydride leads to the diol **441**. Conventional reactions lead to either *cis*- or *trans*-**442**, from which isomenthone (**407b**) or menthone (**407a**) are obtained by ozonolysis.⁴⁴¹

The synthesis of menthol glycosides has been investigated.⁴⁴²

A simple synthesis of menthofuran (**443**) involves treatment of the cyclic peroxide **444**, obtained from 3,8-menthadiene and singlet oxygen, with lithium diisopropylamide at -70° and *p*-toluenesulfonyl chloride.⁴⁴³ (Surely an improvement would be to use the ferrous reagent.⁴⁴⁴) Other, more complicated syntheses start from ethyl 2-oxo-4-methylcyclohexanecarboxylate. Vig uses the carboxylate group to activate the position which is to receive the side chain,⁴⁰⁰ but Wenkert introduces it in order to prepare specifically the enol ether **445** reaction of which with dimethyl diazomalonate in the presence of copper phosphite gives 39% of **446**. Menthofuran (**443**) is prepared conventionally from **446** in 3 steps.⁴⁴⁵ This (and another equally long synthesis in the same paper) is clearly only the vehicle for showing how the addition of the diazomalonate occurs to an enol ether, for not only is it of prohibitive length, but the addition of a carboxyl group, which is later removed in order to add a C₃ unit, is not esthetically satisfying. An older process involving peracid oxidation of isopulegone enol acetate (see Vol. 2, p. 122) has recently been improved.^{445a}

A synthesis of evodone (**447**, Vol. 2, p. 123) has been effected by the reaction of diazomethane with the dihydroresorcinol **448**.⁴⁴⁶

Acid cyclization of the hydroxycitronellal acetal **449** leads to an acetal **450** related to a hydrogenated menthofuran.⁴⁴⁷

The 7-Oxygenated Menthanes

The Diels-Alder reaction between chloroprene (2-chloro-1,3-butadiene) and methyl vinyl ketone leads to the chloroketone **451**, and this is a useful intermediate for the preparation of 7-oxygenated menthanes. For example, oleuropic acid (**452**, R = CO₂H) has been made by protecting the ketone group as an acetal, introducing the aldehyde group with lithium and dimethylformamide, removal of the protecting group on the ketone and subsequent protection of the aldehyde, then Grignard addition and oxidation to **452** (R = CO₂H).⁴⁴⁸ Alternatively, a Grignard reaction on **451** gives an alcohol that can be dehydrated to **453** (R = Cl), from which perilla aldehyde (**453**, R = CHO) is obtained with lithium and dimethylformamide.⁴⁴⁹

For approaches to perilla alcohol (**453**, R = CH₂OH) from **392**, which is a photooxidation product of limonene, see Ref. 312. The corresponding aldehyde **453** (R = CHO) can be reduced with sodium in the two-phase system of benzene-aqueous ammonia to a mixture of *cis*- and *trans*-shisool (**454**),⁴⁵⁰ two alcohols isolated from *Perilla acuta* var. *viridis*,⁴⁵¹ the *trans*-isomer also having been found in the oil of *Juniperus communis*.⁴⁵² More recent work has shown how, with

different conditions, the lithium in ammonia-isopropanol reduction of perilla aldehyde (453, R = CHO) can lead to other products of different oxidation levels.⁴⁵³

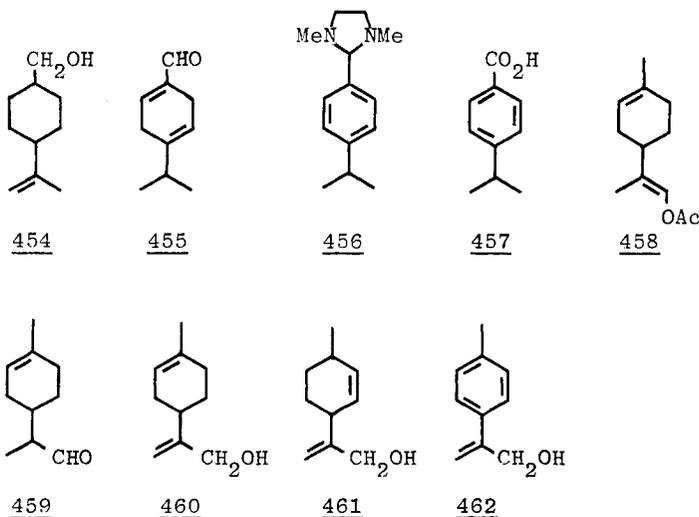
One of the aldehydes 455 occurring in cumin seeds has been synthesized by Birch and Dastur using Birch reduction of the protected cuminaldehyde 456. Removal of the protecting group after reduction yielded the aldehyde 455.⁴⁵⁴ Reduction of cuminic acid (457) with sodium in liquid ammonia was already known.⁴⁵⁵

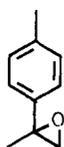
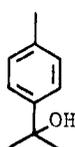
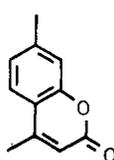
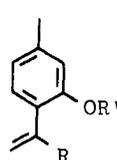
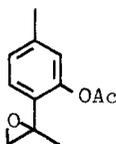
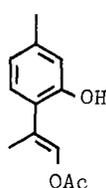
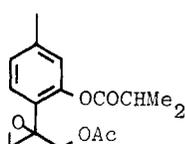
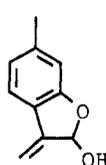
Besides occurring as part of the bitter principle of the olive tree (Vol. 2, p. 135), oleuropic acid (452, R = CO₂H) and other 7-carboxylic acids are metabolic products of *Pseudomonas* sp., 452 (R = CO₂H) being produced from α -terpineol (452, R = Me),⁴⁵⁶ and limonene giving perillic acid (453, R = CO₂H).⁴⁵⁷

The 9-Oxygenated Menthanes

In addition to the previously known 9-oxygenated menthanes, the enol acetate 458 has been found in tangerine oil.⁴⁵⁸

The access to 9-oxygenated menthanes through lead tetraacetate oxidation of limonene was discussed in Vol. 2 (p. 130), but a few modifications have been published more recently,⁴⁵⁹ particularly with the end of synthesizing the aldehyde 459, isolated from rose oil,⁴⁶⁰ cotton seed oil,⁴⁶¹ and Buchu leaf oil,⁴⁶² (the structure of which was determined some time ago⁴⁶⁰) and the widely distributed unsaturated alcohol 460.⁴⁵⁹ Vig has also synthesized the isomer 461 (not yet reported naturally occurring), but the stereochemistry was not established.⁴⁶³



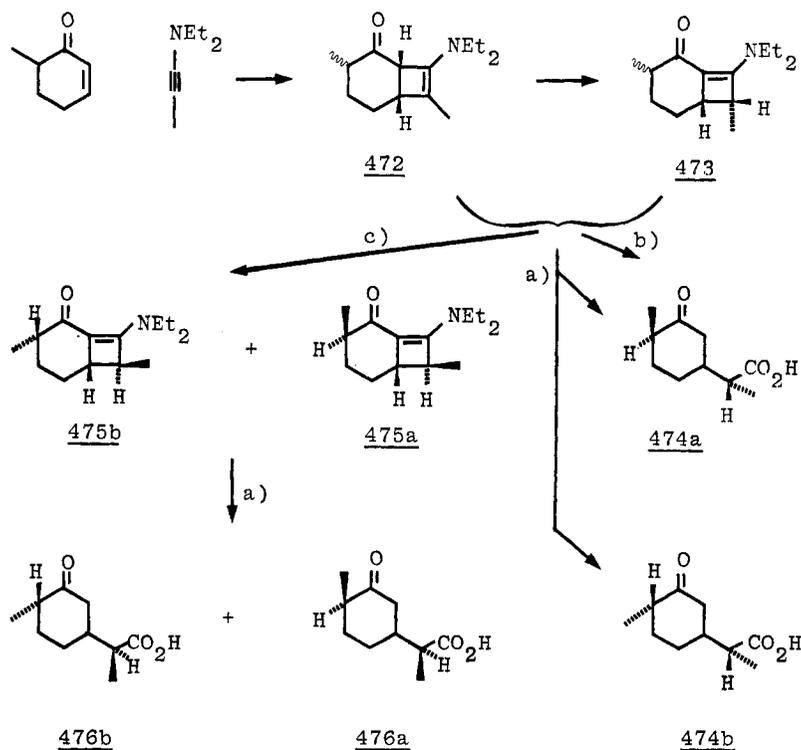

Of the aromatic 9-hydroxylated *p*-cymenes, **462** is not yet reported naturally occurring, but **463** ($R = \text{CH}_2\text{OH}$) and the related acid **463**, ($R = \text{CO}_2\text{H}$) are products of the metabolism of *p*-cymene (**463**, $R = \text{Me}$) by a soil pseudomonad,⁴⁶⁴ and **463** ($R = \text{CH}_2\text{OH}$) also occurs in the oil of *Juniperus communis*,⁴⁶⁵ and has been known for a long time. Recent preparations of **462** include the preparation of the epoxide **464** from 4-methylacetophenone and ring opening with lithium diisopropylamide⁴⁶⁶ [acid-catalyzed ring opening gives mainly the aldehyde **463** ($R = \text{CHO}$)⁴⁶⁷], and solvolysis of the *p*-nitrobenzoate of **465**, prepared by the reaction of dichloroacetone with 4-tolylmagnesium bromide.⁴⁶⁸ Another entry to 9-functionalized α ,4-dimethylstyrenes is via the reaction of α ,4-dimethylstyrene with *N*-bromosuccinimide.⁴⁶⁹ Apart from the catalytic reduction of **462** or related substances, **463** ($R = \text{CH}_2\text{OH}$) can also be prepared directly by the action of propylene oxide and triethylaluminum on toluene. After hydrolysis, the alcohol is obtained in 61% yield.⁴⁷⁰

Related to these synthetic methods are the routes used to prepare some of the many thymol (**467**, $R = \text{Me}$, $R' = \text{H}$) derivatives substituted at C(9) that Bohlmann's group has isolated particularly from Compositae. Divakar and Rao, improving the known reaction of 4,7-dimethylcoumarin (**466**) with base, obtained a good yield of the unsaturated thymol **467** ($R = \text{Me}$, $R' = \text{H}$). After acetylation and perbenzoic acid oxidation, they obtained the epoxide **468**, which they pyrolyzed to the enol acetate **469**;⁴⁷¹ this could be useful in the synthesis of enol acylates that occur naturally.⁴⁷² Divakar et al. have also synthesized the esters **467** ($R = \text{CH}_2\text{OCO-}i\text{-Pr}$, $R' = \text{CO-}i\text{-Pr}$) and **467** ($R = \text{CH}_2\text{OCO-}i\text{-Pr}$, $R' = \text{Me}$).⁴⁷³ In order to synthesize the compound **470** which they had isolated from *Wedelia forsteriana*,⁴⁷⁴ Bohlmann et al. prepared the ester **467** ($R = \text{Me}$, $R' = \text{CO-}i\text{-Pr}$) by the conventional route (Grignard addition,

dehydration and esterification) from methyl 4-methylsalicylate. Introduction of an oxygen function at C(9) was effected using selenium dioxide in acetic anhydride, and the product **467** (R = CH₂OAc, R' = CO-*i*-Pr) was epoxidized to **470**.⁴⁷⁵ Divakar et al. have also always introduced the oxygen function at C(9) with selenium dioxide, but using dimethyl sulfoxide as solvent in order to make the aldehydes **467** (R = CHO). Another compound made by them following similar lines is the naturally occurring benzofuranol **471**.⁴⁷⁶

An ingenious route by Ficini and Touzin does not lead specifically to a natural product, but is a useful entry to racemates of stereochemically established configurations about C(8) of the menthane-9-carboxylic acids. A [2 + 2] cycloaddition of an ynamine to 2-methylcyclohex-5-enone leads to the *cis*-substituted bicyclo[4.2.0]octenone **472a**, converted in neutral or basic solution into the isomer **473** (Scheme 25). Decomposition of these substances with acetic acid yields two of the possible 2-oxomenthane-9-carboxylic acids (**474a**, **474b**), while treatment of the enamines **472**, **473** with dry hydrogen chloride gives two other enamines **475a**, **475b**, which can likewise be decomposed with acetic acid to the enantiomers **476a** and **476b** of **474a** and **474b**.⁴⁷⁷



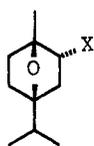
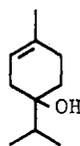
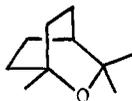
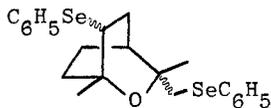
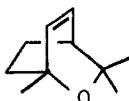
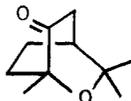
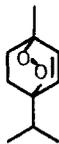
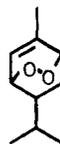
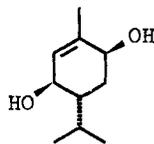
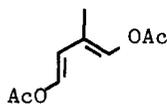
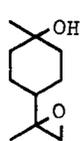
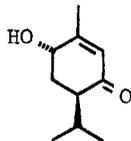
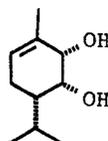

Ethers, Ascaridole, Polyoxygenated Menthanes

A new synthesis of 1,4-cineole (477, X = H, Vol. 2, p. 133) gives 79% overall yield of a cleaner product than earlier methods. 1-Menthen-4-ol (478) is irradiated in the presence of mercuric oxide and iodine, and the resulting iodide 477 (X = I) reduced with lithium aluminum hydride to 1,4-cineole (477, X = H).⁴⁷⁸

1,8-Cineole (=eucalyptole, 479) has been synthesized from limonene (304). When the latter is allowed to react with phenylselenenic acid (C_6H_5SeOH , formed *in situ* from a mixture of phenylseleninic acid and diphenyl selenide⁴⁷⁹) the adduct 480 is formed, and this can be reduced with tri-*n*-butyltin hydride to give 80% of 1,8-cineole (479).⁴⁸⁰ The dehydro analog 481 occurs in *Laurus nobilis*, and has been synthesized in low yield by the reaction of butyllithium on the *p*-tosylhydrazone of 482 (starting from the same material, this paper also describes the synthesis of the non-naturally occurring pinol and isopinol; see also Vol. 2, p. 131).⁴⁸¹

The formation of ascaridole (483) by the addition of oxygen to α -terpinene (Vol. 2, p. 133) is catalyzed by the triphenylmethyl cation.⁴⁸² A similar effect occurs in the presence of Lewis acid in methylene chloride at -90° or in SO_2 solution at -70° without Lewis acids.⁴⁸³

Two peroxides, *cis*- and *trans*-484 are accessible from α -phellandrene (359) in the same way as ascaridole (483) is from α -terpinene.⁴⁸⁴ Ring opening of 484 has been known for some time^{485, 444} one of the products being the diol 485, isolated from *Eupatorium macrocephalum* by González et al.⁴⁸⁶ The diacetate of 485 has also been made by the Diels-Alder reaction between 486 and 3-methyl-1-butene.⁴⁸⁷

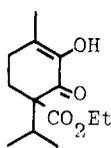
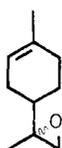
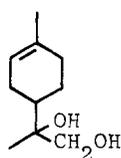
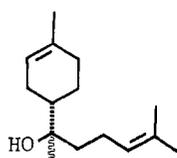
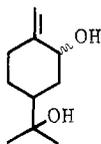
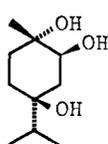
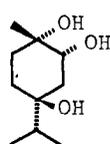
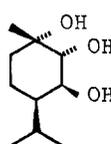
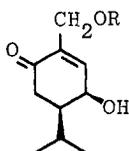
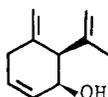
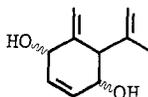
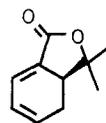
Polyoxygenated menthanes are frequently found among the products of microbiological oxidation of common terpenoids. For instance, besides the 7-oxygenated compounds mentioned above, α -terpineol (452, R = Me) gives one of the epoxides 487,⁴⁸⁸ and piperitone (415) gives various hydroxylated piperitones, particularly 488,⁴⁸⁹ accessible from 484.^{444, 485}

2,3-Dioxygenated menthanes occur naturally, 489 in *Mentha gentilis*,⁴⁹⁰ for example, and an ester 490 of the corresponding ketone in the roots of *Pluchea odorata*.⁴⁹¹ Diosphenol (491) and its isomer, ψ -diosphenol (492), have long been known as constituents of Buchu leaf oil (various species of *Barosma*; for other related constituents see Ref. 492),⁴⁹³ but 492 was apparently unknown to Shibata and Shimizu,⁴⁹⁴ who prepared it as a by-product of diosphenol (491) when repeating the original ferric chloride oxidation of menthone (407).⁴⁹⁵ A reexamination of the acid-catalyzed ring opening of pulegone epoxide (493) has shown that the hydroxy-8-menthenone (494) obtained originally by Reusch et al. using *p*-toluenesulfonic acid⁴⁹⁶ is converted by 20% aqueous sulfuric acid into a 3:7 mixture of diosphenol (491) and ψ -diosphenol (492), the same mixture as is obtained by direct treatment of 493 with sulfuric acid. In this route to 492, it should be noted that the chirality at C(1) is retained.⁴⁹⁷ A "building-block"-type synthesis of diosphenol (491) and its isomer 492 has been effected by Ohashi et al., during which they found that the ester 495 could not be decarboxylated. This induced them to oxidize 2-isopropylcyclohexanone directly, adding the extra methyl group after.⁴⁹⁸

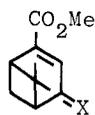
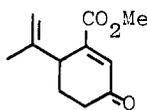
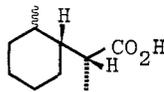
The limonene 8,9-epoxides (496), prepared from limonene by the action of peroxybenzimidic acid,⁴⁹⁹ can be separated by spinning-band distillation⁵⁰⁰

(as can also the 1,2-epoxides⁵⁰¹). Kergomard and Verschambre have correlated the uroterpinols (**497**), obtained on acid-catalyzed ring opening of **496**, with the products from limonene metabolism.⁵⁰⁰ They assigned the stereochemistry of the glycols using europium shift NMR techniques, which, in the case of poly-functional compounds, are not always easy to interpret. This could account for a discrepancy that has been noted between the stereochemistry of bisabolols (**498**) prepared from the epoxides **496**⁵⁰⁰ and by other means,⁵⁰² and until this is resolved,* the configuration of the uroterpinols (**497**) about C(8) must also be in doubt. Uroterpinol (**497**) and its monoacetate are products of the lead tetraacetate oxidation of limonene mentioned above.

The synthesis of both stereoisomers of 1(7)-menthen-2,8-diol (**499**) has been carried out by Vig;⁵⁰³ they are not yet reported in nature. The dimethyl ether of **499** has been made by thallation of myrcene (**6**) in methanol.⁵⁰⁴

The triol **500** was isolated from *Zanthoxylum budrunga*. It was not synthesized, but the structure was determined by comparison with the isomeric triol **501**, made by the reaction of osmium tetroxide on 1-menthen-4-ol.⁵⁰⁵ The 1,2,3-triol **502** is the first monoterpenoid to be isolated from a microorganism, *Fusicoccum amygdali*,⁵⁰⁶ and it has been synthesized from piperitone (**415**), together with six other stereoisomers.^{506a}

Bohlmann et al. have found the angelate ester (**503**, R = angeloyl) in *Blumea wightiana* (Compositae).⁵⁰⁷

9. THE *o*-MENTHANES

The first discovered member of this small group of monoterpenoids, carquejol (**504**) and its acetate^{508,509} have not yet been synthesized.* Some derivatives of related diols **505** have been isolated from other *Baccharis* and *Piqueria* species,⁵¹¹ but again no synthetic work is reported.

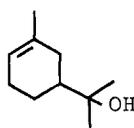
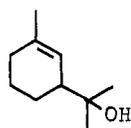
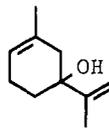
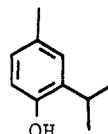
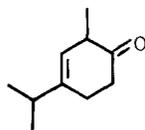
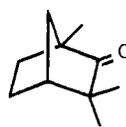
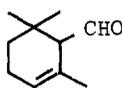
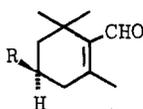
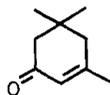
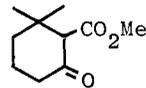
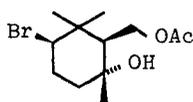
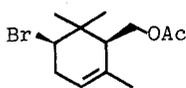
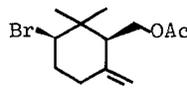
The only successful preparation so far of a natural *o*-menthane is that of the lactone **506**, isolated from the urine of the koala bear (*Phascolarctos cinereus*).⁵¹² Lander and Mechoulam⁵¹³ started with methyl myrtenate (**507**, X = H₂), which can readily be prepared by oxidation of α -pinene (**245**).⁵¹⁴ Oxidation with sodium chromate yields the verbenone derivative (**507**, X = O), and the latter gives the *o*-menthene **508** on treatment with *p*-toluenesulfonic acid in acetic acid and acetic anhydride. After metal hydride reduction, **508** can be converted to the lactone **506** with *p*-toluenesulfonic acid. This paper also contains much useful information about the opening of pinane systems to *o*- rather than to *p*-menthanes.⁵¹³ This is likely to be a similar route to the biogenetic one; Lander and Mechoulam even suggest that the lactone **506** might be an artifact arising from the acid hydrolysis of the urine employed in its workup.

It is clear that a small modification of Ficini's ynamine synthesis (Scheme 25, p. 96) will lead to an entry into substituted *o*-menthanes, and she has made the acids **509** in this way from 4-methyl-2-cyclohexenone, subsequently correlating them with *o*-menthan-4-ones prepared from the copper-catalyzed addition of isopropylmagnesium bromide to 4-methyl-2-cyclohexenone.⁵¹⁵

*The structure of carquejol is frequently incorrect in the literature.⁵¹⁰ The original structure⁵⁰⁸ was later modified.⁵⁰⁹

10. THE *m*-MENTHANES

As stated in Vol. 2 (p. 137), most naturally occurring *m*-menthane derivatives reported are probably to be ascribed to artifacts from carenes, notably the "sylveterpineols" (510a, 510b) of Wallach,⁵¹⁶ one of which 510a has recently been isolated from *Laggera aurita*.⁵¹⁷ Perhaps the 6,8-*m*-menthadien-3-ol (511) isolated from *Cannabis sativa* resin,⁵¹⁸ but not yet synthesized, falls into this category too. Probably more authentically "natural" are isothymol (512), synthesized many decades ago, and now isolated from *Neurolaena oaxacana*,⁵¹⁹ its esters from *Eupatorium* species,⁵²⁰ and, together with an ether, from *Senecio* sp.⁵²¹

Among the conversions of carenes to *m*-menthenes, a recently reported reaction of Lewis acids with carene 2,3-epoxide (513) is very interesting, because the main product, reported to be 514,⁵²² does not have the same spectral properties as another compound said to possess this structure, and made by the action of trifluoromethanesulfonic anhydride on fenchone ((±)-515).⁵²³ At first sight, the evidence presented in Ref. 522 appears to be more reliable. Ficini's ynamine synthesis has also been adapted to the *m*-menthane group.⁵²⁴

11. THE TETRAMETHYLCYCLOHEXANES

A. 1,1,2,3-Substituted Cyclohexanes

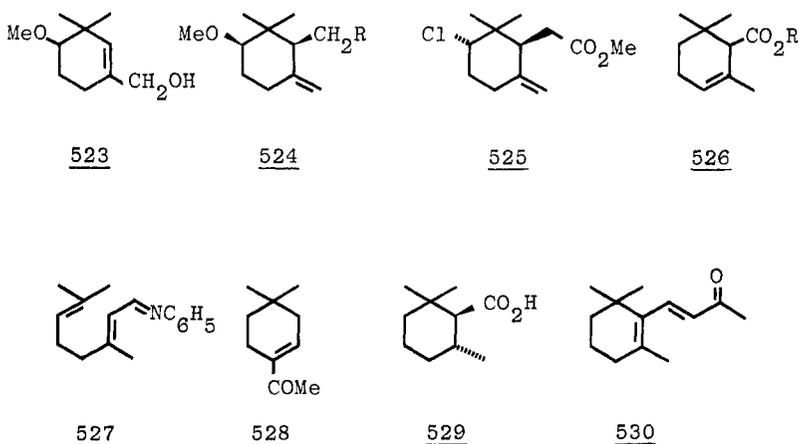
The naturally occurring compounds of this group arise formally by cyclization of the dimethyloctane monoterpenoids, to form, for example, two of the most common members of the group, α - (516) and β -cyclocitral (517, R = H). The latter is widespread, and occurs in oxygenated forms. Saffron (*Crocus sativa*) for example, contains a number of cyclocitrals and related substances oxygenated at C(4) and C(5),⁵²⁵ particularly picrocrocin, the full stereochemistry of which has been shown to be 517, R = β -glucosyl.⁵²⁶ The corresponding acid to picrocrocin occurs in *Gardenia jasminoides grandiflora*.⁵²⁷ A list of related compounds detected in virginia tobacco has been given,⁵²⁸ and β -cyclocitral is also the only monoterpenoid detected in the blue-green algae *Microcystis wesenbergii* and *M. aeruginosa*.⁵²⁹

Some of the compounds of the series lack a carbon atom at C(1), and these can readily be made by various oxidations of isophorone (518).^{525, 530}

The cyclization of geraniol (36) and related monoterpenoids has been known for a long time. Recent developments include the cyclization of geranyl acetate by thiyl radicals generated by photolysis of thiols (for instance), after Raney nickel desulfurization, the product is fully hydrogenated 516.⁵³¹ A mixture of thioethers corresponding to 516 and 517 is obtained on acid treatment of geranyl phenyl sulfide.⁵³² Acid treatment of the addition product of geranyl acetate epoxide and C₆H₅Se yields a cyclized product that was then converted to safranal (2,6,6-trimethylcyclohexa-1,3-dienecarbaldehyde).^{532a} The ketoester 61 has been cyclized to 519, a versatile intermediate (although it was only used to make the readily accessible methyl β -cyclogeranate in this paper).⁵³³ Geranyl acetate is cyclized by bromine in the presence of stannic bromide at 0°, when 16% of 520 is formed. The latter can be dehydrated to a mixture of bromine-substituted α -(521) and γ -cyclogeranyl acetates (522).⁵³⁴ The interest in this synthesis lies in the possibility that it might be a model for the biosynthesis of some of the halogen-containing monoterpenoids found in marine organisms (see Ref. 46), syntheses of which are very rare. Although not strictly speaking the

synthesis of a naturally occurring monoterpene, the recent work by Rouessac and Zamarlik is an interesting approach to the synthesis of 6-chloro-1,1,2,3-substituted cyclohexanes. After placing a function in the 2-position by a sigma-tropic reaction of, say, the vinyl ether of **523**, thus leading to **524** (several methods besides this were used, with products having different functions for R), they found that by refluxing the acid chloride **524** (R = COCl) in benzene, the chloroester **525** was obtained.⁵³⁵ This type of intramolecular exchange was first described by Prelog in 1941.⁵³⁶

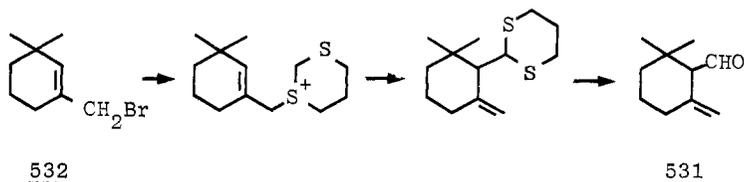


Geranyl cyanide yields 15% of cyclized material with Lewis acid and 2,4,4,6-tetrabromo-2,5-cyclohexadienone,⁵³⁷ and graphite bisulfate is said to favor the formation of the α -acid **526** (R = H),⁵³⁸ though full details are not available. Methyl geranate is cyclized by liquid sulfur dioxide at -70° ⁵³⁹ or by mercuric trifluoroacetate⁵⁴⁰ very efficiently to **526** (R = Me). Breslow's mechanism for the cyclization of geranyl acetate by dibenzoyl peroxide and copper salts (cf. Vol. 2, p. 139 and Ref. 541) has been criticized by Beckwith et al., who point out that a pure radical mechanism should give a 5-membered rather than a 6-membered ring.⁵⁴² An old method for the preparation of the cyclocitral was the treatment of citral anil (**527**) with sulfuric acid at low temperature; the main problem being the separation of the β -isomer **517** (R = H) from an accompanying by-product **528**.⁵⁴³ A practical method for overcoming the difficulty has been given, consisting in avoiding a steam distillation during workup.⁵⁴⁴ The situation during this synthesis is reminiscent of similar difficulties encountered during certain reactions of piperitone (**415**, see p. 000 and Ref. 415). Derived from this synthesis is the treatment of citral pyrrolidine enamine with 90% sulfuric acid at 0° . After hydrolysis, α -cyclocitral (**516**) is obtained.⁵⁴⁵ Using an optically active amine to make the enamine leads to optically active α -cyclo-

citral, L-proline diethylamide, for example, gives (*R*)- α -cyclocitral.⁵⁴⁶ Optically active α -cyclocitral has also been prepared from α -cyclogeranic acid (**526**, R = H), which is readily resolved.⁵⁴⁷ Reduction to the alcohol is straightforward, but the Oppenauer oxidation to the optically active aldehyde **516** requires careful conditions so that the product is rapidly removed from the reaction medium.⁵⁴⁸ The optically active **516** thus obtained was converted to the acid **529**, present in Californian crude oil.⁵⁴⁹

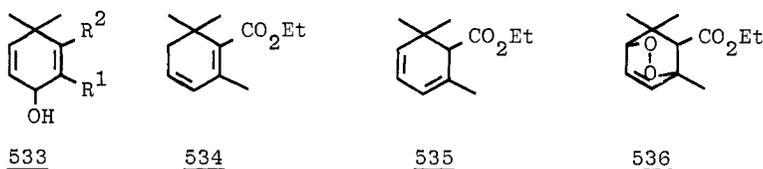
Aside from the cyclization methods of dimethyloctane monoterpenoids, the best method of formation of β -cyclocitral is by ozonolysis of β -ionone (**530**).⁵⁵⁰ The same method using α -ionone to obtain α -cyclocitral is less efficient because both double bonds of the ionone are attacked simultaneously.

Hunt and Lythgoe have described an intriguing method for the preparation of γ -cyclocitral (**531**), β -cyclocitral being obtained from this by base-catalyzed conjugation of the double bond. The bromide **532** is condensed with dithiane, and the sulfonium salt thus obtained is rearranged to the thioacetal of γ -cyclocitral by butyllithium (Scheme 26).⁵⁵¹

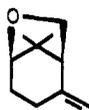
Another type of oxidation of tetrasubstituted cyclohexanes is illustrated by esters of **533** ($\text{R}^1 = \text{Me}$, $\text{R}^2 = \text{CHO}$), the angelate of which has been isolated from *Bupleurum gibraltarium*⁵⁵² and other Umbelliferae.⁵⁵³ Esters of the compound **533** ($\text{R}^1 = \text{CHO}$, $\text{R}^2 = \text{Me}$) have also been found in *Piqueria trinervia* (Compositae).⁵⁵⁴ Access to this type of substance is by oxidation of the anion of ethyl β -safranate (**534**) which occurs in the C(5) position.⁵⁵⁵ Photooxidation of ethyl α -safranate (**535**) has also been examined, and while the main products obtained after reduction of the initially formed peroxide **536** are oxidized at C(3), 22% of a C(5) alcohol is obtained.⁵⁵⁶



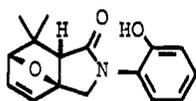
Recently, Mukaiyama et al. have described a seven-step synthesis of karahana ether (**537**) from the amide **538**,⁵⁵⁷ the latter having been made by a organo-

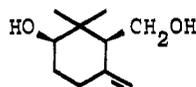
metallically accelerated intramolecular Diels-Alder reaction the same authors described earlier.⁵⁵⁸ This synthesis is long, and does not seem to offer any improvement over the earlier synthesis of Coates and Melvin⁵⁵⁹ (which also involves the *cis*-diol **539** as a key intermediate; cf. Vol. 2, p. 139, and Refs. 431 and 432). On the other hand, nerol (**28**) is cyclized directly to a 15:45 mixture of karahana ether (**537**) and its *endo*-unsaturated isomer with thallium(III) perchlorate.⁵⁶⁰

Before leaving this group, mention should be made of a possible synthetic approach from the pyronenes (540a, 540b), pyrolysis products of α -pinene (245). Various oxidations of α -pyronene (540a) were initiated by Cocker et al. in 1973,⁵⁶¹ then De Pascual Teresa et al. studied the oxidation of both pyronenes at a lower temperature and in a two-phase system which enabled further products to be isolated,⁵⁶² and finally Cocker completed the earlier work with an examination of β -pyronene (540b).⁵⁶³ These oxidations did not, however, lead to natural products.

B. 1,1,3,4-Substituted Cyclohexanes

This is the cyclolavandulol skeleton (Vol. 2, p. 48), cyclolavandulol (541) itself being found as an ether with furocoumarins in *Seseli iliense* (Umbelliferae).⁵⁶⁴ The acid has been isolated again from another species, *Carum roxburghianum*,⁵⁶⁵ but there is nothing new concerning the synthesis.

A deuterium-labeled double-bond isomer 542 of cyclolavandulol has been synthesized.⁵⁶⁶

C. 1,1,2,5-Substituted Cyclohexanes

Esters of the hydroxyaldehyde 543 were isolated from *Ferula hispanica* in 1969,⁵⁶⁷ and Bohlmann suggested the name "ferulol" for this alcohol, further esters of which were isolated later from other umbelliferae.^{552, 553, 568} Two lactones of the group, (-)-filifolide A (544) and (+)-filifolide B (545), together with isophorone (518) and the ketoacid (546) occur in the compositae *Artemisia filifolia* (the skeleton being exaggeratedly called "unique" by the authors).⁵⁶⁹ 1,1,2,5-Tetramethyl-5-cyclohexen-4-one has been found in iris rhizomes.⁵⁷⁰

Bohlmann's synthesis of ferulol (543) consists in oxidizing the Diels-Alder product 547 of propynal and 2,4-dimethyl-1,3-pentadiene with lead tetraacetate. Two products were obtained, 548 and the acetate of ferulol, from which the alcohol 543 was easily obtained.⁵⁷¹

Allylic bromination (*N*-bromosuccinimide) of 2,2,4-trimethyl-3-cyclohexene-carboxylic acid (549) yielded a bromide, which, after losing hydrogen bromide, gave the lactone 544.⁵⁶⁹ More interesting is the conversion of (-)-chrysanthenone (145) to the same lactone. Epoxidation of chrysanthenone was known to give an epoxide,⁵⁷² (the stereochemistry of which had definitely been established as *trans*⁵⁷³), and this epoxide yielded the hydroxyacid 550 with hydroxide ion.⁵⁷² When either chrysanthenone epoxide or 550 are heated, they are converted to (-)-filifolide A (544), thereby proving the absolute stereochemistry of the natural product.⁵⁶⁹ An interesting relationship also exists between 544 and 545. They are interconverted by gas chromatography, but not by steam distillation, whereas the corresponding hydroxyacids, 550 and 551,

are interconverted by steam distillation. These facts enabled the absolute configuration of **545** also to be established.⁵⁶⁹

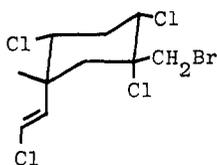
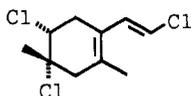
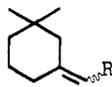
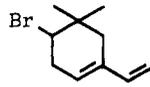
The formation of the isomer **552** of **547** by base-catalyzed condensation of two molecules of 3-methyl-2-butenal has been recently reinvestigated, and several dihydro compounds of **552** were prepared.⁵⁷⁴

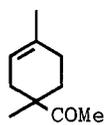
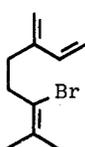
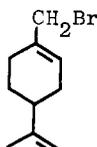
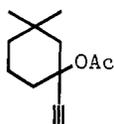
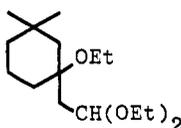
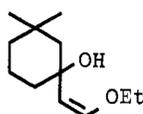
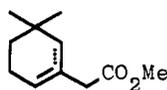
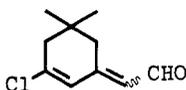
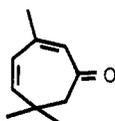
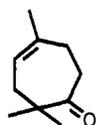
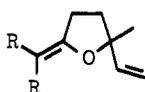
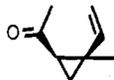
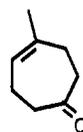
12. THE DIMETHYLETHYLCYCLOHEXANES

This small group of compounds comprises four carbon skeletons. Violacene (**533**, revised structure⁵⁷⁵), isolated from the red alga *Plocamium violaceum*,⁵⁷⁶ is a 1,3-dimethylethylcyclohexane. Plocamene B, (**554**) isolated from the same alga,⁵⁷⁷ is a 2,4-dimethylethylcyclohexane. The 3,3-dimethylethylcyclohexane skeleton of the boll weevil pheromone constituents **555** (R = CHO or CH₂OH) is the same as that of a brominated terpenoid **556** isolated from the seaweed *Desmia (Chondrococcus) hornemanni*;⁵⁷⁸ other marine terpenoids with this skeleton are known⁵⁷⁹ but not synthesized. Finally the ketone **557**, isolated from *Juniperus communis*,⁵⁸⁰ is a 1,4-dimethylethylcyclohexane.

The first two compounds, **553**, **554** have not yet been synthesized. The ketone **557** is readily made by the stannic chloride-promoted Diels-Alder reaction between isoprene and 3-methyl-3-buten-2-one,⁵⁸¹ a six-step synthesis from diethyl 4-acetyl-4-methylheptane-1,7-dicarboxylate also having been described.⁵⁸² The bromide **556** has been synthesized by the brominative cyclization of myrcene (**6**) using 2,4,4,6-tetrabromo-2,5-cyclohexadienone, when **558** and **559** are the major by-products.⁵⁸³

The major synthetic effort in this group is thus concentrated on the boll weevil pheromones. Many routes require 3,3-dimethylcyclohexanone as a key intermediate. Pelletier and Mody prepared this substance by the copper-catalyzed Grignard addition to 3-methyl-2-cyclohexenone. Subsequent addition of acetylene and acetylation yielded **560**, from which the two stereoisomeric aldehydes **555** (R = CHO) were obtained using silver carbonate in acetic acid then hydrolysis. The alcohols **555** (R = CH₂OH) were obtained by borohydride reduction of the aldehydes.⁵⁸⁴ A variant of the route consists in using the zinc chloride-catalyzed addition of ethyl vinyl ether to the acetal of 3,3-dimethyl-

cyclohexanone. This yields **561**, from which the aldehydes **555** (R = CHO) are obtained by treatment with sodium acetate in acetic acid and pyrolysis.⁵⁸⁵

Several other methods involving 3,3-dimethylcyclohexanone have been published. The original synthesis used a Reformatsky reaction which led to the corresponding esters **555** (R = CO₂Et). These were then reduced with lithium aluminum hydride to the alcohols **555** (R = CH₂OH), from which the aldehydes are accessible with manganese dioxide.⁵⁸⁶ Vig et al. used a modified Wittig reaction (ethyl trimethoxyphosphonoacetate),⁵⁸⁷ as did Babler and Mortell (diethylcyanomethylphosphonate; these authors also made their 3,3-dimethylcyclohexanone from *m*-methylanisole)⁵⁸⁸. Less convenient reagents are the dihydro-1,3-oxazine reagent of Meyers et al. (which additionally gave an *endo*-double bond isomer of **555**, R = CHO)⁵⁸⁹ and the acetaldehyde equivalent, (*Z*)-2-ethoxyvinyl lithium, of Wollenberg and Pereis. The product **562** of this reaction is converted to **555** (R = CHO) by silica gel.⁵⁹⁰ Alkylation of 3,3-dimethylcyclohexanone with *O*-ethyl *S*-ethoxycarbonylmethyl dithiocarbonate leads stereoselectively to the (*E*)-isomer of **555** (R = CO₂Et).⁵⁹¹ Apart from being economically more attractive, the synthesis of Bedoukian and Wolinsky is interesting in that it follows what is believed to be a biogenetic route. γ -

Geraniol (**54**) may be the precursor of all the boll weevil pheromones since, depending on the mode of cyclization, either grandisol (**251**) or **555** ($R = \text{CHO}$ or CH_2OH) can be obtained. In this synthesis, methyl γ -geranate (the ester of **72**) made by deconjugation of geranic acid (**56**) is cyclized with polyphosphoric acid to yield the *endo*-unsaturated esters **563**. The double bond was brought into conjugation with the ester group by brominating (HBr) and dehydrobrominating (triethylamine), when the alcohols **555** ($R = \text{CH}_2\text{OH}$) were made as before.⁵⁹² Another cyclization, this time of 3,7-dimethyl-1,6-octadiene, leading to the 3,3-dimethylethylcyclohexane skeleton, but not, however, to the natural products, has been described.⁵⁹³ The most straightforward synthesis is probably that of Hoffmann and Müller, who carried out a Vilsmeier reaction (formamide and phosphorus oxychloride) on isophorone (**518**) to obtain the imine of **564**. This was converted to the aldehydes **555** ($R = \text{CHO}$) with sodium perchlorate or sodium iodide.⁵⁹⁴ This approach has also been used by Traas, Boelens, and Takken, who found that the chloroaldehyde **564** can be reduced directly to the aldehydes **555** ($R = \text{CHO}$) over a poisoned palladium on charcoal catalyst.⁵⁹⁵ These authors have also used an alternative route from isophorone (**518**), which involves reduction with sodium dihydrobis (methoxyethoxy)aluminate and dehydration before the Vilsmeier formylation.⁵⁹⁶

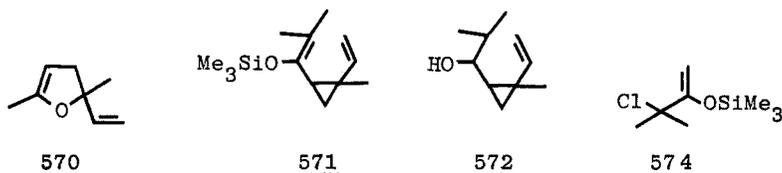
13. THE CYCLOHEPTANES

A. Trimethylcycloheptanes

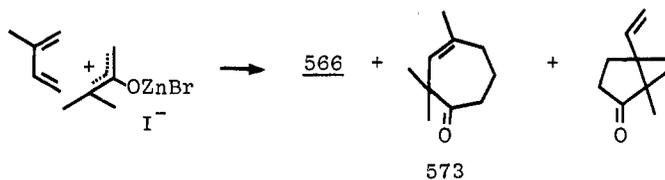
In addition to the compounds described in Vol. 2 (p. 140), the doubly unsaturated ketone **565** has been isolated from pepper oil³⁷² and, together with karahanaenone (**566**) and the alcohol corresponding to **566**, from *Cupressus sempervirens*.⁵⁹⁷

Thermolytic rearrangement of 2-methyl-2-vinyl-5-isopropylidenetetrahydrofuran (**567**, $R = \text{Me}$) leads directly to karahanaenone (Vol. 2, p. 142) and reactions that might lead to some **567** ($R = \text{Me}$) usually have **566** present in the products.⁵⁹⁸ *cis*-1-Acetyl-2-methyl-2-vinylcyclopropane (**568**) rearranges thermally to 4-methyl-4-cycloheptenone (**569**), and so does 2,5-dimethyl-2-vinyl-2,3-dihydrofuran (**570**). Rhoads has shown that the two reactions are independent, **570** passing through an intermediate **567** ($R = \text{H}$) homologous to that of the karahanaenone synthesis.⁵⁹⁹ The possibility that the acetylvinylcyclopropane synthesis passes through an enol intermediate was discussed by Rhoads,⁵⁹⁹ and this approach has in fact been carried out by Wender and Filosa, who prepared the trimethylsilyl enol ether **571** conventionally from the alcohol **572** of the Grignard reaction between 2-methyl-2-vinyl-cyclopropyl lithium and

isobutanal. Karahanaenone (**566**) was obtained by thermolysis of **571** followed by desilylation (butyllithium in tetrahydrofuran at 25°).⁶⁰⁰



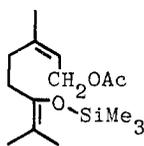
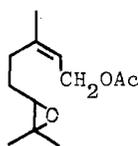
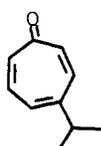
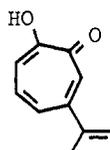
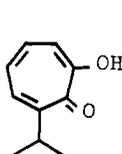
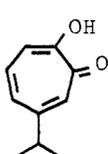
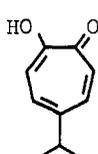
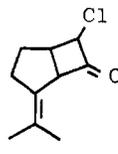
Cycloheptene carbocations can be constructed by the cycloaddition of an allyl carbocation to a diene (see the review by H. M. R. Hoffmann,⁶⁰¹ for example), and Hoffmann has synthesized karahanaenone (**566**) in this way from a carbocation prepared by the action of a zinc-copper couple on 3-bromo-1-iodo-3-methyl-2-butanone and isoprene under various conditions. The yields were just over 50%, and considerable amounts of two other by-products (one, **573**, the product of inverse addition of isoprene) were formed (Scheme 27).⁶⁰² The dihaloketones can also be activated with $\text{Fe}_2(\text{CO})_9$, and examples of syntheses of this nature are described in the next section (thujaplicins). A similar approach was followed by Shimizu and Tsuno, who made the trimethylsilyl enol ether (**574**) of 2-chloro-2-methyl-3-butanone, forming the carbocation with silver perchlorate. In this case, the proportion of karahanaenone (**566**) to **573** was 2.5:1.⁶⁰³

The direct cyclization of a nerol derivative was effected by Hashimoto et al.; this consisted in treating the trimethylsilyl ether **575** with methylaluminum bis(trifluoroacetate). The ether **575** was made by opening neryl acetate epoxide (**576**) with hydrogen bromide to give the bromohydrin, then oxidation and treatment of the bromoketone with zinc in trimethylsilyl chloride.⁶⁰⁴ A recent modification using titanium complexes has led to a synthesis of nezukone (**577**, see below).

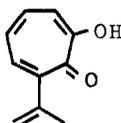
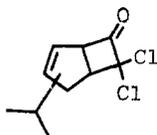
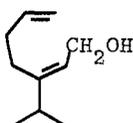
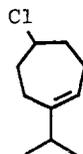
It is clear that none of these methods really represents a synthesis for its own sake; they are used to illustrate a principle of cyclization—but are possibly more use for the preparation of sesquiterpenes.

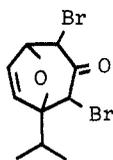
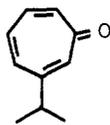
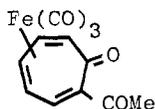
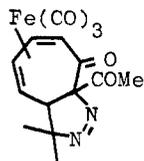
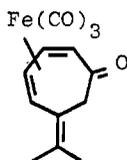
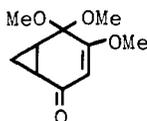
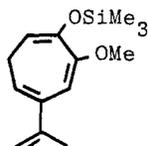
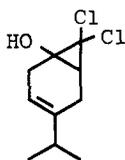
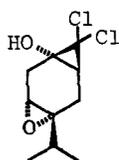
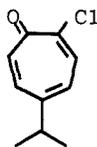

B. Isopropyl- and Isopropenylcycloheptanes

In addition to nezukone (577) and the thujaplicins, described in Vol. 2, p. 143, a member of the group that was not mentioned is β -dolabrin (578) isolated from *Thujaopsis dolabrata*.⁶⁰⁵

This group of compounds was not given extensive treatment in Vol. 2, so a brief summary of early syntheses will be given. The first syntheses of α - (579), β - (580 = "hinokitiol"), and γ -thujaplicin (581) consisted in the bromination of cycloheptane-1,2-diones, followed by dehydrobromination,^{606,607} or oxidation of isopropylcycloheptatrienes, the latter being made by the ring expansion of benzenes (diazomethane and irradiation).⁶⁰⁸ Later, Asao et al. attempted to synthesize β -dolabrin by the action of potassium acetate or tetramethylammonium acetate on the product 582 of the [2 + 2] addition of chloroketene to dimethylfulvene, but unexpectedly, the main product was α -dolabrin (583), although small amounts of the β -isomer were obtained when the product derived from dichloroketene was used. By reduction of 583, they were able to synthesize α -thujaplicin (579).⁶⁰⁹ The [2 + 2] cycloaddition of dichloroketene to

isopropylcyclopentadienes (mixture of isomers) gives a mixture of isomers **584**, the isopropyl group being attached at C(1), C(2), and C(3), treatment of which with potassium acetate in acetic acid yields a mixture of β - (**580**) and γ -thujaplicins (**581**).⁶¹⁰

The [4 + 3] cycloadditions mentioned in the previous section were used by Noyori et al. to make isopropylcycloheptanes of this series.⁶¹¹ The method required reaction of tetrabromoacetone with 2-isopropylfuran, for example, in the presence of iron nonacarbonyl, $\text{Fe}_2(\text{CO})_9$, when the dibrominated cycloheptene oxide **585** is formed. Hydrogenation removes the bromine atoms, and boron trifluoride etherate removes the ether. Bromination (*N*-bromosuccinimide) and dehydrobromination (lithium in dimethylformamide) give the isomer **586** of nezukone, which was converted to β -thujaplicin (**580**) by known techniques (hydrazine hydrate followed by potassium hydroxide).⁶¹² By a similar route from 3-isopropylfuran (though with some improvements in the later stages), they prepared nezukone (**577**).⁶¹³ The synthesis of α -thujaplicin

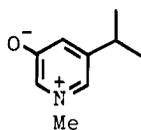
(579) starting from 1,1,1,3-tetrabromo-4-methyl-2-pentanone and furan has also been described (together with further details about the synthesis of the other products of the series).⁶¹⁴

Cyclization of the allyl alcohol 587 using a complex formed from methylamine and titanium tetrachloride gave a chloride 588 that was converted to nezukone (577).⁶¹⁵

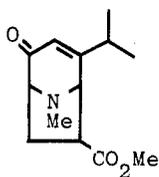
In one of Noyori's papers⁶¹² it is pointed out that there was at that time no way of introducing the isopropyl group into tropone site-specifically. Now Franck-Neumann et al. have supplied this deficiency with syntheses of β -thujaplicin (580) and dolabrin (578). The key step in these syntheses is the addition of 2-diazopropane to the complex 589, readily prepared from tropone. The resulting pyrazoline 590 undergoes loss of nitrogen and β -ketone hydrolysis in refluxing ethanol containing potassium carbonate, and the resulting complex 591 forms the material for synthesizing both 580 and 578. Removal of the iron (trimethylamine oxide) and conjugation of the double bond with potassium carbonate gives the ketone 586, which has already been converted to β -thujaplicin (580). Alternatively, oxidation of 591 (MnO_2) before removal of the iron gives the ketone 586, but having an isopropenyl side chain, from which β -dolabrin (578) can be obtained by the hydrazine hydrate method.⁶¹⁶

Evans has developed a synthesis of β -dolabrin (578) that depends on ring expansion of a cyclohexenone. The action of oxosulfonium methylide on 3,4,4-trimethoxy-2,5-cyclohexadien-1-one gives the cyclopropane 592, the key intermediate to a variety of monocyclic tropolones. The side chain is introduced by a Grignard reaction, then potassium hydride in tetrahydrofuran, followed by trimethylchlorosilane gives the cycloheptatriene 593, from which β -dolabrin is obtained after oxidation (chloranil) and treatment with boron tribromide.⁶¹⁷ Another method involving a somewhat similar type of ring enlargement is that of Macdonald. Dichlorocarbene is added to the Birch reduction product of the triethylsilyl ether of 4-isopropylphenol. After desilylation, the product 594 is epoxidized, and the epoxide 595 treated with a trace of *p*-toluenesulfonic acid in refluxing benzene. The chlorocycloheptatrienone 596 thus obtained gives γ -thujaplicin (581) with aqueous phosphoric acid in refluxing acetic acid. By a similar route from the trimethylsilyl ether of 3-isopropylphenol it is possible to synthesize β -thujaplicin.⁶¹⁸

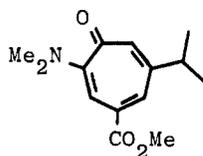
Betains were suggested as sources of tropolones by Katritzky et al.,⁶¹⁹ and Tamura et al. have synthesized β -thujaplicin from the betain 597. Addition of methyl methacrylate to 597 gives the bicyclic compound 598, the methiodide of which is cleaved by sodium carbonate to 599. The hydrochloride of the latter gives the corresponding tropolone with potassium hydroxide, and decarboxylation to 580 is effected by copper chromite in quinoline.⁶²⁰



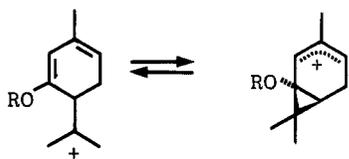

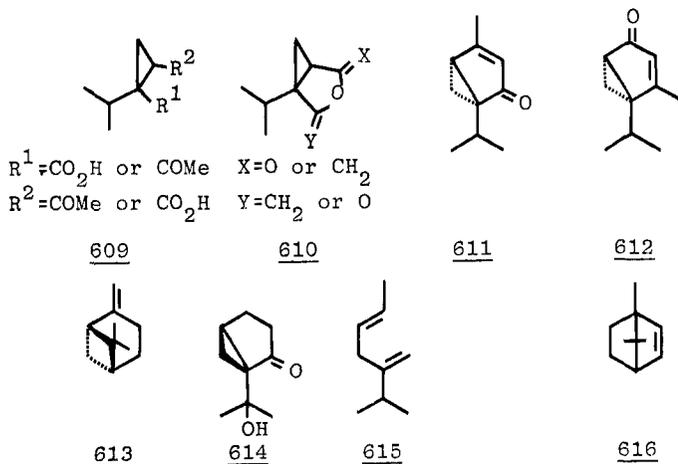
14. BICYCLO[3.2.0]HEPTANES

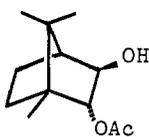
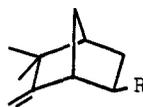
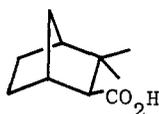
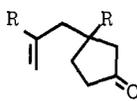
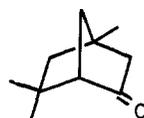
Ocimenone (132) is converted to filifolone (144) by the action of aluminum chloride,¹⁶¹ and it was suggested that the route involves the ions 600, already proposed as intermediates in the formation of filifolone from chrysanthenone (145).⁶²¹ In their exhaustive examination of the possible routes to filifolone that such rearrangements might take, Erman et al. excluded a possibility that passed through a cycloheptene intermediate. In this connection, it is interesting that Capellini et al. found no substances with the bicyclo[3.2.0]heptane skeleton when they examined the solvolysis of 2,2,5-trimethyl-4-cycloheptenyl esters, but only menthane derivatives.⁶²²

15. BICYCLO[3.1.0]HEPTANES, THE THUJANES

A problem of nomenclature exists in this group. Some years ago, Brown et al. proposed that, as for comparable menthane derivatives, the prefix "iso-" be reserved for compounds having a *cis*-orientation of the methyl and isopropyl groups.⁶²³ Most authors adhere to the principle now, but not all, and notably the review by Whittaker and Banthorpe⁶²⁴ about the group employs the opposite convention (as these authors have continued to do in their publications). We use Brown's logical suggestion in this chapter, as we did in Vol. 2.

The group is widely distributed, and the thujones (601a, and isothujone 601b) are often believed to be associated with pharmacological activity,⁶²⁵ but syntheses are very rare. Large amounts of isothujone (601b) are present in *Thuja plicata*, and it is possible to convert this to thujone (601a).⁶²⁶ Sabinene (602) and the two isomers of sabinene hydrate (603) are also widely distributed, generally in small amounts.

Alexandre and Rouessac prepared the cyclopentanone **604** by a fairly long route from methyl 1-isopropyl-3-cyclohexenylcarboxylate, then cyclized **604** to the bicyclic ketone **605** ($R = H$) with dicyclohexylcarbodiimide.⁶²⁷ A more rapid synthesis is that of Gaoni, who found that the epoxide (**606**) of 4-isopropylidencyclohexanone was converted to **605** ($R = OH$) with ethanolic sodium hydroxide, although the preparation of the isopropylidencyclohexanone requires further stages.⁶²⁸ 3-Isopropyl-2-cyclopentenone (the cyclization product of 6-methylheptane-2,5-dione), on treatment with excess sulfoxonium methylide yields a mixture of the two sabinene epoxides (**607**), making the sabinene hydrates (**603**) available by this route.⁶²⁹

These methods all depend on the formation of the cyclopropane ring from a cyclopentane or cyclohexane; another method starts with the cyclopropane in the form of the anhydride (**608**) of 1-isopropylcyclopropane-1,2-dicarboxylic acid. Reaction with lithium dimethylcuprate now yields a mixture of two isomeric ketoacids **609**, which cyclize with acid, to **610**. These substances are then allowed to react with the anion of diethyl methylphosphonate, to yield the natural product umbellulone (**611**) and its isomer **612**.⁶³⁰

There is one interesting conversion of the pinane skeleton to a "northujane." During a conventional oxidation of β -pinene (**613**) using the von Rudloff reagent, Jefford et al. observed the formation of the ketol **614**. They were able to dehydrate this to the corresponding isopropenyl derivative with thionyl chloride in pyridine.⁶³¹ If this method could be made more reliable and to work in higher yield, it would truly be a breakthrough so far as access to the bicyclo[3.1.0]hexane system is concerned.

Salvan (**615**), the photolysis product from thujone (**601a**) has been synthesized by Sharma and Aggarwal; the synthesis is conventional except for the use of the nonconjugated 3-pentenal in a Grignard reaction with isopropyl-

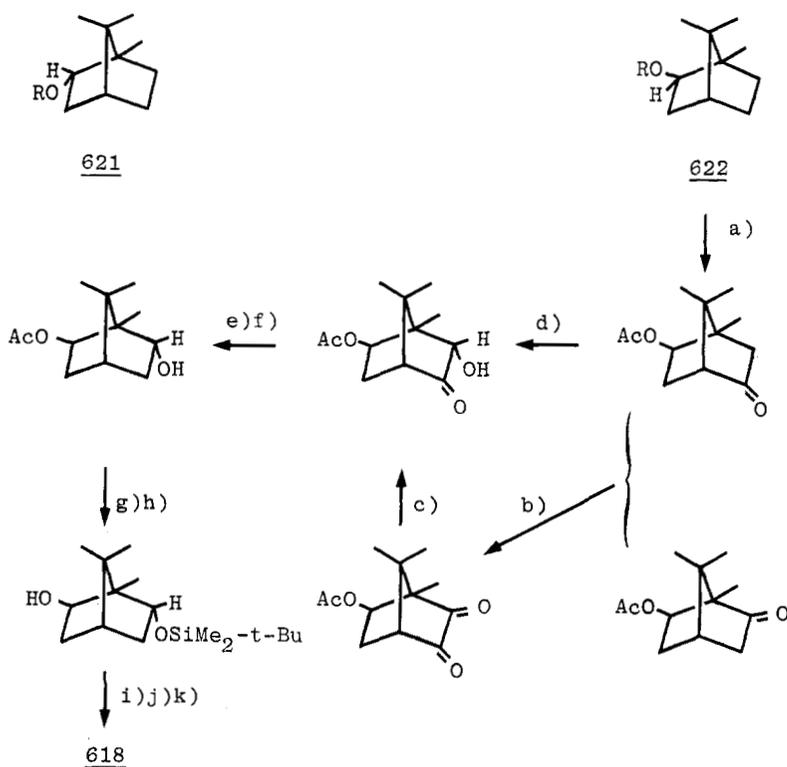
magnesium iodide. Oxidation of the product and Wittig reaction to introduce the methylene group yielded salvan (**615**).⁶³²

16. BICYCLO[2.2.1]HEPTANES

Apart from many esters of borneol, the following bornane derivatives have been announced recently as natural products. Bornylene (**616**) has been found in *Abies alba* needles.⁶³³ It has been known for many years, and the best synthesis is probably by the action of butyllithium on camphor *p*-toluenesulfonylhydrazone.⁶³⁴ The monoacetate (**617**) of *trans*-bornanediol, isolated from *Artemisia vulgaris* has been named vulgarol.⁶³⁵ The bornanediols are also well known, but a recent description of the physical properties includes adequate references for the synthesis.⁶³⁶ The hydroxylated camphene nojigiku alcohol (**618**) has been isolated from *Chrysanthemum japonese*.⁶³⁷

The racemate of **618** had been known at least since it was prepared by Lipp in 1947 by the reaction of phosphorus tribromide on tricyclol (**619**), followed by alkaline treatment of the resulting bromide **620** (R = Br).⁶³⁸ Other subsequent syntheses of the racemate followed a closely paralleled route, Sukh Dev using the action of *N*-bromosuccinimide on tricyclene to arrive at the same bromide **620** (R = Br),⁶³⁹ While the chlorination of camphene (**620**, R = H) followed by the action of acetate gave an acetate, which, after several incorrect structures had been discussed, finally turned out to be **620** (R = Ac).⁶⁴⁰ The first synthesis of the optically active material was by Julia et al., although they did not claim it to be a very efficient route for large amounts. This synthesis was interesting for a second reason, since it depended on the remote oxidation of (+)-camphene (**620**, R = H) using *t*-butyl perbenzoate in the presence of copper salts. Since the product, after treatment with potassium hydroxide, was optically active (+)-nojigiku alcohol (**618**), it must have been formed directly and not via tricyclol (**619**).⁶⁴¹ More detailed work on the remote oxidation of bornyl acetate (**621**, R = Ac) by chemical and microbiological means (using *Helminthosporium sativum* and *Fusarium culmorum*) was carried out by Money et al., who isolated various 3- and 5-oxygenated compounds,⁶⁴² following this up with a synthesis of (+)-nojigiku alcohol (**618**) from isobornyl acetate (**622**, R = Ac, Scheme 28).⁶⁴³

There was a slight confusion in the literature owing to an incorrect interpretation of the relationship between optically active isocamphanic acid (**623**) and camphene (**620**, R = H).⁶⁴⁴ This error has been carefully corrected, (+)-isocamphanic acid (**623**) having been synthesized from the Diels-Alder product of cyclopentadiene and mesityl oxide (Vol. 2, p. 151), resolved,⁶⁴⁵ and after its structure was confirmed by X-ray crystallographic work, converted by a Cope reaction of the corresponding amine to (-)-camphene (the enantiomer of **620**,

$\text{R} = \text{H}$).^{646, 647} This work also produced the (-)-camphene with the highest recorded rotation.⁶⁴⁷

The full paper about Money's synthesis of racemic camphor (Vol. 2, p. 152) by treatment of dihydrocarvone (401) enol acetate with boron trifluoride has appeared,⁶⁴⁸ soon after, Lange and Conia showed that simple pyrolysis of optically pure dihydrocarvone (401) yields camphor (624) which is 80% optically pure.⁶⁴⁹ More recently, Wolff and Agosta heated the cyclopentanone 625 ($\text{R} = \text{Me}$) for 6 hours at 375° and obtained 71% of (\pm)-epiisofenchone (626), the simpler compound 625 ($\text{R} = \text{H}$) yielding 6-endo-methyl-2-norbornanone.⁶⁵⁰

The old principle of formation of a bicyclo[2.2.1]heptane by solvolysis of a 3-cyclopentenylethyl tosylate⁶⁵¹ was the basis of a synthesis of norcamphor

from the tosylate **627**, which cyclizes via the enol to the extent of 3% in acetic acid, but 74% if urea is added.⁶⁵² This is also the principle of Cocker's synthesis of (+)-fenchone (**515**), although the starting material was (+)- α -pinene epoxide (**628**), the first step being the pinane-bornane rearrangement to **629**. Cleavage of the latter with silver acetate led to the aldehyde **630**. By conventional means, this was converted to the chloroketone **631**, which cyclized with ethoxide

ion.⁶⁵³ This is scarcely a "total" synthesis except indirectly.* Another interconversion from another monoterpenoid by ring opening to a suitable cyclopentene and ring closing was employed by Gream et al. to make high optical purity (-)-camphene from borneol (621, R = H); in the course of this work (related to bornyl carbonium ions) they also examined the conversion of isoborneol (622, R = H) to (+)-camphene (620, R = H).⁶⁵⁴

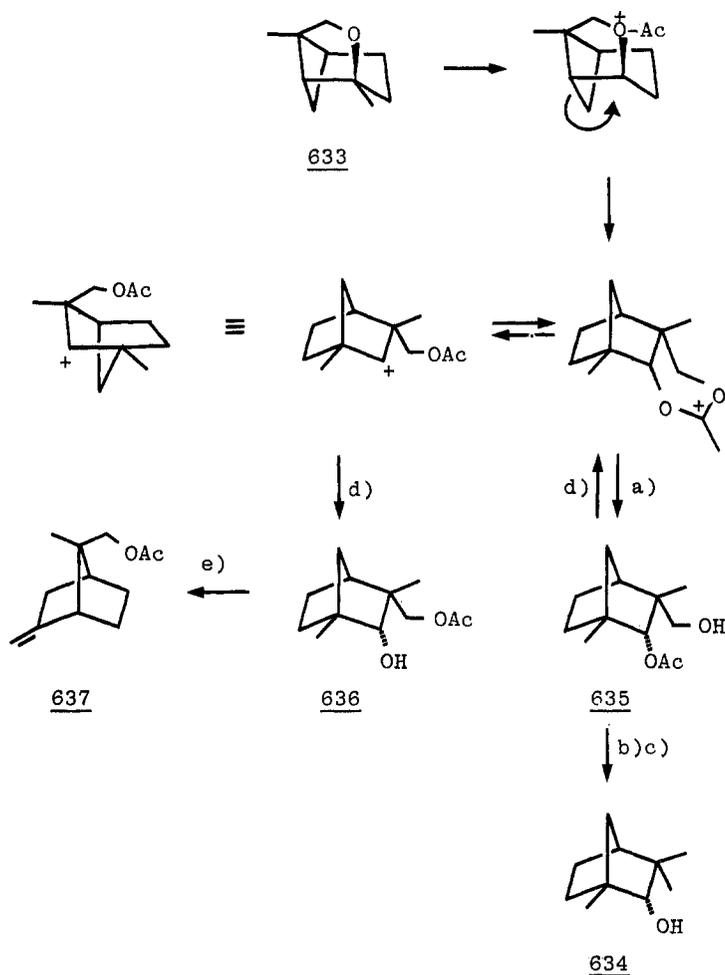
The classical rearrangements of pinyl ions (632) to bornanes (migration of bond a) or fenchanes (migration of bond b) are well-known entries to the two latter groups. One of us has evaluated the steric conditions necessary for migration of a or b,⁶⁵⁵ and the alternatives between the two migrations and ring opening in the case of ions generated by the action of *p*-toluenesulfonic acid or zinc bromide on pinane 2-*trans*,3-*trans*-diol have been described by Pascual Teresa.⁶⁵⁶ The situation has been extensively discussed by Whittaker et al.⁶⁵⁷ More unusual is the rearrangement of the oxide 633 (prepared by Gibson and Erman⁶⁵⁸). This reaction has been studied by Bosworth and Magnus⁶⁵⁹ and Grison and one of us,⁶⁶⁰ in both instances the aim was to produce substances suited for elaboration to sesquiterpenes, although both described the synthesis of α -fenchol (634). A limited amount of acetic anhydride in the presence of boron trifluoride causes the oxide 633 to rearrange, giving the primary alcohol 635 as the major product, and lithium aluminum hydride reduction of the tosylate of 635 yields α -fenchol (634). The alcohol 635 is, however, unstable on prolonged treatment with acid (e.g., excess acetic anhydride and boron trifluoride, or reflux with carbon tetrachloride), and is readily converted to the secondary alcohol 636, acetolysis of which yields the acetate 637 by a second rearrangement (Scheme 29).

Camphor (624) has been synthesized in one step from the dibromide 638 using $\text{Fe}_2(\text{CO})_9$ at 100-110°.⁶⁶¹

A number of compounds related to the long-known santene (639)⁶⁶² have been described. Demole et al. have isolated several of these, including santalene (640, R = COMe), 640 (R = CHO), and 641, from the top fraction of sandalwood oil (*Santalum album*).⁶⁶³ The aldehyde 640 (R = CHO) was made from the well-known teresantalol (640, R = CH₂OH)⁶⁶² by oxidation. Photooxygenation of santene (639) followed by reduction of the hydroperoxide yielded the alcohol 641. The latter had probably already been isolated by Müller in 1900,⁶⁶⁴ but not recognized.

An interesting compound identified by Demole was 642. This is the Wagner-Meerwein precursor of santenol (643), traditionally believed to occur in sandalwood oil, but which Demole did not find. 642 was made by hydroboration of santene (639), and there was no doubt about which isomer it was, all isomers

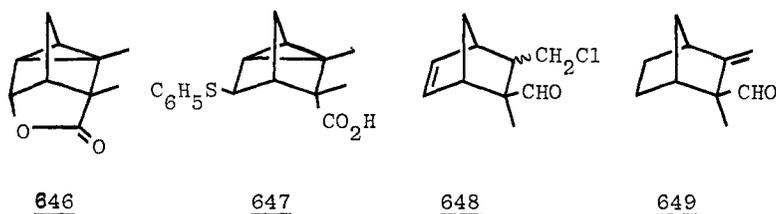
- a) BF_3 /limited Ac_2O ; b) TsCl/pyr ; c) LiAlH_4 ;

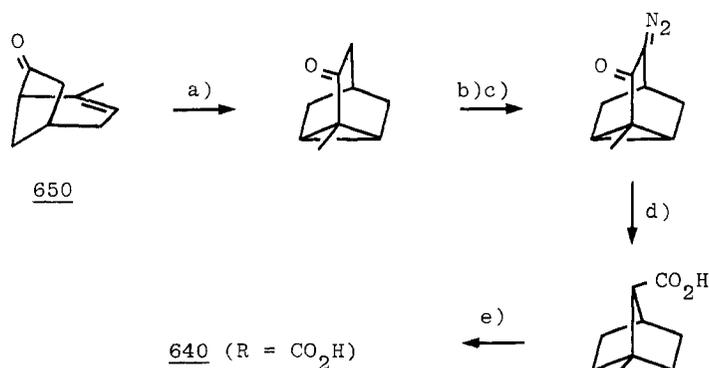
having been described by Beckmann and Geiger in 1961.⁶⁶⁵ Another hydrated santene **644** was suspected in *Cymbopogon jawarancusa* (a type of lemon grass), but not completely identified.⁶⁶⁶ A synthesis of teresantalol (**640**, $\text{R} = \text{CH}_2\text{OH}$) uses the classical Diels-Alder way of making the bicycloheptane unit, but with the modification of having the allene, 2-methyl-2,3-butadienoic acid, as the dienophile. The product of the reaction with cyclopentadiene is a mixture of the *exo*- and *endo*-acids **645**. The *endo*-acid was separated by iodolactonization

and regenerated with zinc, then formic acid yielded the tricyclene lactone **646**. Reduction of the ester of the acid **647** obtained by the action of sodium thiophenate on **646**, first with lithium aluminum hydride, then with Raney nickel, yielded teresantalol (**640**, R = CH₂OH).⁶⁶⁷

4-Chloro-2-methylbutenal is an intermediate in one industrial route to vitamin A and other polyenes,⁶⁶⁸ and it reacts readily in a Diels-Alder addition both thermally and by Lewis acid catalysis with cyclopentadiene. The product **648** was hydrogenated and the dimethyl acetal of the saturated chloride dehydrochlorinated (potassium *t*-butoxide in dimethyl sulfoxide) to yield the aldehyde **649**,⁶⁶⁹ which might also be a component of sandalwood oil.⁶⁶³



Teresantalic acid (**640**, R = CO₂H) has also been known as a constituent of sandalwood oil for a very long time, but syntheses are extremely rare. Now Monti and Larsen have made the racemate from the ketone **650**, the compound obtained by cyclization of 4-methyl-3-cyclohexenylacetic acid with trifluoroacetic anhydride. This synthesis is illustrated in Scheme 30,⁶⁷⁰ the same authors have used the same starting material to synthesize racemic α -pinene (**245**) (below).



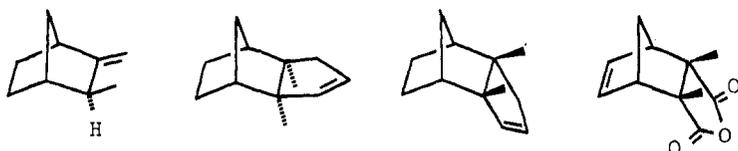
- a) $h\nu$, acetone; b) NaH/HCO₂Et; c) tosyl azide/Et₃N;

exo-Isosantene (**651**), not known to be naturally occurring, is difficult to synthesize. Now Castanet and Petit have found that treatment of 2-methylene-norbornane with palladium chloride yields 90% of the *exo*-methylated product **651**.⁶⁷¹

Albene, now known to have the structure **652** was first isolated from plants of the genera *Petasites* and *Adenostyles*,⁶⁷² and in 1972 was attributed the formula **653**,⁶⁷³ apparently confirmed by the preparation of a ketone which could also be obtained from albene.⁶⁷⁴ In 1977 Kreiser et al. showed that something was wrong with this structure, and, after many difficulties, synthesized **653**, which was not identical with the natural product, and which they named isoalbene.⁶⁷⁵ The synthesis started with the (difficult) Diels-Alder reaction between cyclopentadiene and dimethylmaleic anhydride, yielding **654**. This was converted via the dinitrile **655** ($R^1 = CH_2CN$, $R^2 = Me$) to the ketone **656**. Later

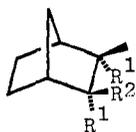

the ketone **656** was made by methylation of the more readily available ester **655** ($R^1 = \text{CO}_2\text{Me}$, $R^2 = \text{H}$)⁶⁷⁶. The benzyl thioenol ether **657** (following a method of Barton⁶⁷⁷) had the stereochemistry confirmed by X-ray crystallography, and it was found that the hydrocarbon obtained after desulfurization with Raney nickel was not albene, but isoalbene (**653**).⁶⁷⁸ Kreiser then synthesized the correct structure **652** from camphenilone (**658**), following in fact a route that was fairly close to that described by Lansbury⁶⁷⁴ in the earlier work. Grignard reaction made available the chloride **659**, and treatment of this with formic acid gave the ketone **660** ($R = \text{COMe}$)—this was the step where the rearrangement invoked by Lansbury had involved a different stereochemistry. Oxidation with trifluoroacetic anhydride and hydrogen peroxide gave a mixture of the acetate **660** ($R = \text{OAc}$) and the acid **660** ($R = \text{CO}_2\text{H}$), lead tetraacetate oxidation of which yielded albene (**652**).⁶⁷⁹

We cannot pretend to have listed the entire literature of labeled terpenoids of this series, which is voluminous, but the following will give key references. All the ¹⁴C-methyl-labeled camphors have been made,⁶⁸⁰ as has ¹⁴C(8)-camphene⁶⁸¹. Various deuterium-labeled camphors (in the C(8) methyl group)⁶⁸² and C(8)-deuterated camphene have been described.⁶⁸³ Exchange reactions of various ketones of the series have been further examined,⁶⁸⁴ and a series of deuterated alcohols (borneols and fenchols) has been made from α -pinene.⁶⁸⁵ A synthesis of 3,3-difluorocamphor is also reported.⁶⁸⁶

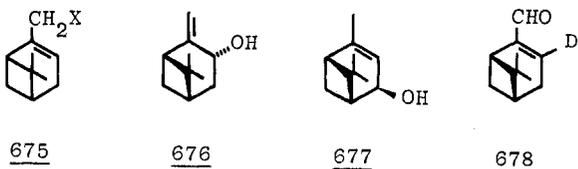
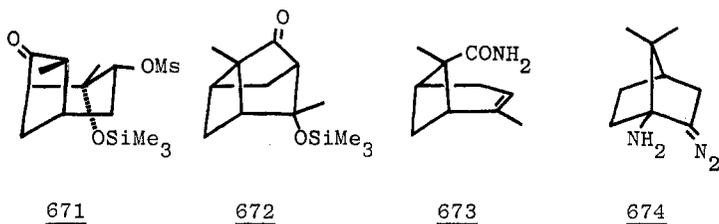
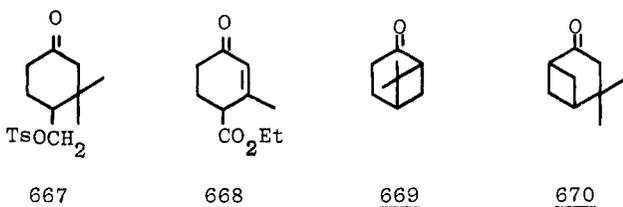
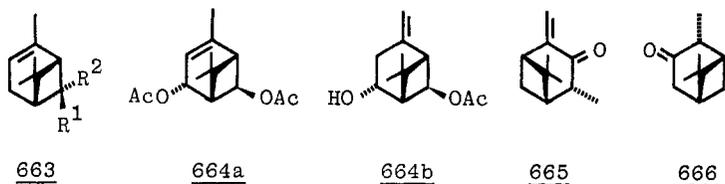
17. BICYCLO[3.1.1]HEPTANES

The United States production of turpentine is around 95,500 tonnes annually (sulfate) and 9000 tonnes (wood), making the pinene skeleton by far the most commonly available from natural sources. Somewhat over half of this is converted to "synthetic" pine oil (mostly α -terpineol) and camphene. The former is used in soaps and the latter as a starting material for insecticides. Much of the remainder is used in the manufacture of the so-called "fine" terpene chemicals. linalool, geraniol, citral, etc.* It is thus not too surprising that there are still only very few syntheses of the pinane skeleton.

Recent novel terpenoids belonging to the group are the glycoside paeoniflorin (**661**) from Chinese paeony root (*Paeonia albiflora*),⁶⁸⁷ where it is accompanied by albiflorin (**662**).⁶⁸⁸ *cis*-Chrysanthenyl glucoside (**663**, $R^1 = \text{O-glucose}$, $R^2 = \text{H}$) has been found in *Dicoria canescens*,⁶⁸⁹ and the corresponding acetate **663** ($R^1 = \text{OAc}$, $R^2 = \text{H}$) in the Australian Compositae *Centipeda cunninghamii*.⁶⁹⁰ *trans*-Chrysanthenyl acetate (**663**, $R^1 = \text{H}$, $R^2 = \text{OAc}$) occurs in two species of *Chrysanthemum*.⁶⁹¹ Two hydroxylated *cis*-chrysanthenyl acetates

(**664a** and **664b**), together with chrysanthenol and the corresponding ketone have been isolated from *Diotis maritima*.⁶⁹² A homoterpenoid, **665**, has been reported in *Artemisia annua*,⁶⁹³ but the NMR data are somewhat sketchy and no stereochemistry was given; it was stated, however, that the NMR spectrum resembled the data given for the *trans*-isomer (**665**, as shown), which one of us had already synthesized from *trans*-pinocamphone **666** by making, first, the hydroxymethylene derivative, then reducing with formaldehyde.⁶⁹⁴

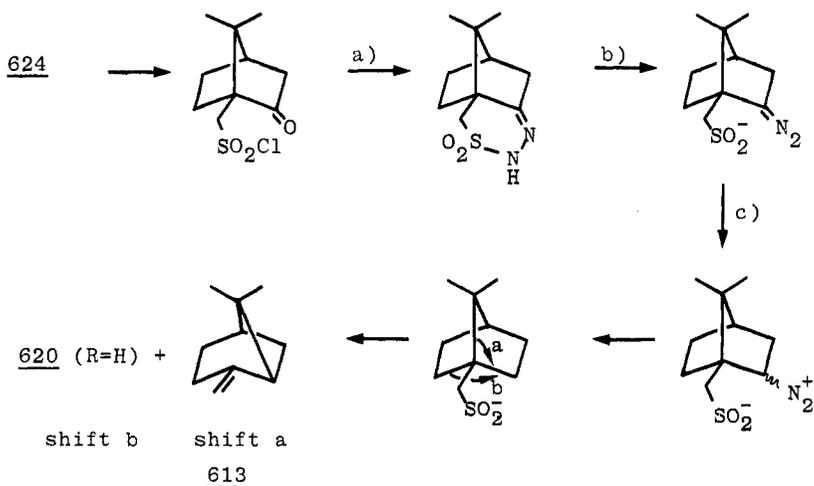


The first direct total synthesis of the pinenes was described by M. T. Thomas and Fallis in 1973.⁶⁹⁵ It consists in cyclizing the tosylate **667**, prepared from Hagemann's ester (**668**) after protection of the keto group as a thioketal, lithium

aluminum hydride reduction, addition of the extra methyl group by copper-catalyzed Grignard addition, and deprotection of the keto group using mercuric chloride and cadmium carbonate in acetonitrile. The cyclization of **667** (carried out using sodium hydride in dimethoxyethane) furnished nopinone (**669**) together with an isomer **670**, to avoid which it was necessary to block the C(6) position of the cyclohexanone **667** with benzaldehyde, removing the blocking group afterwards, best with potassium hydroxide and crown ether (see Ref. 696). Conversion of nopinone (**669**) to other pinane derivatives is well known.⁶⁹⁷

Larsen and Monti have also synthesized (\pm)- α -pinene (**245**) from the same material **650**⁶⁷⁰ they used for the synthesis of teresantallic acid (**640**, R = CO₂H) (above).⁶⁹⁸ Methylation of the ketone **650**, and protection of the glycol obtained by opening the corresponding epoxide gives the ester **671**, cyclization of which gives the pinane derivative **672**, that, after cleavage to the amide **673** opens the route to α -pinene (**245**).⁶⁹⁸

Kirmse's conversion of (+)-camphor (**624**) into optically pure (+)- β -pinene (**613**) also represents a total (though indirect) synthesis of the latter.⁶⁹⁹ Generally ions of the type **632** rearrange to the bicyclo[2.2.1]heptane skeleton, but by placing a suitable leaving group at C(10) of camphor (i.e., on the bridgehead methyl group), Kirmse showed that rearrangement in the other direction could predominate (Scheme 31). Indeed, rearrangement of 1-amino-2-diazo-7,7-dimethylnorbornane (**674**) yields 91% of nopinone (**669**).⁷⁰⁰ Another rearrangement of the Kirmse type using phosphorus pentachloride on 3-bromo-borneol is reported, but we have been unable to assess the experimental detail.⁷⁰¹



a) N₂H₄; b) h ν ; c) MeOH

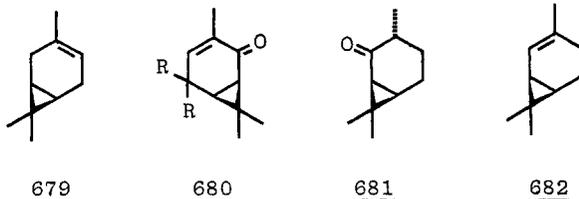

Concerning the interrelation of different pinane derivatives, attention is drawn to the error in Vol. 2, pp. 156-157 concerning the reaction of *N*-bromosuccinimide with α -pinene, the major product from which is myrtenyl bromide (675, R = Br).⁷⁰² The best conditions for obtaining myrtenol (675, R = OH) from the readily accessible *trans*-pinocarveol (676) consist of treatment of the latter with phosphorus tribromide, when a good yield of the rearranged bromide (675, R = Br) is obtained.⁷⁰³ Generally, conversion of β - to α -pinene is easy, while the reverse reaction, to obtain the more expensive (and frequently more useful) β -pinene (613) is more difficult. It has recently been reported that certain palladium on alumina catalysts are efficient for this reverse reaction.⁷⁰⁴ Another important "synthesis" is that of the optically pure *cis*-verbenols (677) from α -pinenes (245), as a result of which Mori was able to show that the (1*S*,4*S*,5*S*) isomer (as shown, 677) has a positive rotation in chloroform and a negative rotation in methanol.⁷⁰⁵ Mori also made the *trans*-verbenols (427).⁷⁰⁶ These compounds are important as metabolites of pinene by the bark beetle *Ips paraconfusus*, the gut of which contains a microorganism, *Bacillus cereus*, which effects the oxidation.⁷⁰⁷ The rabbit also metabolizes α -pinene to verbenol.⁷⁰⁸

Stereospecifically deuterium-labeled β -pinene [*trans*-C(3)],⁷⁰⁹ C(3)-deuterated myrtenal (678),⁵⁶⁶ and deuterated verbenones⁷¹¹ have been prepared. Other deuterated β -pinenes have also been prepared.⁷¹⁰

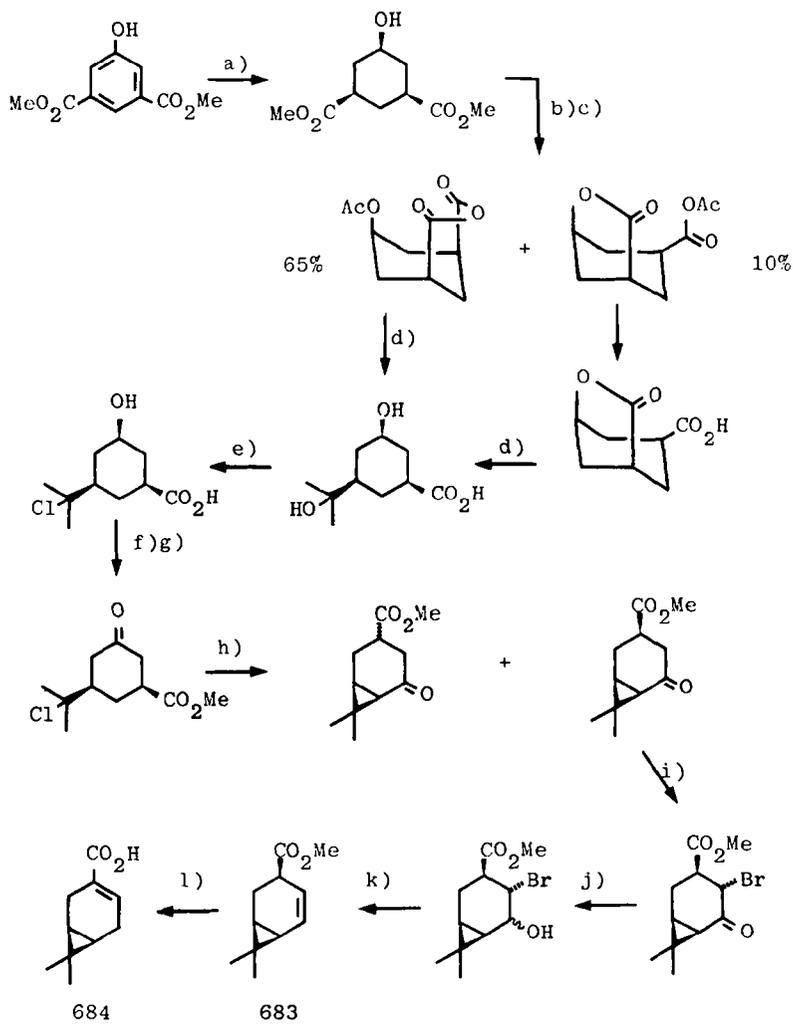
18. BICYCLO[4.1.0]HEPTANES

This group of monoterpenoids is as lacking in synthetic approaches as pinanes and thujanes. Once again, very large amounts of the hydrocarbon (+)-3-carene (679) are available (see Vol. 2, p. 157), making synthetic approaches less attractive. Surprisingly few oxidized carenes are naturally occurring, compared with other terpenoid groups. (-)-3-Caren-2-one (680, R = H) occurs in *Zieria asplanthoides*,⁷¹² and the enedione (680, RR = O) in *Asiasarum heteropoides*,⁷¹³ but little else of novelty has been reported.



Some improvement in the synthesis of 2-carene (681) from dihydrocarvone (401), and conversion of 681 to 2-carene (682) have been described⁷¹⁴ (cf. Vol.

2, p. 157). Cyclization of 3-(2-chloro-2-propyl)cyclohexanones of this type is one of the best ways of making the carane skeleton, and forms the basis of the synthesis of chamic acid methyl ester (**683**) and chaminic acid (**684**) shown in Scheme 32.⁷¹⁵ Chamic acid and chaminic acid were isolated from *Chamaecyparis*



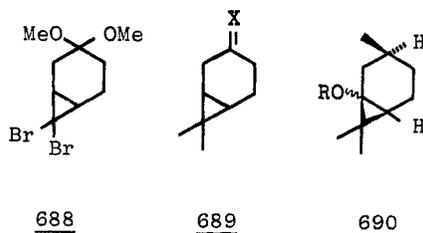
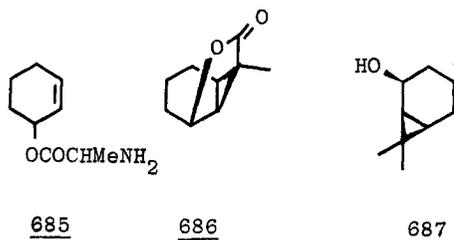

nootkatensis; their structure and stereochemistry was fully known,⁷¹⁶ and they had previously been obtained from other carane derivatives⁷¹⁷ (thereby having been synthesized indirectly), but this was the first direct synthesis.

The synthesis of optically active 2-carene (682) from the cyclohexenyl ester (685) of alanine has been effected by treatment of 685 with isopentyl nitrite in the presence of copper salts. This leads to a lactone 686 already containing the carane skeleton, and which is readily converted, first, to the alcohol 687, then to 2-carene (682).⁷¹⁸ Cocker et al. have synthesized the carane skeleton by replacing the two bromine atoms of the norcarane 688 (obtained by dibromocarbene addition to the acetal of 3-cyclohexenone) with methyl groups using lithium dimethylcuprate for 4 days then adding methyl iodide. (Another approach using the ethylene thioketal gave a poorer yield.) The ketone 689 (X = O) obtained after deacetalization was converted to a mixture of 2-carene (682), 3-carene (679) and β -carene (689, X = CH₂) by Grignard reaction followed by dehydration.⁷¹⁹

The conversion of pulegone (354) to carenes has been known for a long time (cf. Vol. 2, p. 157). Recent knowledge about the formation of hydroxycyclopropanes during zinc/hydrochloric acid reductions of unsaturated ketones⁷²⁰ has led to a synthesis of the carane skeleton (as the hydroxy or acetoxy compound 690, R = H or Ac) by the zinc/hydrochloric acid reduction of pulegone in the presence of acetic acid or acetic anhydride (the latter giving the acetate 690, R = Ac).⁷²¹

19. FURAN MONOTERPENOIDS

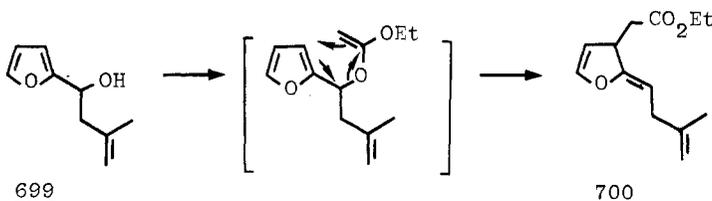
A. 3-Methyl-2-Substituted and 3-Substituted Furans

There has been a marked increase in the amount of synthetic work related to both this class of terpenoids and the pyrans (next section), possibly owing to greater facility in identification of these compounds from natural sources where they are fairly widespread, but nearly always in small amounts, and sometimes making an important contribution to the odor of the natural oil. A typical example is that of verbena oil, which contains small amounts of rose furan (691), perillene (692) and rose oxide (693).⁷²² Naves has reviewed rose furan and the related pyrans⁷²³ (see next section).

The Büchi synthesis of rose furan (691, cf. Vol. 2, p. 161; Ref. 724) involved lithiation of 3-methylfuran, which involved replacement of a mercury salt. This awkward step has been avoided by Takeda et al. by making 2-bromo-3-methylfuran (known) from a Grignard reagent with magnesium and copper, and carrying out a Wurtz coupling with prenyl bromide (13).⁷²⁵ Nguyễn Dinh Ly and Schlosser have described a method which looks well on paper, but which from a technical point of view suffers from a number of disadvantages.⁷²⁶ First, it requires 3-bromofuran, which generally involves a multi-step synthesis, for example, Diels-Alder addition of furan to maleic anhydride, bromination, and pyrolysis of the dibromo-adduct 694.⁷²⁷ The 3-bromofuran thus obtained can be metallated with lithium diisopropylamide, but this requires a very low

temperature, and reacts with prenyl bromide (**13**) in 66% yield. Metal exchange (butyllithium) and methylation (methyl iodide) of the bromide **695** then yields rose furan (**691**).⁷²⁶ Another method involving introduction of the prenyl group to a preformed furan ring is that of Birch and Slobbe. 3-Methylfuran-2-carboxylic acid is reduced with lithium in liquid ammonia, and the resulting anion is quenched with prenyl bromide (**13**). It is then necessary to reoxidize and decarboxylate (using lead tetraacetate) to arrive at rose furan (**691**).⁷²⁸ On a large scale, lead tetraacetate is an unsatisfactory reagent, making this too unacceptable.

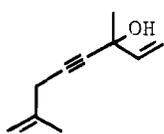
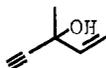
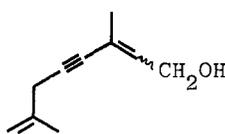
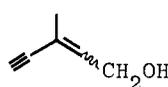
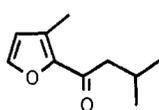
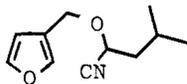
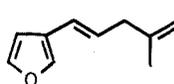
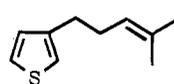
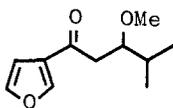
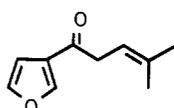
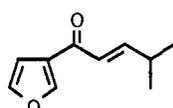
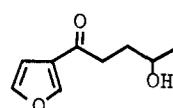
In 1970 one of us reported that the vinyl ether (**696**) of 2-furfuryl alcohol on pyrolysis yielded the aldehyde **697**.⁷²⁹ By operating the other way round, that is, with the vinyl ether of 3-furfuryl alcohol, Vig et al. prepared the aldehyde **698**, which they readily converted into rose furan by a Wittig reaction.⁷³⁰ Unfortunately the yields of these steps are fairly low (apart from the use of mercury to make the vinyl ethers). Nevertheless, another rearrangement method has led to a technically feasible process for rose furan. This consists in treating the Grignard product **699** from furfural and 2-methyl-2-propenylmagnesium chloride with triethyl orthoacetate in the presence of pivalic acid, when a Claisen rearrangement occurs (Scheme 33) yielding the ester **700**. Hydrolysis and decarboxylation, either preceded by or followed by isomerization (palladium on charcoal), then give rose furan (**691**).⁷³¹

Another technically feasible method has been described by Schulte-Elte, which involves construction of the furan ring by reaction with a mercury-impregnated ion exchange resin of the acetylene **701**, obtained in turn from 2-methyl-2-propenyl chloride and the commercially available acetylenic alcohol **702**.⁷³² The allylicly rearranged isomers **703** of **701** also undergoes this cyclization;⁷³² the dangers of certain manipulations of the acetylenic precursors **702** and **704** should be noted.⁷³³

Elsholtzia ketone (**705**) has also been made by a "rearrangement" method. Cazes and Julia prepared the 3-furfuryl ether of 3-methylbutanal cyanohydrin (**706**) from 3-furfuryl bromide. This compound **706** undergoes a [2,3]sigmatropic rearrangement of the anion, made with lithium diisopropylamide, leading directly to **705**.¹⁵⁹

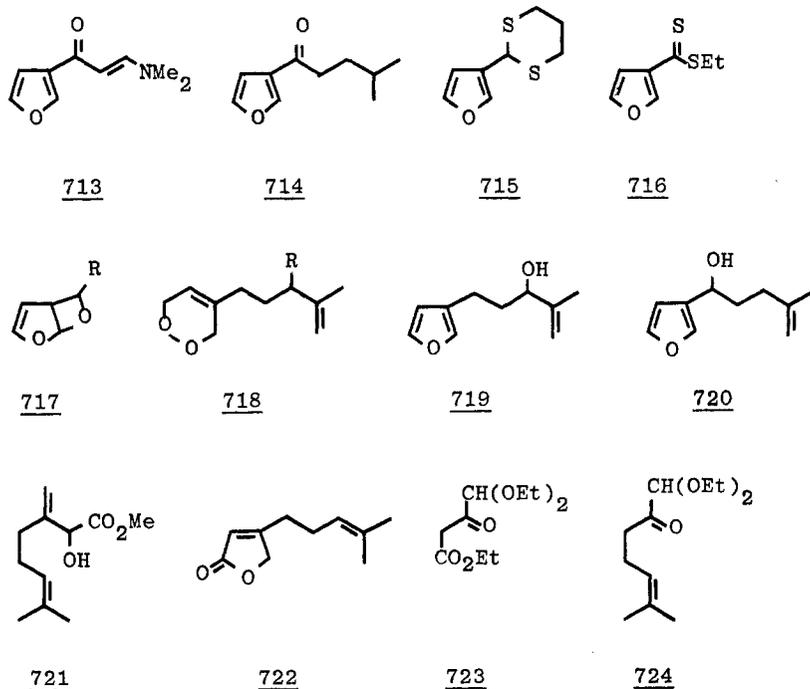
In addition to the list of naturally occurring 3-substituted furans given in Vol. 2 (p. 159), α -clausenane (707)⁷³⁴ should be added.* We might also include the thio-analog 708 of perillene (692), which, together with some related substances containing additional sulfur atoms, has been isolated from hops,⁷³⁵ but not yet synthesized. The ketol ether 709 has been reported in *Perilla frutescens*⁷³⁶ — the same plant that contains egomaketone (710) and its isomer 711; such natural juxtapositions always make one wonder whether all of these compounds are really naturally occurring. Probably the highly toxic 4-ipomeanol (712) and related compounds, isolated from moldy sweet potatoes⁷³⁷ are also isoprenoid.

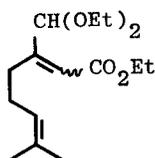
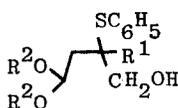
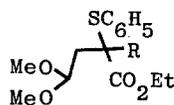
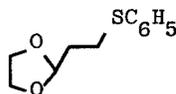
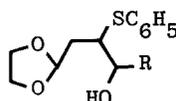
All the older methods for preparing 3-substituted furans of this type involve attaching the side chain to a furan already substituted in the 3-position. A typical modification of this approach is that used in the synthesis of isoegomaketone (711) involving the addition of dimethylformamide dimethyl acetal to

3-acetylfuran. The resulting enamine **713** reacts with isopropylolithium to give **711**, which the authors also reduced to perilla ketone (**714**). All the yields were fairly low, addition to the enamine **713** reaching only 37%.⁷³⁸ Better yields were achieved by Hoppmann and Weyerstahl, who activated 3-furfural with a dithiane group, then added prenyl halide to the lithium derivative of the thioacetal **715** to obtain perillene (**692**).⁷³⁹ A longer route of this type is that of Gosselin et al., who required 3-bromofuran⁷²⁷ in order to prepare the thioester **716**. A Grignard reaction with prenyl bromide (and ethylmagnesium bromide) led to the thioacetal of egomaketone (**710**). The latter could then be obtained by dethioacetalization with cadmium carbonate and silver nitrate, or alternatively, sodium in liquid ammonia gave perillene (**692**).⁷⁴⁰

An ingenious approach starting from furan itself was published by Zamojski and Kozluk,⁷⁴¹ and immediately after by Kitamura et al.⁷⁴² This took advantage of the fact that when an aldehyde, RCHO, is irradiated in furan, a dioxabicyclo-[3.2.0]heptane **717** is formed. The yield is usually small (although the reaction works well when R = CO₂Et), but in view of the low cost, this is less important. *p*-Toluenesulfonic acid in carbon tetrachloride will open the 4-membered ring of **717** (R = CH₂CH₂CHMe₂), and the resulting alcohol is readily oxidized to perilla ketone (**714**).^{741, 742}

We have already spoken about the photooxygenation of myrcene (6) to two alcohols, 98 and 112.¹³⁴ Further addition of oxygen to 112 under the influence of light yields the endoperoxide 718 (R = OH), which can be converted to the corresponding furan 719* in various ways, Kondo having used lithium *t*-butoxide. Treatment of 719 with thionyl chloride, followed by lithium aluminum hydride reduction of the chloride thus obtained, gave perillene (692).¹³⁴ Several modifications of this scheme exist. For example, photooxidation of myrcene (6) to the hydroperoxide 718 (R = OOH) can be carried out in a single step,⁷⁴³ and photooxygenation of ipsenol (96) can be used (following the same route) to prepare perilla ketone (714) or α -clausenane (707) via the alcohol 720.⁷⁴⁴ An improved conversion of the peroxides like 718 to the corresponding furans using ferrous sulfate has also been described.⁷⁴⁵

Conversion of an ester of geranic acid (56) functionalized on the allylic methyl group to a γ -lactone is possible, the lactone being subsequently reduced with diisobutylaluminum hydride to a furan. There are examples of either direct functionalization of the geranic ester and of construction of such a molecule from smaller pieces. For the first example, Katsumura et al. oxygenated the anion of methyl geranate (obtained with lithium diisopropylamide in hexamethylphosphoramide), obtaining ester 721 as the main product (66%). The benzoate of 721 was cyclized to the lactone 722 with lithium iodide in dimethylformamide, and the lactone converted to perillene (692).⁷⁴⁶ Takahashi's longer route to 722 consisted in addition of prenyl chloride to the substituted ethyl acetoacetate 723. After hydrolysis and decarboxylation of the product, the resulting substituted methylheptenone 724 must be converted to the corresponding geranic acid ester 725 with ethyl triethoxyphosphonoacetate. Cyclization to an ethoxybut-

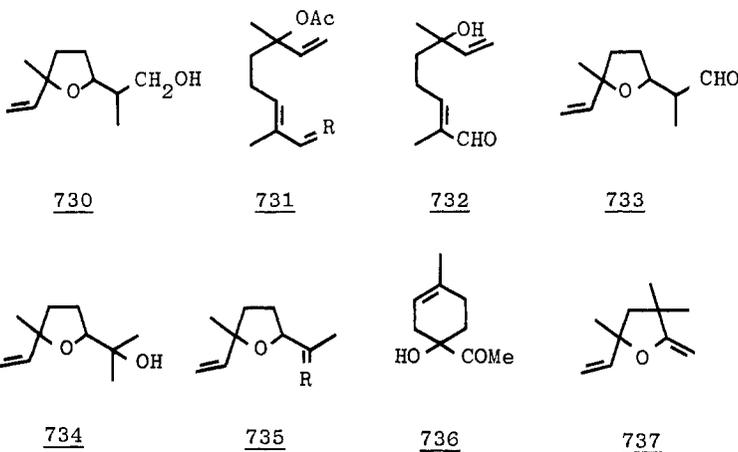

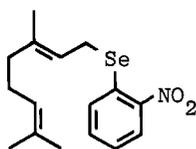
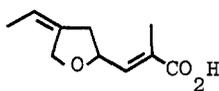
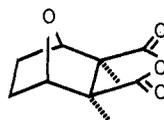
nolide occurs on UV irradiation in the presence of acid, the reduction of this with sodium borohydride gives the butenolide **722**.⁷⁴⁷

In the syntheses exploited by Inomata et al., the furan ring is constructed in the last step, by cyclization of the primary alcohol group and the aldehyde formed by the acid-catalyzed removal of the acetal of formula **726**. Several ways have been used to make **726**, which was not always isolated. One route involves condensation of bromoacetaldehyde dimethyl acetal with the anion of ethyl phenylthioacetate; the product **727** (R = H) can then form an anion which will react with an alkyl halide yielding the ester **727** (R = alkyl). Lithium aluminum hydride reduction then gives **726**, cyclizable to the 3-substituted furan with acid.⁷⁴⁸ Alternatively, the acetal **728** can be metallated (butyllithium) and condensed with an aldehyde, RCHO. This time the resulting alcohol **729** must be oxidized, then, if R = CH₂CH₂CHMe₂, the anion of the ketone obtained yields perilla ketone (**714**) after reaction with formaldehyde and acid workup.⁷⁴⁹

B. 2,5,5-Substituted Tetrahydrofurans

All four stereoisomers of lilac alcohol (**730**) are present in lilac flower oil (*Syringa vulgaris*),⁷⁵⁰ and their synthesis has been accomplished from linalyl acetate (**731**, R = H₂). The first step, oxidation (selenium dioxide), yields an aldehyde **731** (R = O), which can be converted to the alcohol **732**. The cyclization step to **733** can either be carried out directly on **731** (R = O)⁷⁵¹ or on **732**,⁷⁵² but the yields are not very good in either case. Reduction of the aldehydes **733** to the lilac alcohols (**730**) is straightforward, and the various isomers of **730** can be separated by gas chromatography.⁷⁵² Lilac alcohols have also been synthesized by cyclization of the ester corresponding to **732**, then lithium aluminum hydride reduction.^{753, 109}

Linalool oxides (**734**) can be dehydrated to **735** ($R = CH_2$), and it might be thought that Grignard additions to the corresponding ketone **735** ($R = O$, obtained by ozonolysis of **735**, $R = CH_2$ ⁷⁵⁴) would provide an entry to other tetrahydrofurans of this type. This is not the case, and an attempt to synthesize linalool oxides (**734**) again from **735** ($R = O$) yielded **736**, the product of a [2,3]sigmatropic reaction of the anion of **735** ($R = O$).⁷⁵⁵ The other dehydration product **567** ($R = Me$) of linalool oxide rearranges to karahanaenone (**566**, see Vol. 2, p. 142), and it was synthesized by Chidgey and Hoffmann from isoprene and 1,3-dibromo-3-methyl-2-butanone with copper bronze and sodium iodide in acetonitrile. The isomer **737** was separated from the reaction mixture too, but yields were not very good.⁷⁵⁶ A new synthesis of linalool oxides (**734**) from geraniol involves reaction with 2-nitrophenylselenocyanide in the presence of tributylphosphine. The selenide **738** thus obtained is oxidized to the linalool oxides (**734**) with 30% hydrogen peroxide in tetrahydrofuran.⁷⁵⁷

C. Other Furans

Menthofuran and 1,4-cineole occur under the section about menthanes.

The acid **739** appears to be a monoterpene, and occurs as an ester with a triterpene alcohol in *Acacia concinna*,⁷⁵⁸ but it has not been synthesized.

It was once believed that cantharidin (**740**) was isoprenoid, especially since it is synthesized from farnesol and methyl farnesate by males of the "spanish fly" *Lytta vesicatoria*, more efficiently when stimulated by copulation;⁷⁵⁹ later results, however, show that it is apparently not isoprenoid.⁷⁶⁰

20. PYRAN MONOTERPENOIDS

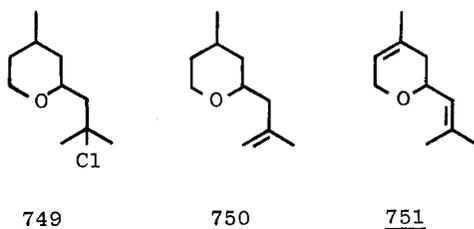
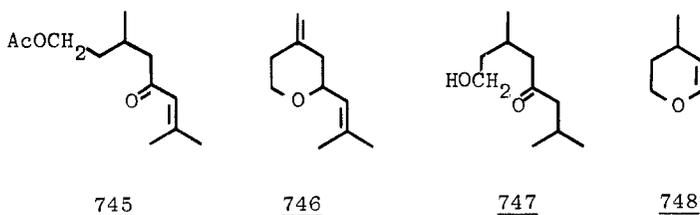
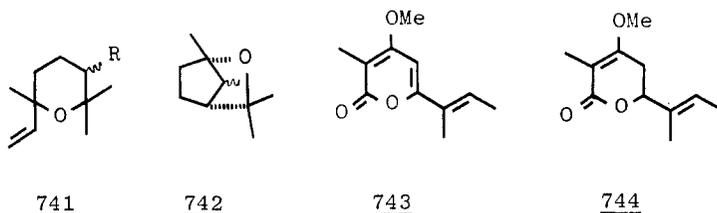
Attention is drawn to the review already mentioned.⁷²³

2,6,6-Trimethyl-2-vinyltetrahydropyran (**741**, $R = H$; Vol 2, p. 167) has been synthesized by Torii et al. (who incorrectly refer to it as "linaloyl oxide") from the epoxide **126** via the dithiane **127**. The latter was cyclized with boron trifluoride, then the dithiane group removed with boron trifluoride/mercuric oxide. The resulting aldehyde was reduced to the alcohol, the xanthate of which was dehydrated to the pyran **741** ($R = H$).¹⁵²

There is a close relation between the alcohols **741** ($R = OH$) and the linalool oxides (**734**); in *Lilium makinoi* they all have the same absolute configuration at C(2) as that of the congeneric linalool (**11**), which is presumed to be the biogenetic precursor⁷⁶¹ (see Vol. 2, p. 166). It was reported that the two acetates **741** ($R = OAc$) occurred in Indian linaloe (*Bursera delpechiana*),⁷⁶² but it transpired that they were not this structure, but were the acetates of linalool oxide (**734**, acetate).⁷⁶³

It is interesting to note that linalool (**11**) is cyclized by mercuric acetate to **741**, $R = HgOAc$, but borohydride reduction of this does not give simple demercuration to **741** ($R = H$) but mostly cyclopentane ethers.⁷⁶⁴

The antibiotic nectriapyrone (**743**) was isolated from the fungus *Gyrostroma missouriense*,⁷⁶⁵ and synthesized from tiglic aldehyde [(*E*)-2-methyl-2-butenal (**3**)] and ethyl methylacetoacetate. This condensation yields the dihydropyrene **744**, where it is necessary to protect the double bond in the side chain (by addition of bromine) before dehydrogenating; removal of the two bromine atoms then yields the antibiotic.⁷⁶⁶



Most of the remaining synthetic work on pyran monoterpenoids concerns rose oxide (693). Many methods are based (like the earliest ones, Vol. 2, p. 168) on the oxidation of citronellol (33) or some closely related compound. Thus *N*-iodosuccinimide in carbon tetrachloride gives a 36% yield of rose oxide from citronellol without loss of the stereochemistry.⁷⁶⁷ Citronellyl acetate (33 acetate) is oxidized with *t*-butyl chromate to 745 and products of further degradation. Reduction of 745 to the diol and cyclization with sulfuric acid gives the two isomers of rose oxide (693).⁷⁶⁸ The dehydro analog 105 of 745 after reduction with lithium aluminum hydride cyclized to 746, and the latter can be hydrogenated, in particular with homogeneous rhodium catalysts, to the rose oxides.¹²³ Another similar scheme, this time for dihydrorose oxide, consists in synthesizing the precursor 747 from the trimethylsilyl enol ether of 4-methyl-2-pentanone and the dimethyl acetal of 2-butenal before metal hydride reduction and cyclization as usual.⁷⁶⁹ Anodic oxidation of citronellol can be made to yield a 71:29 mixture of *cis*:*trans* rose oxides.⁷⁷⁰

The other "classical" route to the rose oxides starts from the dihydropyran 748. One modification involves the reaction of 748 with hydrogen chloride, then reaction of the 2-chlorotetrahydropyran thus obtained with isobutylene in the presence of zinc chloride yields the chloride 749. This can be dehydrochlorinated to yield the two rose oxides, and their isomers 750.⁷⁷¹ Alternatively, the dihydropyran 748 has been converted to the tetrahydropyranyl ether of 2,4-dichlorophenol. The latter reacts with isobutenylmagnesium bromide to give the rose oxides, or isobutylmagnesium bromide to give the dihydro analogs.⁷⁷²

Tyman and Willis succeeded in constructing the pyran ring at the same time as the side chain is introduced. 3-Methyl-2-butenal (102) reacts with 3-methyl-3-butenol (53) in the presence of acid to yield a mixture of nerol oxide (751) and 746. Reduction then gives rose oxides (693). The authors examined a number of reduction systems, and found varying amounts of rose oxide stereoisomers (they also prepared the dihydrorose oxides).⁷⁷³ Recently Schulte-Elte has found that treatment of *trans*-rose oxide with a Lewis acid yields a high proportion of *cis*-oxide.⁷⁷⁴

Many pyran monoterpenoids are related to other monoterpenoid skeletons (as, in fact, are those that have been given a separate section here), but the relation is frequently so close that it has been more convenient to treat them in the sections relating to their parent compounds: see, for example, artemisia compounds and iridoids.
